(57) **CLAIM**

The ornamental design of a container for packing cosmetics, as shown and described.

DESCRIPTION

FIG. 3 is a front elevation view of the container for packing cosmetics.

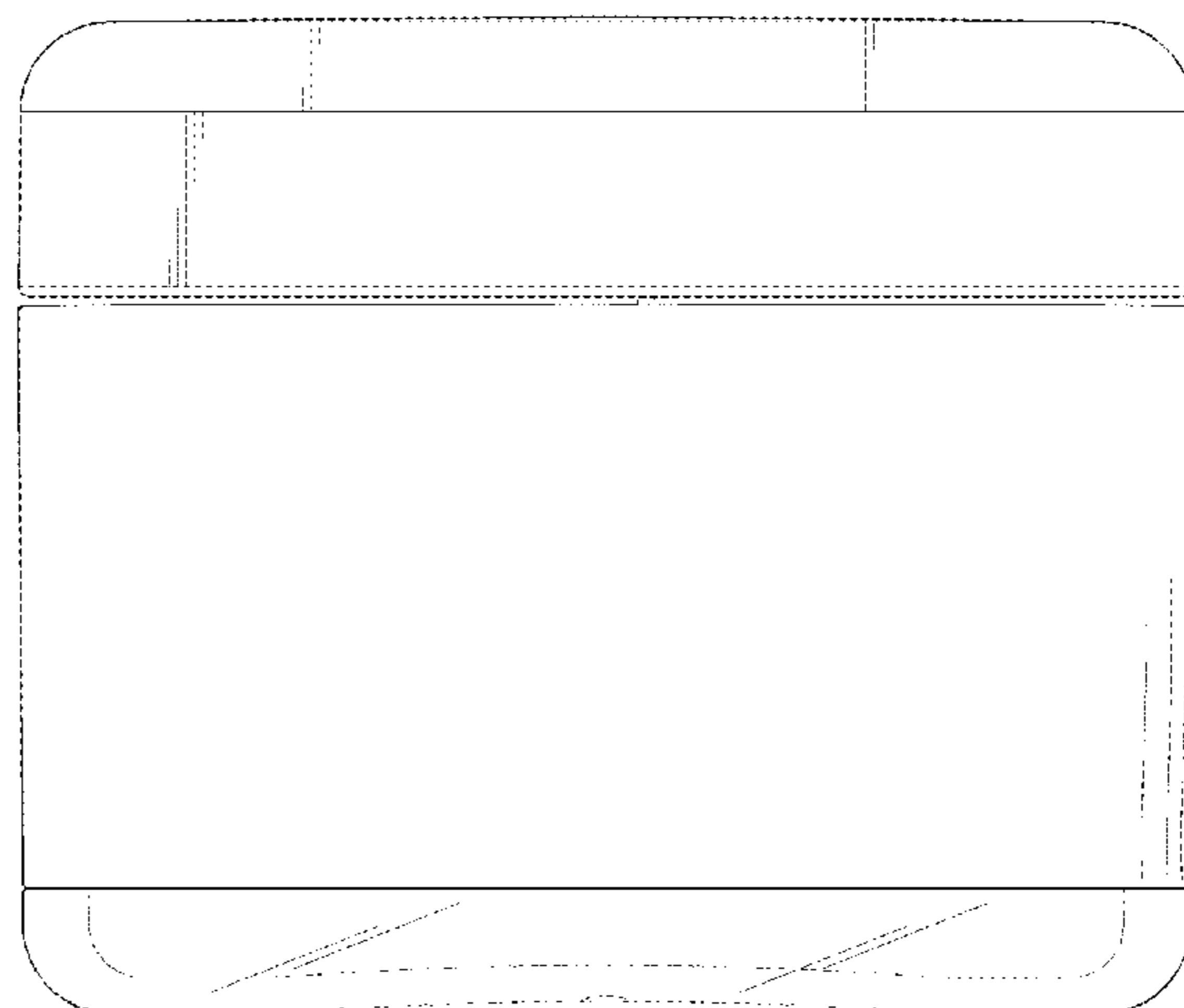
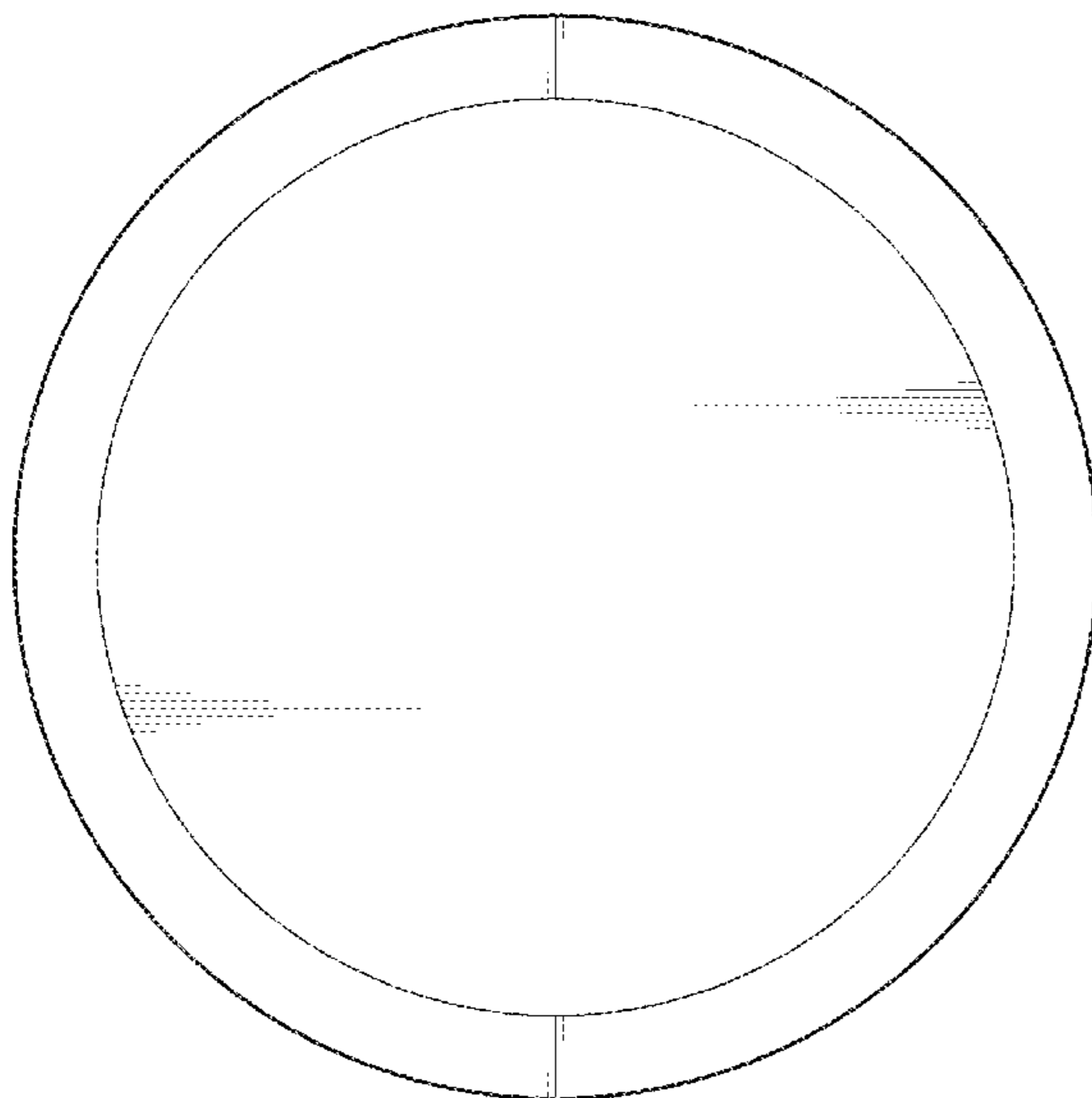
FIG. 4 is a right-side elevation view of the container for packing cosmetics.

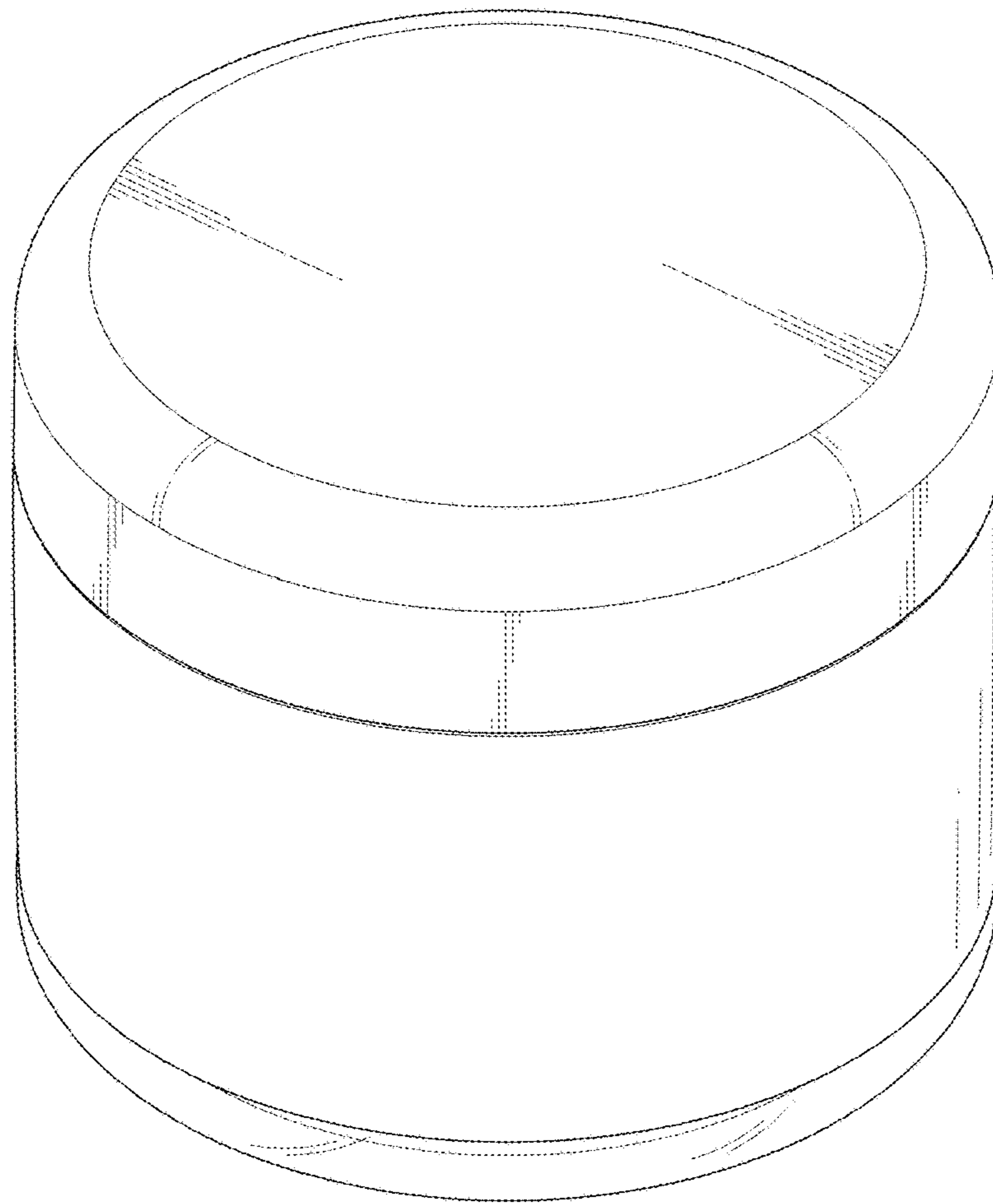

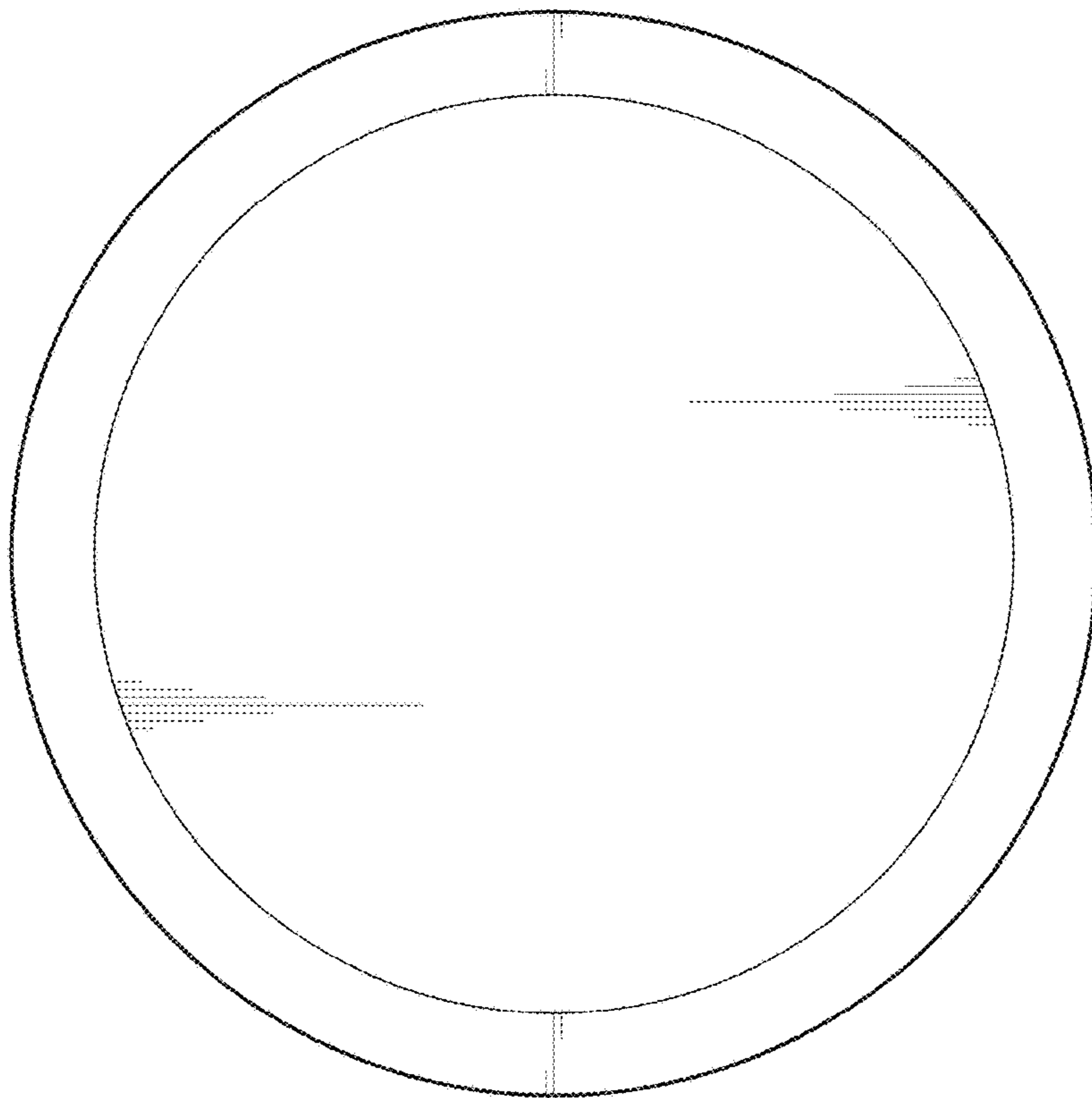

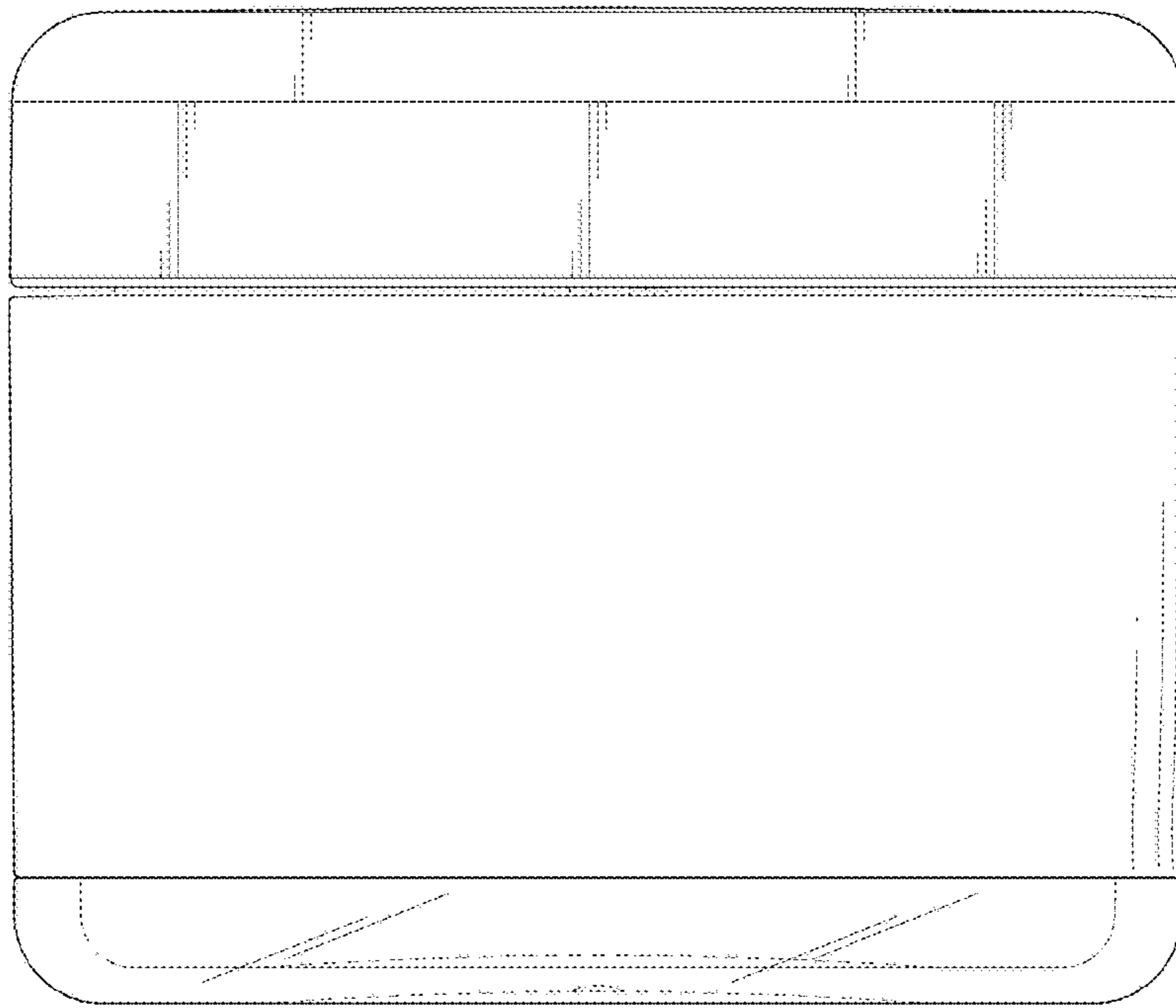

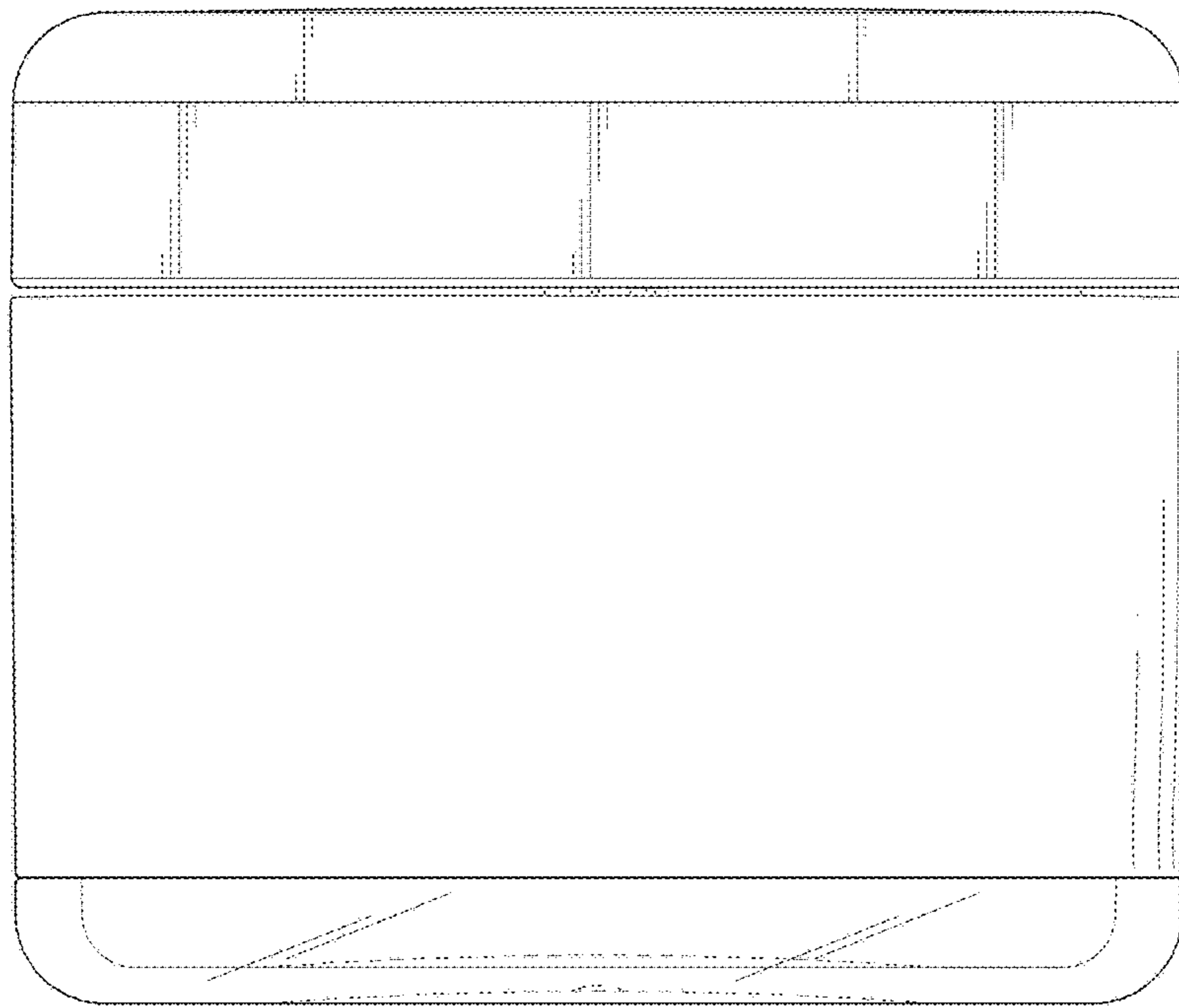

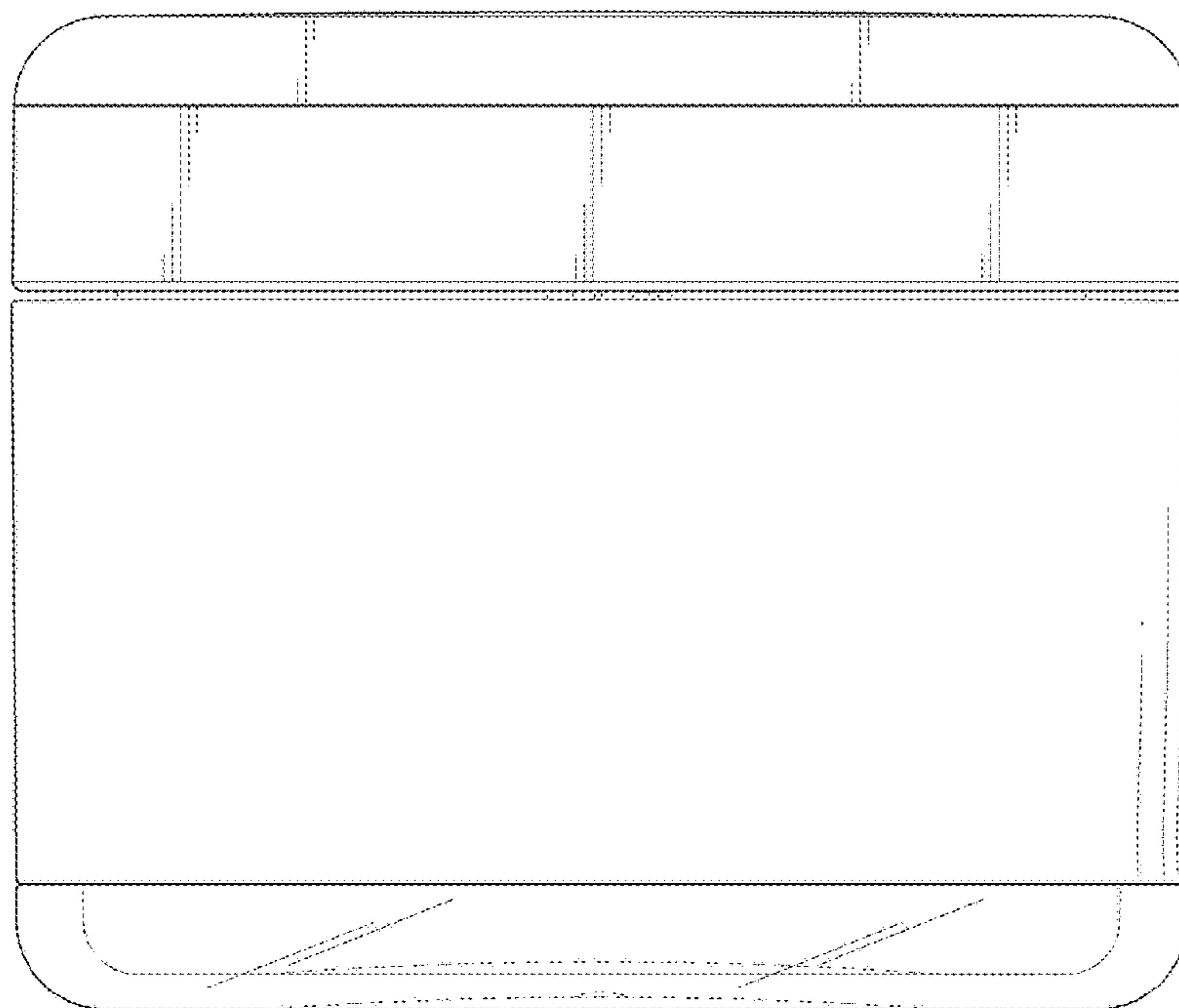

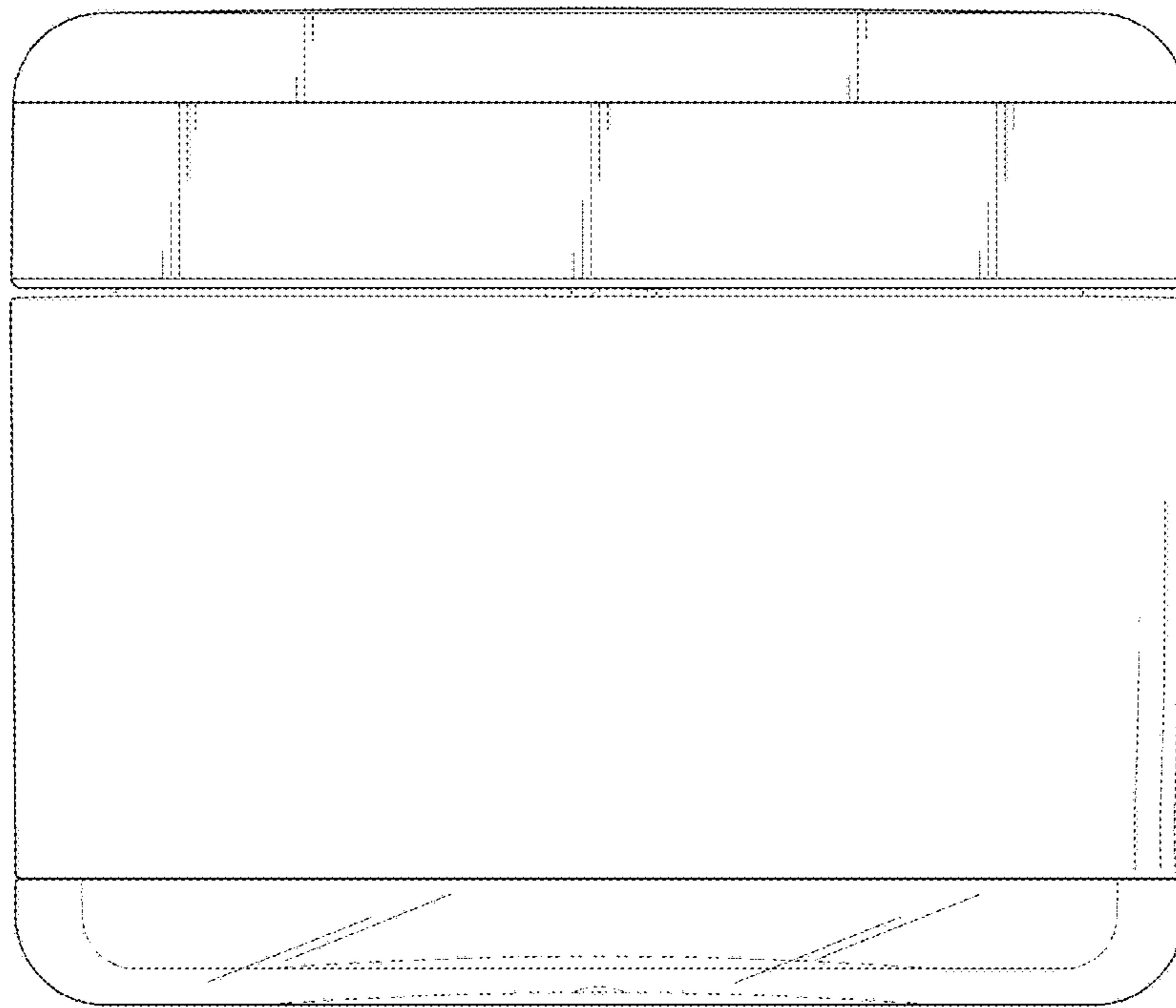
