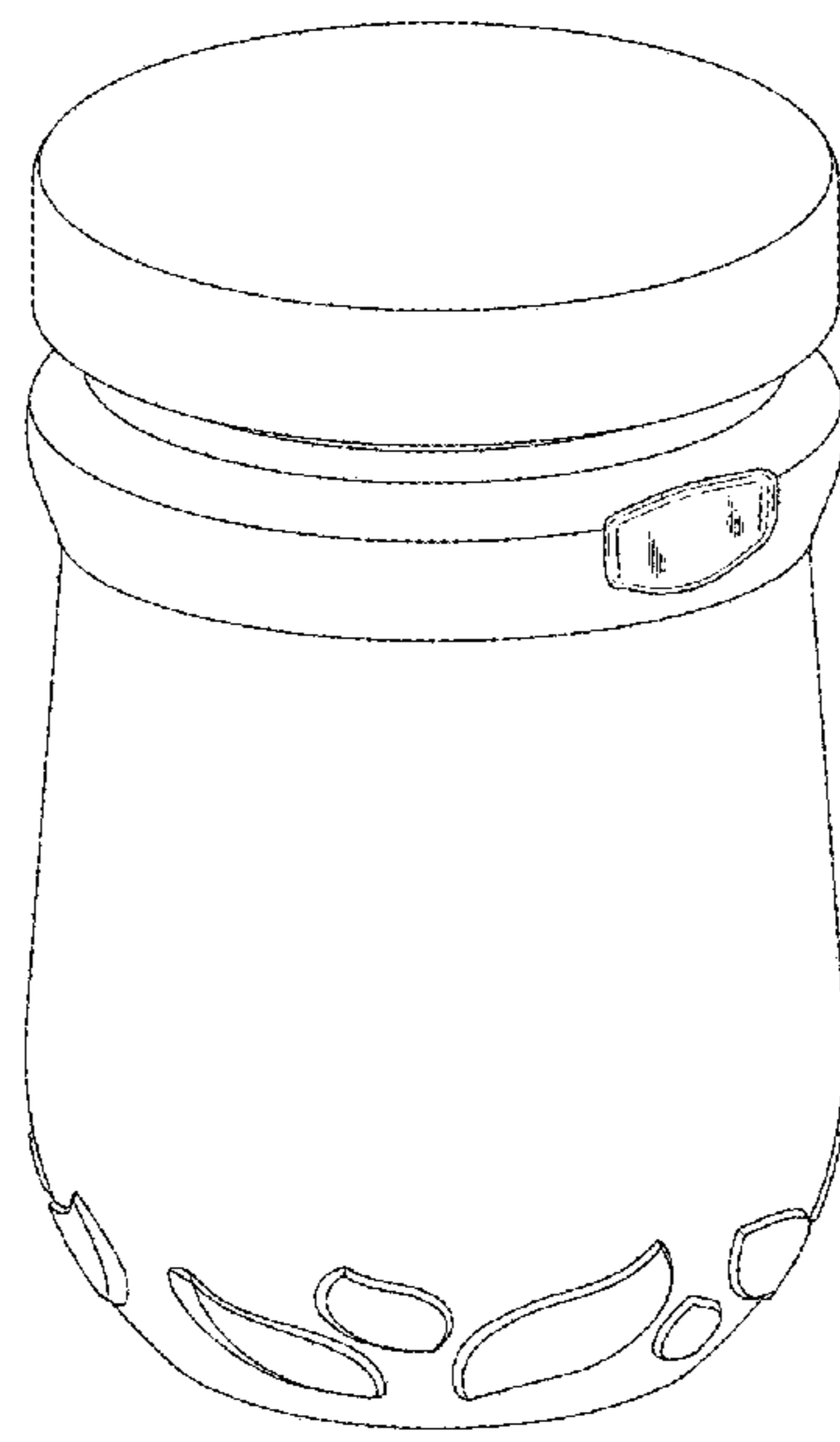

(57) **CLAIM**
I claim the ornamental design for a jar, as shown and described.

DESCRIPTION
FIG. 1 is a top, front and left side perspective view of a jar with a lid showing our new design;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a top, front and left side perspective view of the jar in FIG. 1 without a lid showing our new design;

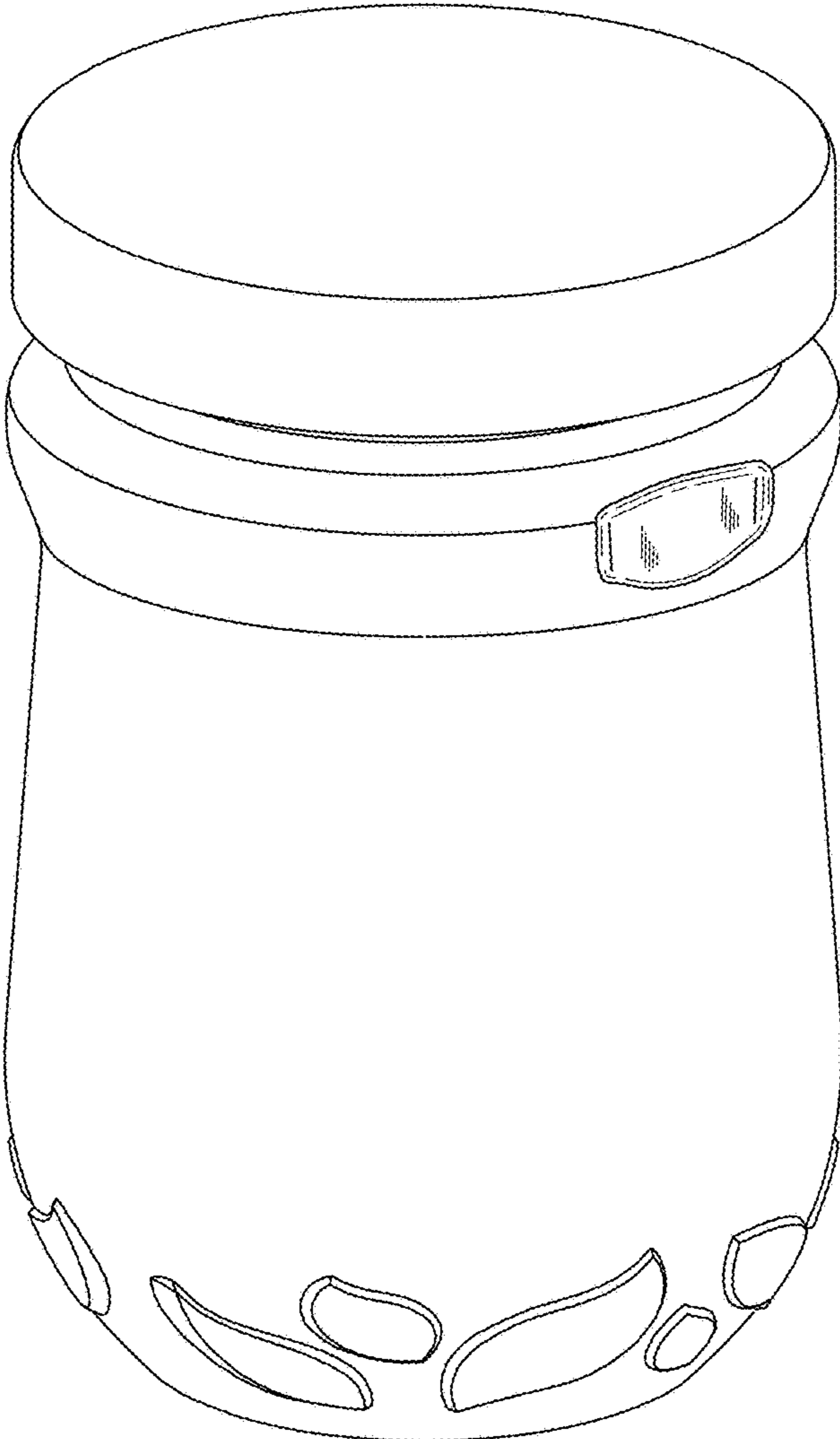

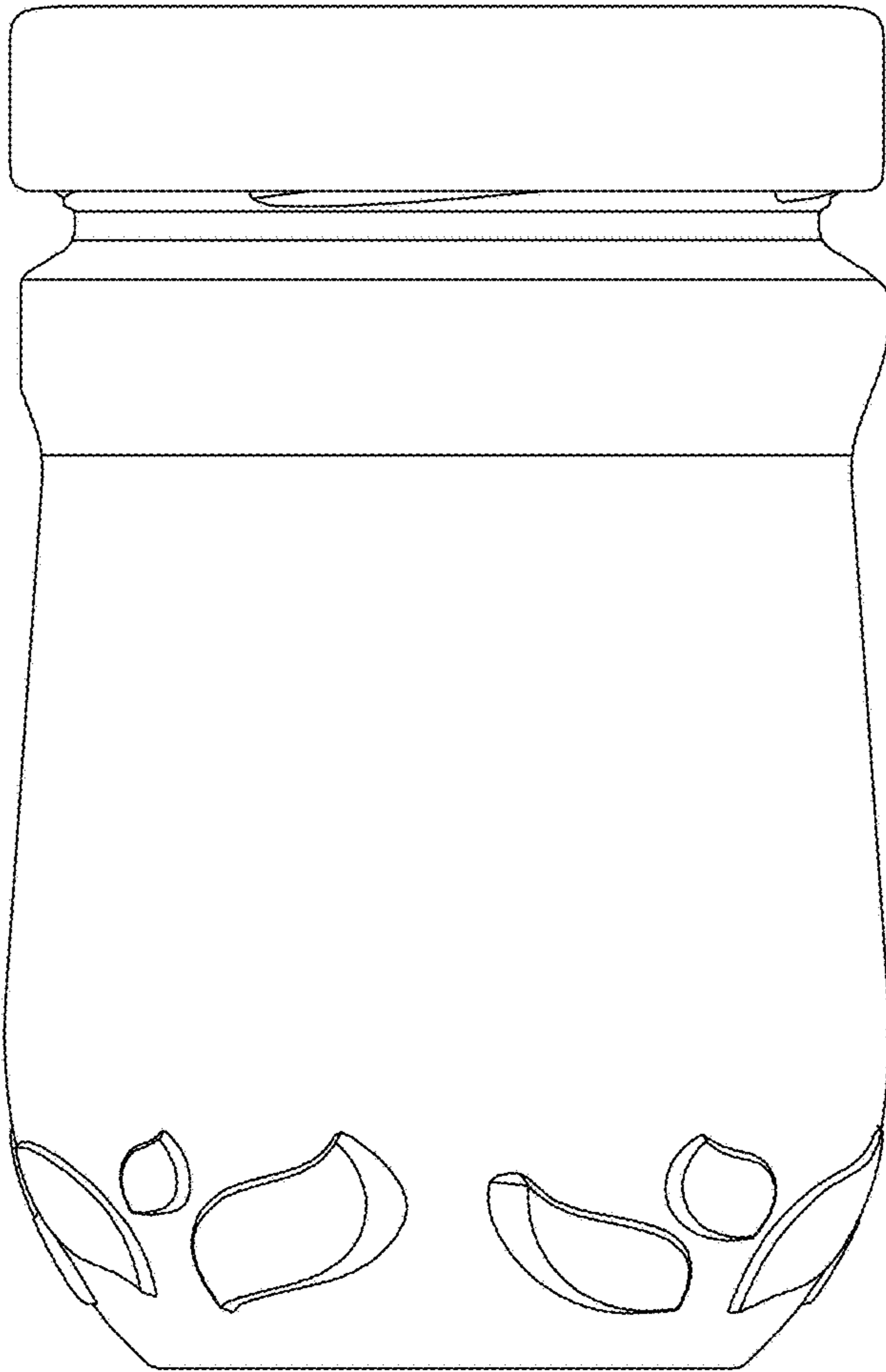

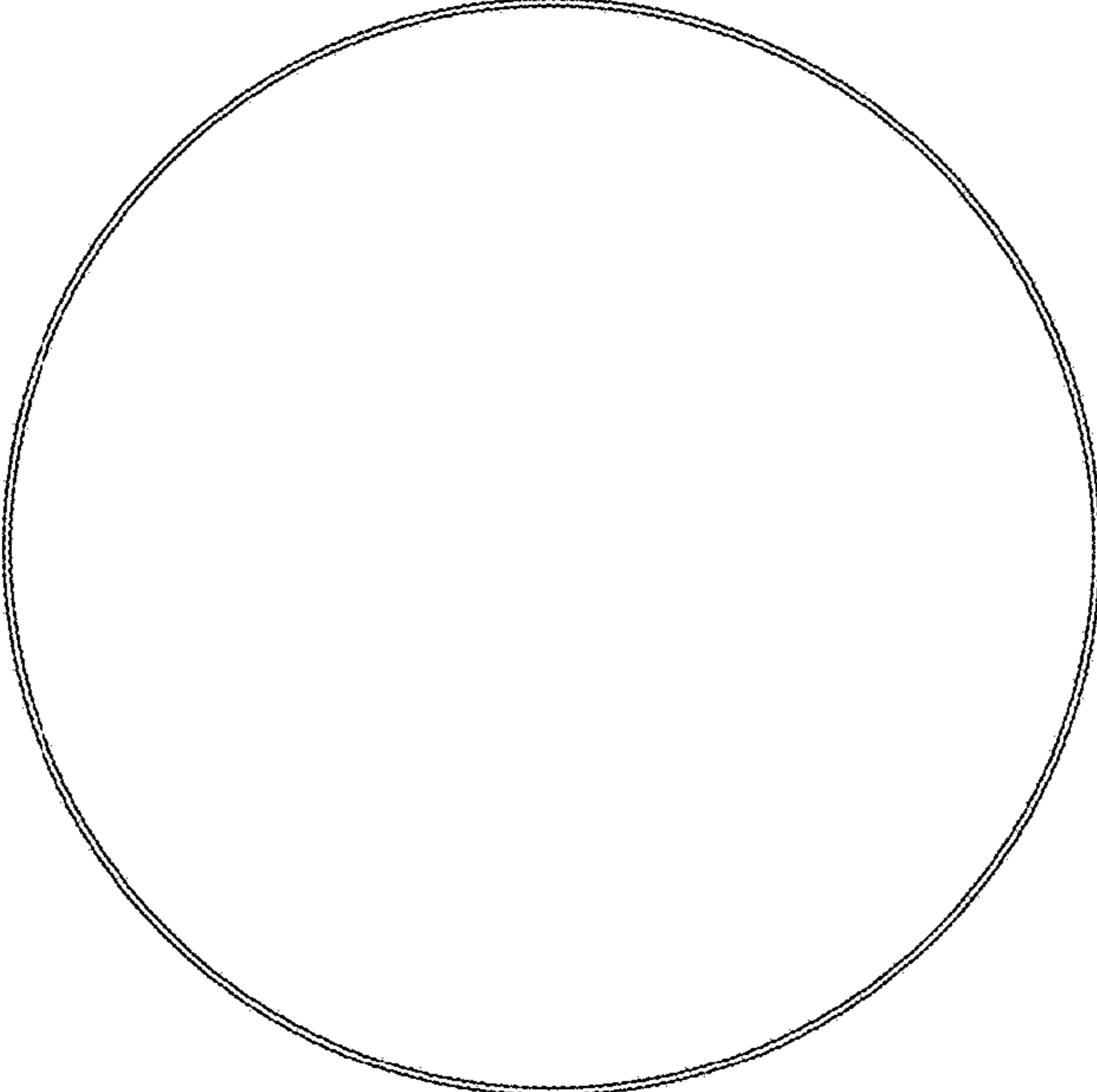

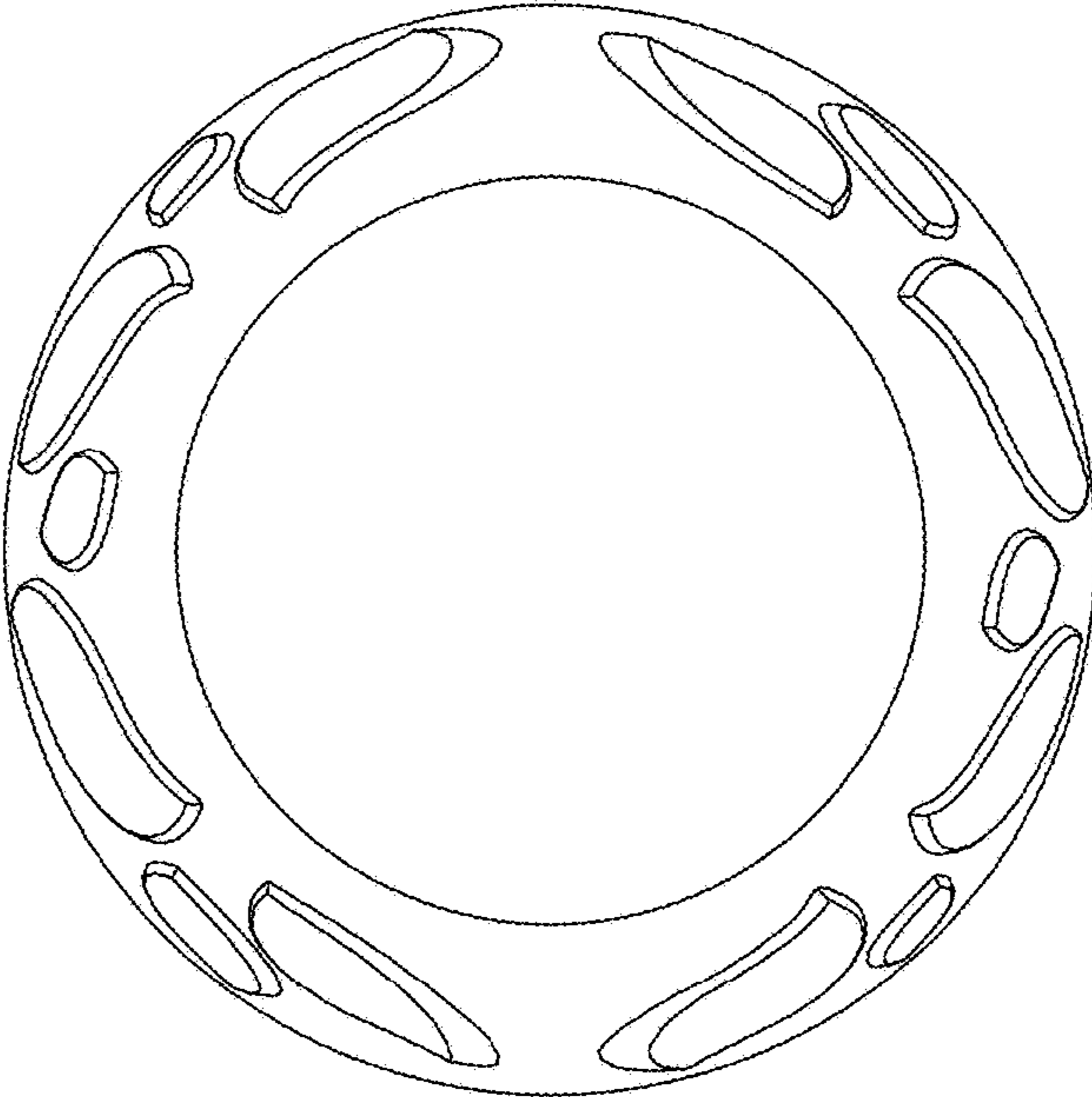

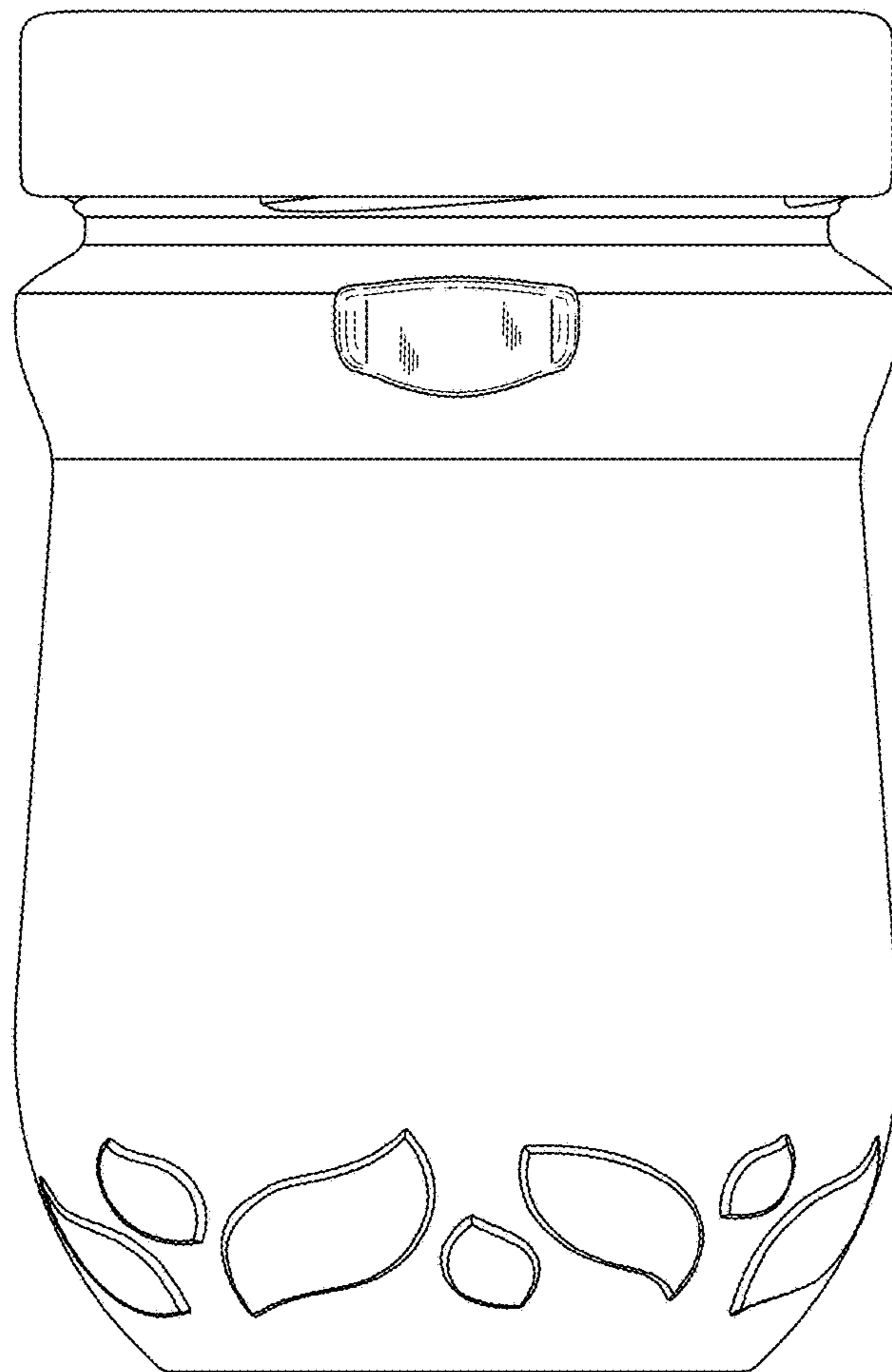

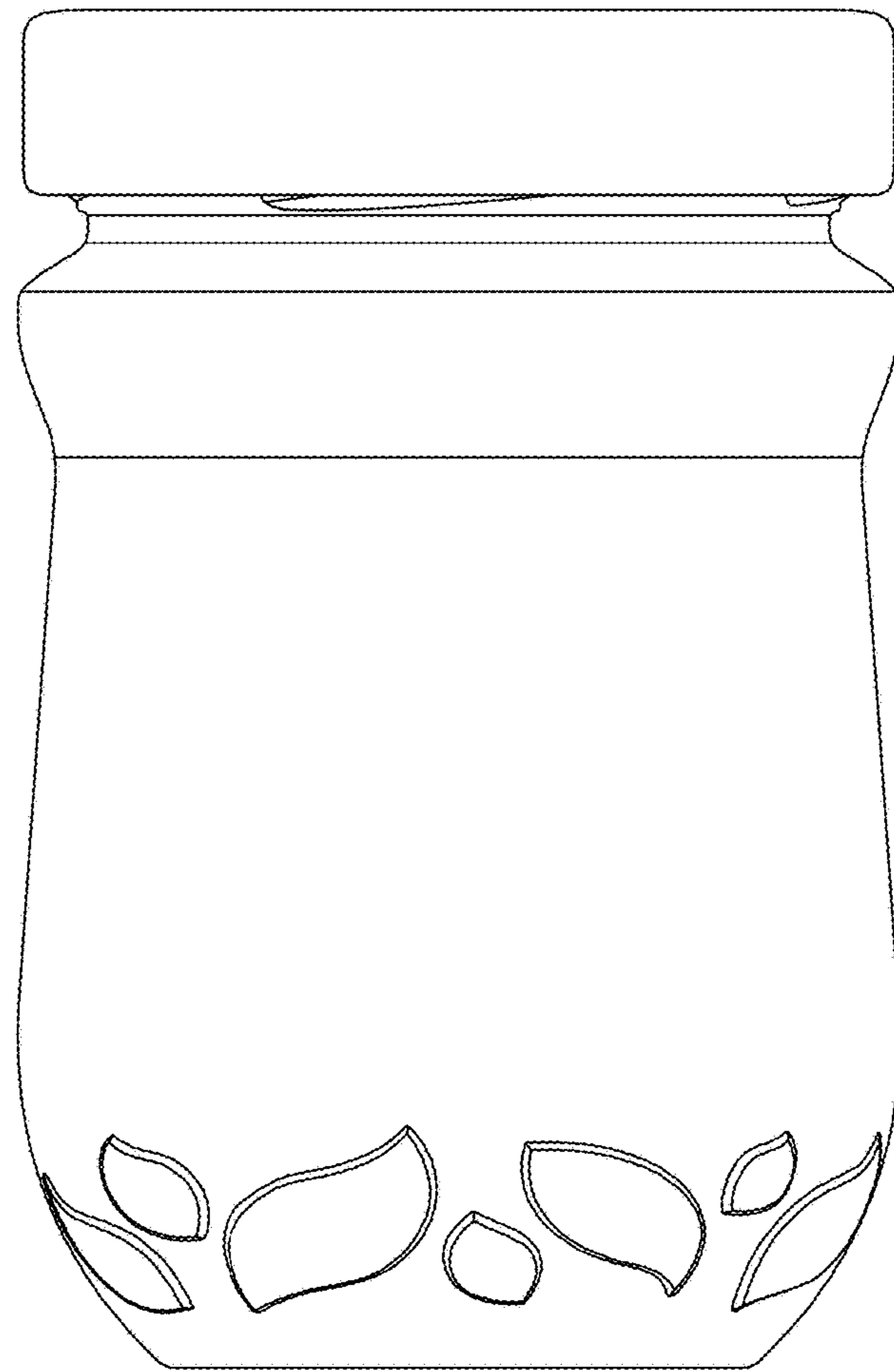

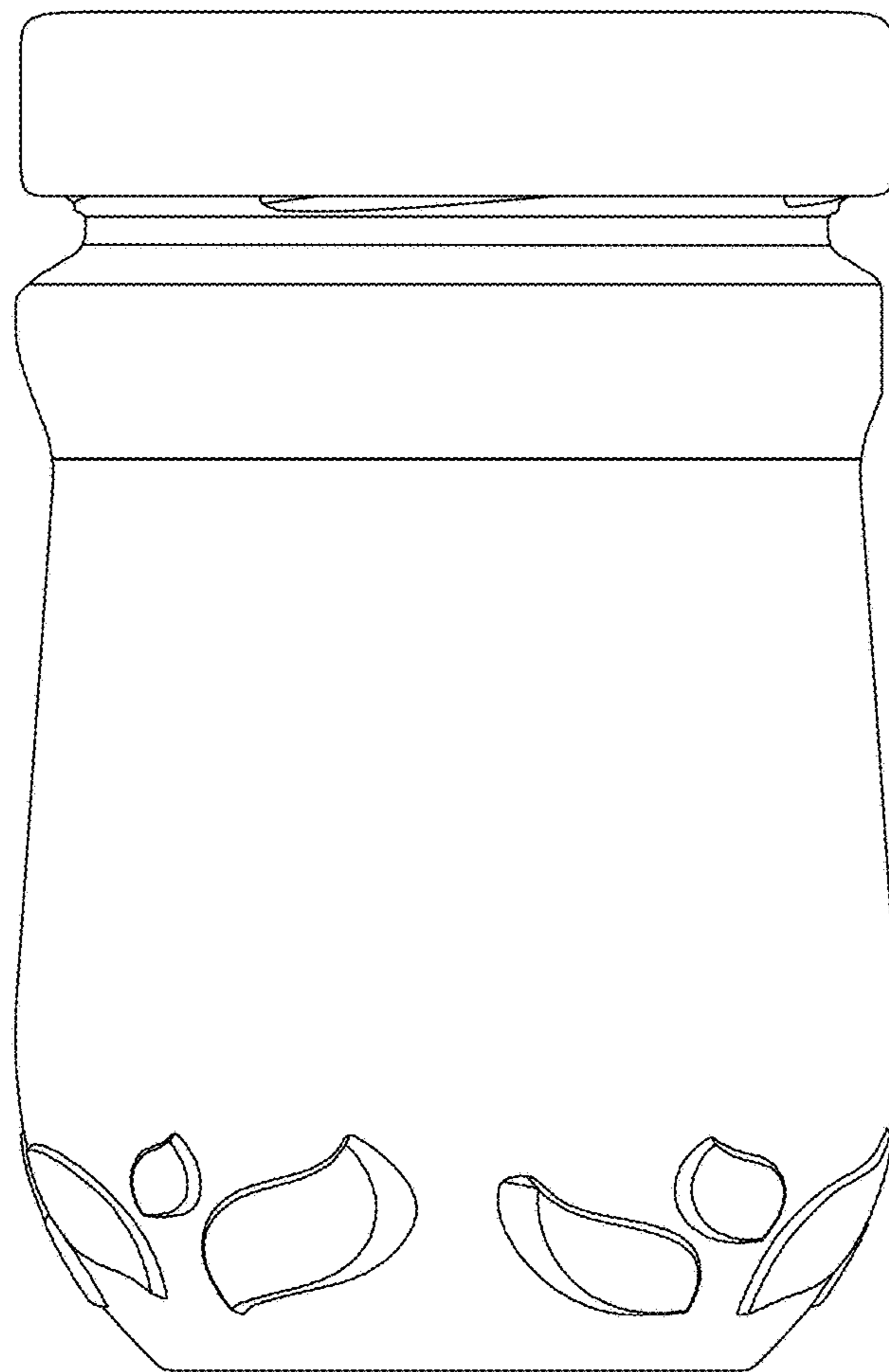

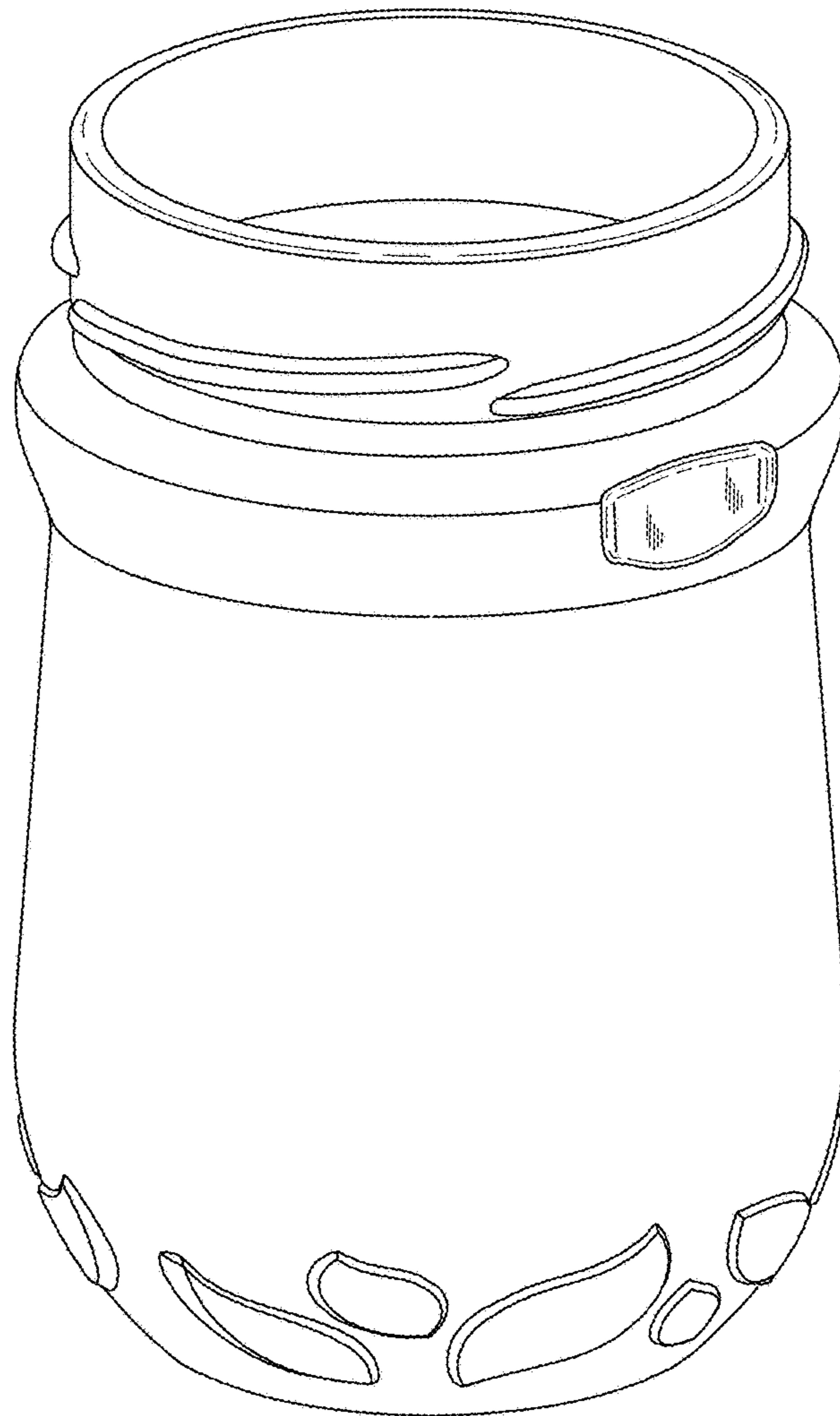

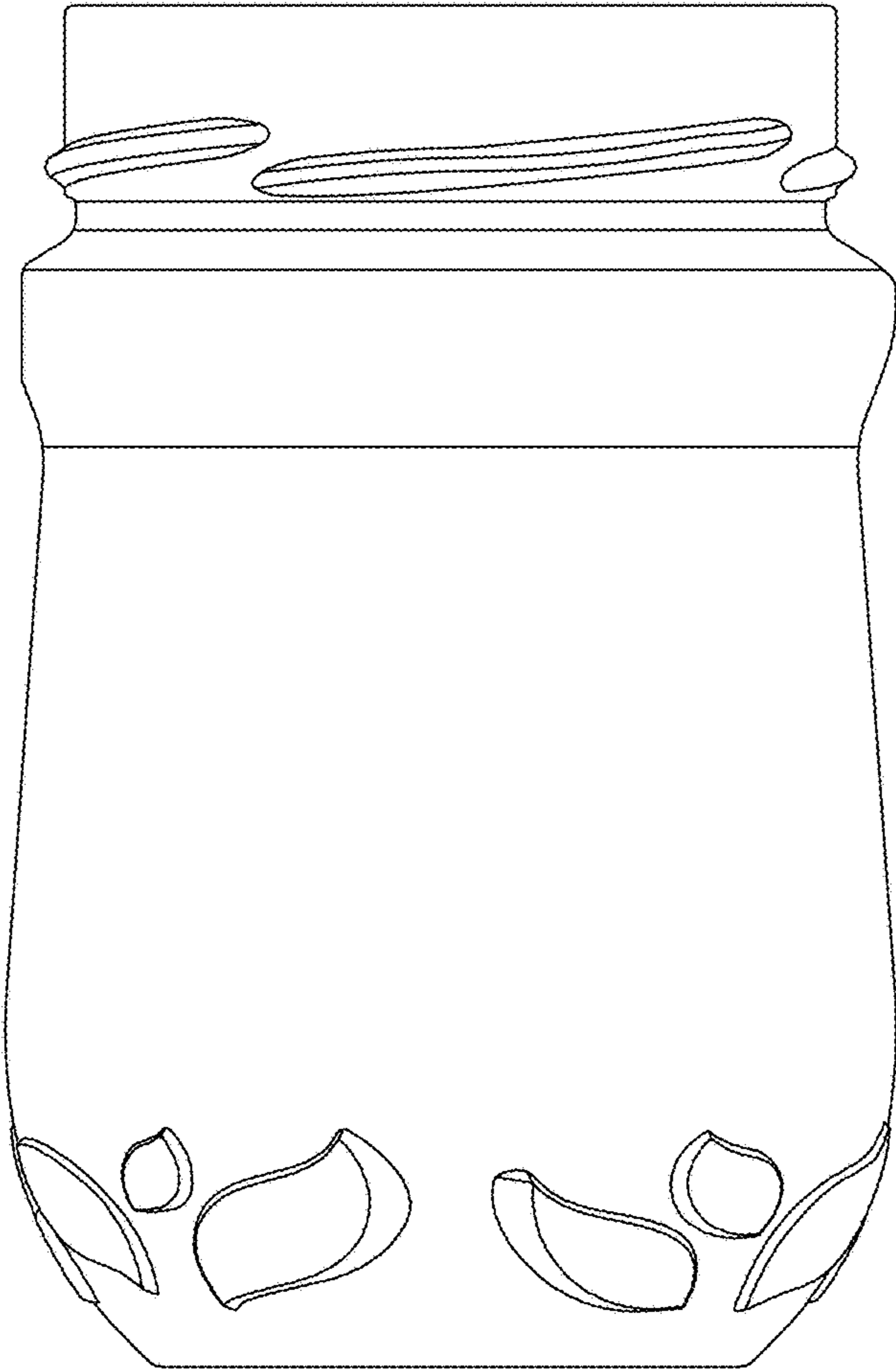

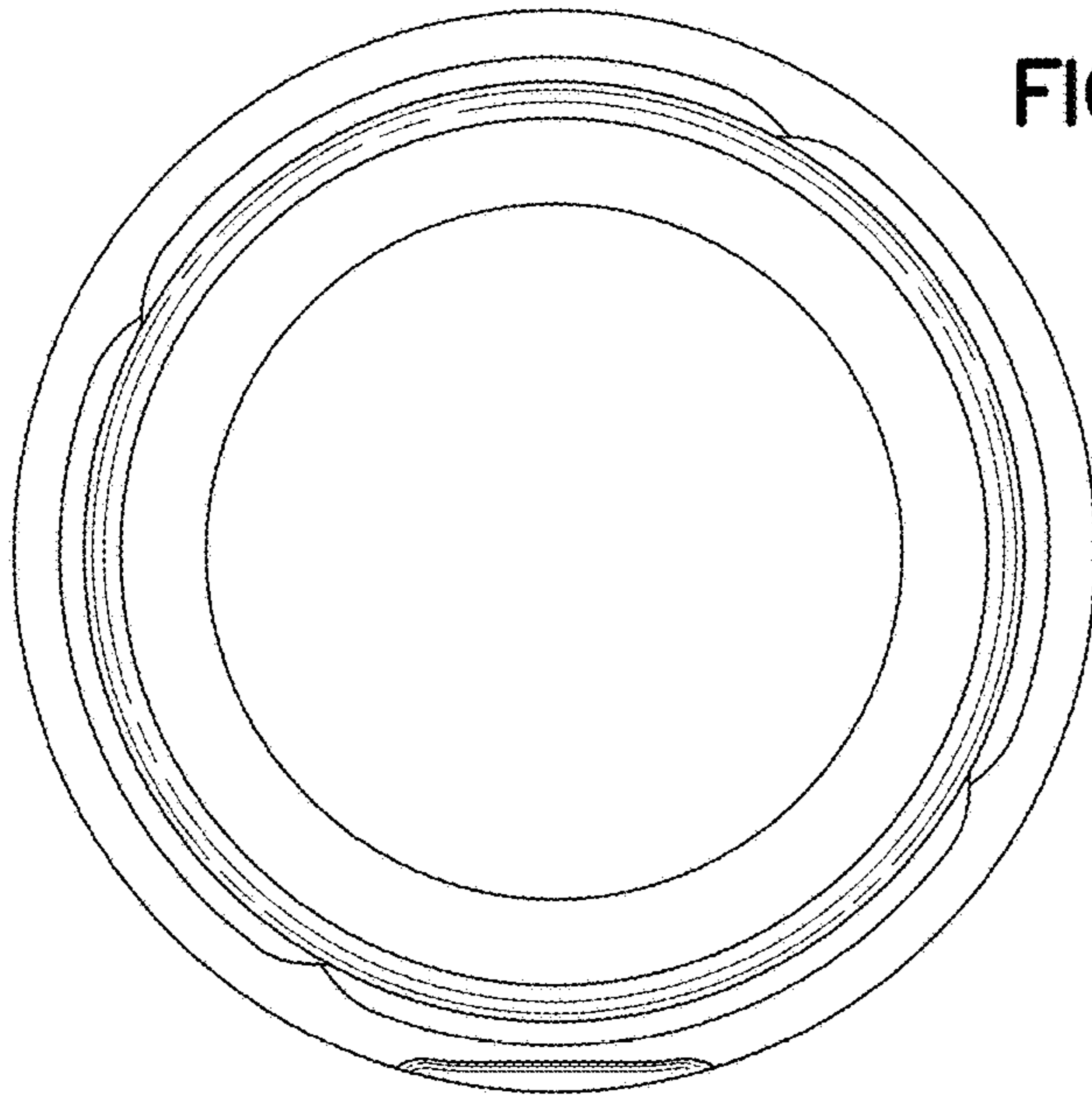

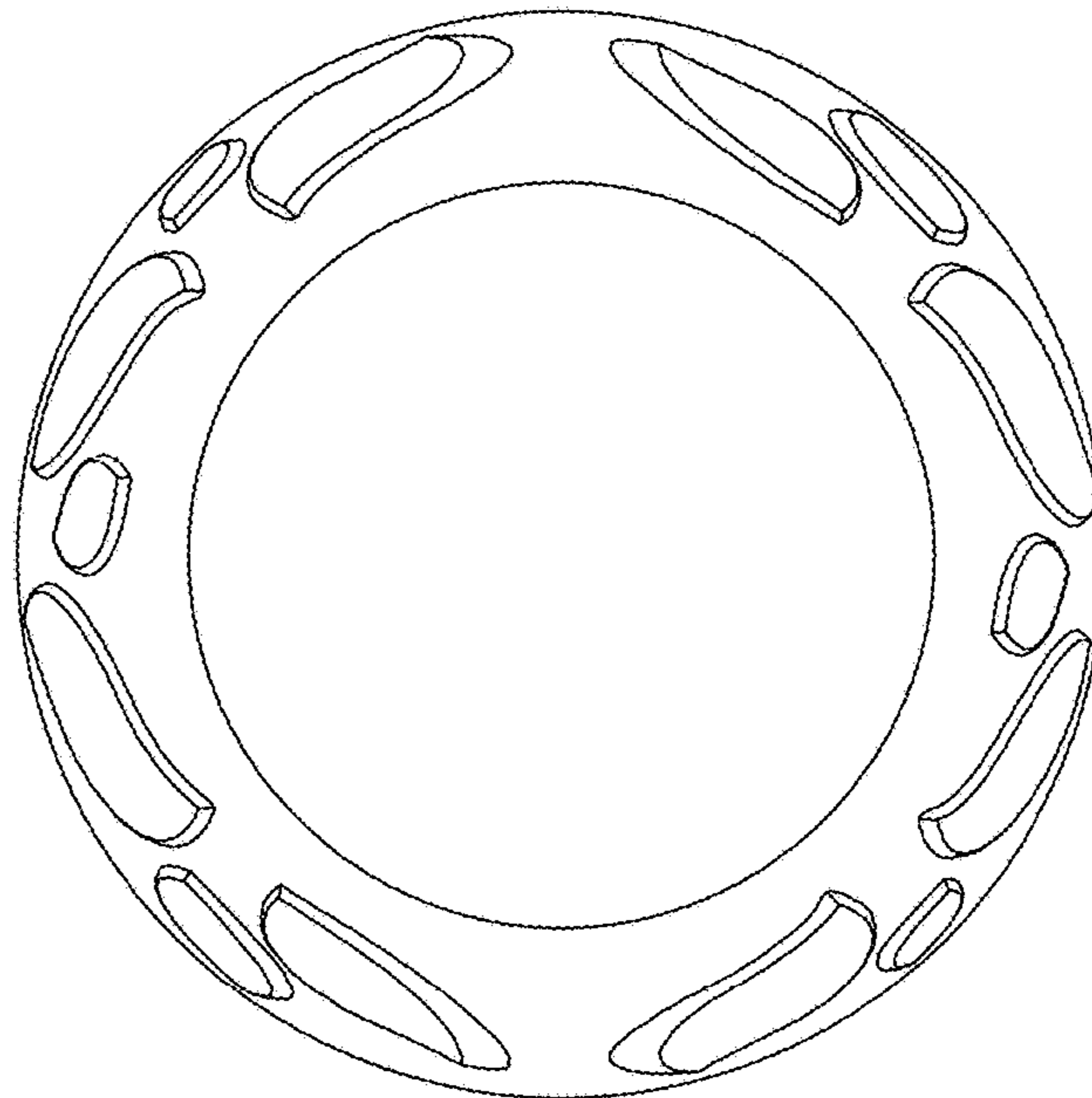

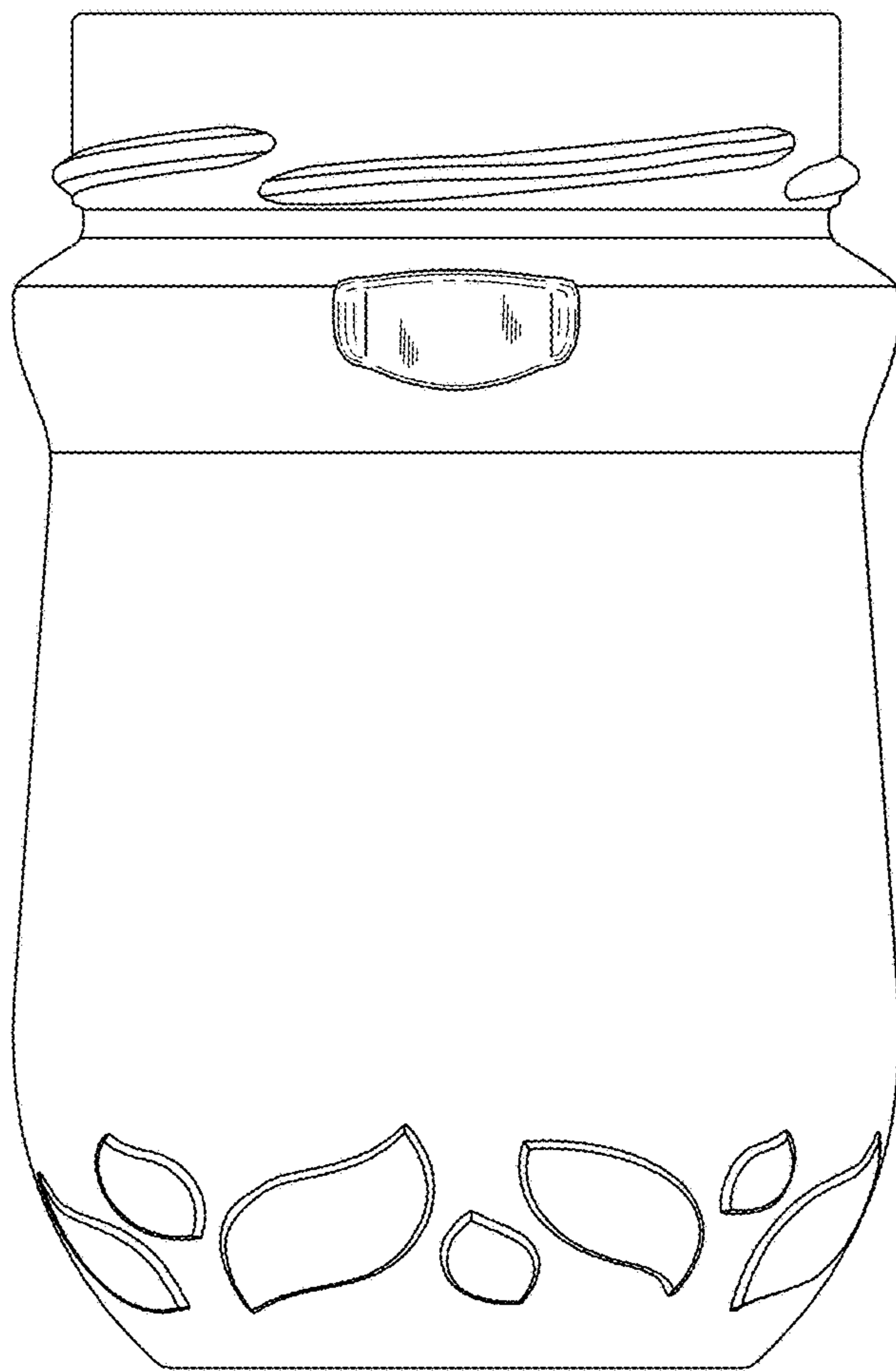

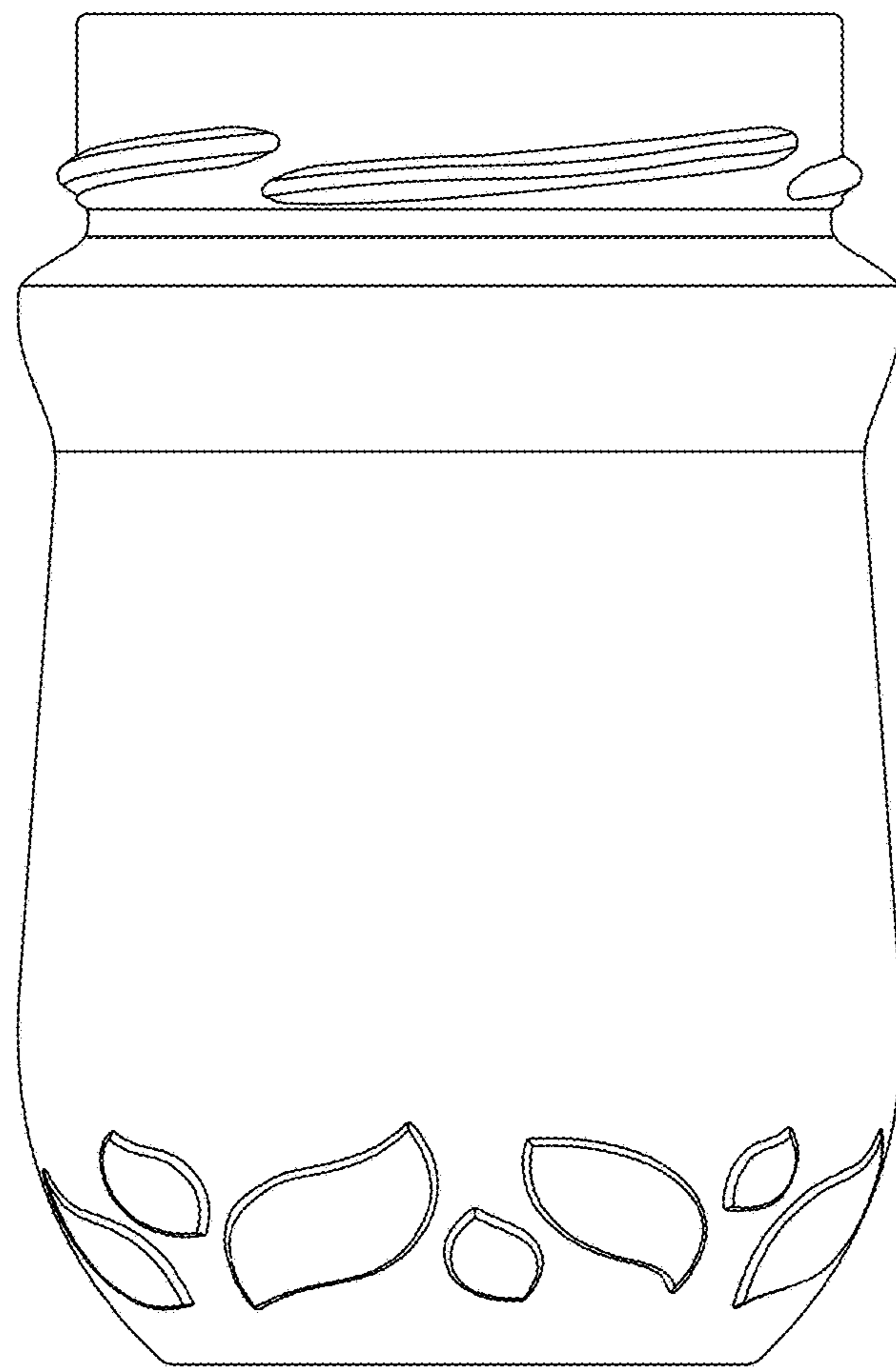

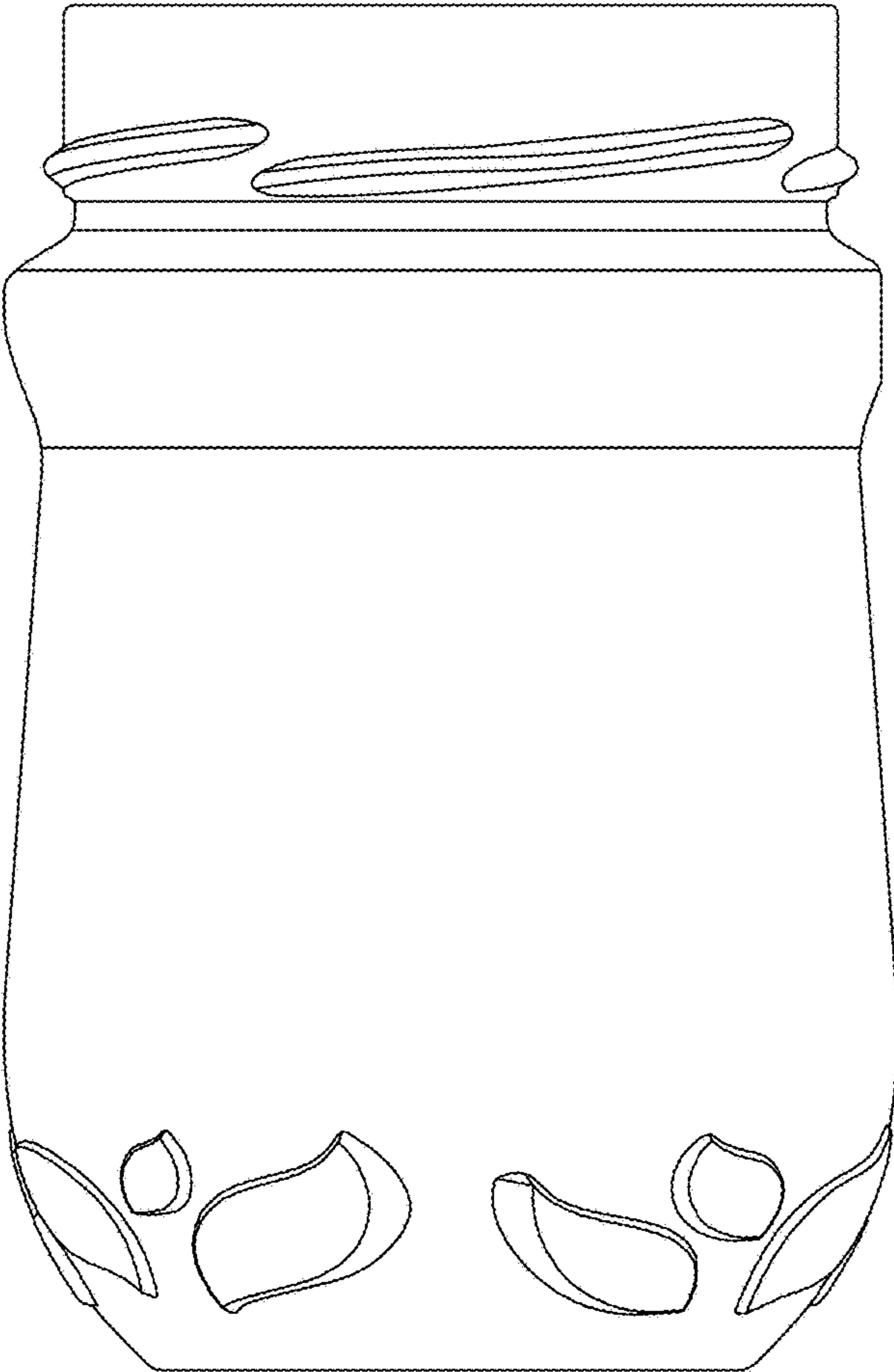
