DESCRIPTION

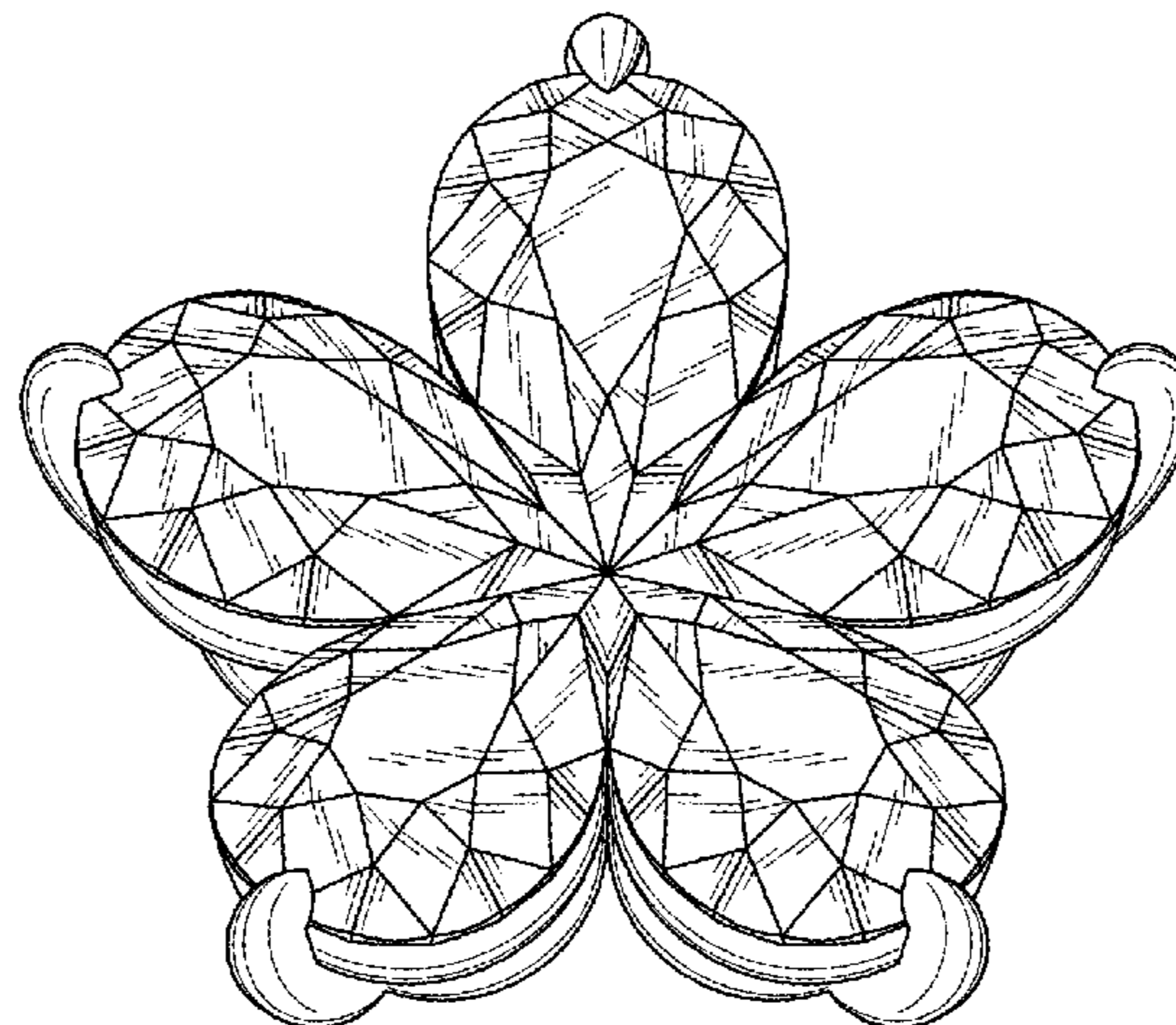
FIG. 1 is a perspective view of a jewelry setting showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is another perspective view showing the jewelry setting of FIG. 1 in an environment of use;
FIG. 9 is another perspective view showing the jewelry setting of FIG. 1 in an environment of use; and,
FIG. 10 is another perspective view showing the jewelry setting of FIG. 1 in an environment of use.
The broken lines in FIG. 3 illustrate portions of the jewelry setting that form no part of the claimed design. The other broken lines FIGS. 8 through 10 depicting a ring, an earring cap and a pendant buckle merely represent environmental subject matter only and form no part of the claimed design.

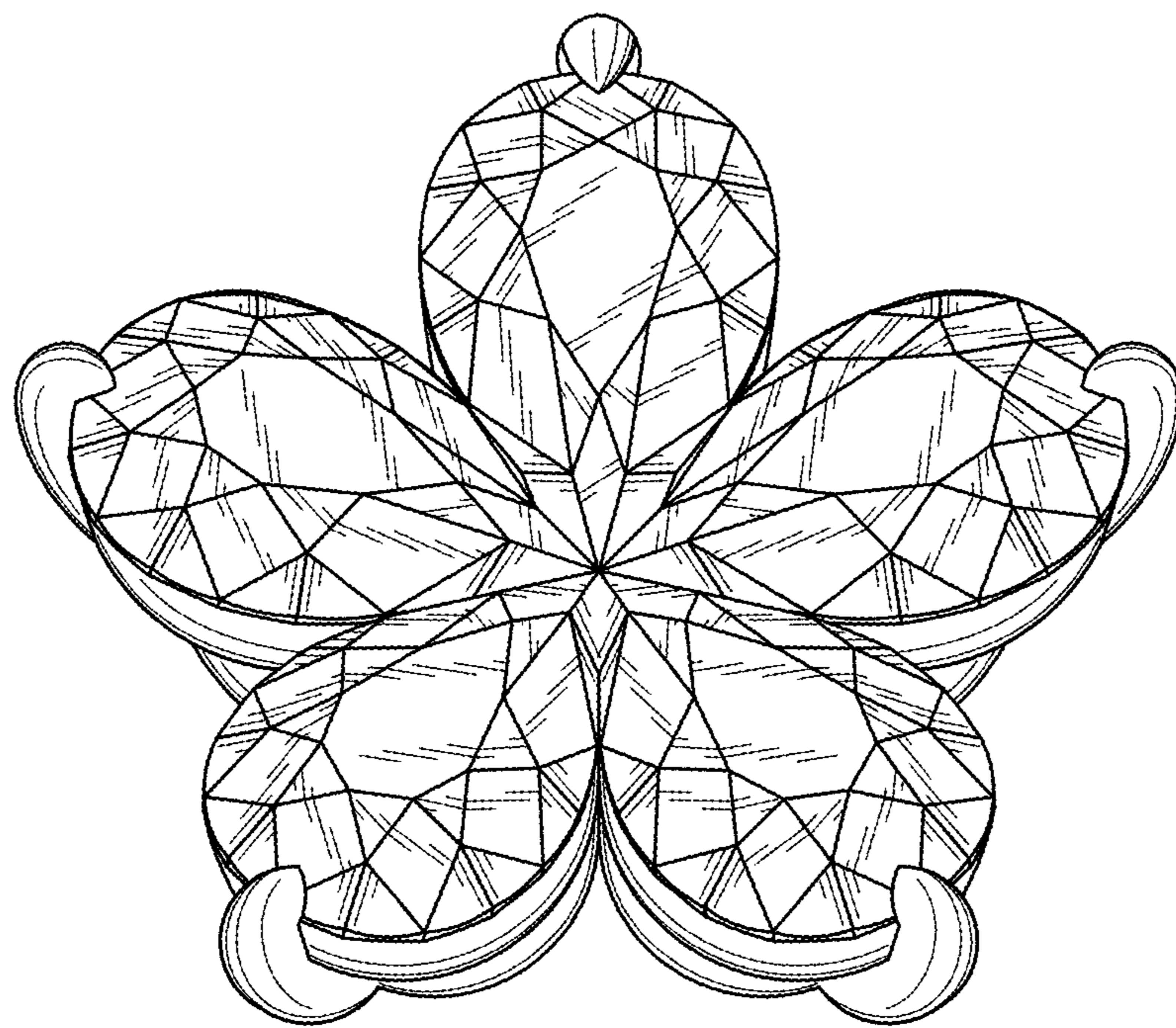

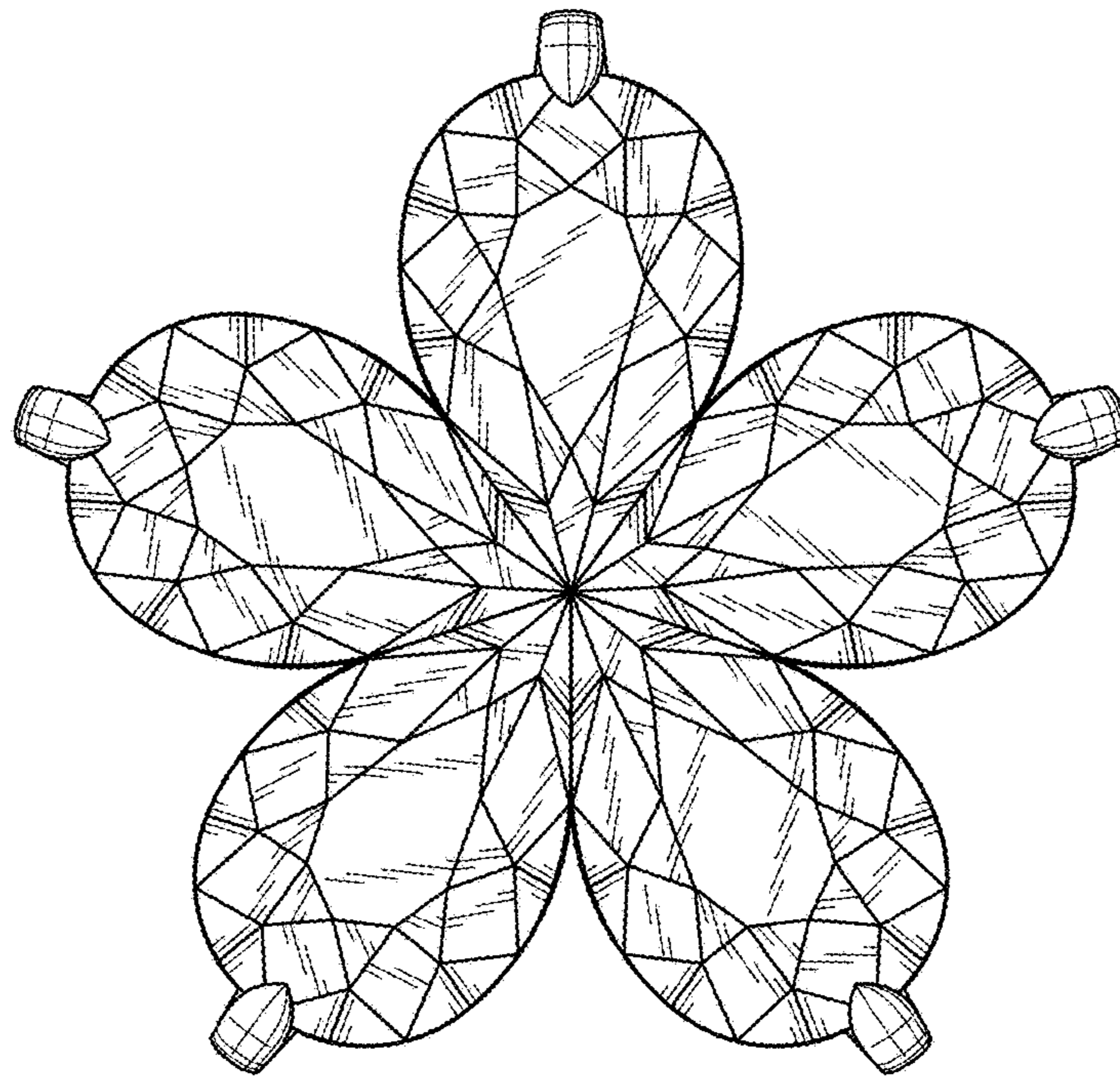

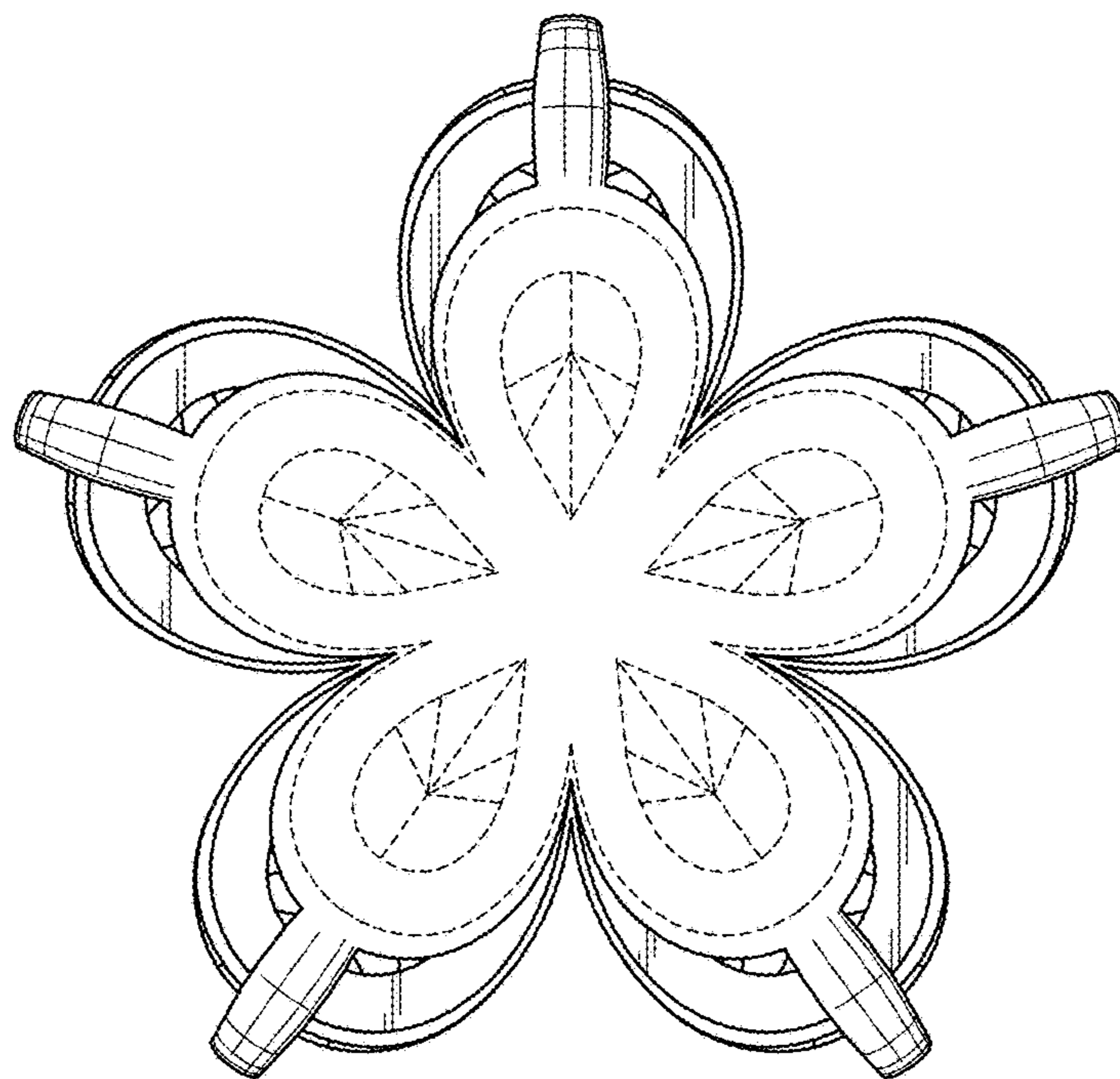

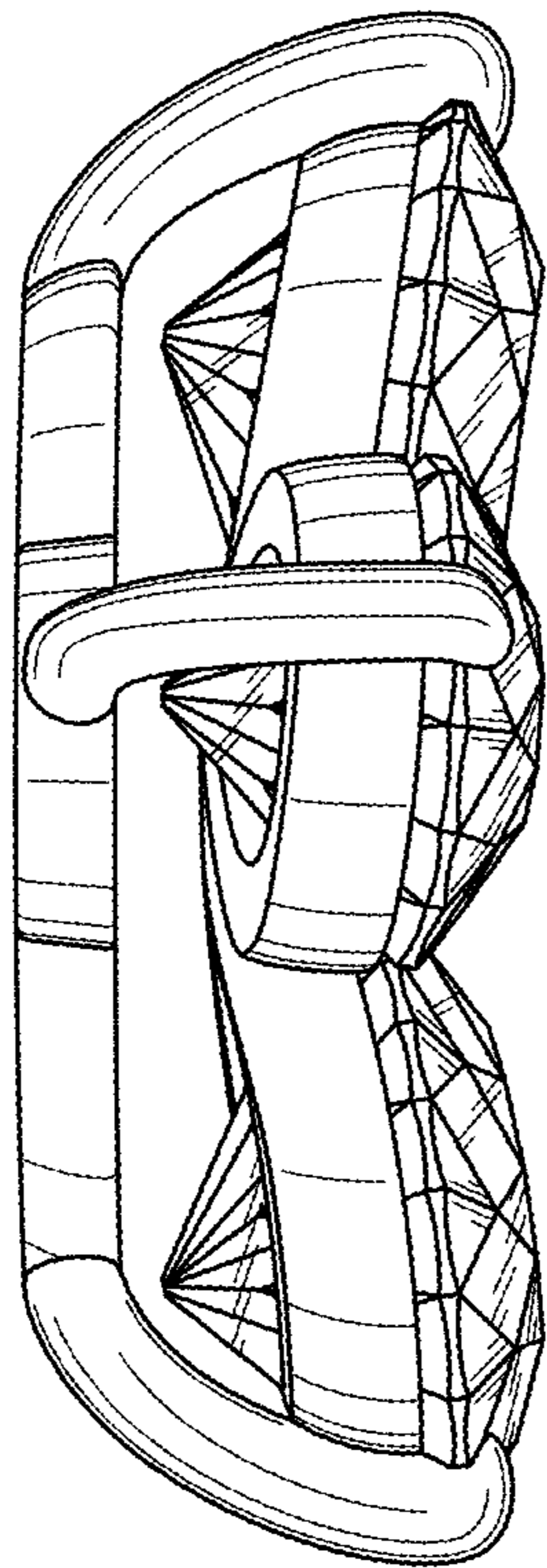

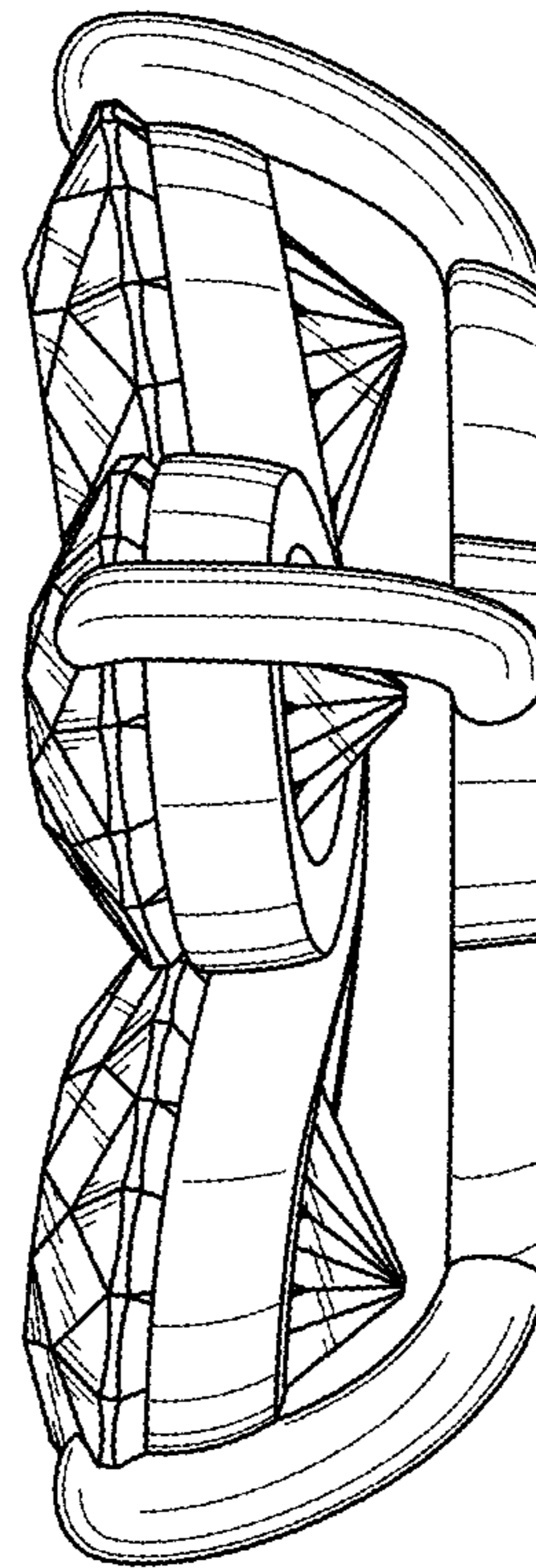

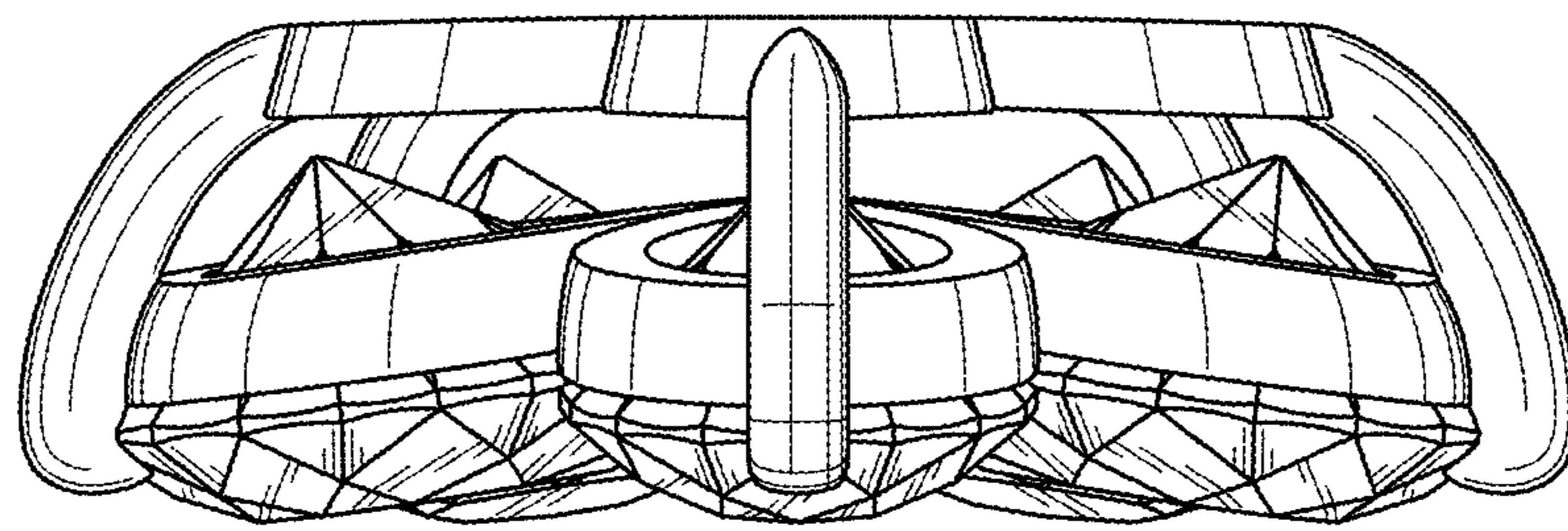

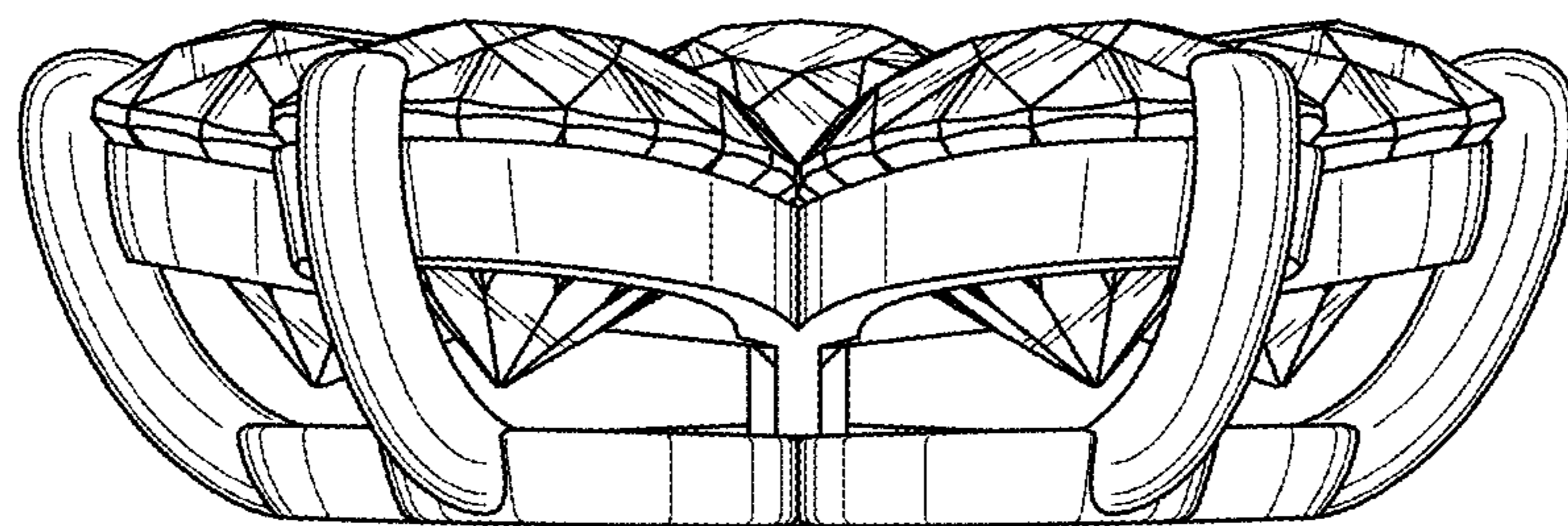

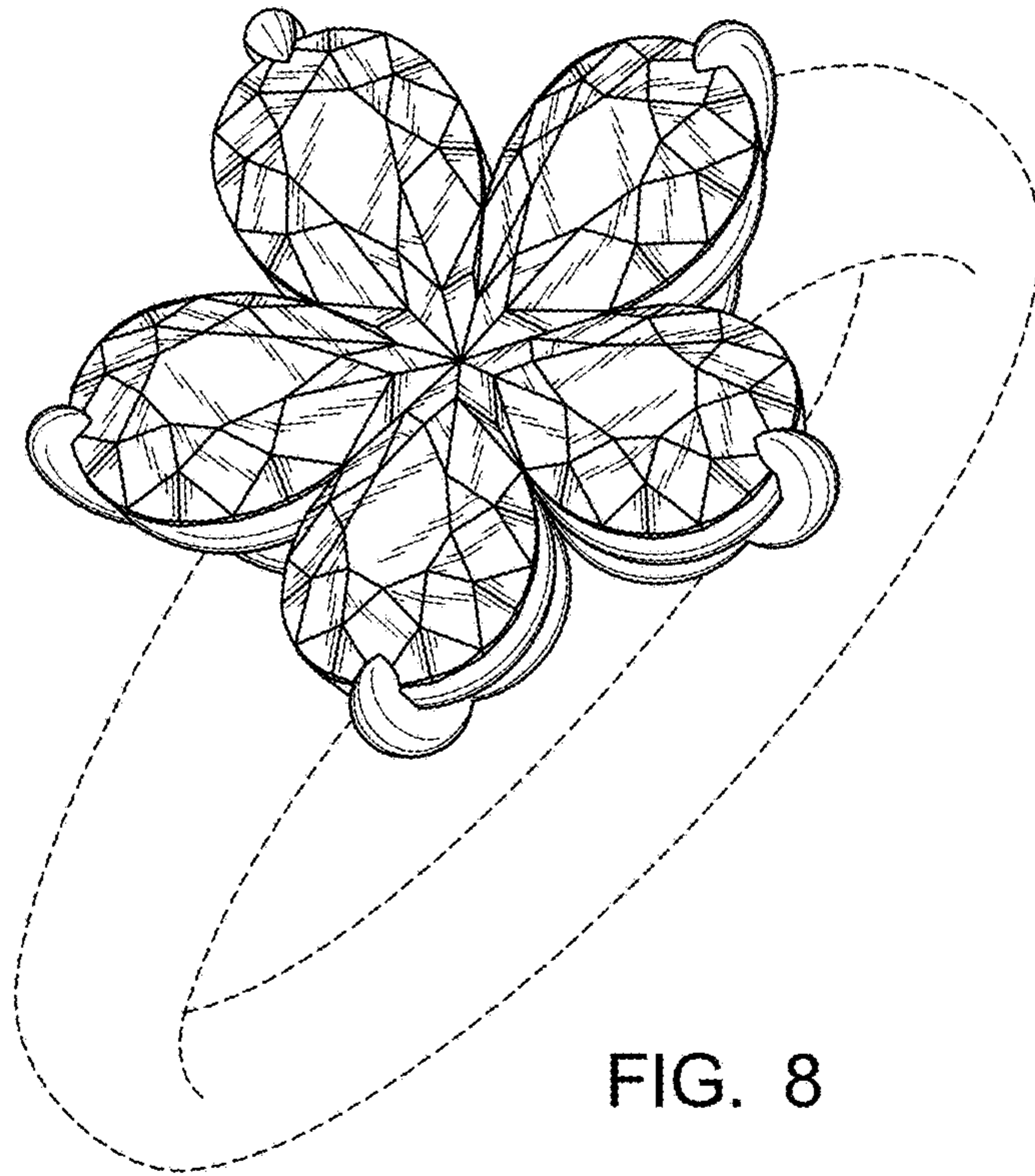

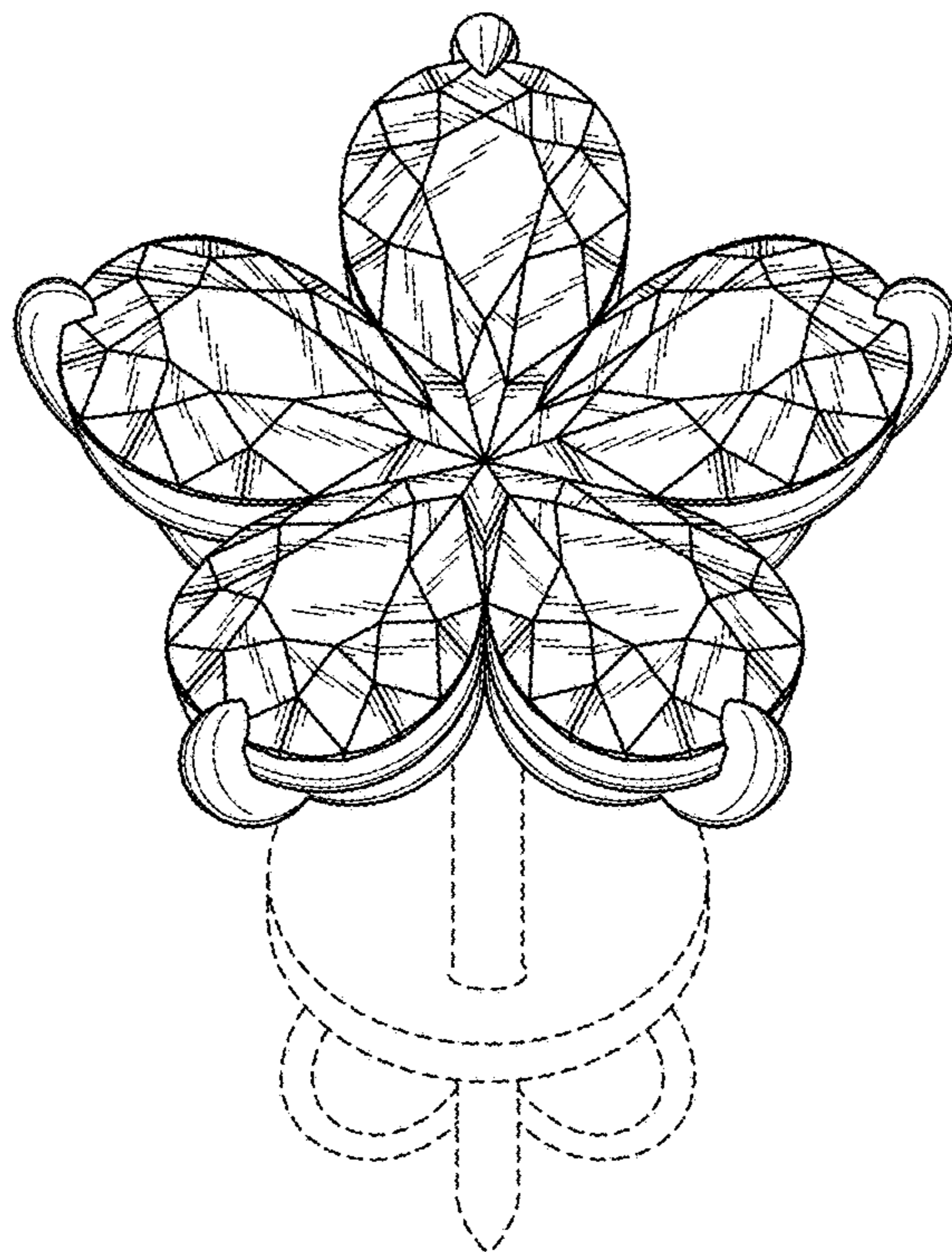

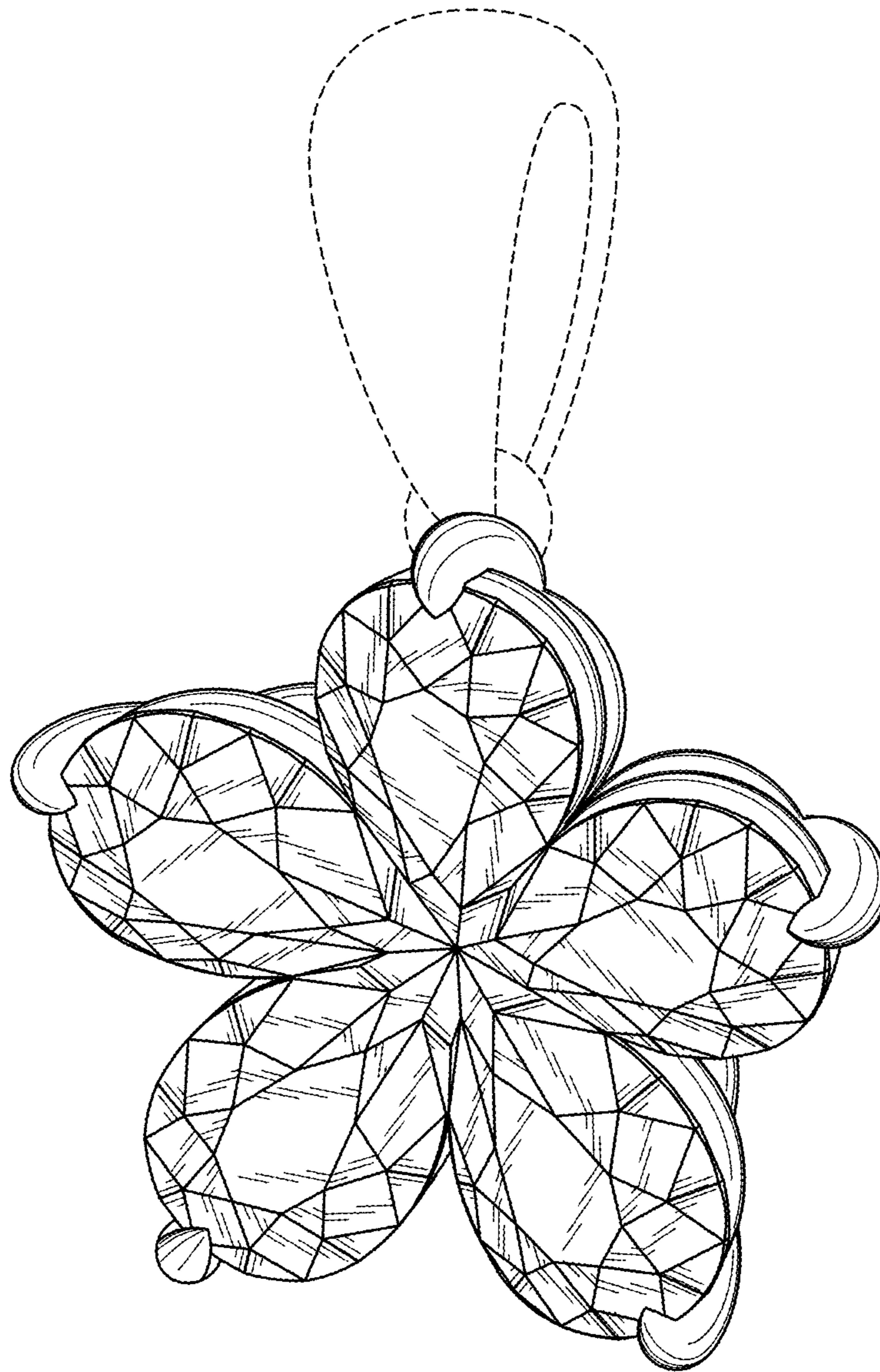
