The broken lines in the drawings depict portions of the mobile showroom advertising system that form no part of the claimed design.

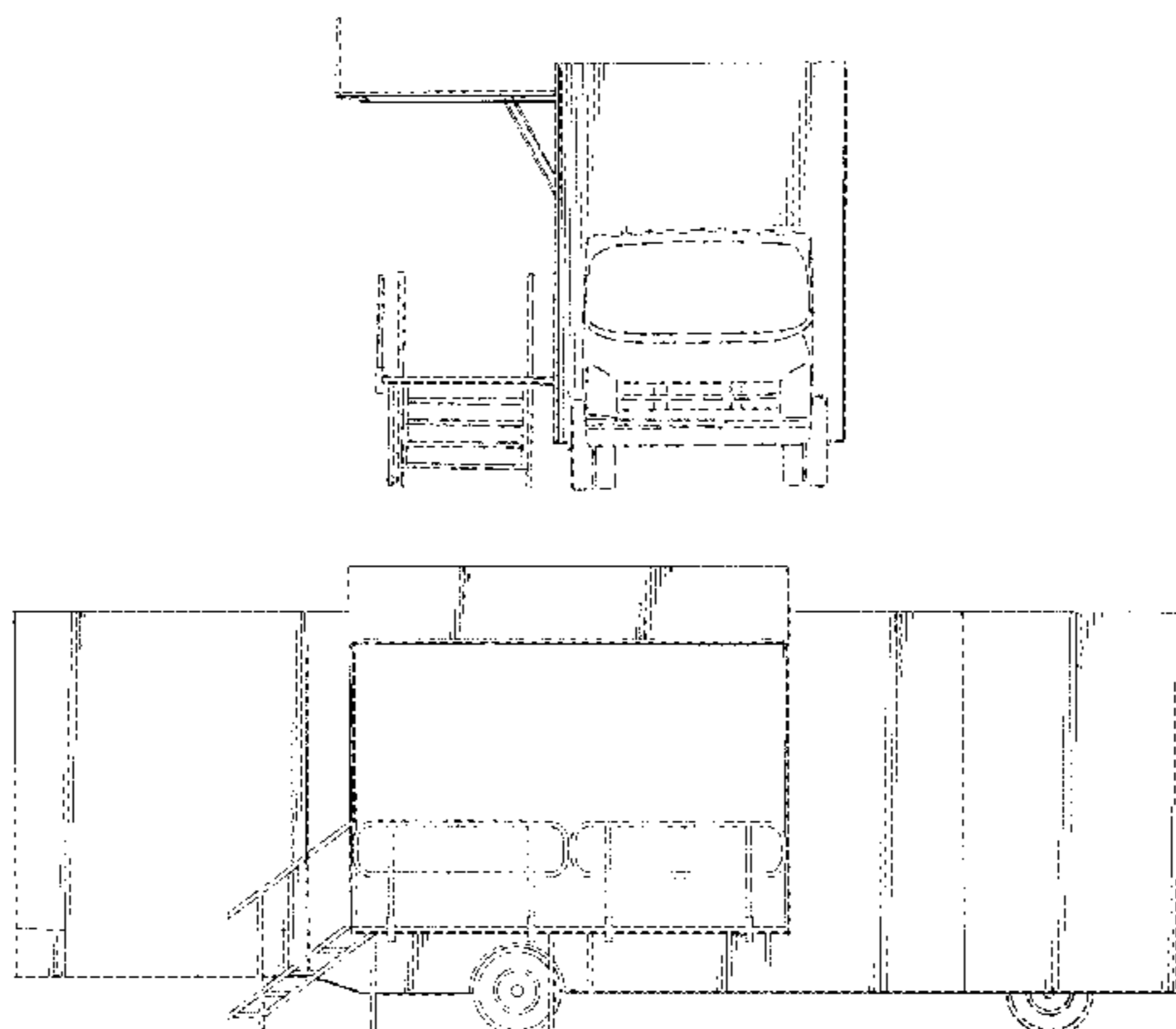

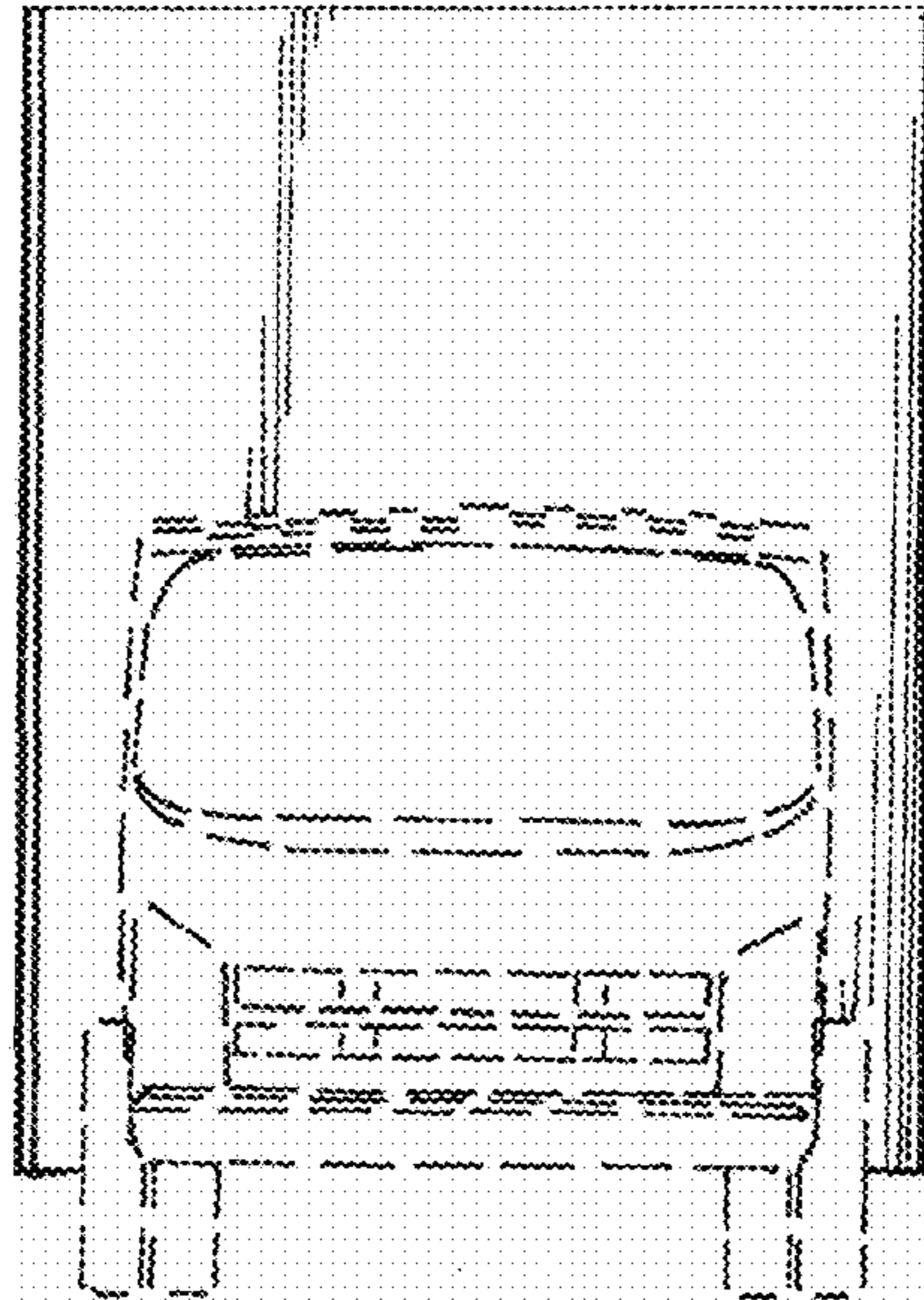

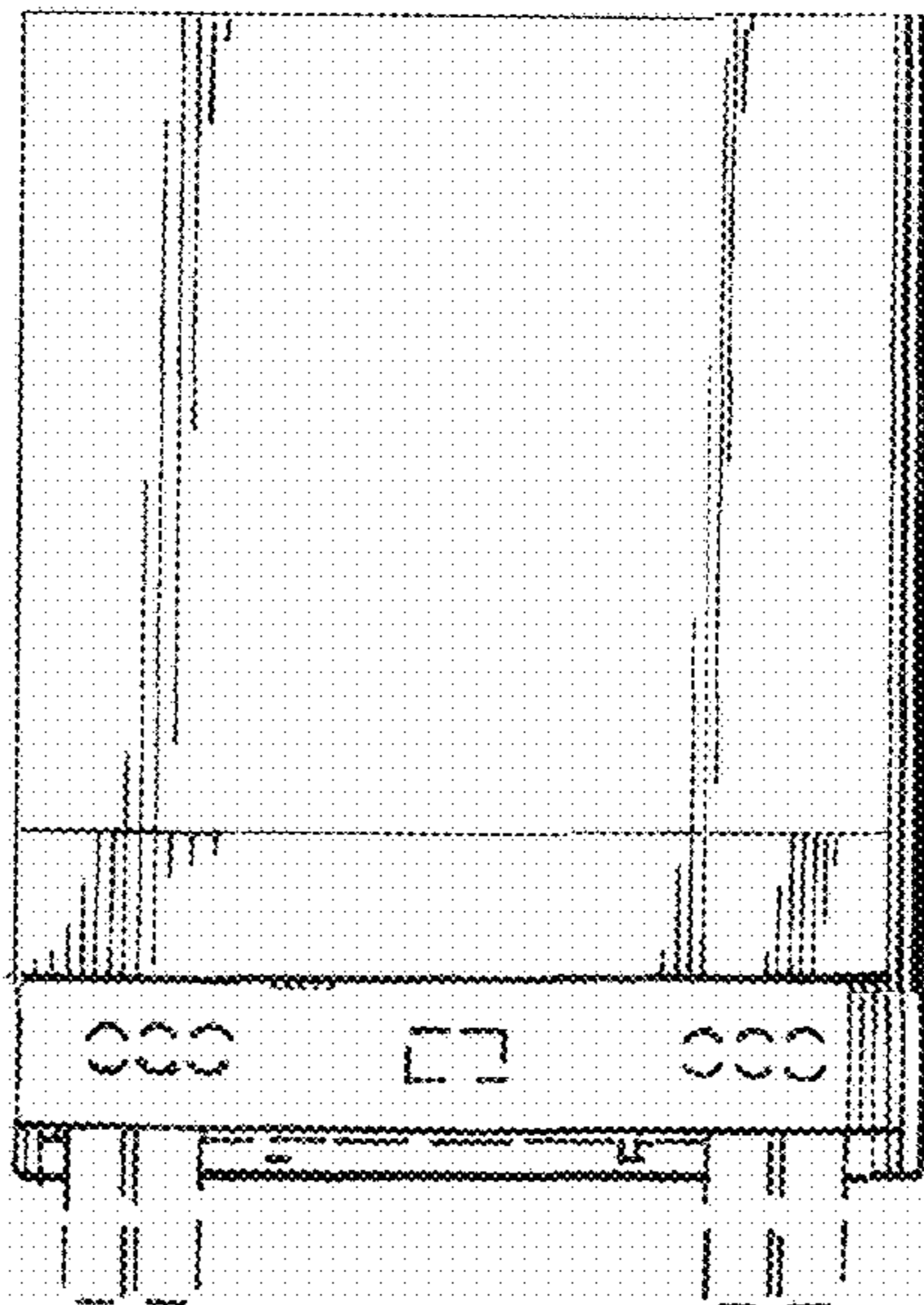

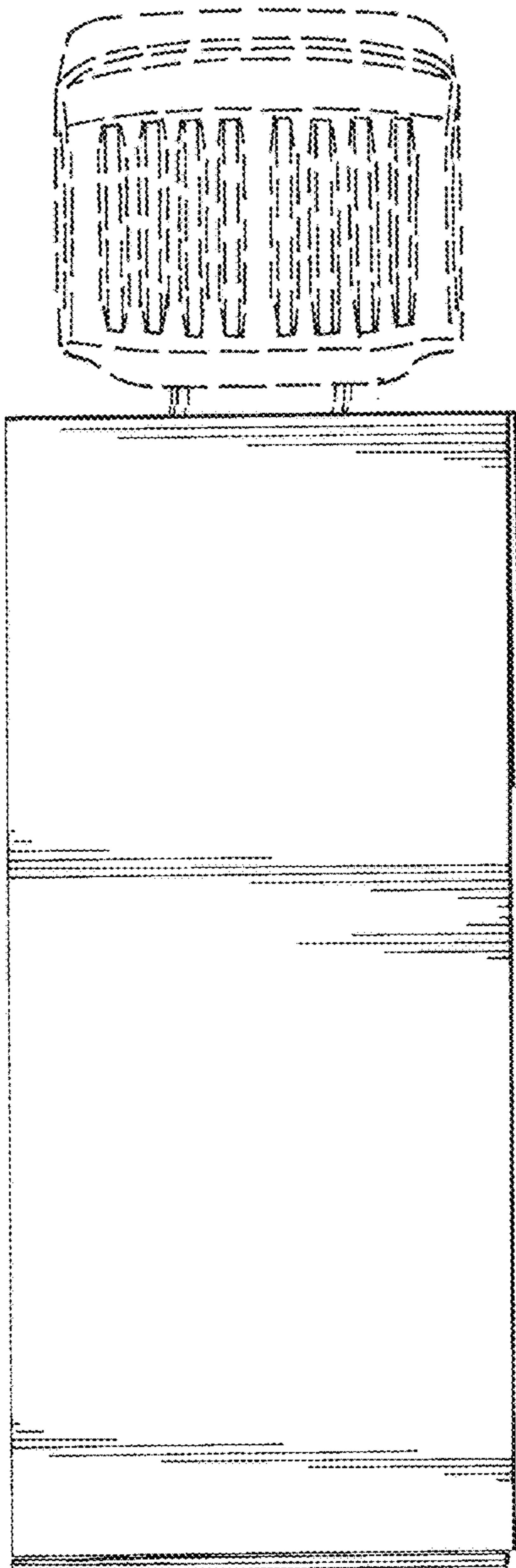
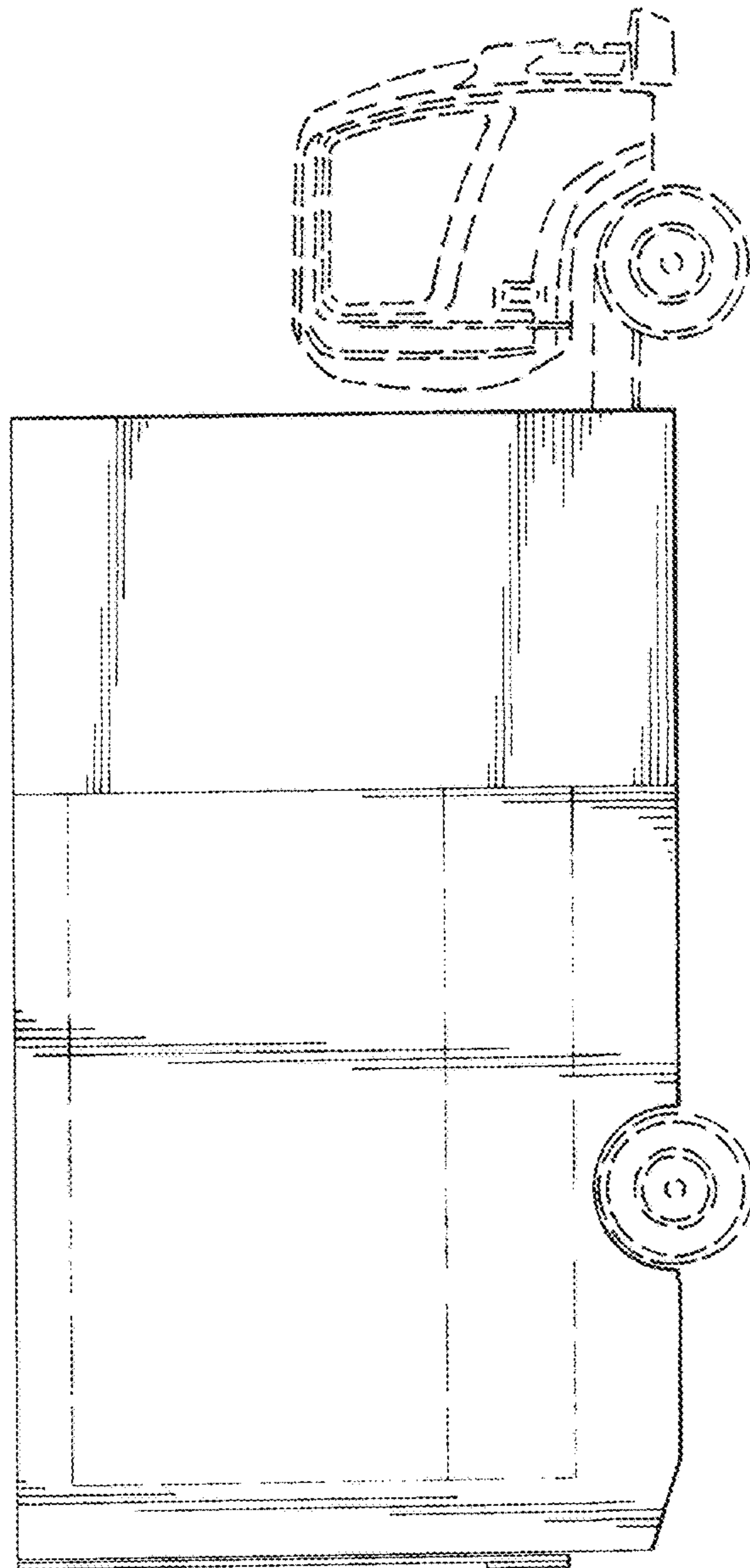

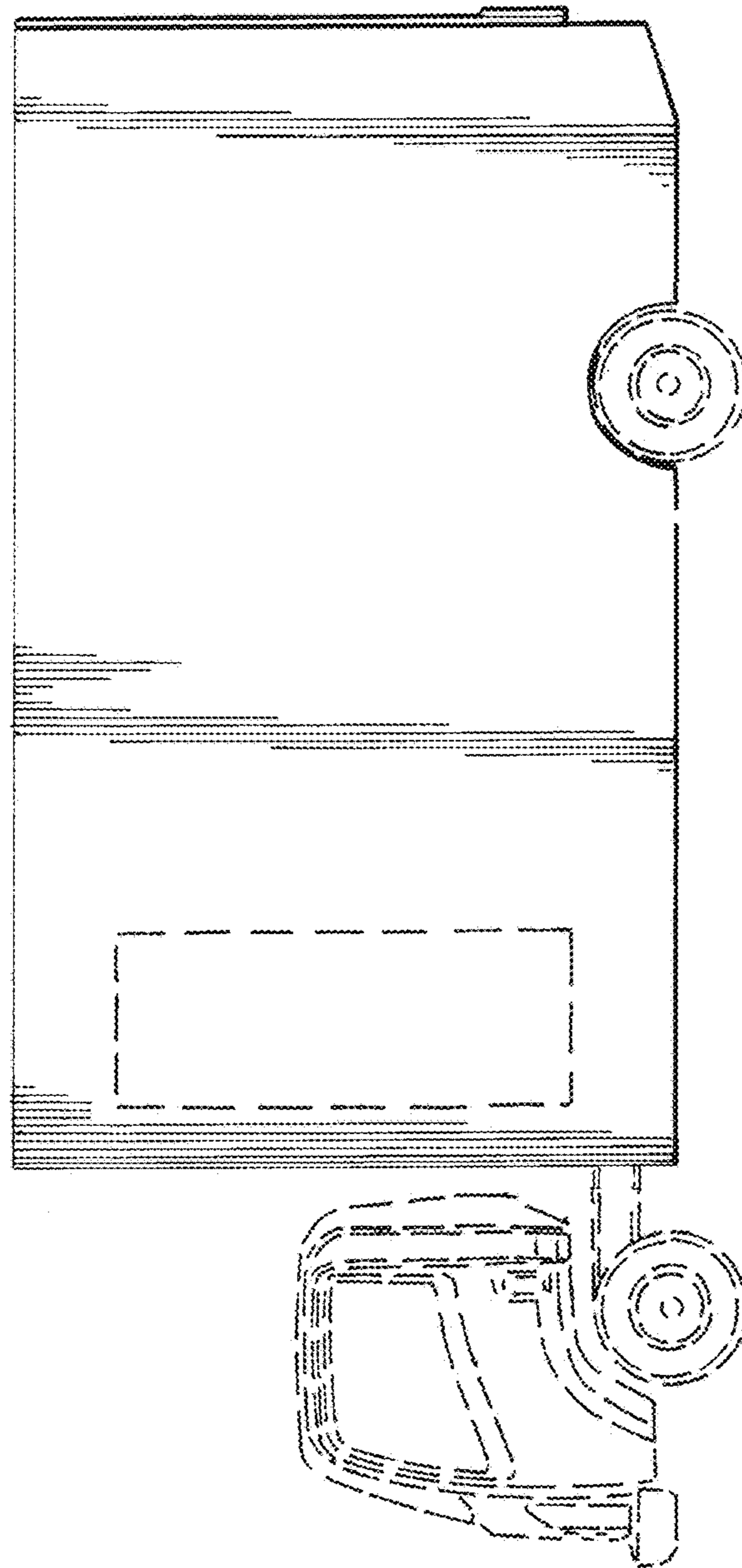

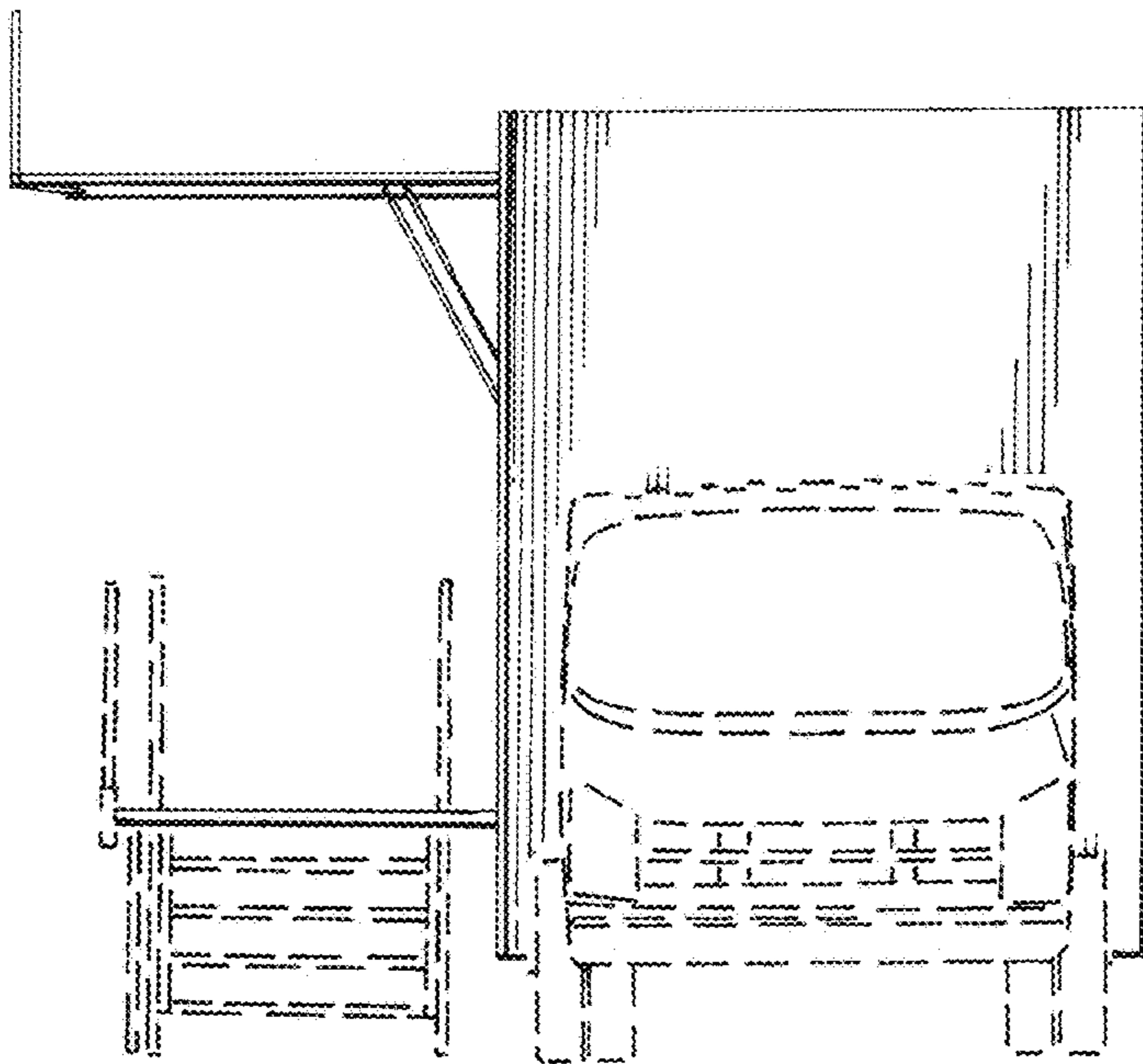
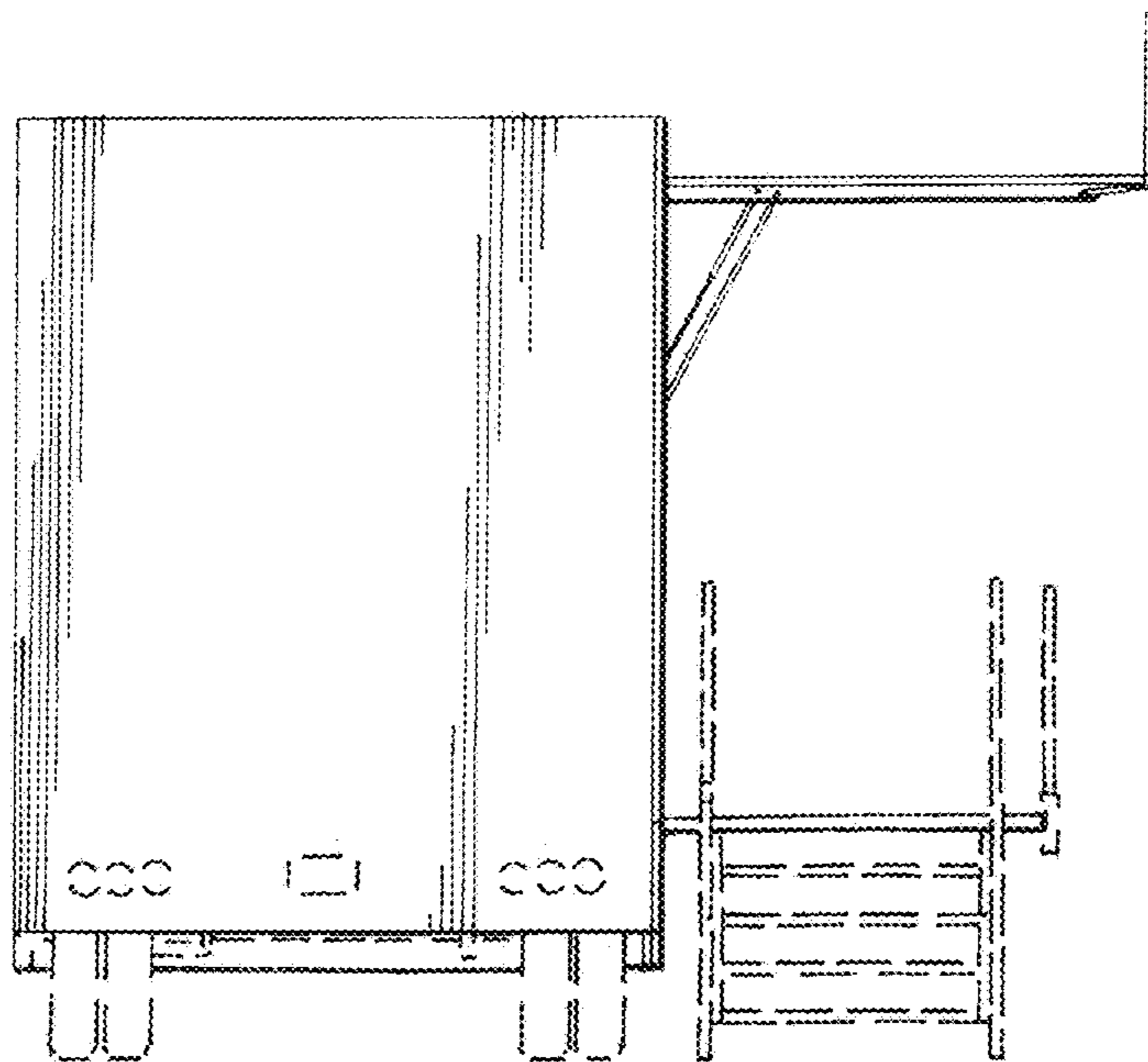

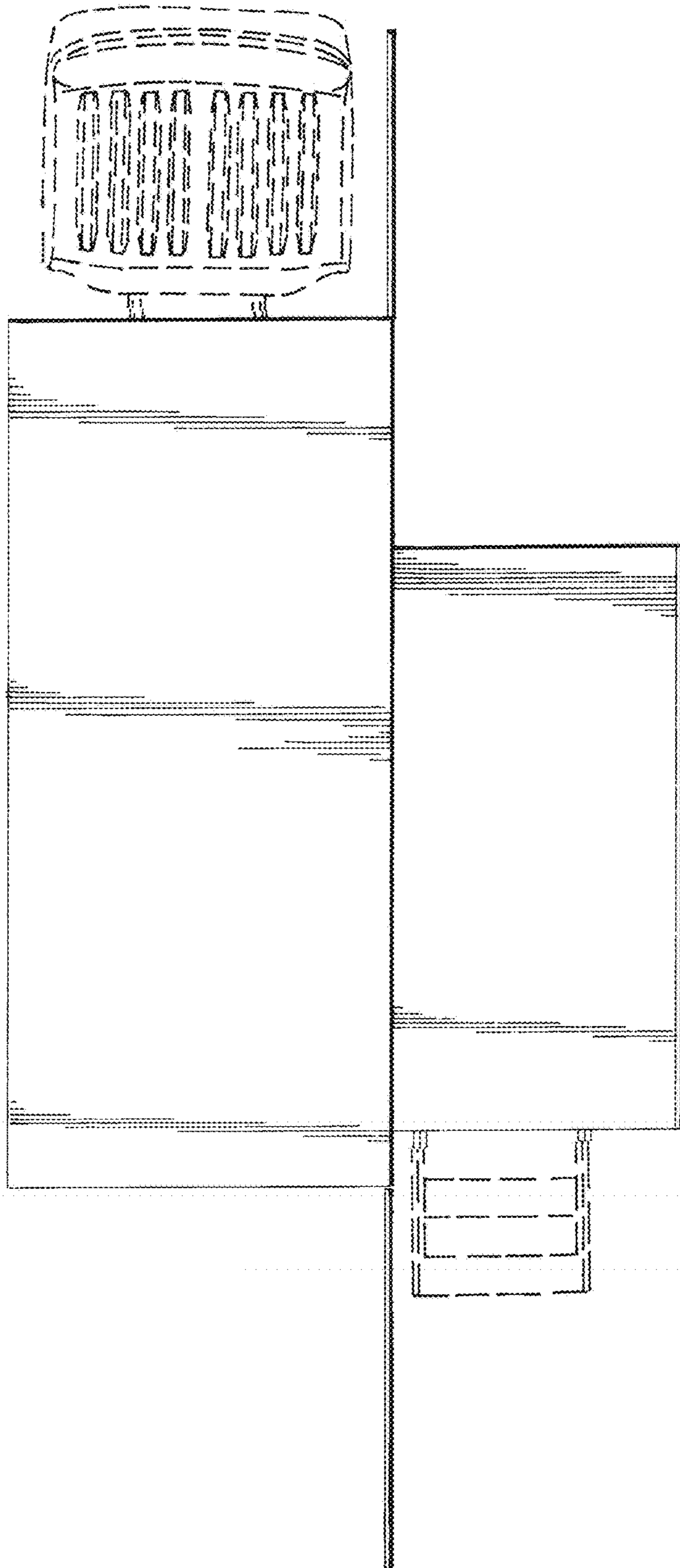

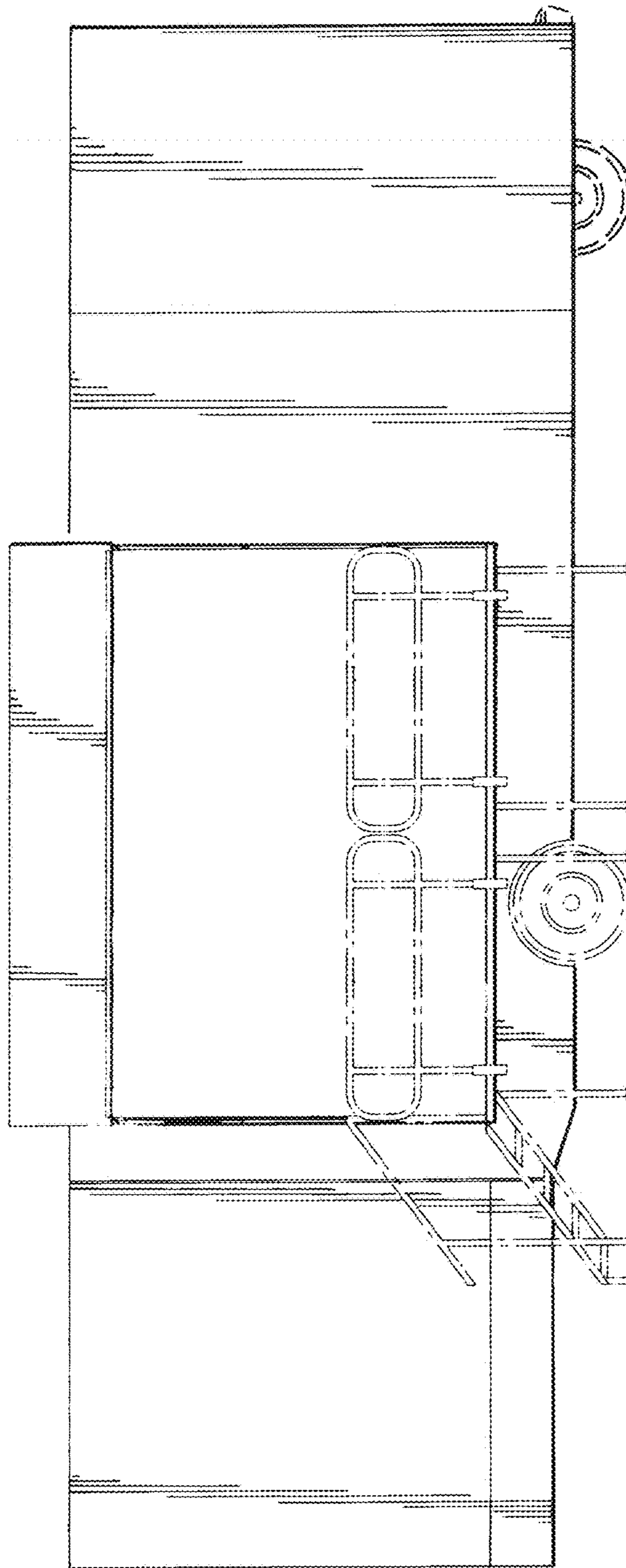

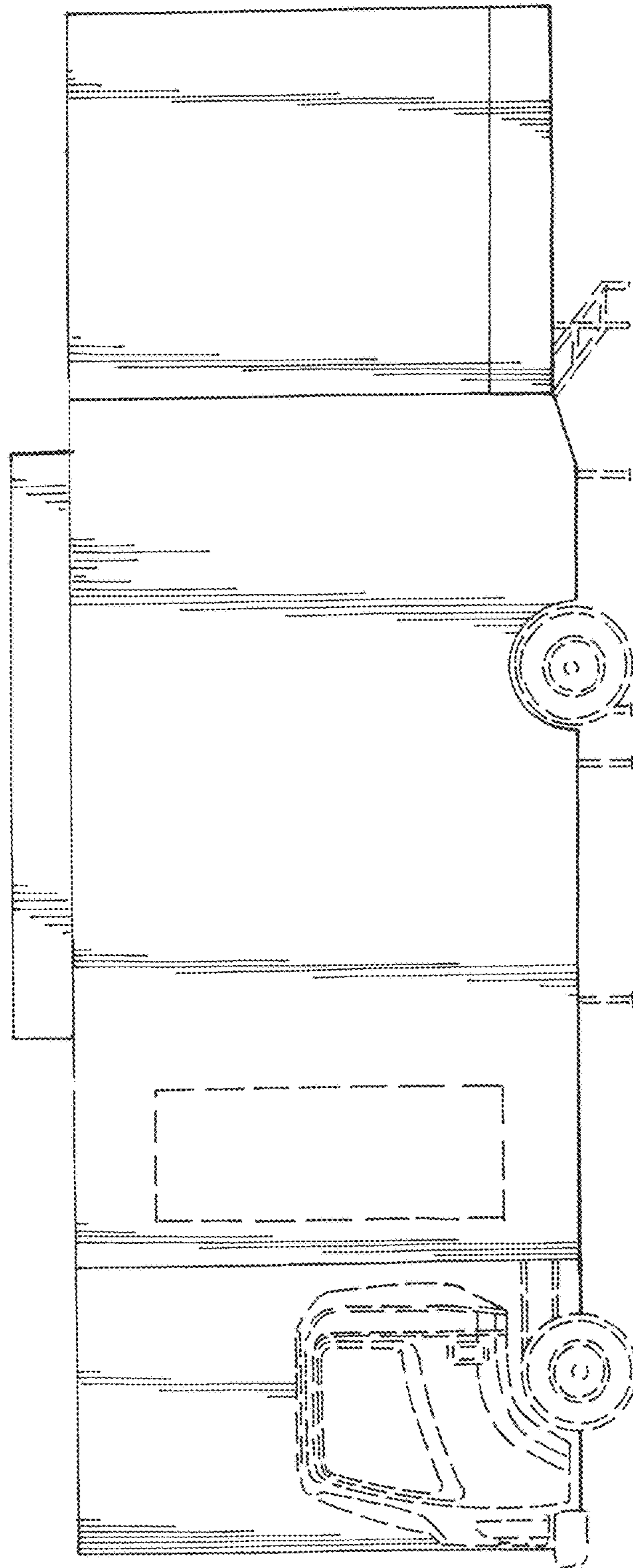
