The ornamental design for a handlebar for cycles or motorcycles, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear, and right side perspective view of a handlebar for cycles or motorcycles showing our new design;

FIG. 4 is a left side elevation view thereof;

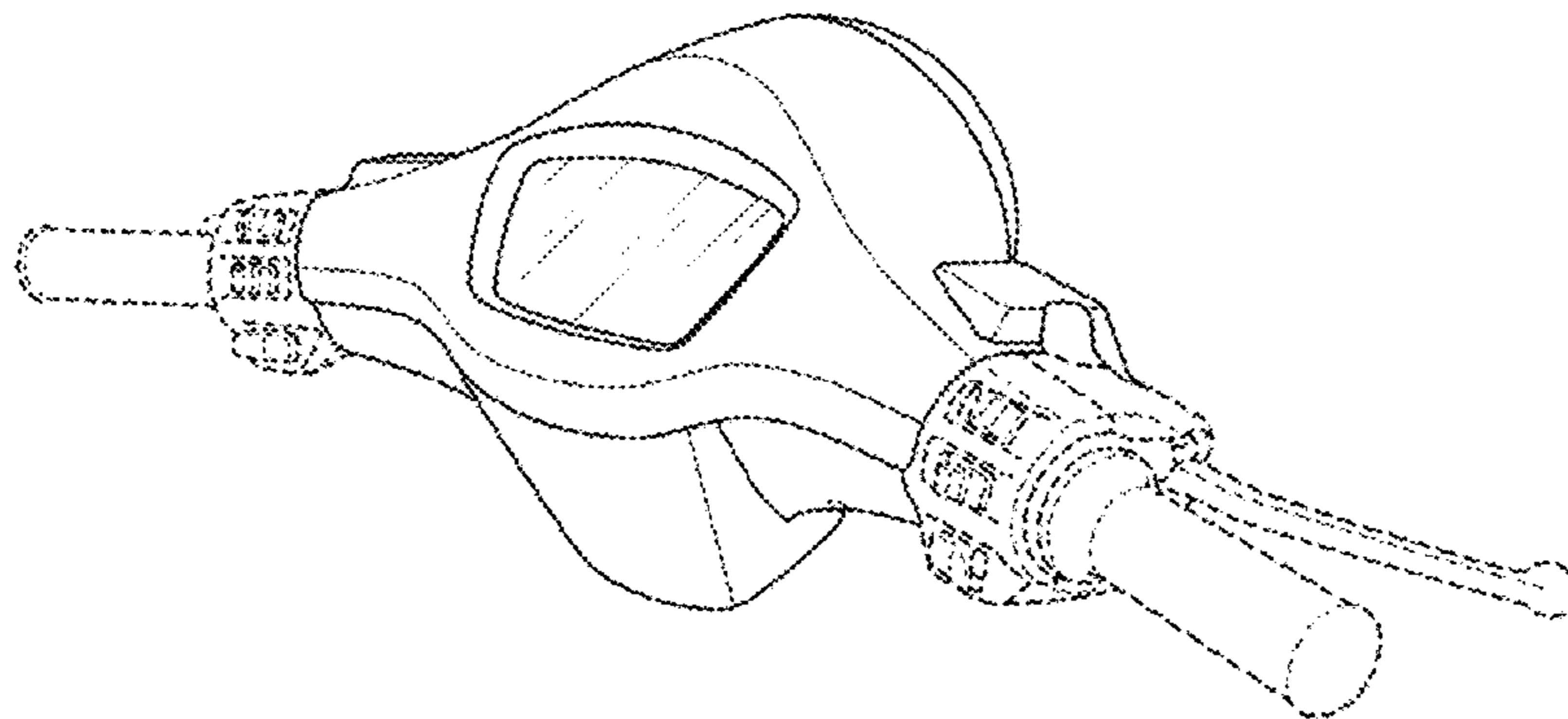
FIG. 5 is a right side elevation view thereof;

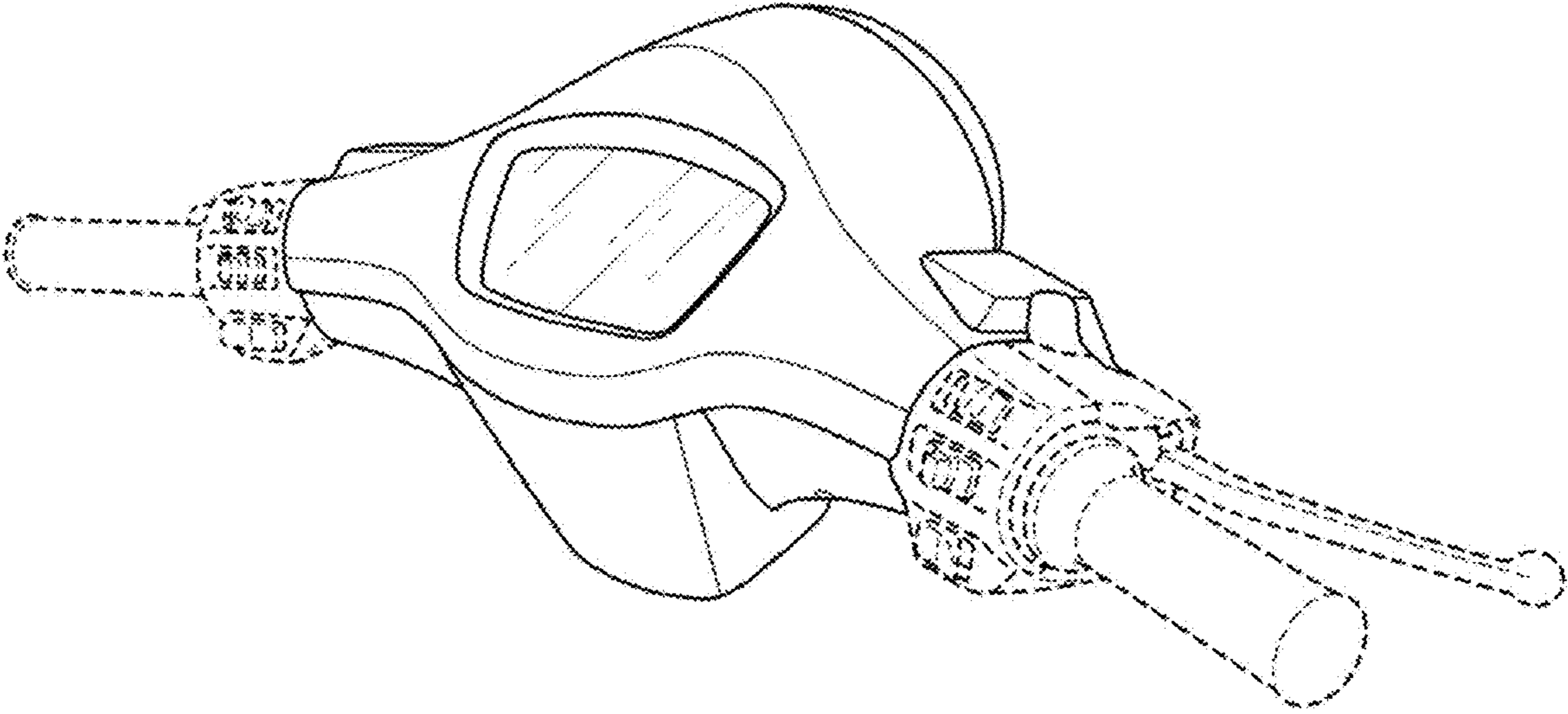

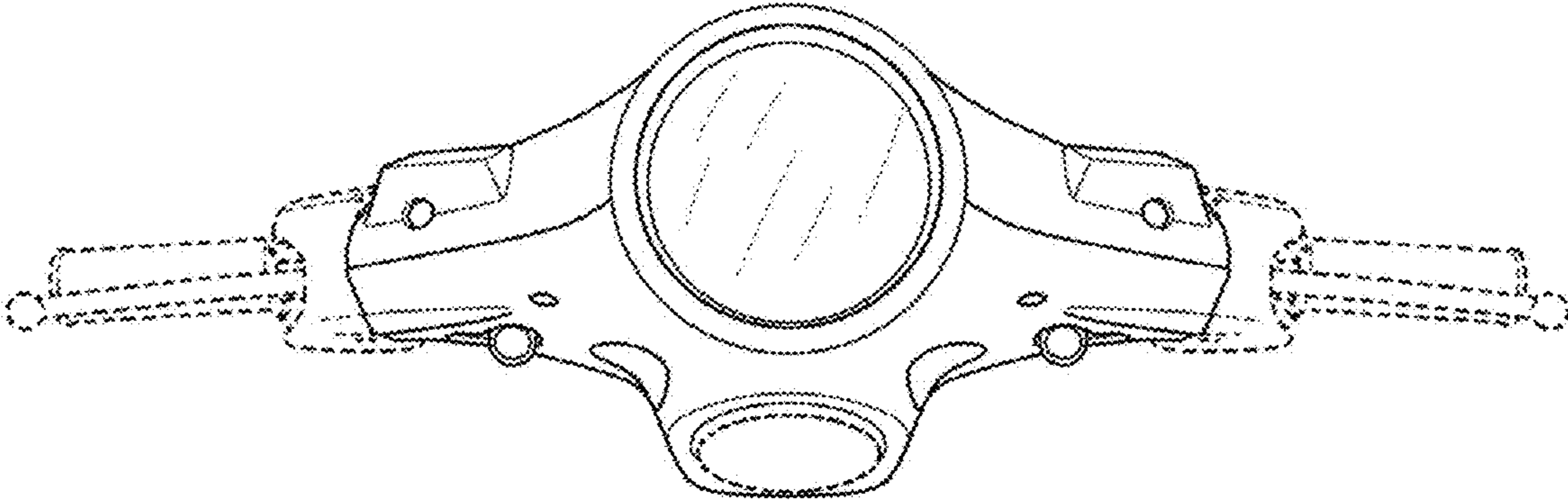

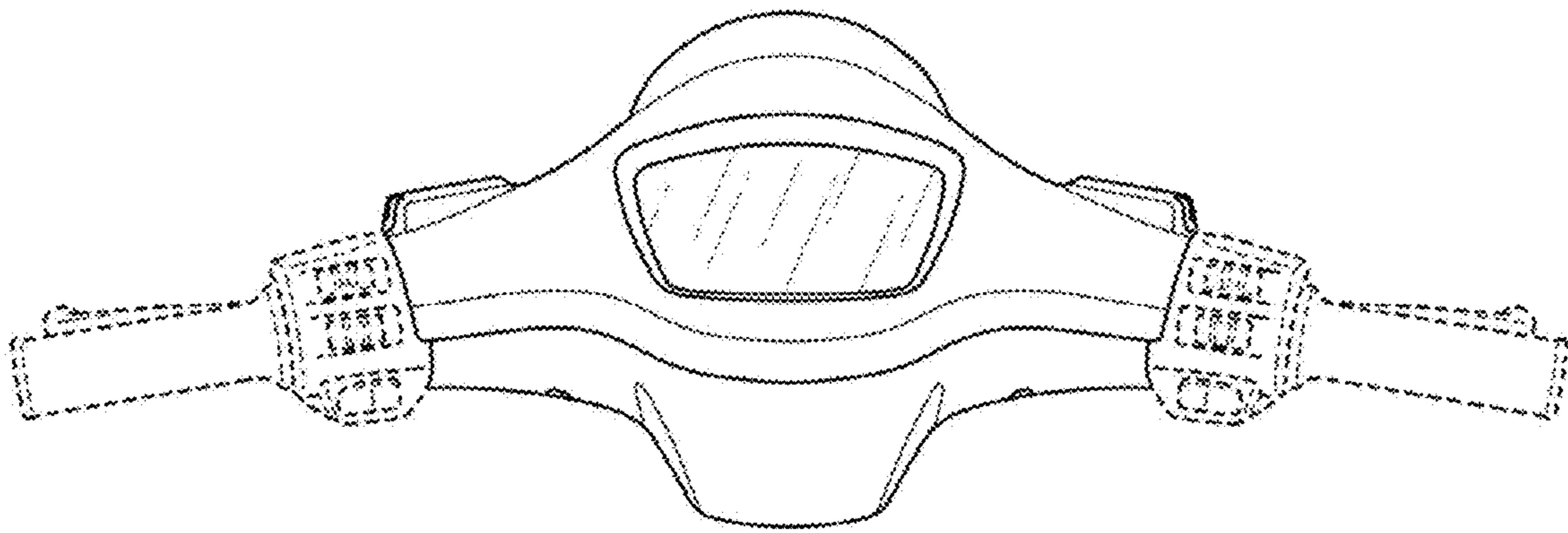

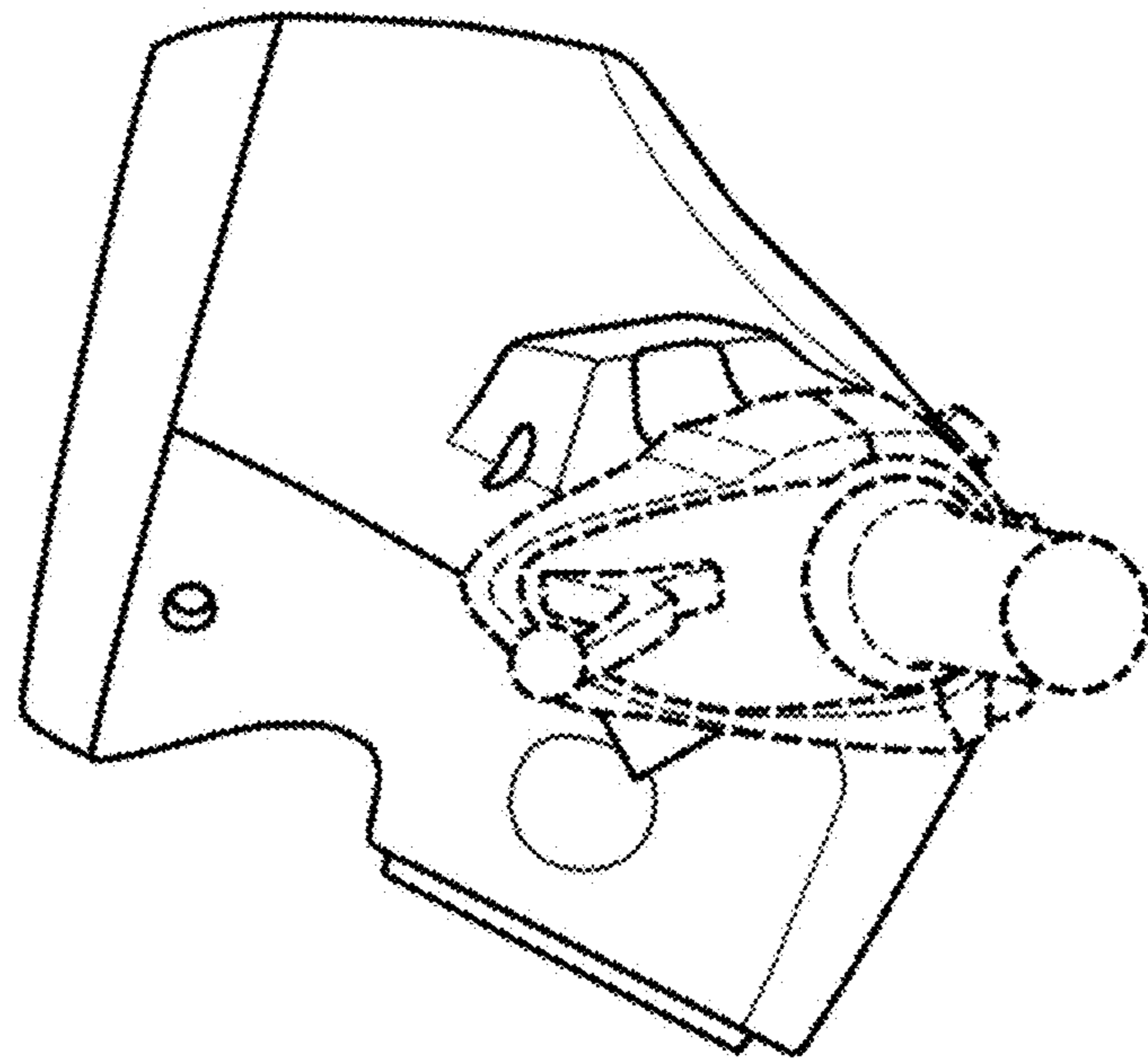

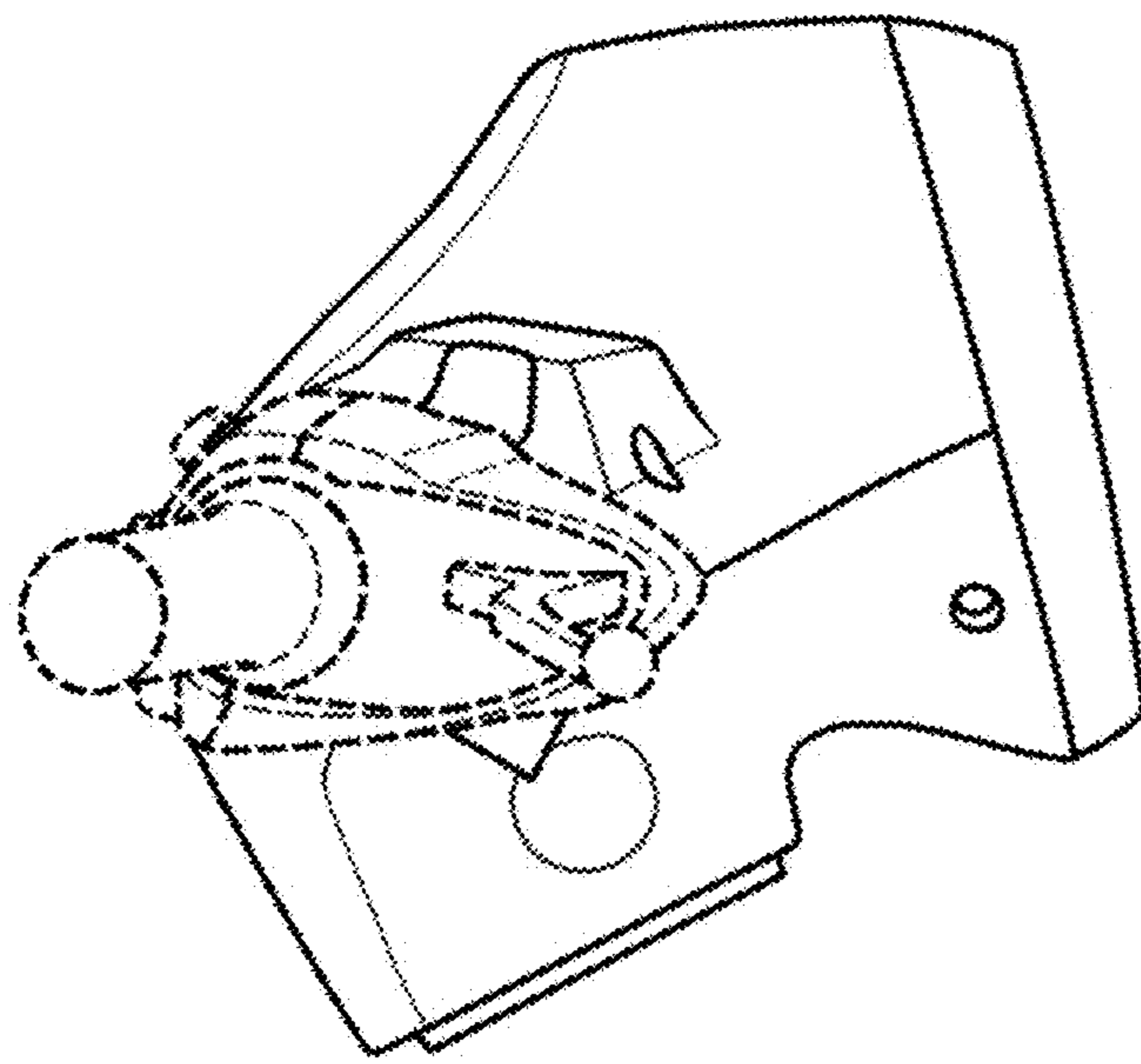

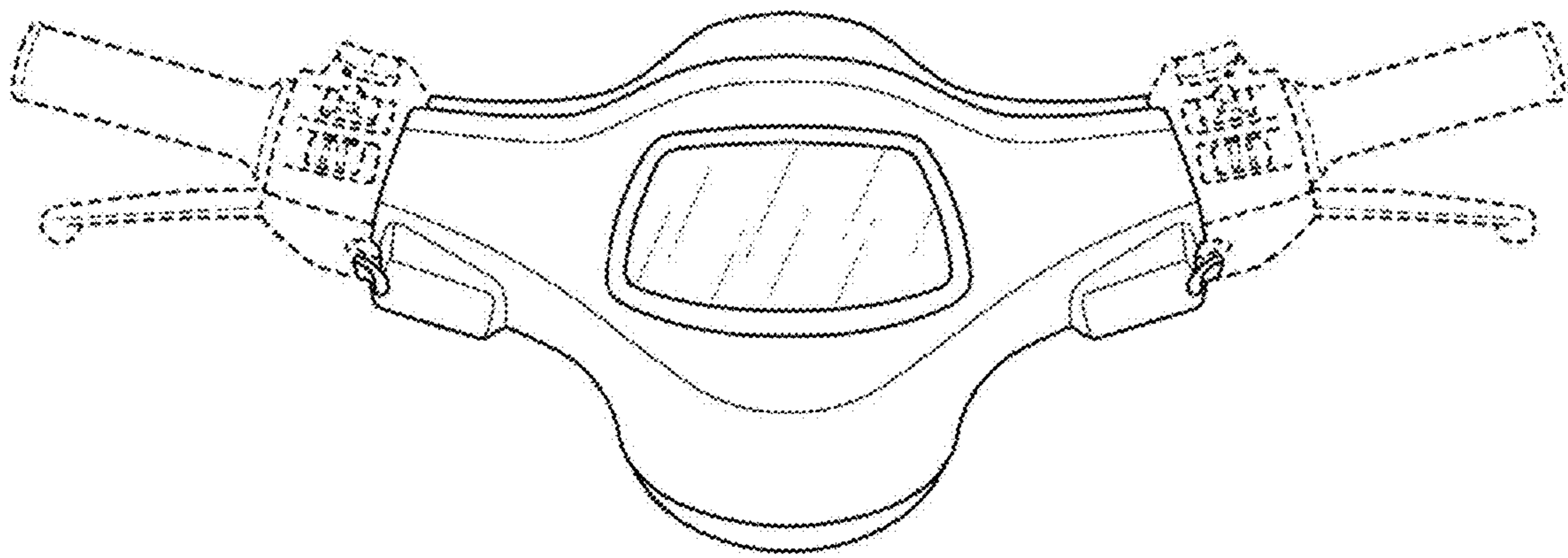

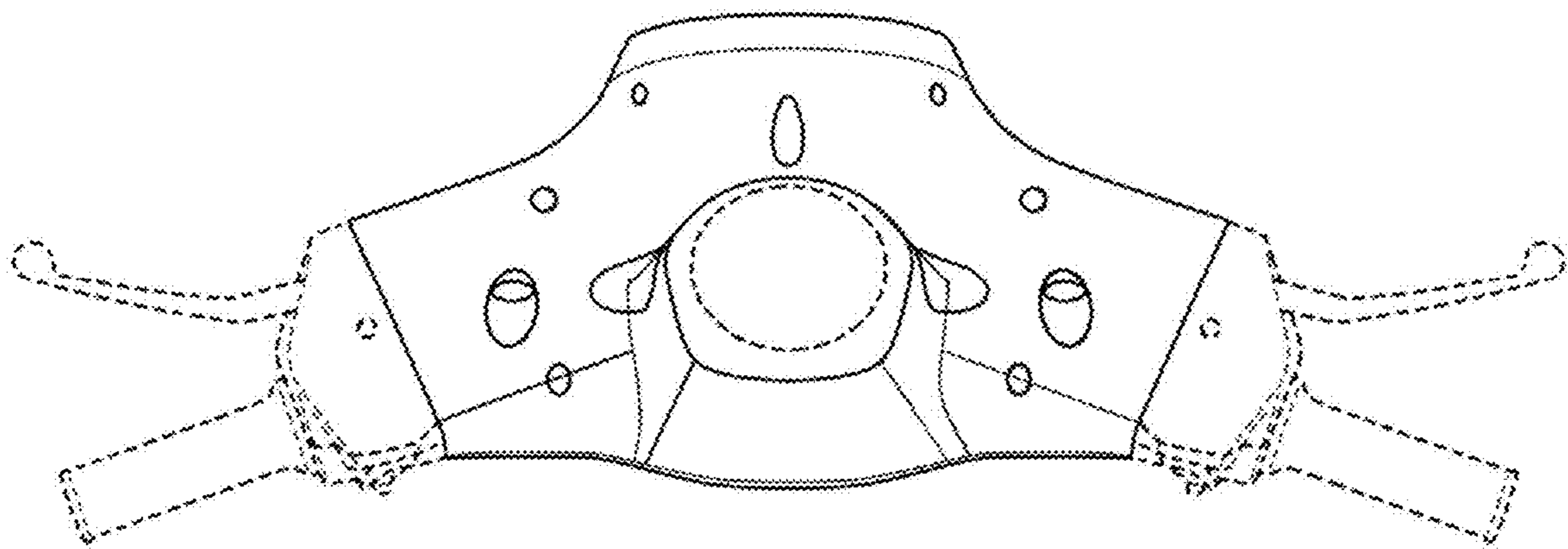
