FIG. 4 is a bottom view of the headset including a neckband;

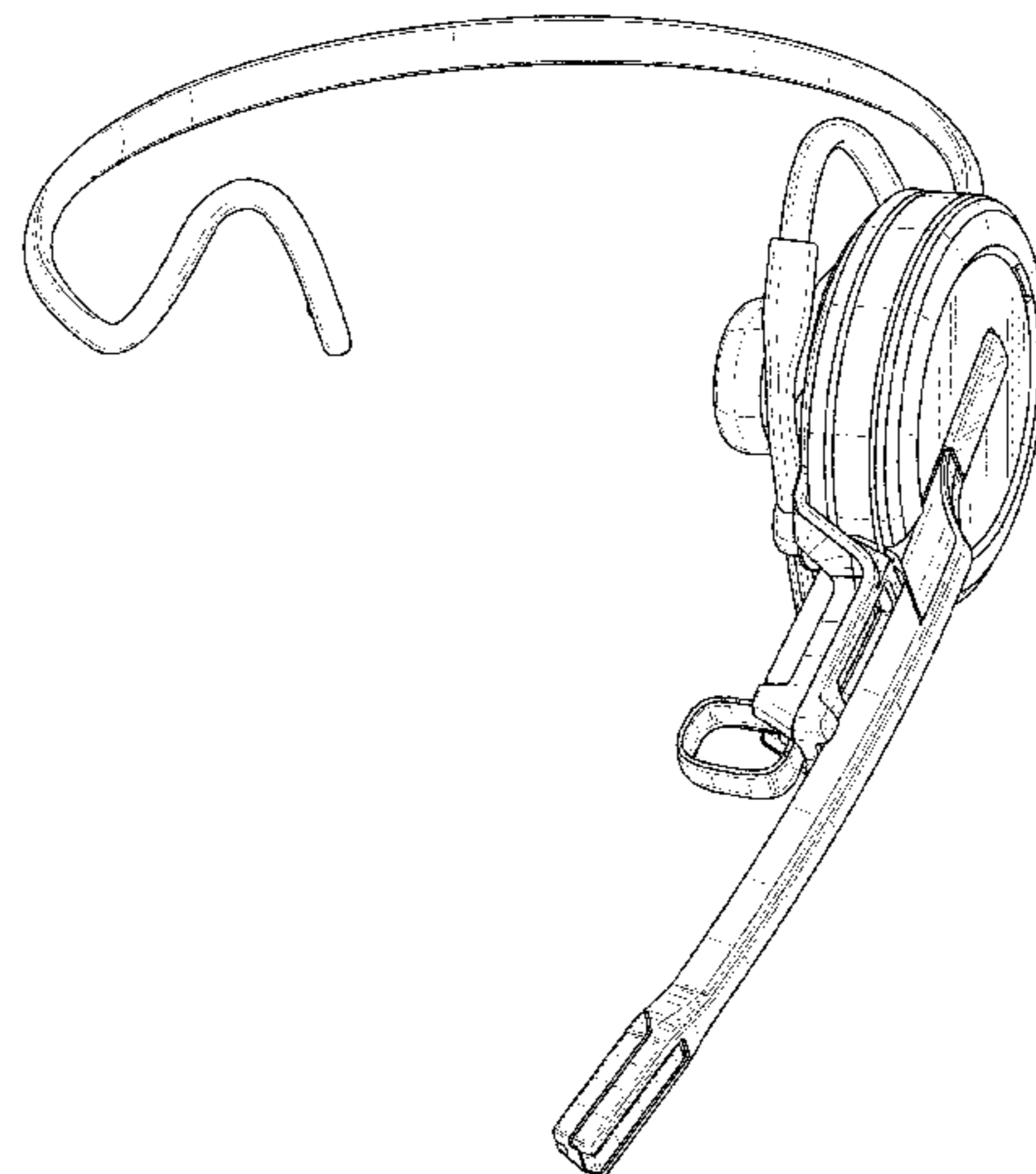
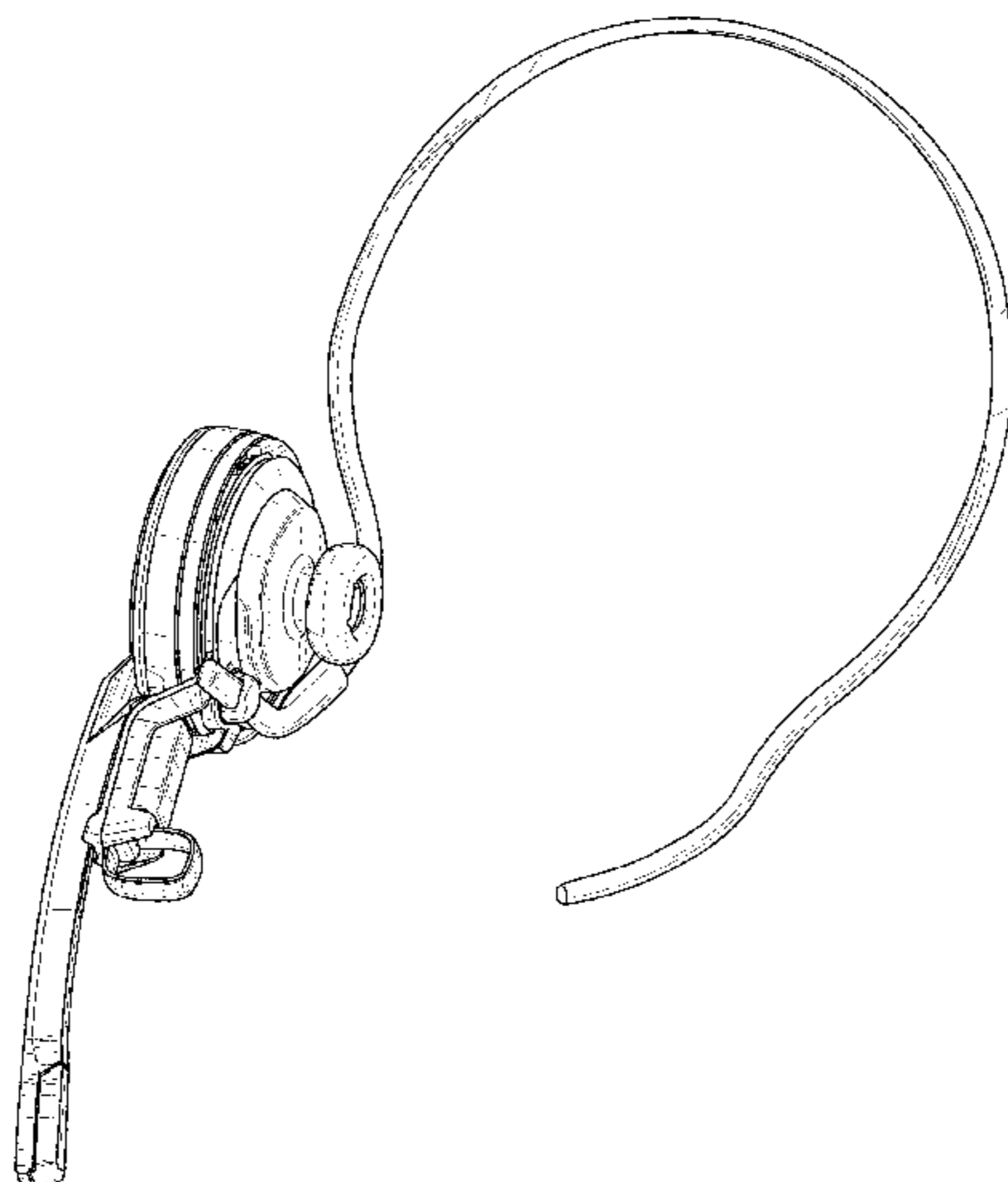
FIG. 5 is a right side view of the headset including a

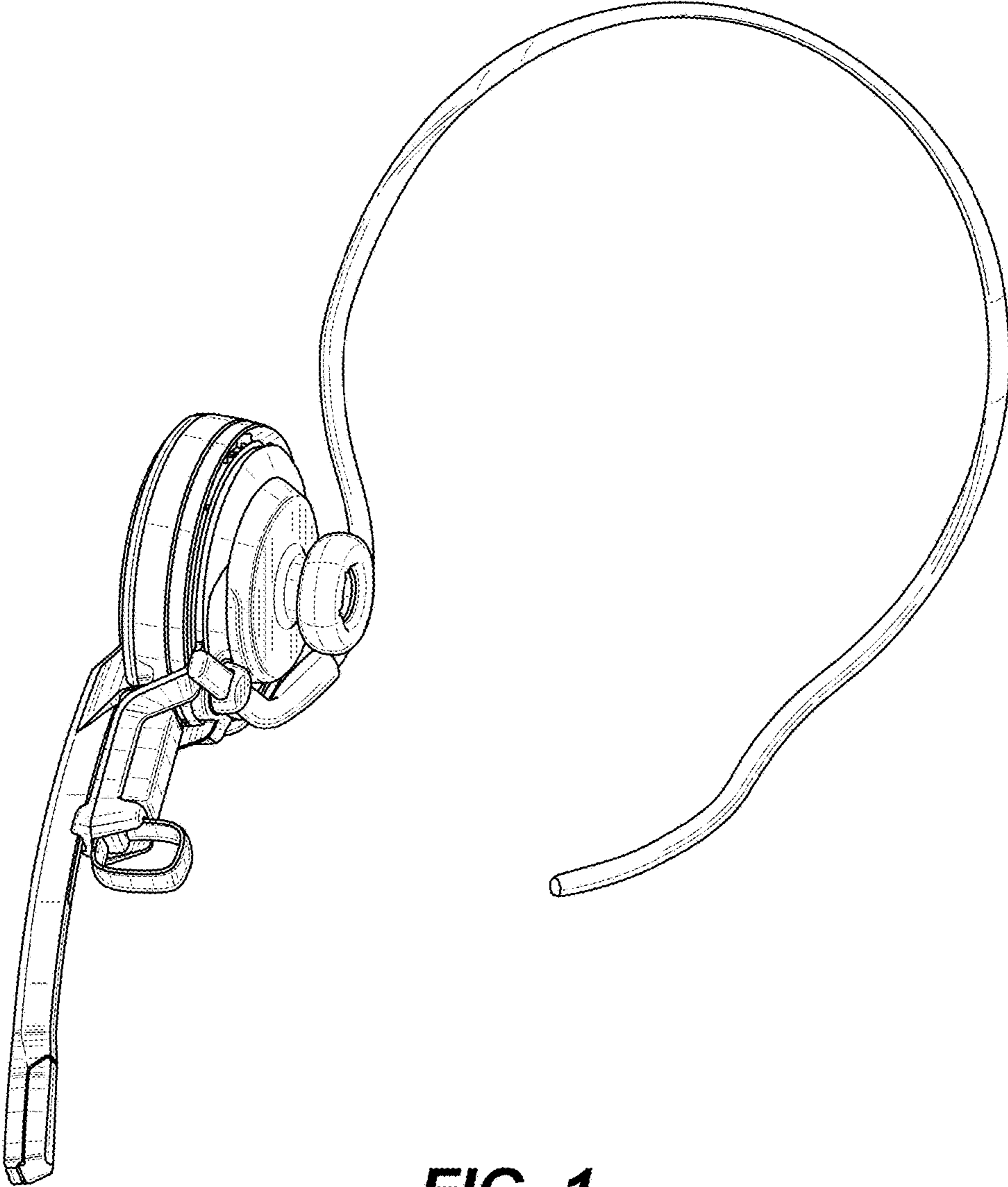

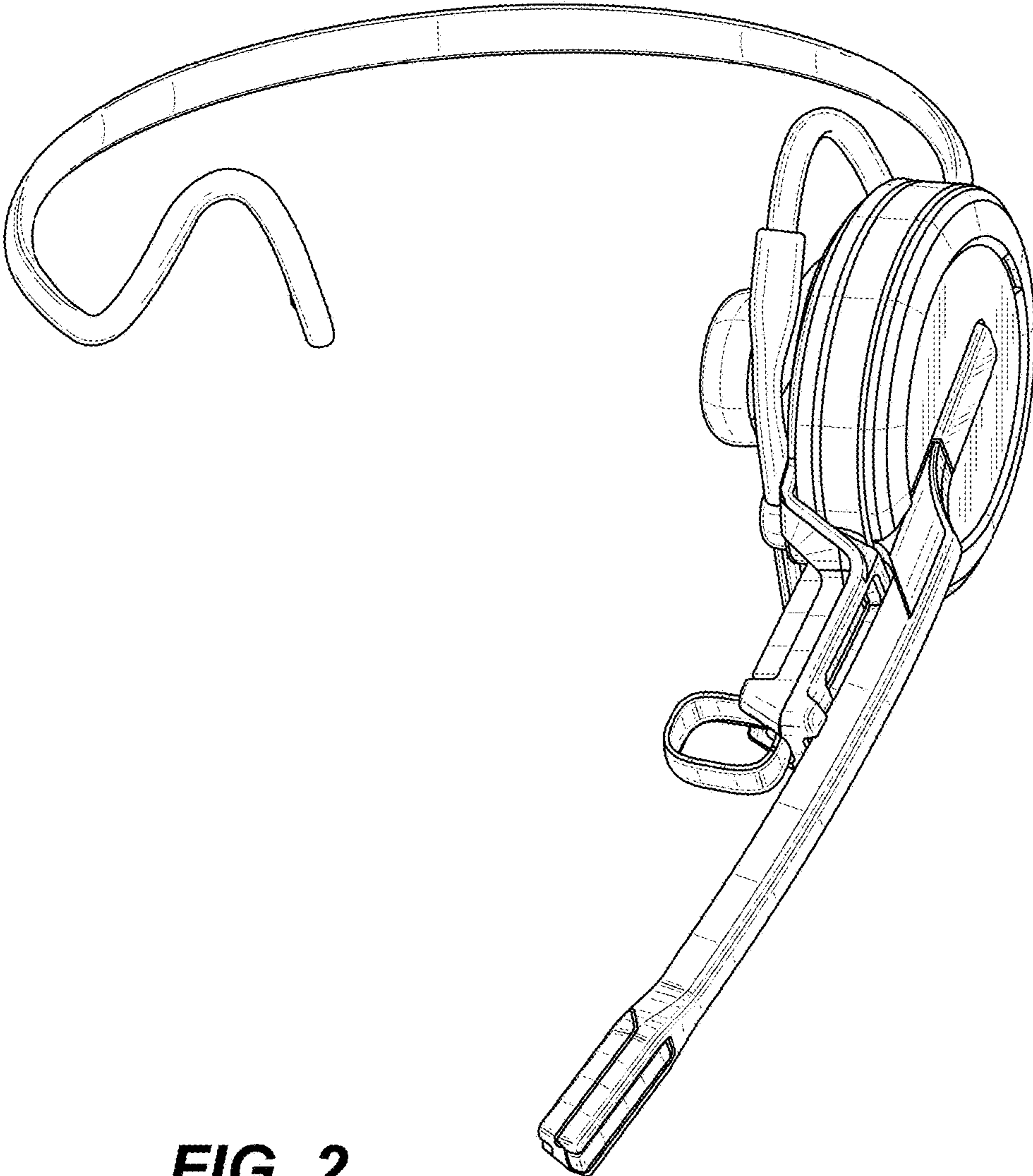

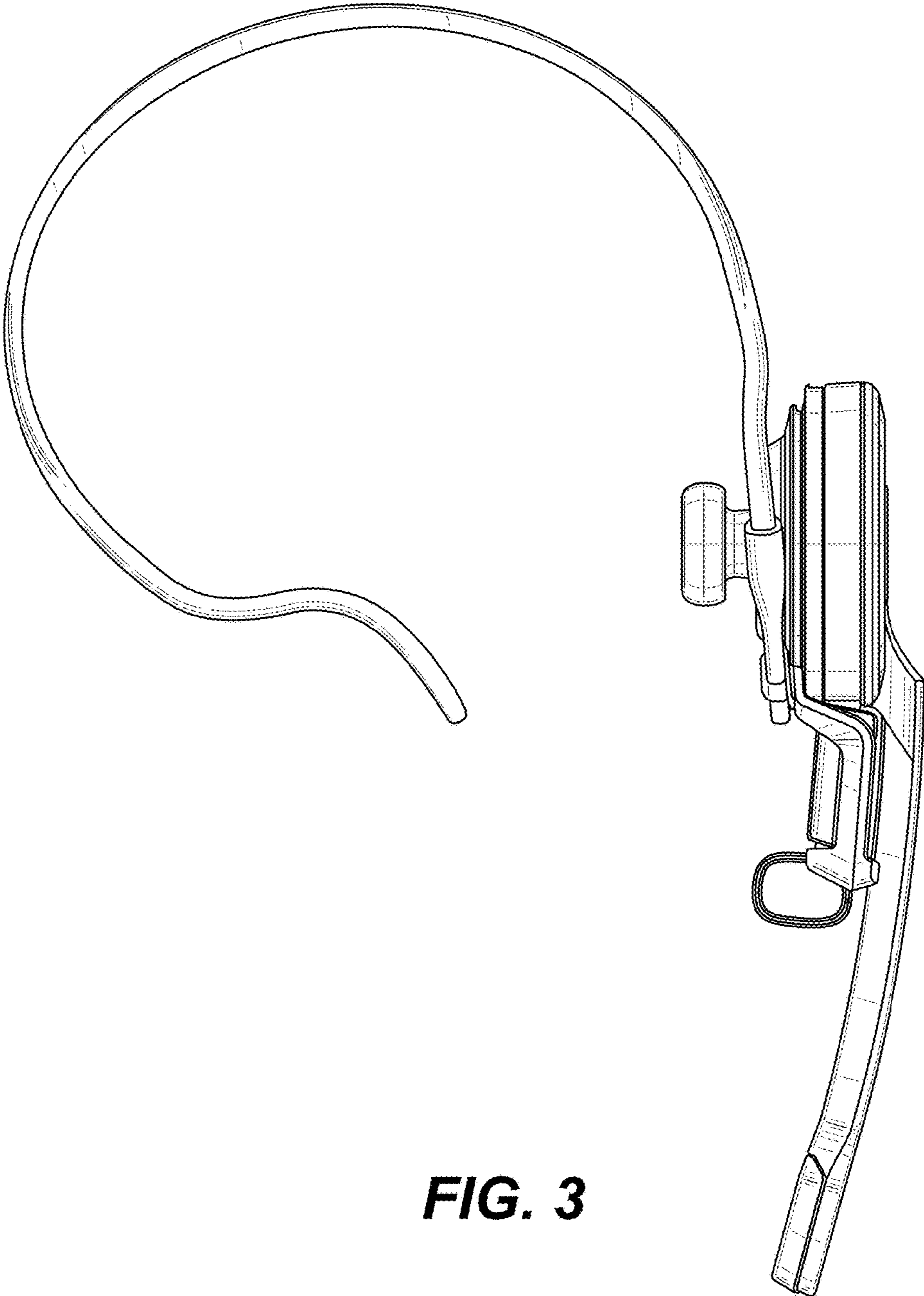

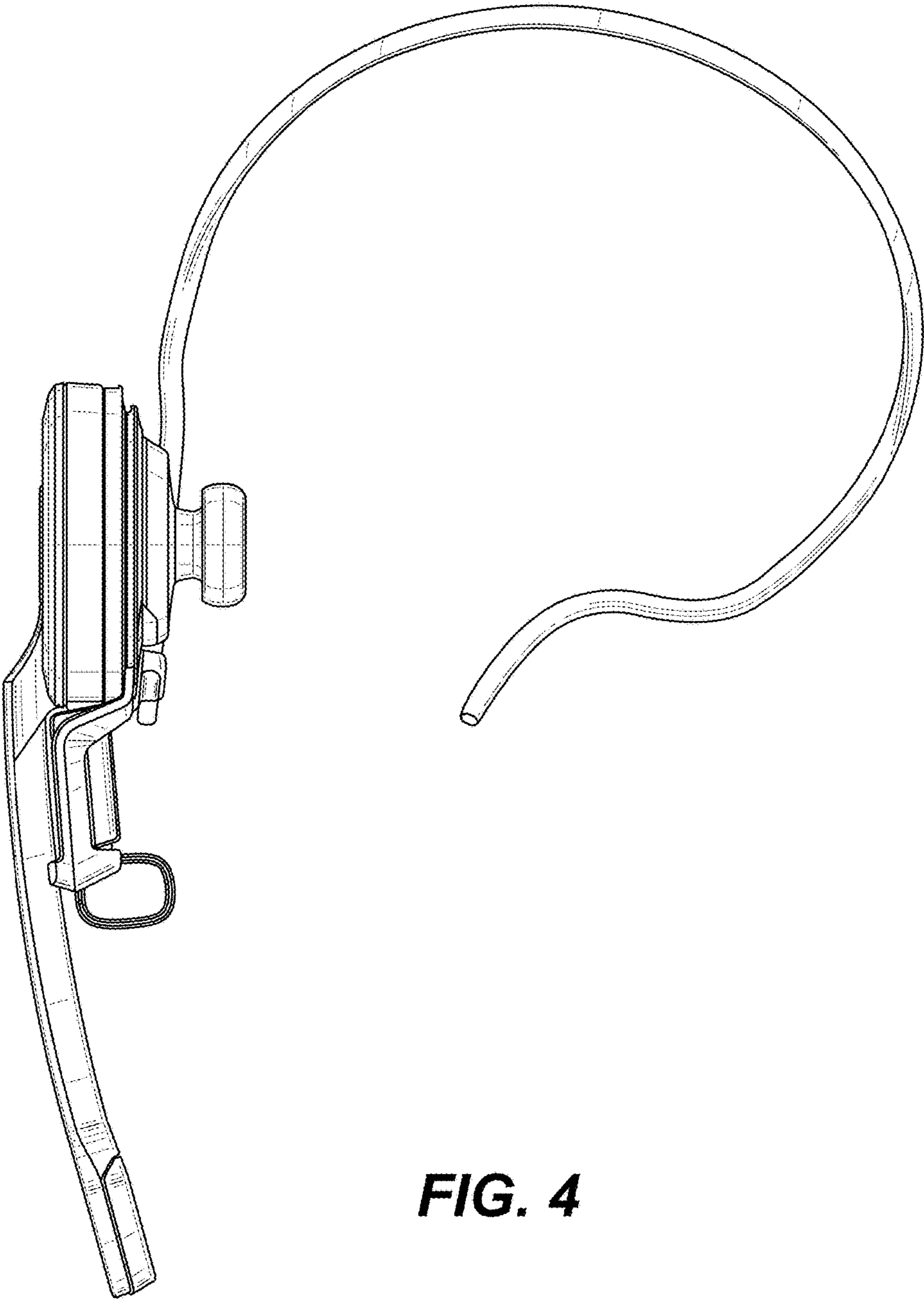

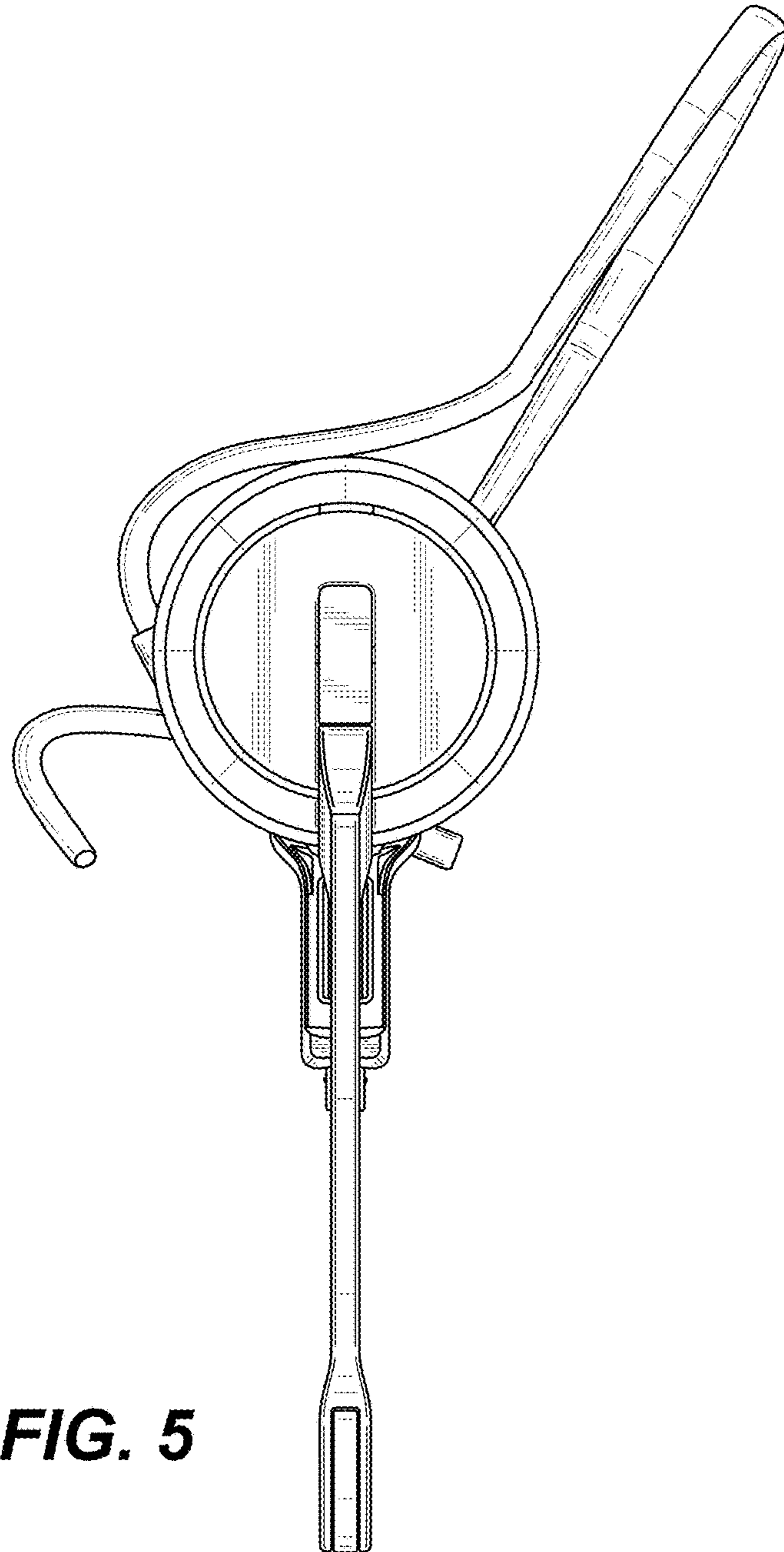

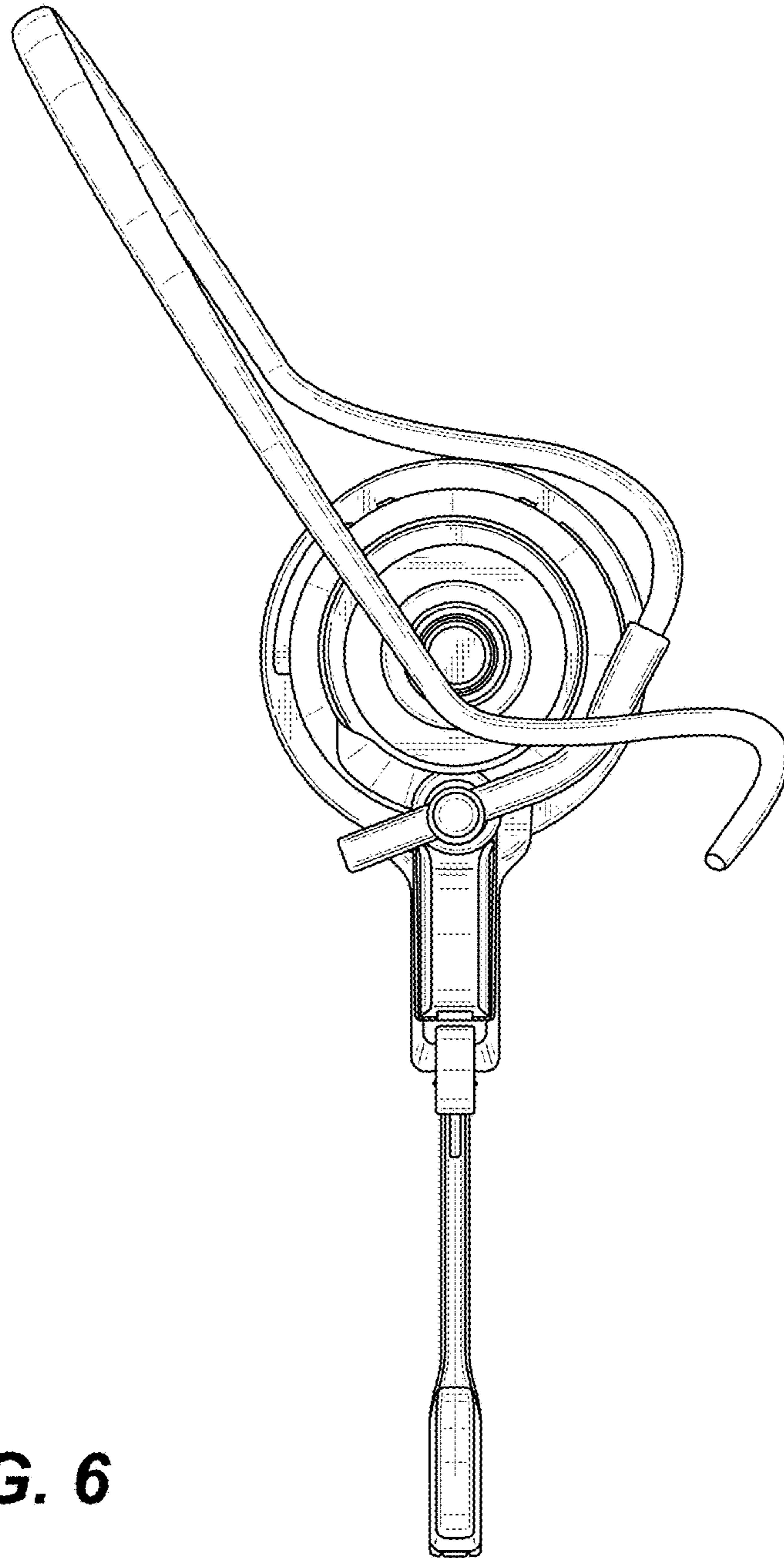

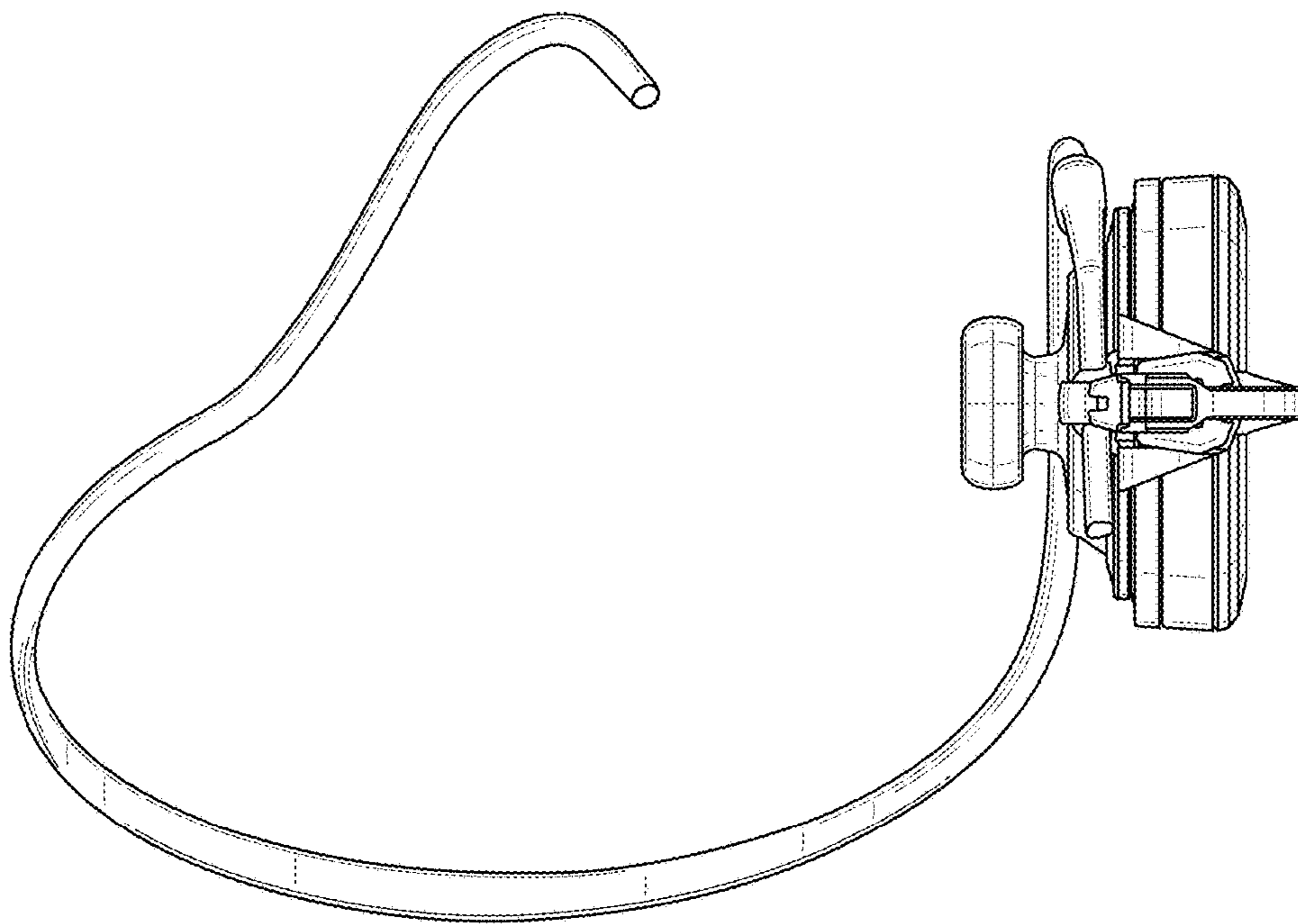

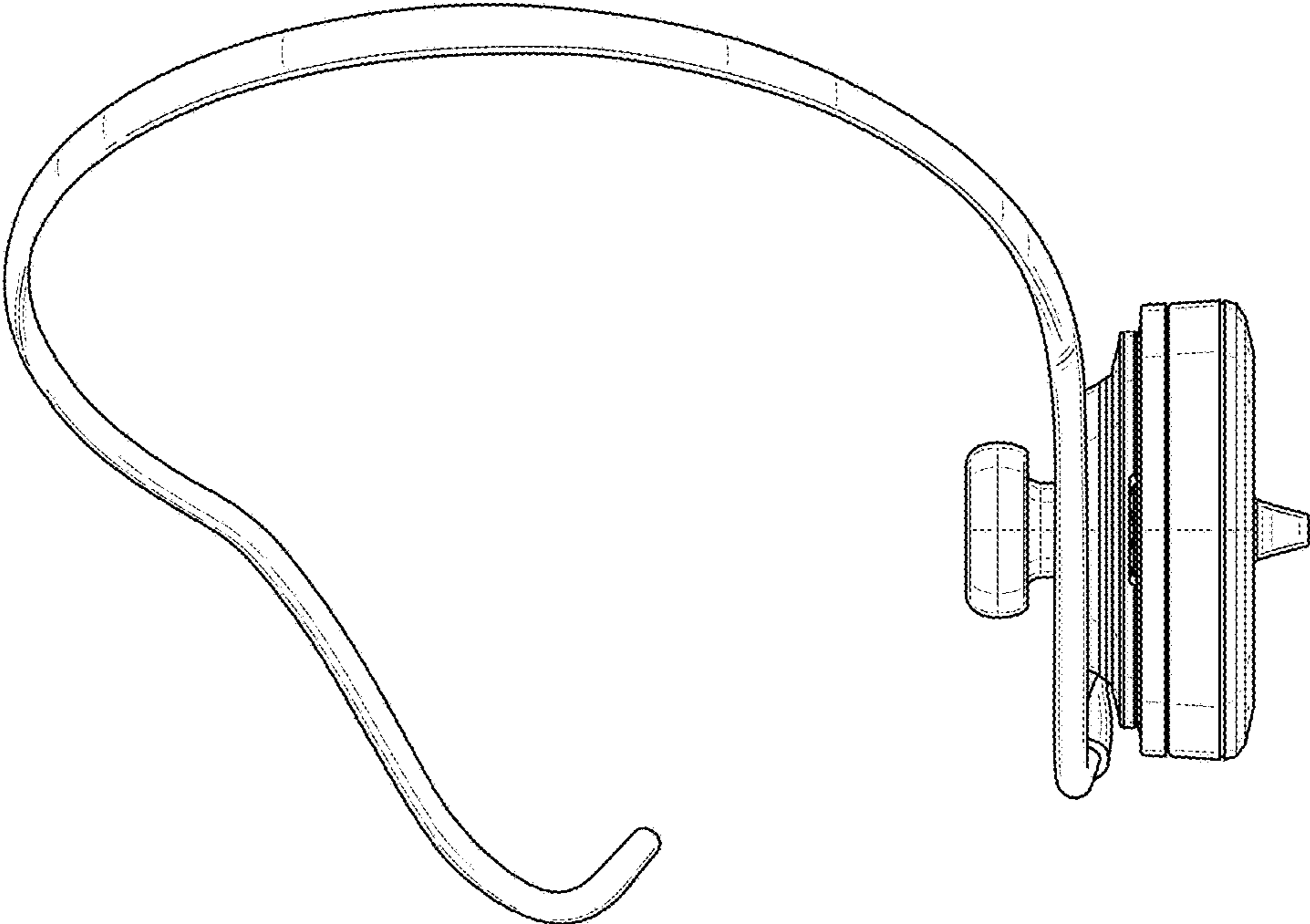
