(57) **CLAIM**

The ornamental design for a phone case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the rear, bottom and one-side of a phone case showing the first embodiment of our new design;

FIG. 2 is a perspective view of the front, top and side of the phone case of FIG. 1;

FIG. 3 is an elevational view of the rear of the phone case of FIG. 1;

FIG. 4 is an elevational view of the front of the phone case of FIG. 1;

FIG. 5 is an elevational view of one side of the phone case of FIG. 1;

FIG. 6 is an elevational view of the opposite side of the phone case of FIG. 1;

FIG. 7 is a plan view of the top of the phone case of FIG. 1; and

FIG. 8 is a plan view of the bottom of the phone case of FIG. 1;

FIG. 9 is a perspective view of the rear, bottom and-one side of a phone case showing the second embodiment of our new design;

FIG. 10 is a perspective view of the front, top and side of the phone case of FIG. 9;

FIG. 11 is an elevational view of the rear of the phone case of FIG. 9;

FIG. 12 is an elevational view of the front of the phone case of FIG. 9;

FIG. 13 is an elevational view of one side of the phone case of FIG. 9;

FIG. 14 is an elevational view of the opposite side of the phone case of FIG. 9;

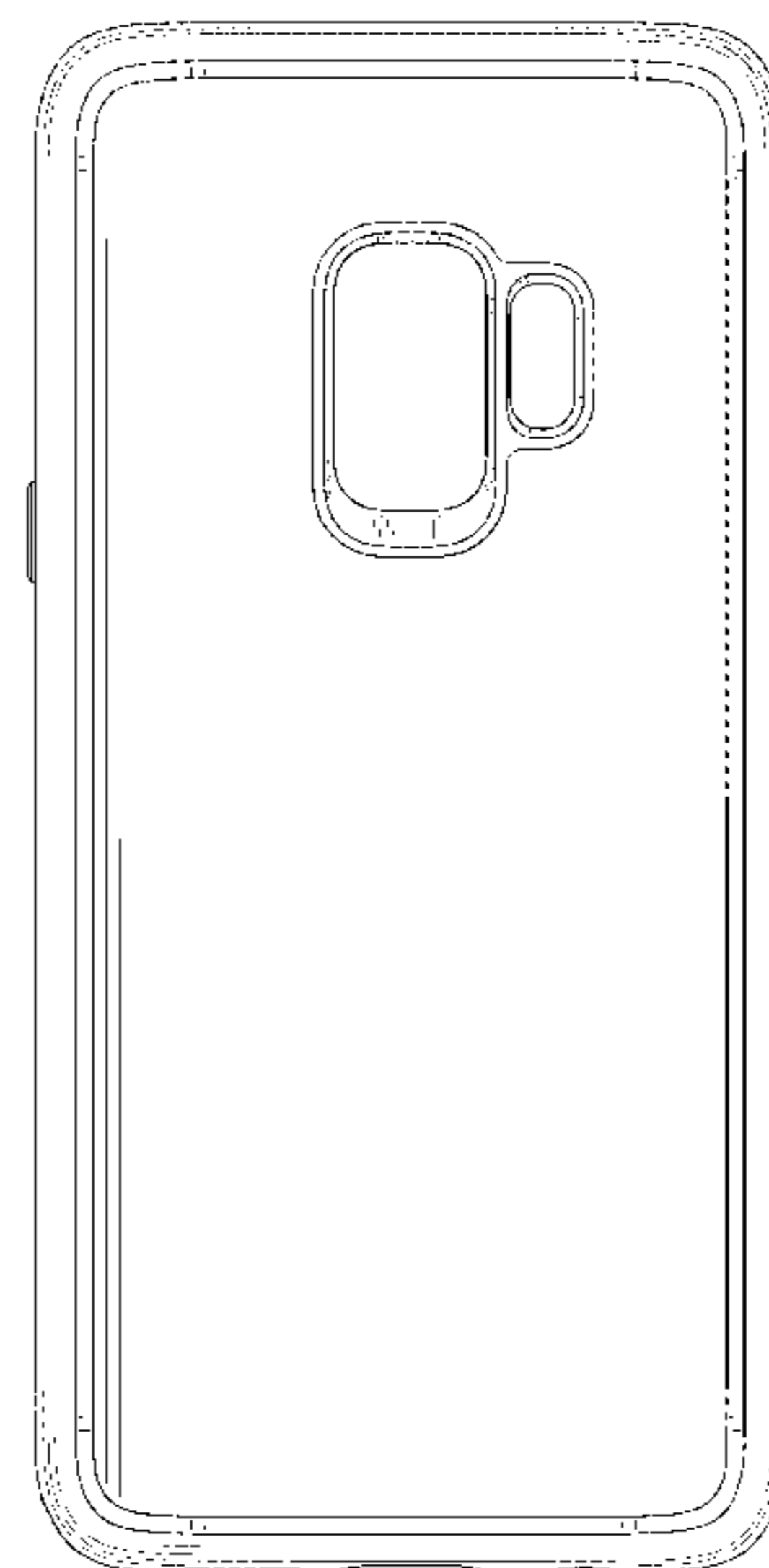
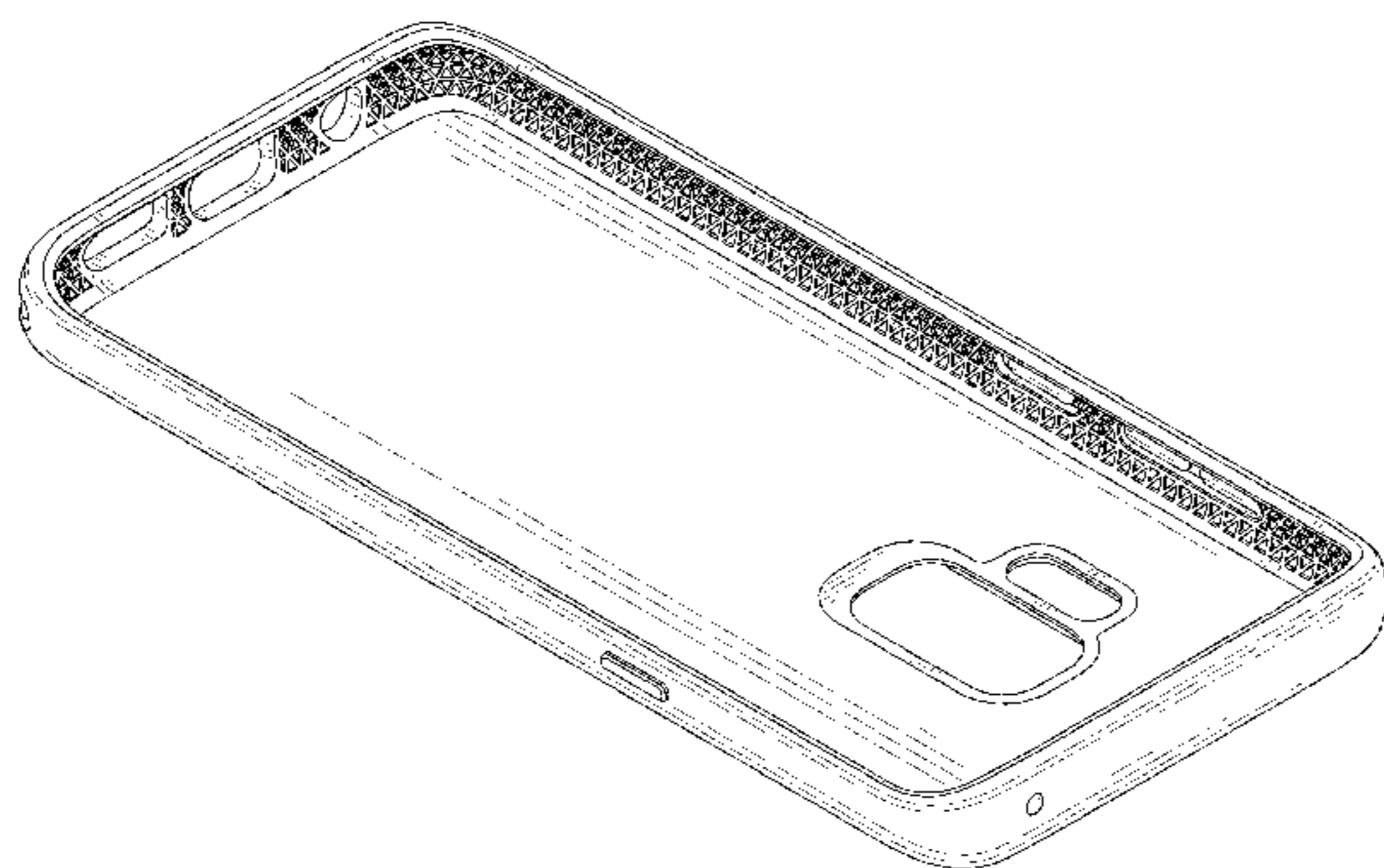
FIG. 15 is a plan view of the top of the phone case of FIG. 9;

FIG. 16 is a plan view of the bottom of the phone case of FIG. 9; and,

FIG. 17 is an enlarged detail view of the encircled region of FIG. 10.

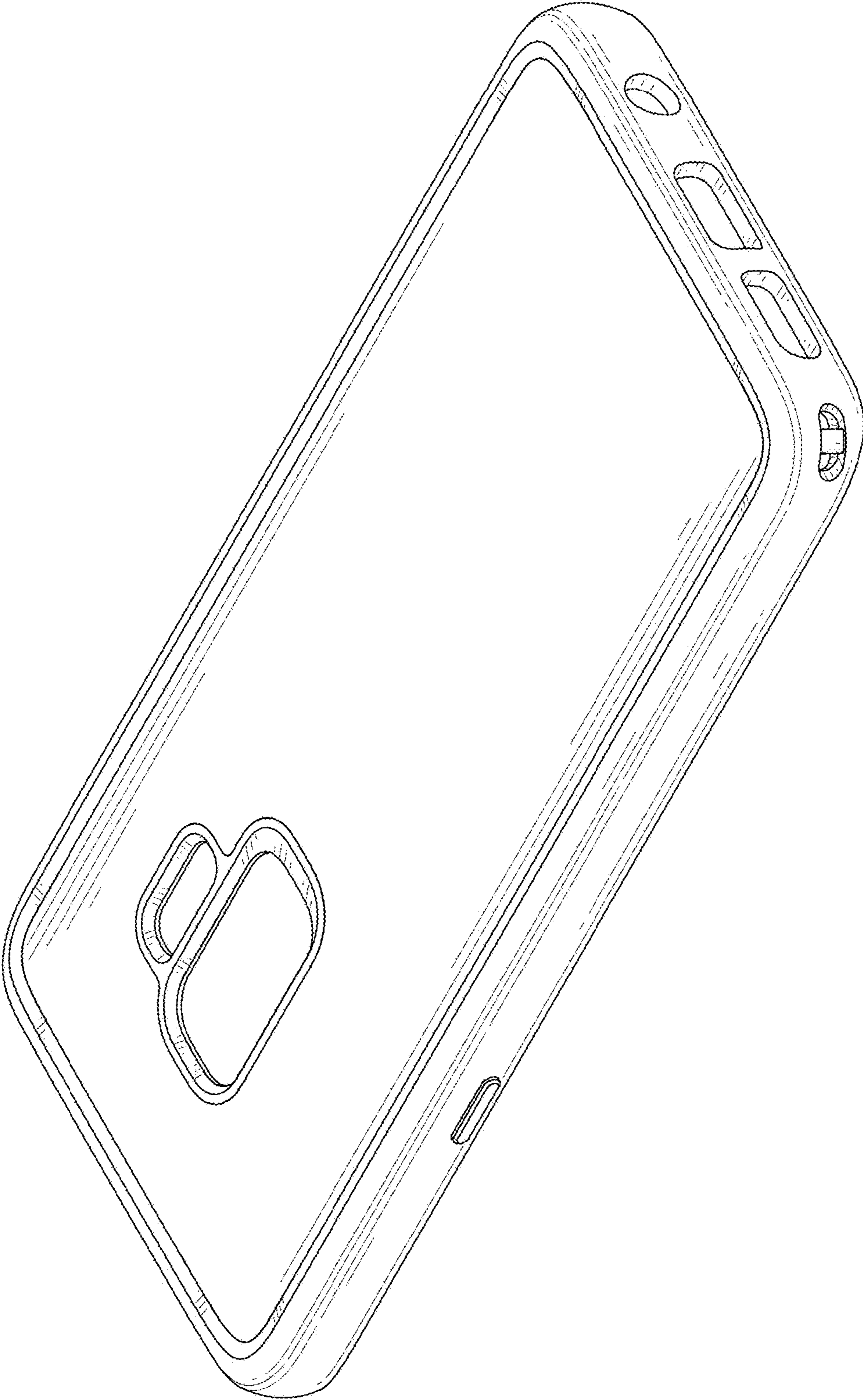

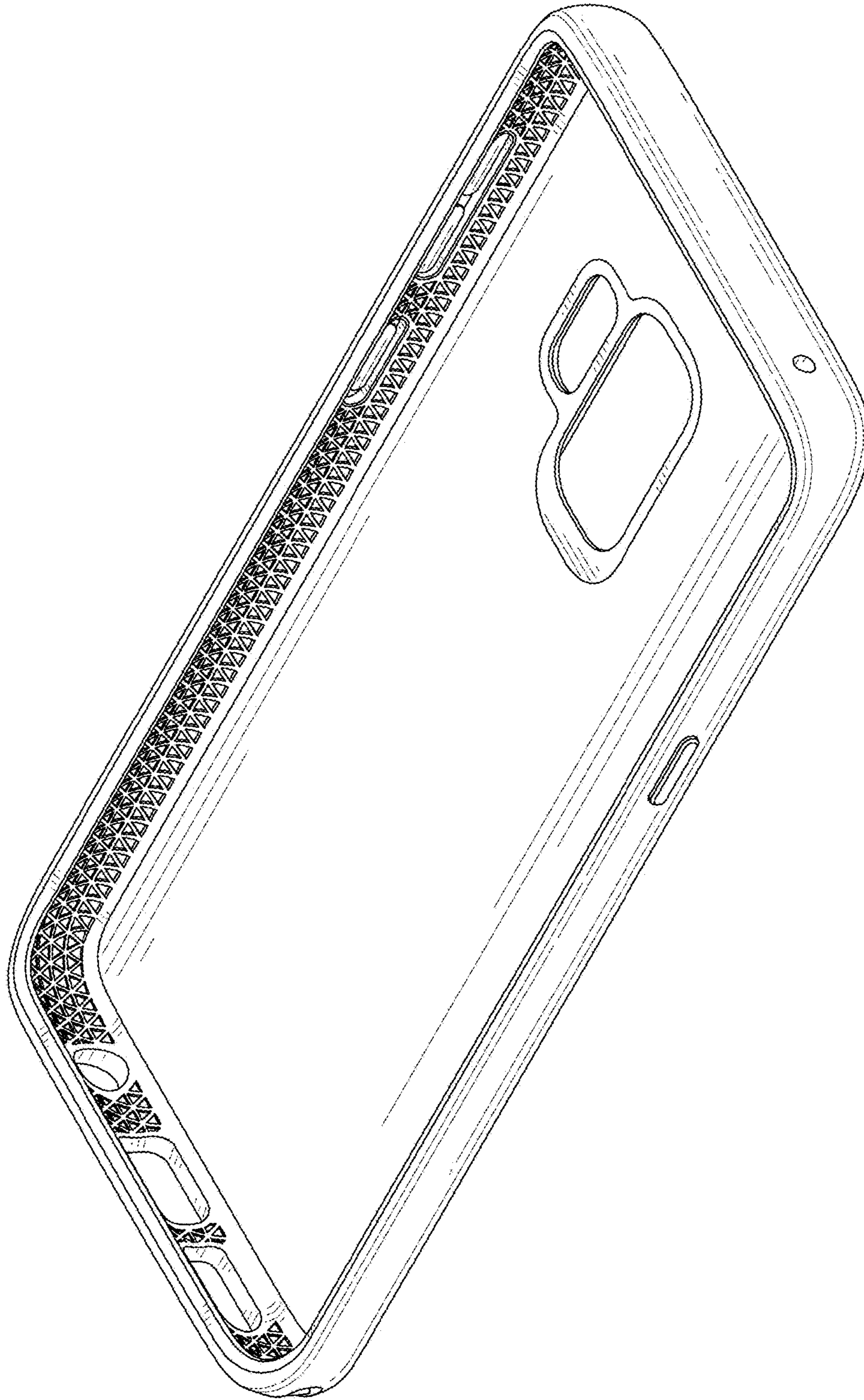

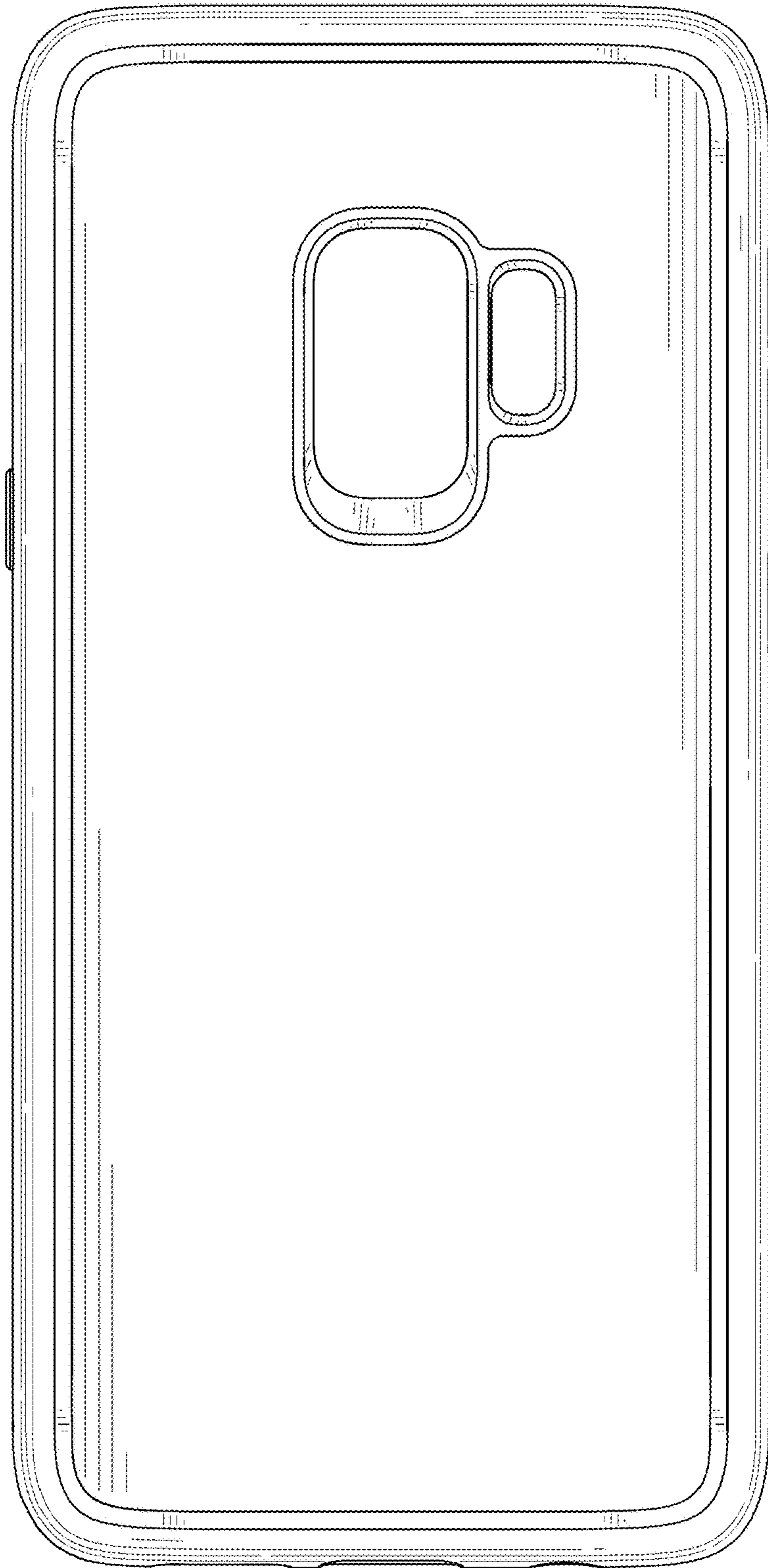

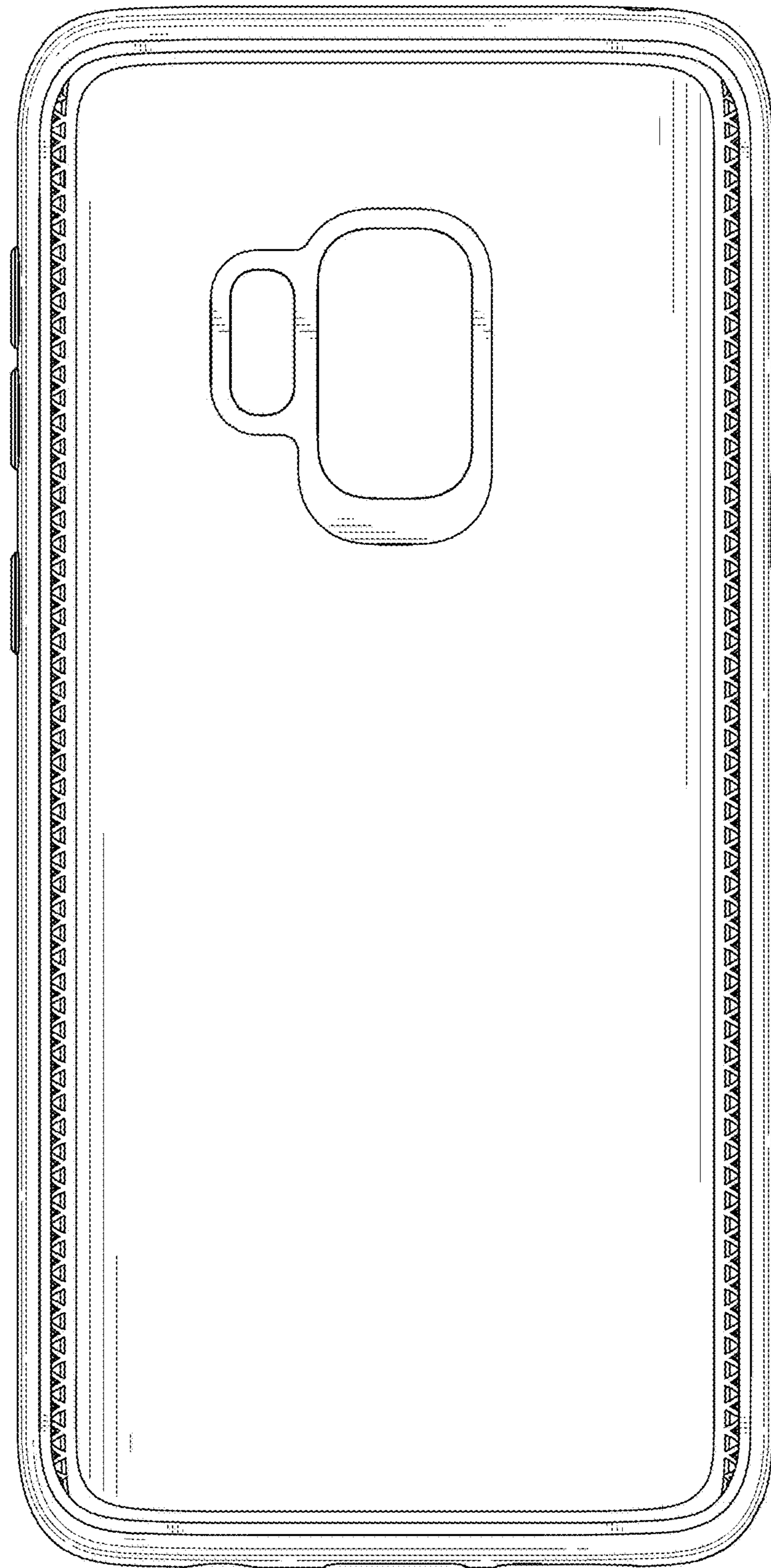

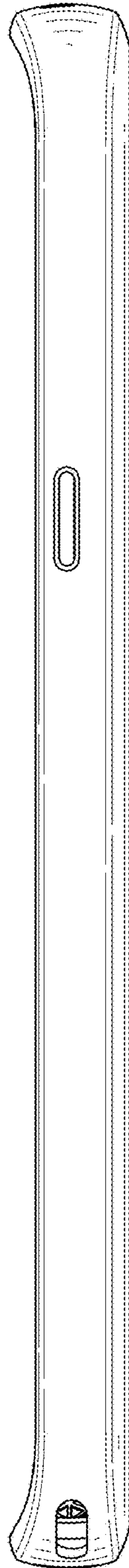

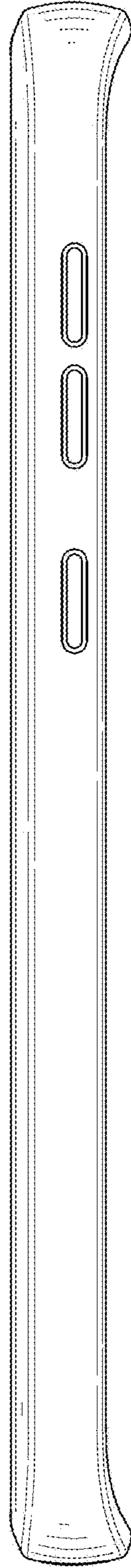

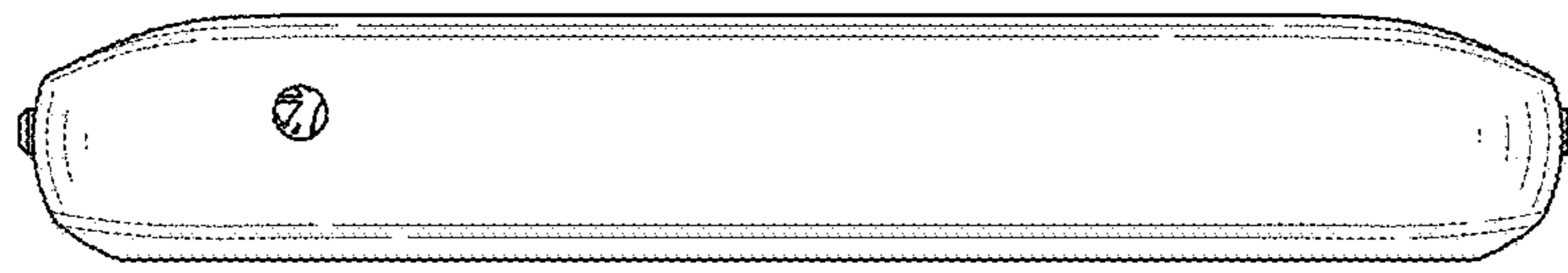

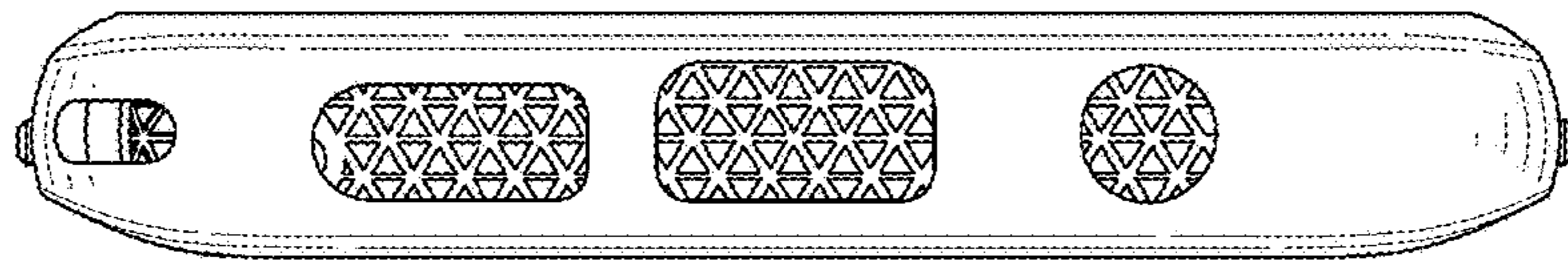

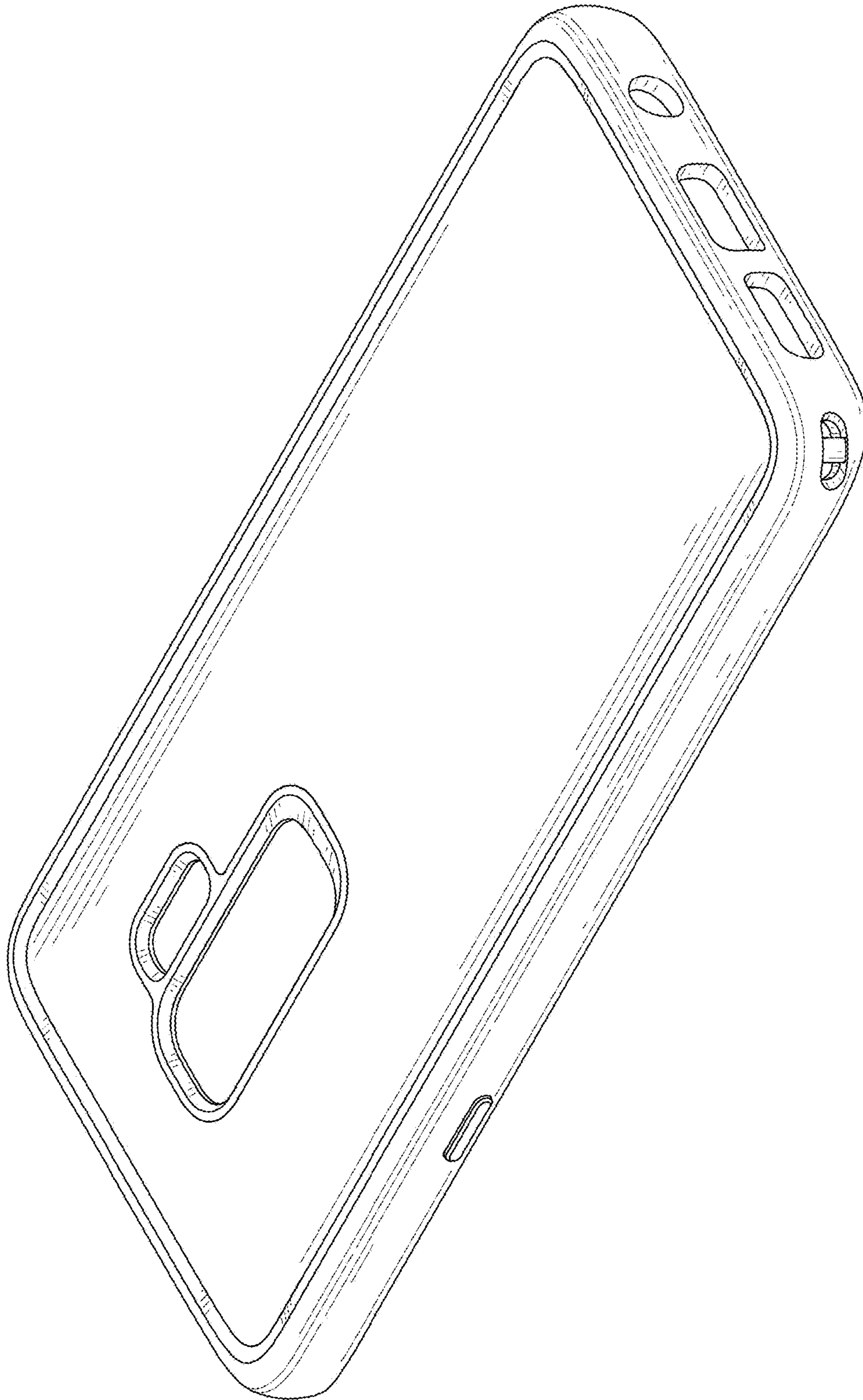

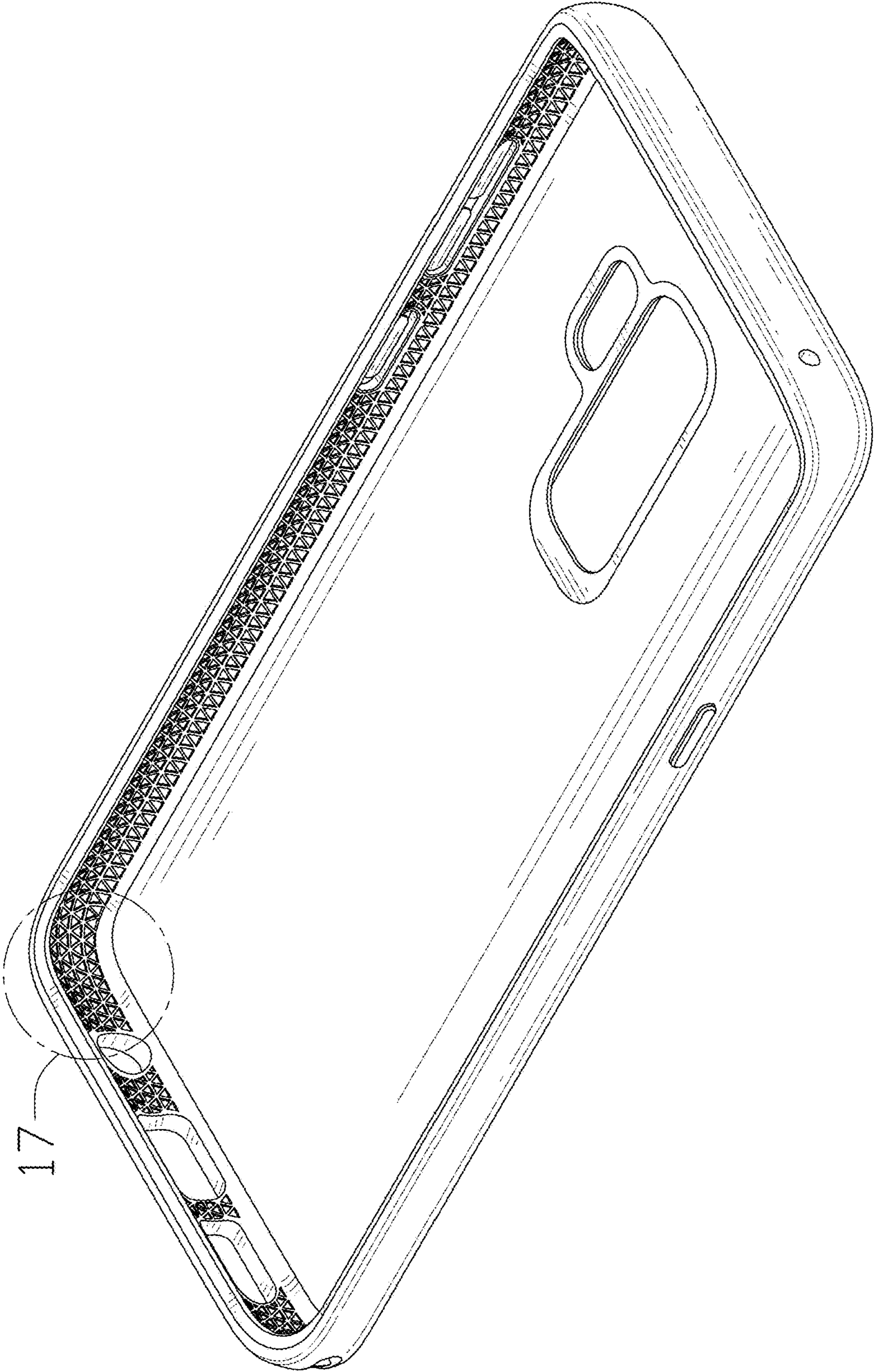

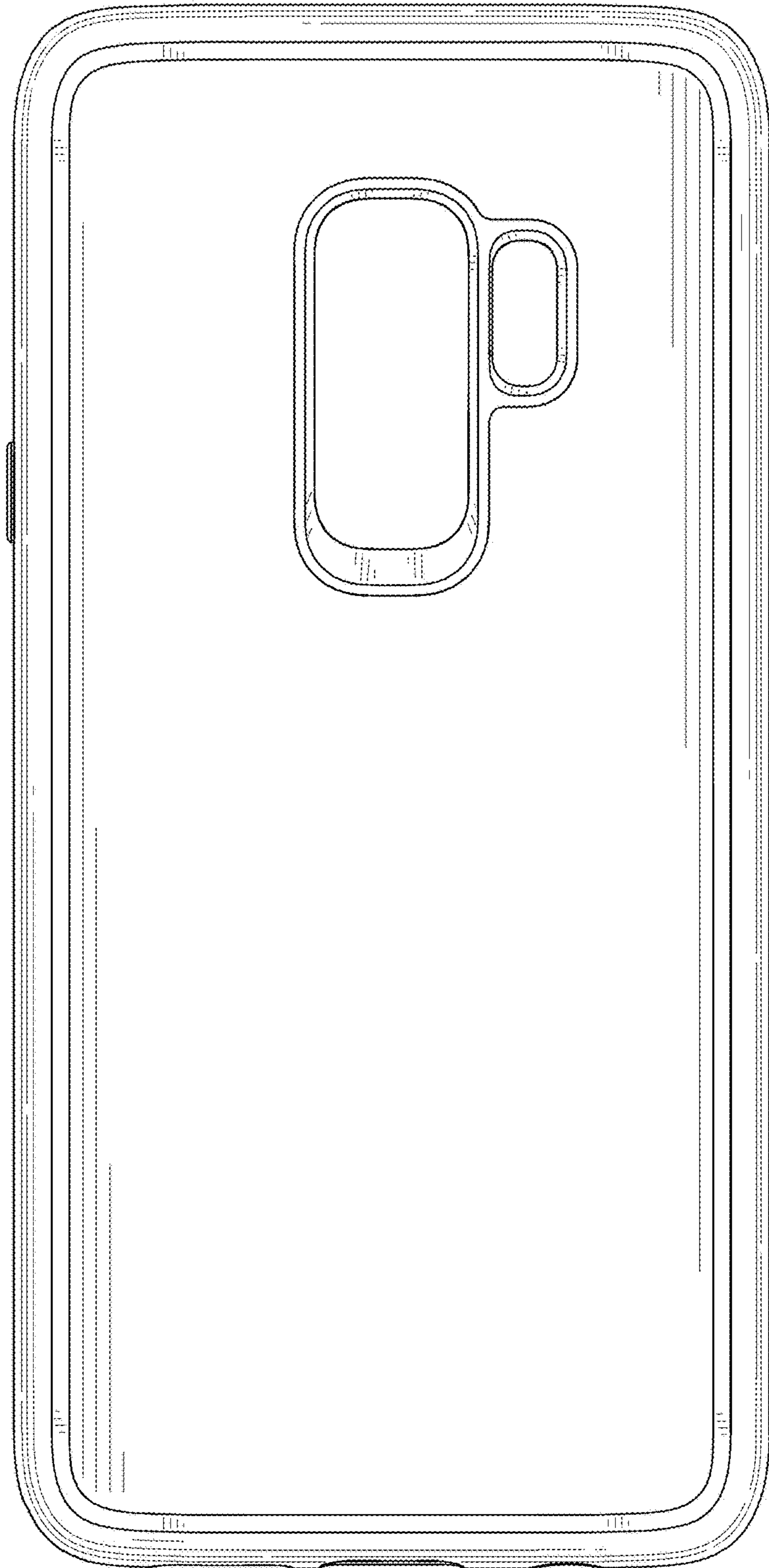

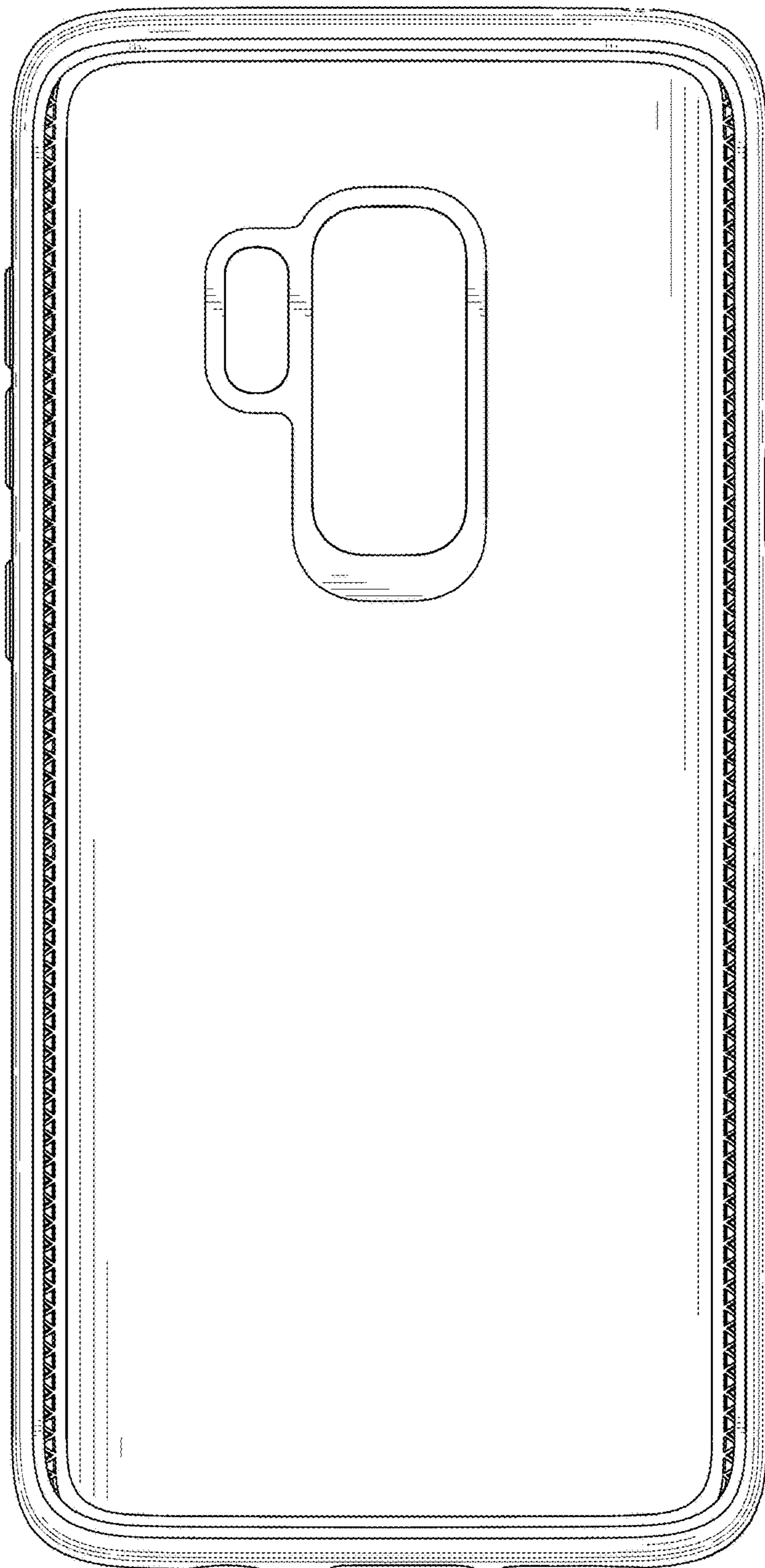

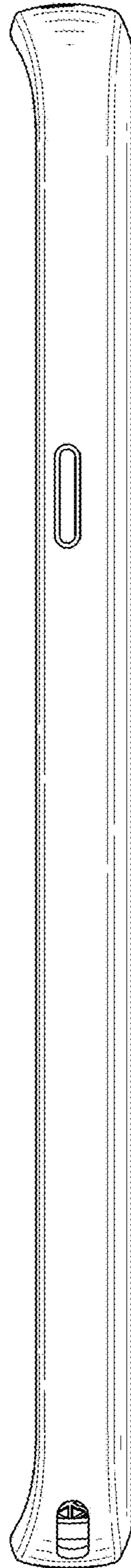

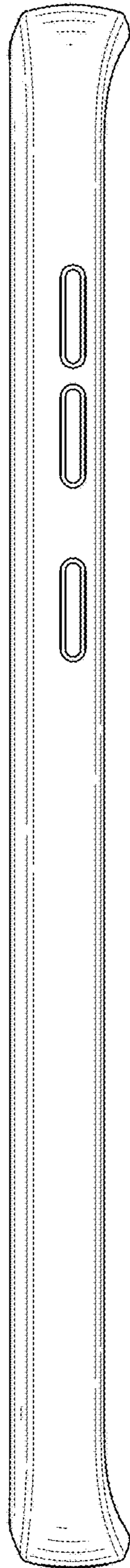

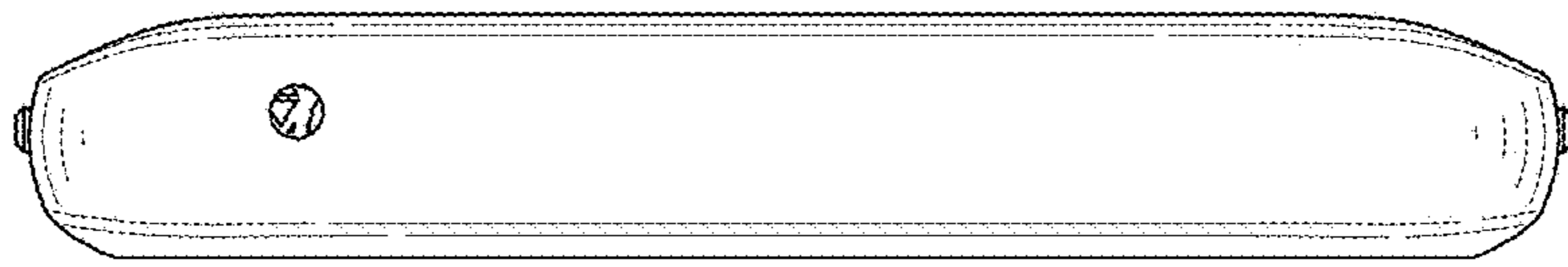

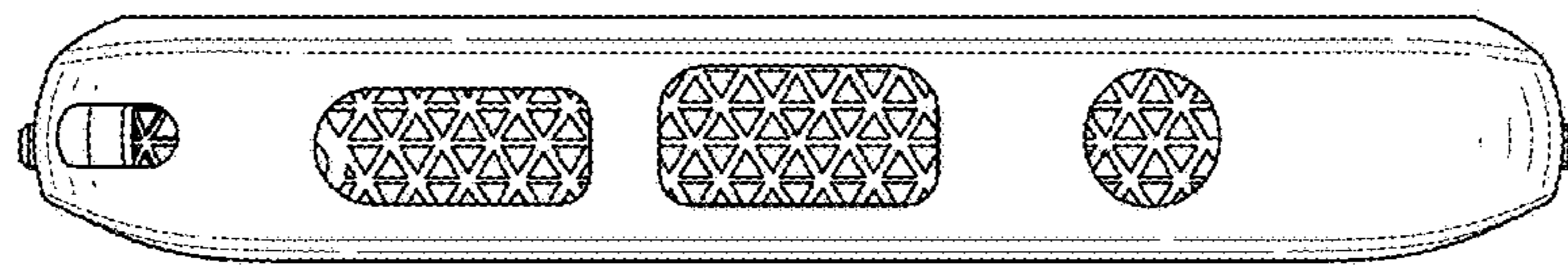

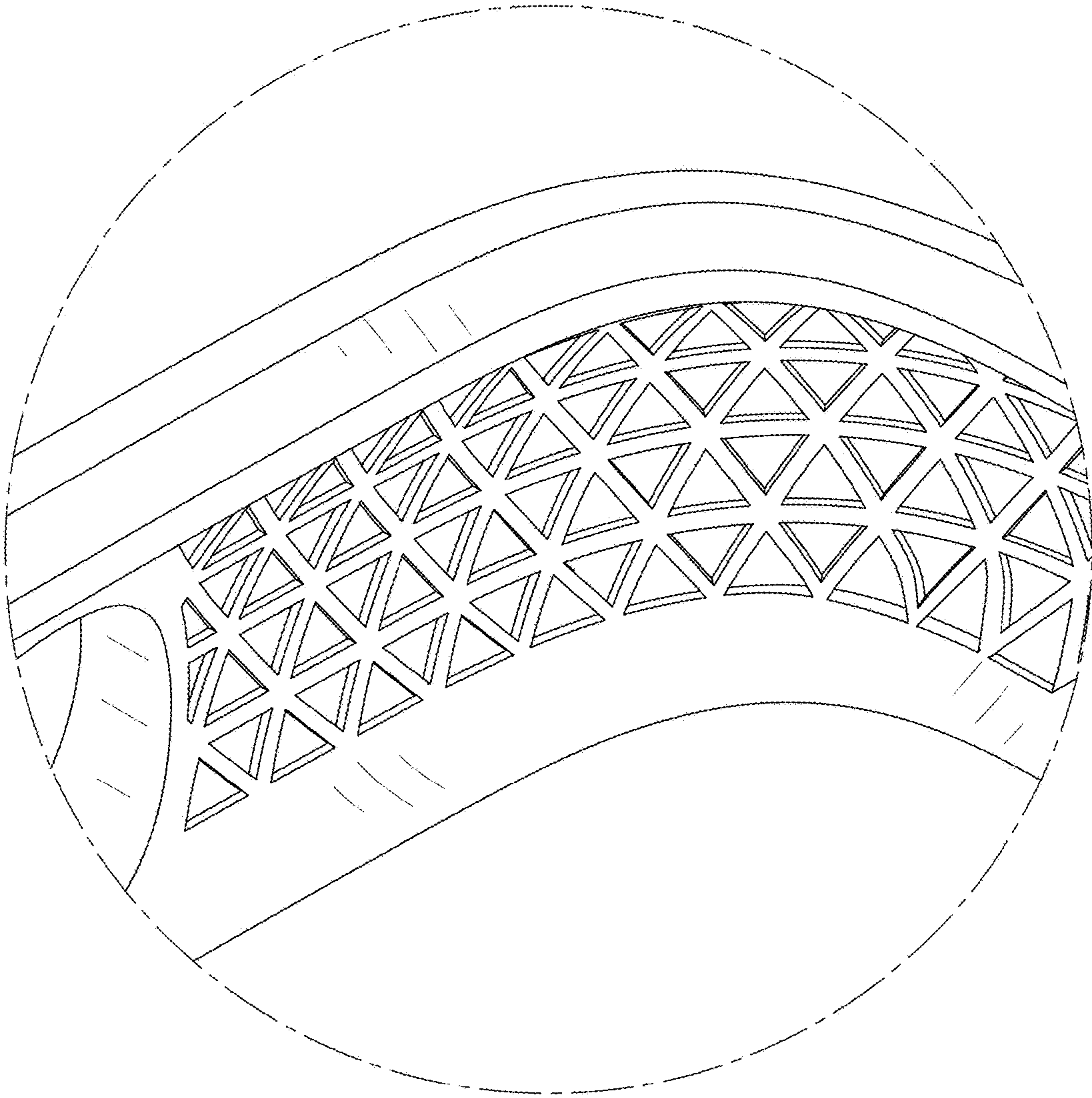
