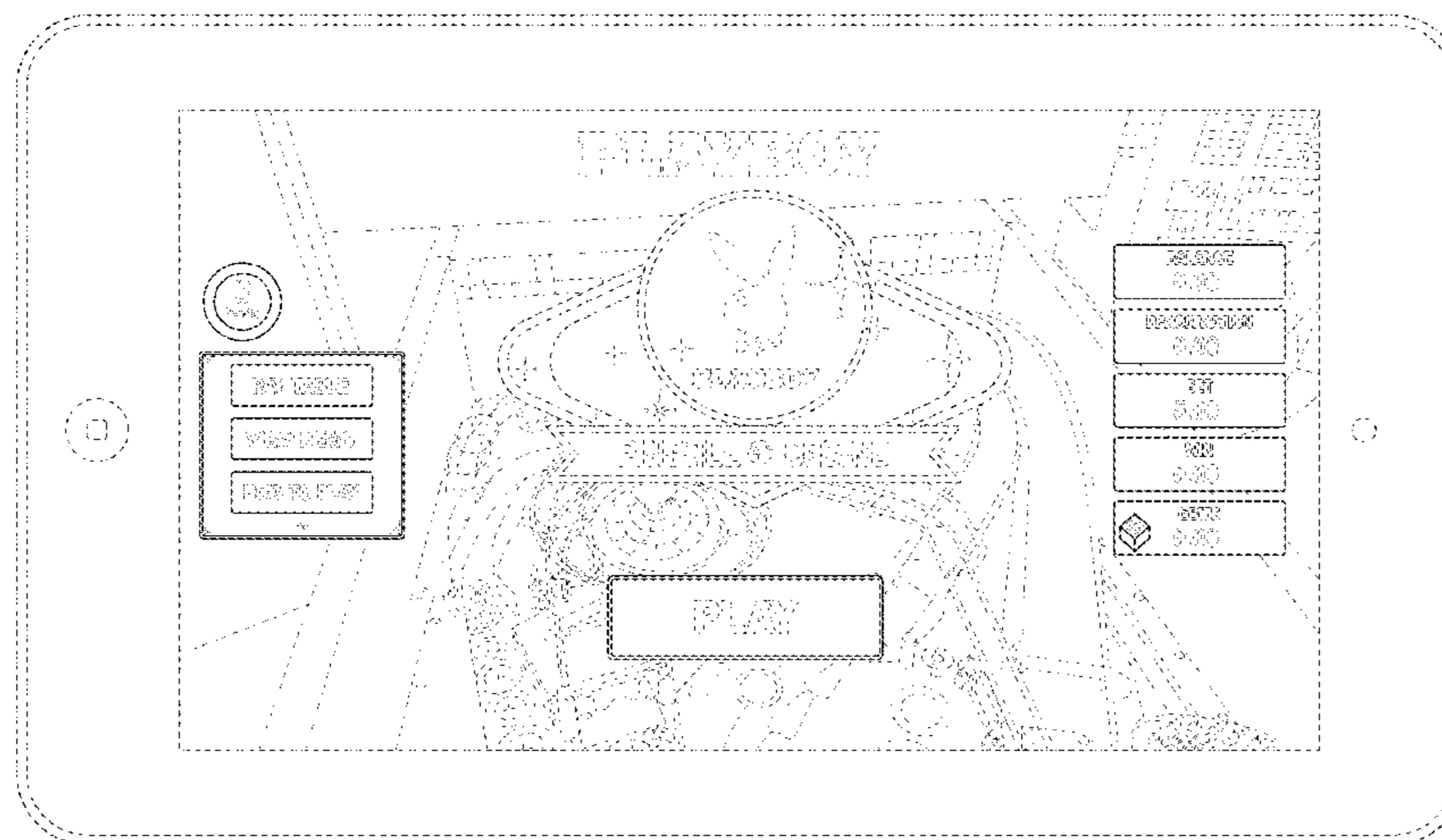
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

The broken lines outside this rectangle illustrate an electronic device as the environment of the display screen. 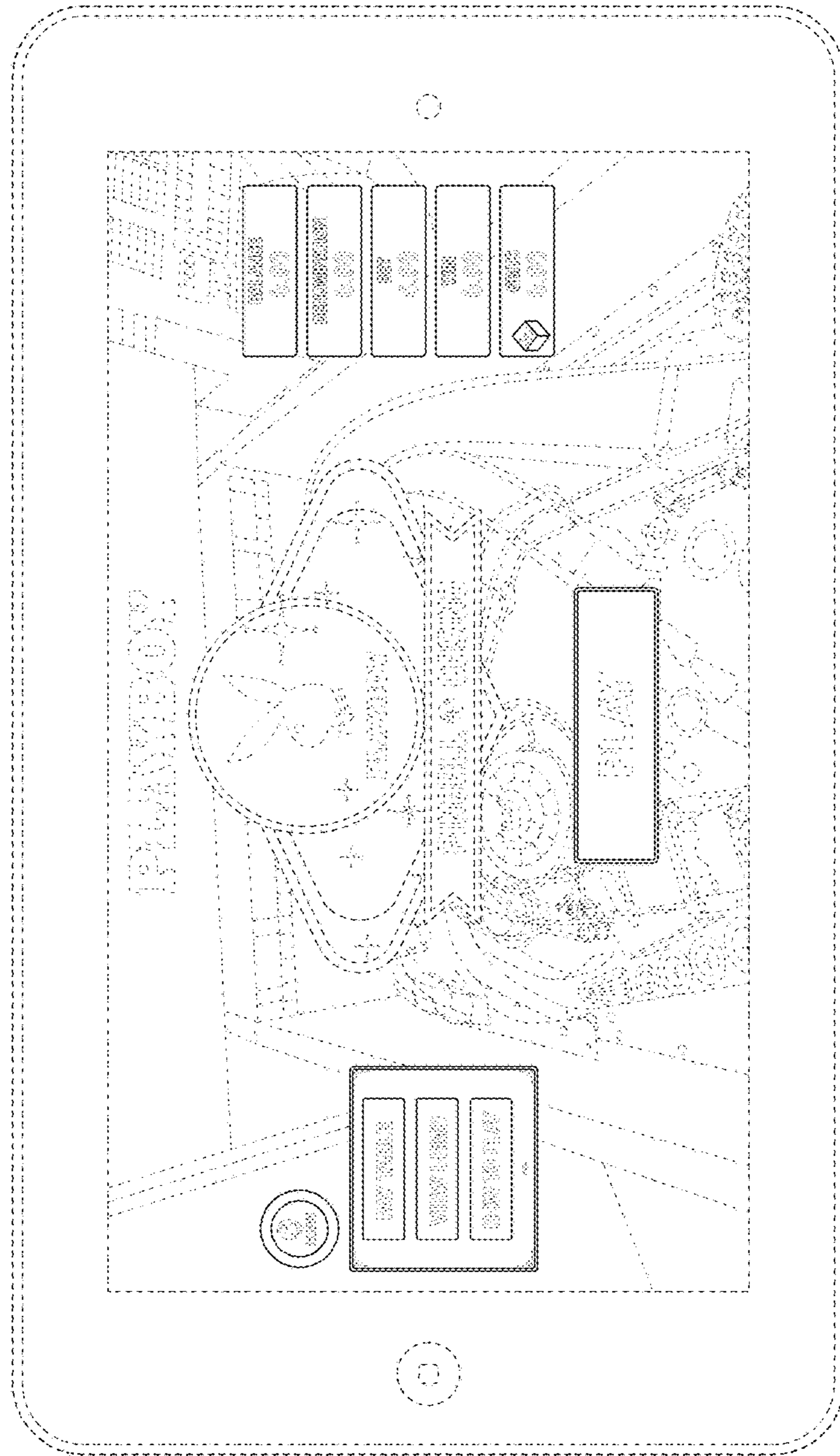
