FIG. 1 is a front elevation view of an ice compartment for a refrigerator fresh food compartment showing our new design;

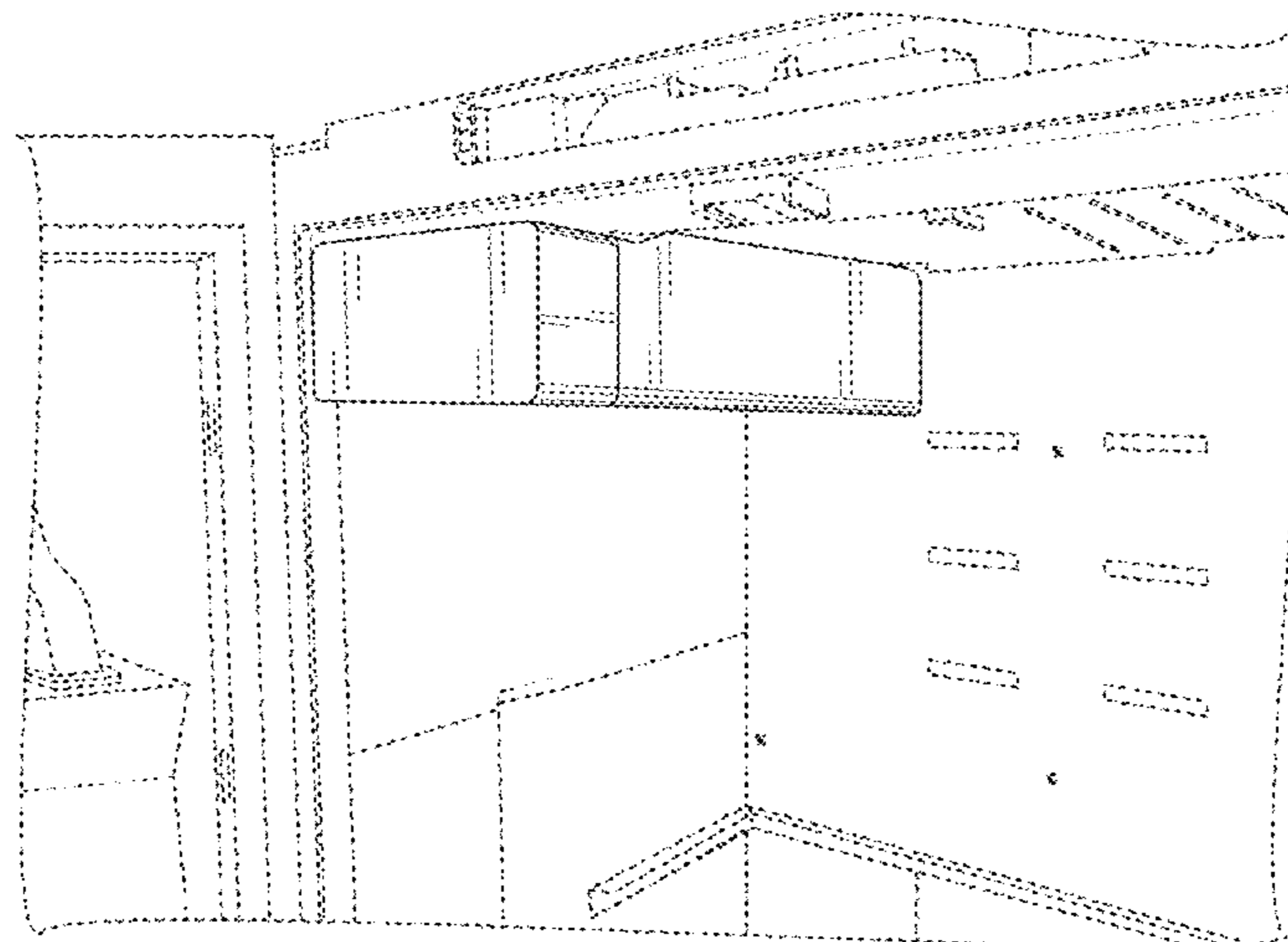
FIG. 2 is a right side elevation view thereof, shown without environment;

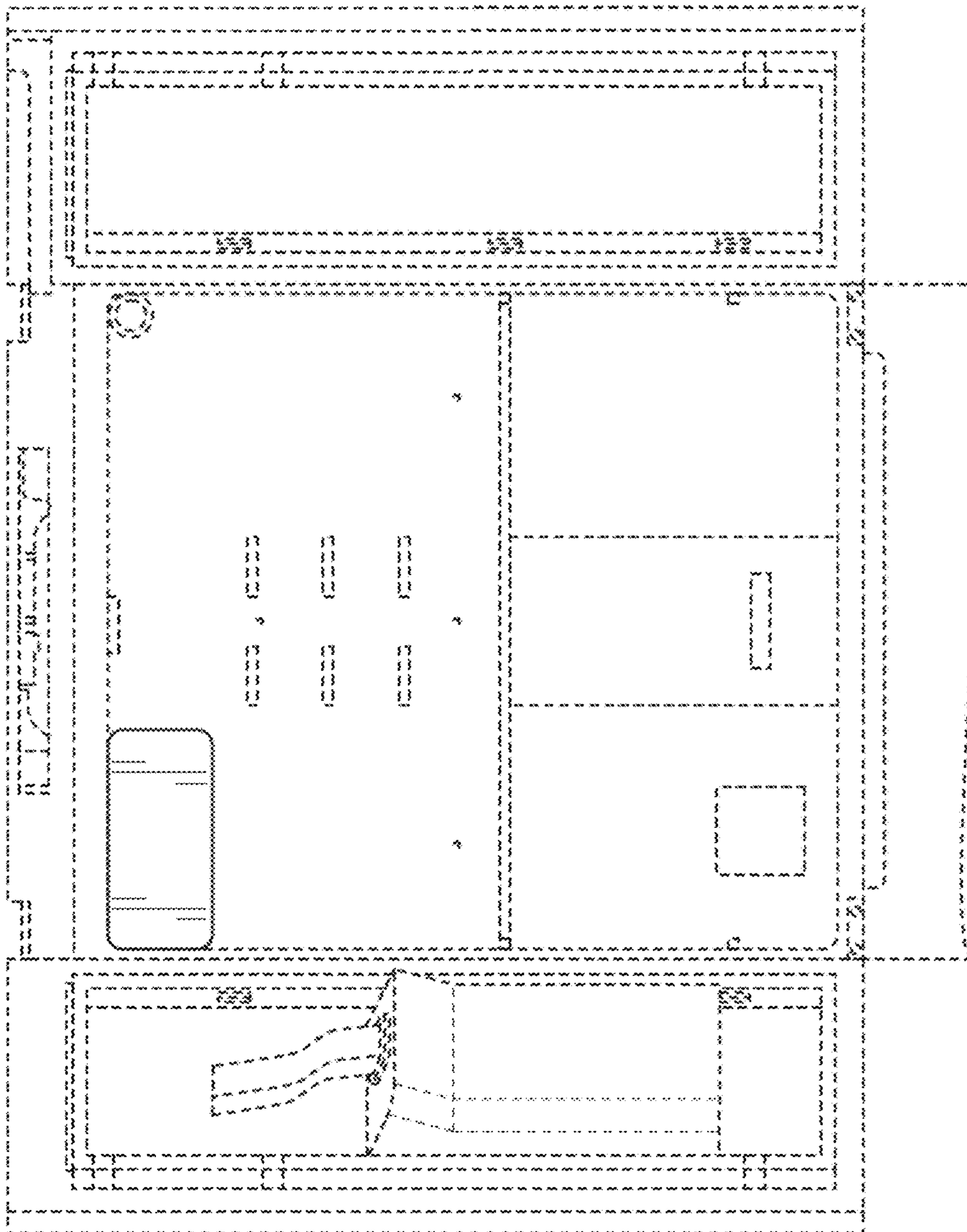

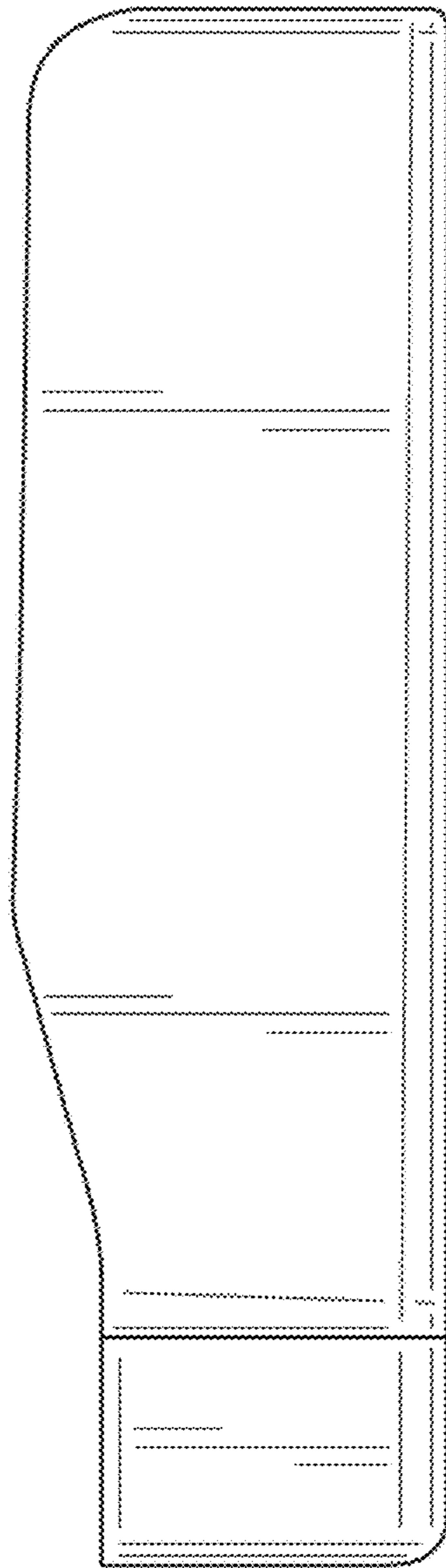

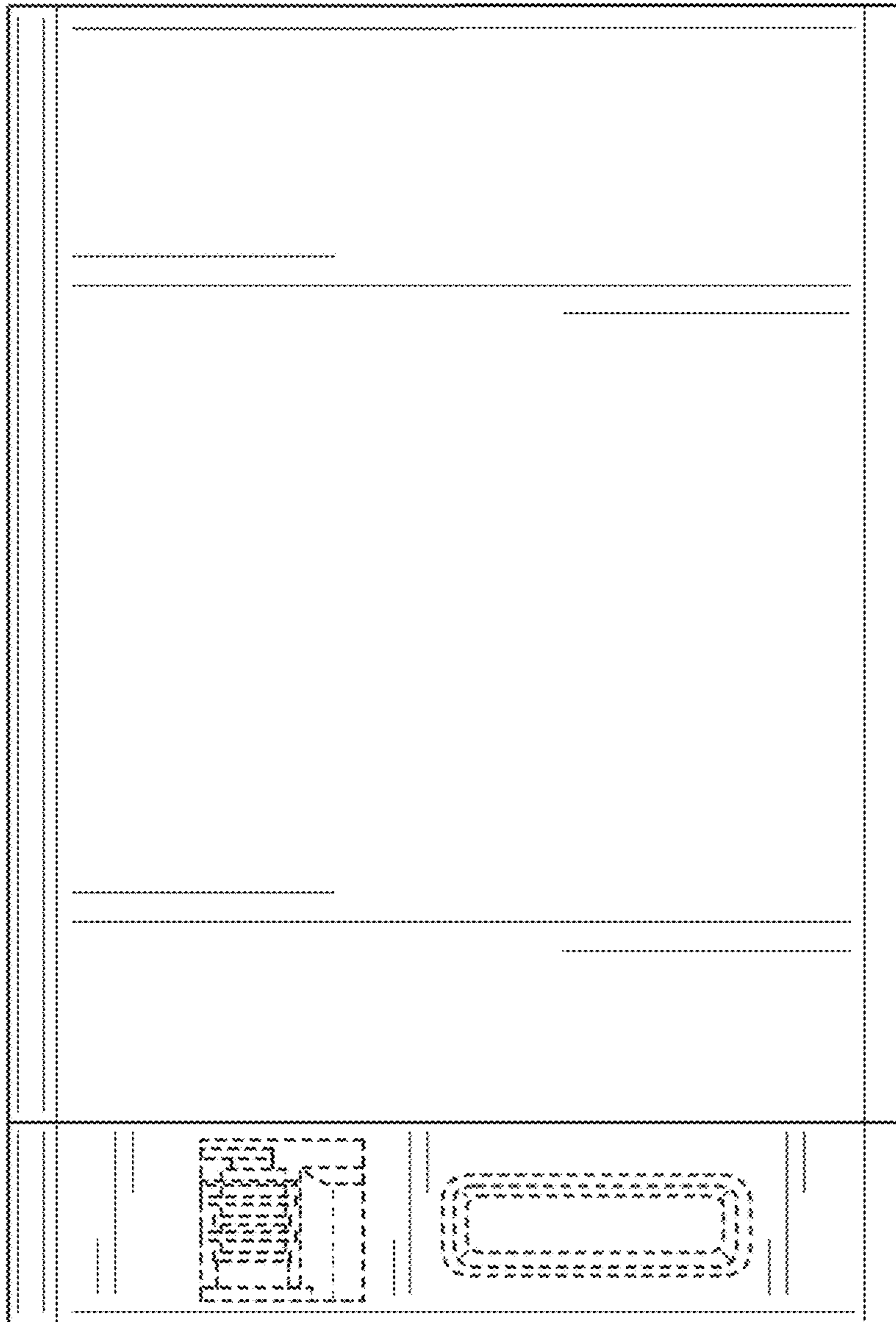

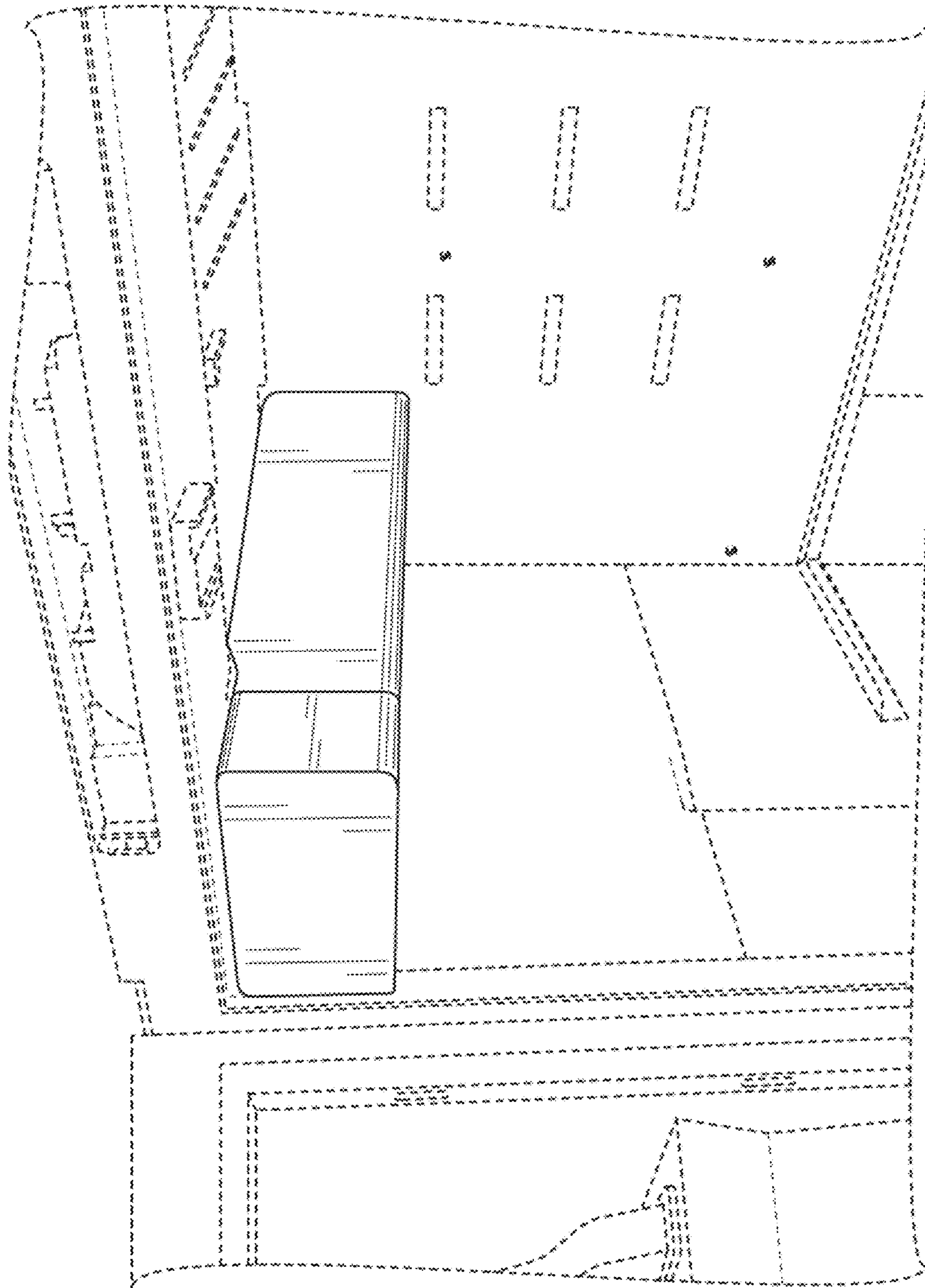
