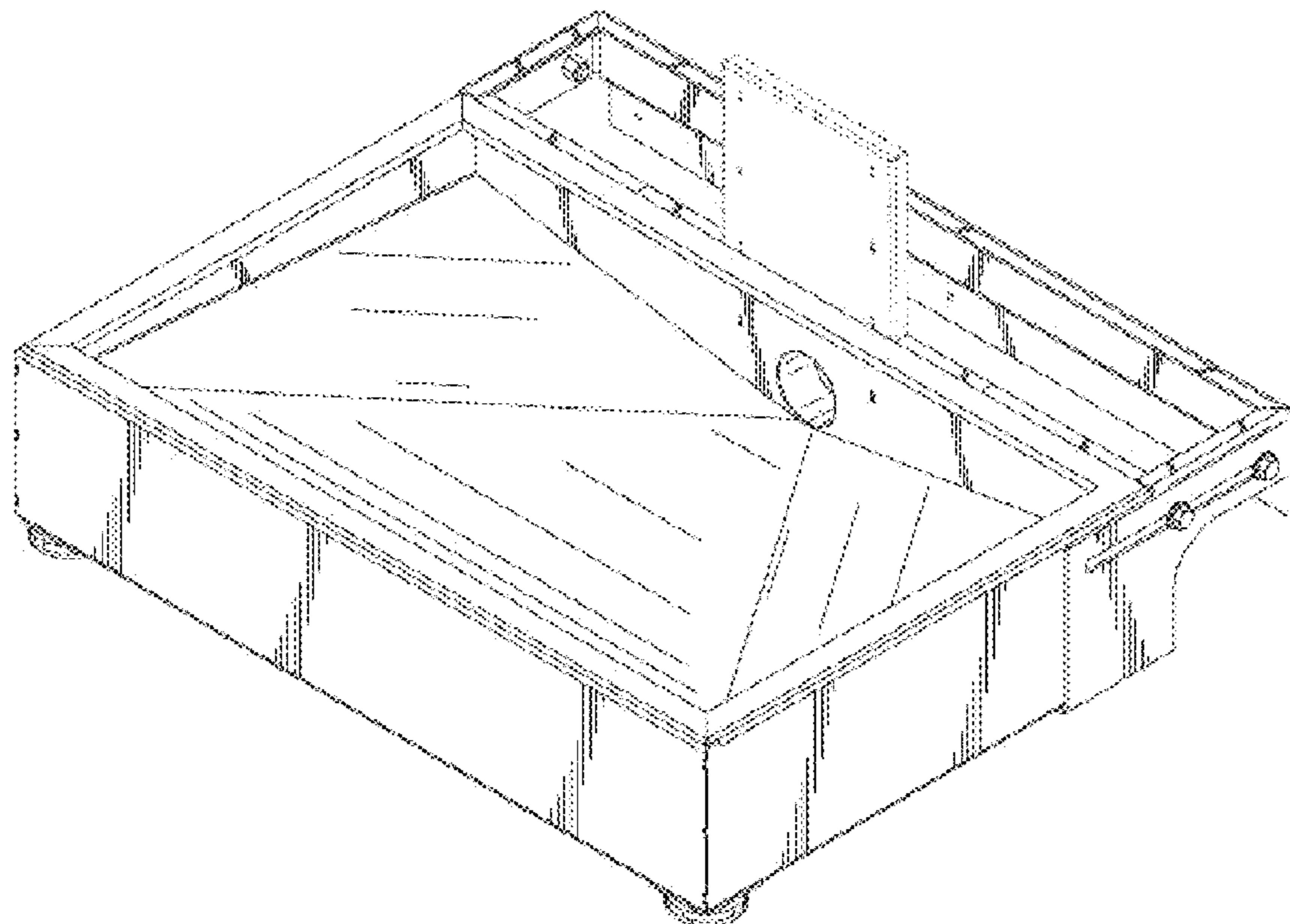
The ornamental design for a catch basin, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view including a front, top and one side of the catch basin;

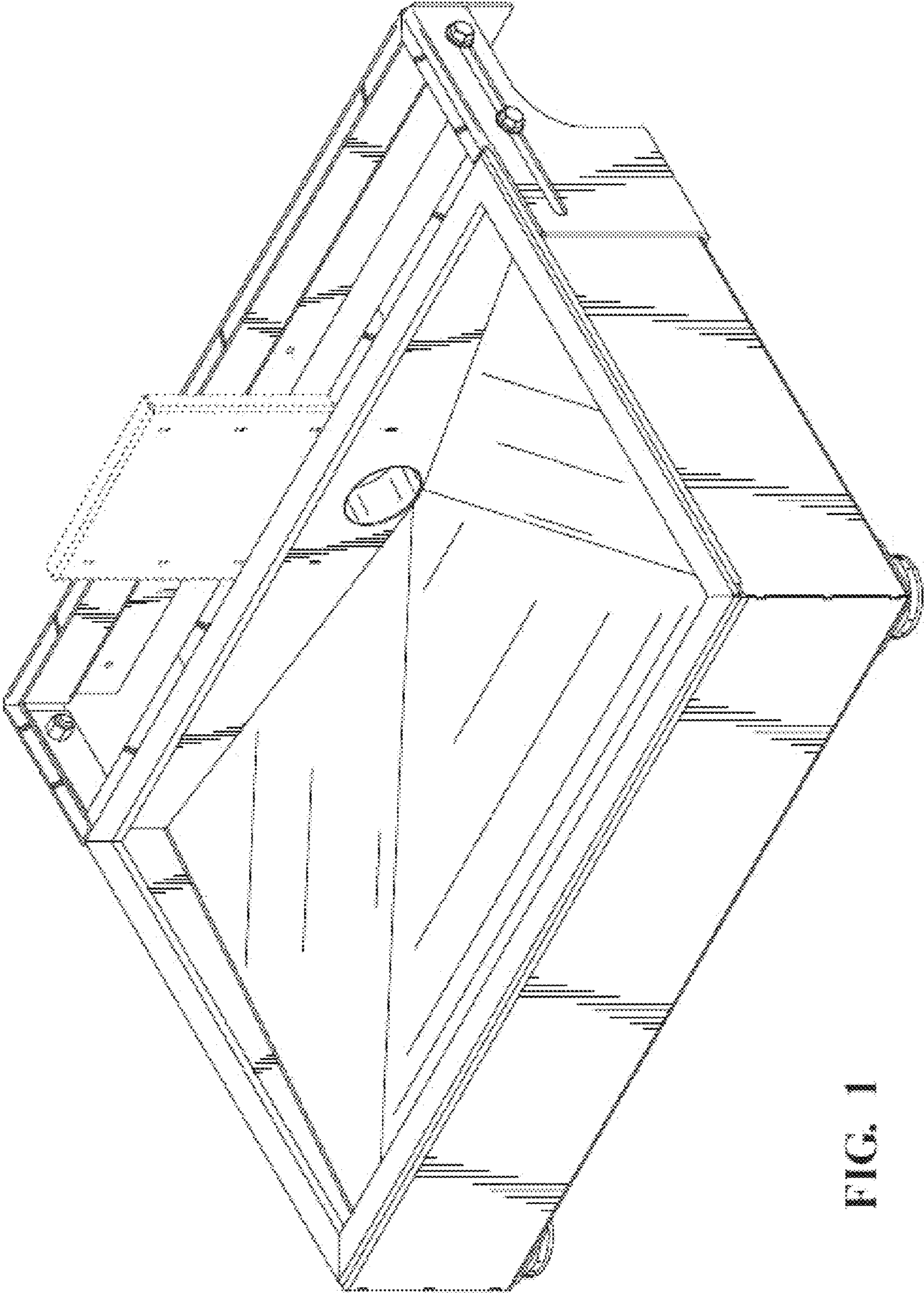

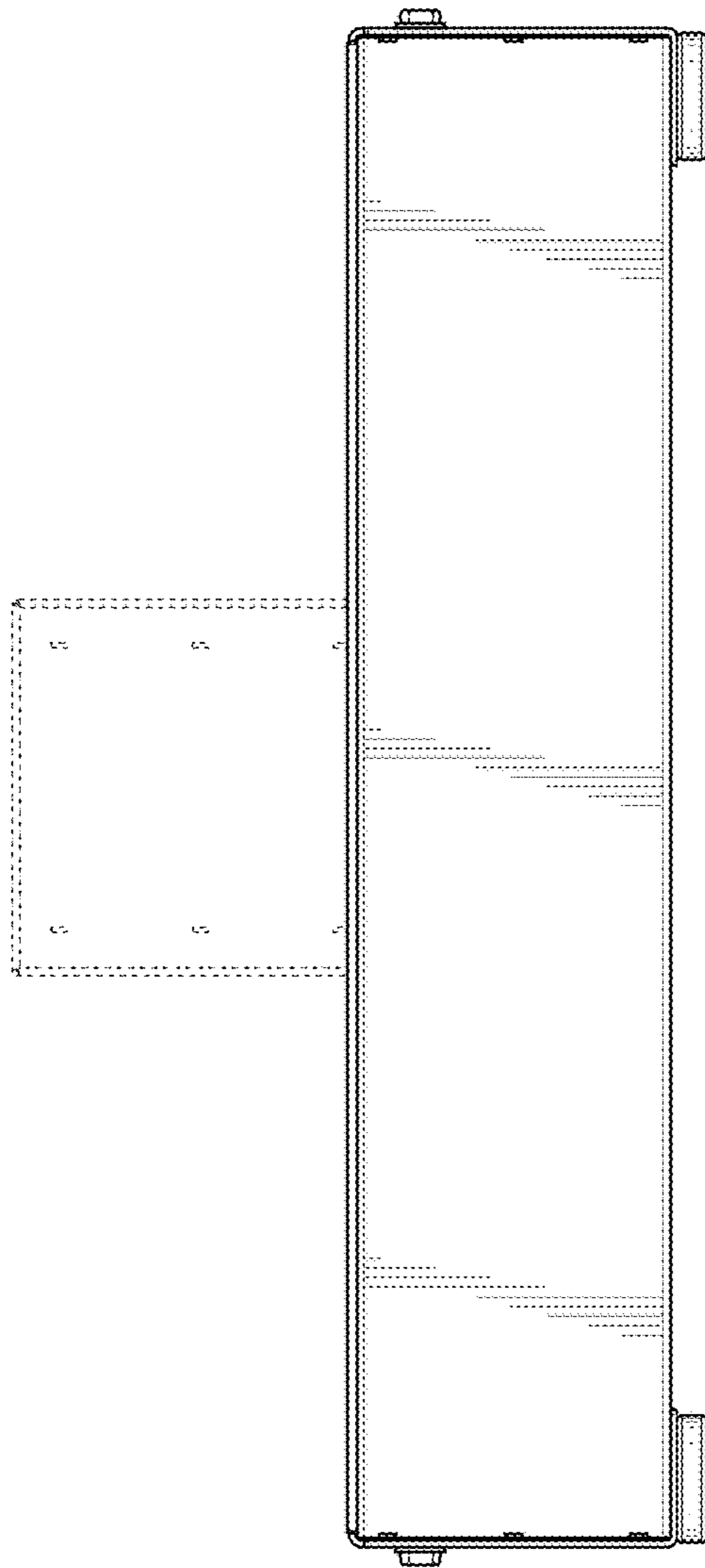

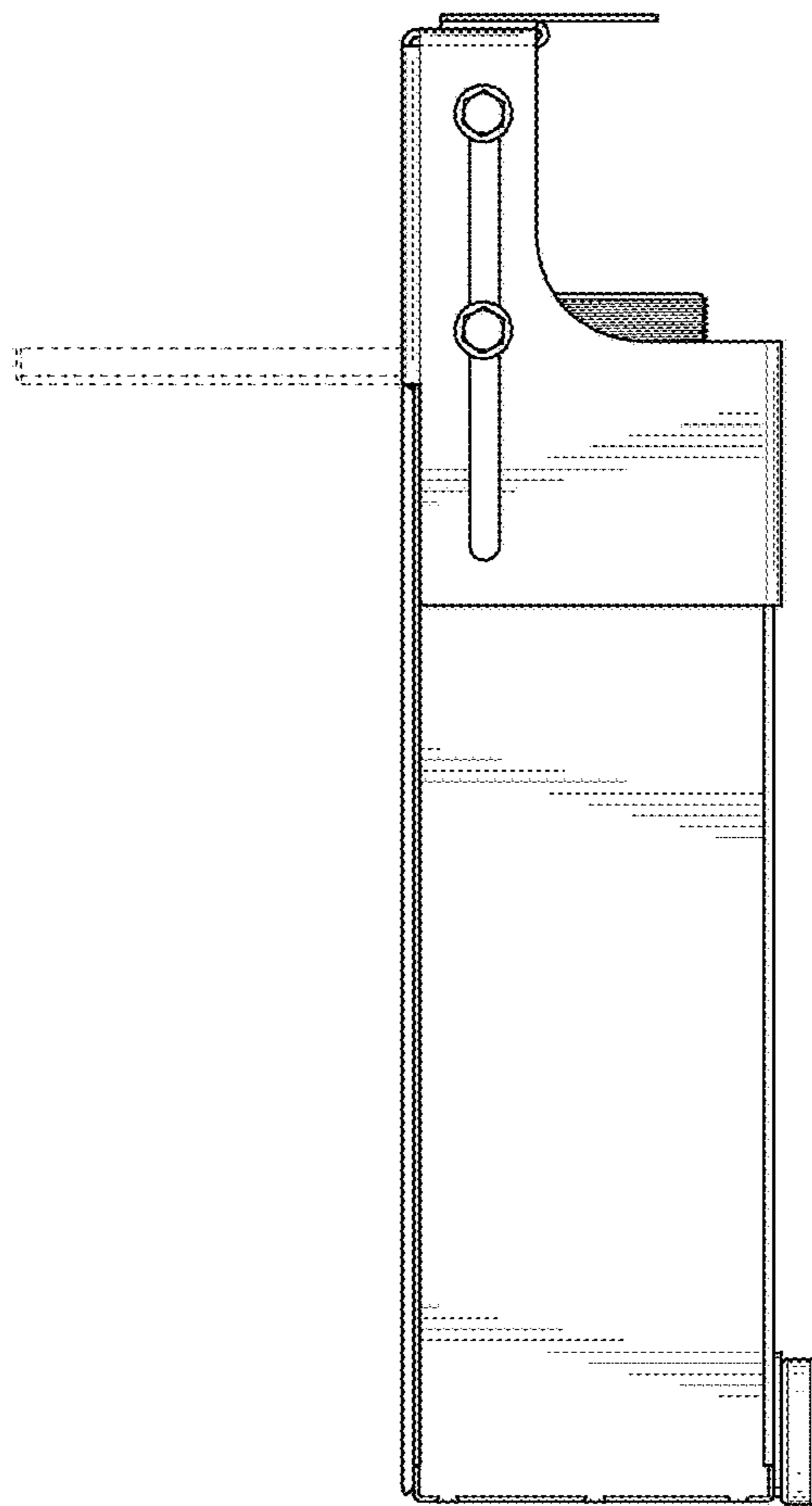

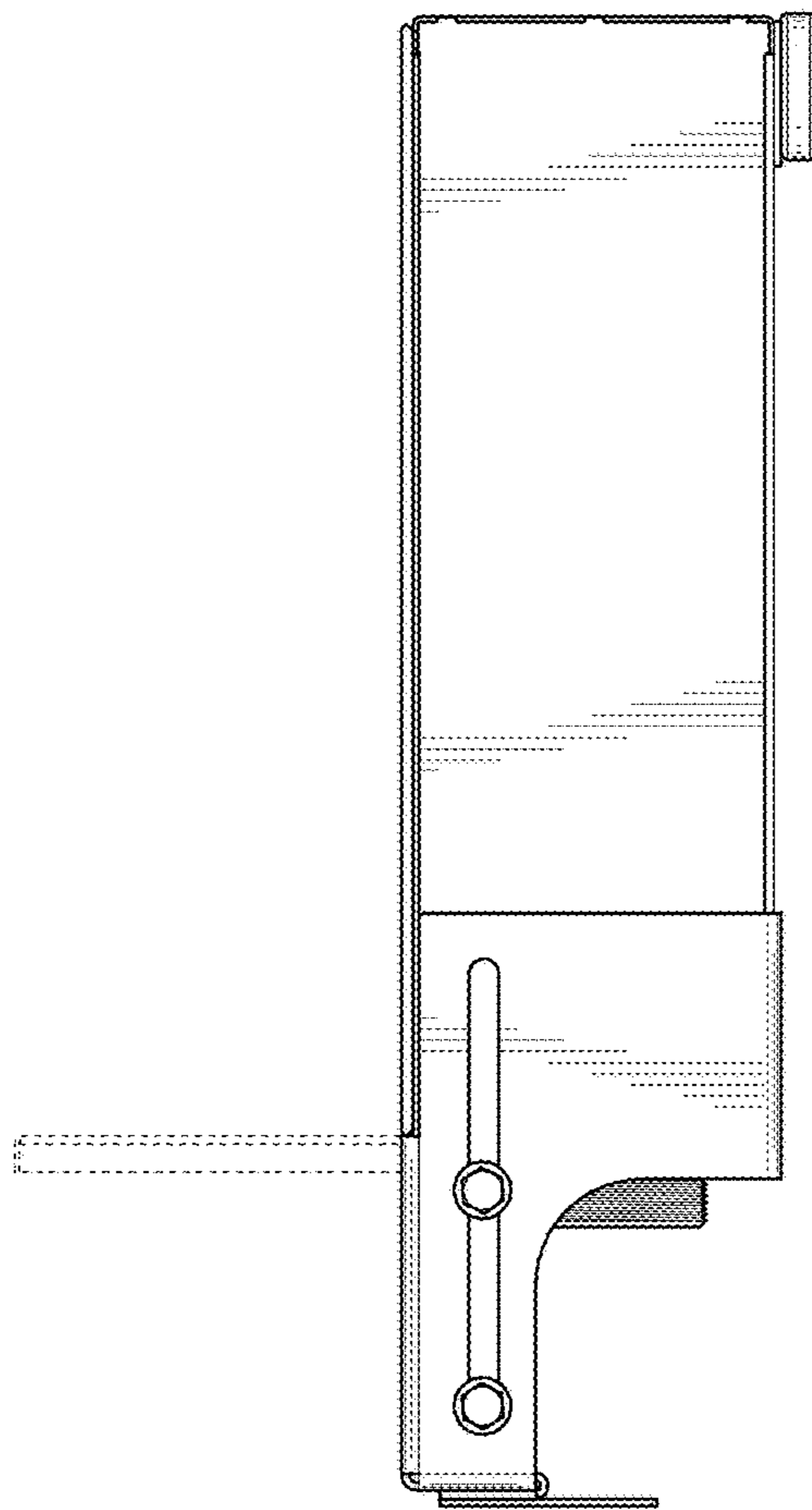

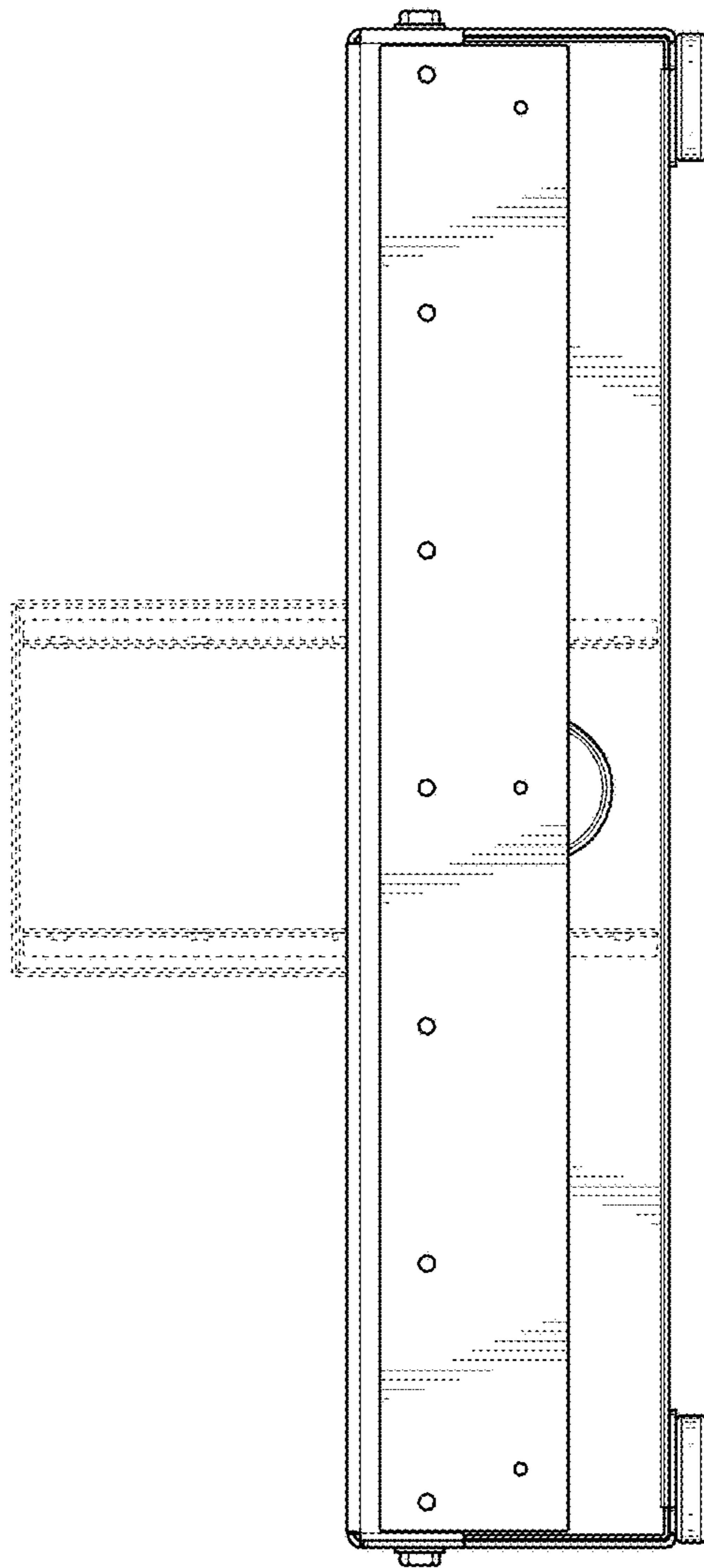

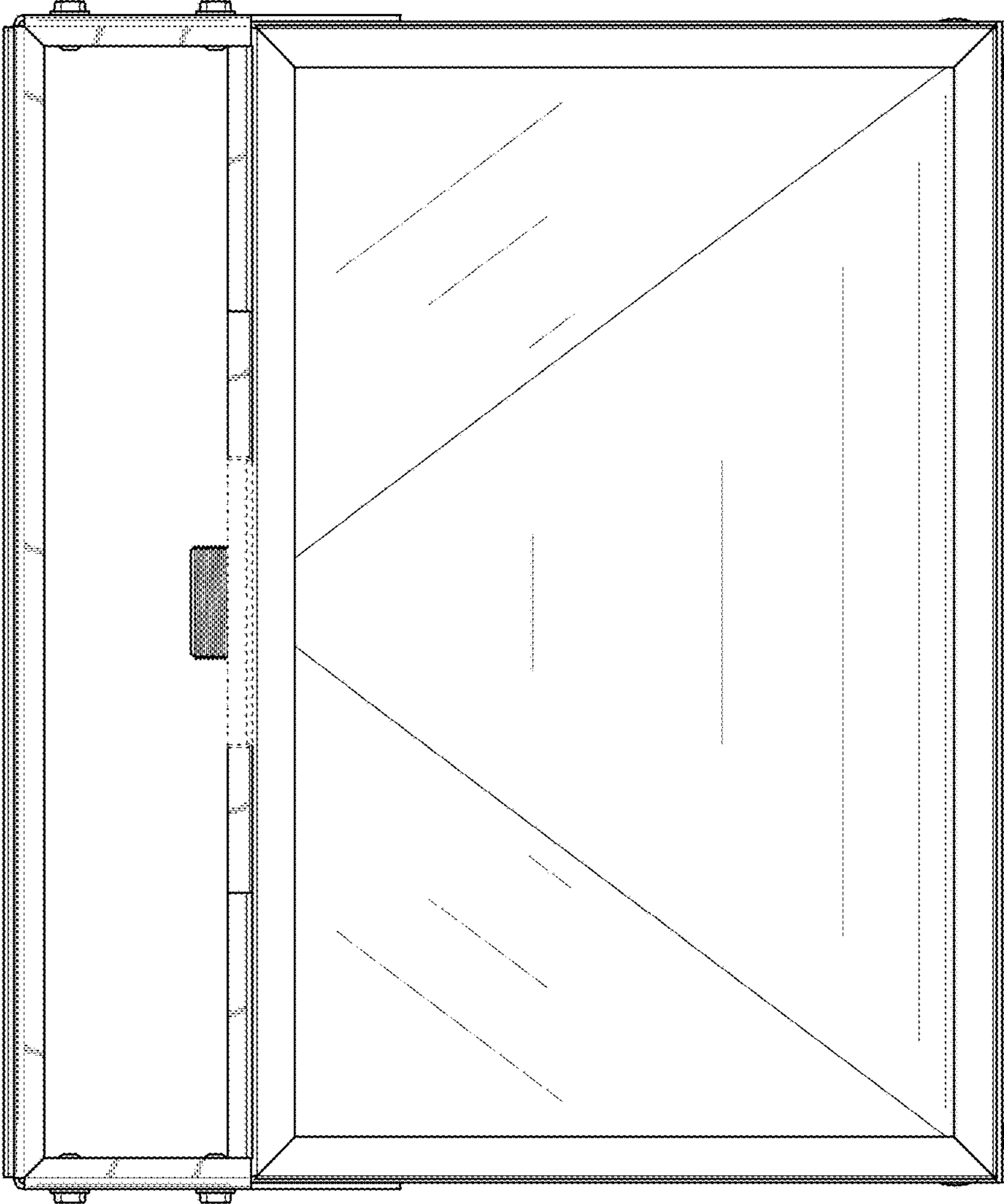

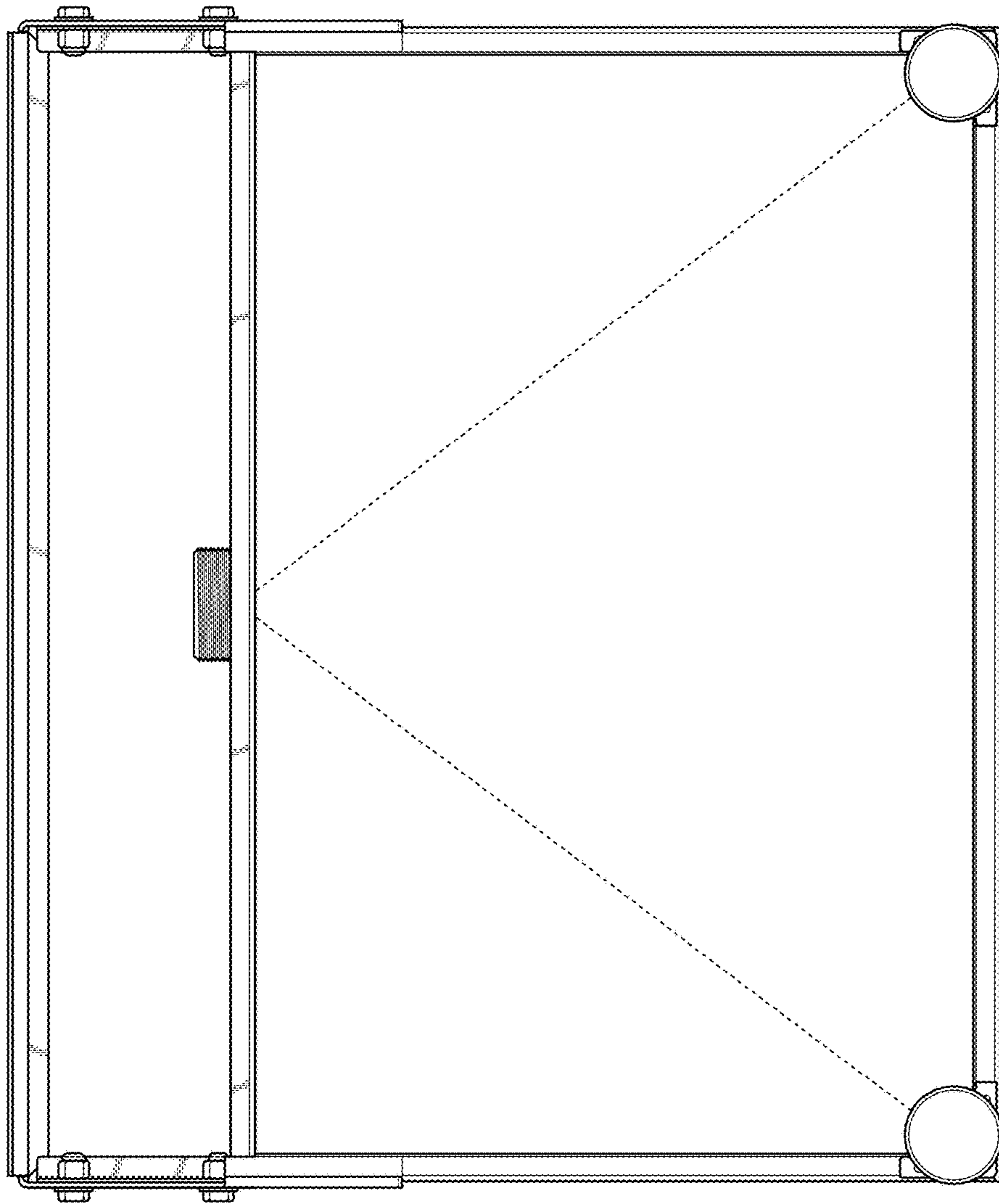
