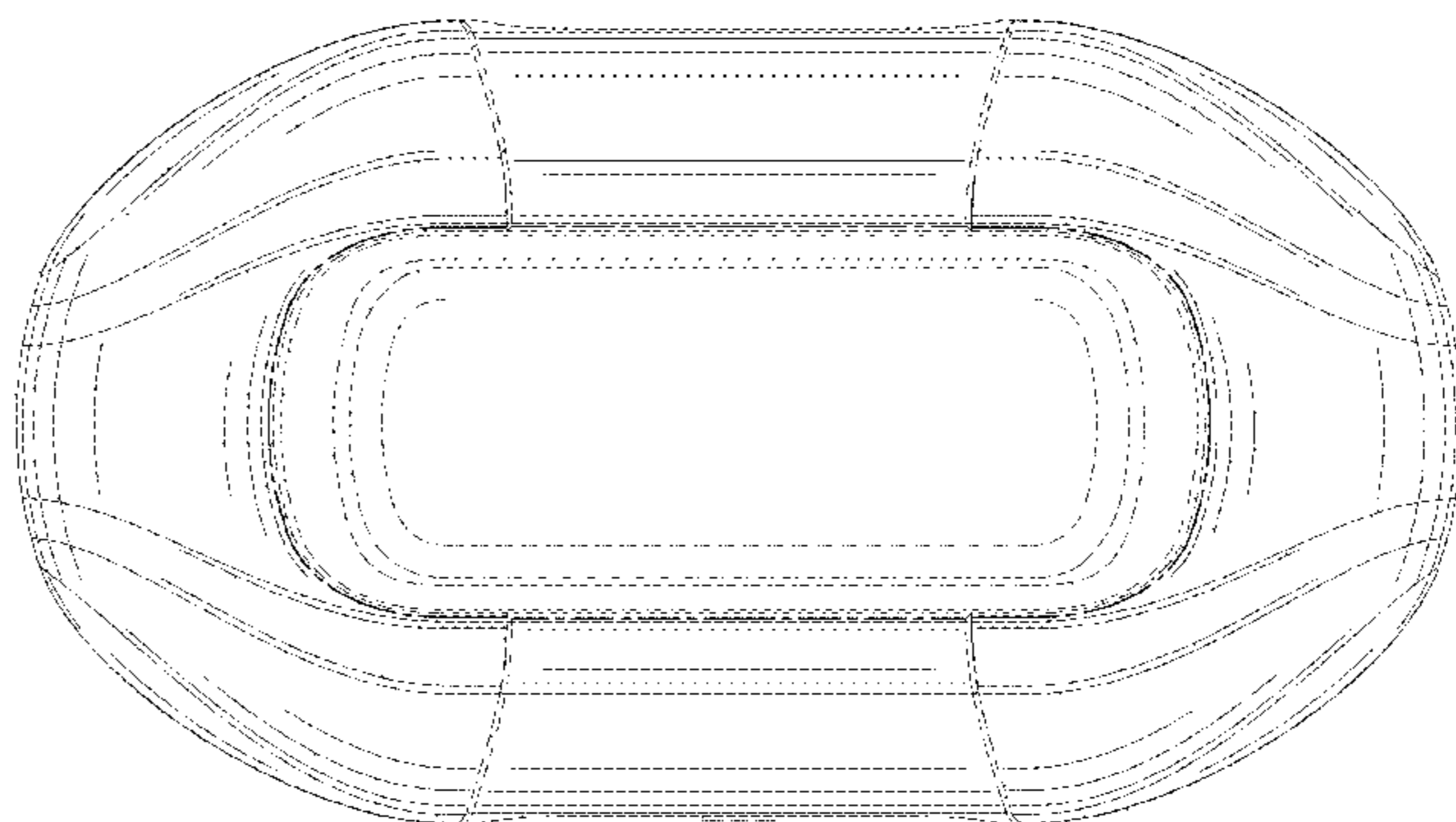
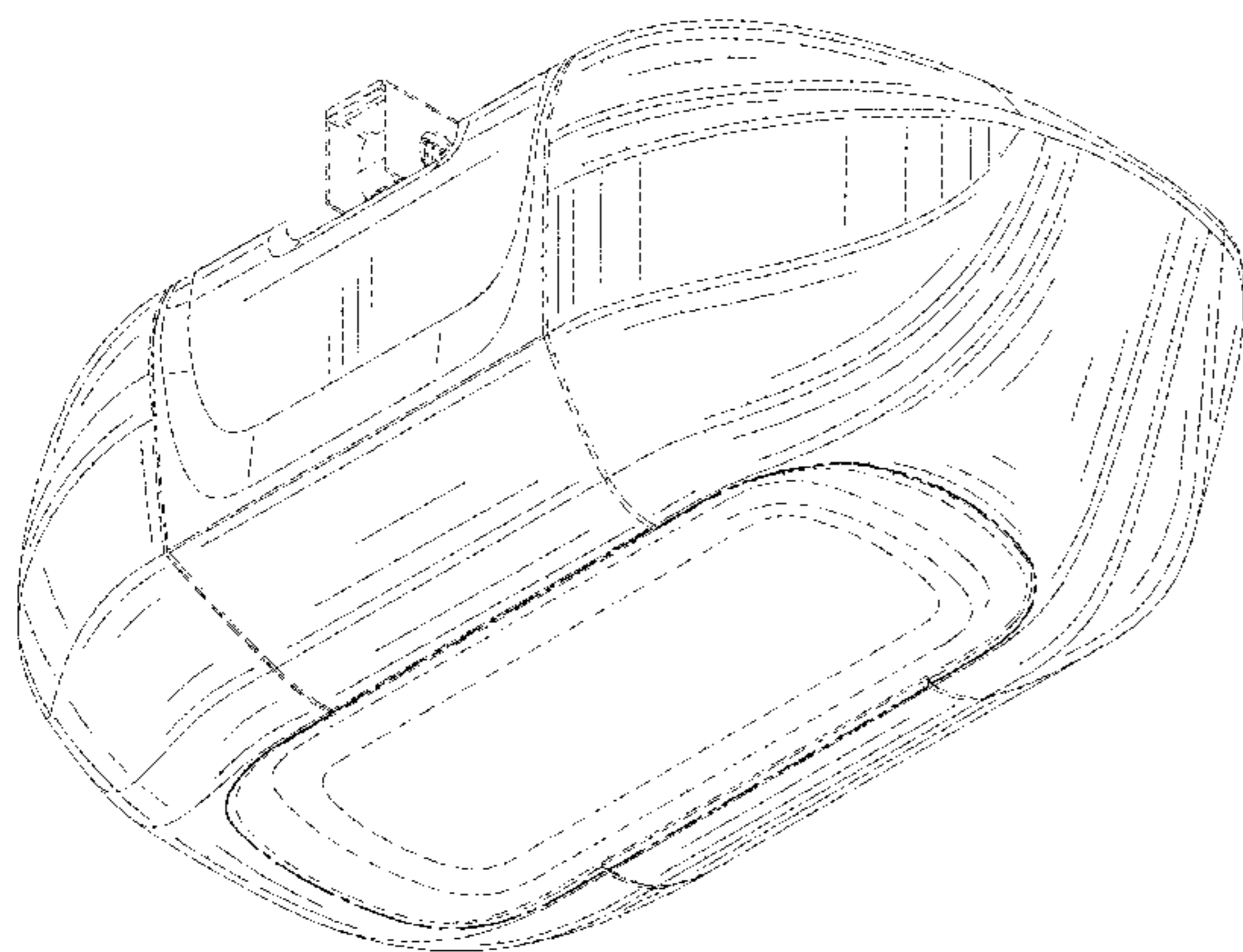
We claim the ornamental design for movable barrier operator device, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the movable barrier operator device showing our new design; FIG. 2 is a top perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a right side elevation view thereof; and, FIG. 8 is a left side elevation view thereof.

The broken lines in the drawings depict portions of the movable barrier operator device that form no part of the claimed design. The dash-dot-dash broken lines immediately adjacent to the shaded surfaces form a boundary of the claim and form no part thereof.

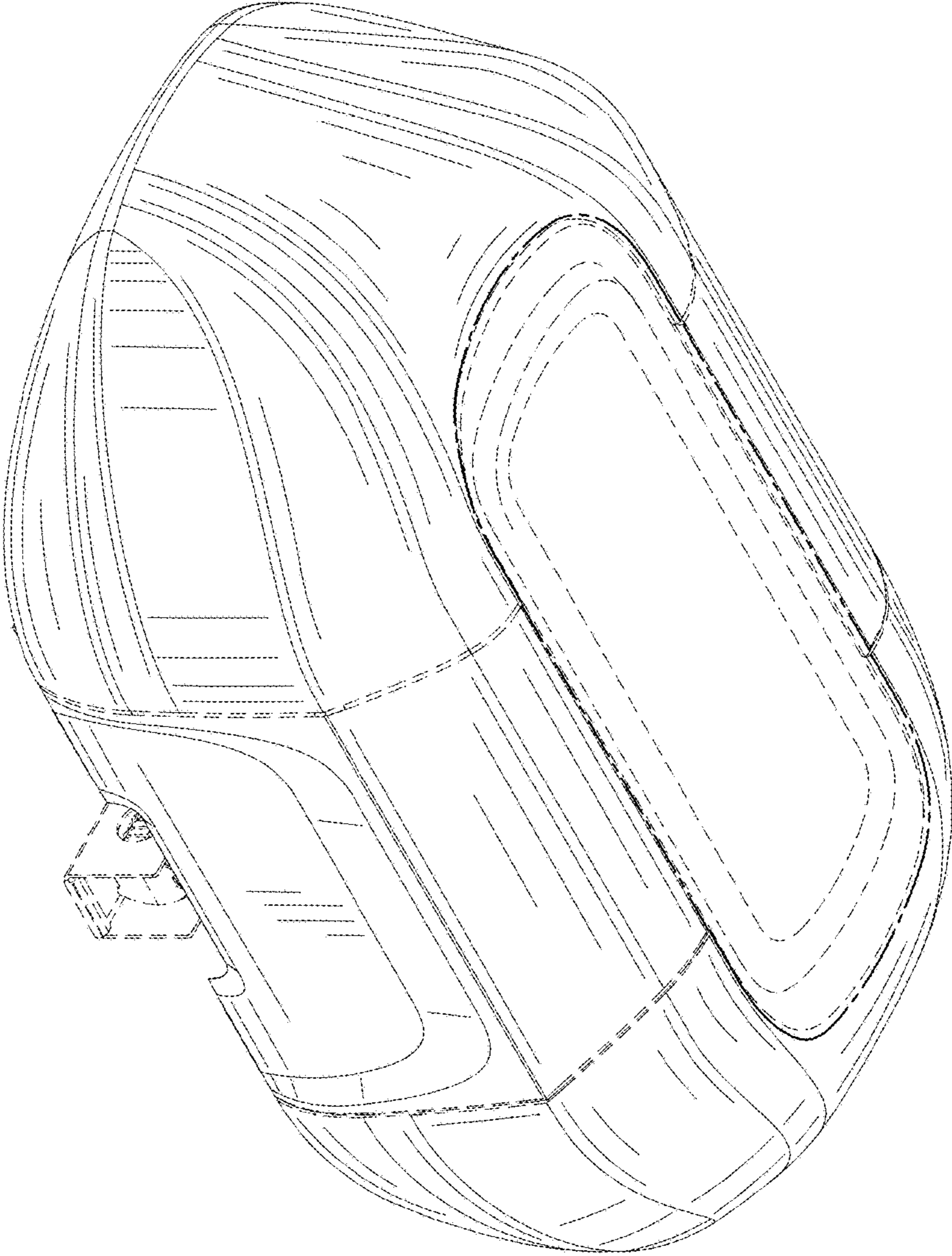

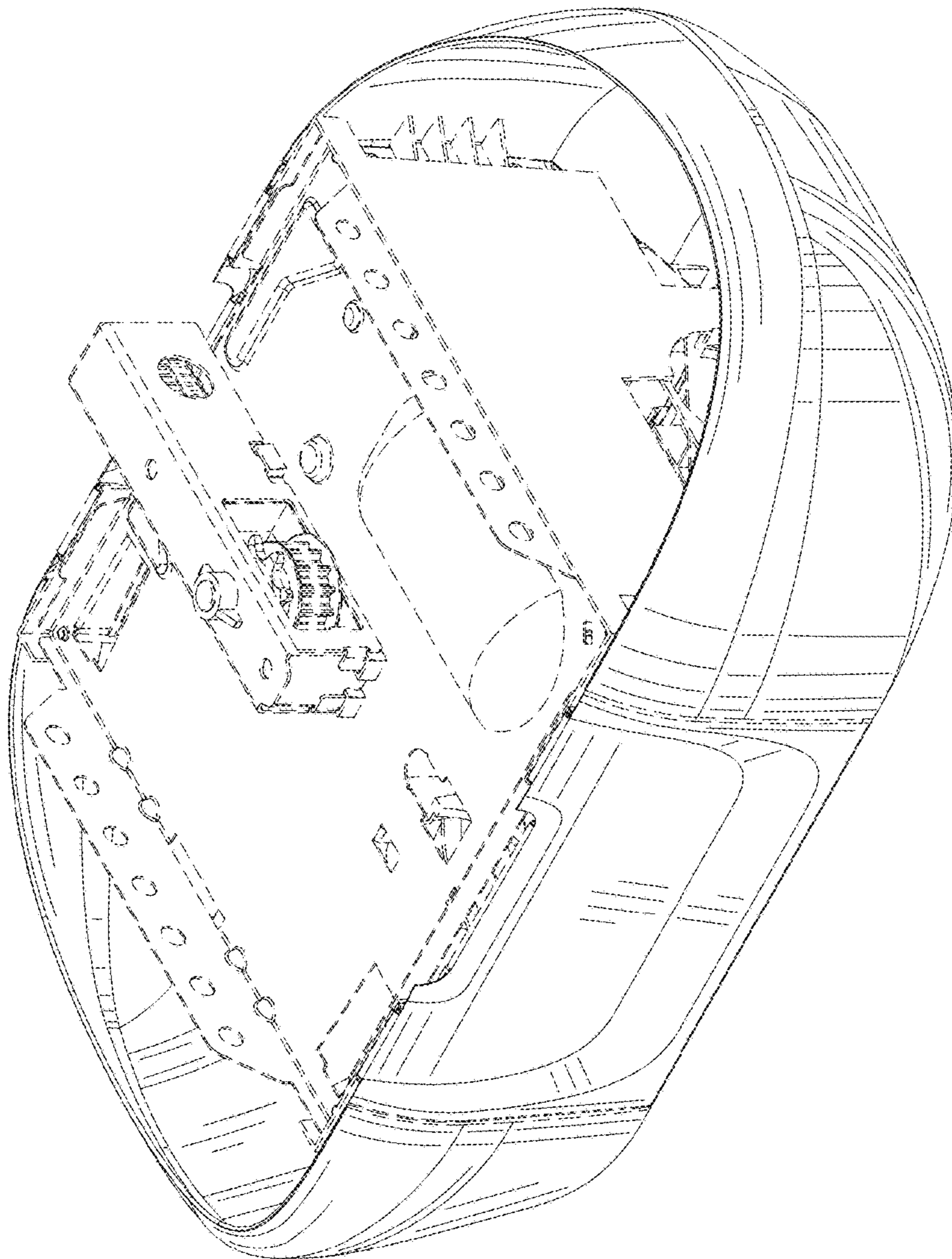

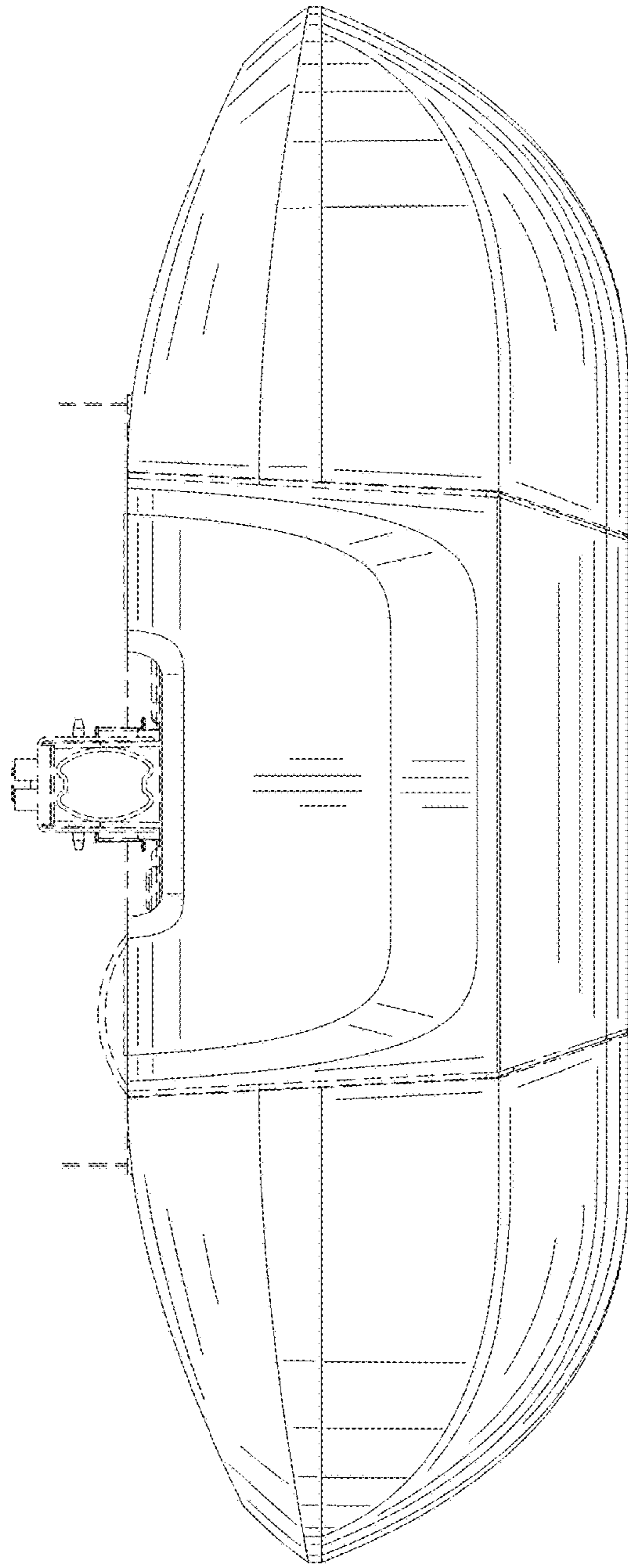

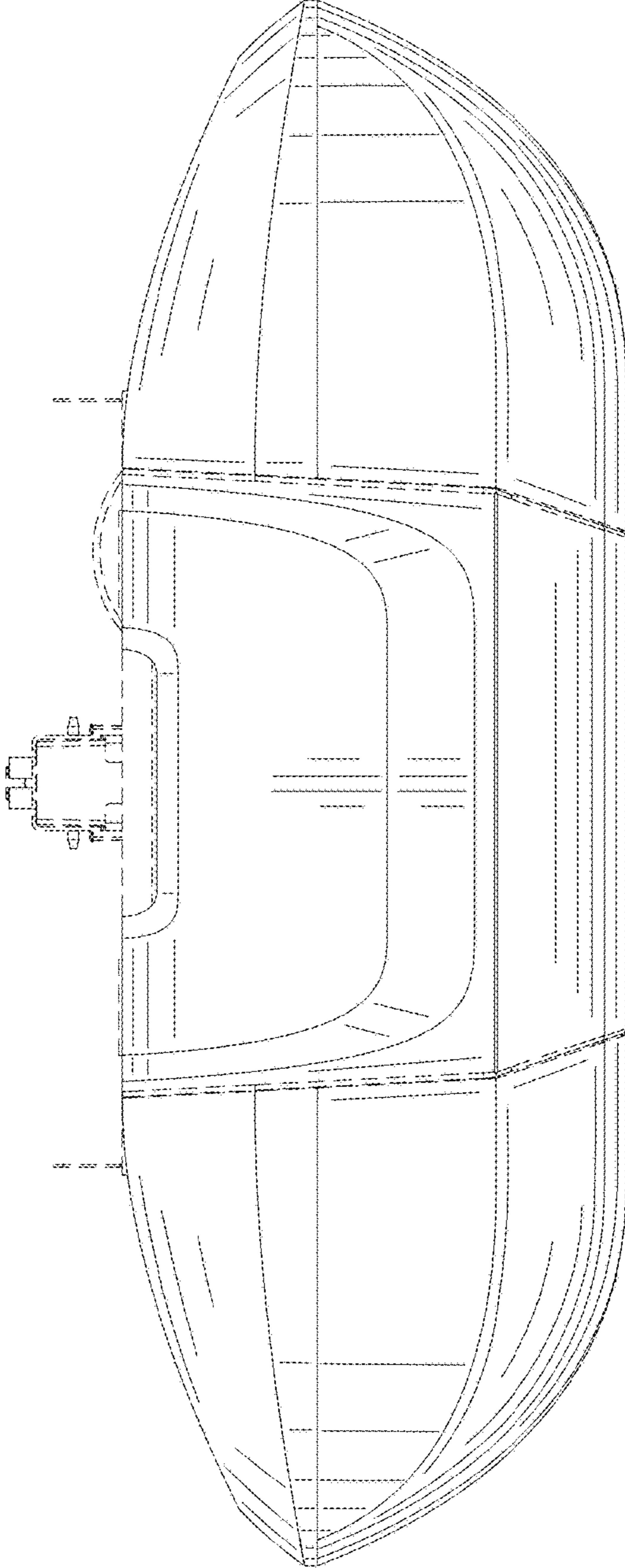

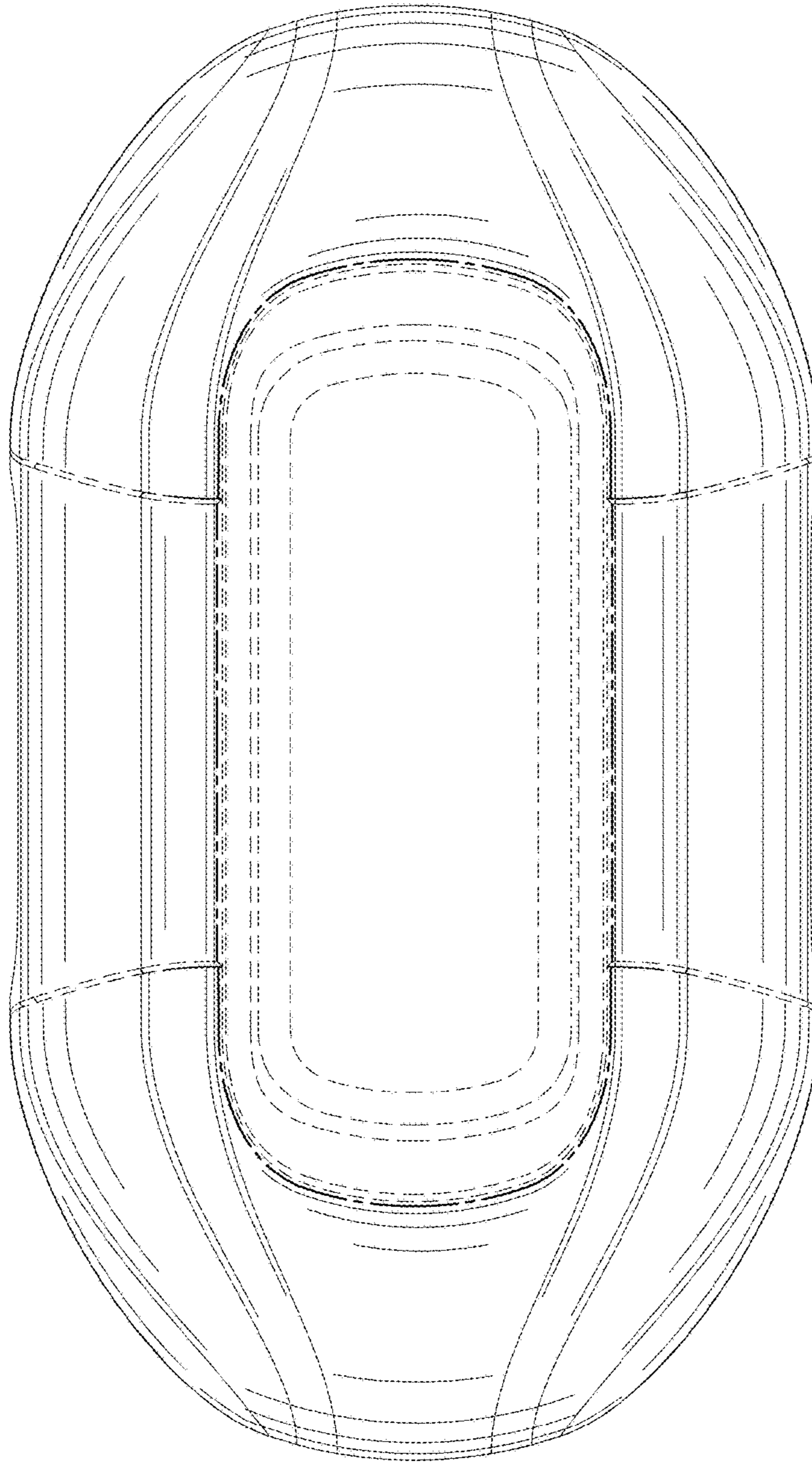

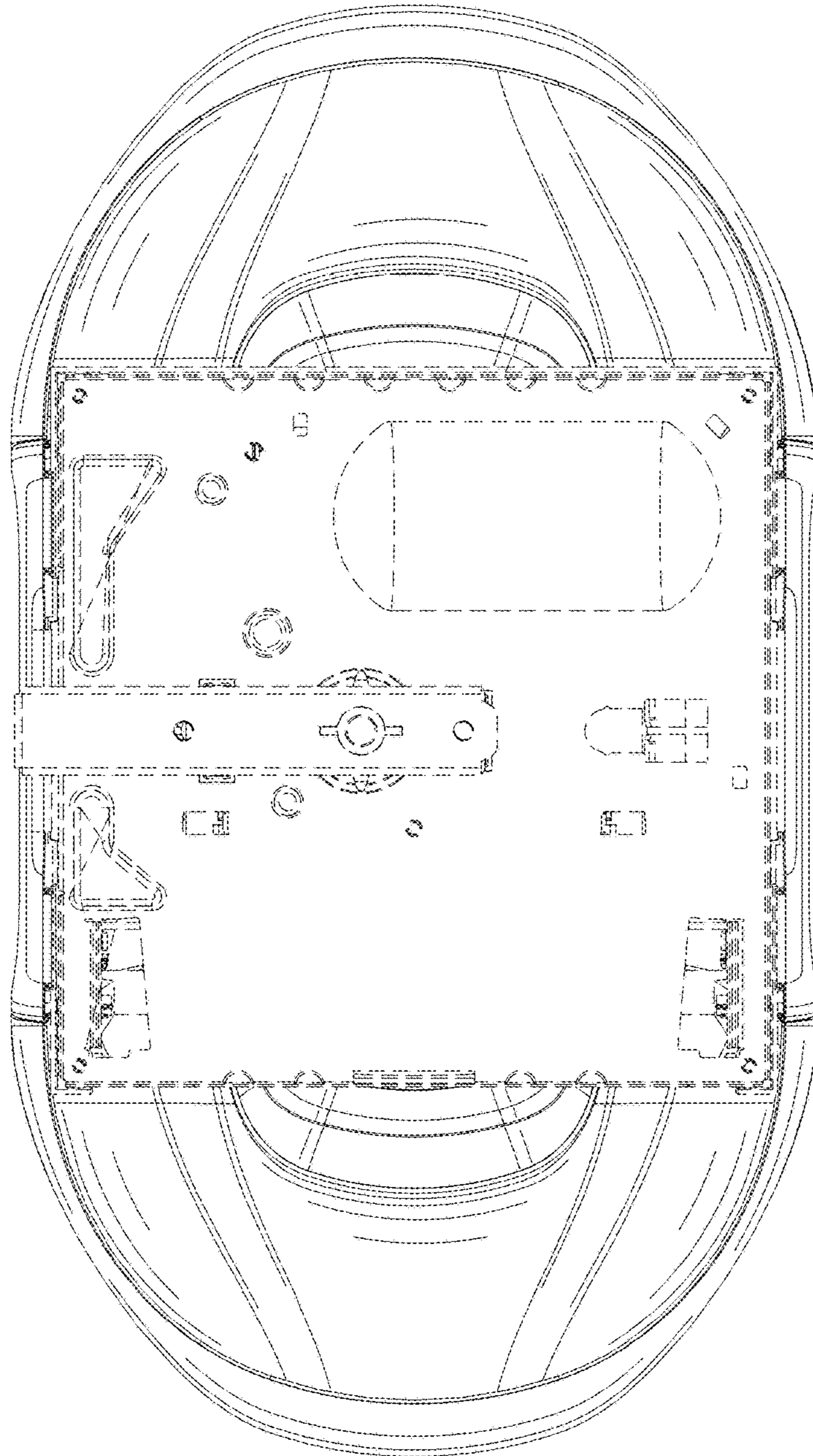

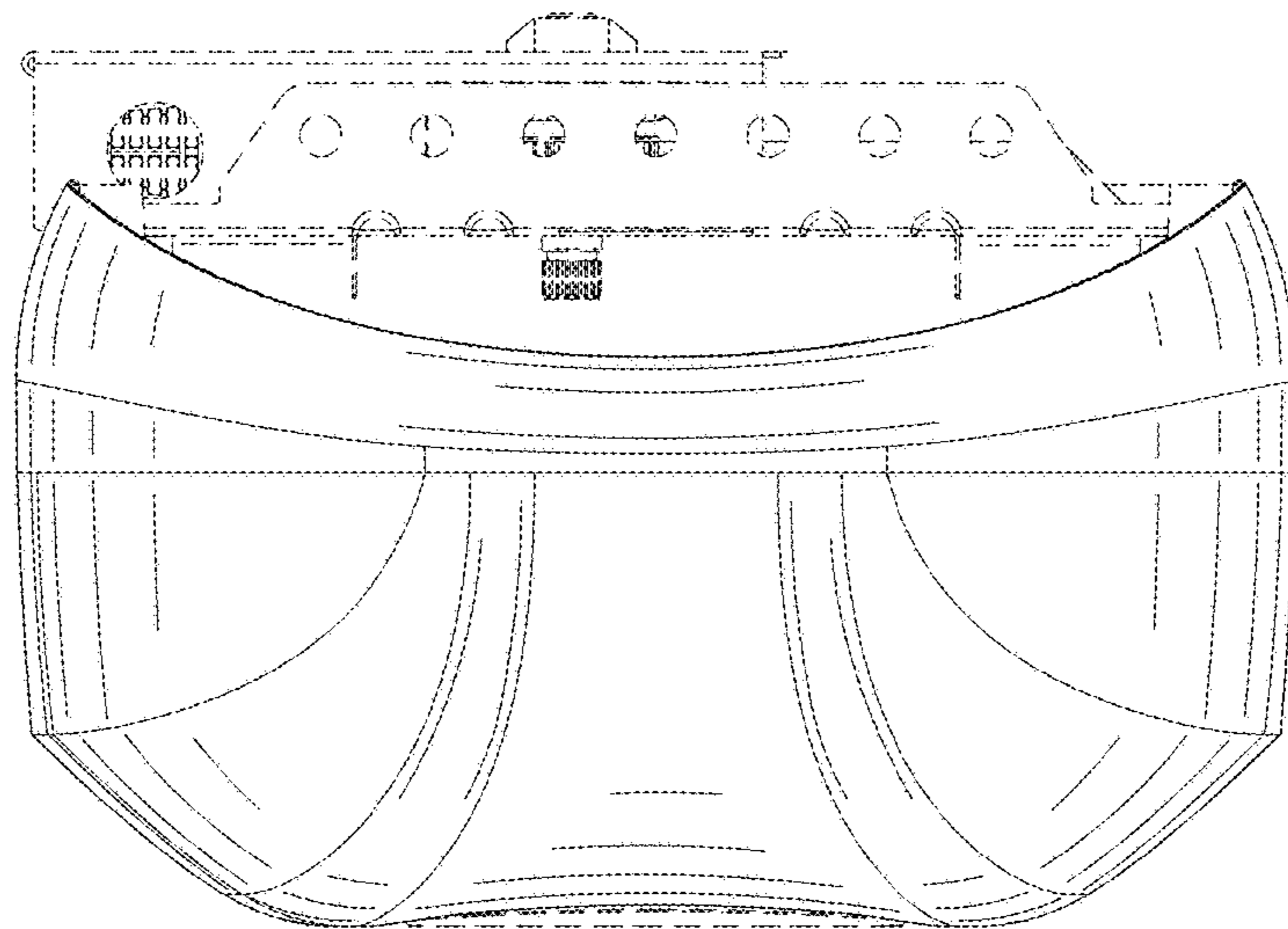

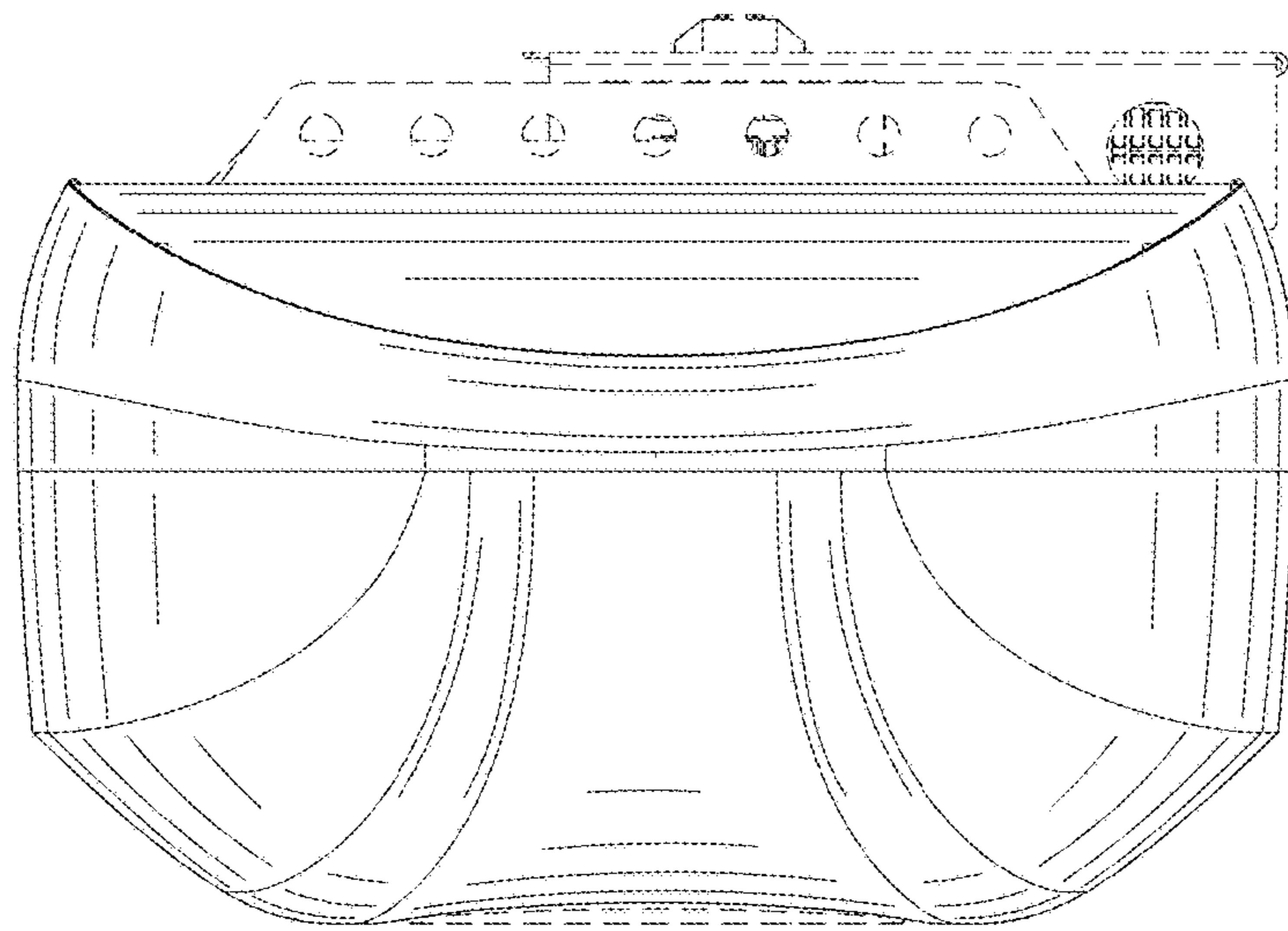
