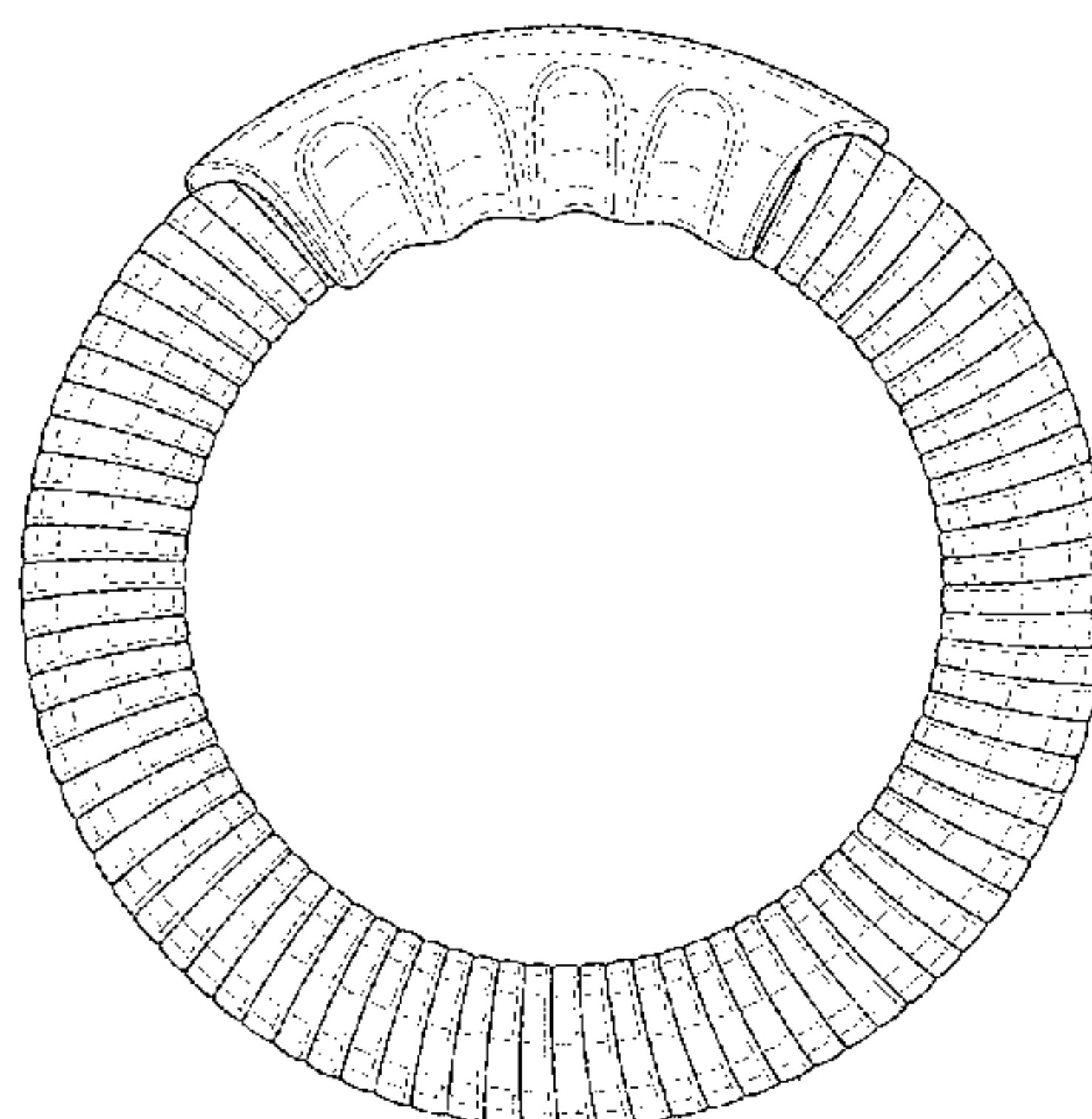
(57) **CLAIM**

The ornamental design for an exercise ring for athletes, recreational users and patients, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of an exercise ring for athletes, recreational users and patients of a first embodiment. The opposite side is a mirror image of the shown side. FIG. 2 is a perspective view showing a top, one side and an inside opposite the top of the exercise ring for athletes, recreational users and patients shown in FIG. 1. FIG. 3 is a enlarged detail perspective view of an underside of the top of the exercise ring for athletes, recreational users and patients shown in FIGS. 1 and 2. FIG. 4 is a side elevation of an exercise ring for athletes, recreational users and patients of a second embodiment. The opposite side is a mirror image of the shown side. FIG. 5 is a bottom rear side perspective view thereof. FIG. 6 is a top rear side perspective view thereof; and, FIG. 7 is another top rear side perspective view thereof taken from the opposite side shown in FIG. 6.

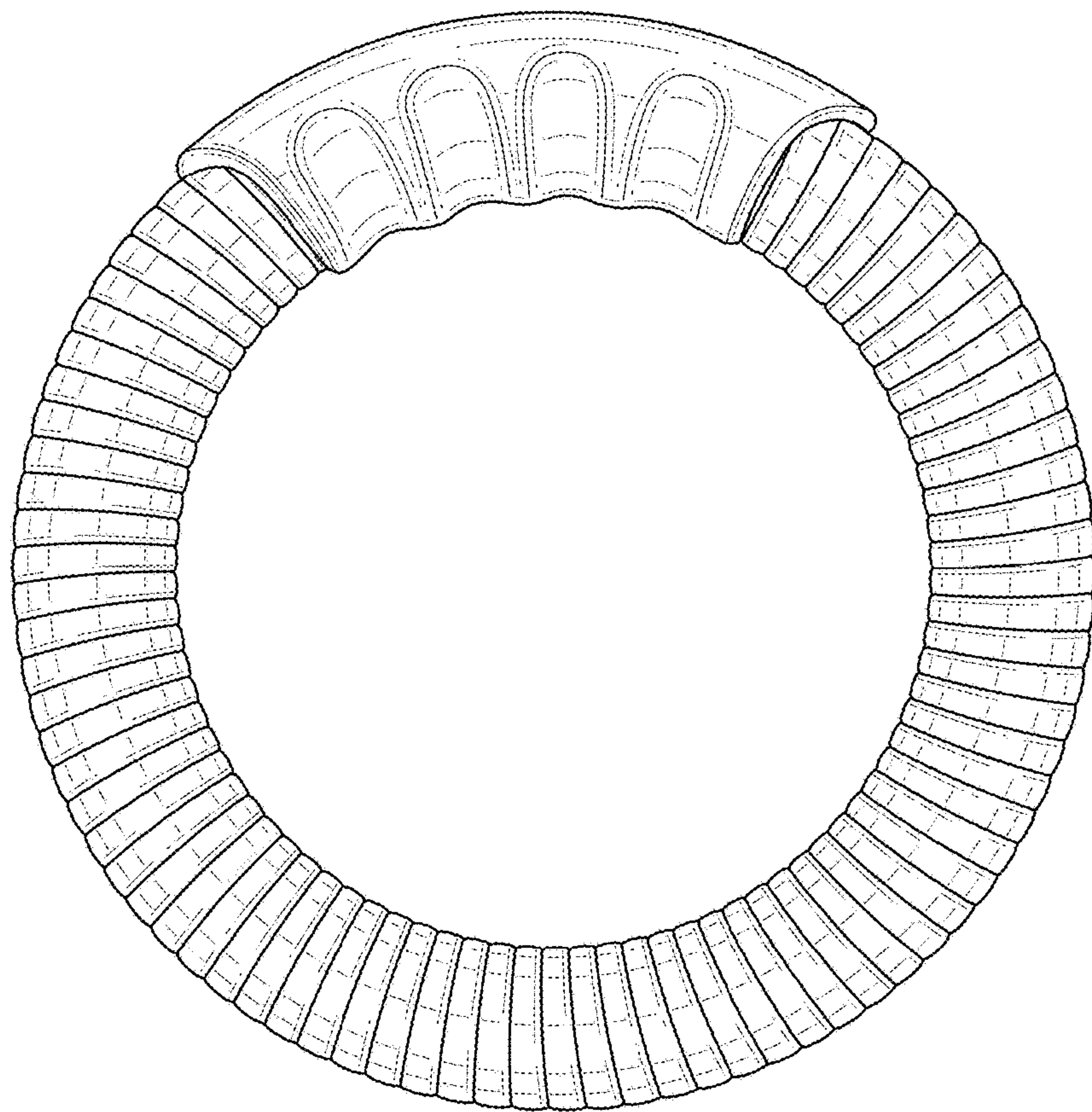

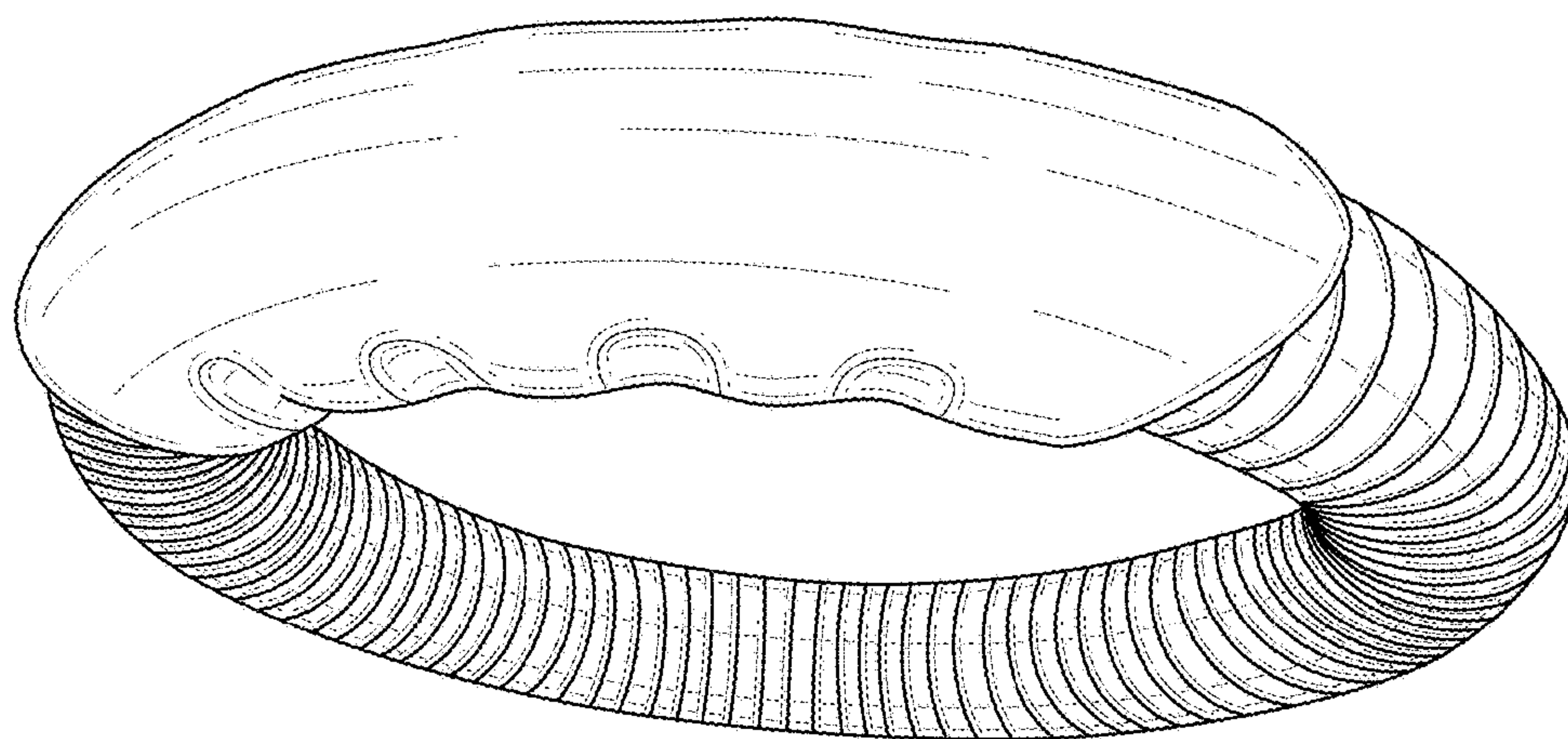

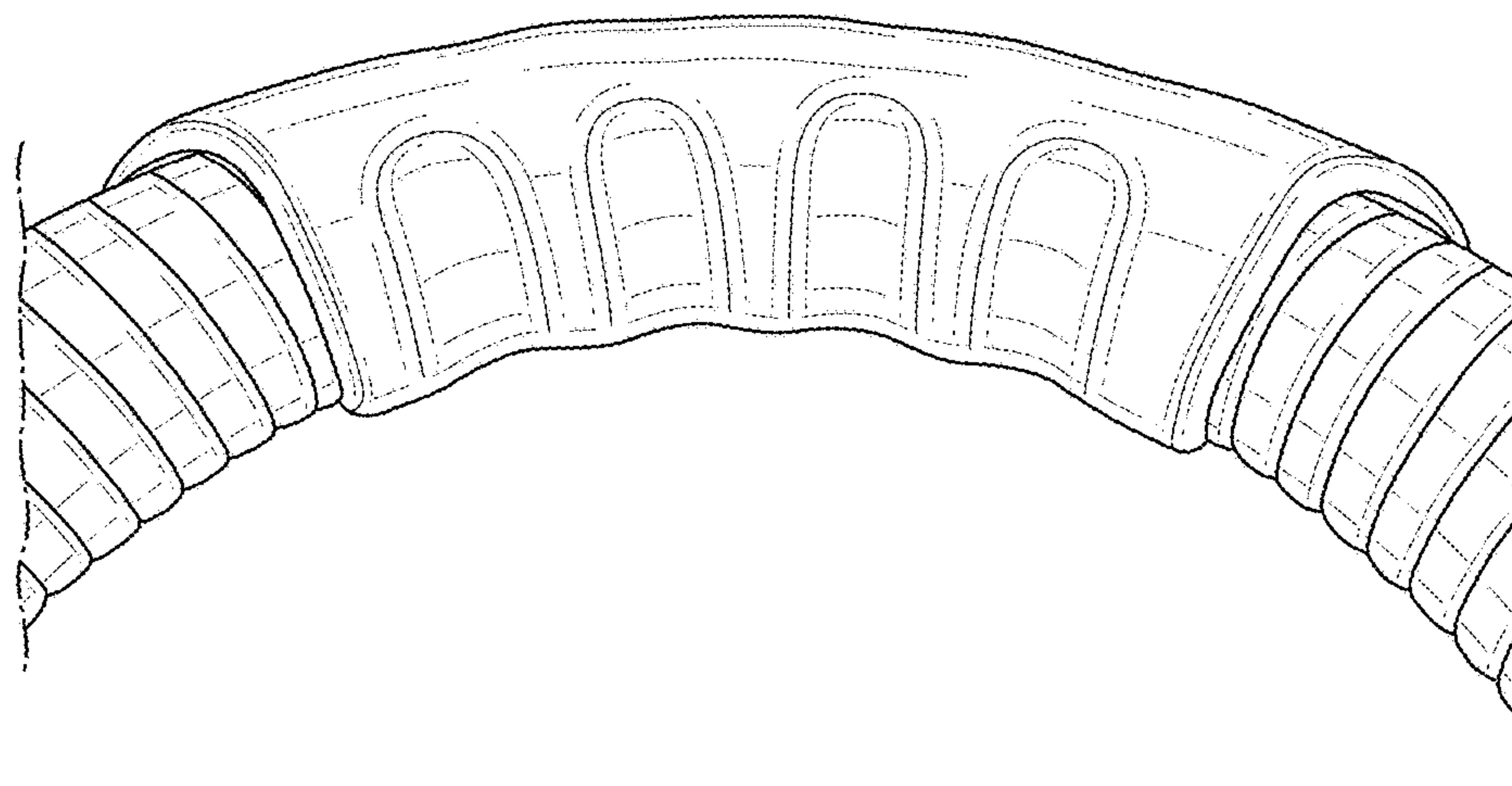

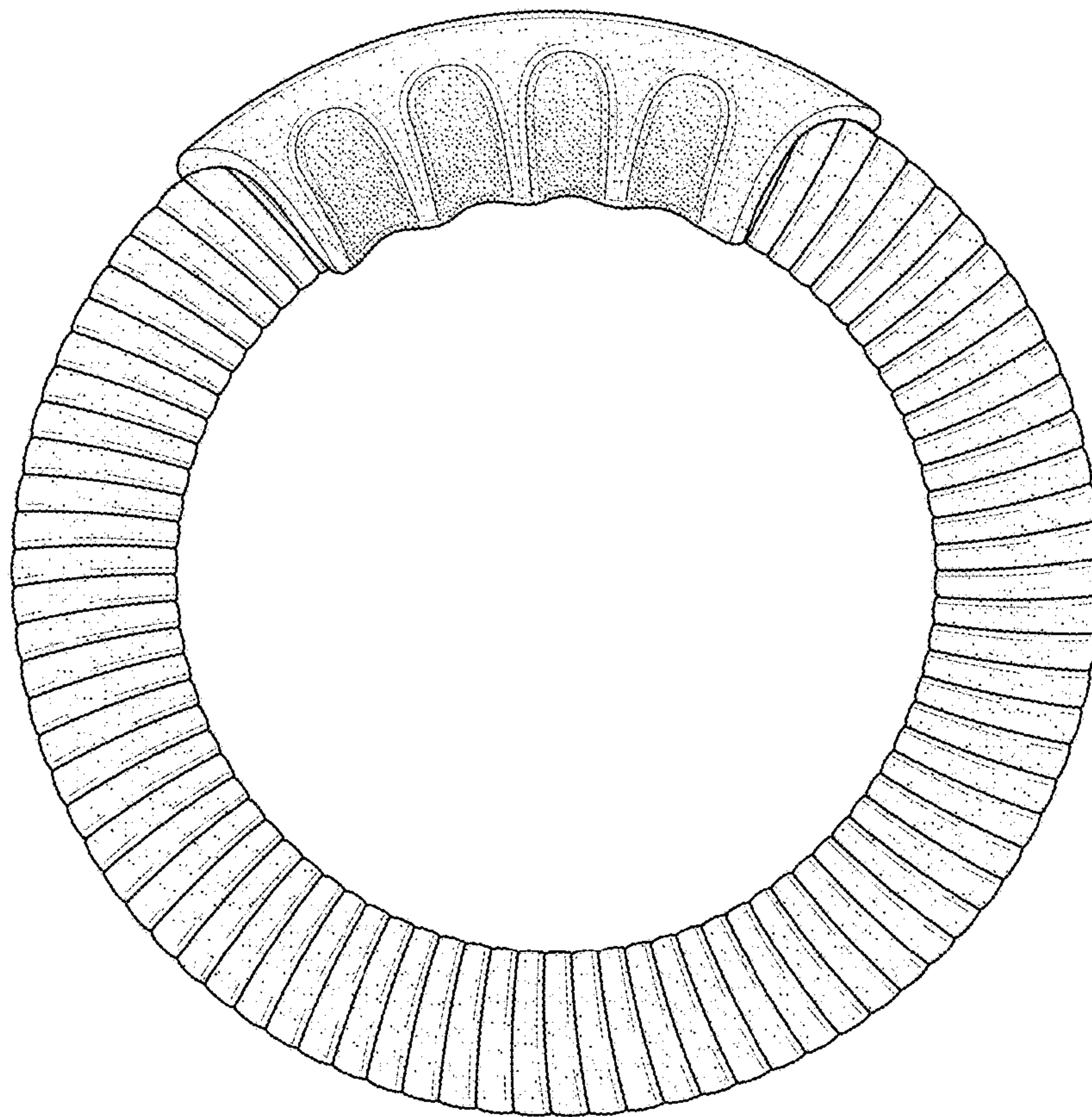

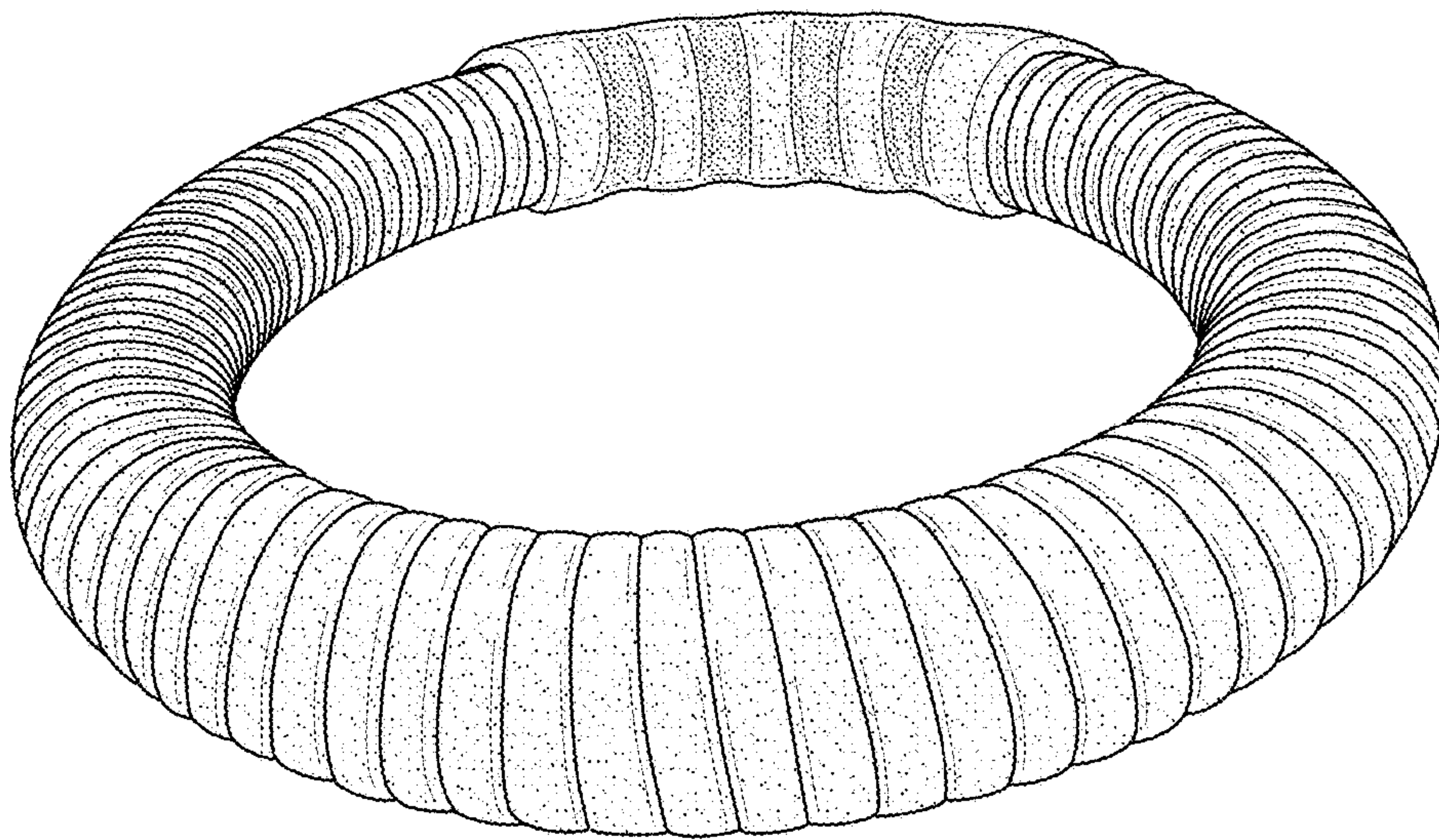

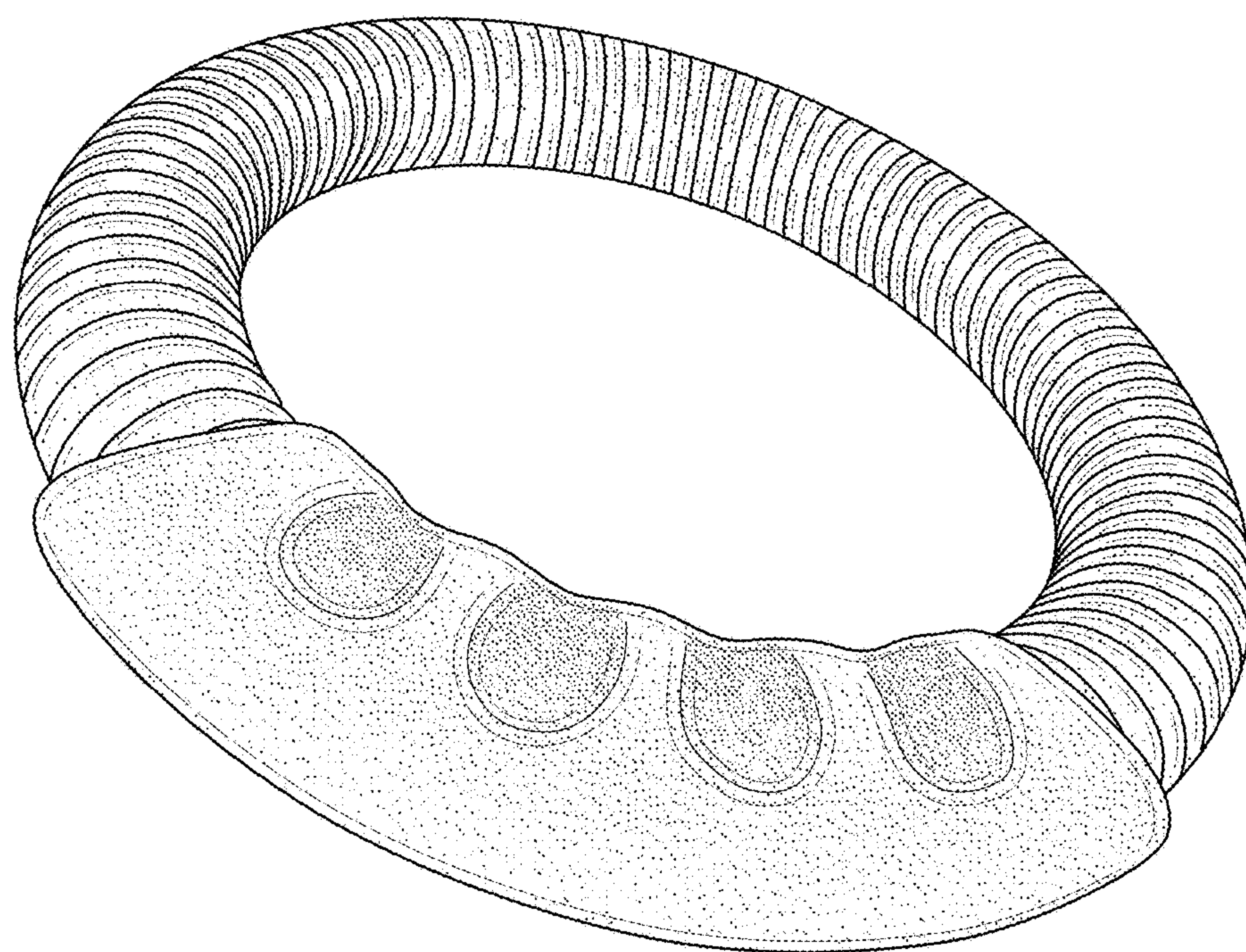

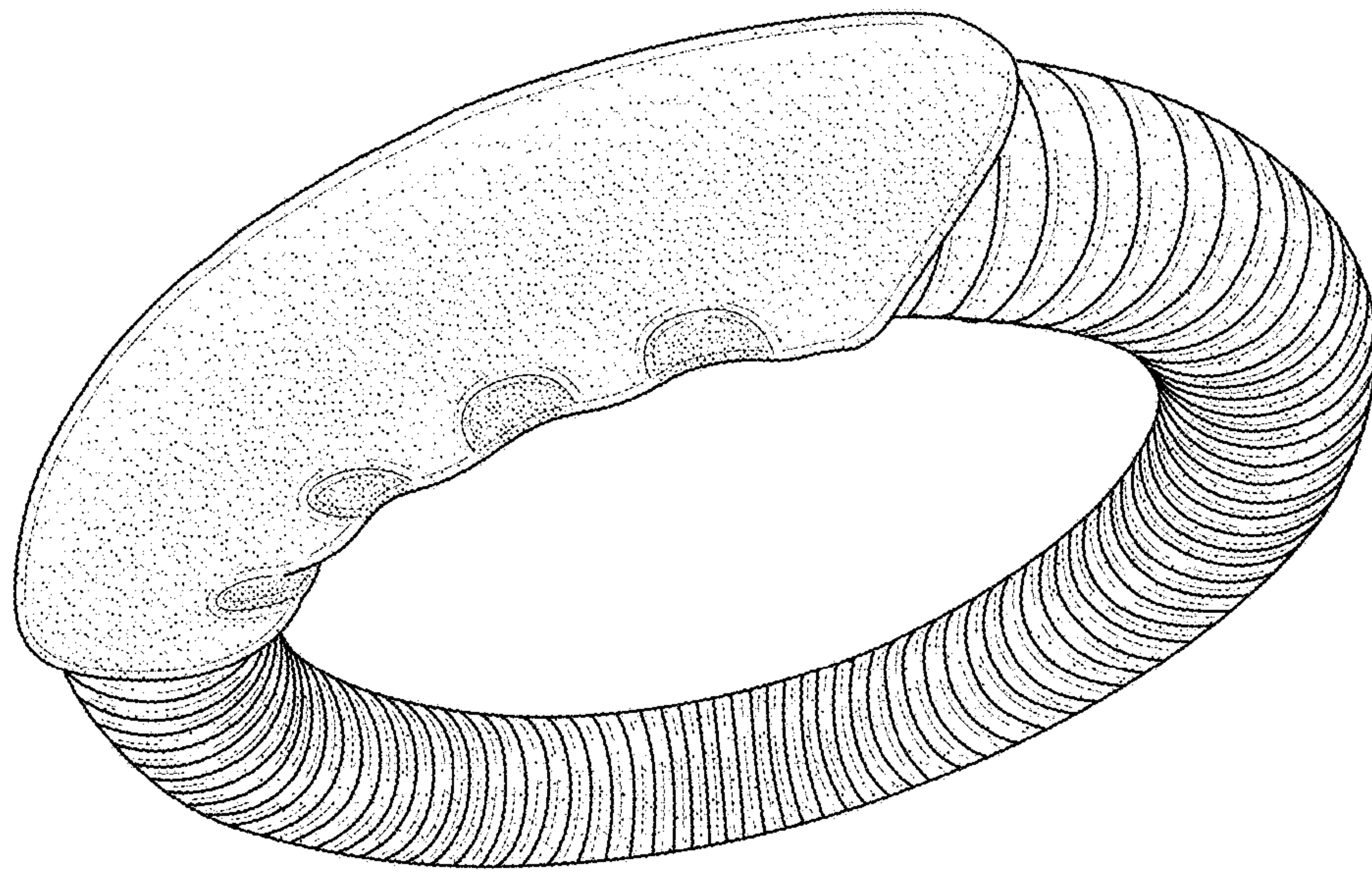
