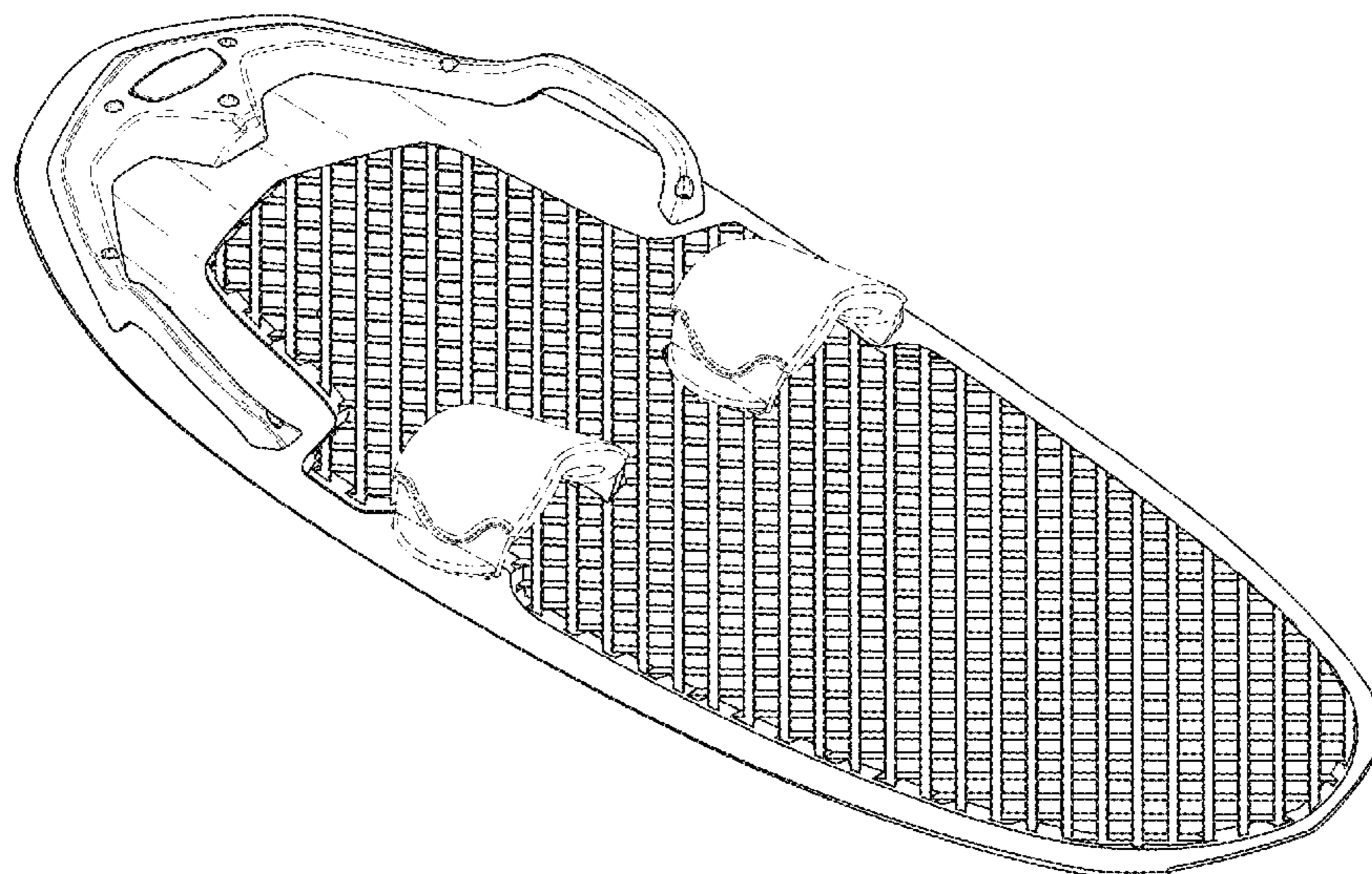
The ornamental design for a water recreation craft, as shown and described.

**DESCRIPTION**

FIG. 1 is a left rear perspective view of our design;  
FIG. 2 is a left front perspective view of our design;  
FIG. 3 is a top plan view of our design;  
FIG. 4 is a bottom plan view of our design;  
FIG. 5 is a front elevation view;  
FIG. 6 is a rear elevation view;  
FIG. 7 is a right side elevation view;

FIG. 10 is a view of a second version of our design showing a plain unadorned top surface, the pattern is shown in dotted relief.

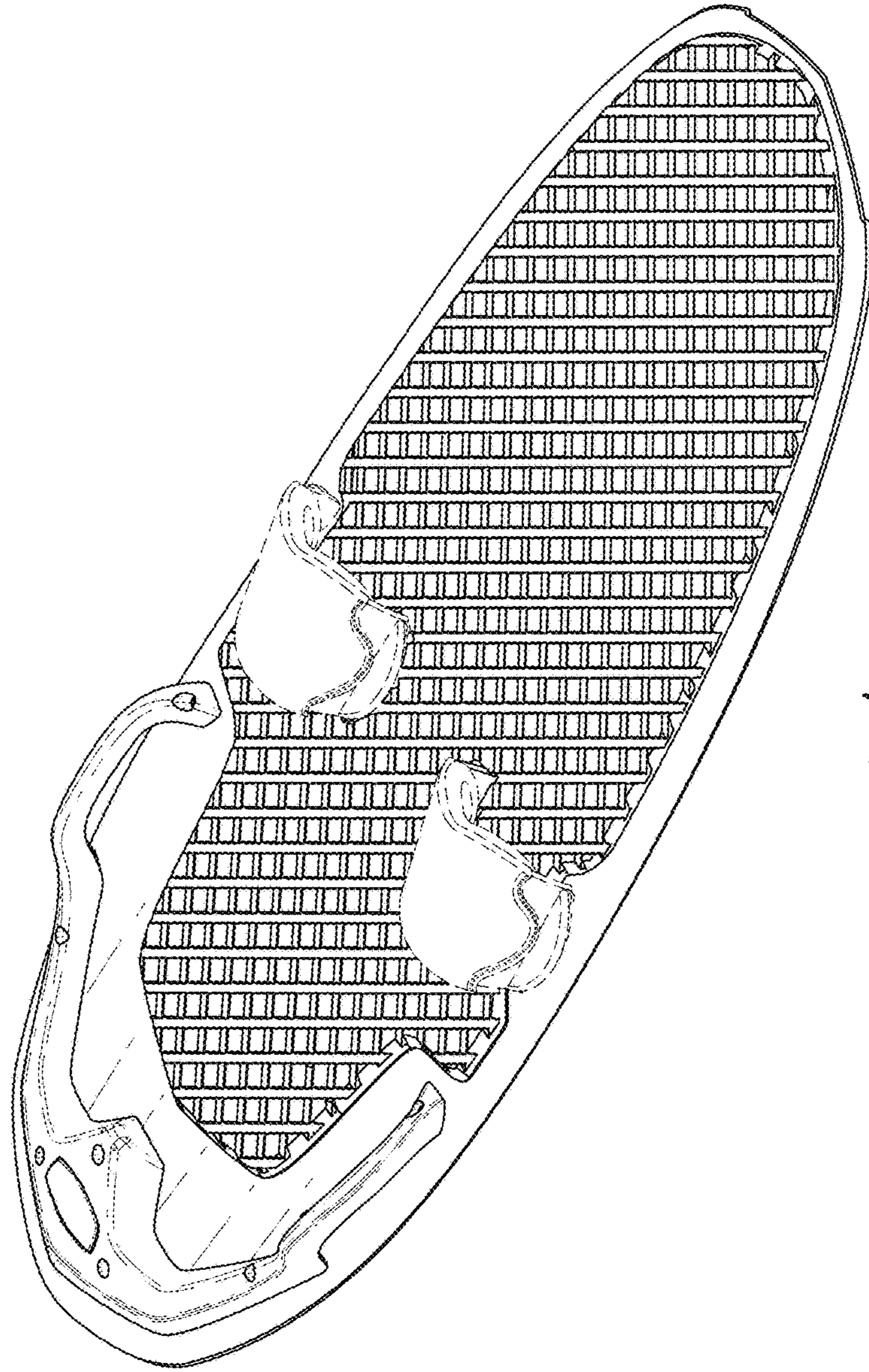

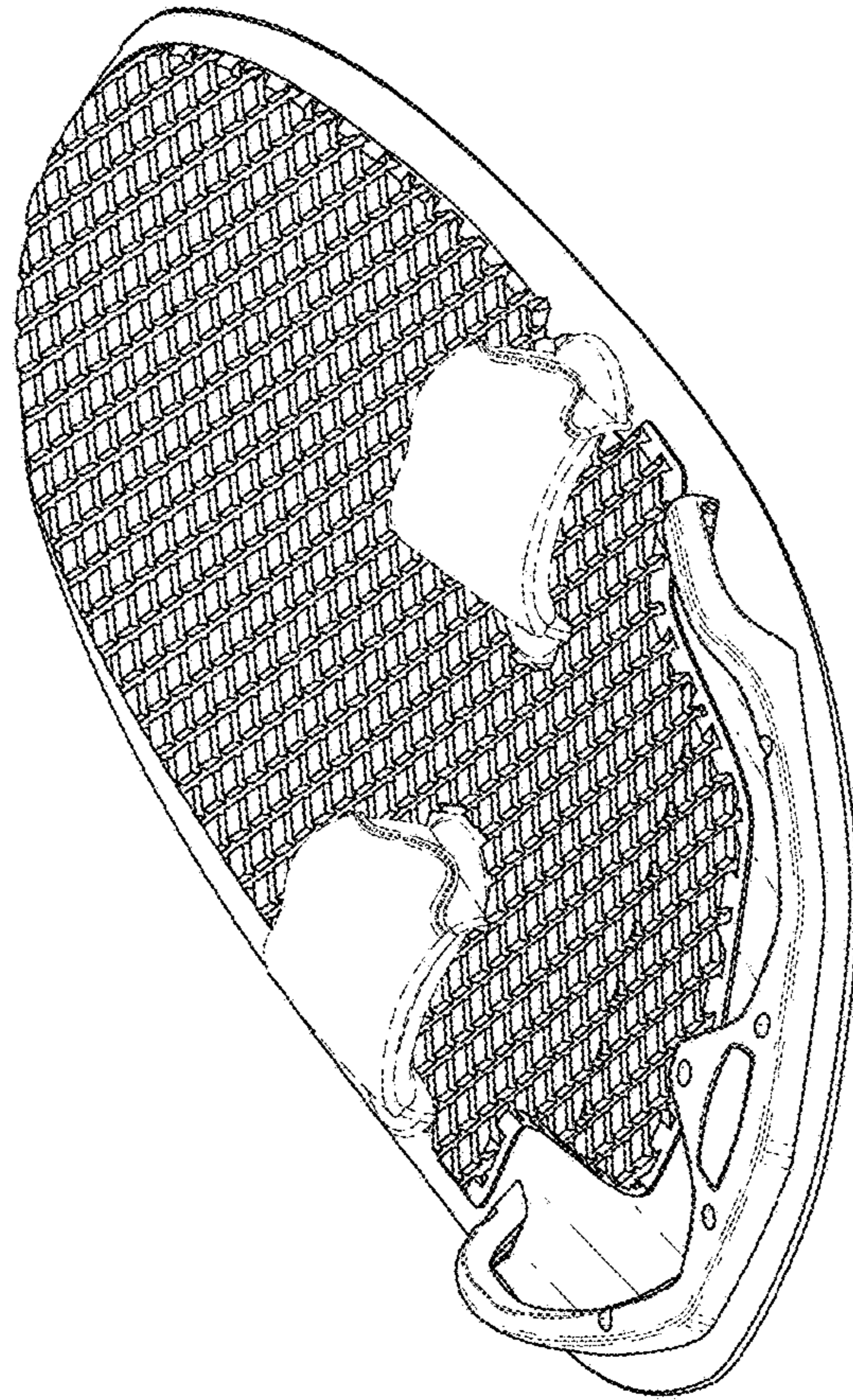

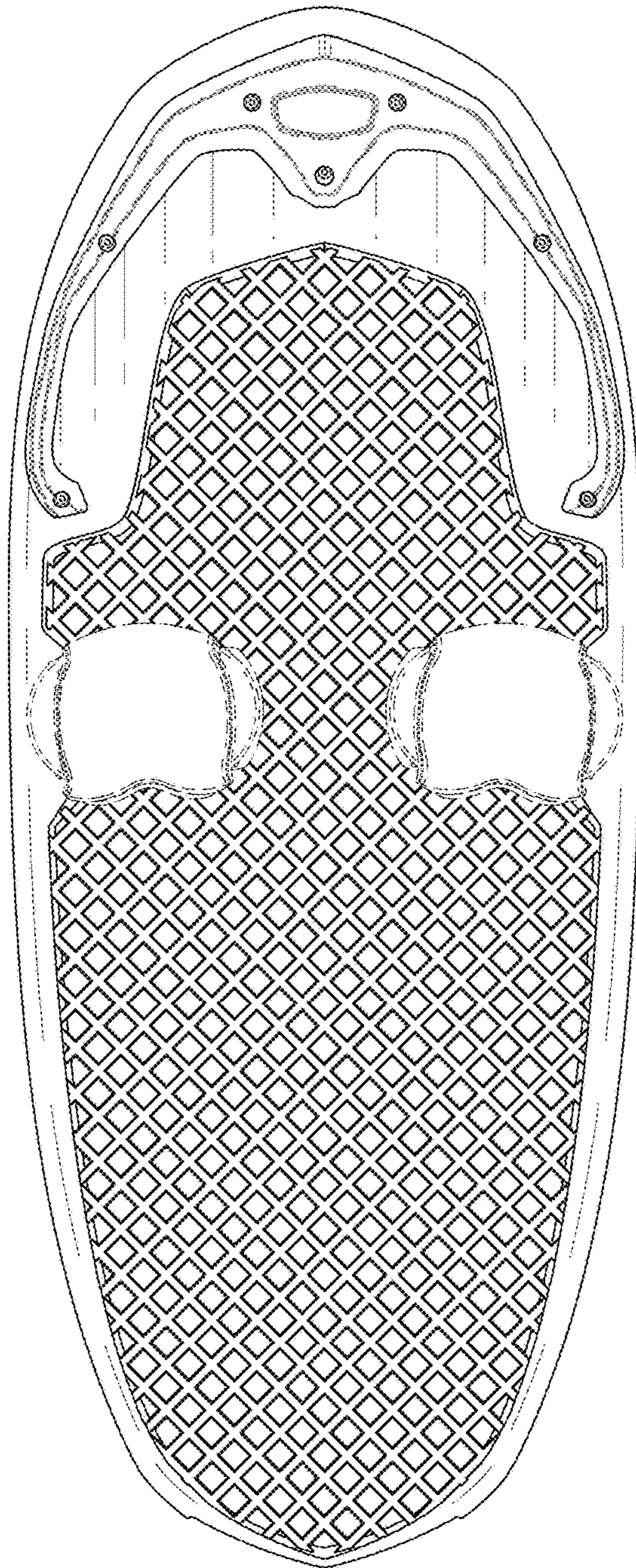

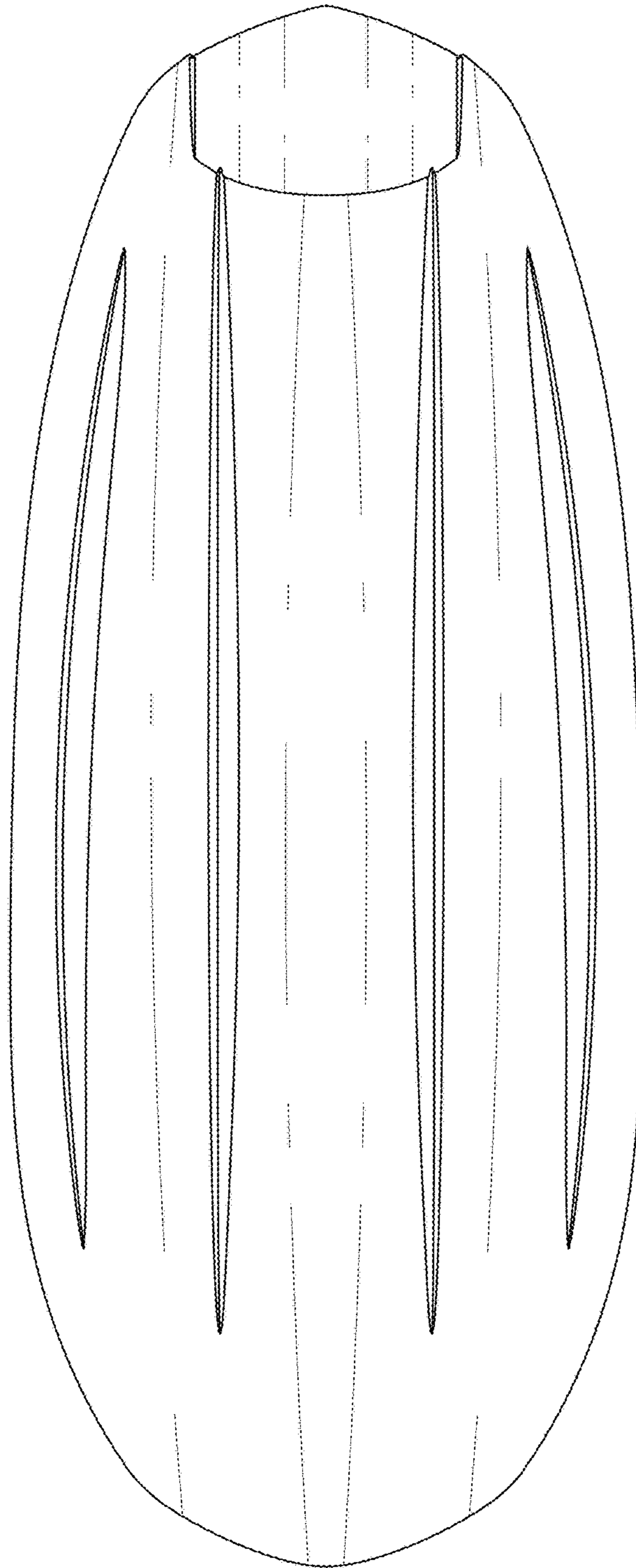

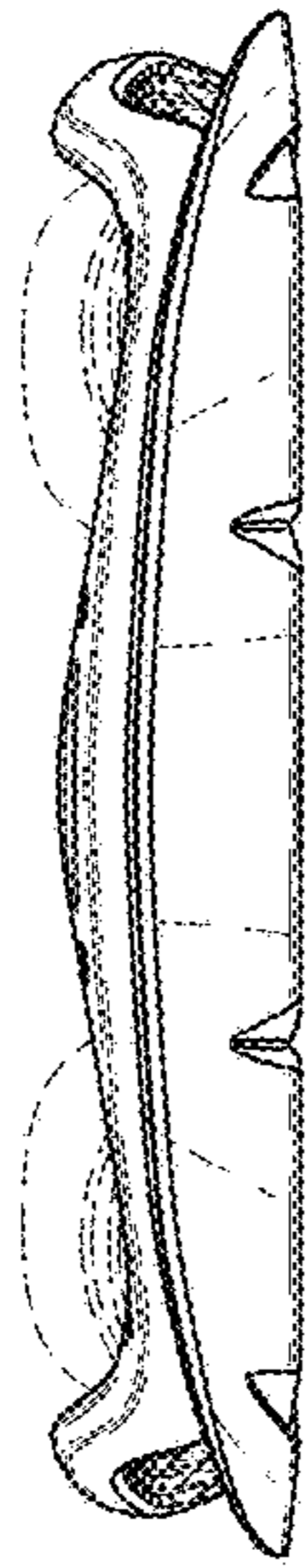

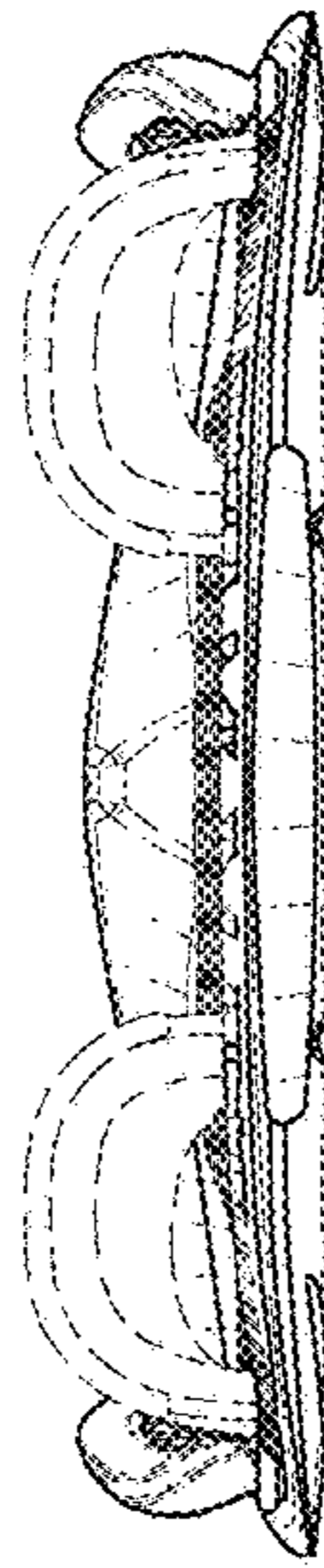

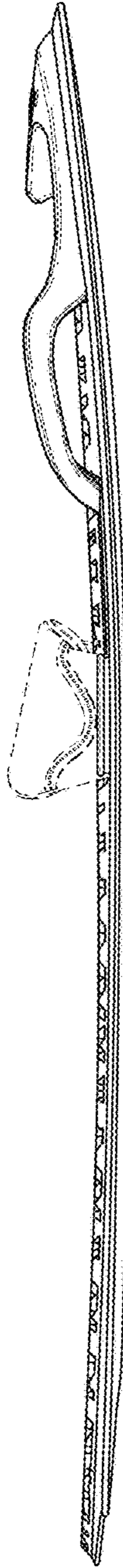

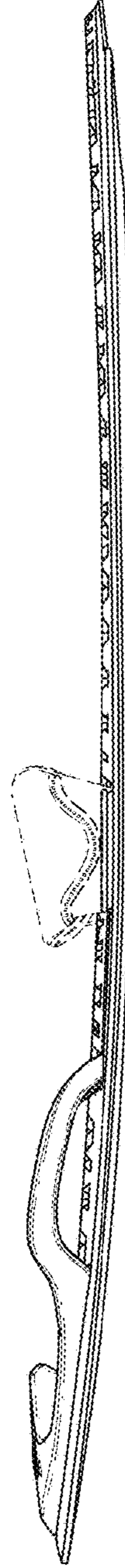

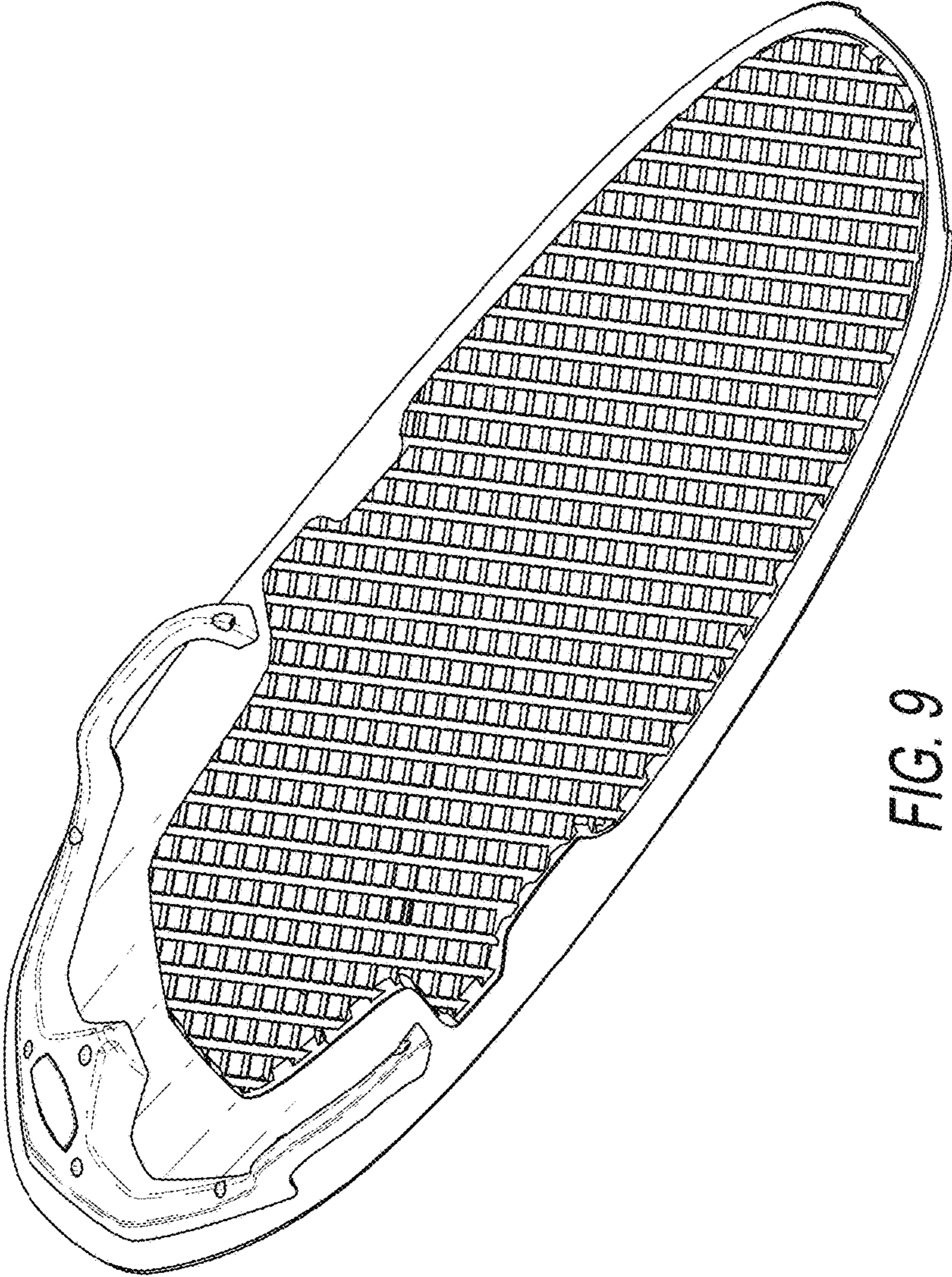

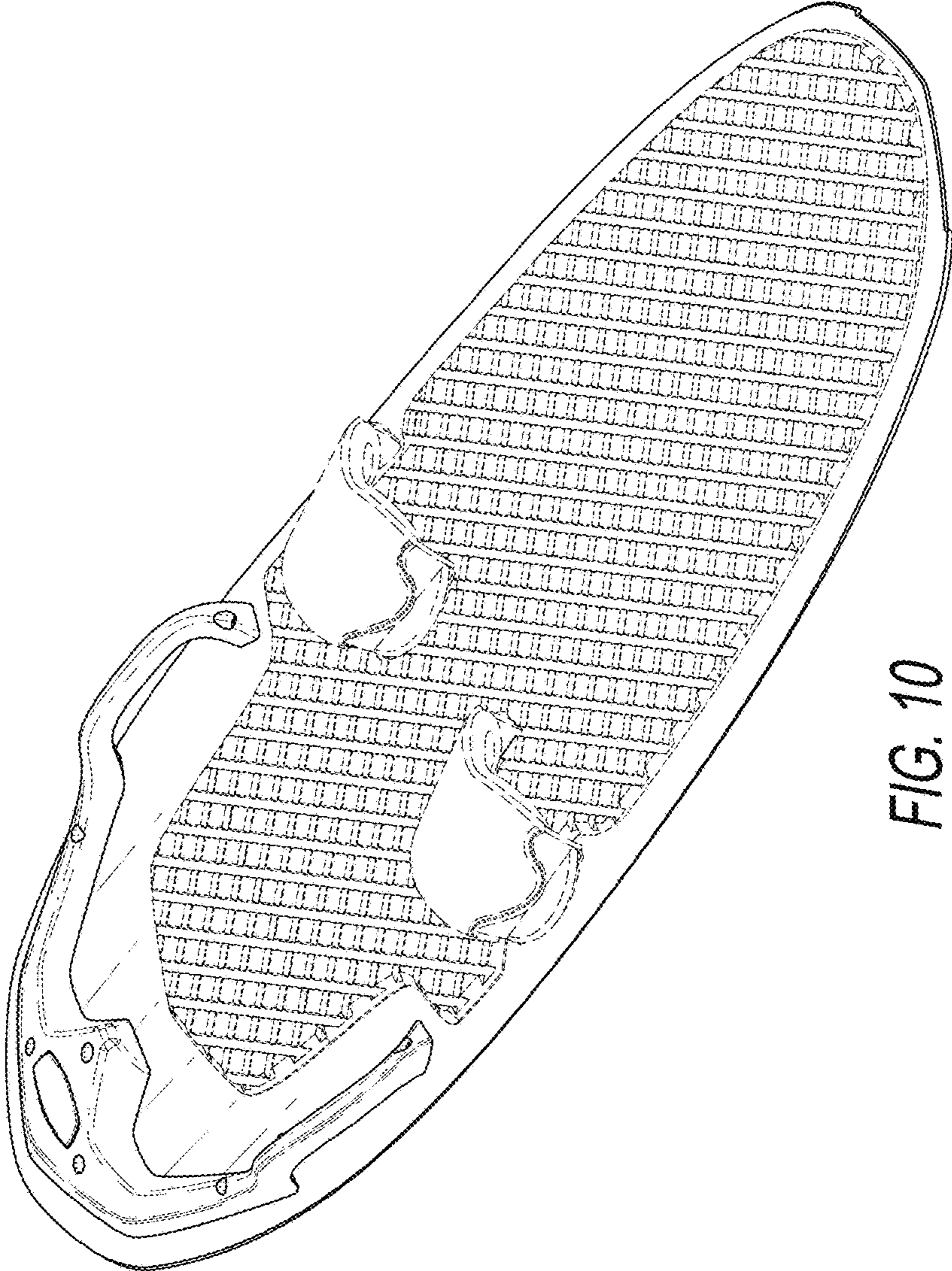
