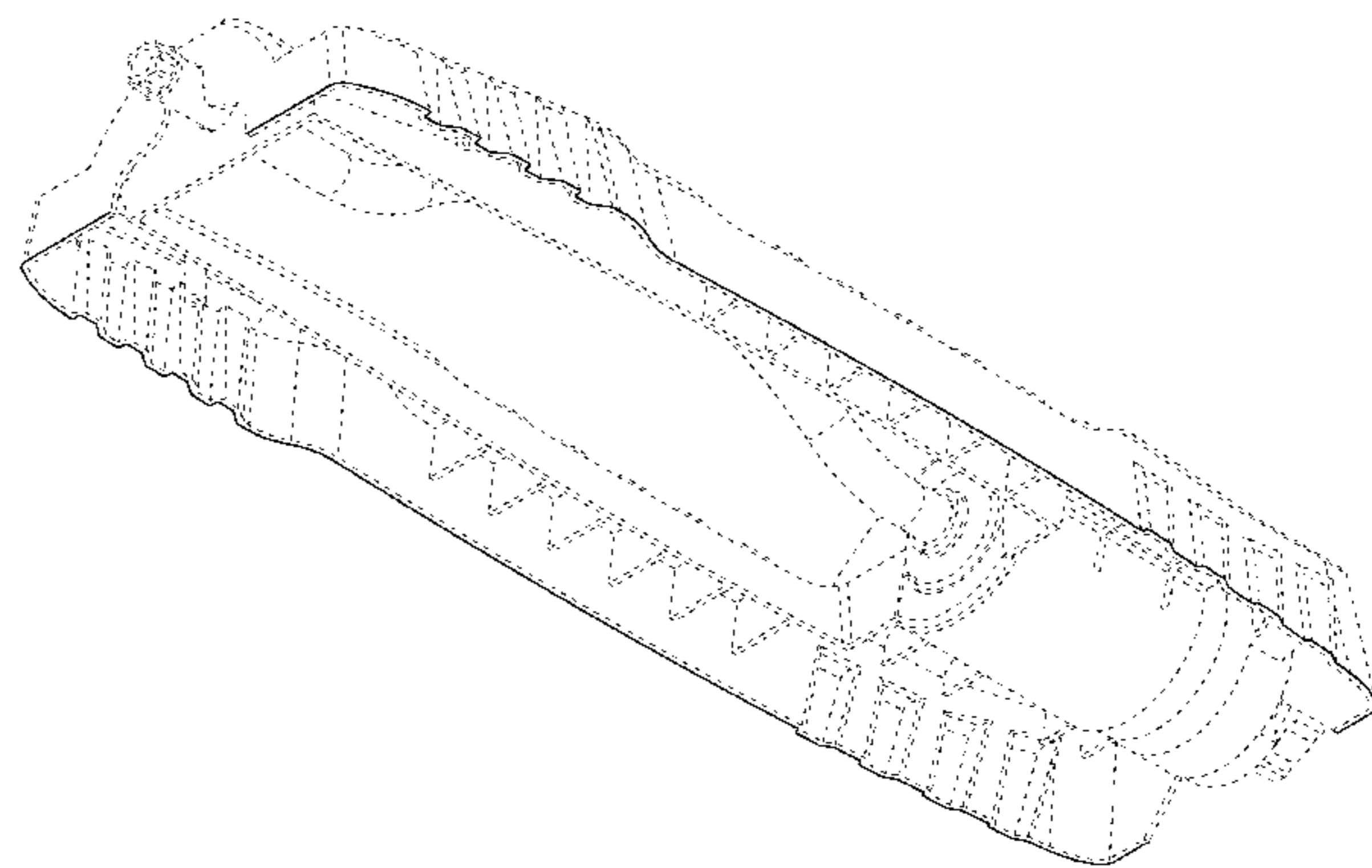
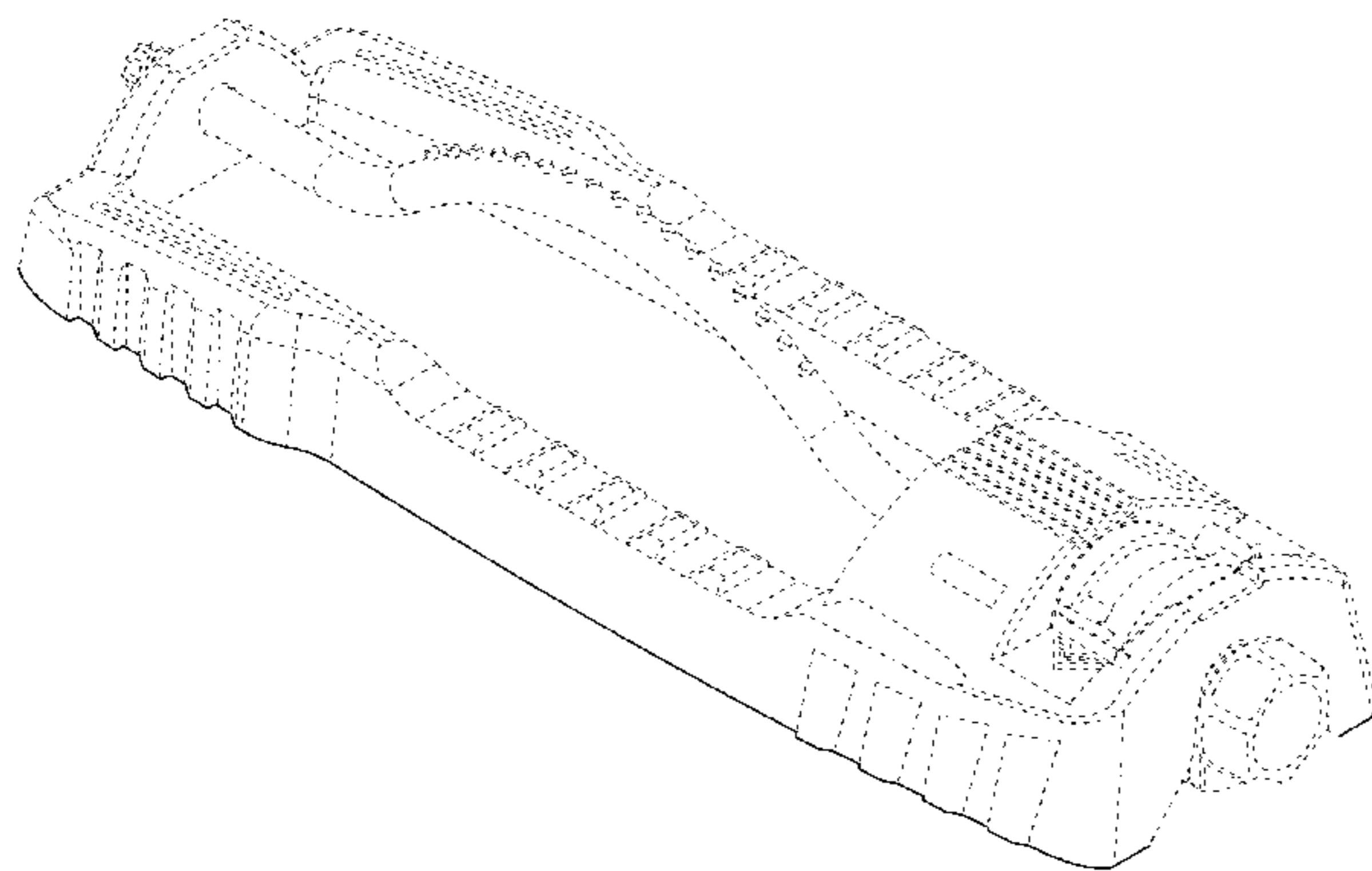
The ornamental design for an oscillating sprinkler, as shown and described.

DESCRIPTION

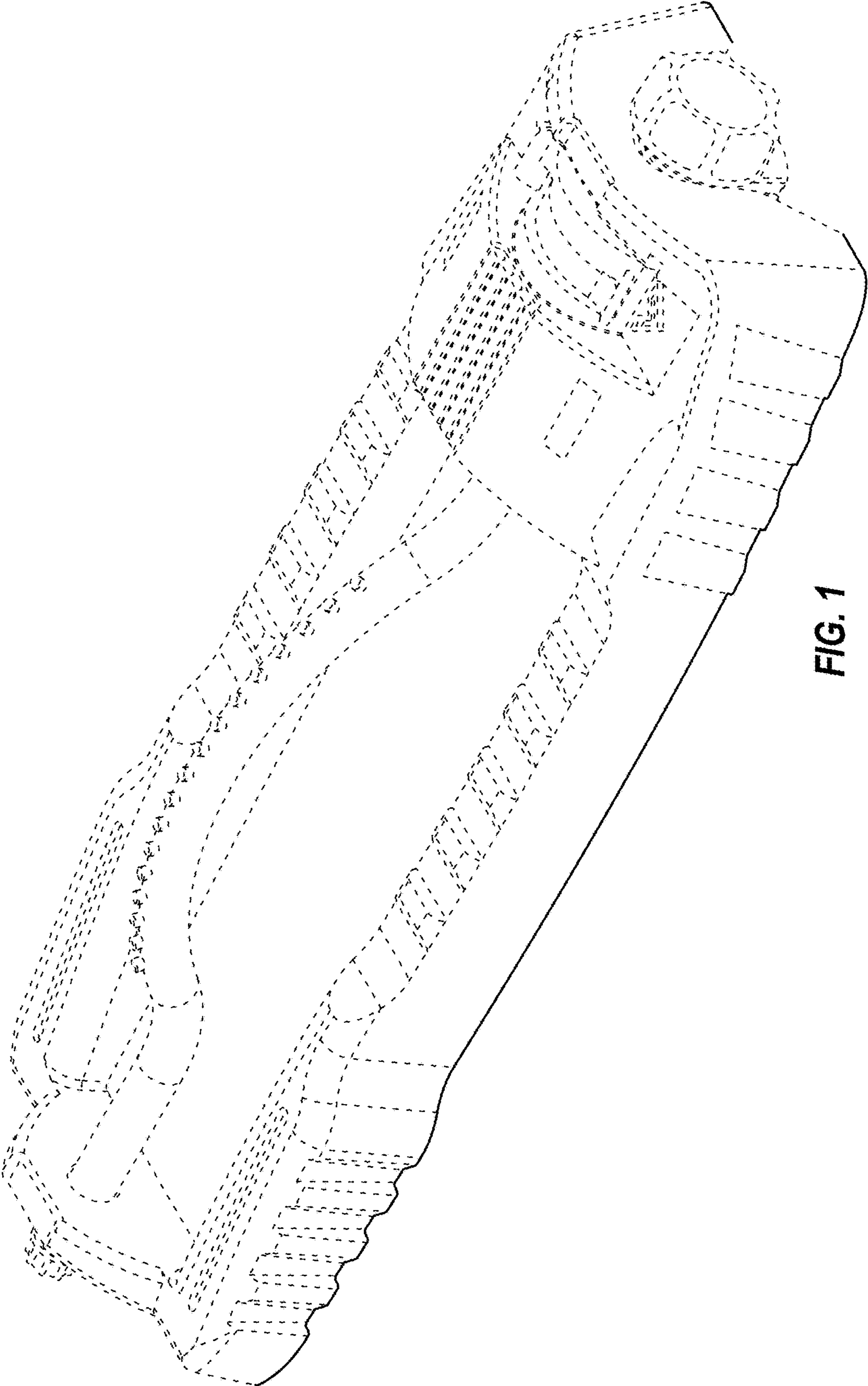

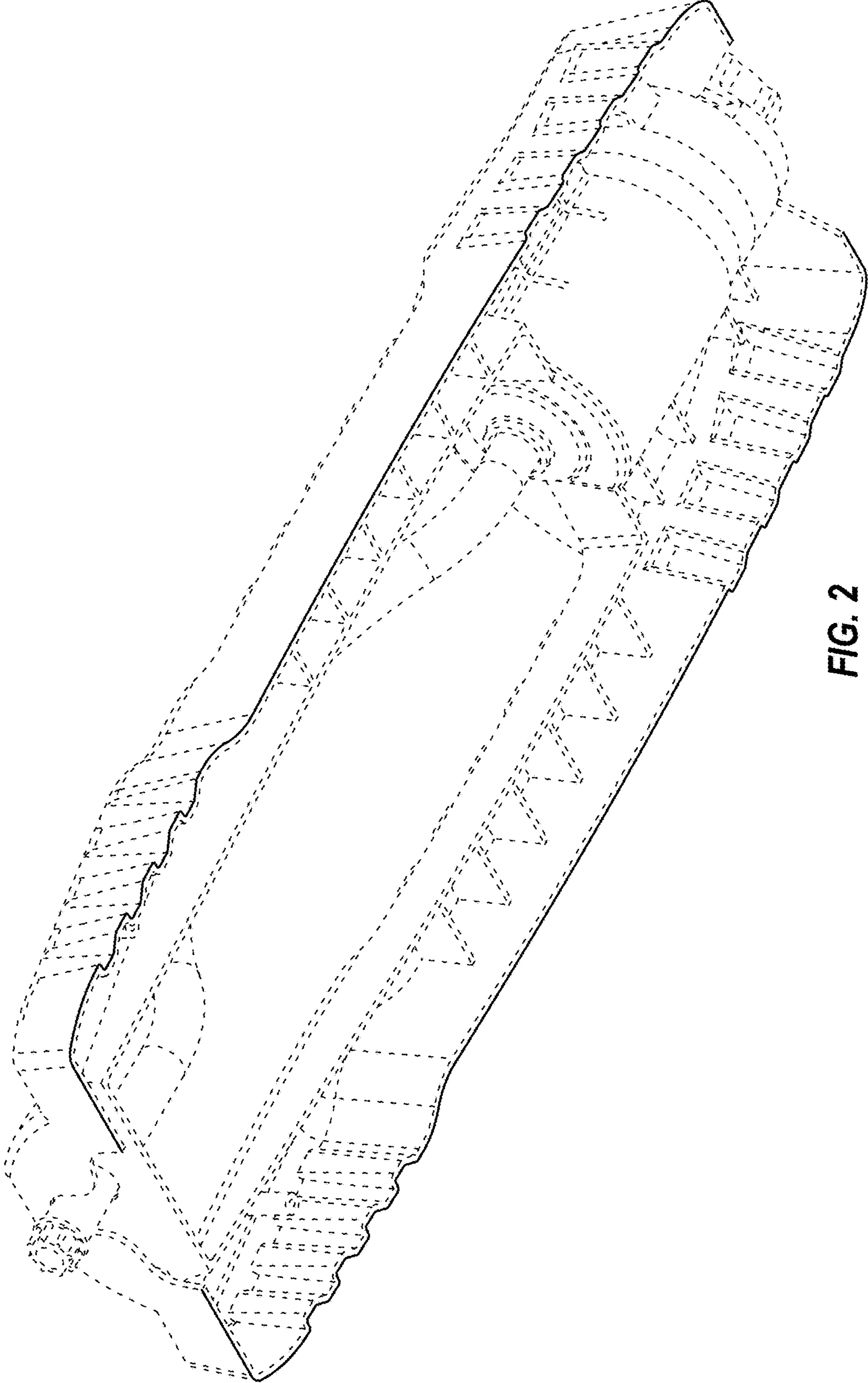

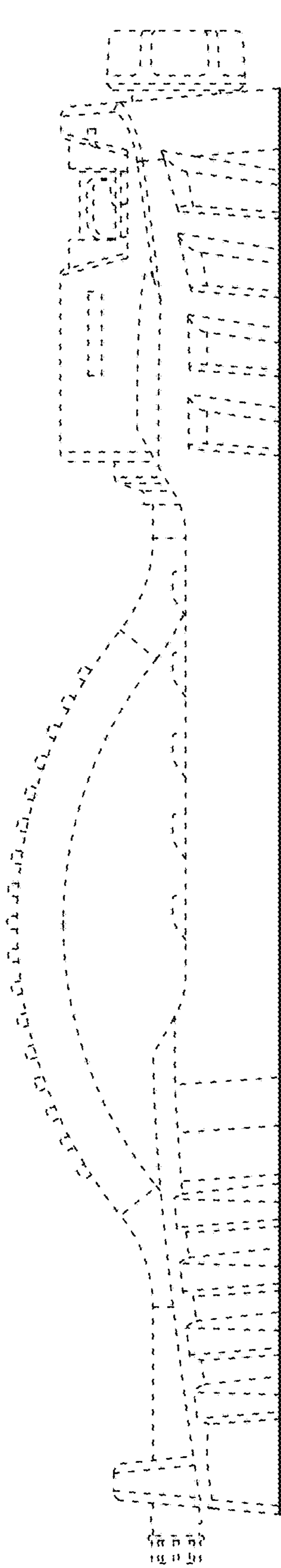

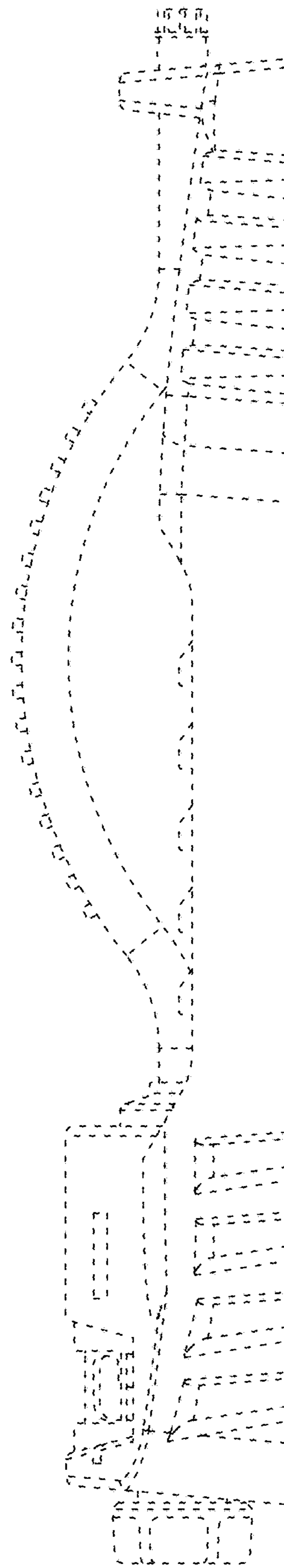

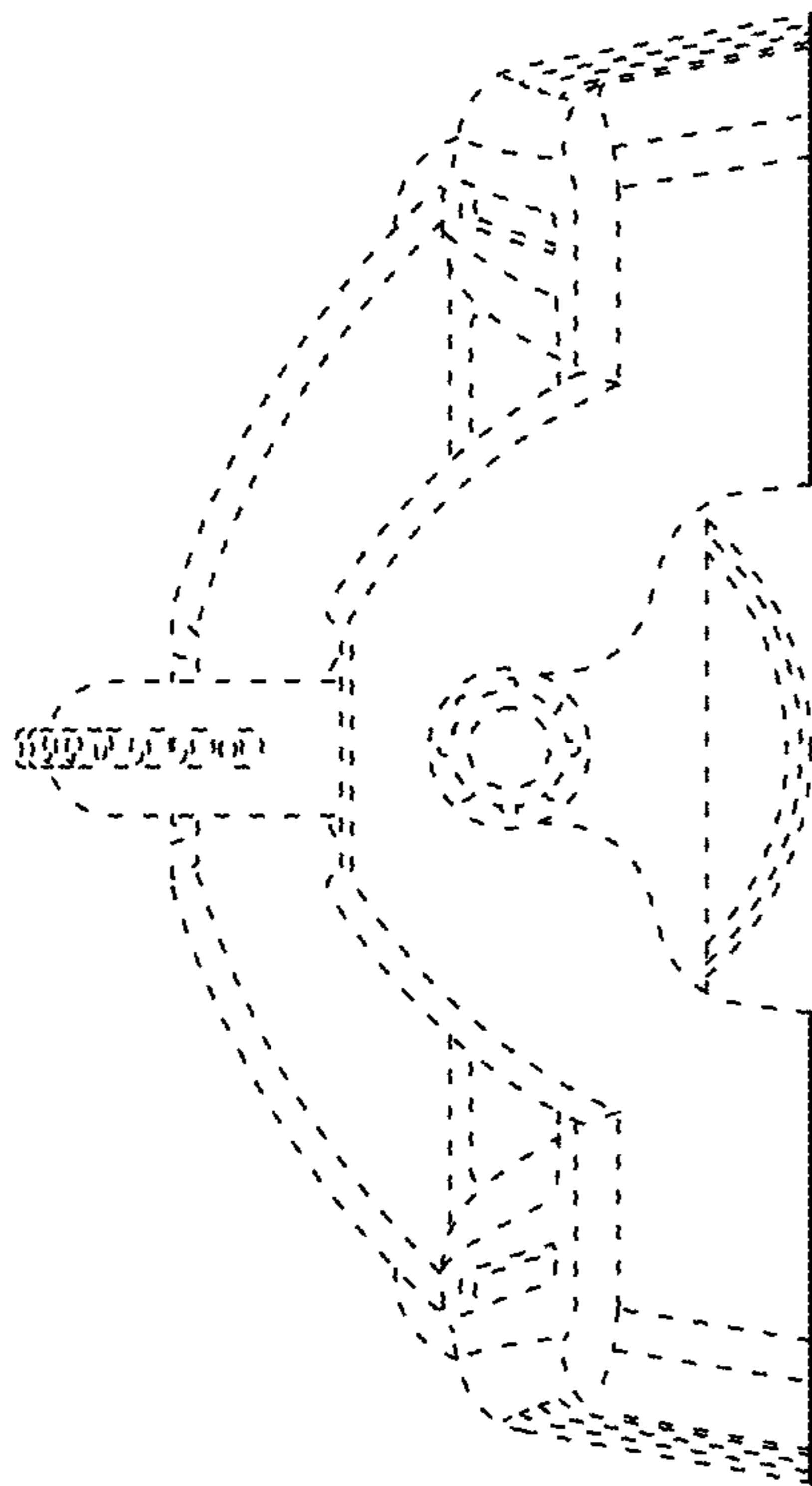

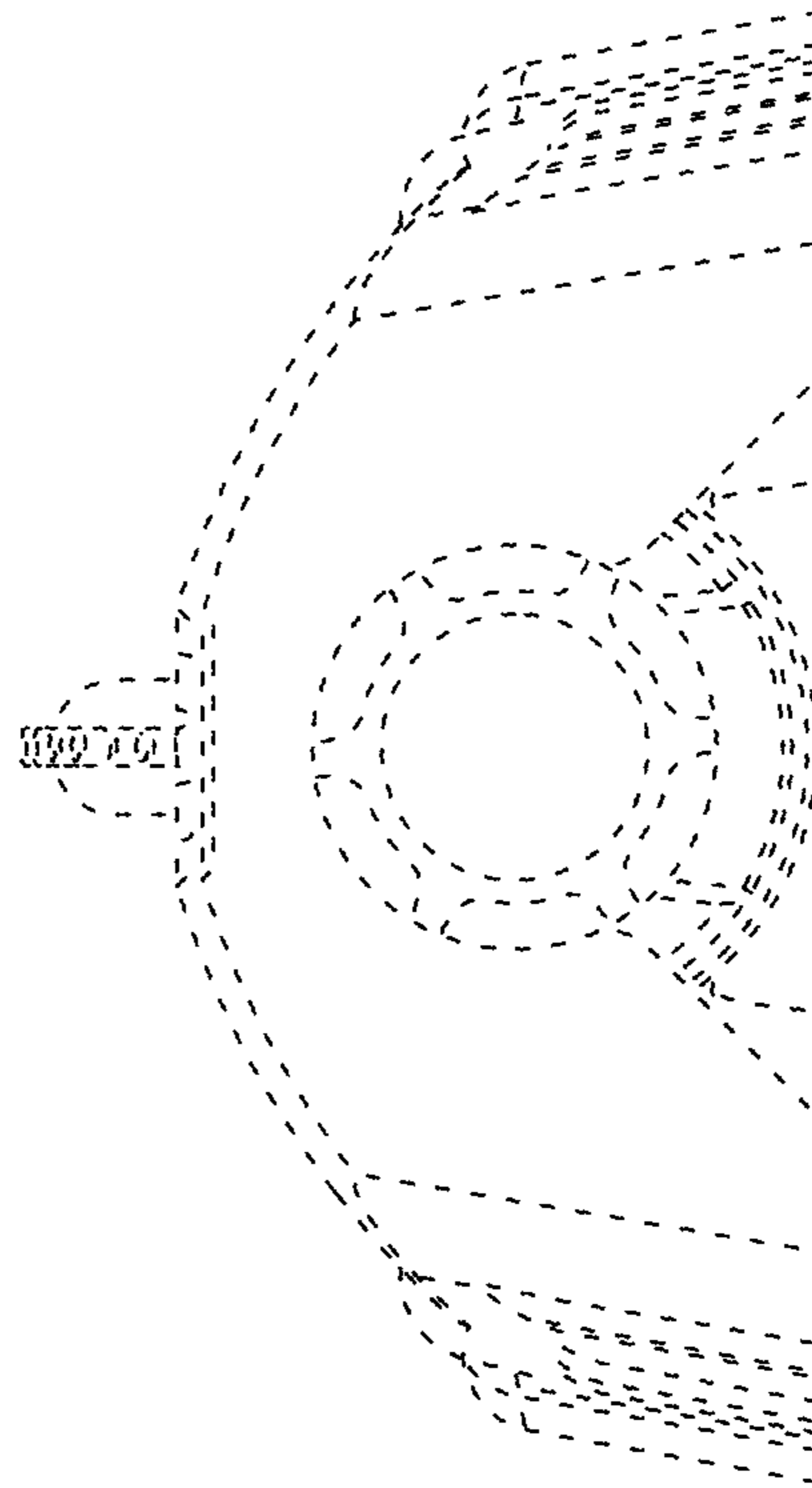

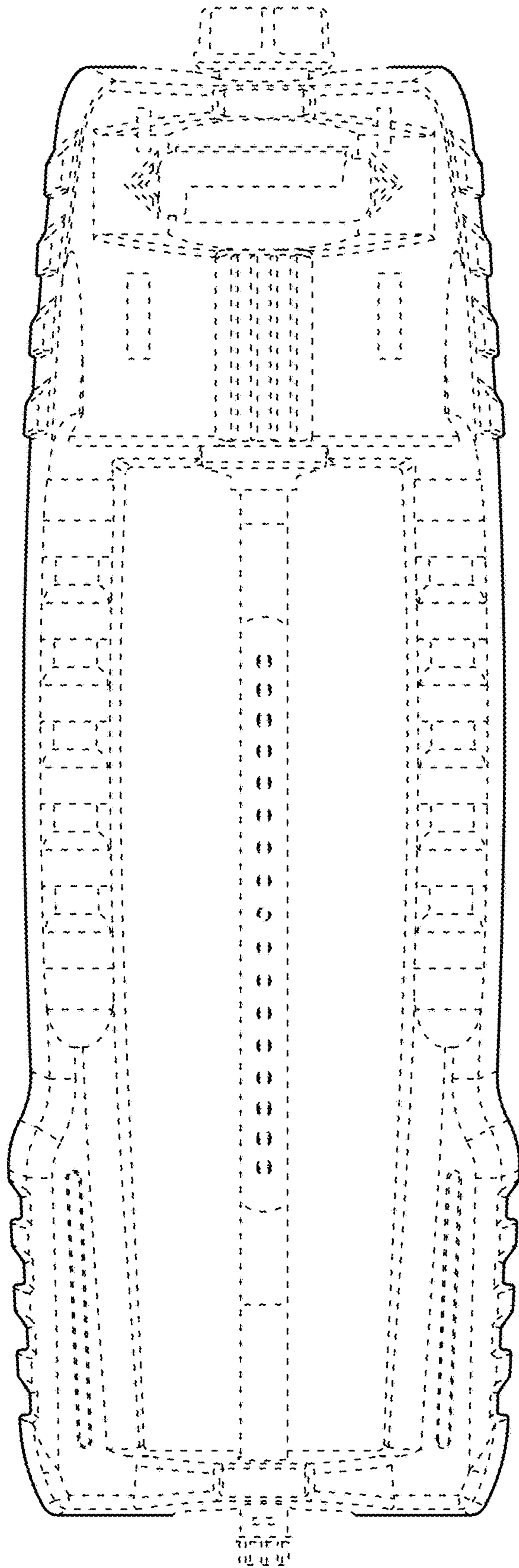

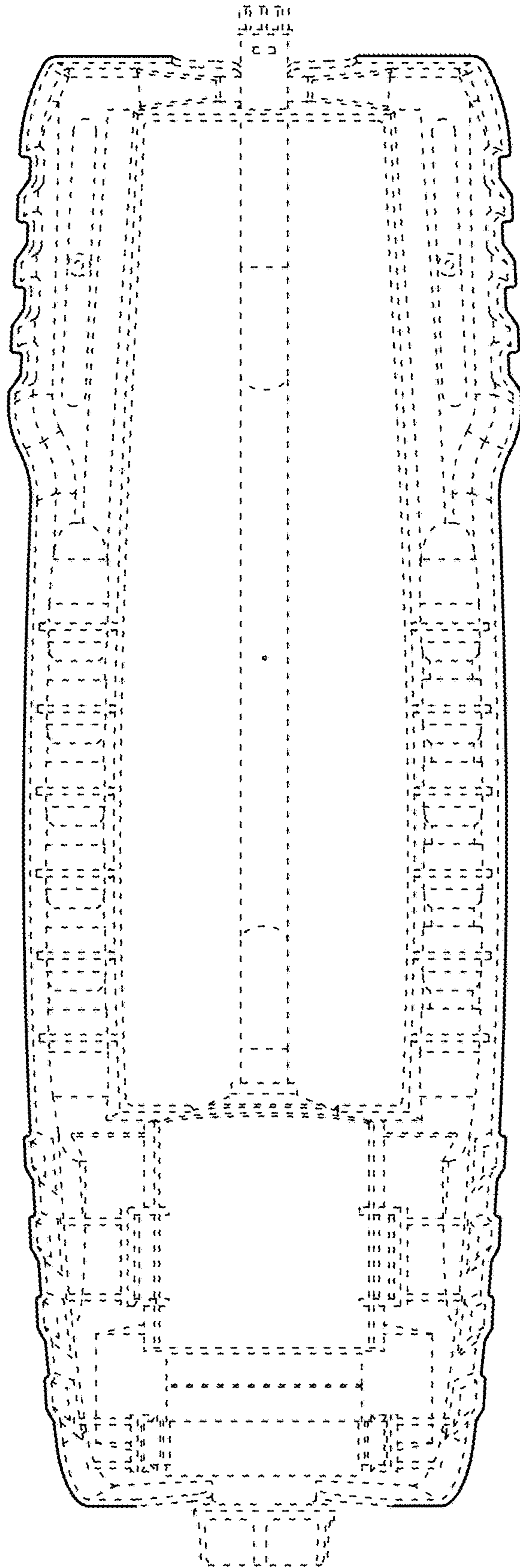
