We claim the ornamental design for adult toy, as shown and described.

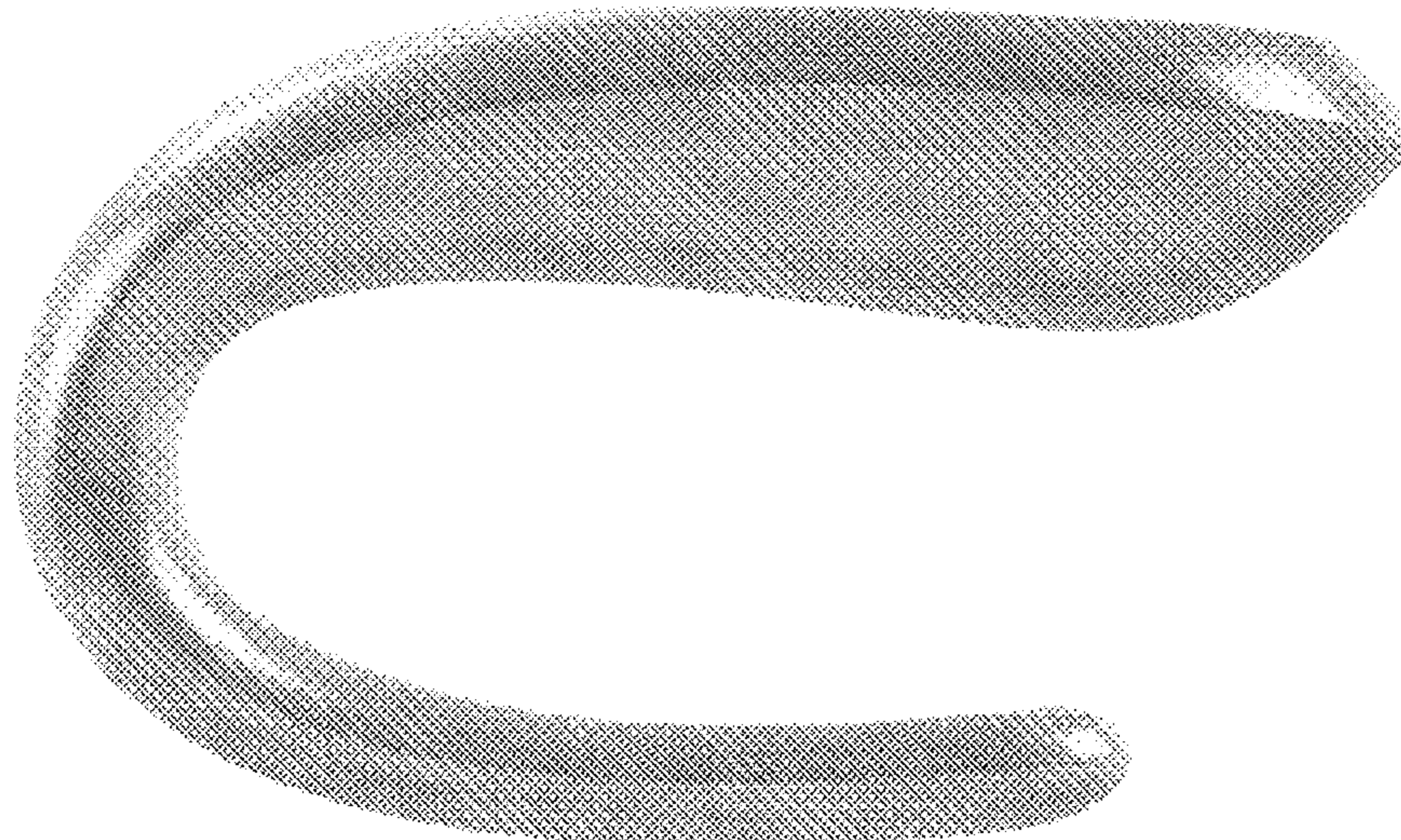
DESCRIPTION

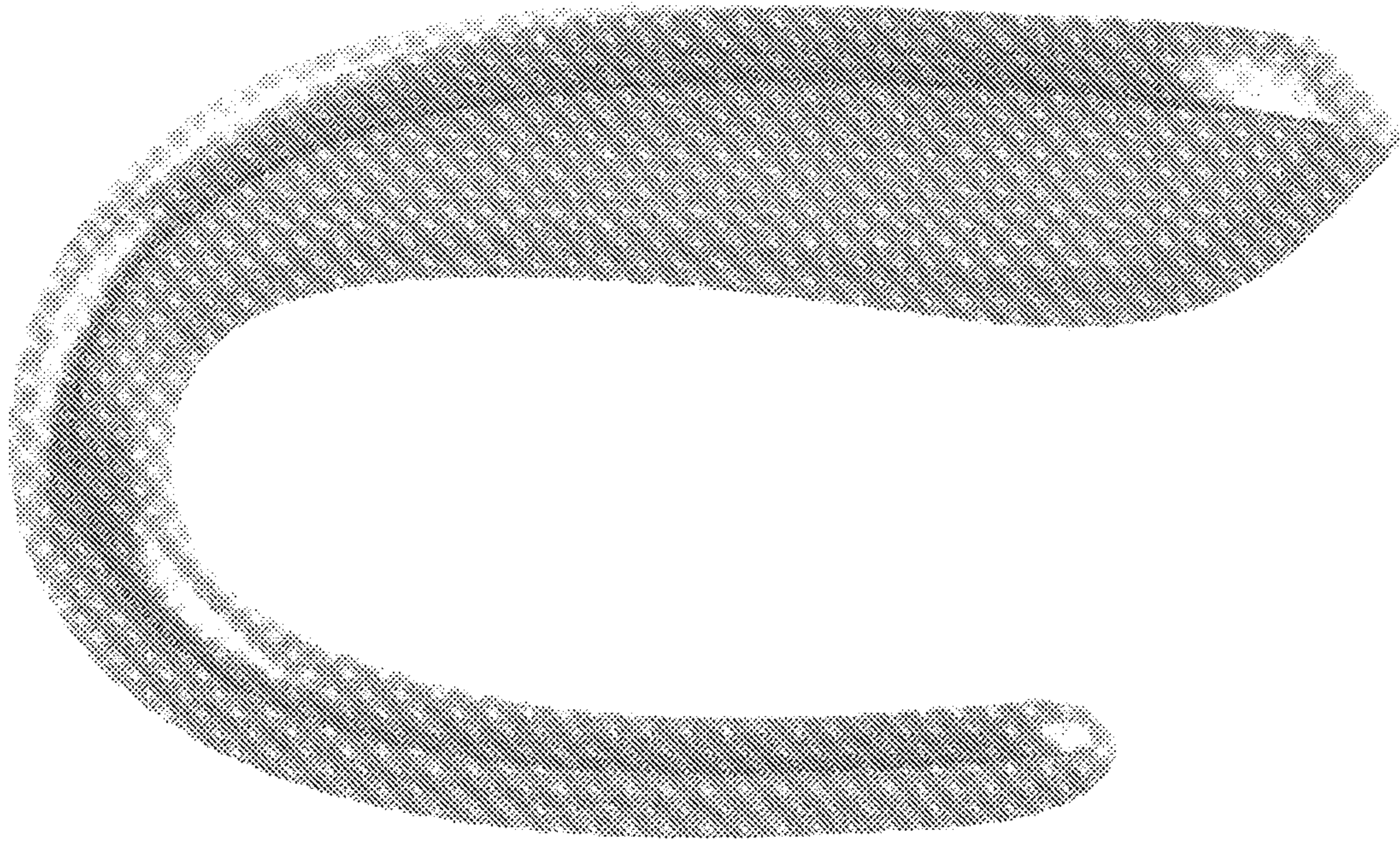

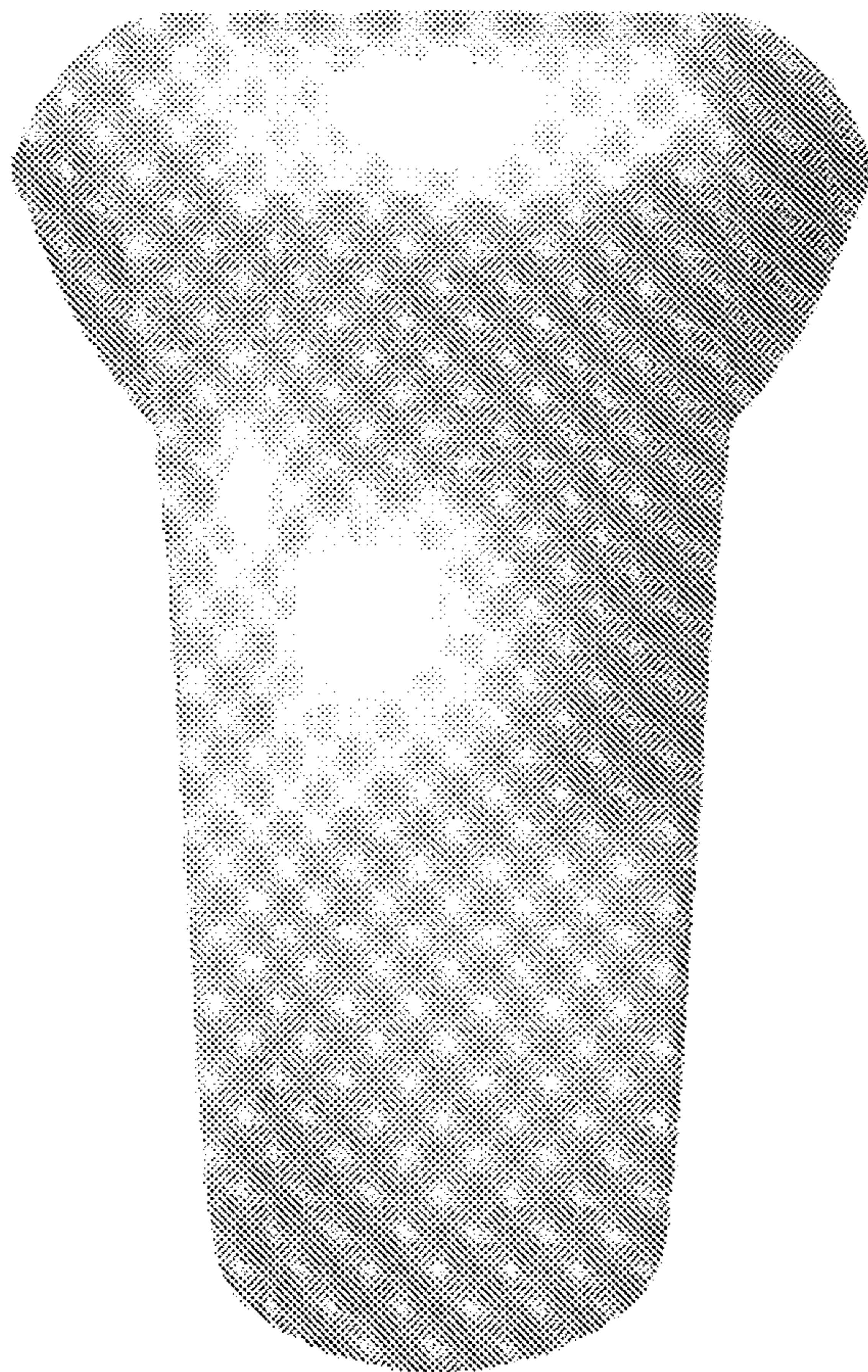

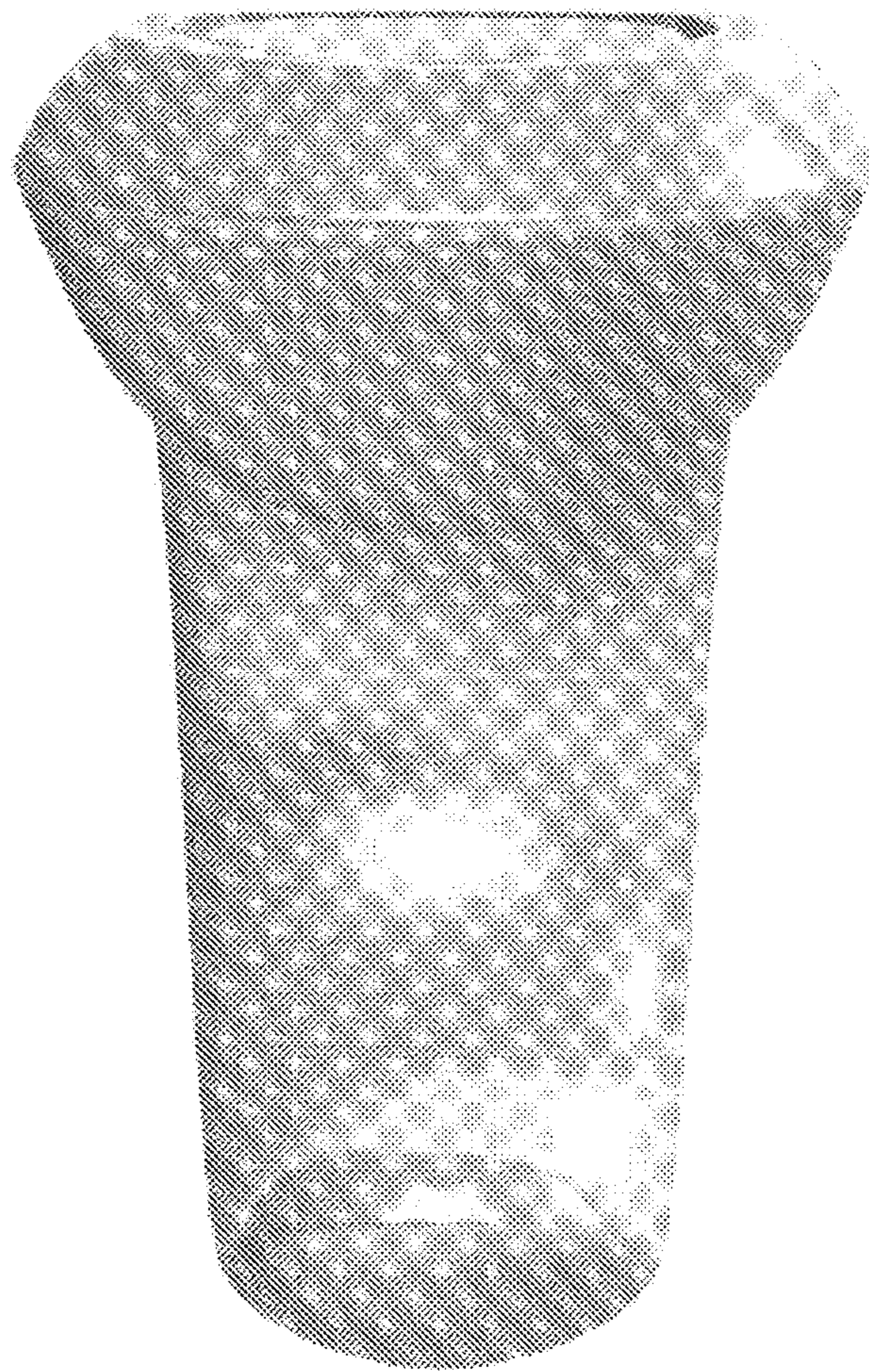

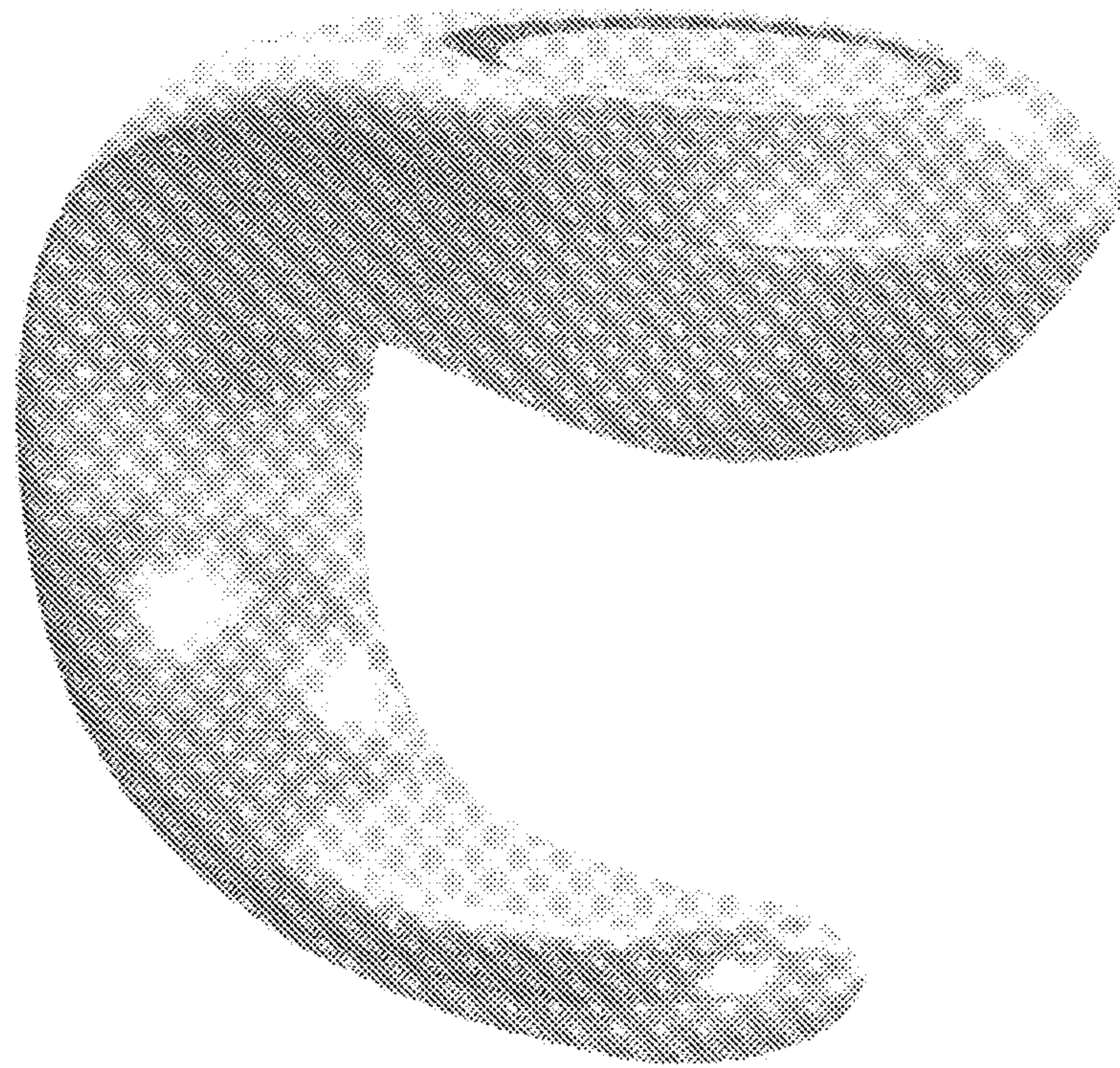

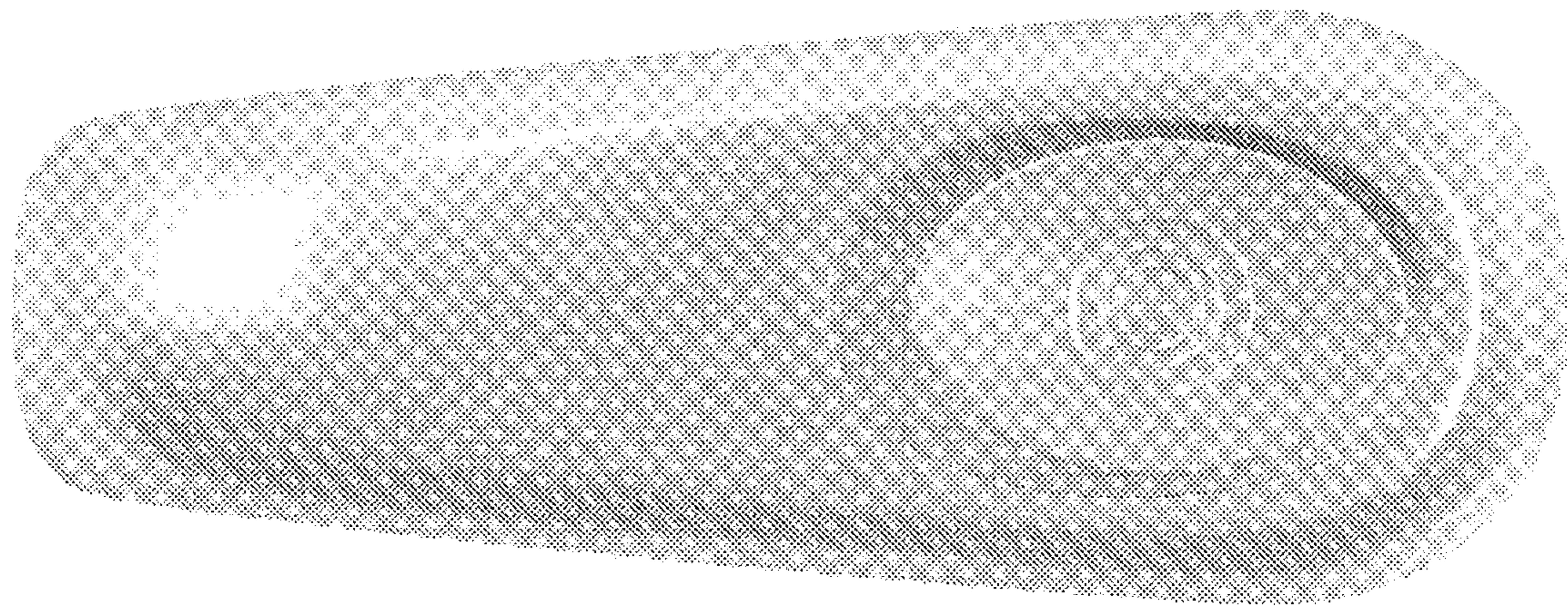

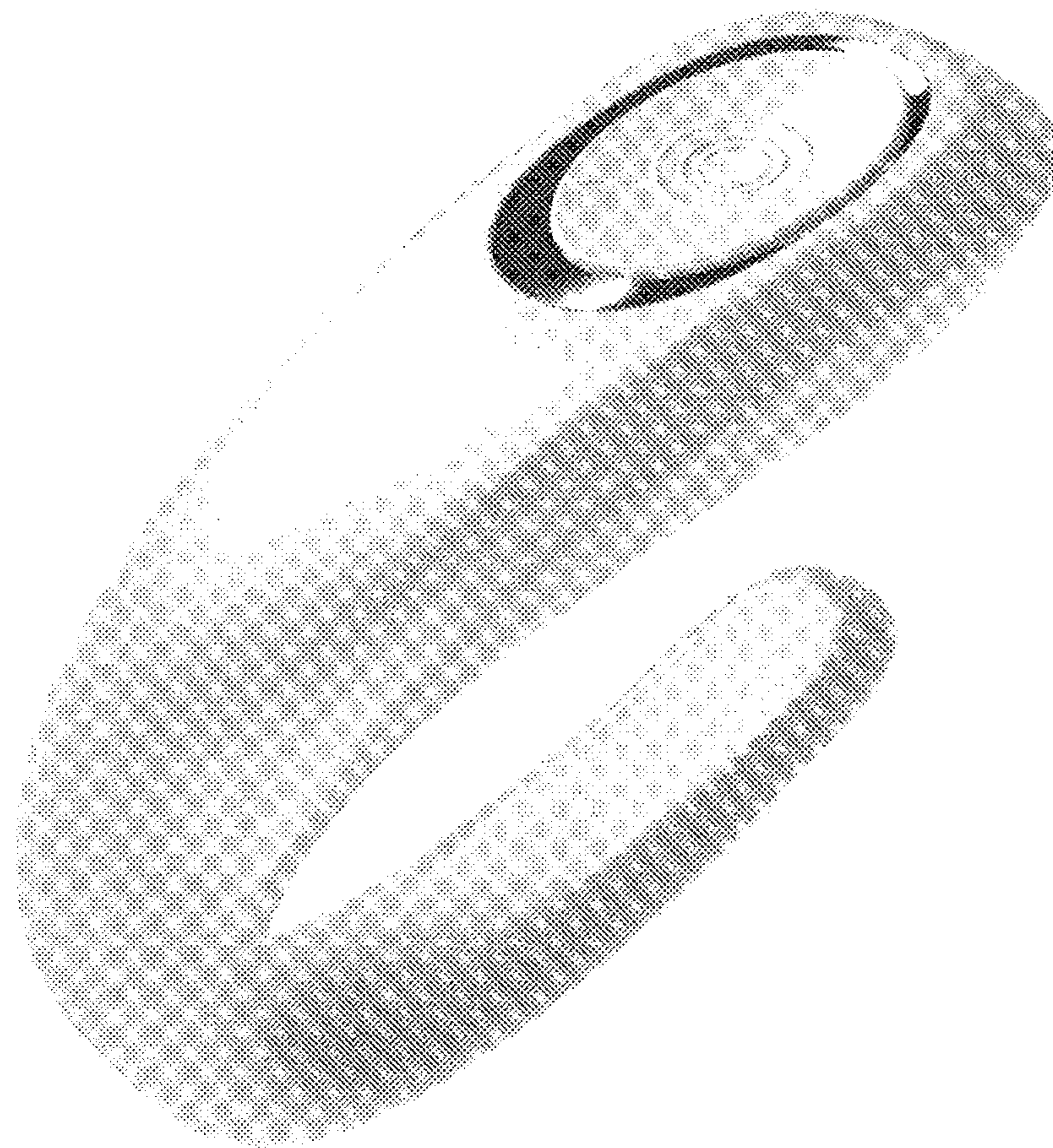
