FIG. 7 is a top view of the design;

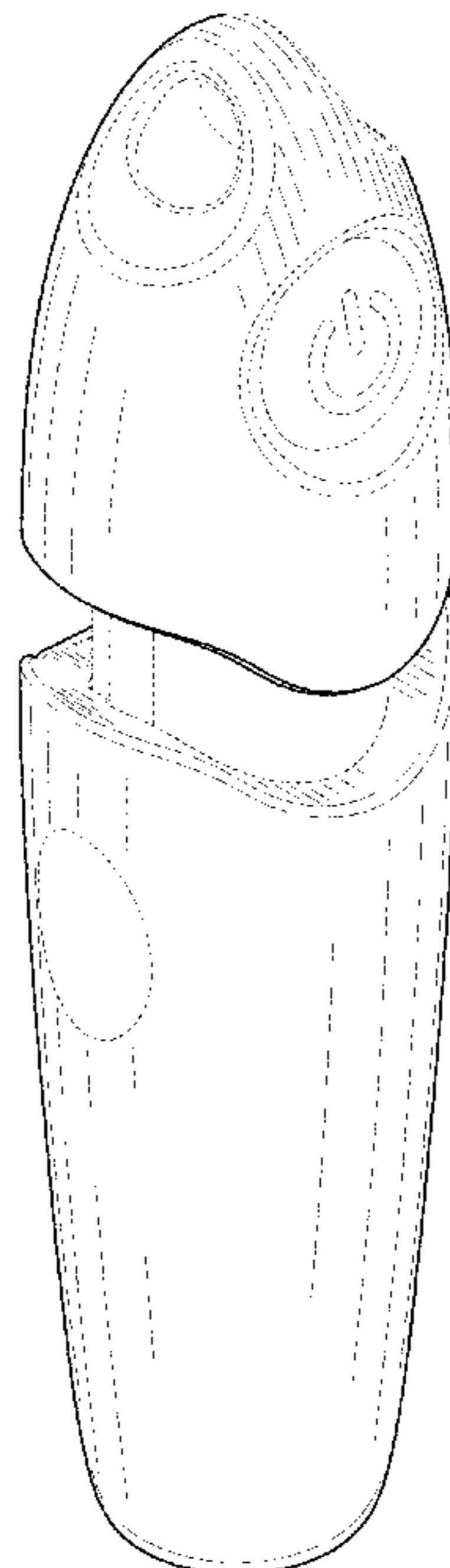
FIG. 8 is a bottom view of the design;

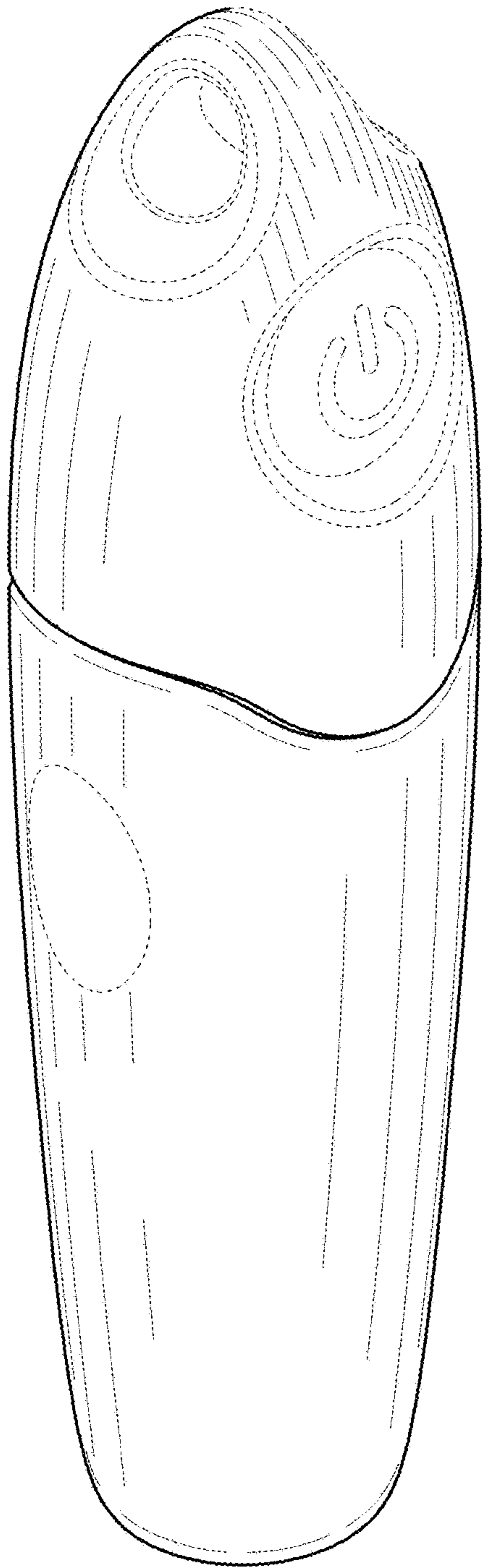
FIG. 9 is a front perspective view of the design in the open position; and,

FIG. 10 is a rear perspective view of the design in the open position.

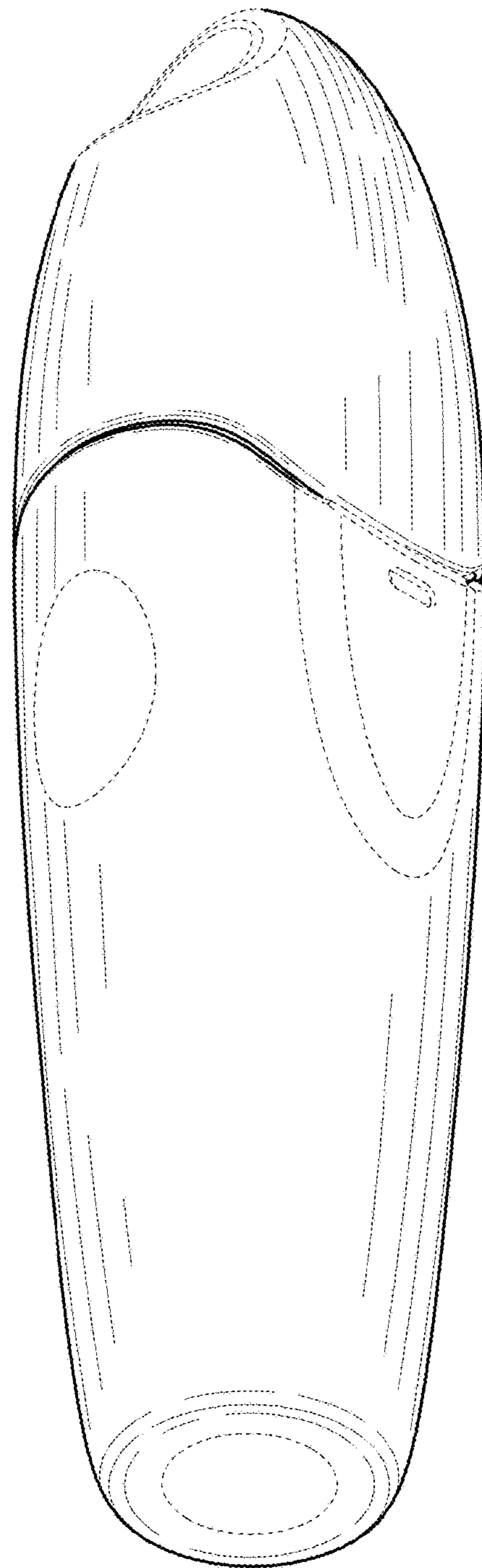

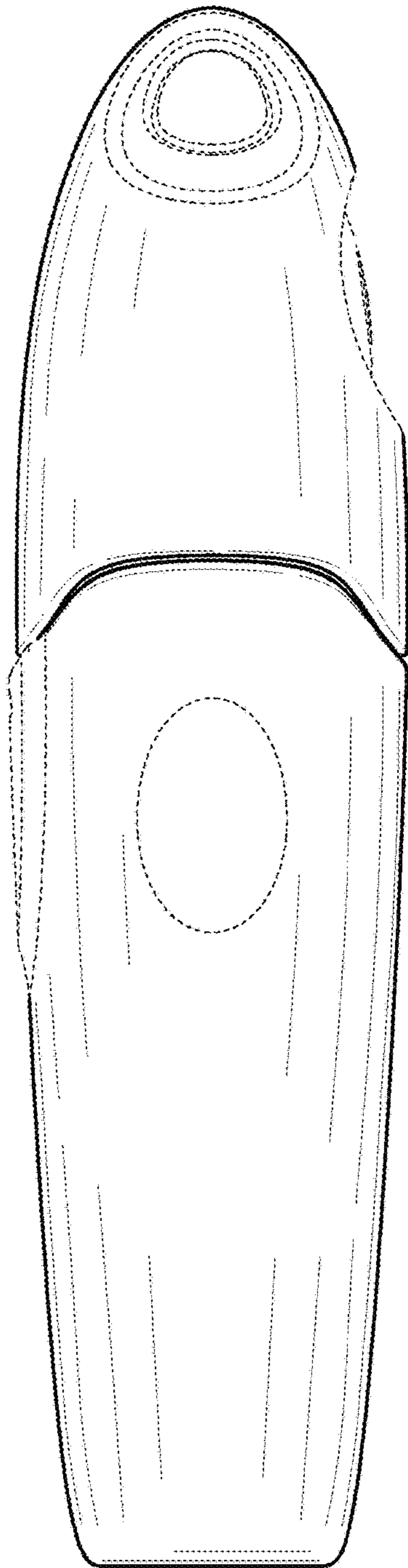




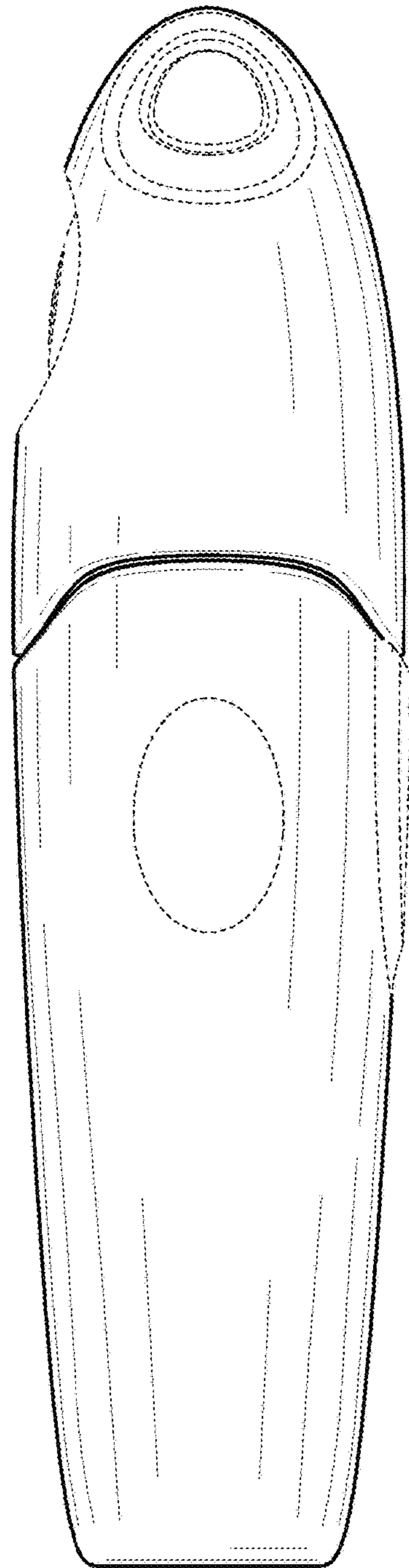

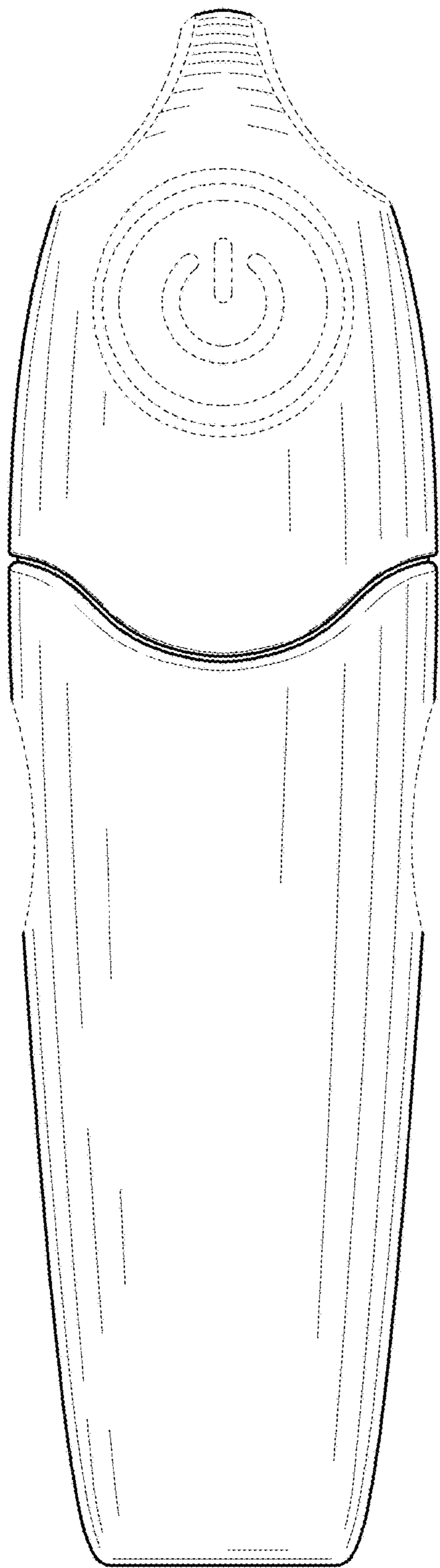

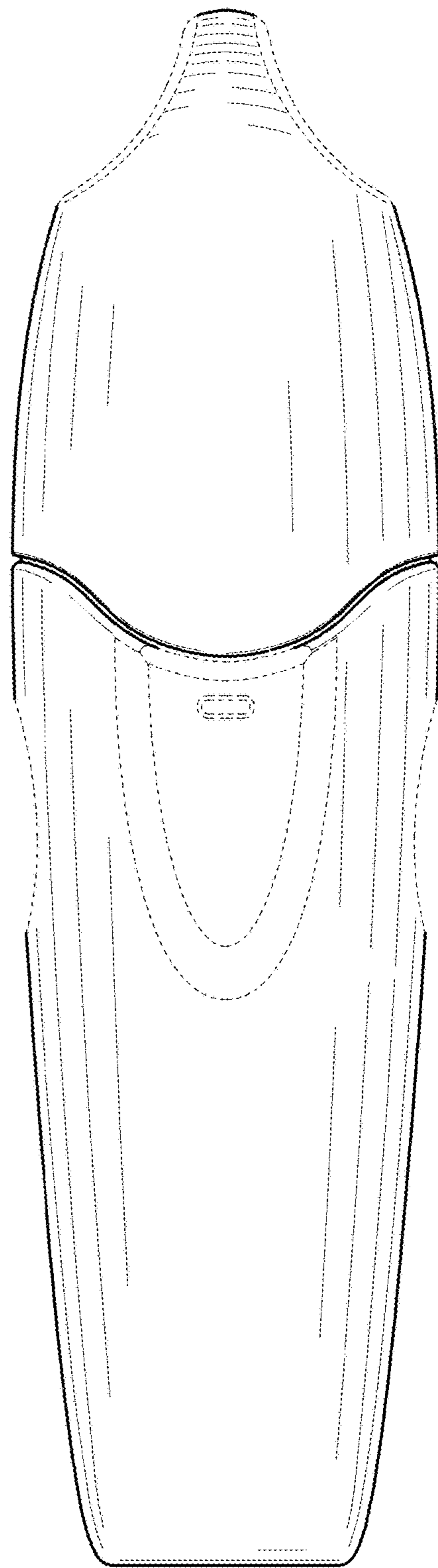

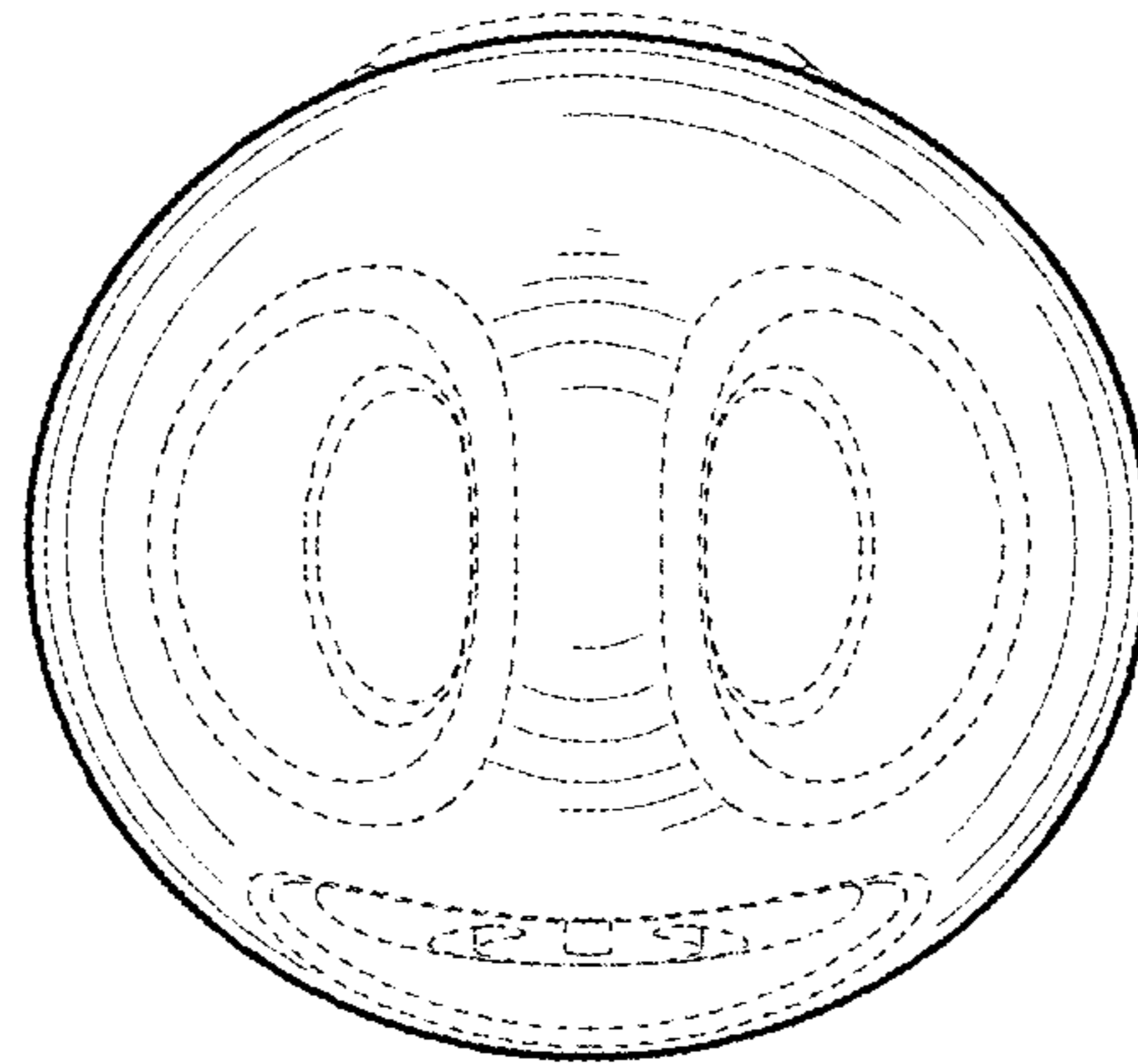

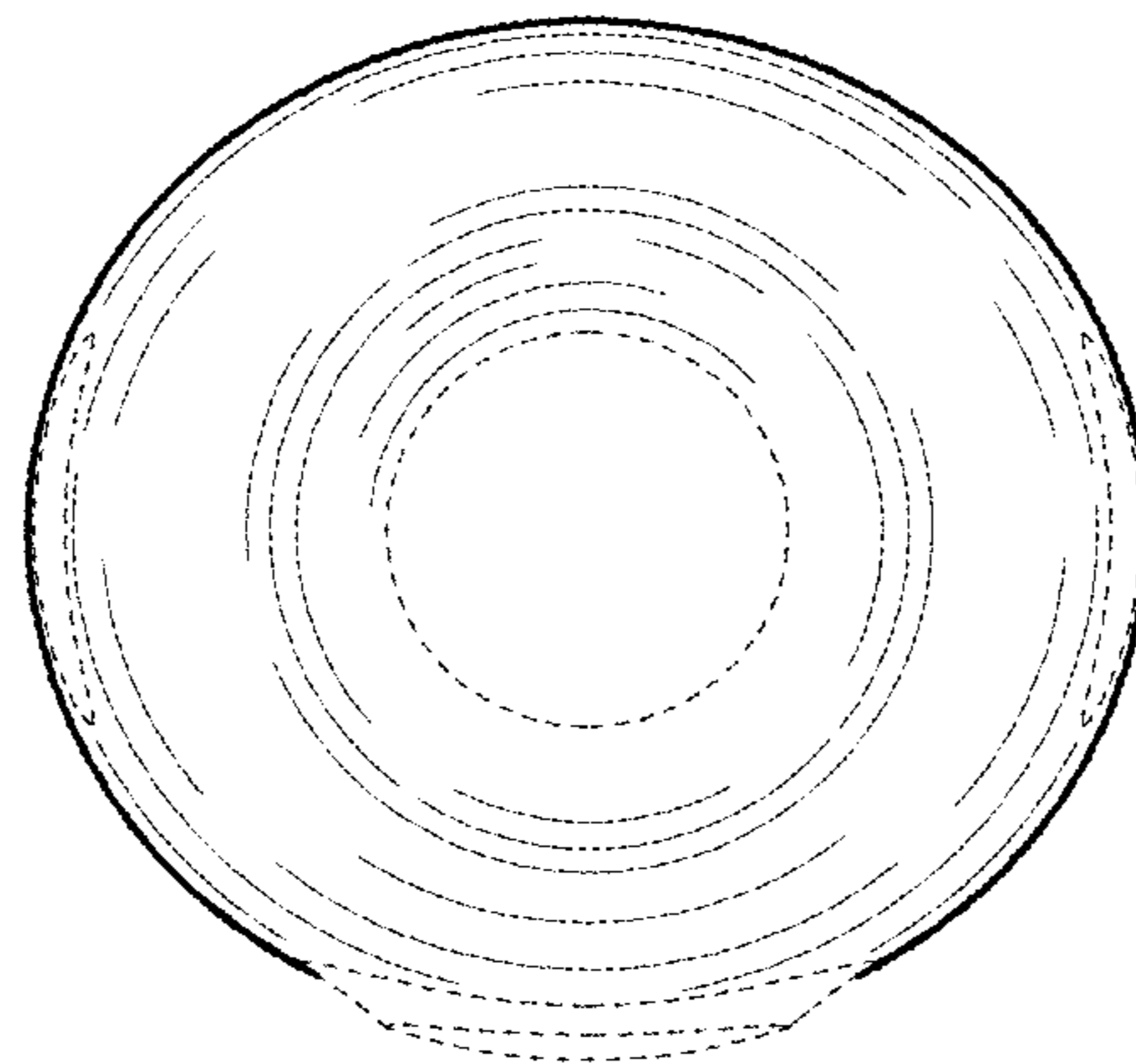

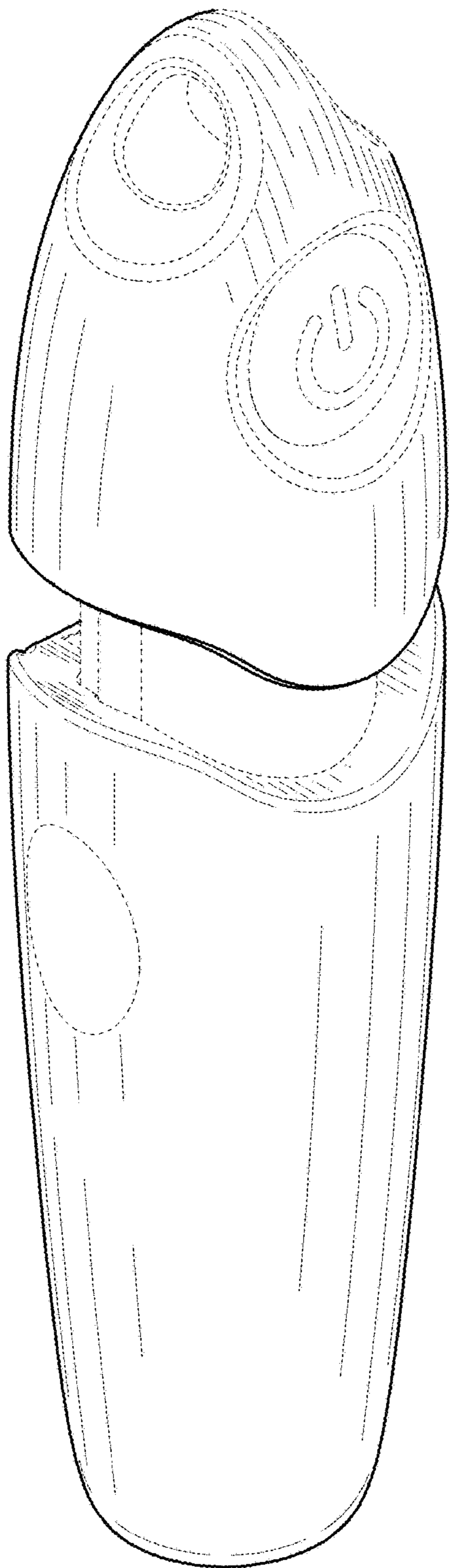

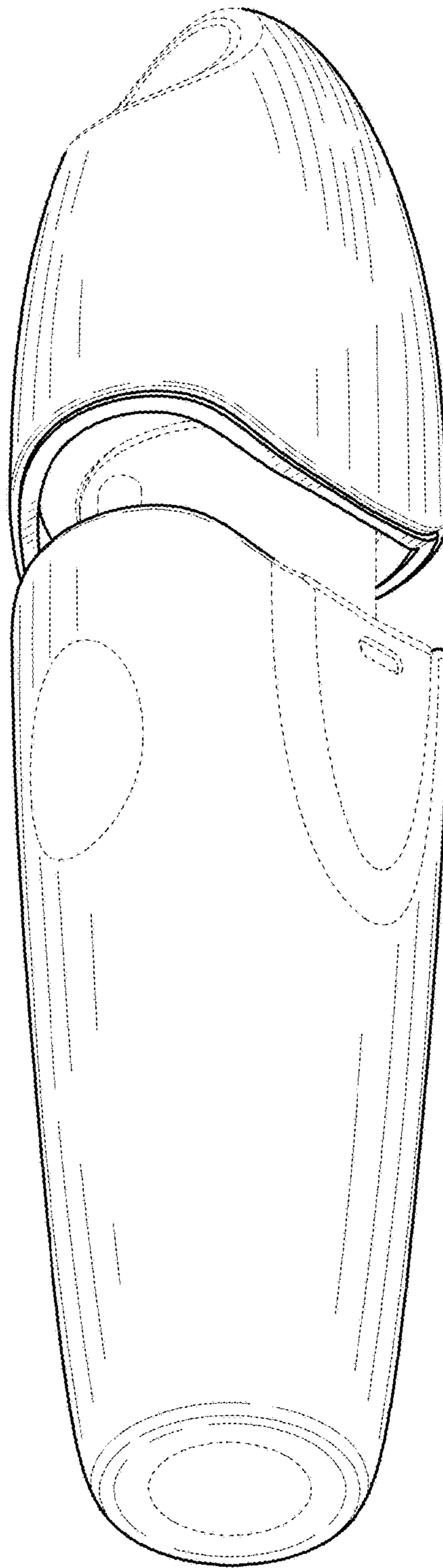
