DESCRIPTION

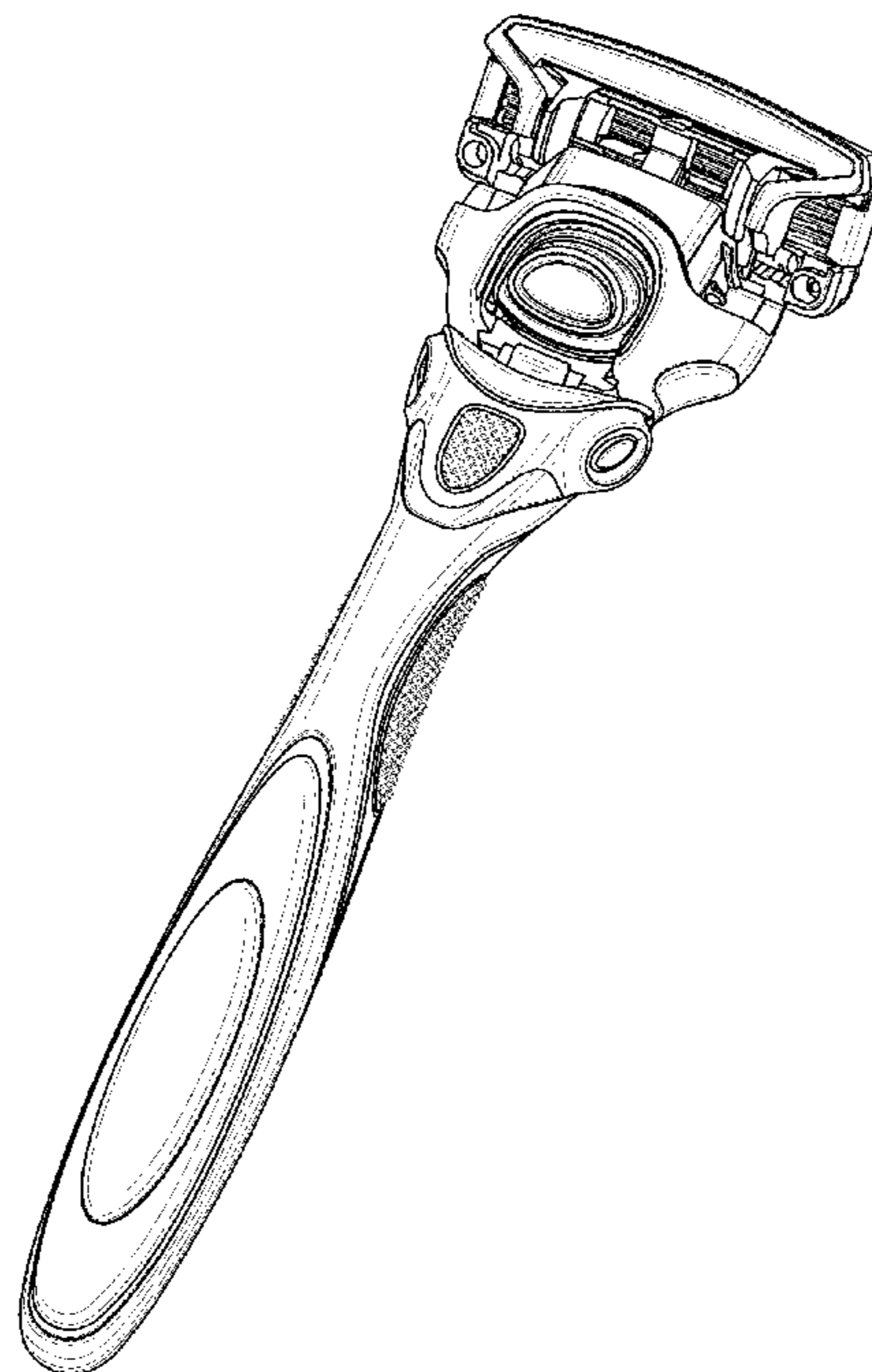
FIG. 1 is an upper perspective view of a safety razor.

FIG. 8 is a bottom view thereof.

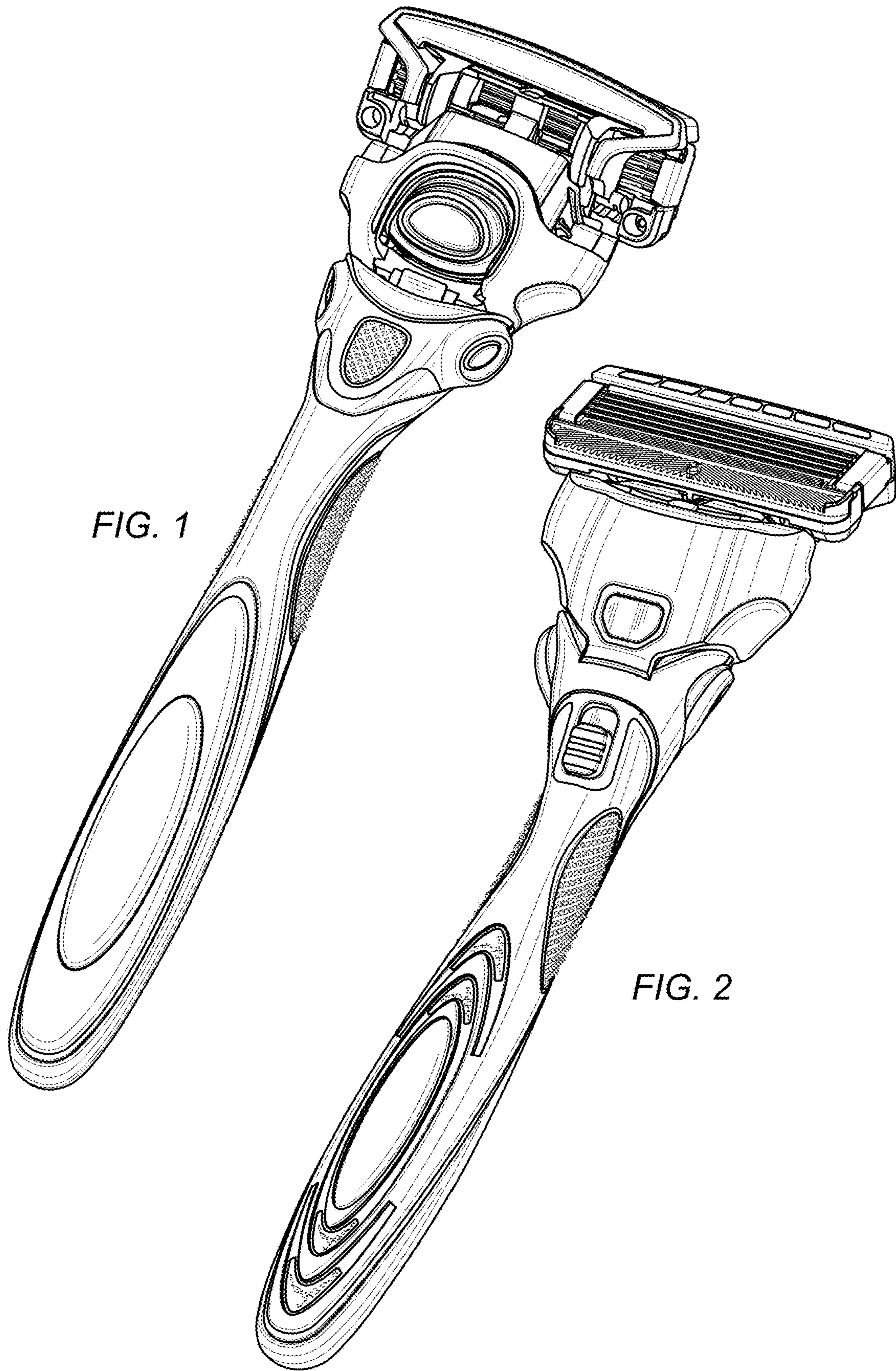

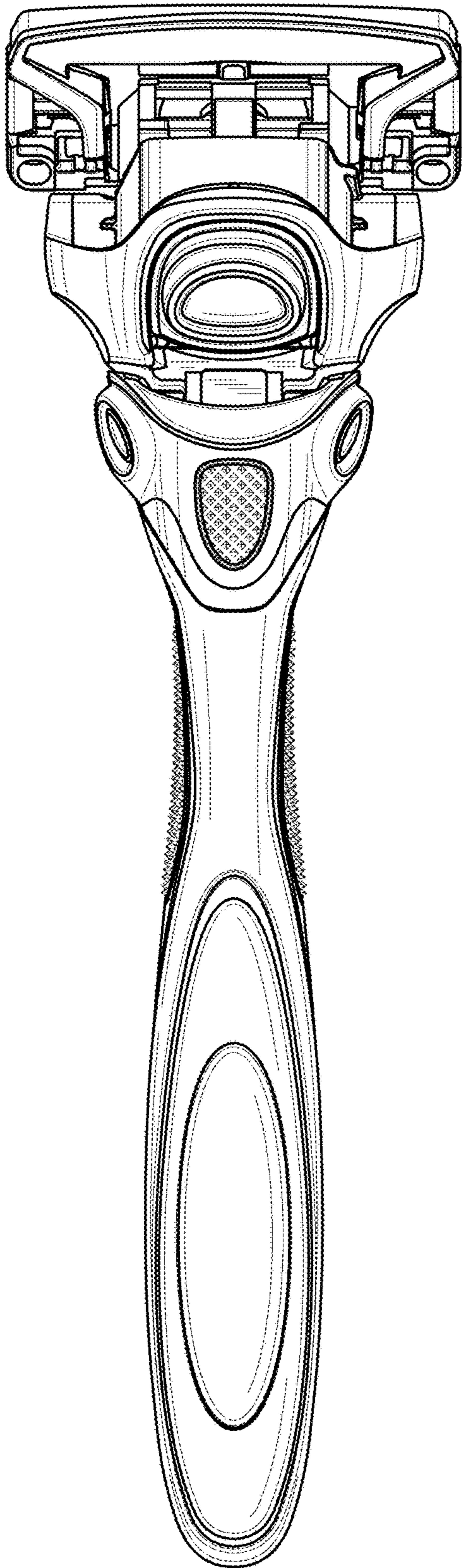

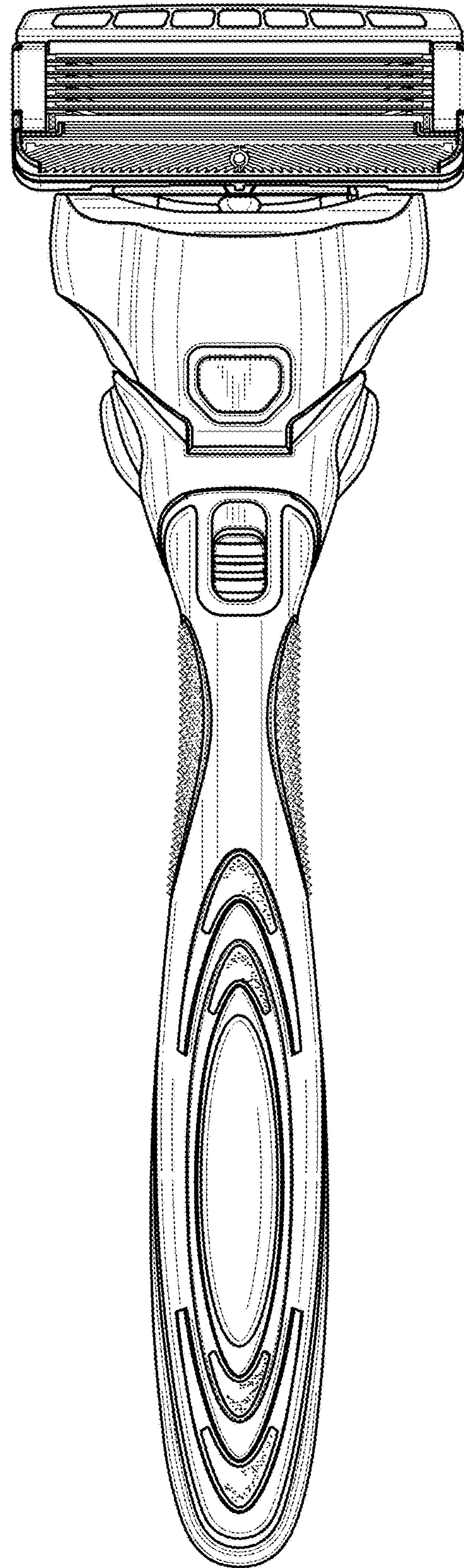

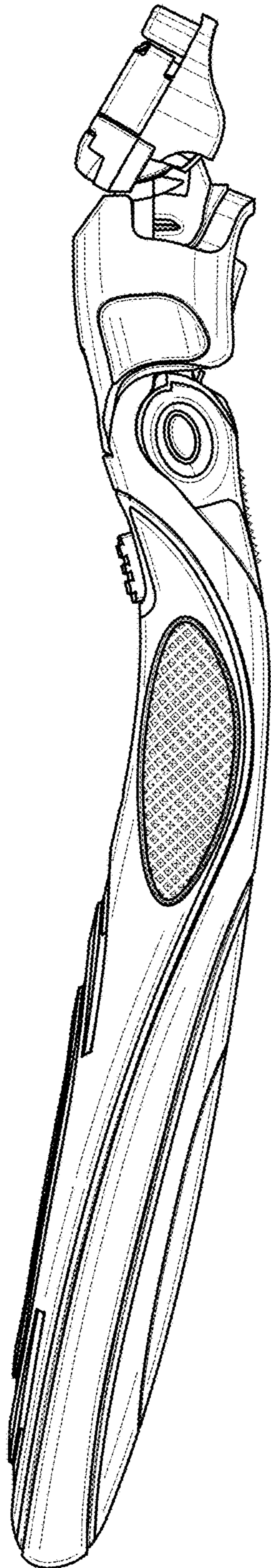

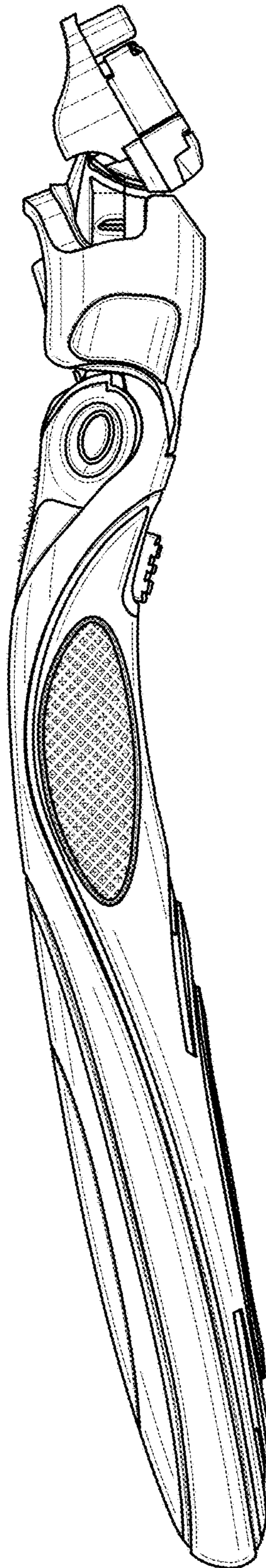

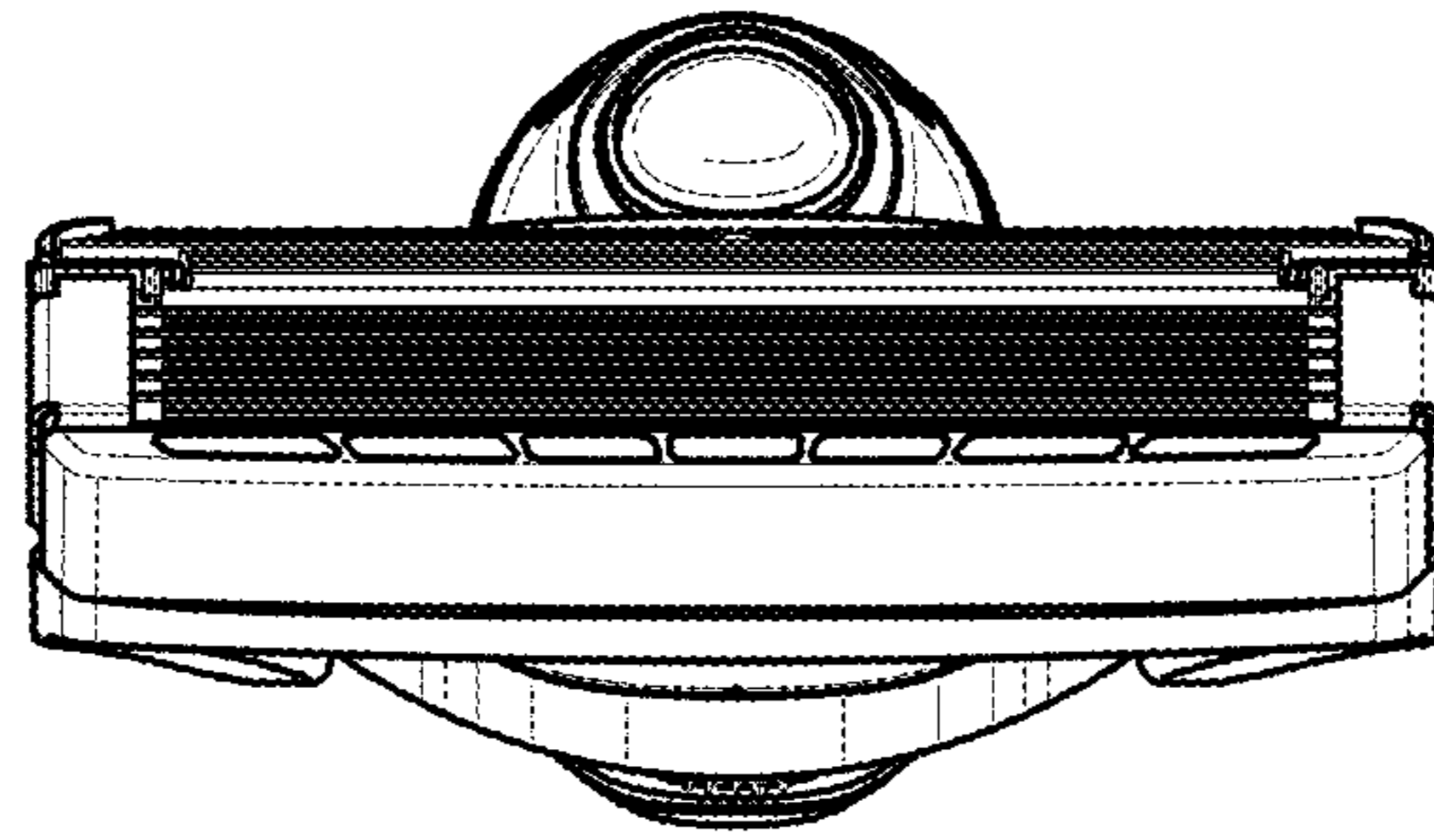

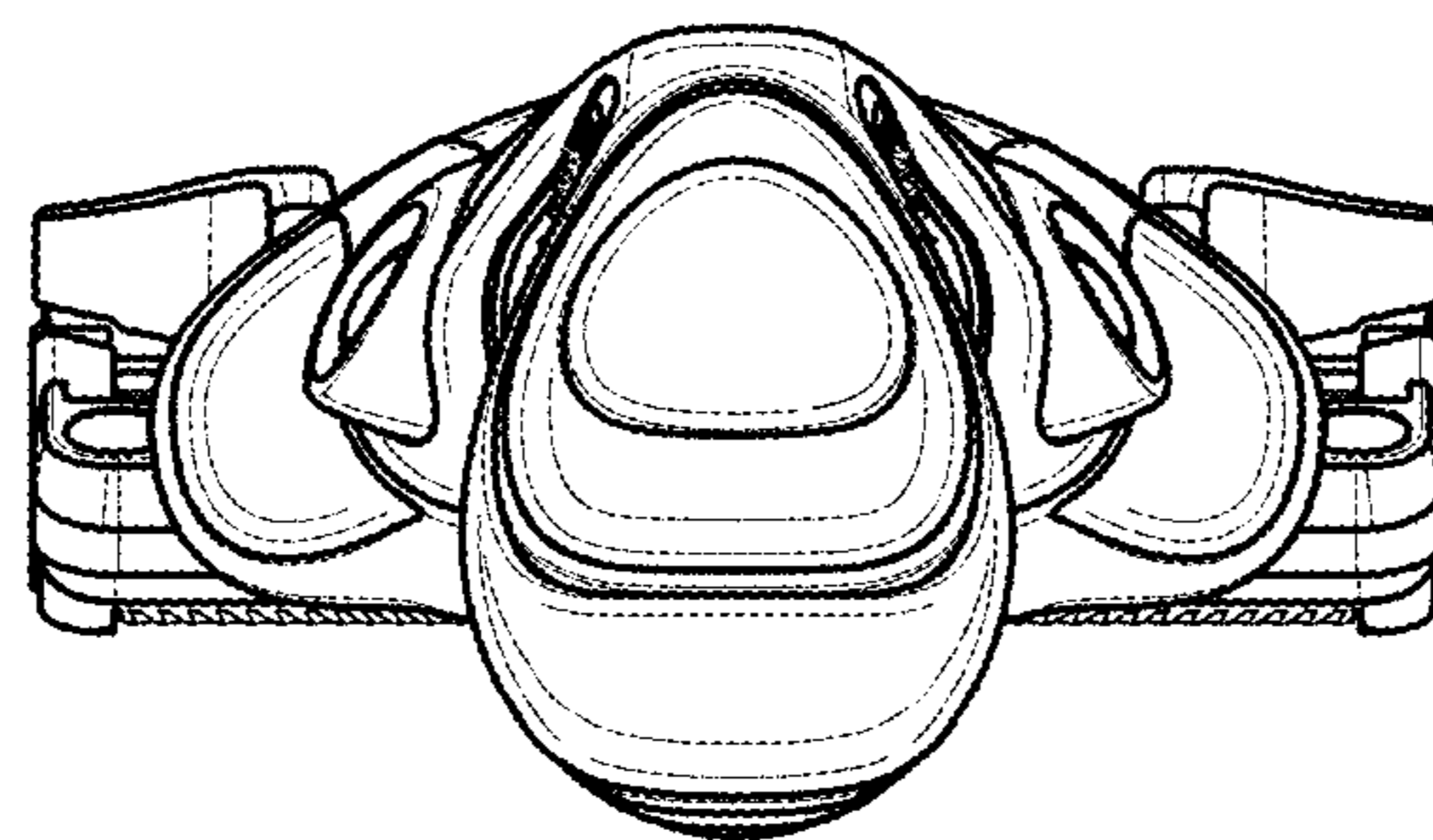
