The ornamental design for a glove, as shown and described.

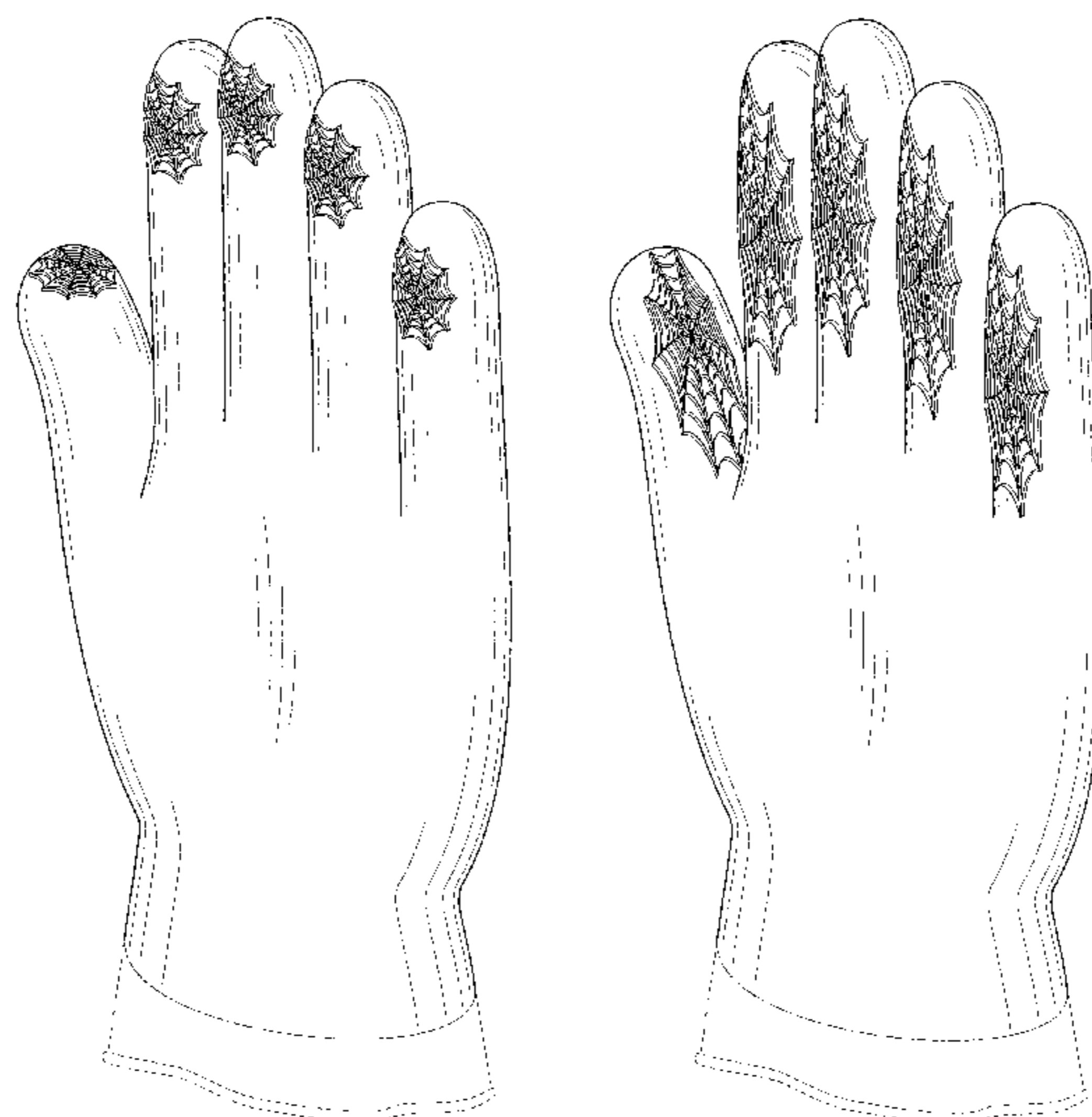

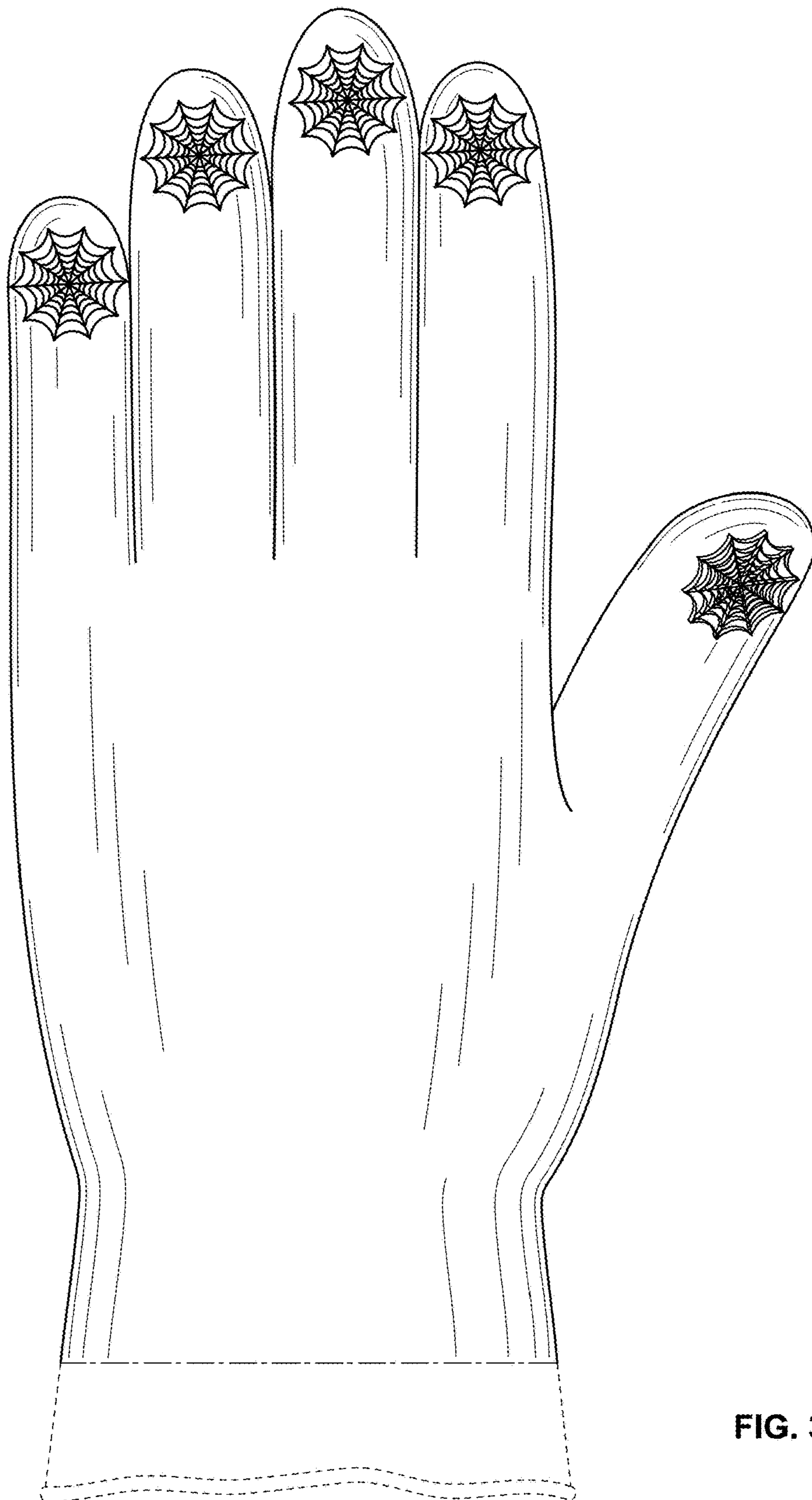

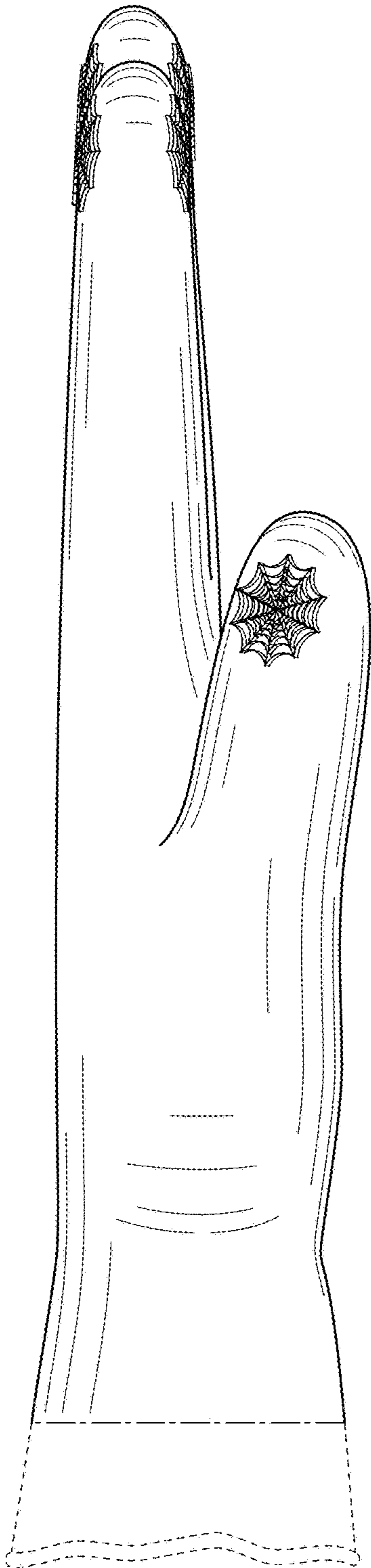

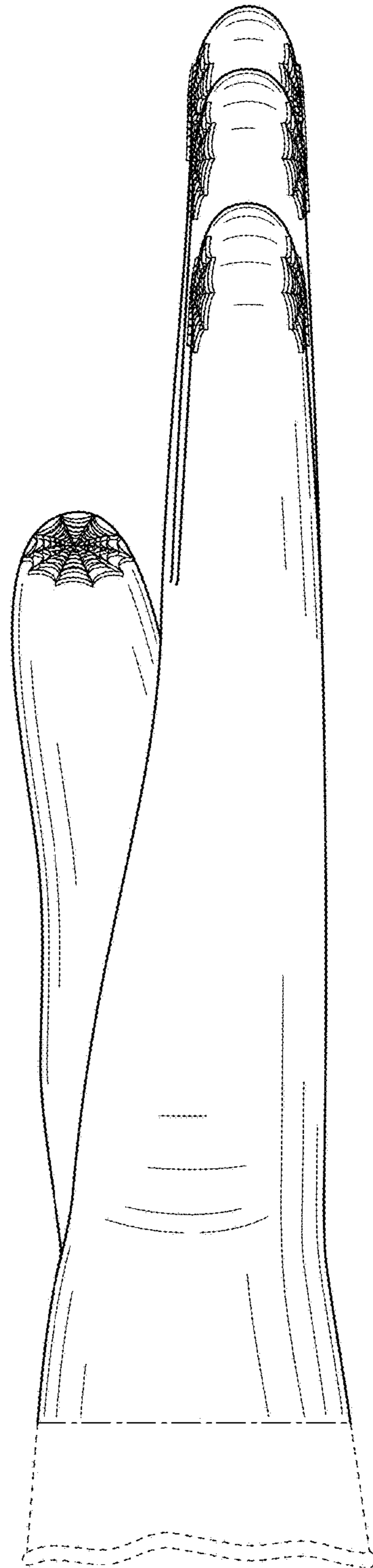

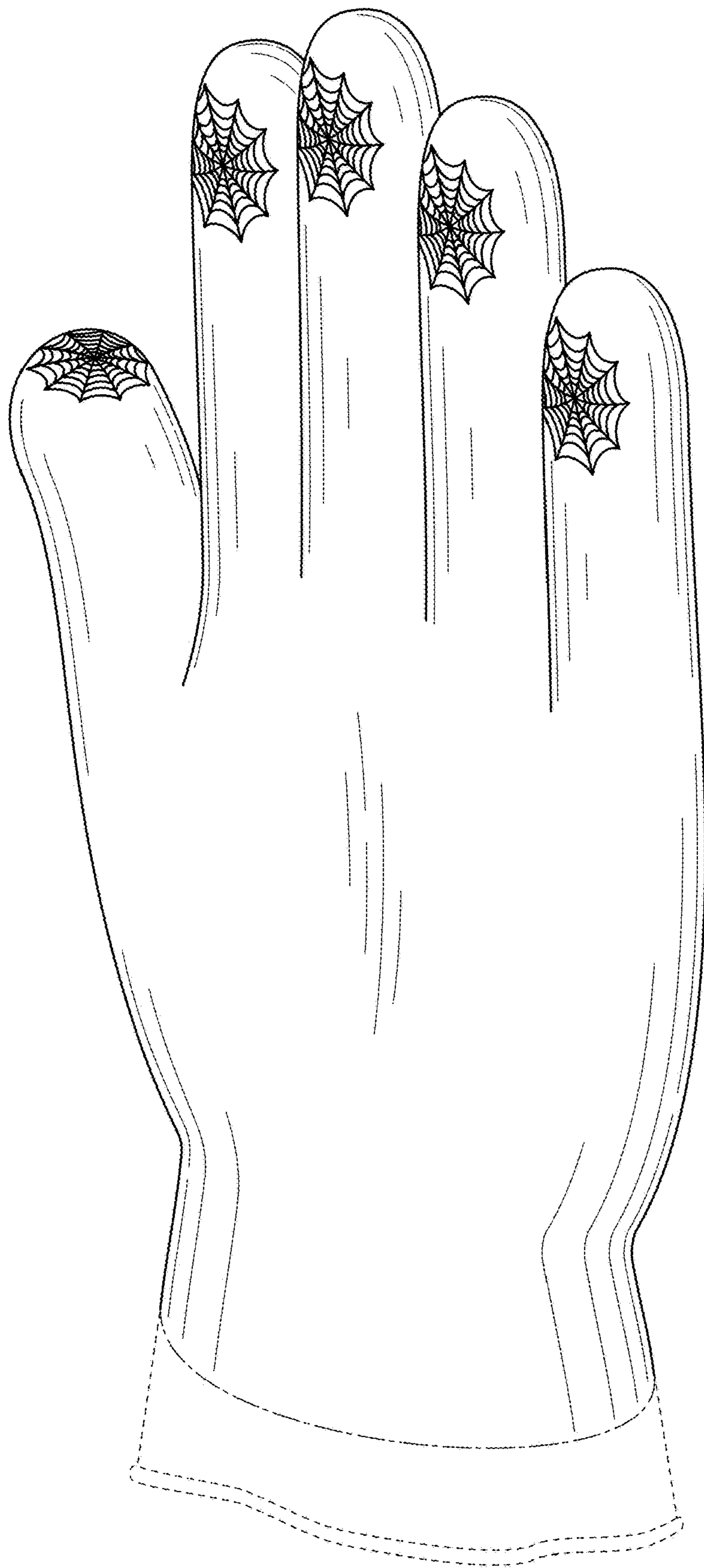

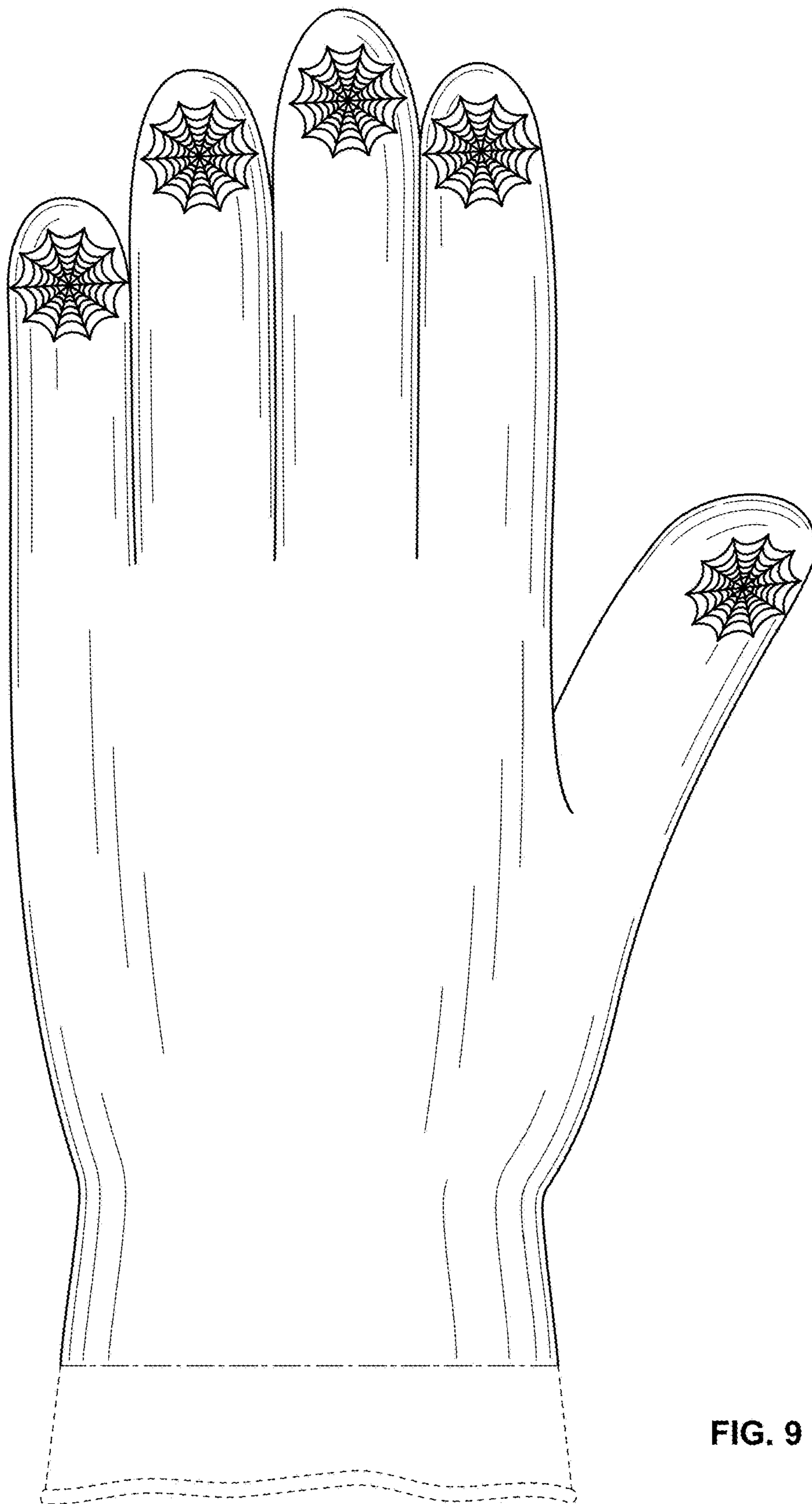

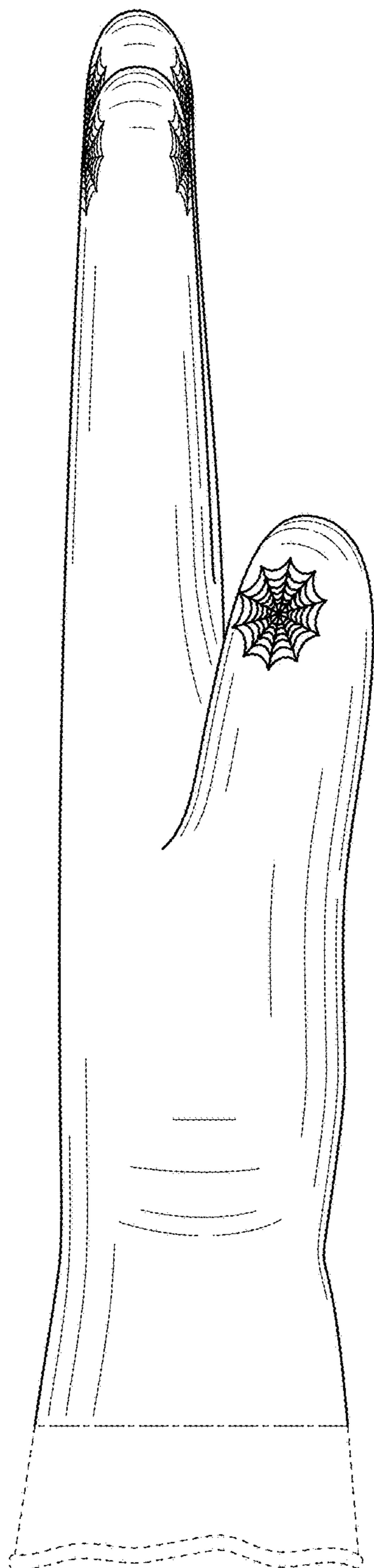

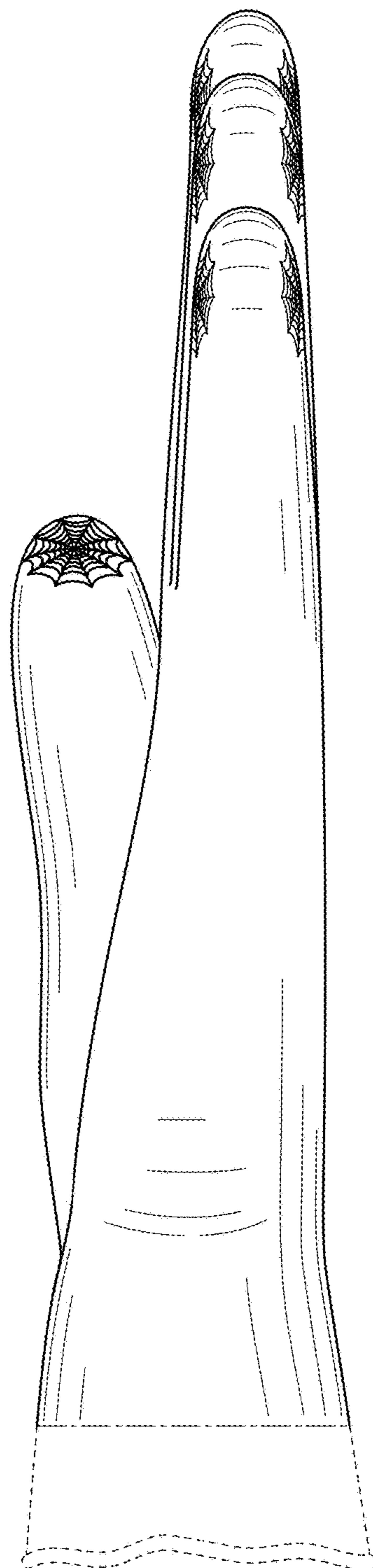

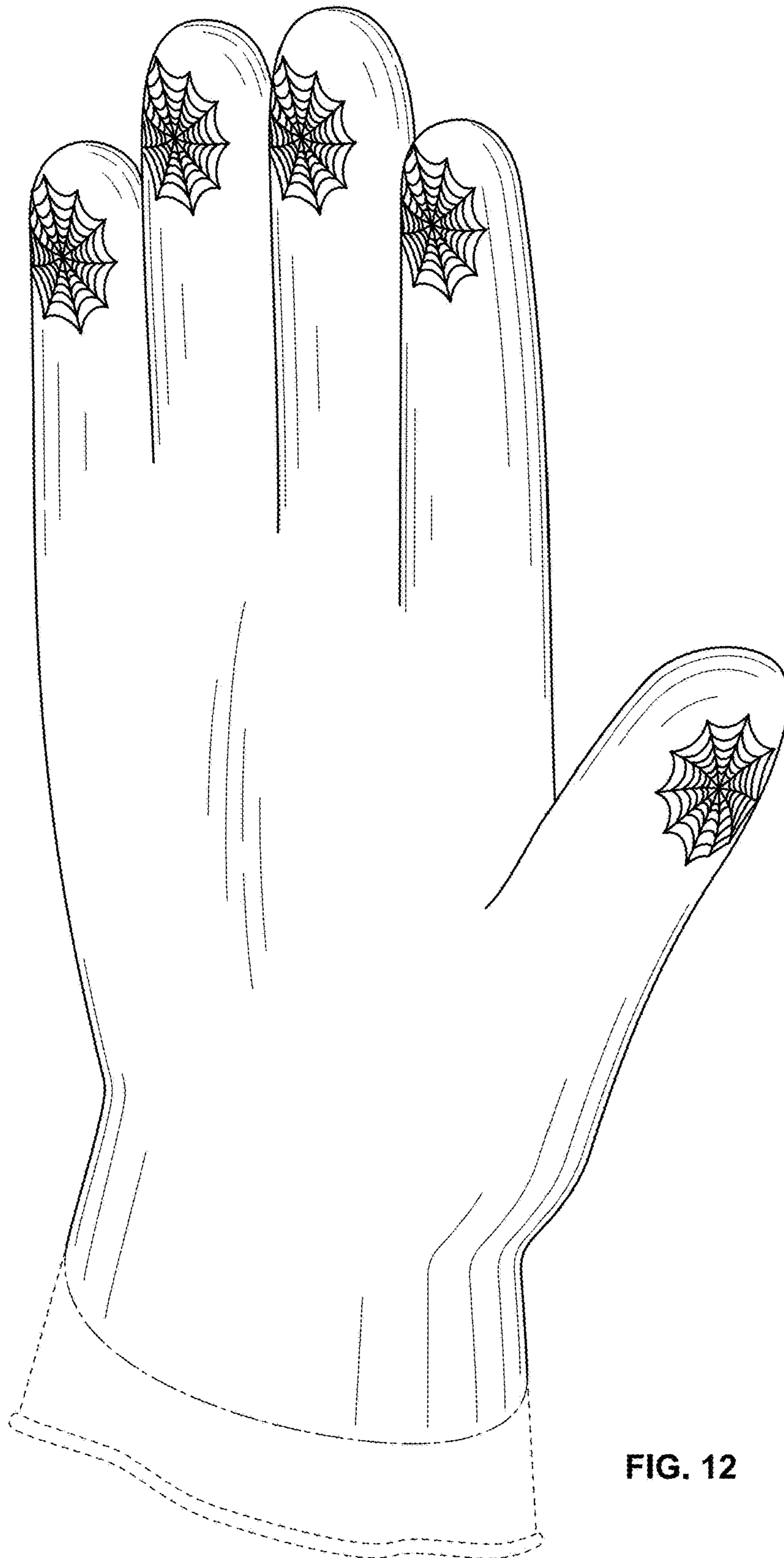

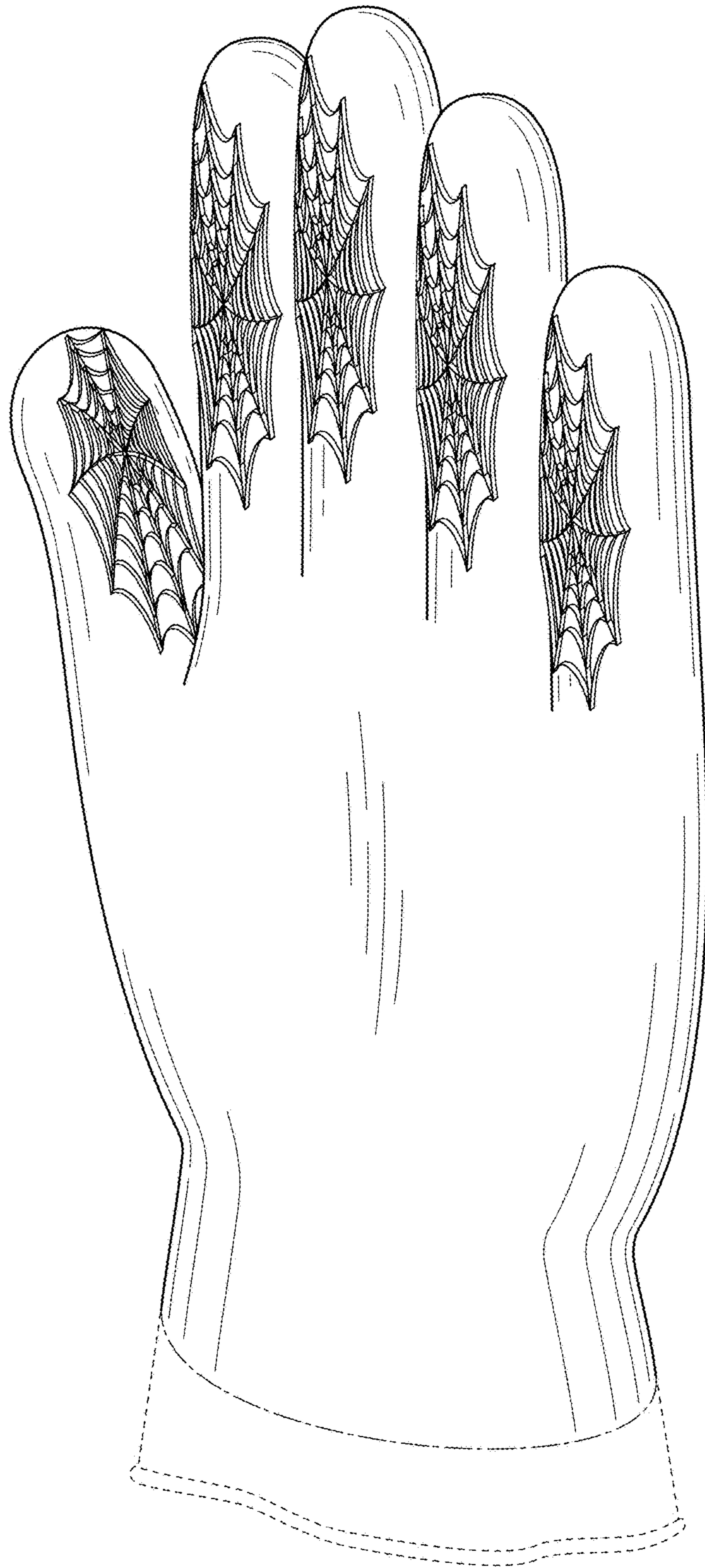

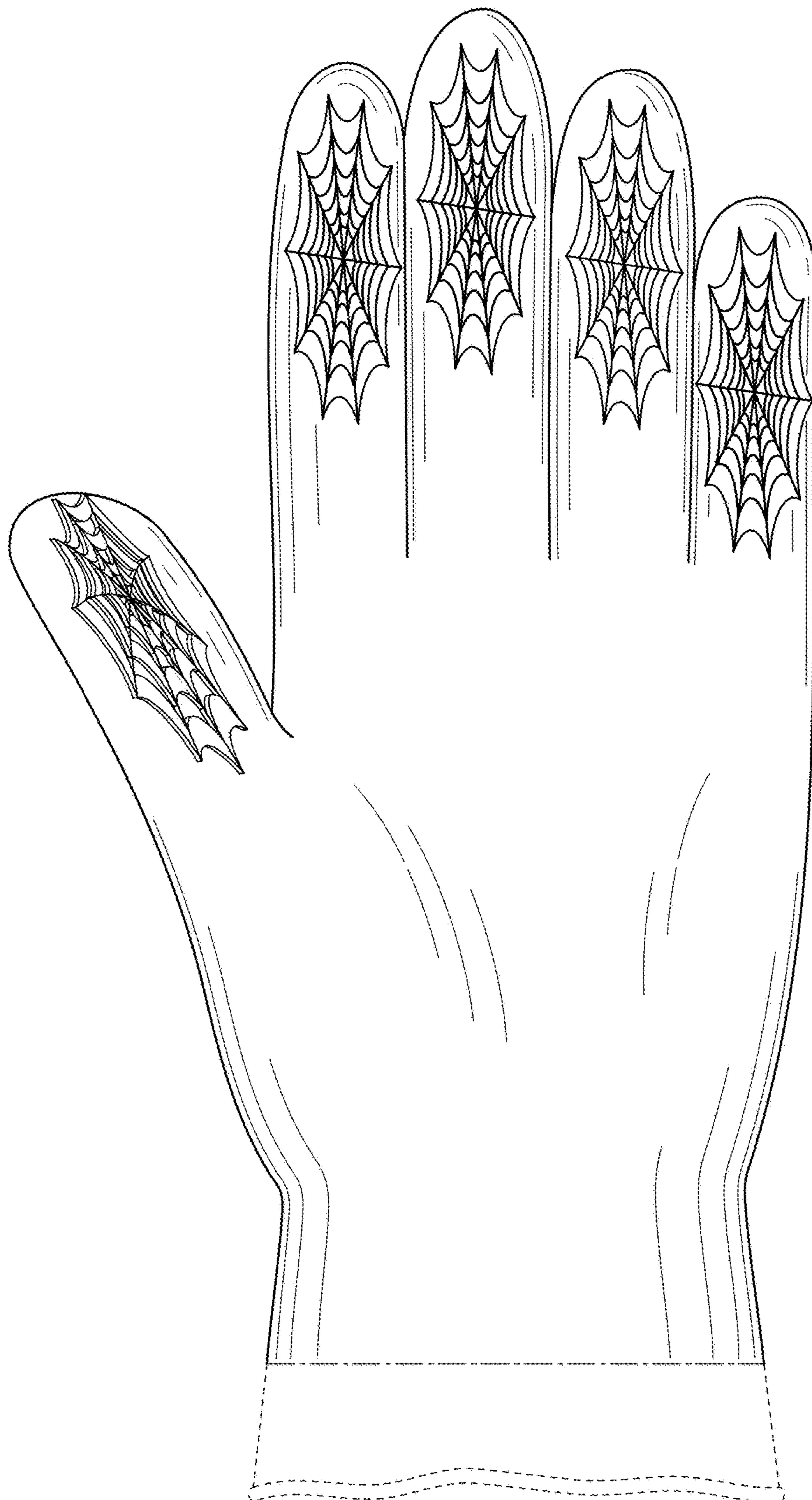

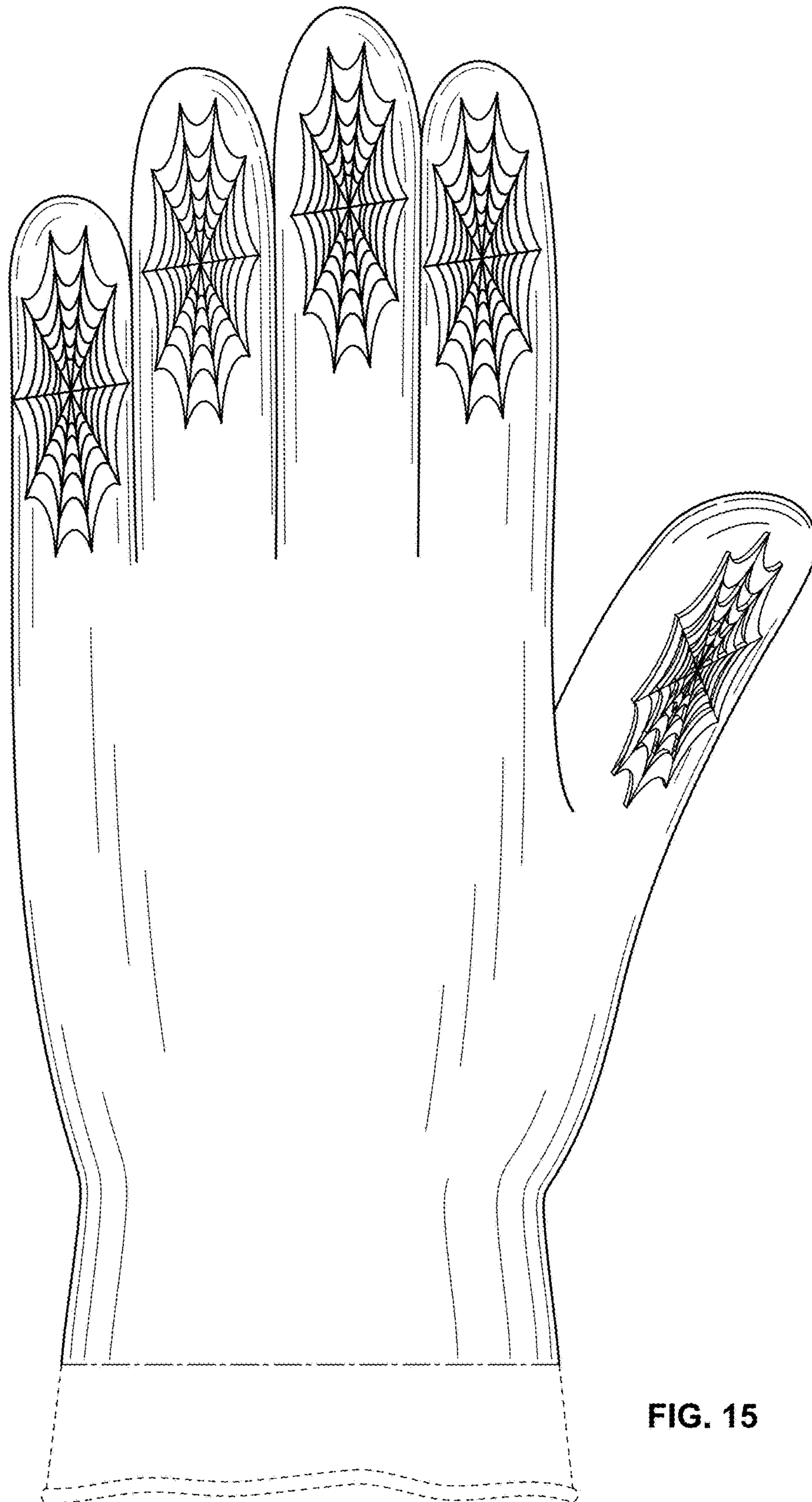

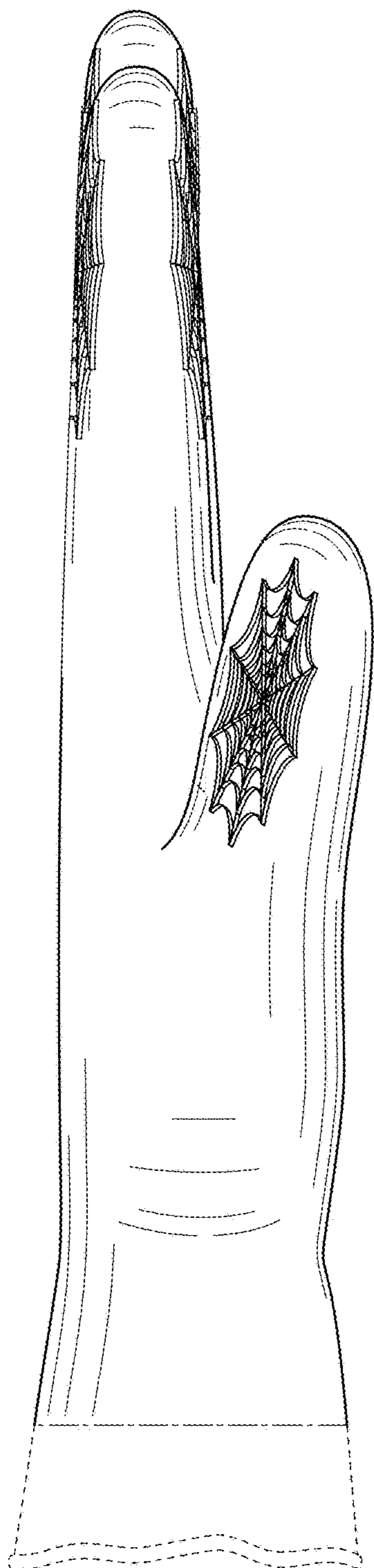

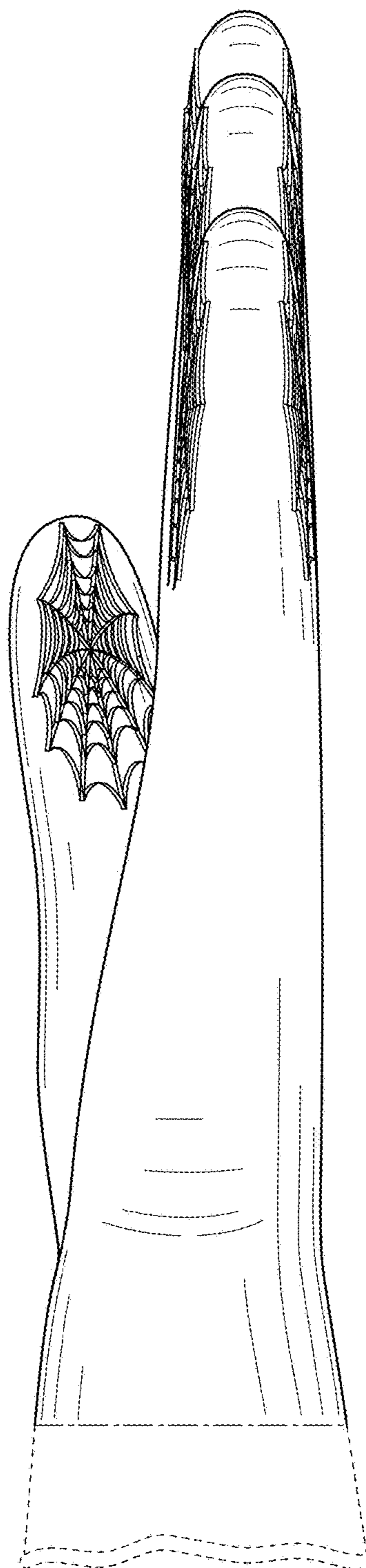

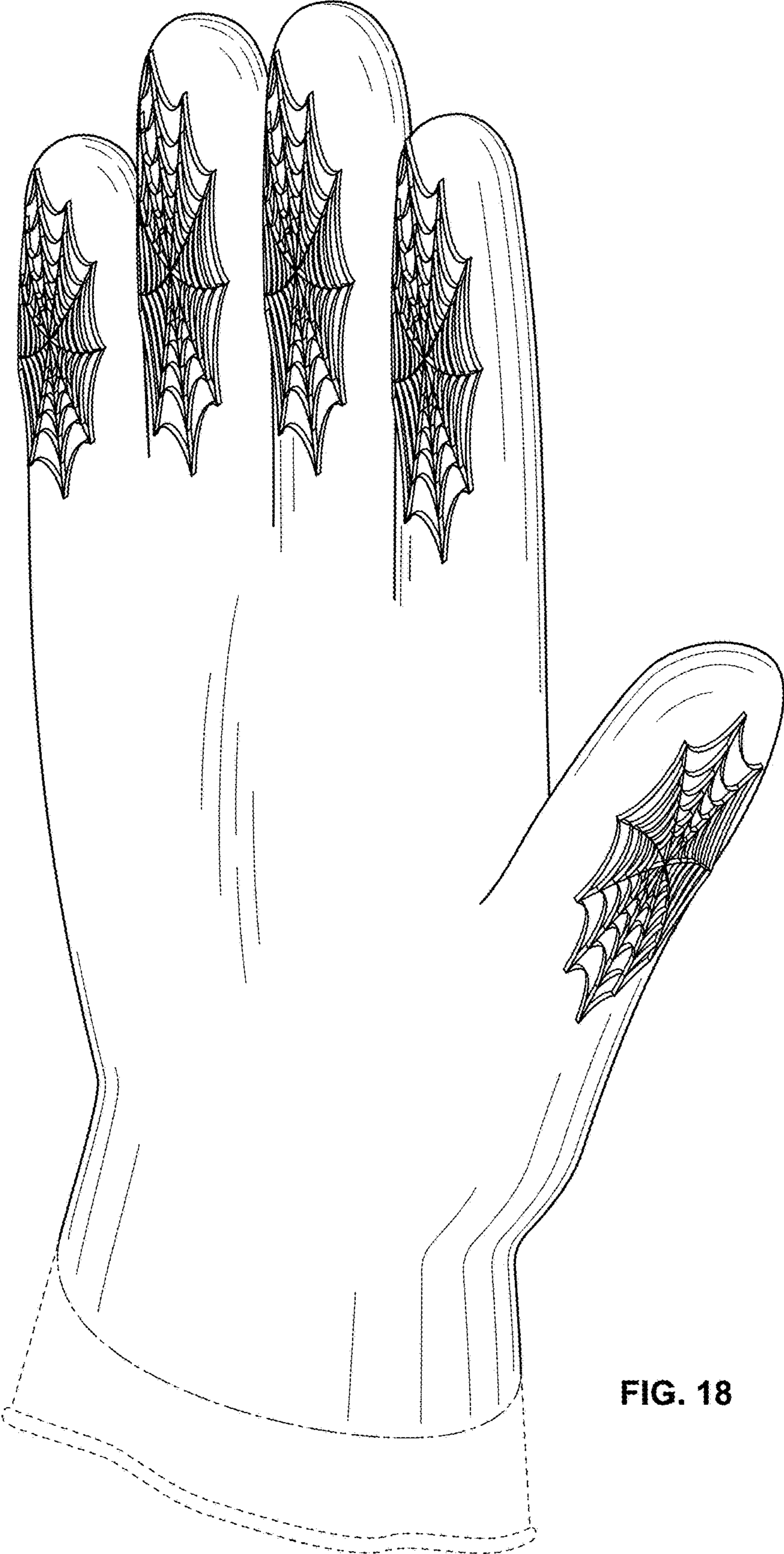

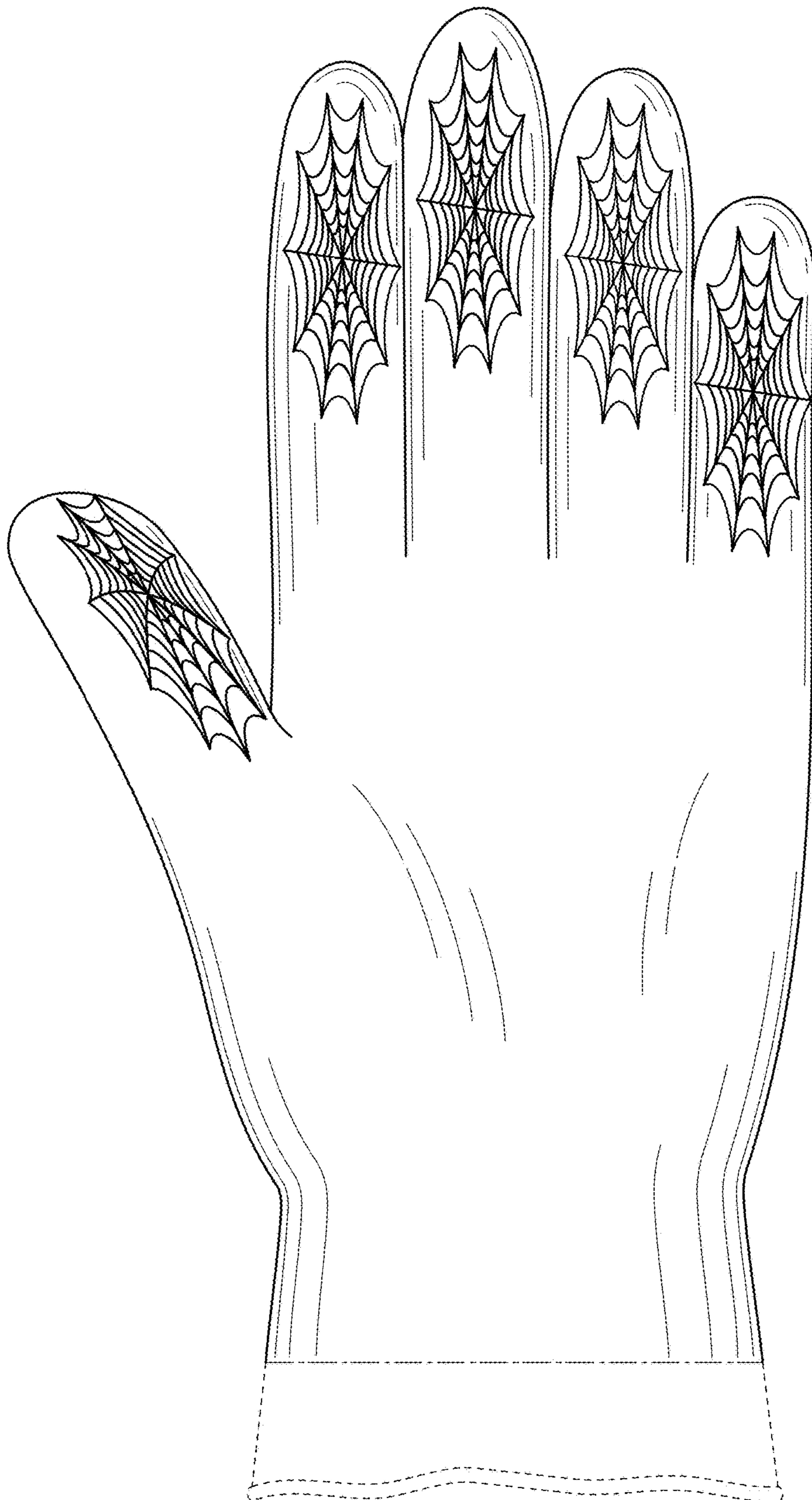

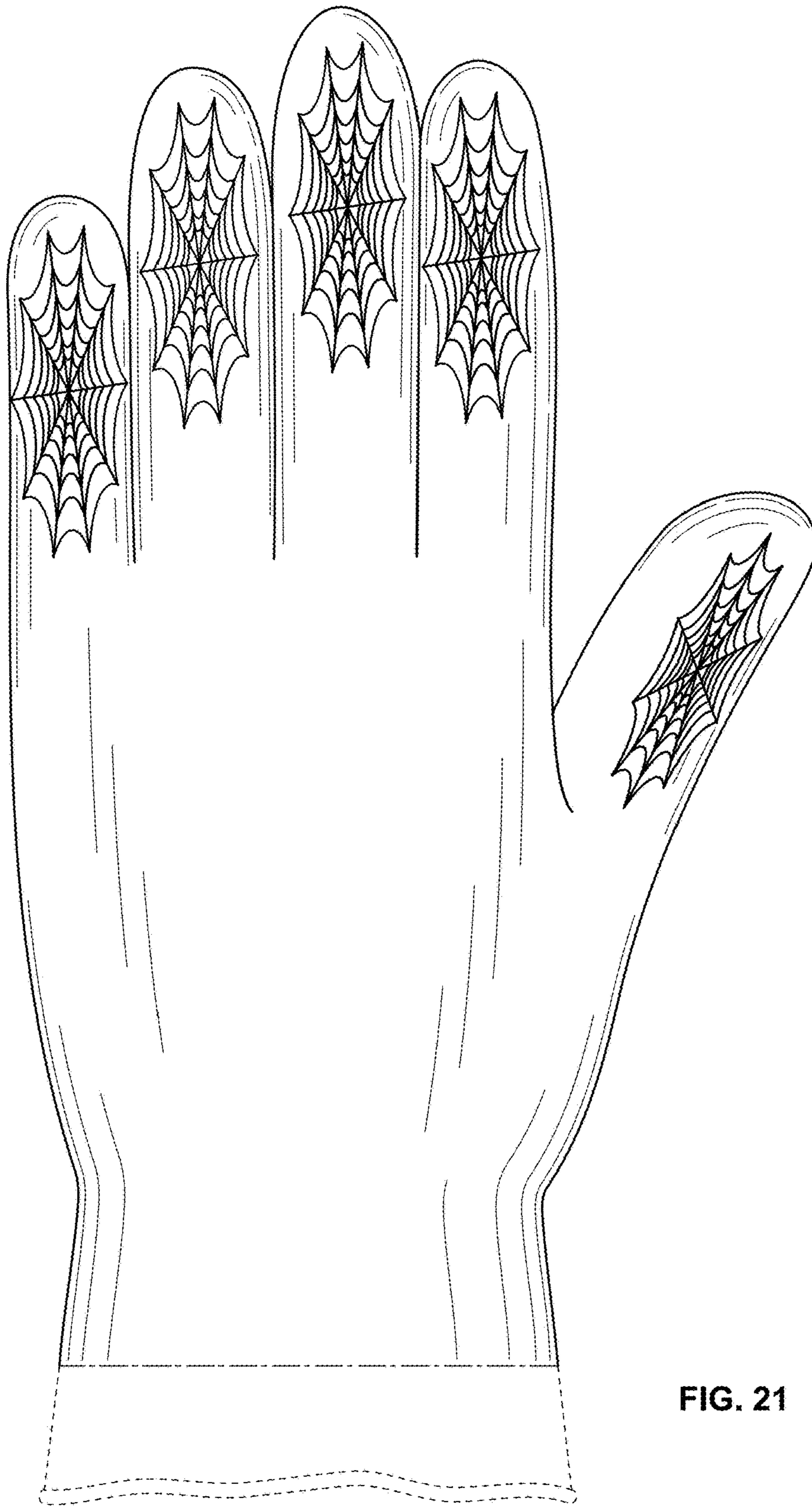

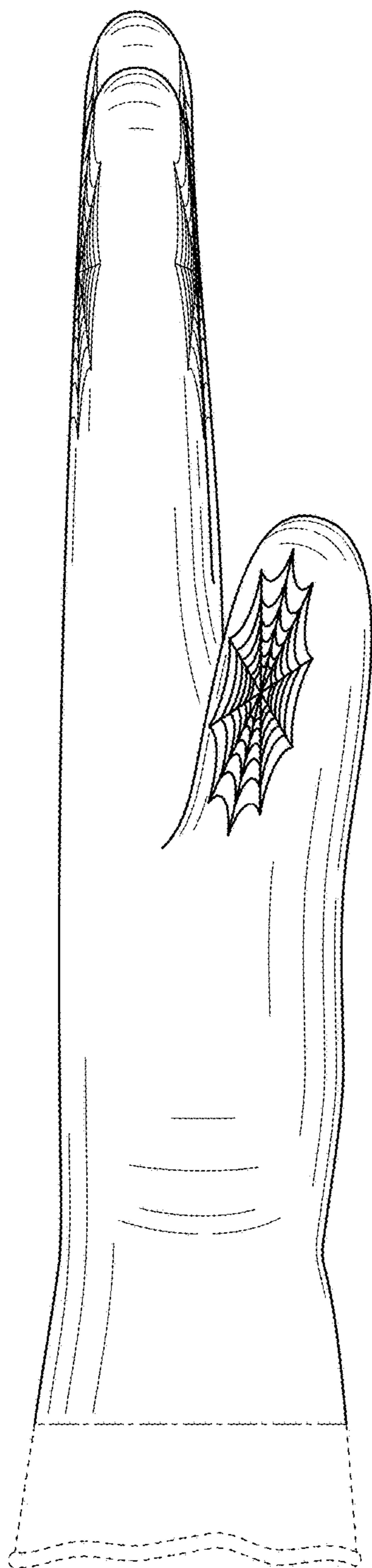

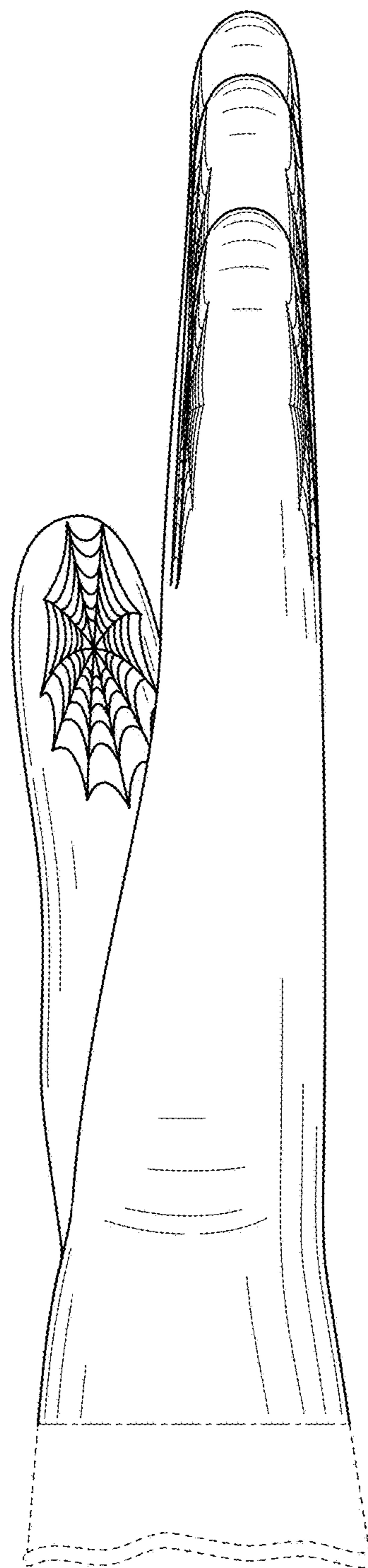
