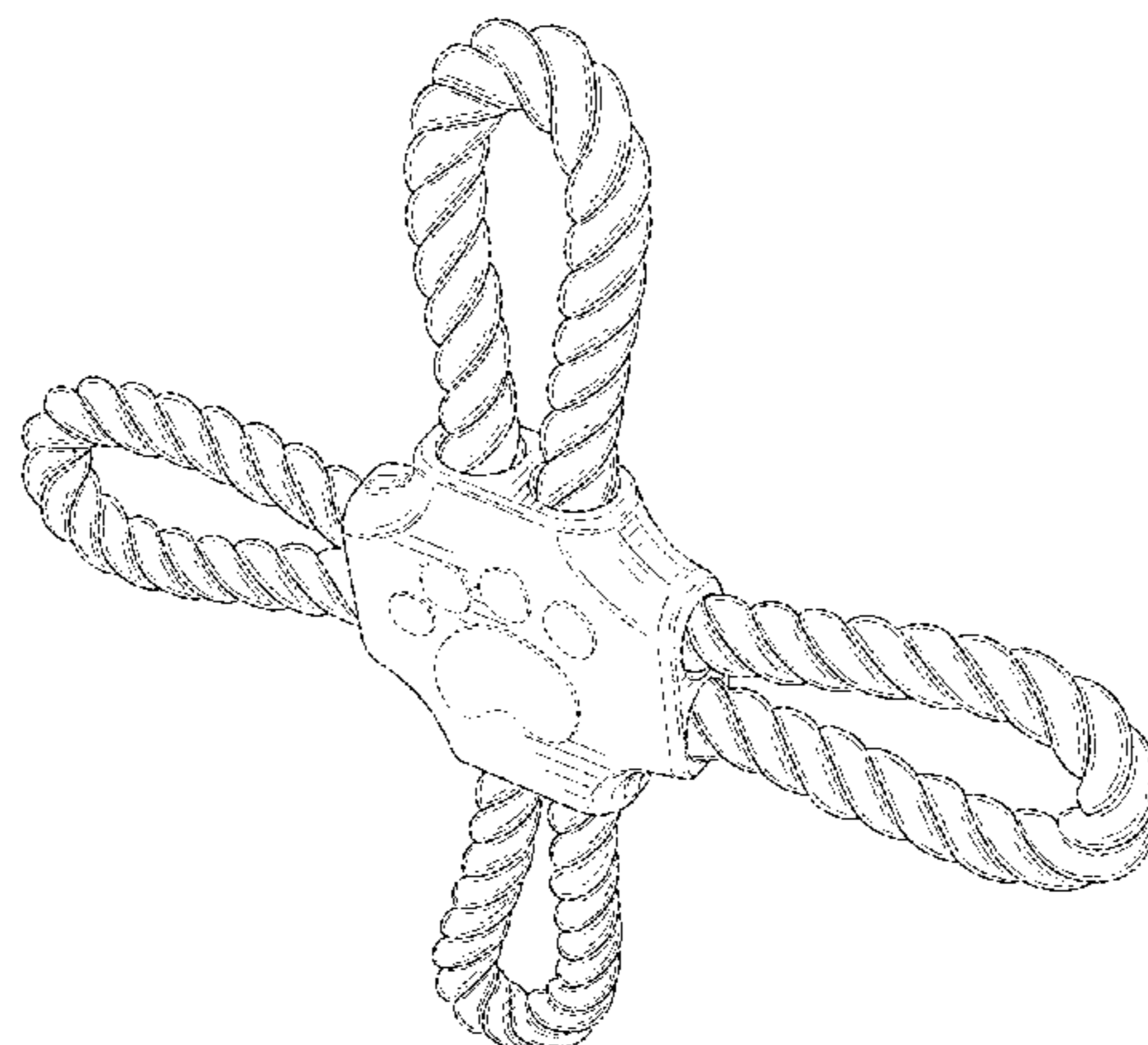
(57) **CLAIM**

The ornamental design for an animal rope toy, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the animal rope toy. FIG. 2 is a front elevational view of the animal rope toy. FIG. 3 is a rear elevational view of the animal rope toy. FIG. 4 is a left elevational view of the animal rope toy. FIG. 5 is a right elevational view of the animal rope toy. FIG. 6 is a bottom plan view of the animal rope toy; and, FIG. 7 is a top plan view of the animal rope toy.

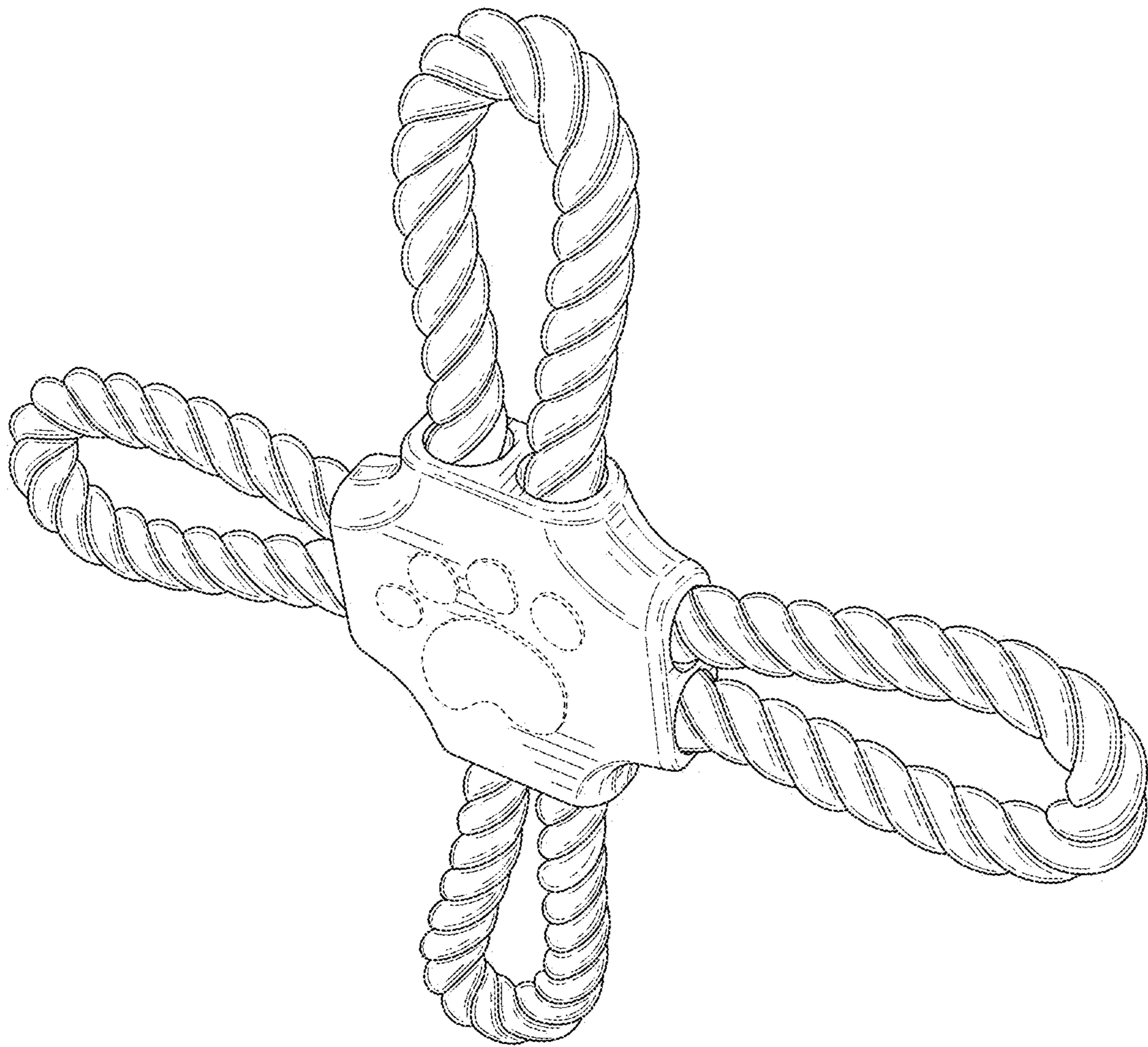

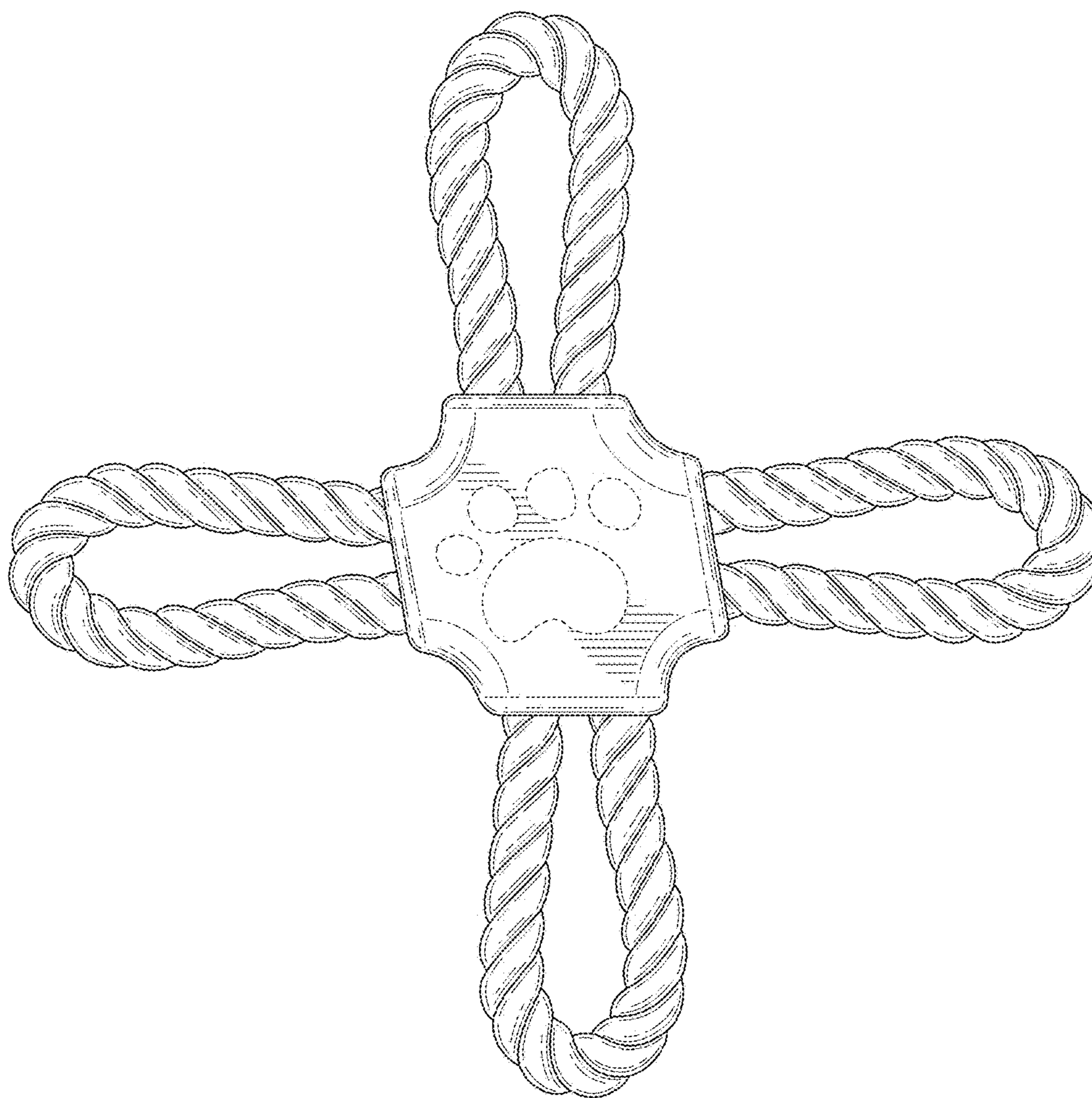

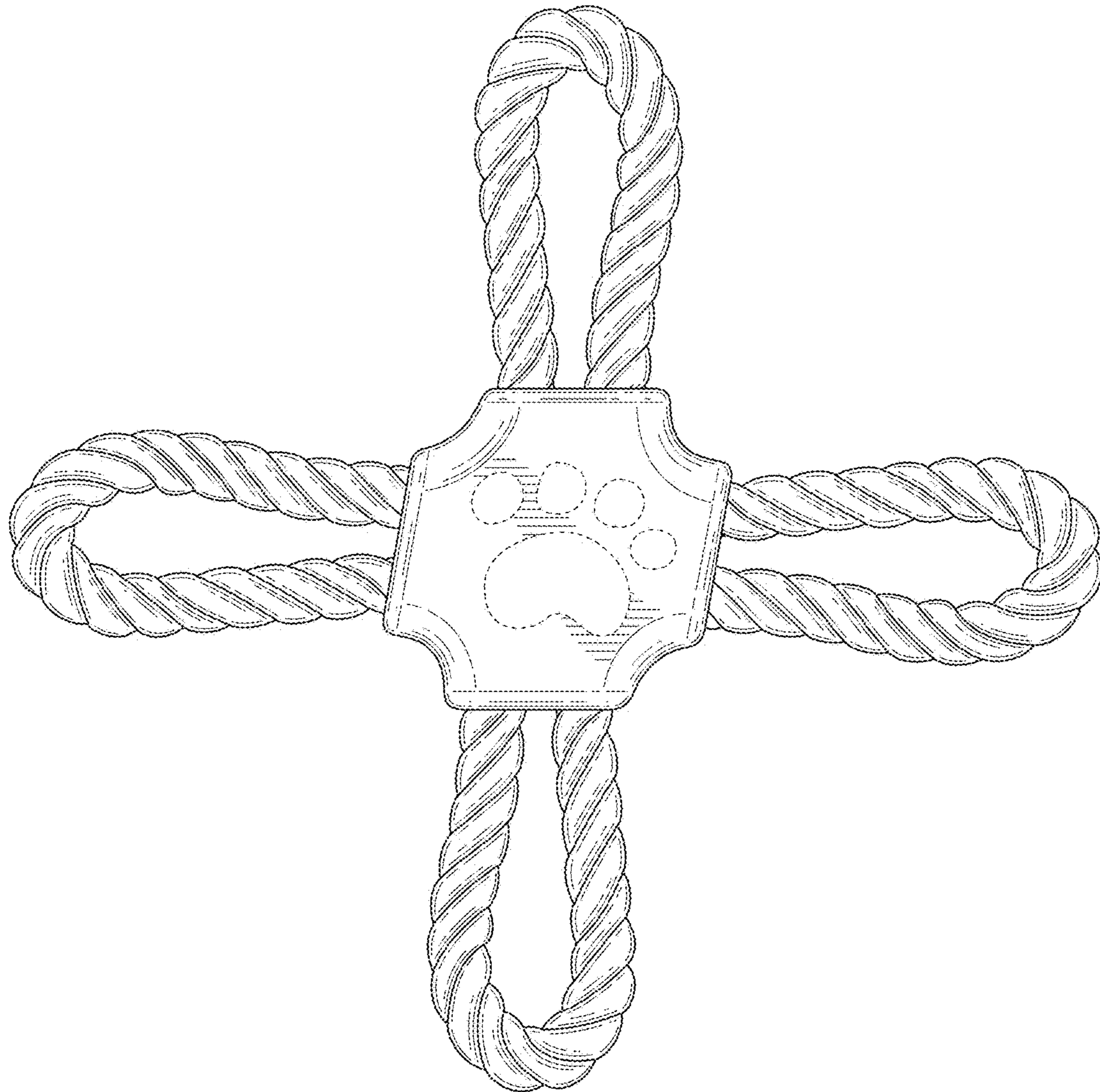

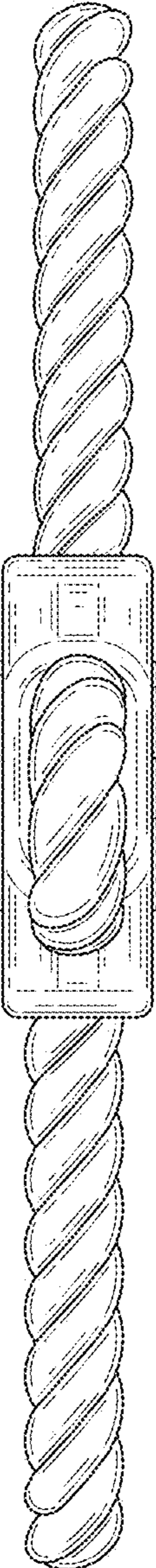

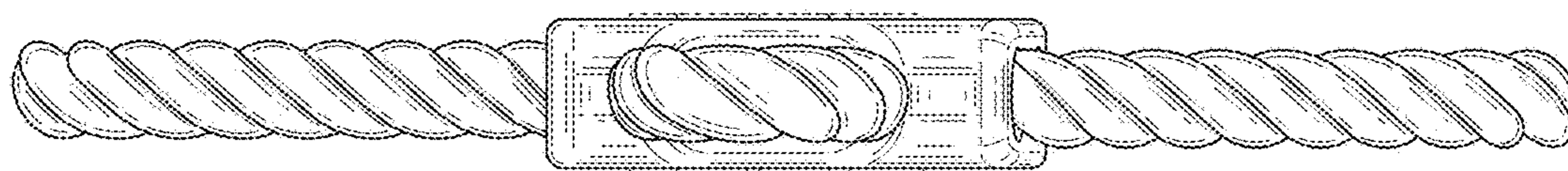

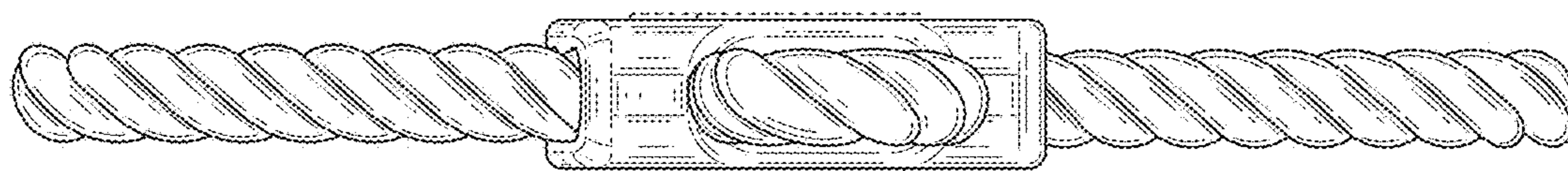
