DESCRIPTION

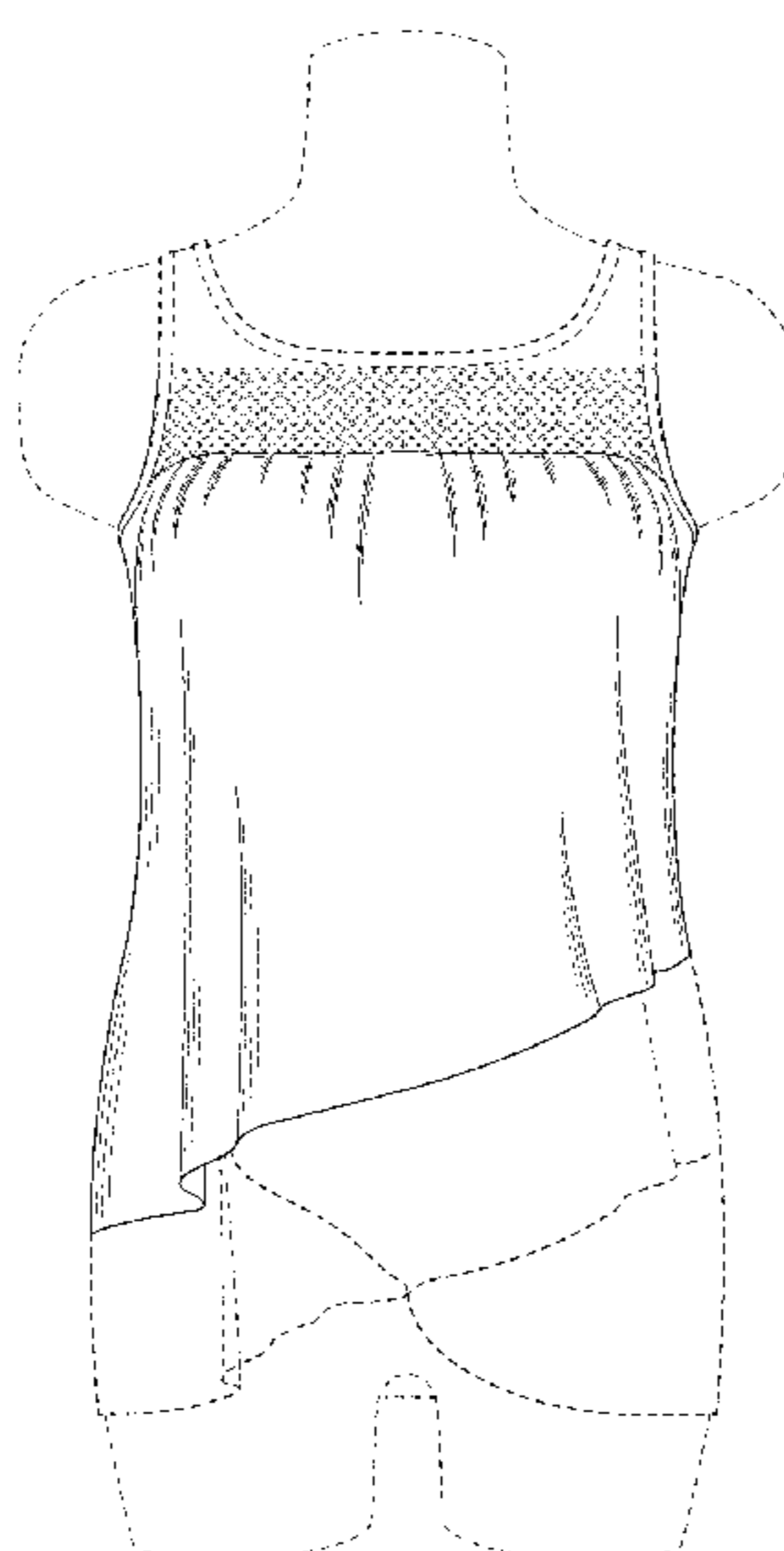
FIG. 1 is a front view of a swimsuit showing my new design. FIG. 2 is a rear view thereof.

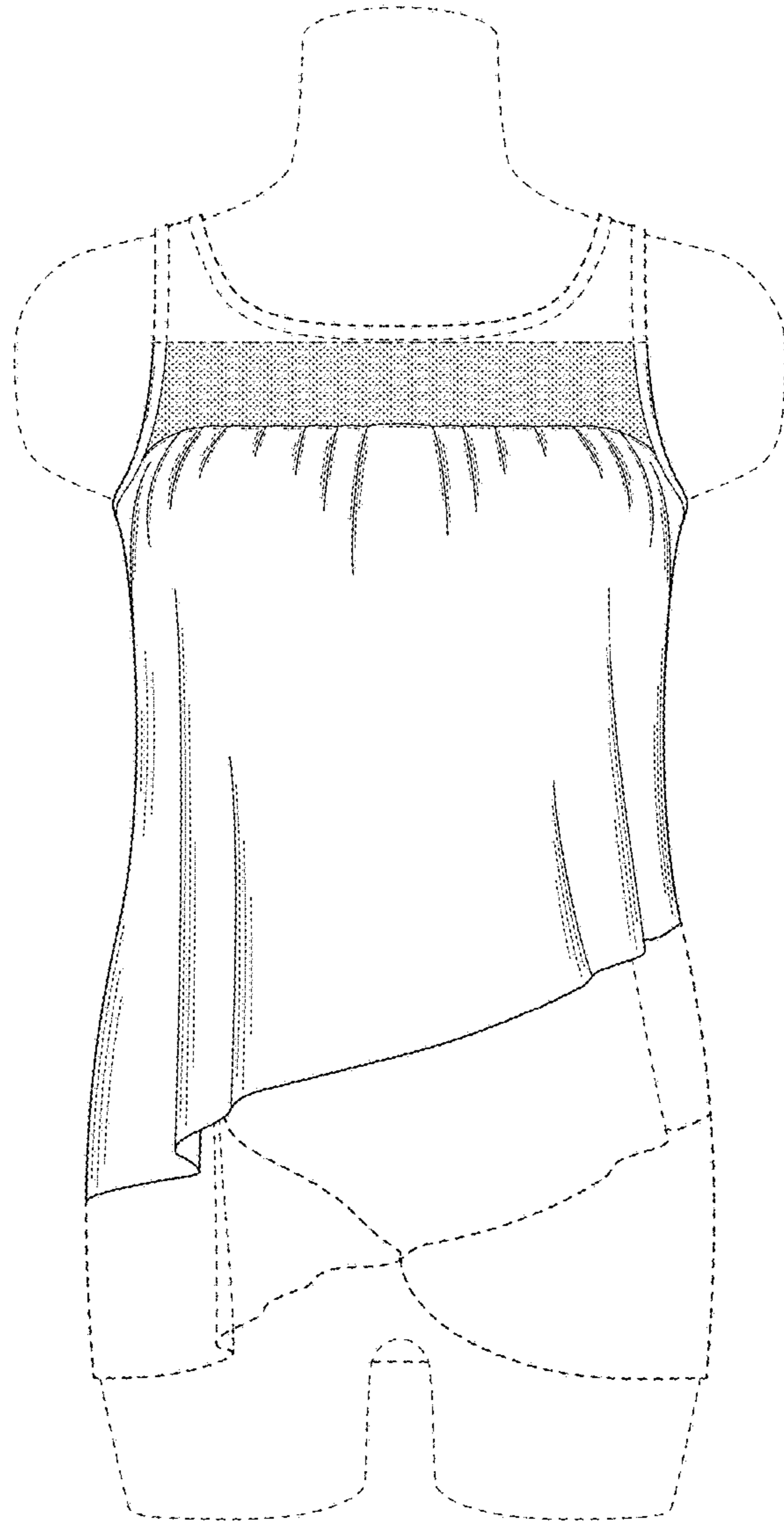

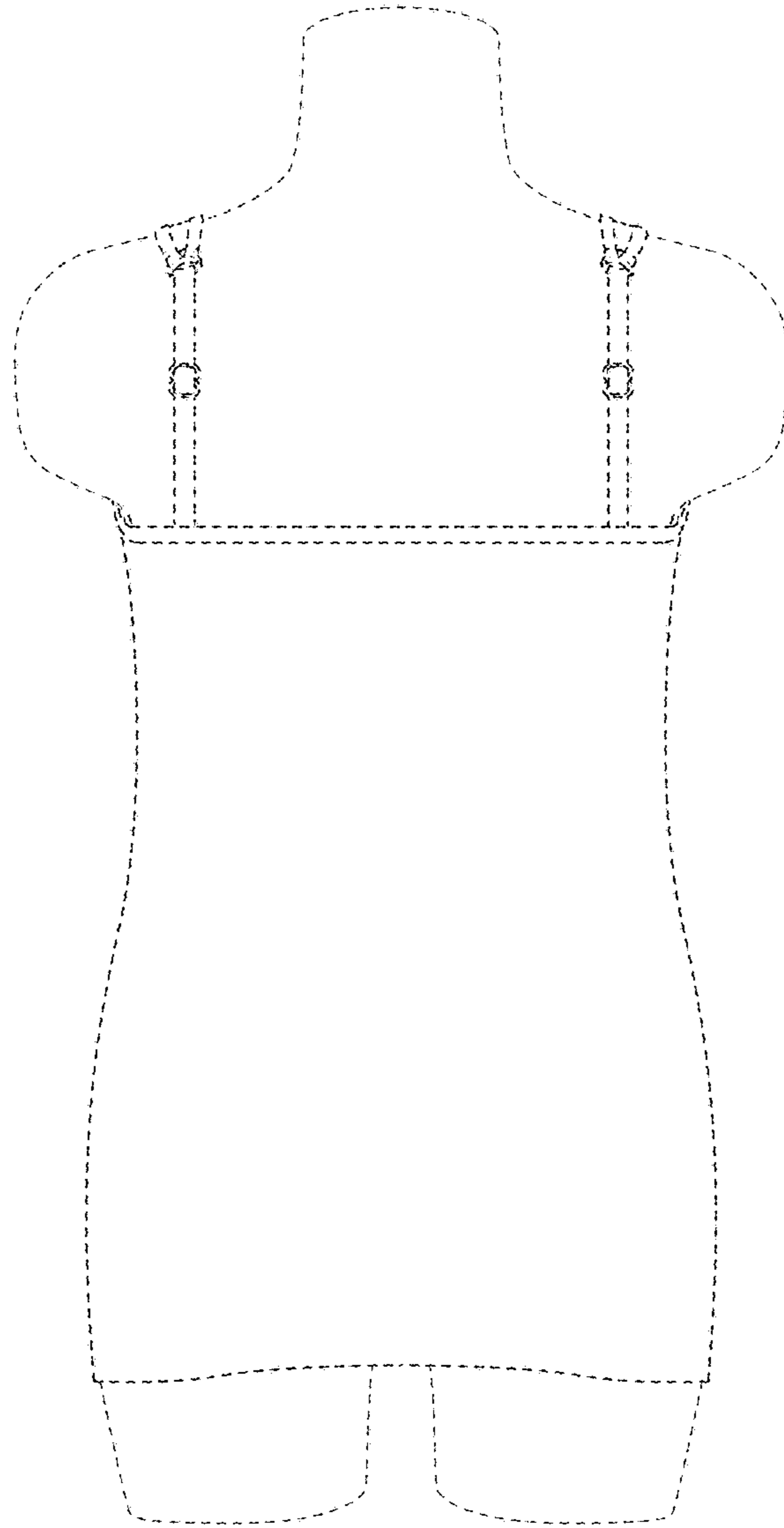

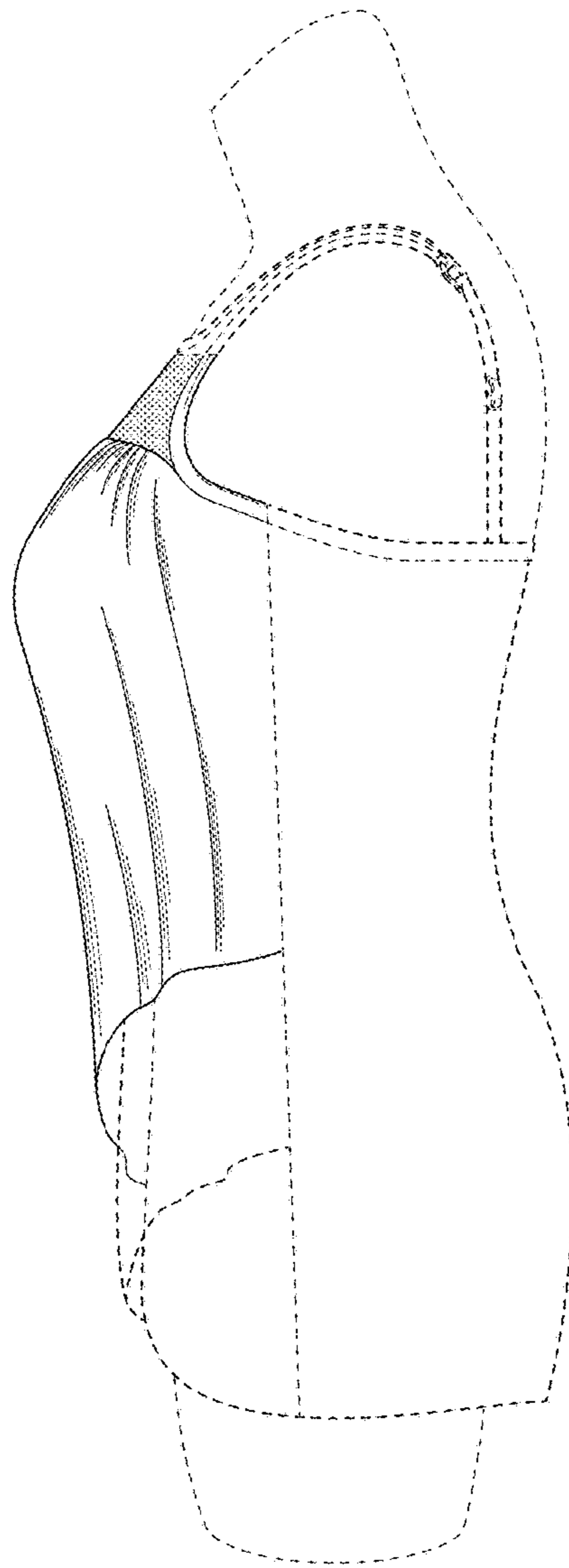

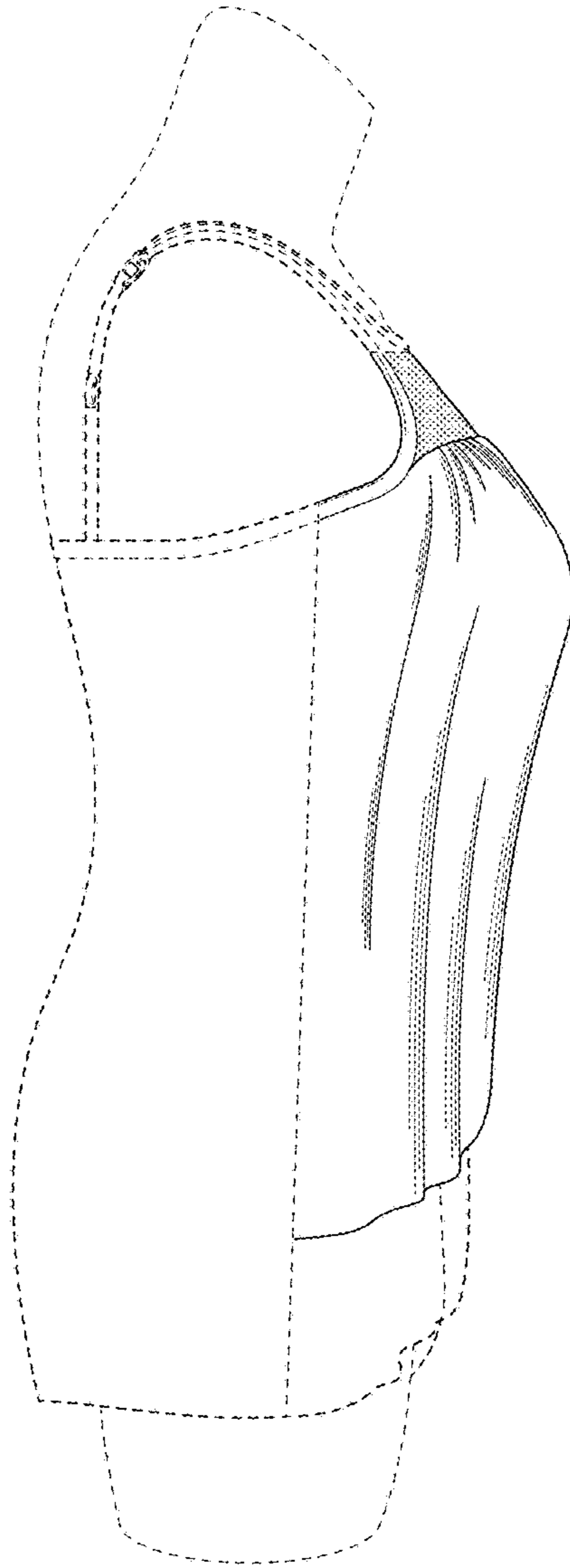
