The ornamental design for a sock, as shown and described.

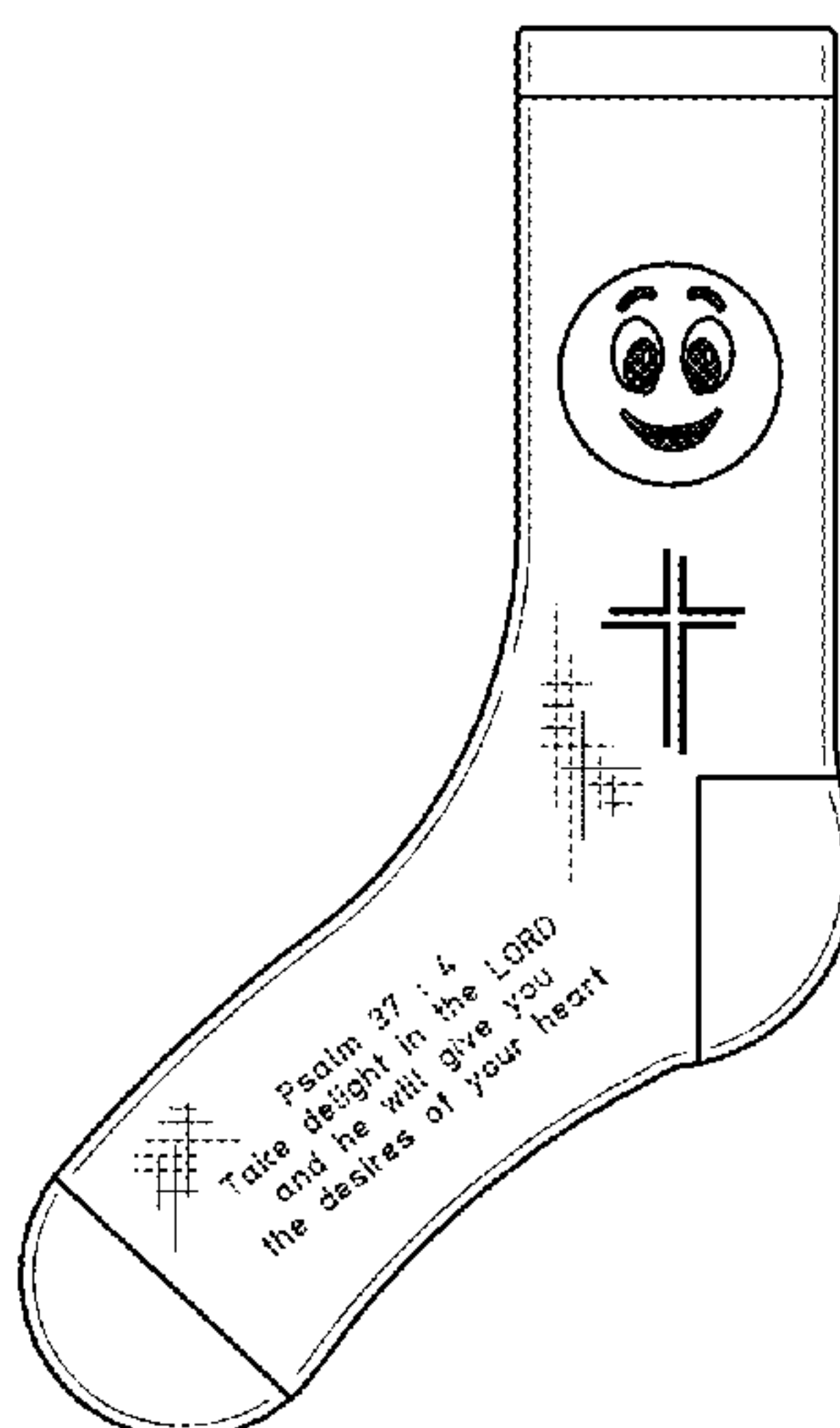
DESCRIPTION

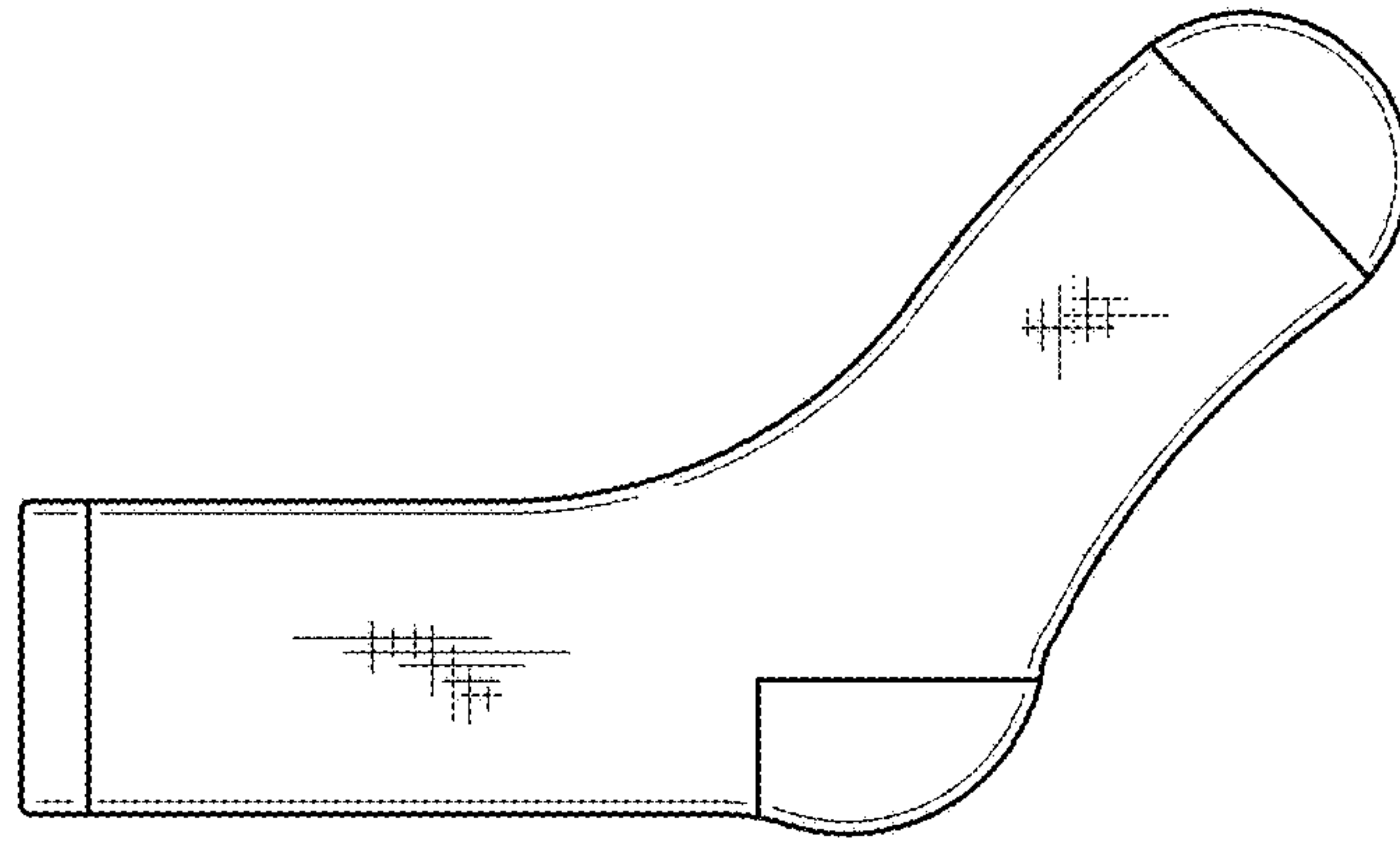

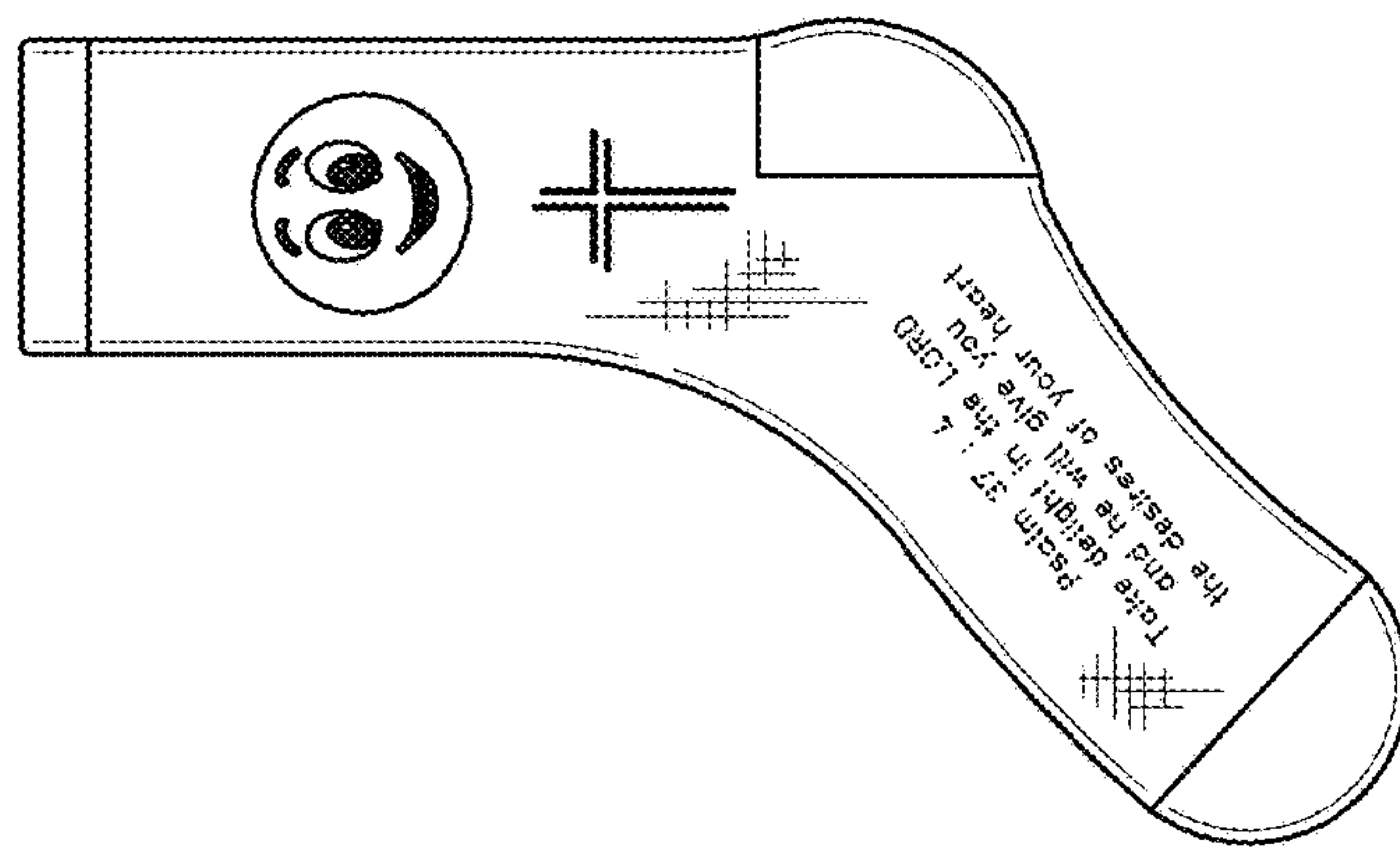

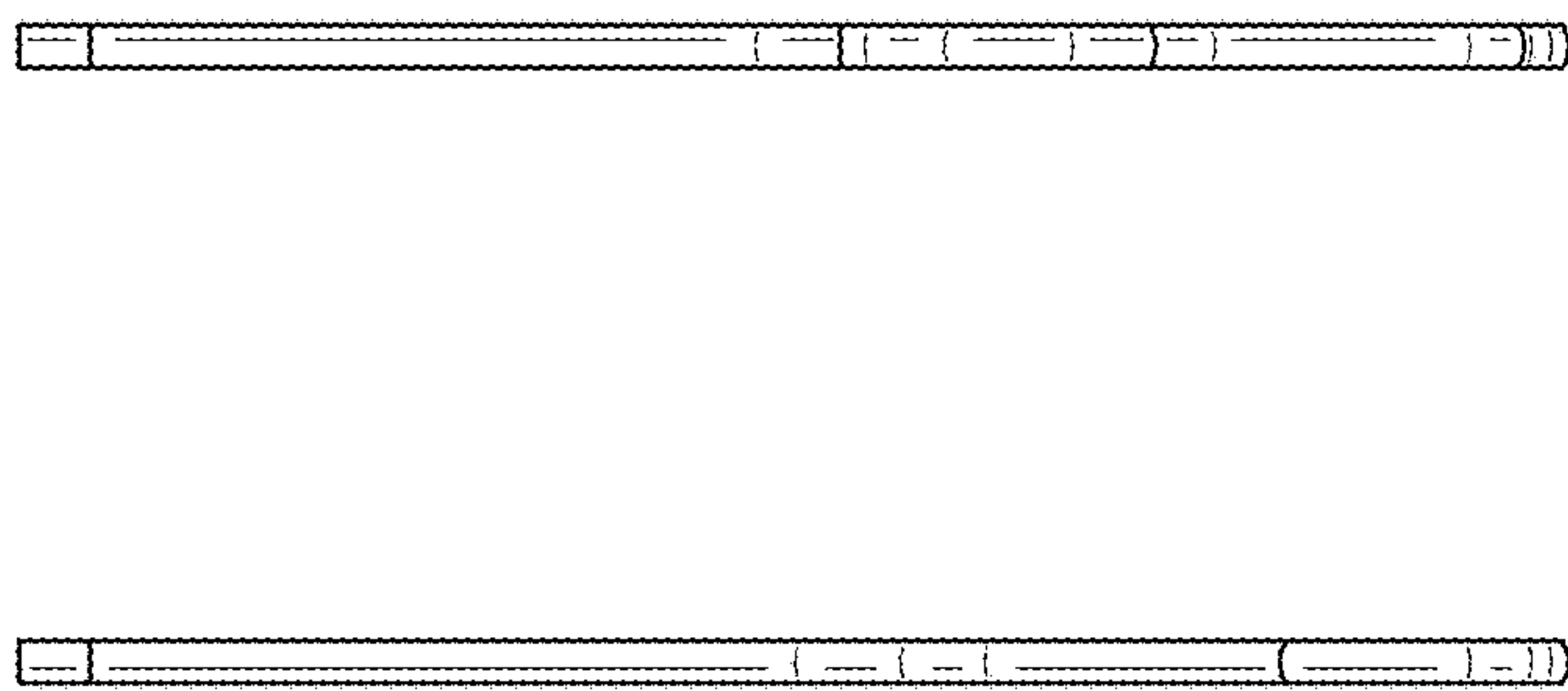

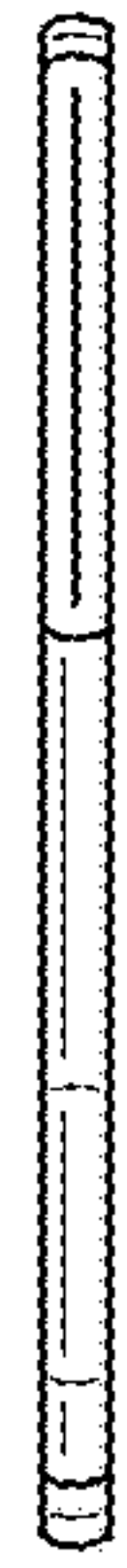

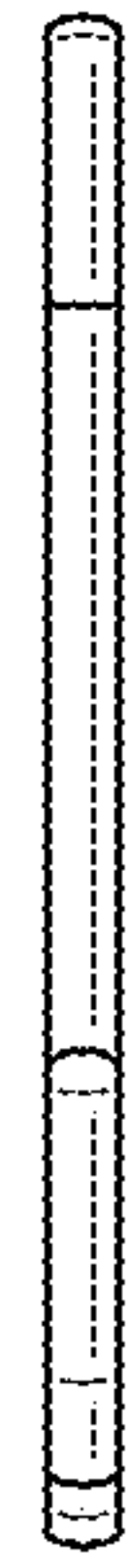
