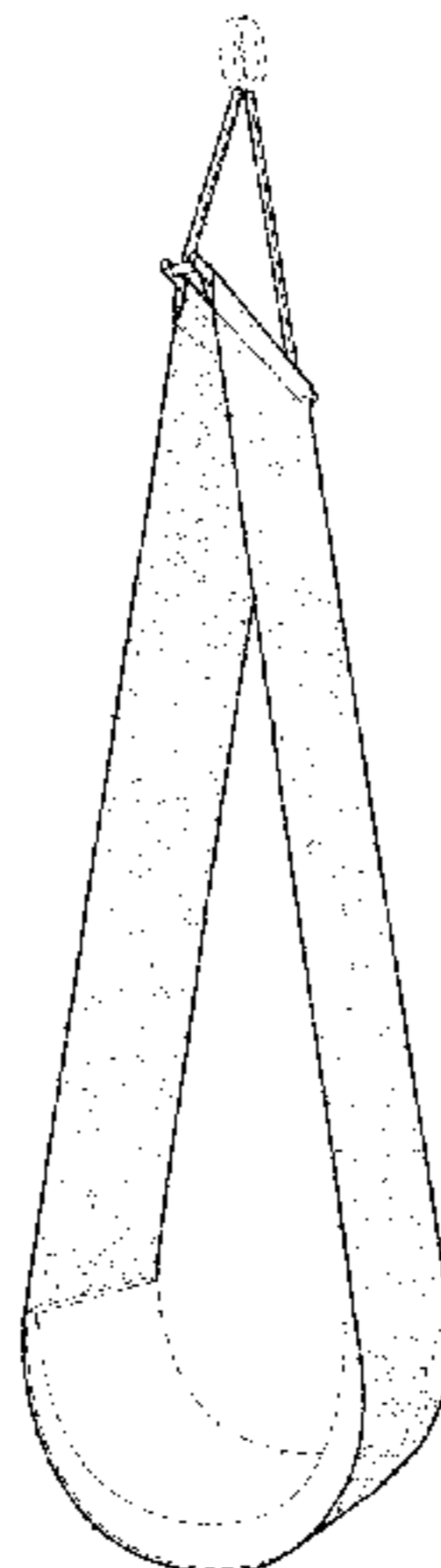
(57) **CLAIM**

We claim the ornamental design for a hanging chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our hanging chair; FIG. 2 is a front view, the rear view (not shown) is a mirror image thereof; FIG. 3 is a left side view, the right side (not shown) is a mirror image thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a close-up view of the area designated “6” in FIG. 2 of our hanging chair. The broken lines are for environmental purposes only and form no part of the claimed design.

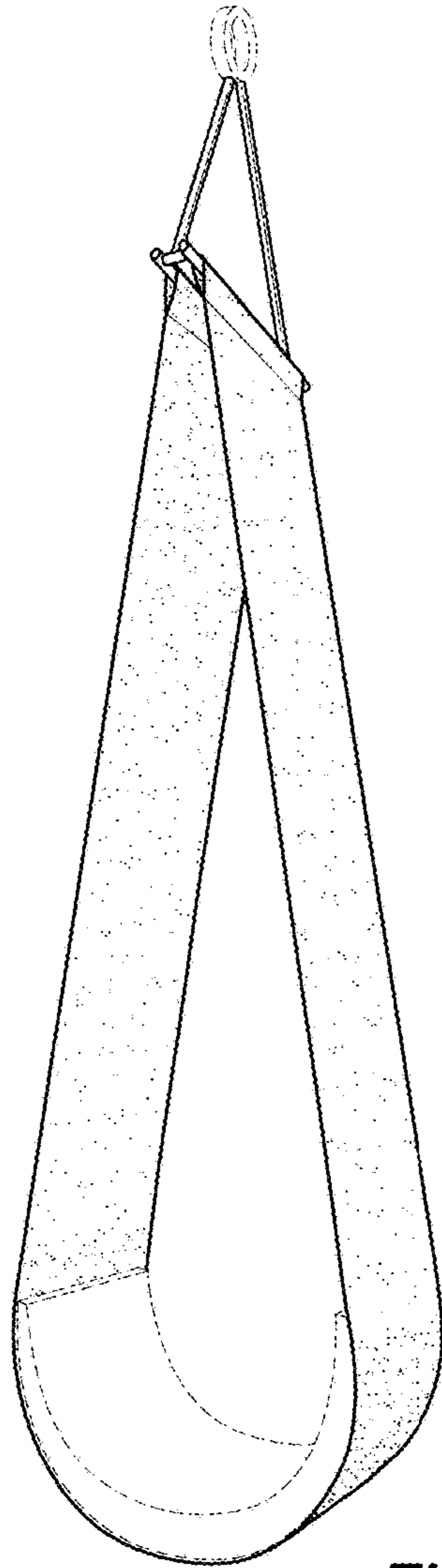

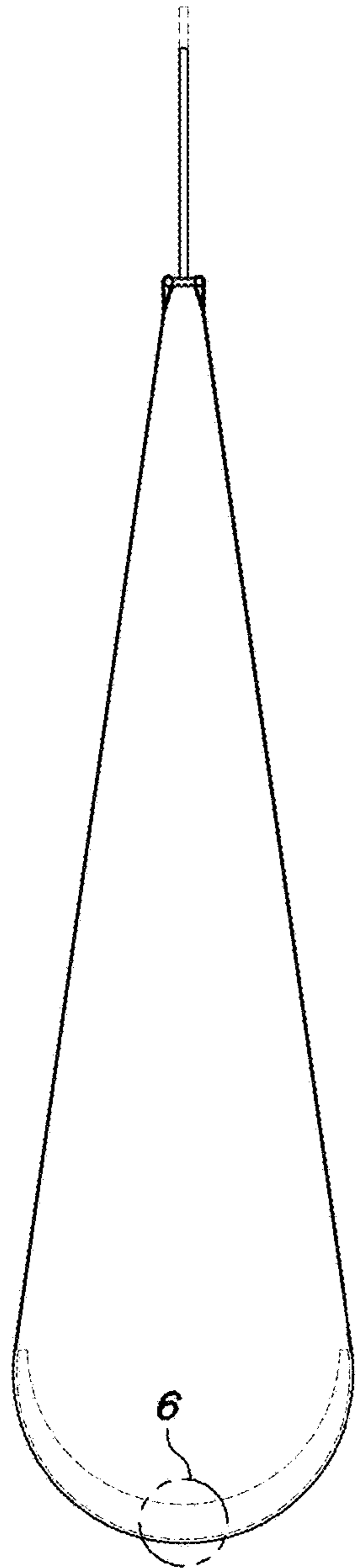

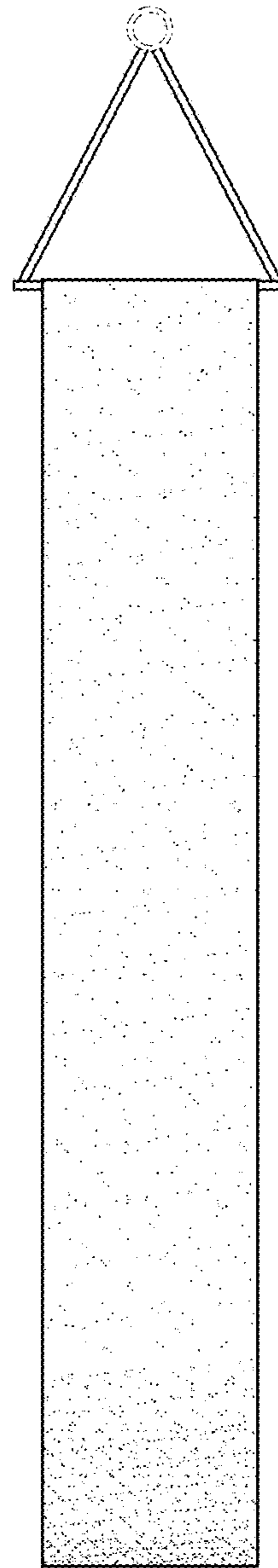

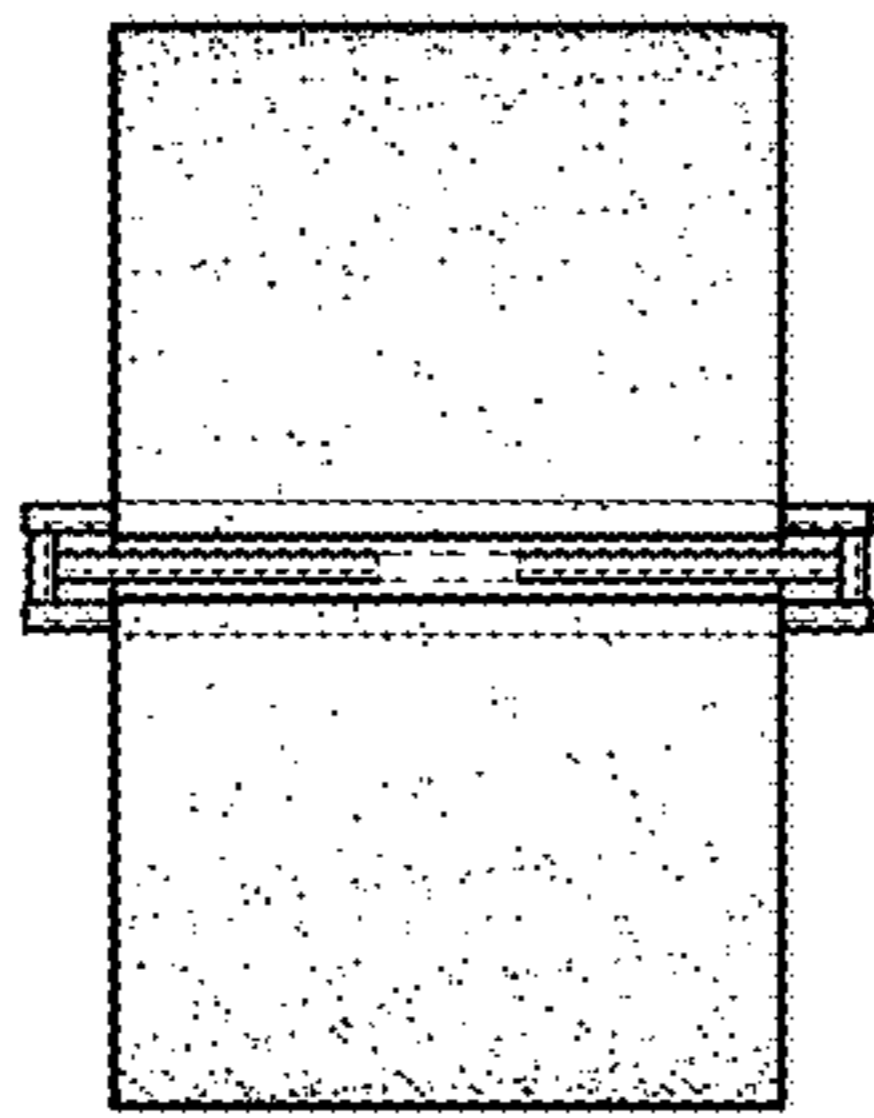

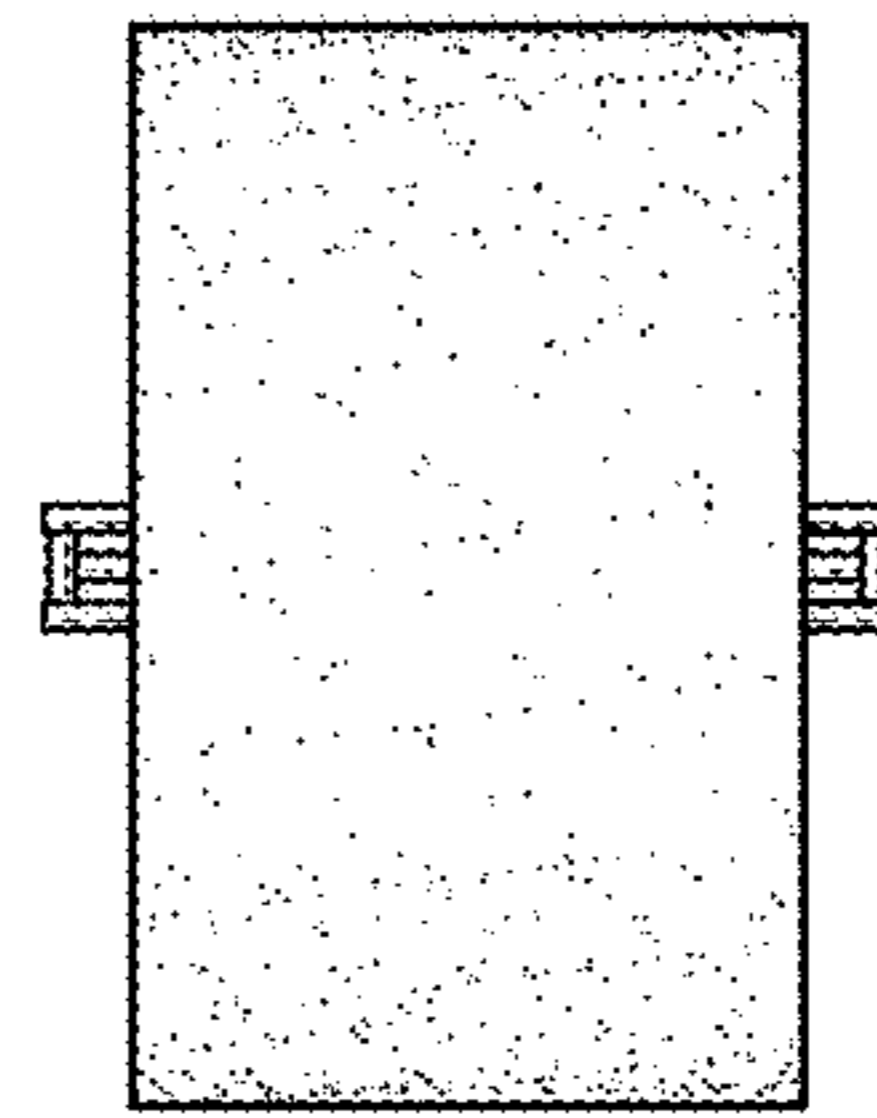

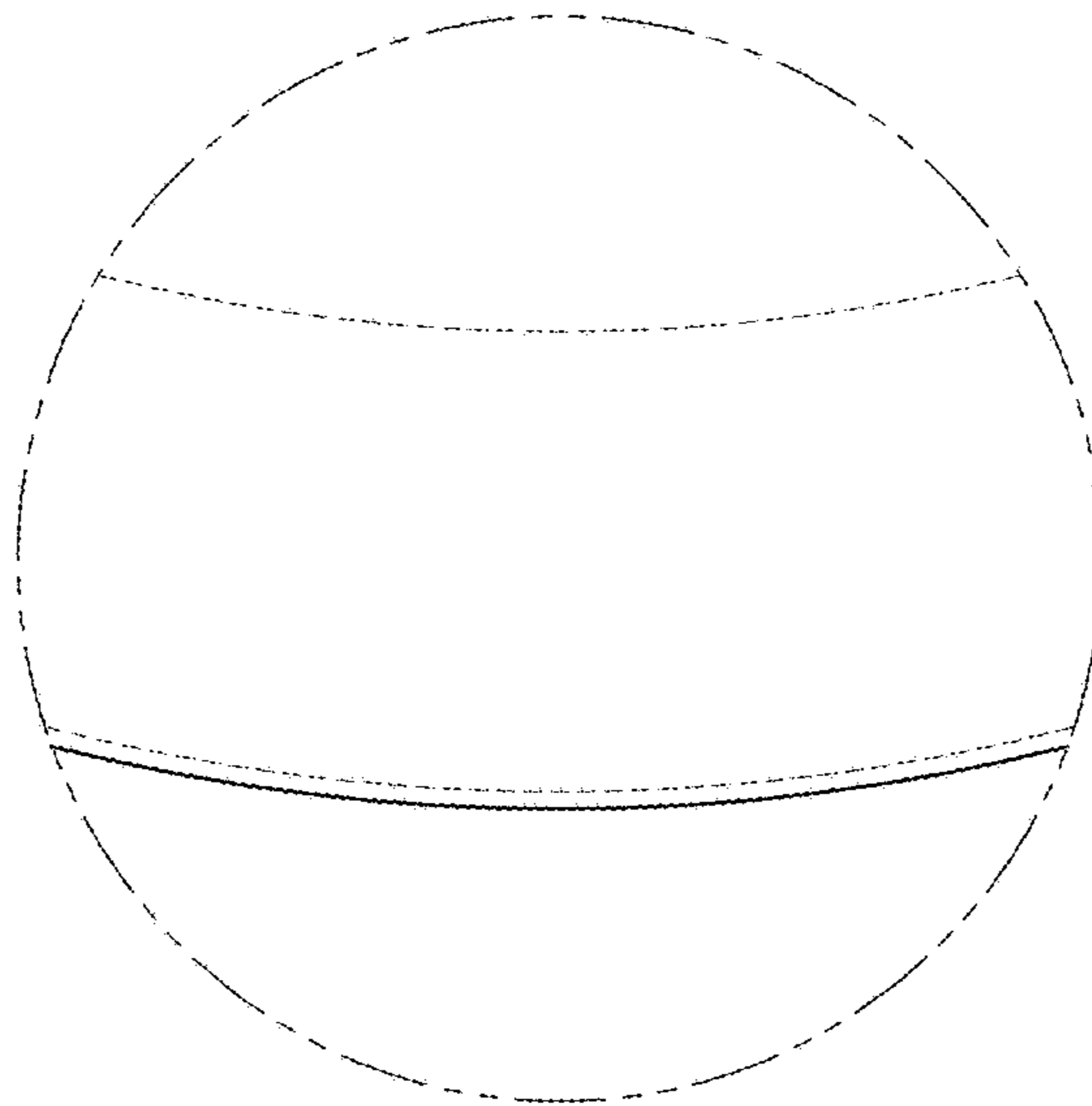
