We claim the ornamental design for a oven appliance, as shown and described.

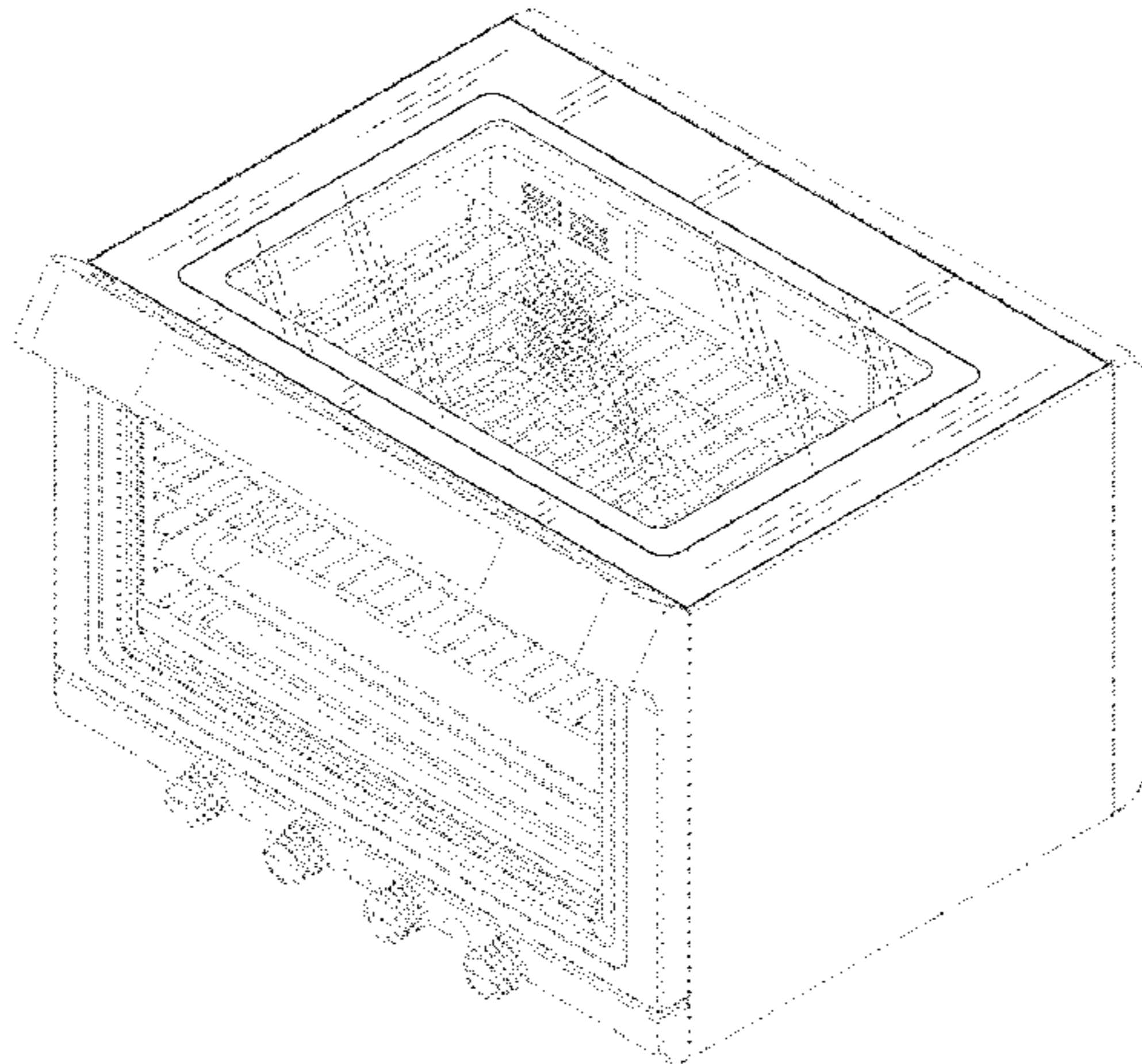
DESCRIPTION

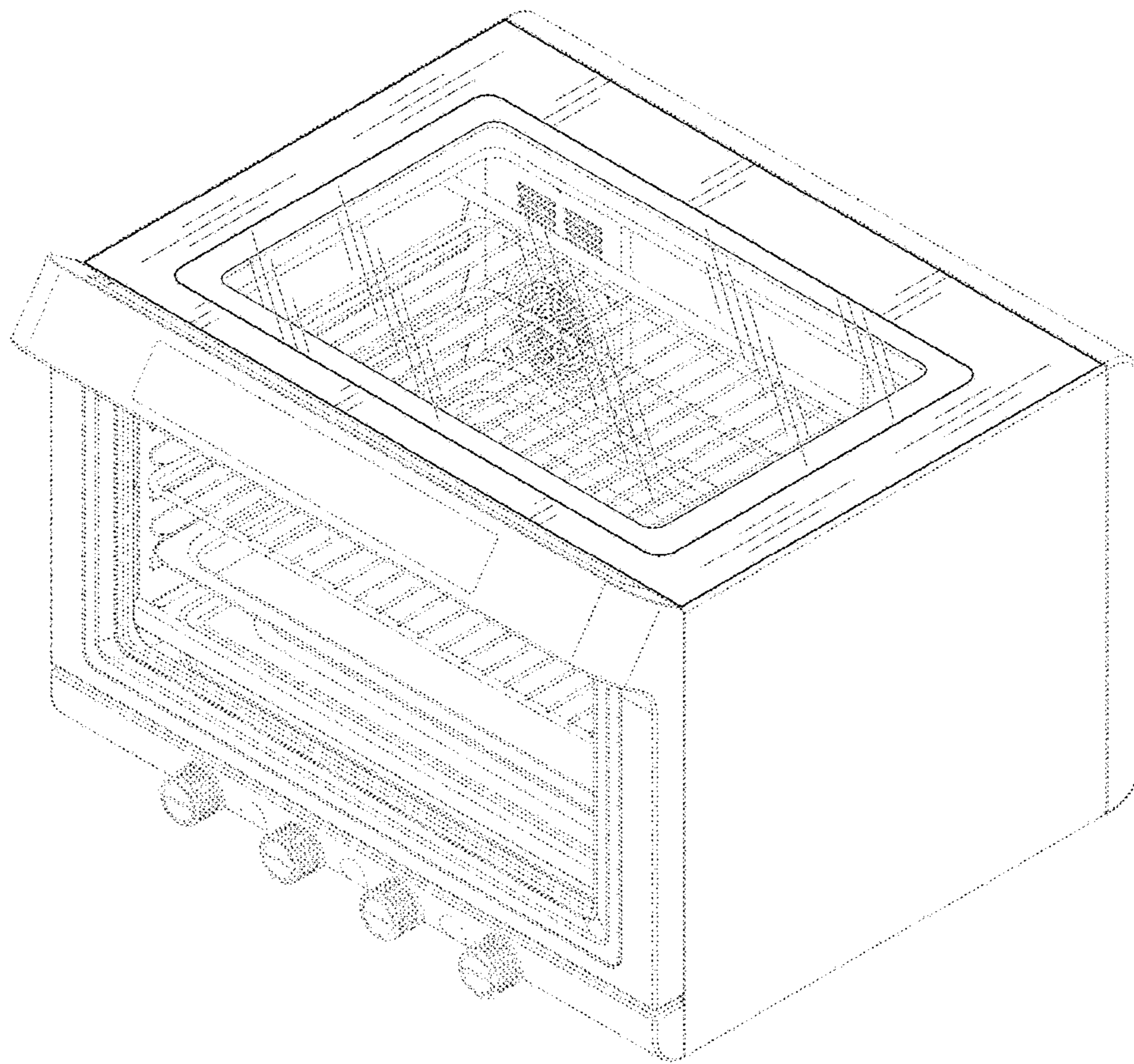

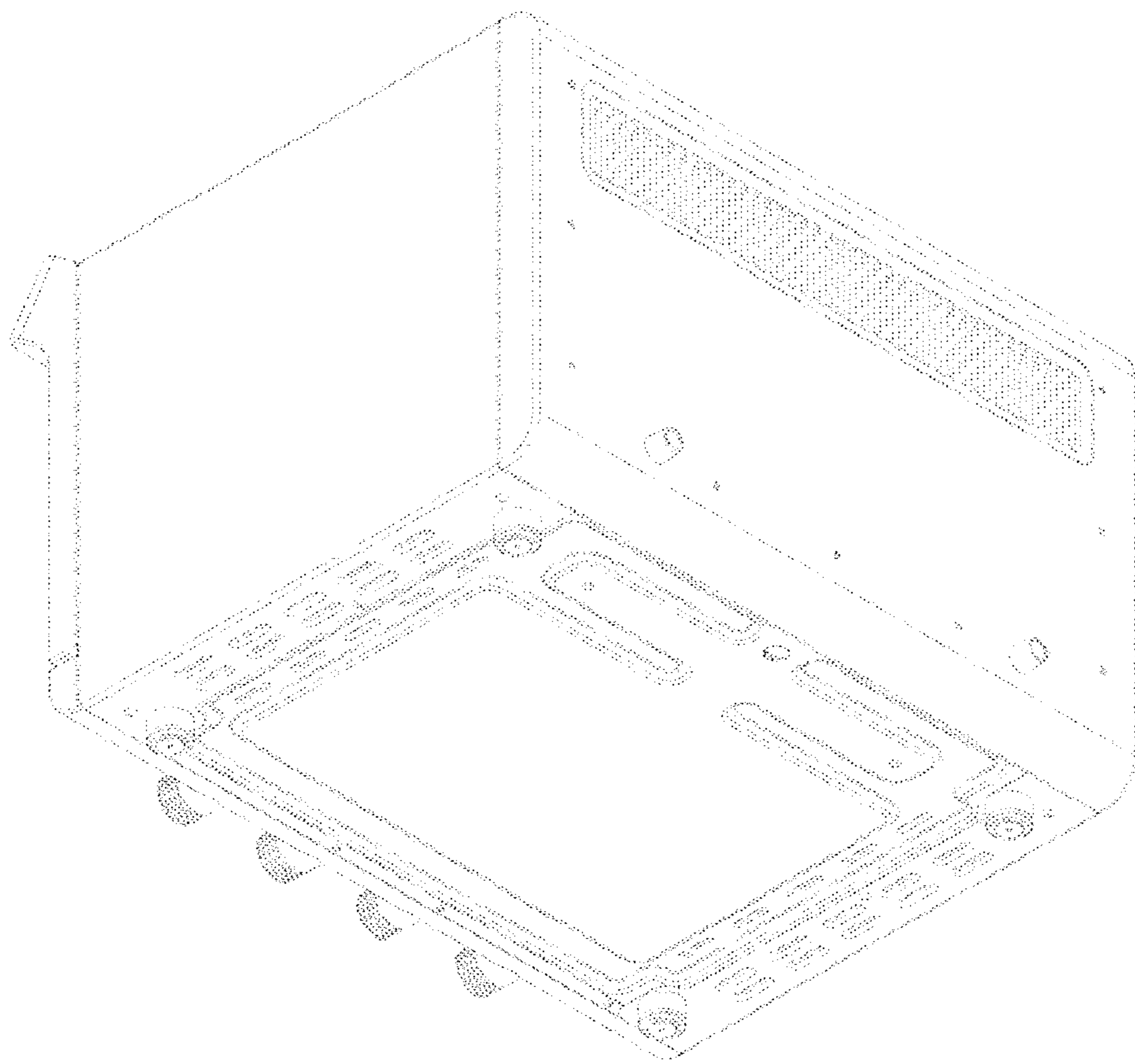

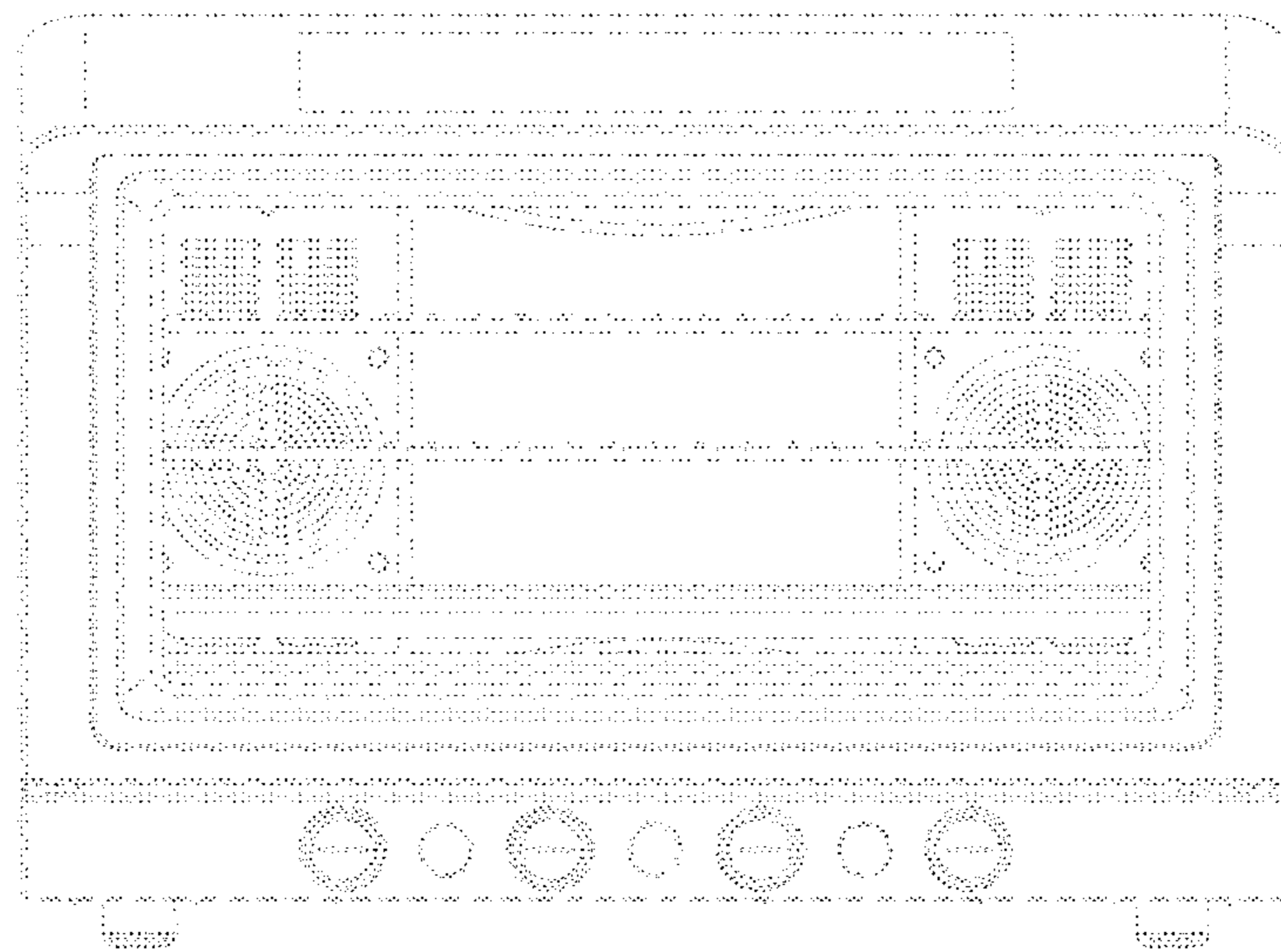

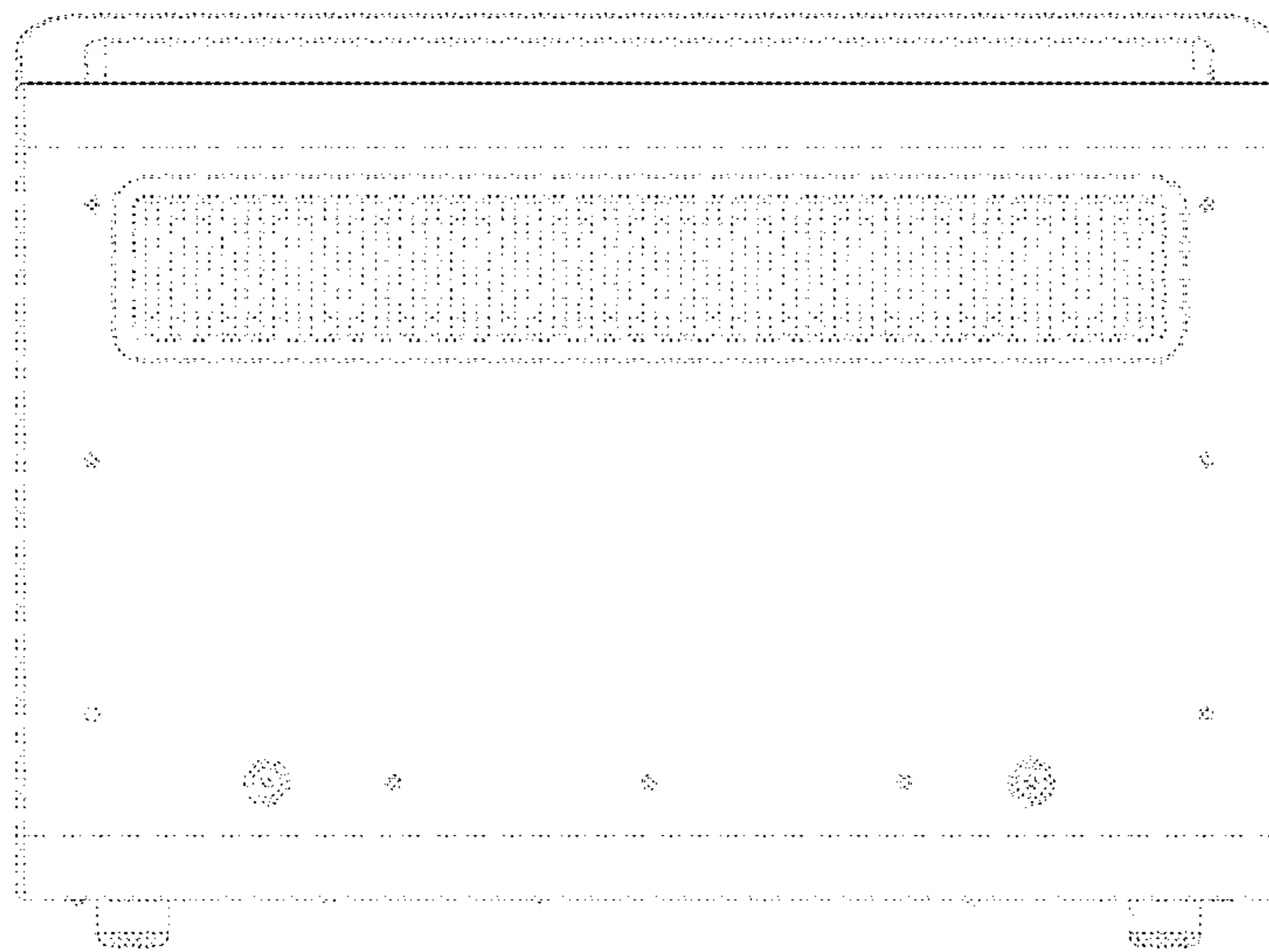

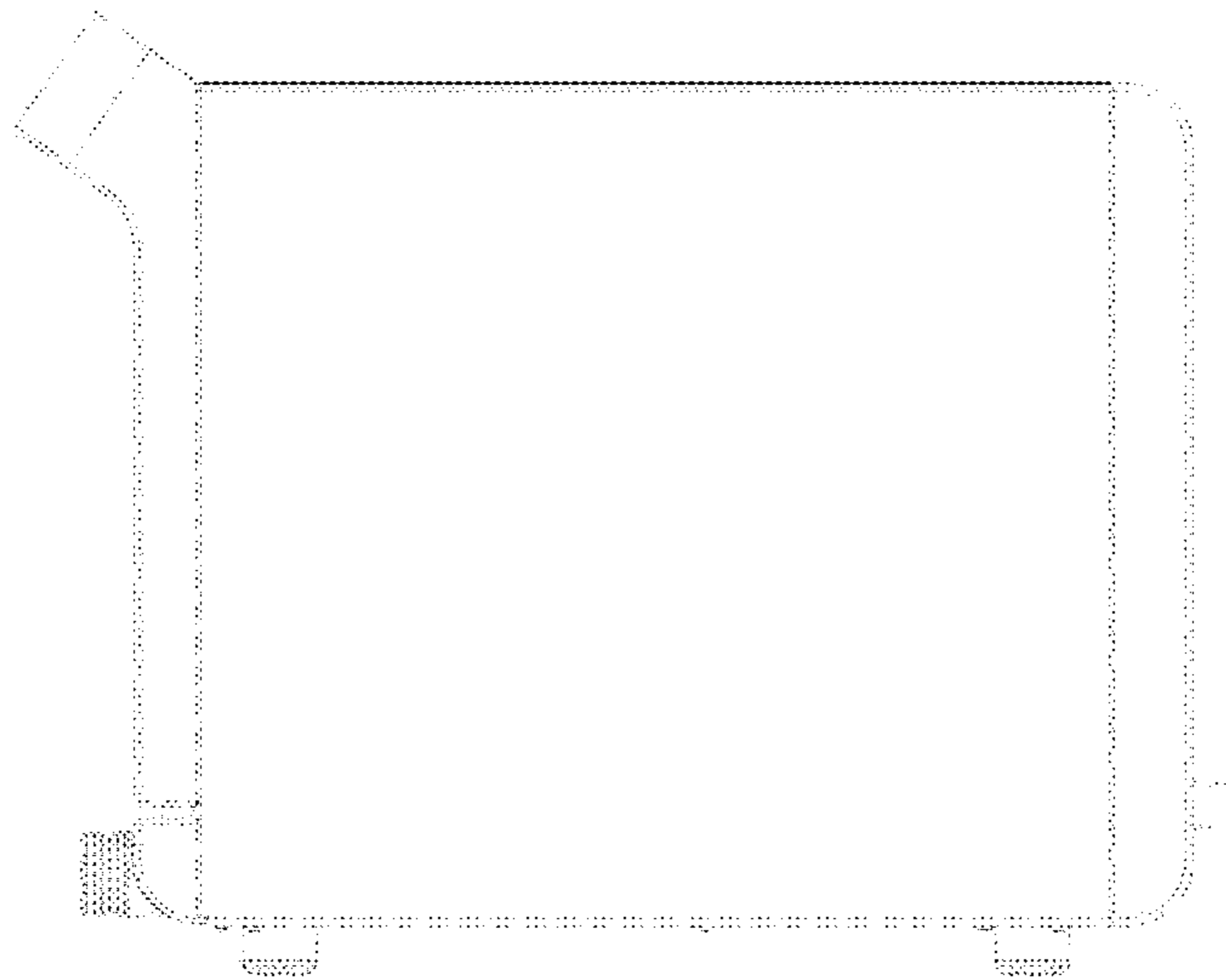

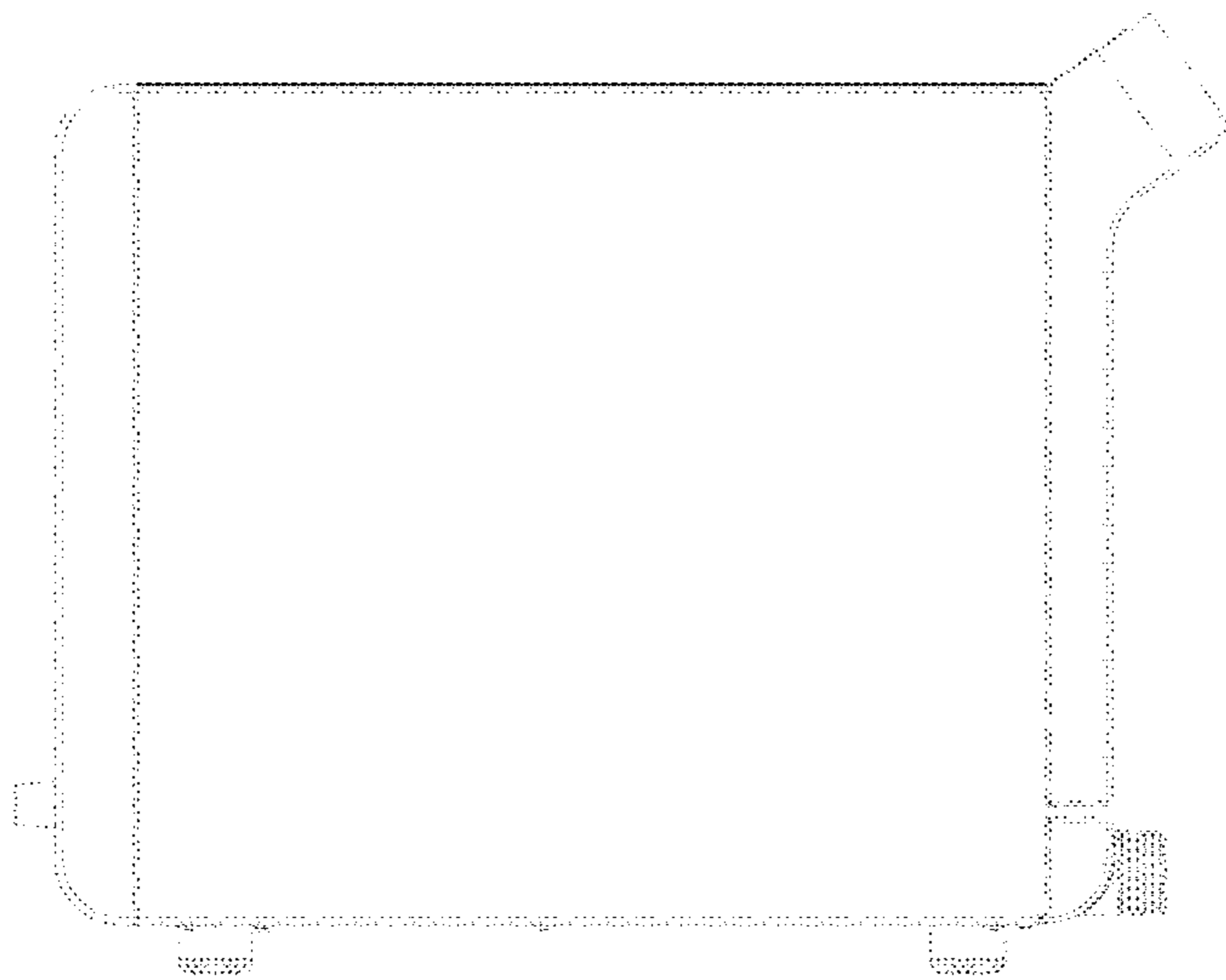

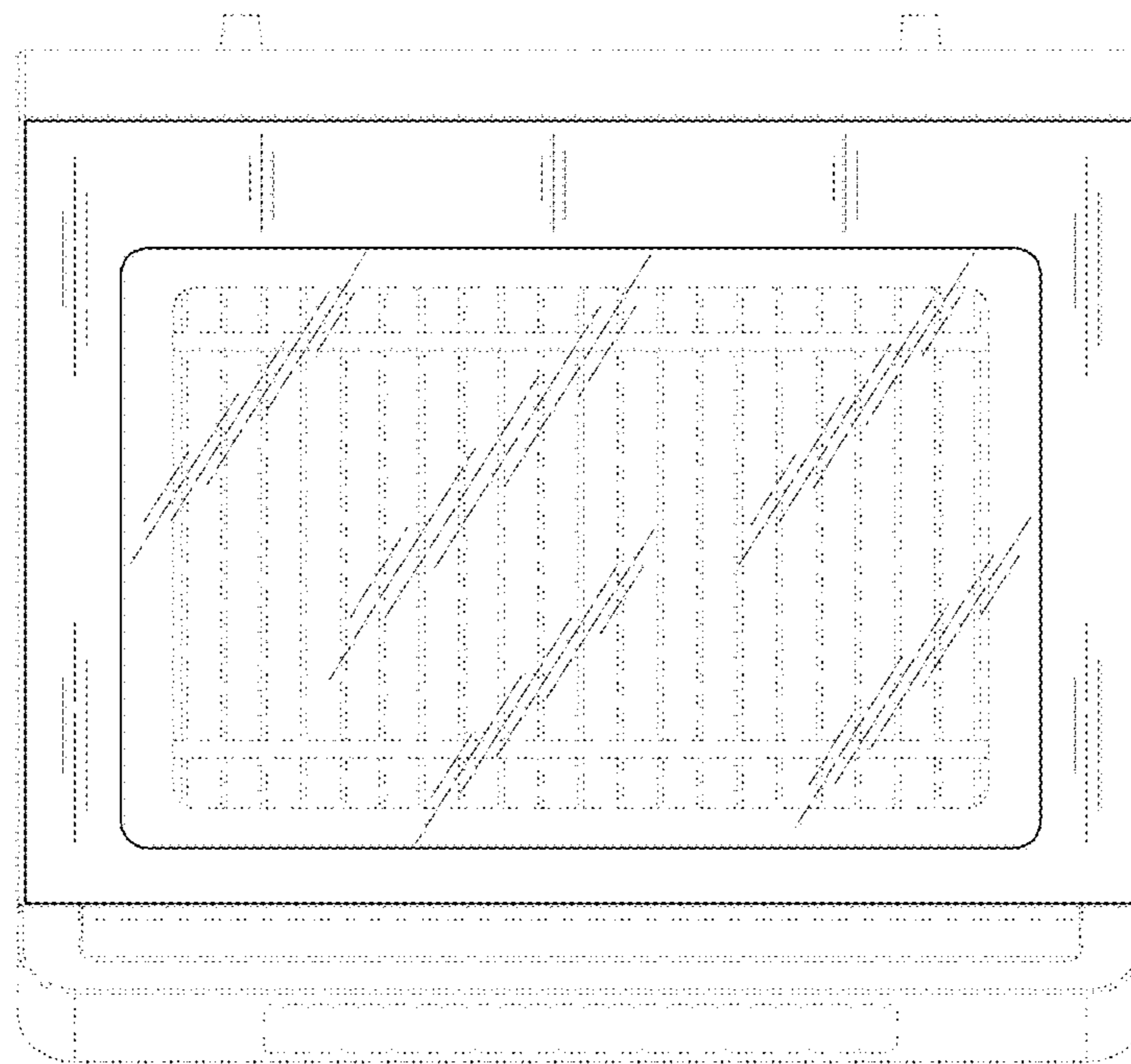

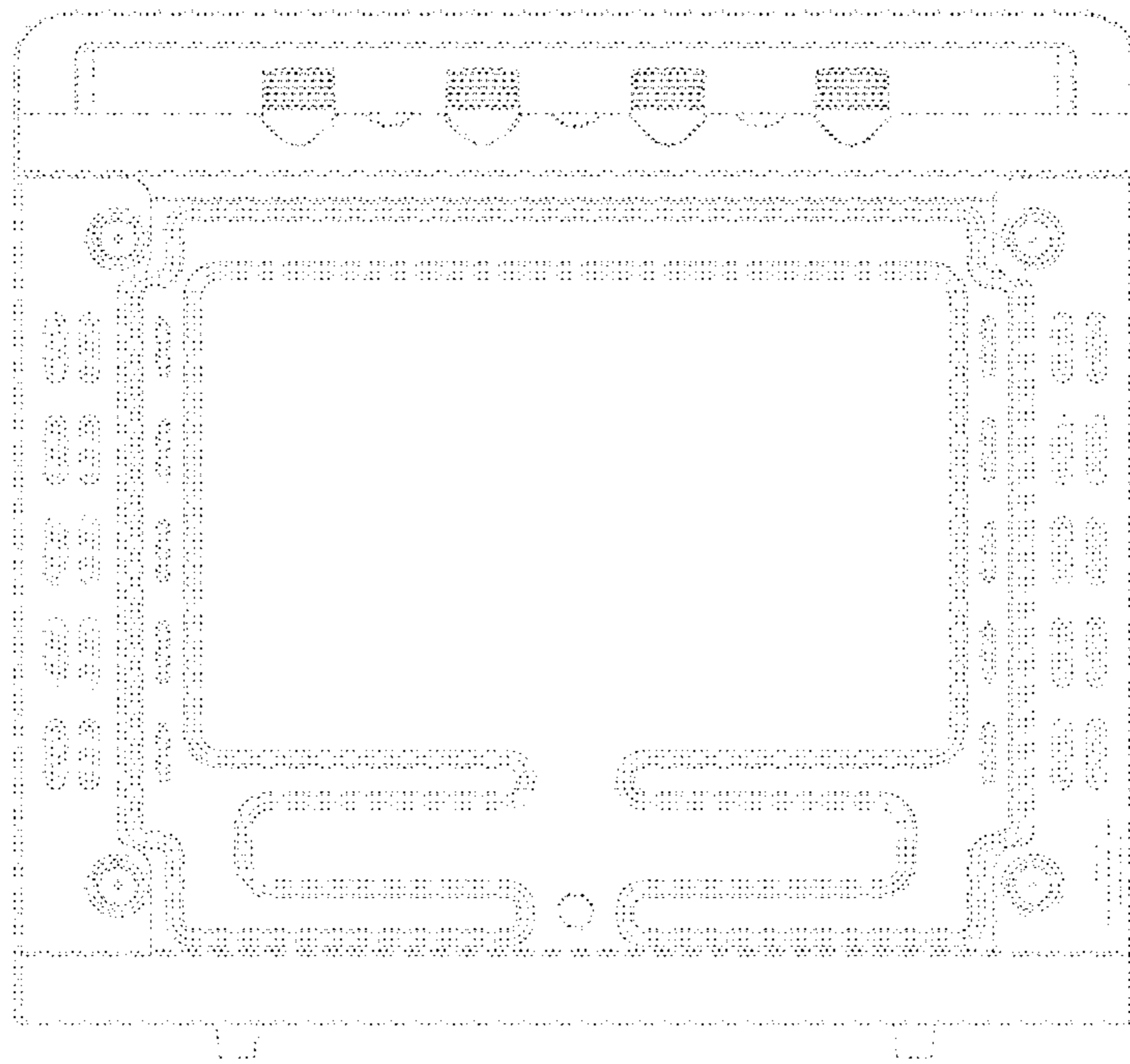
