DESCRIPTION

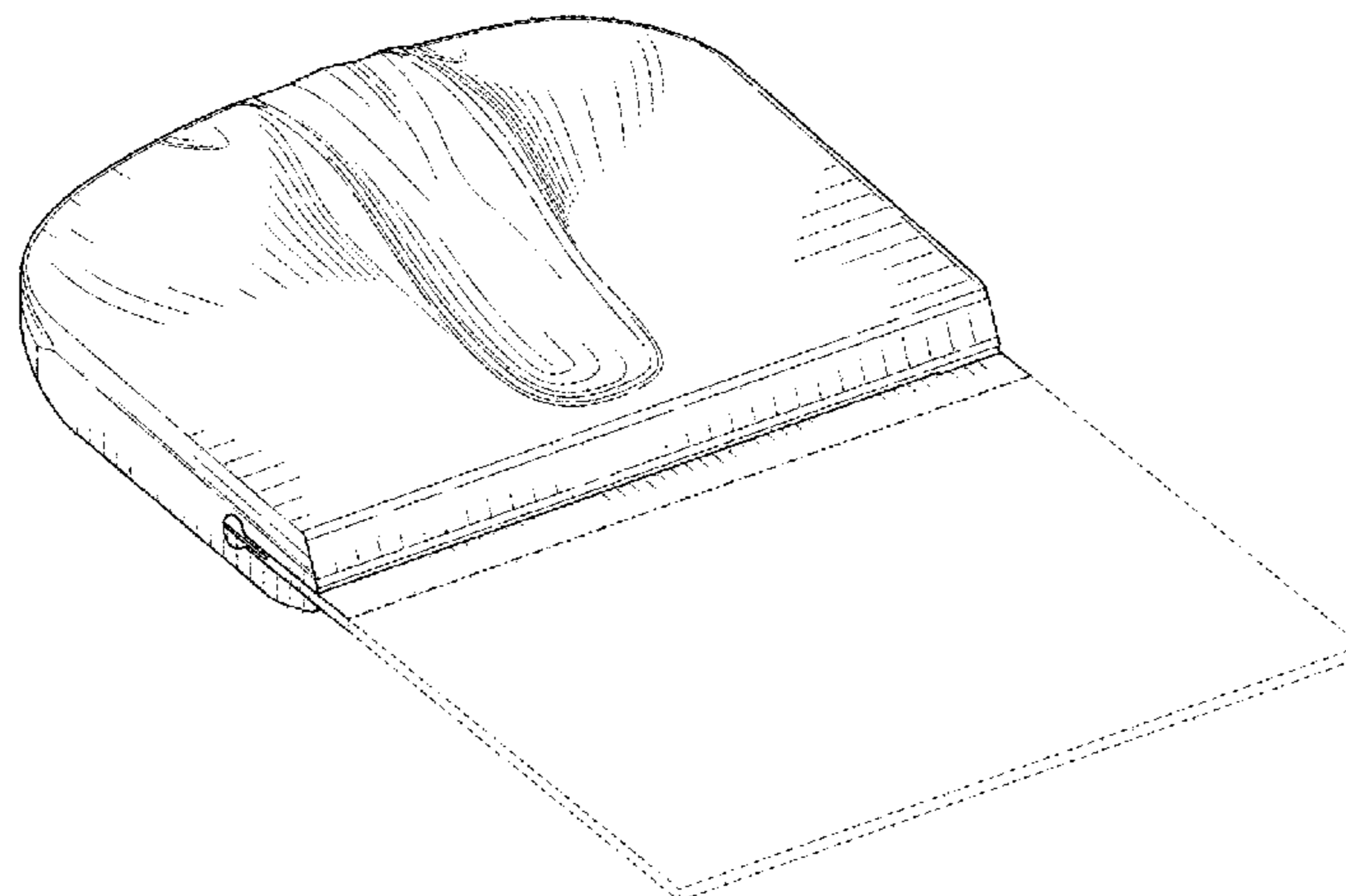

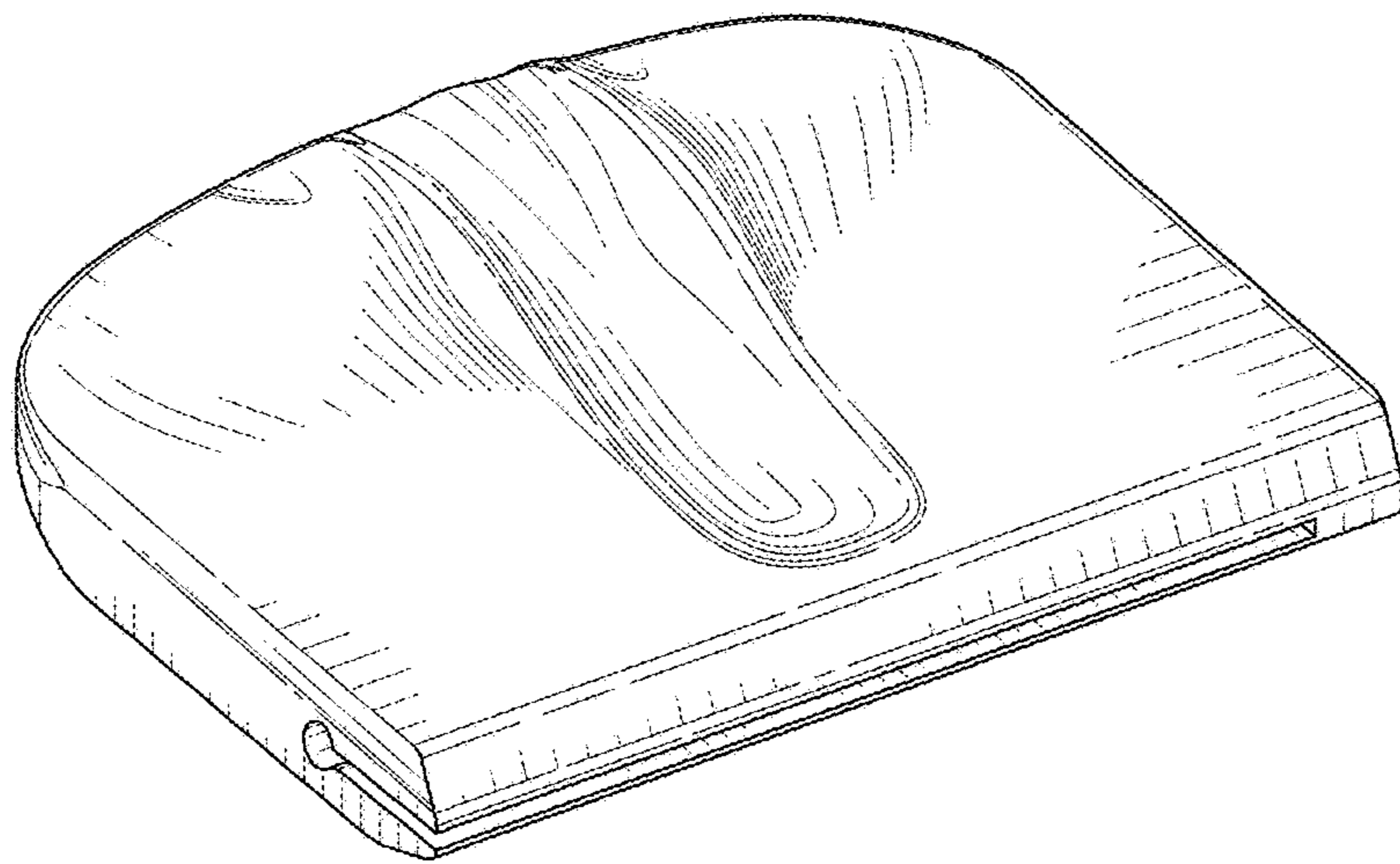

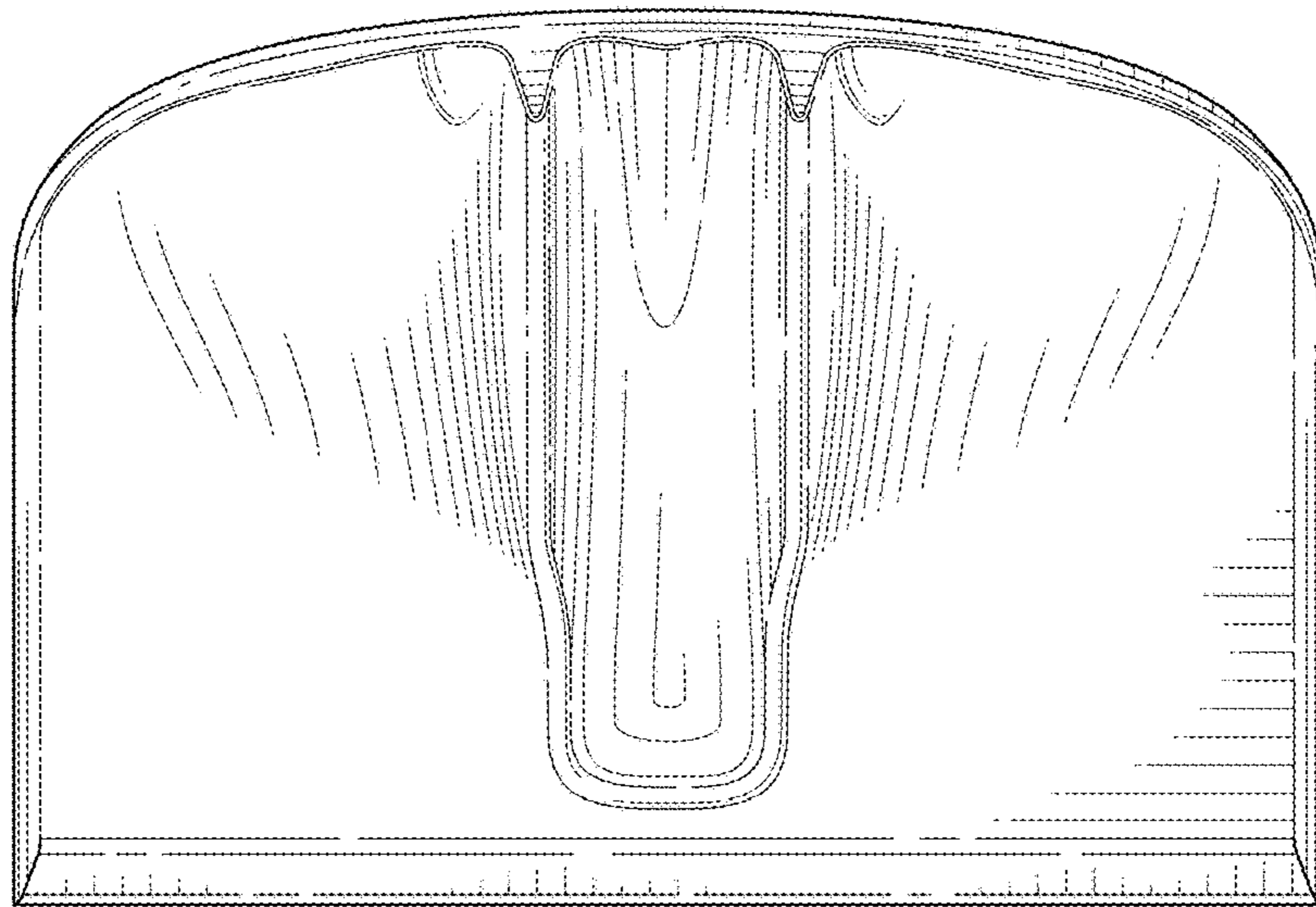

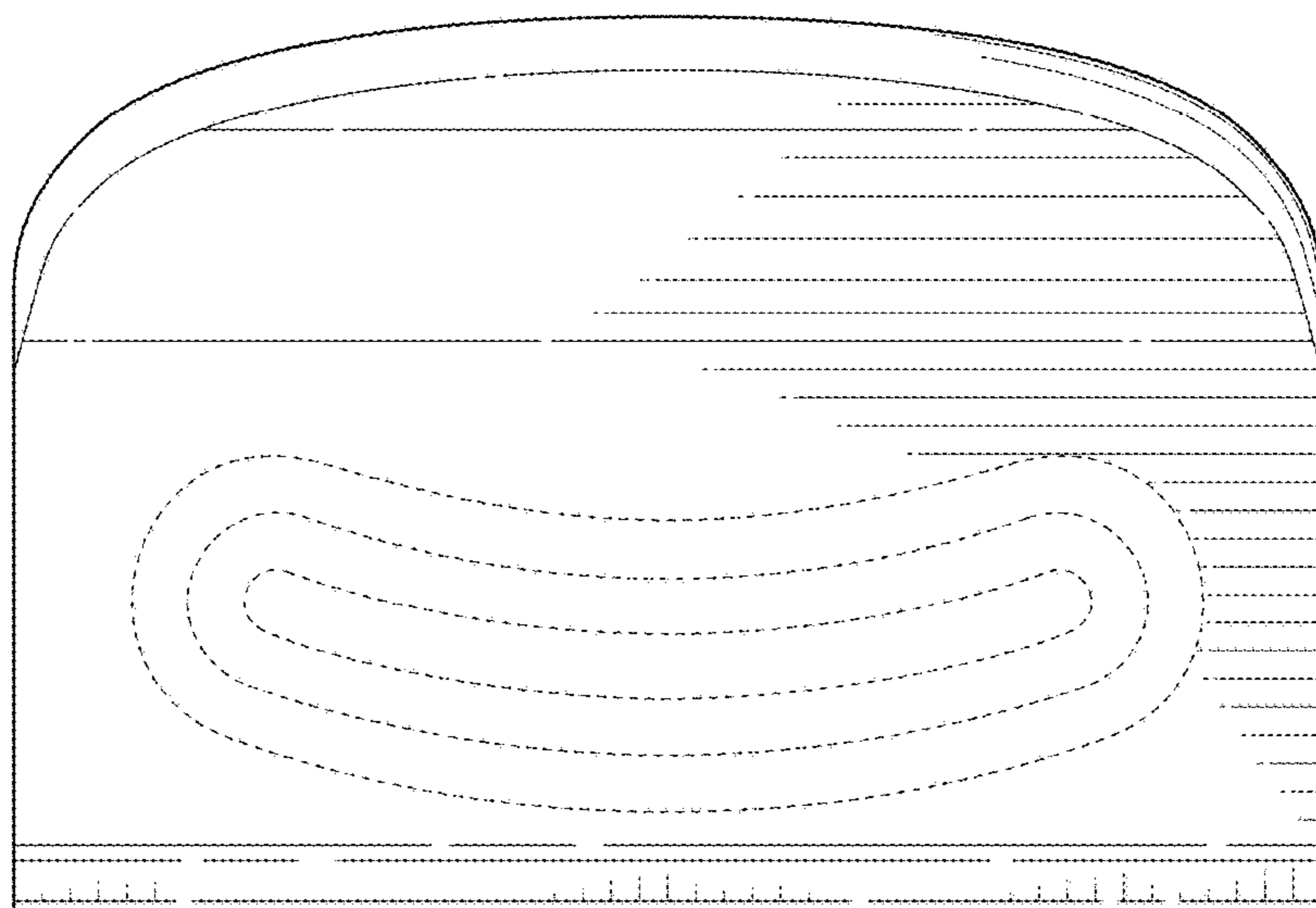

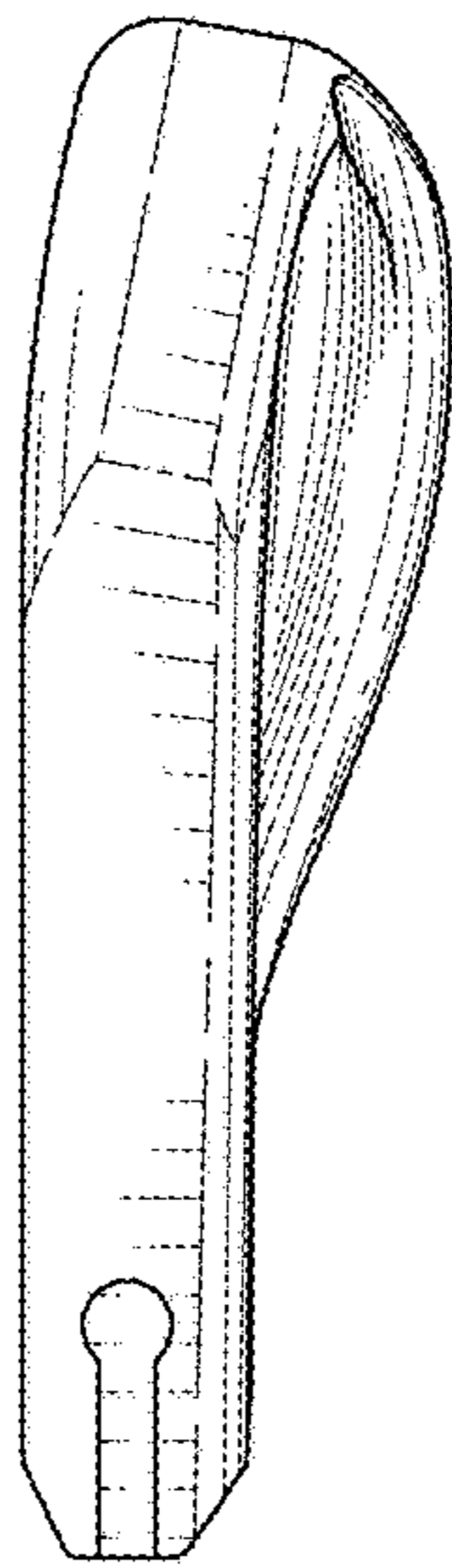

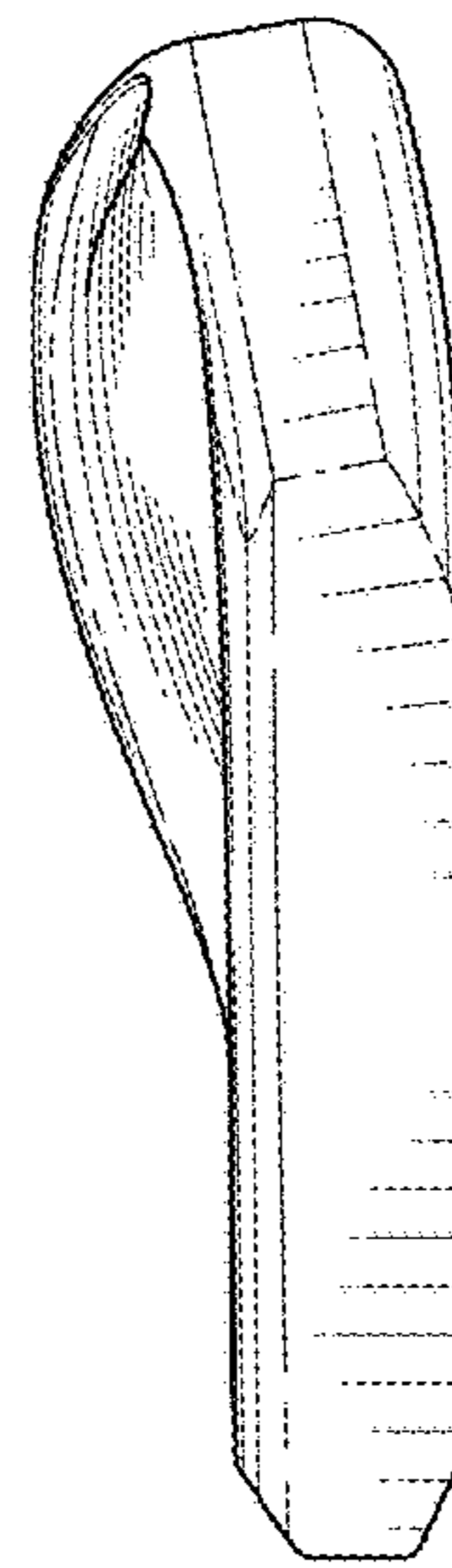

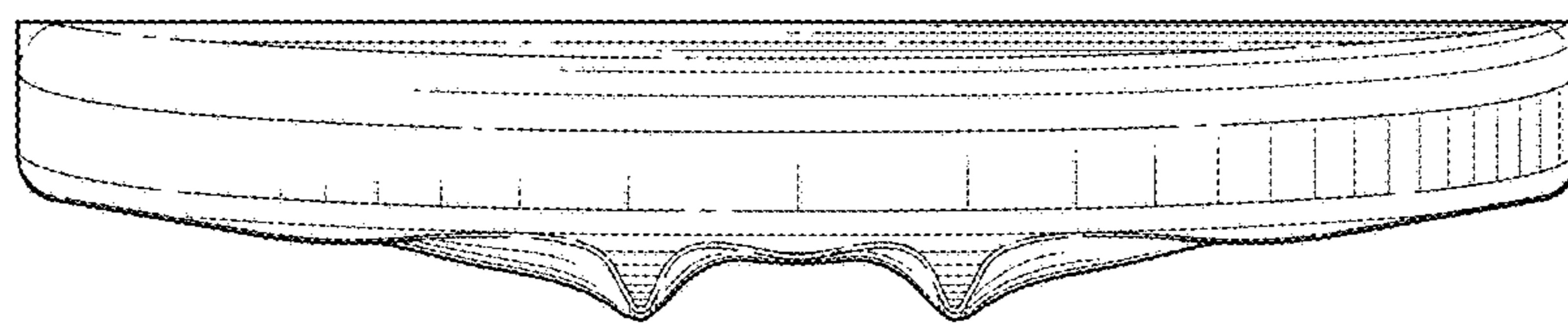

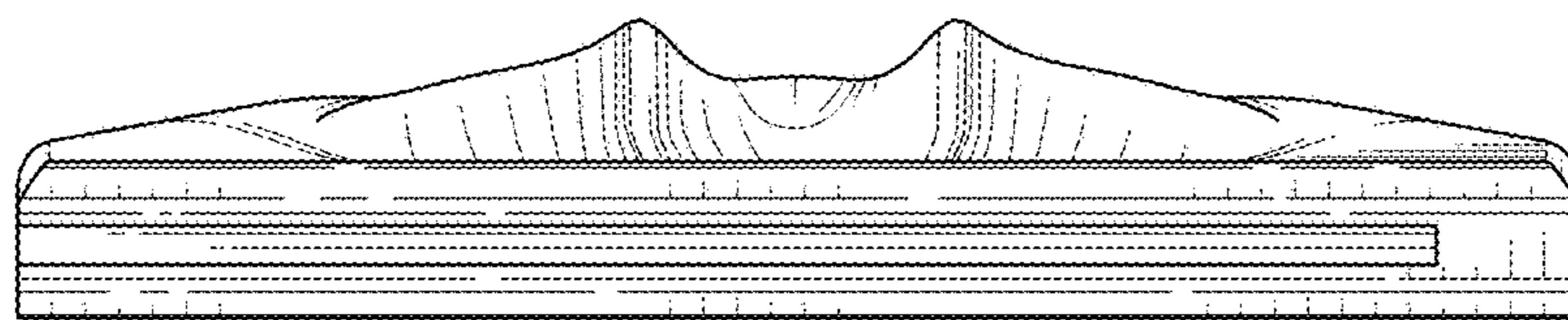

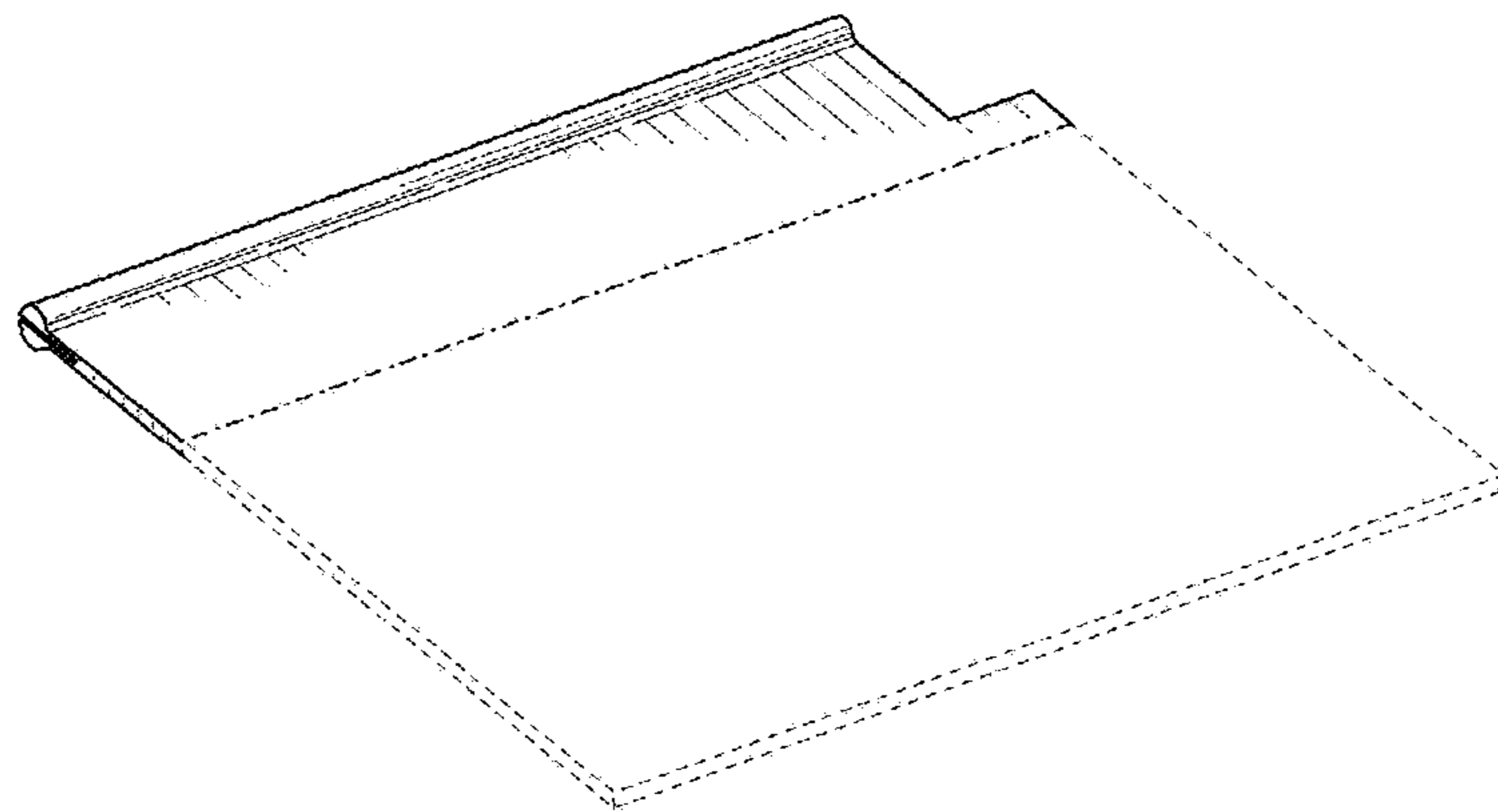

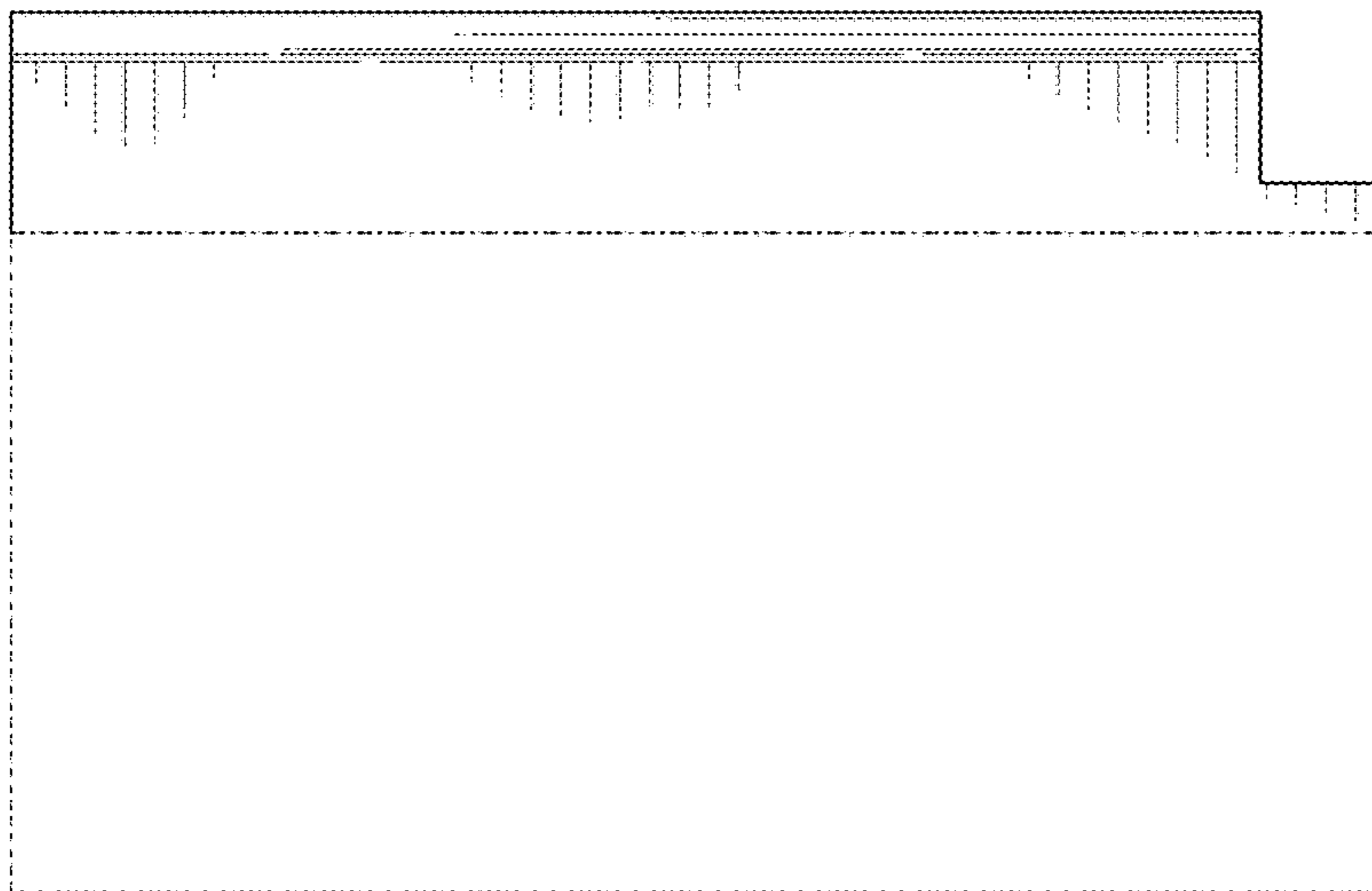

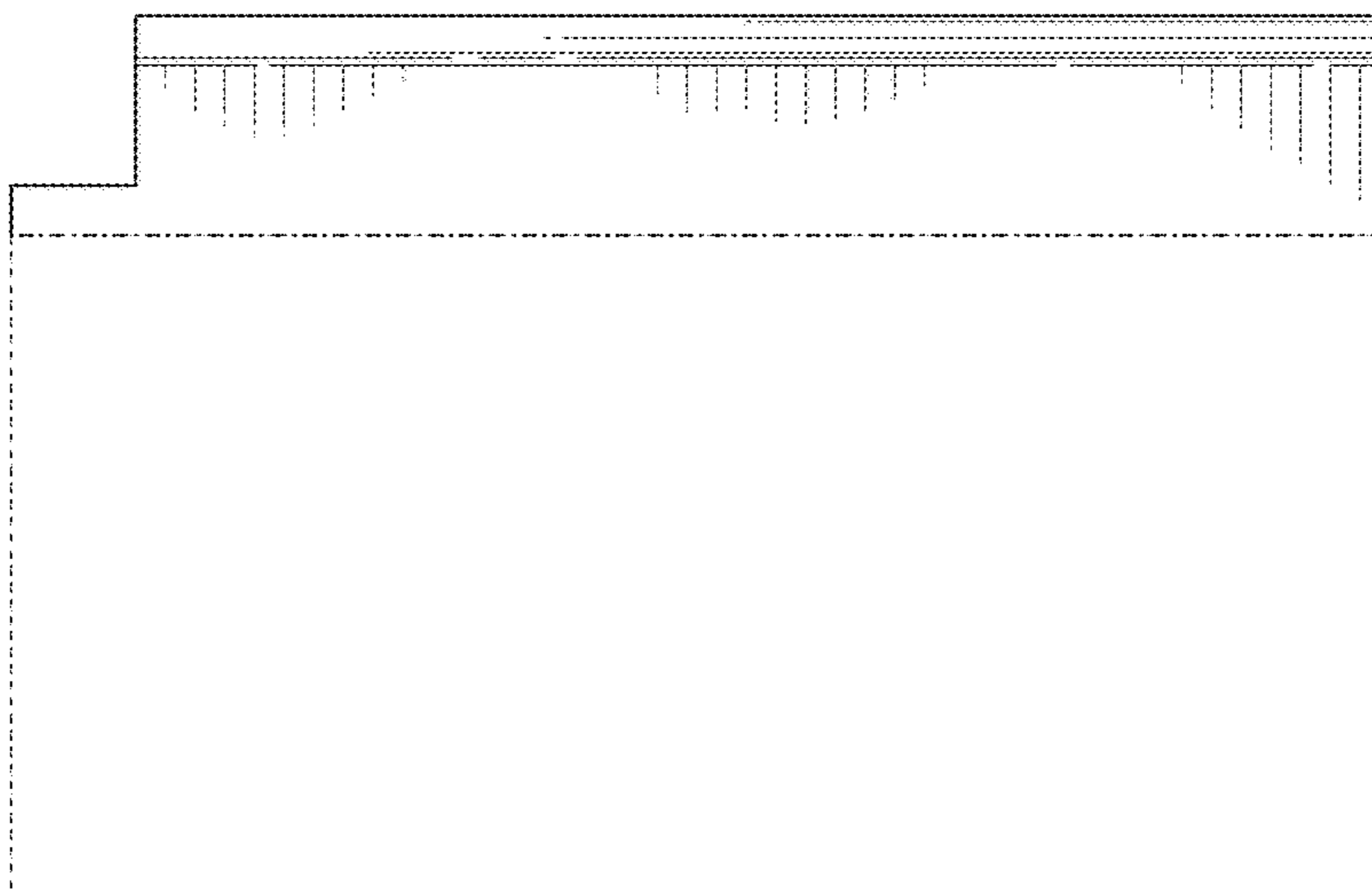

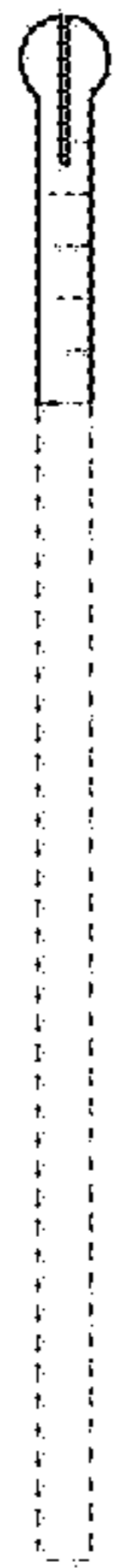

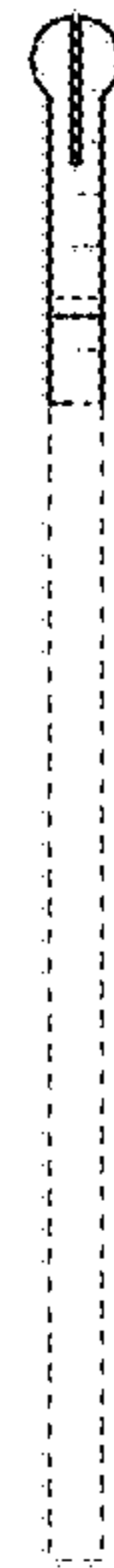

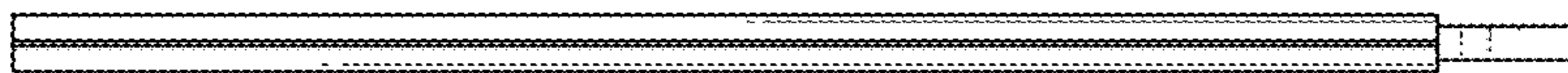

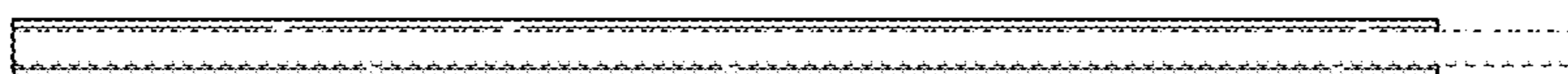

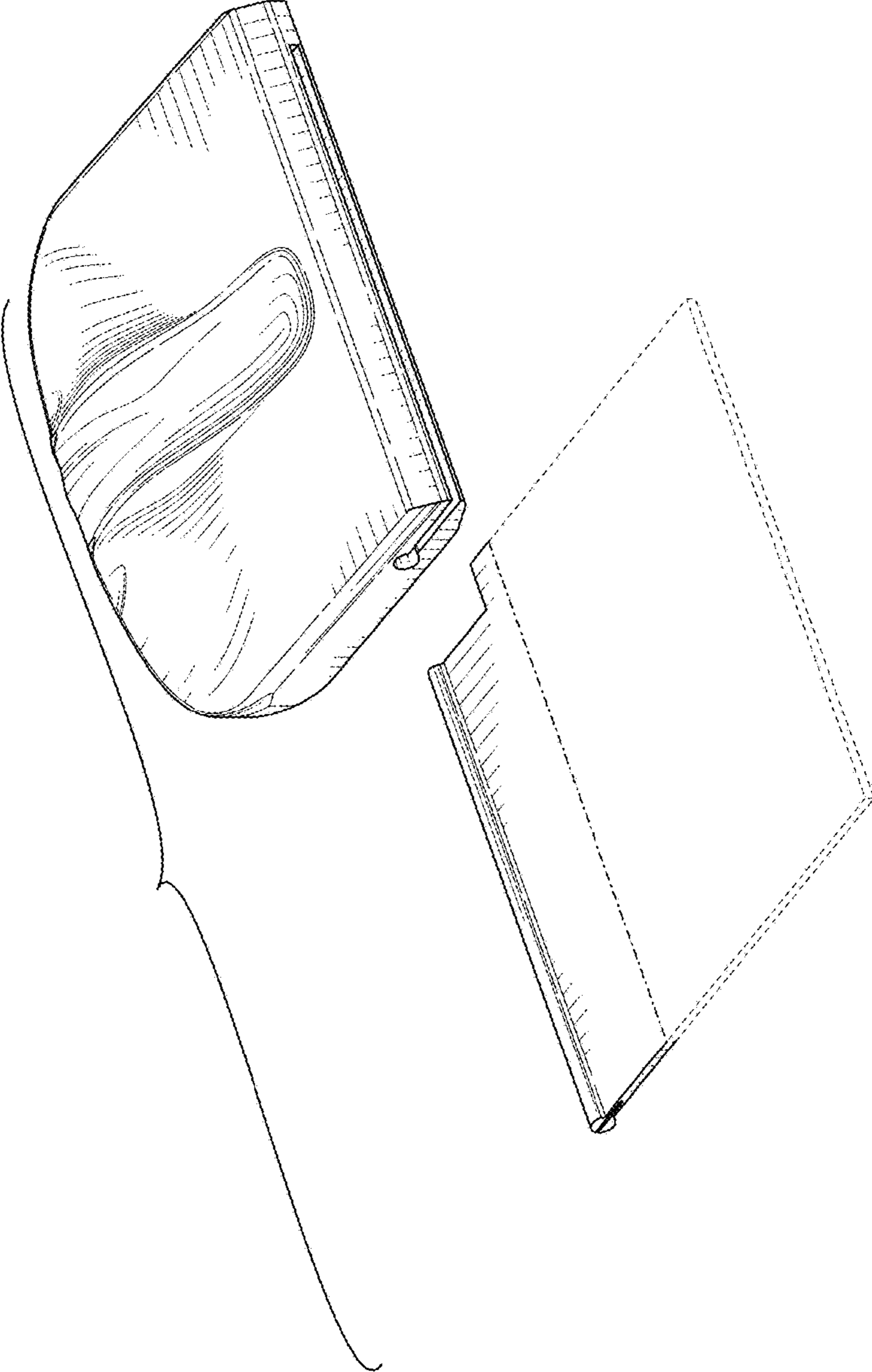

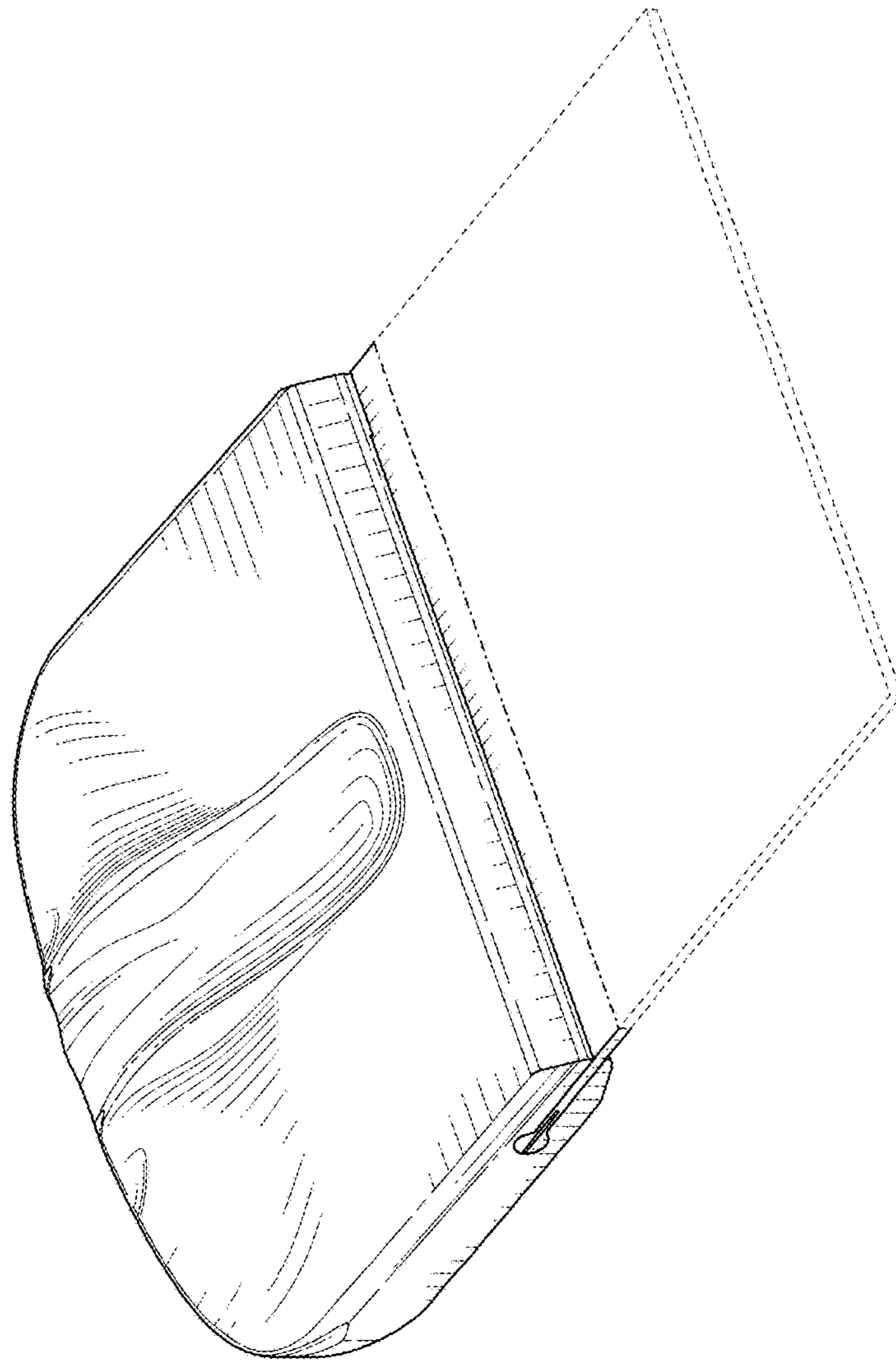
