1.3 : Back

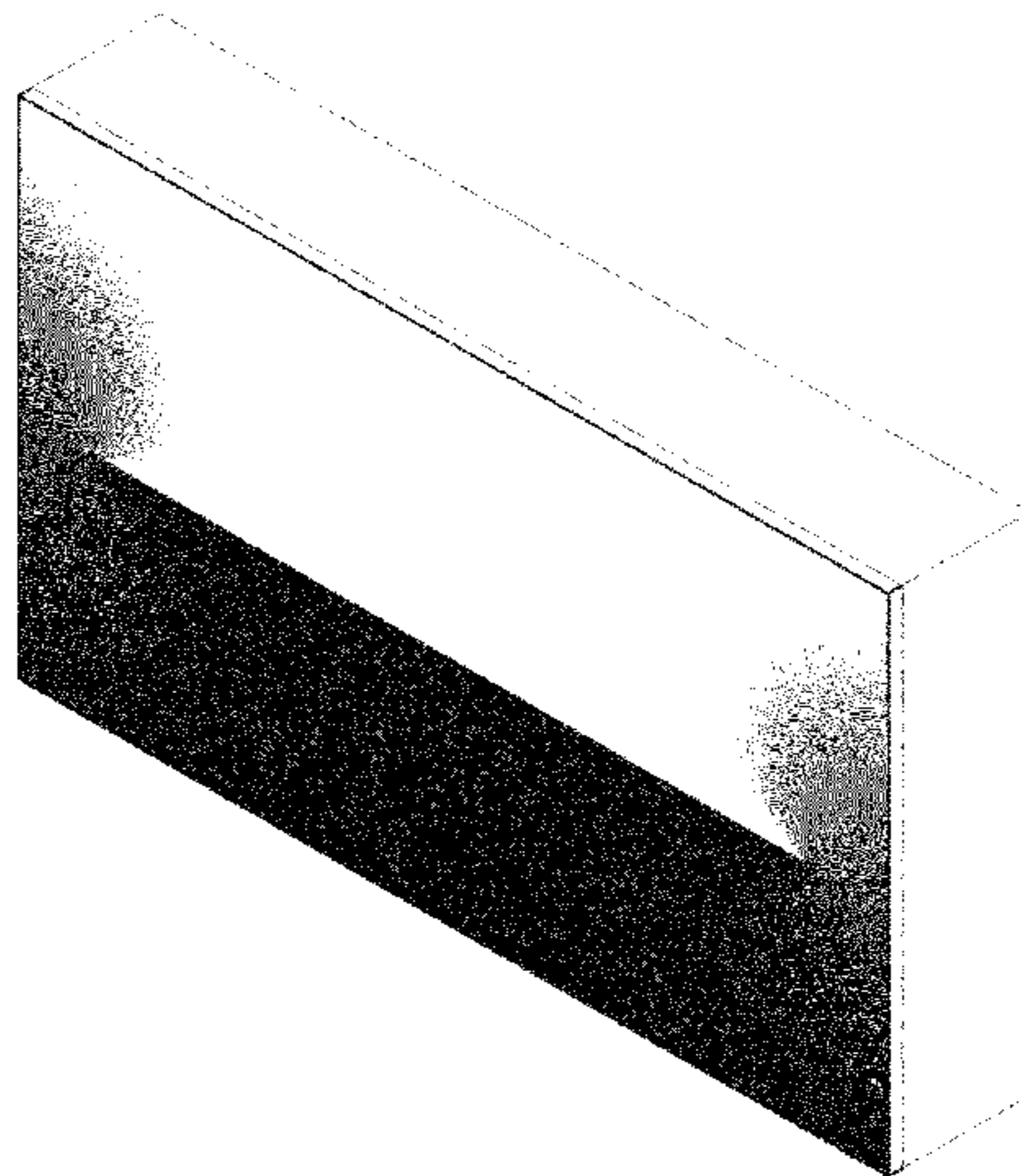
1.4 : Left

1.5 : Top

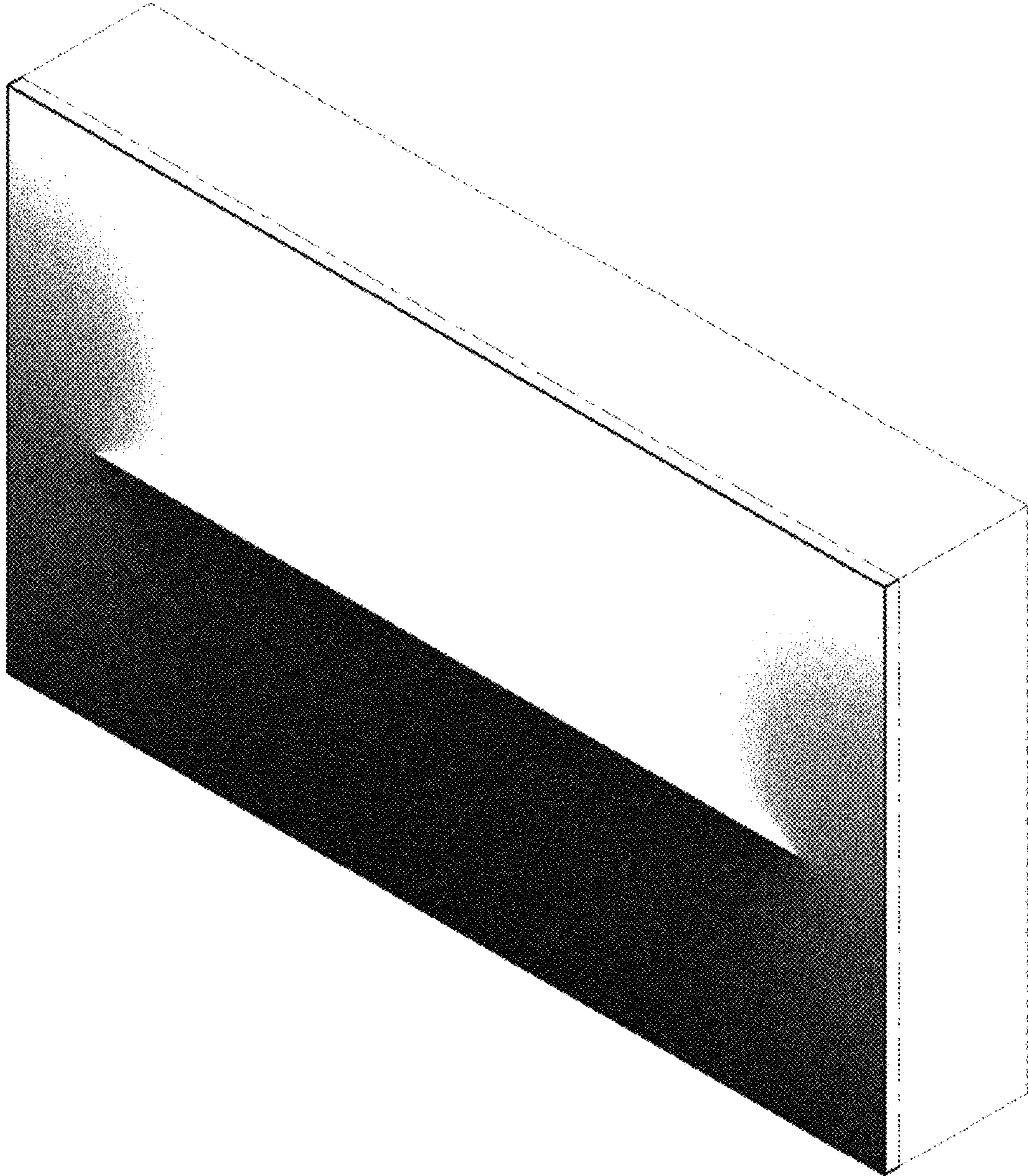
1.6 : Reference photo

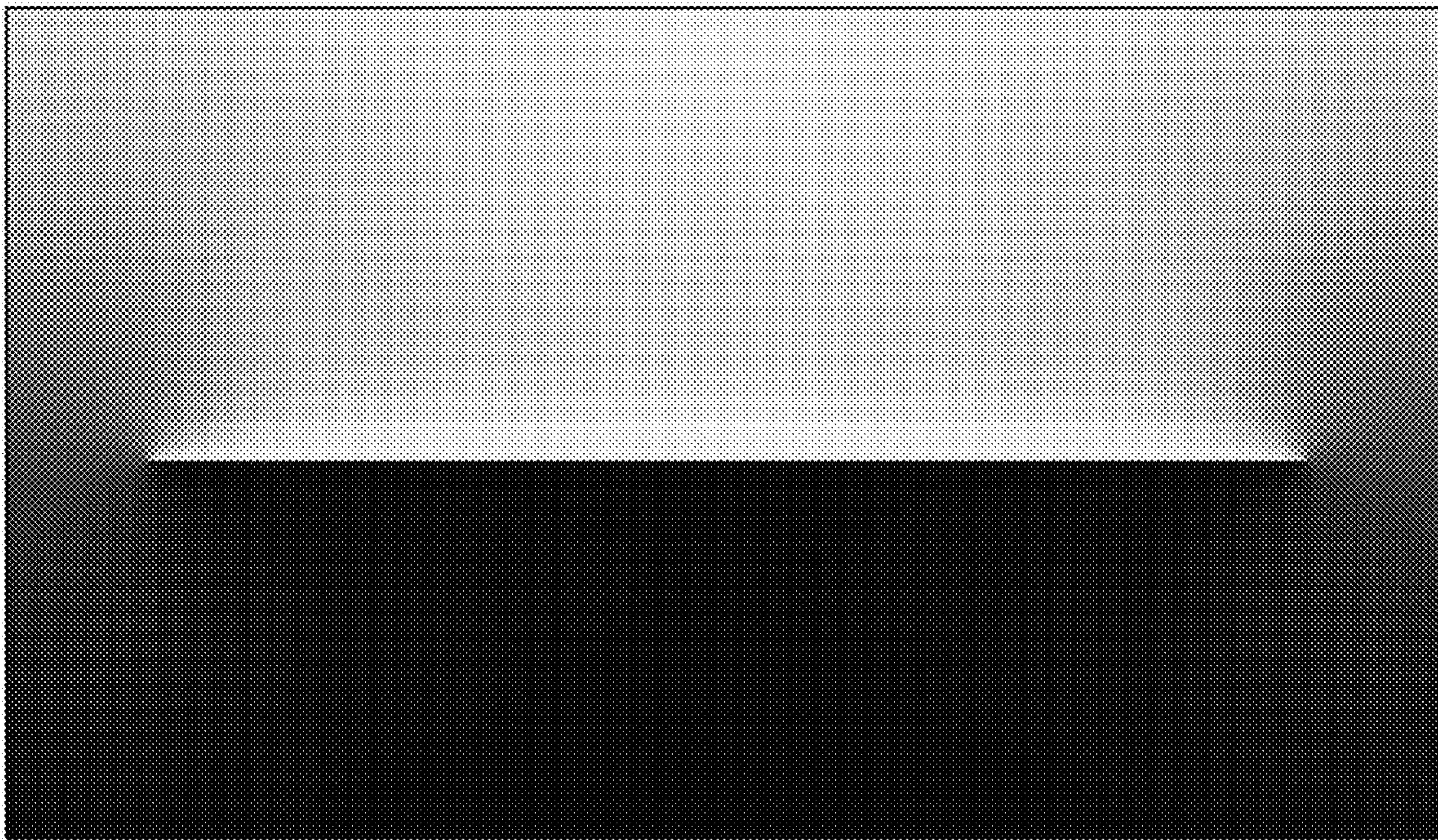

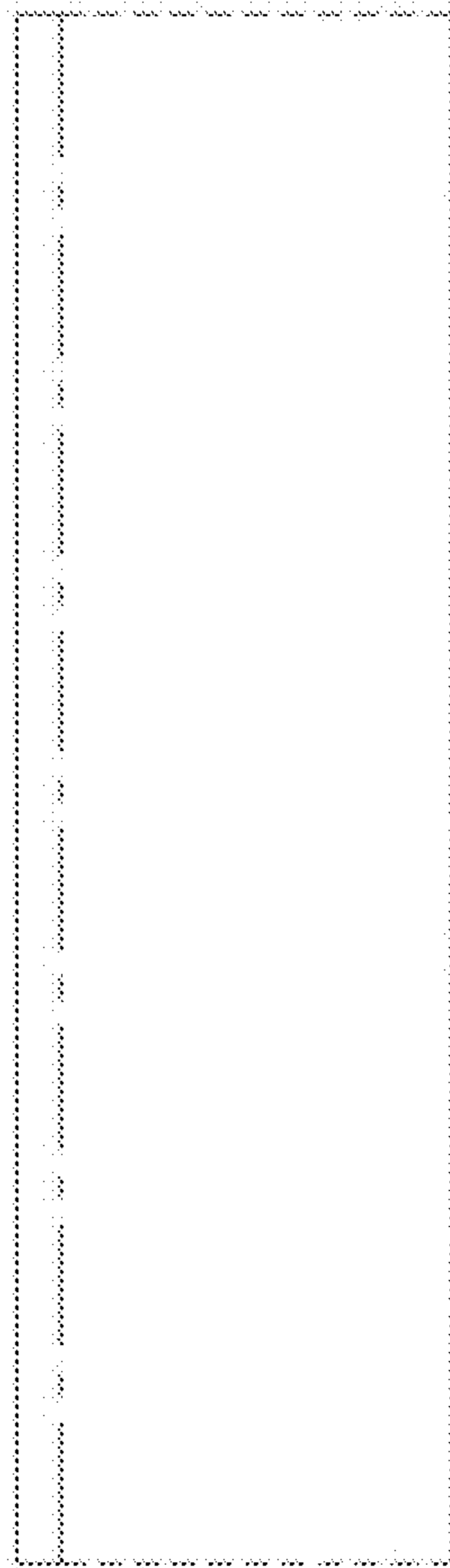
