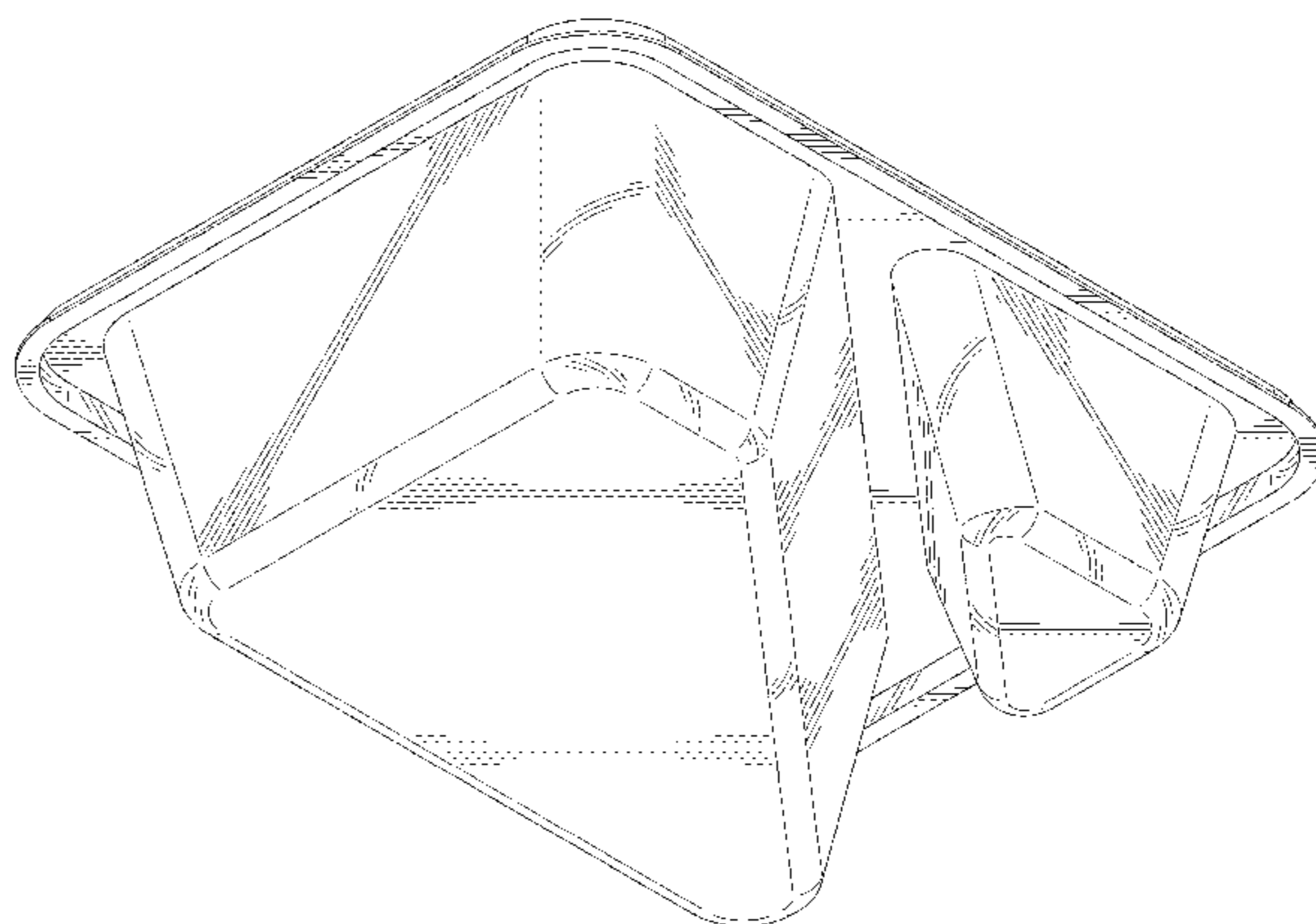
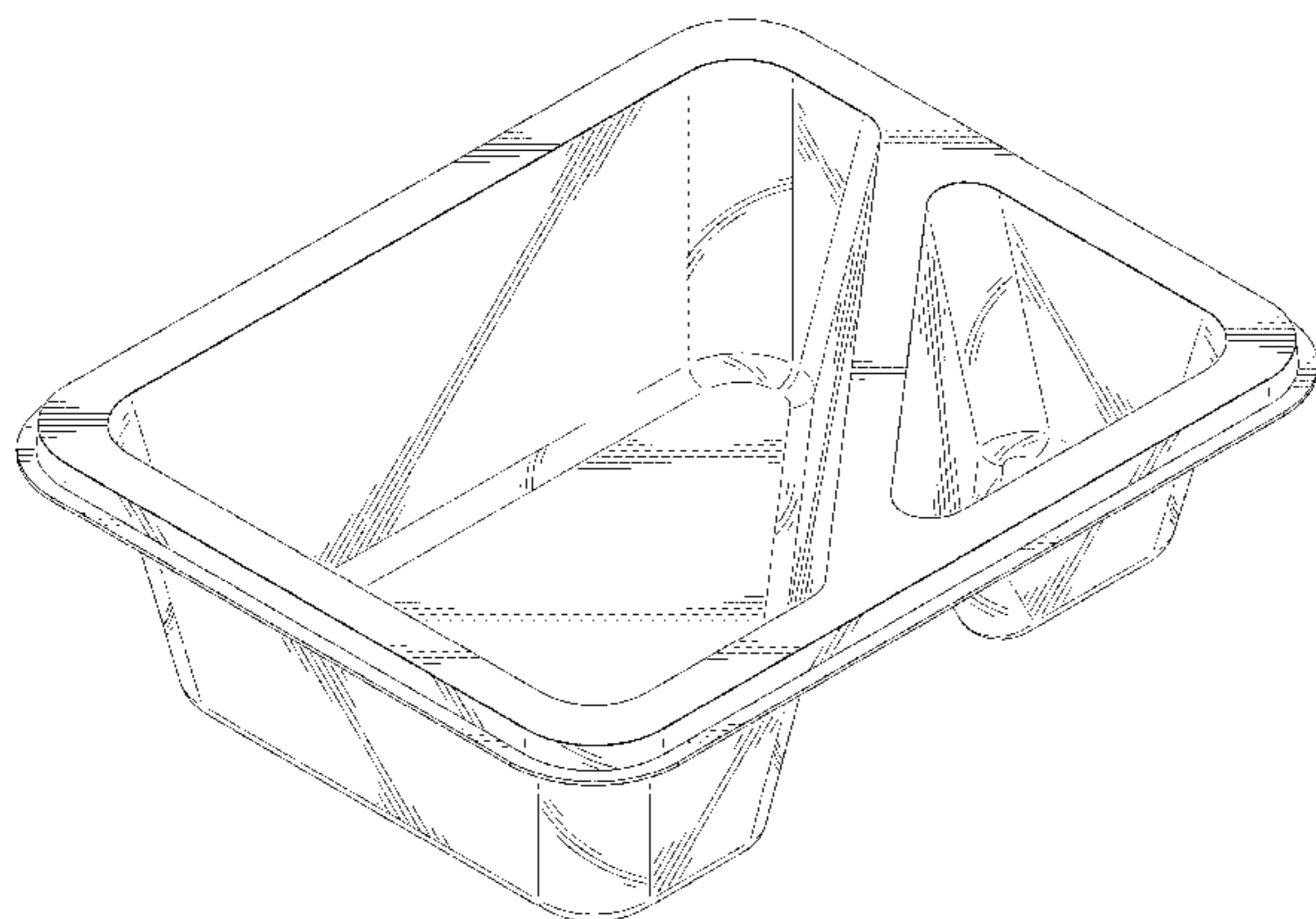
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top perspective view of a container showing our new design;
FIG. 2 is front elevation view thereof;
FIG. 3 is rear elevation view thereof;

FIG. 5 is a left side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,

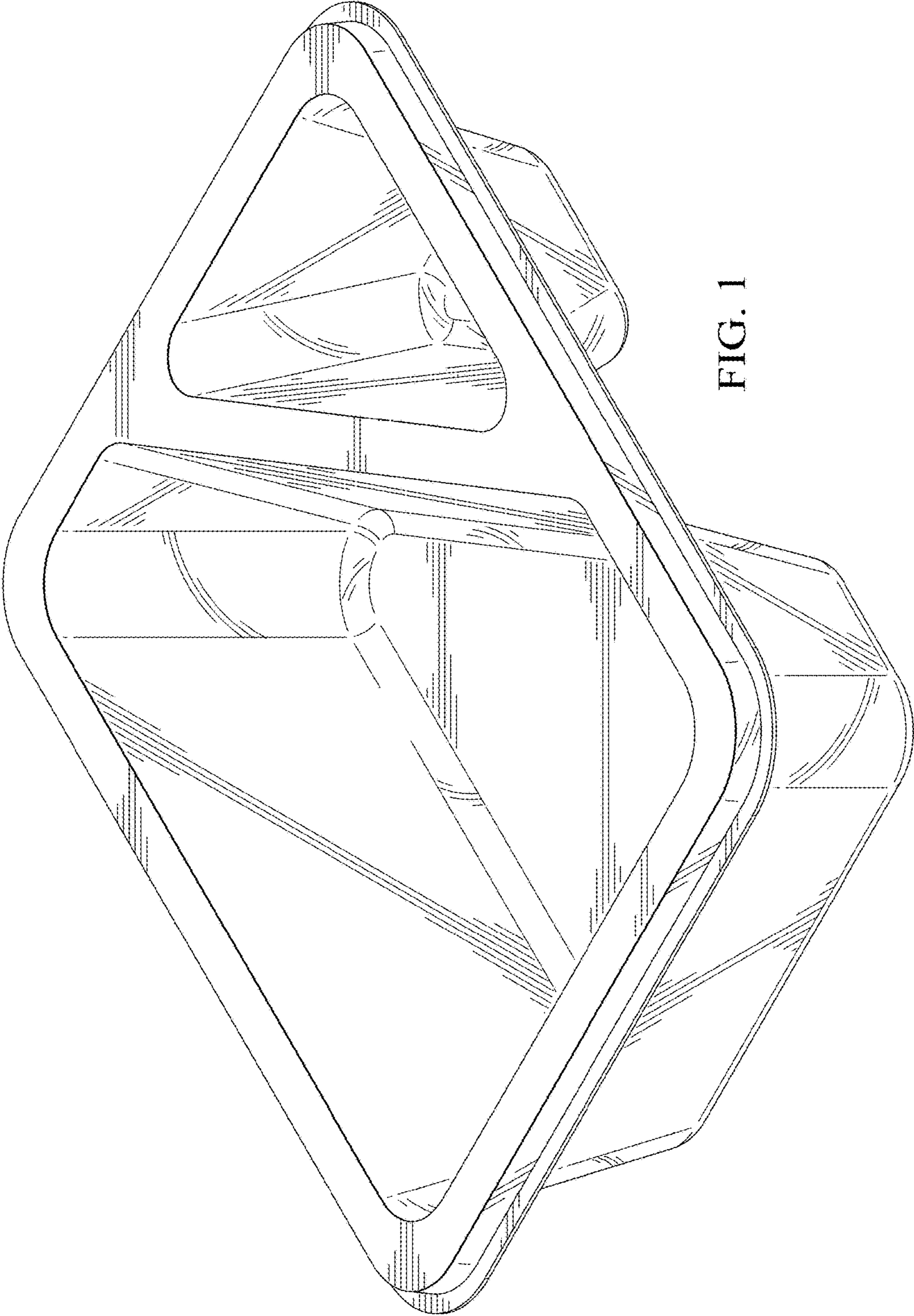

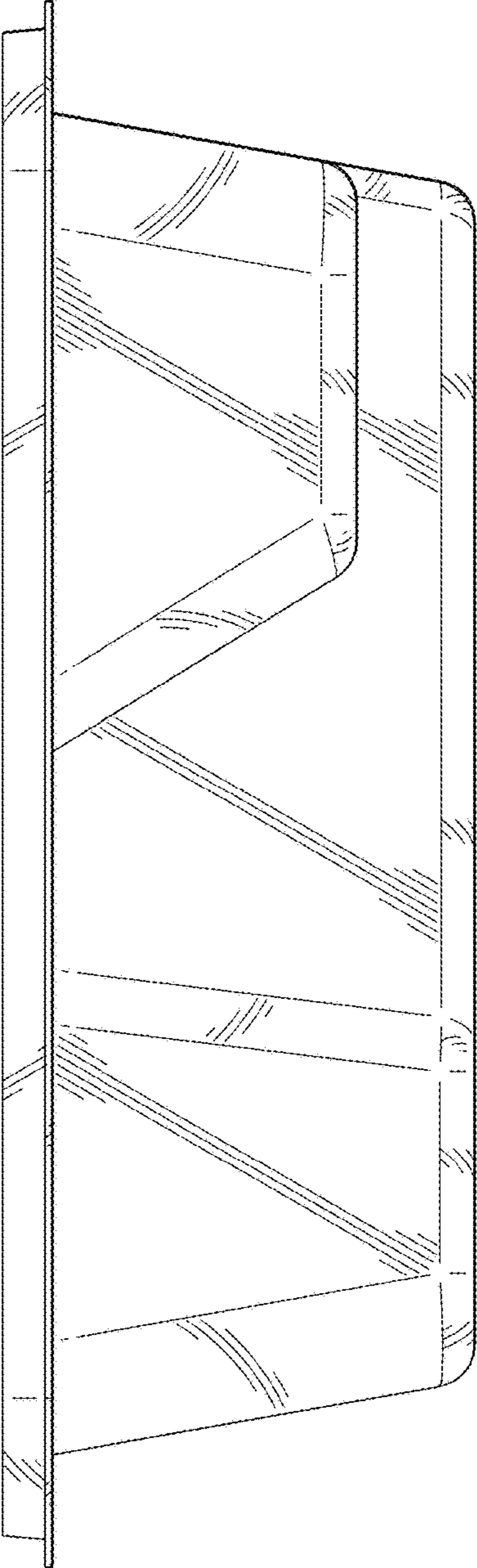

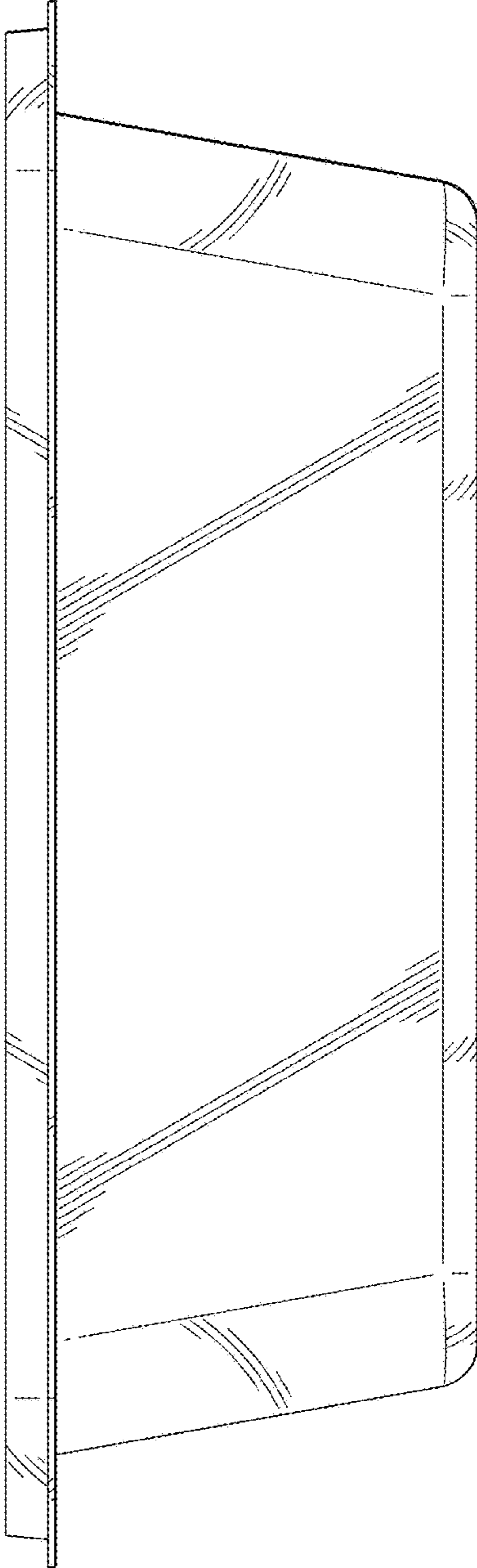

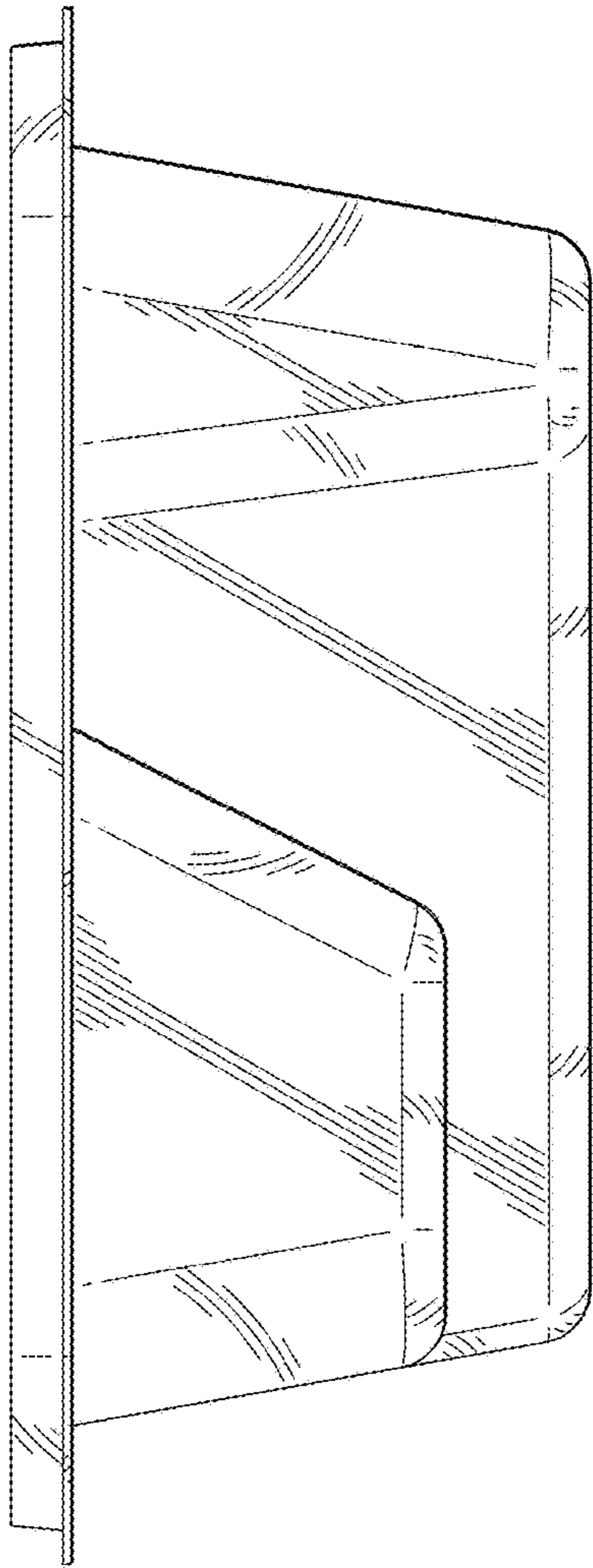

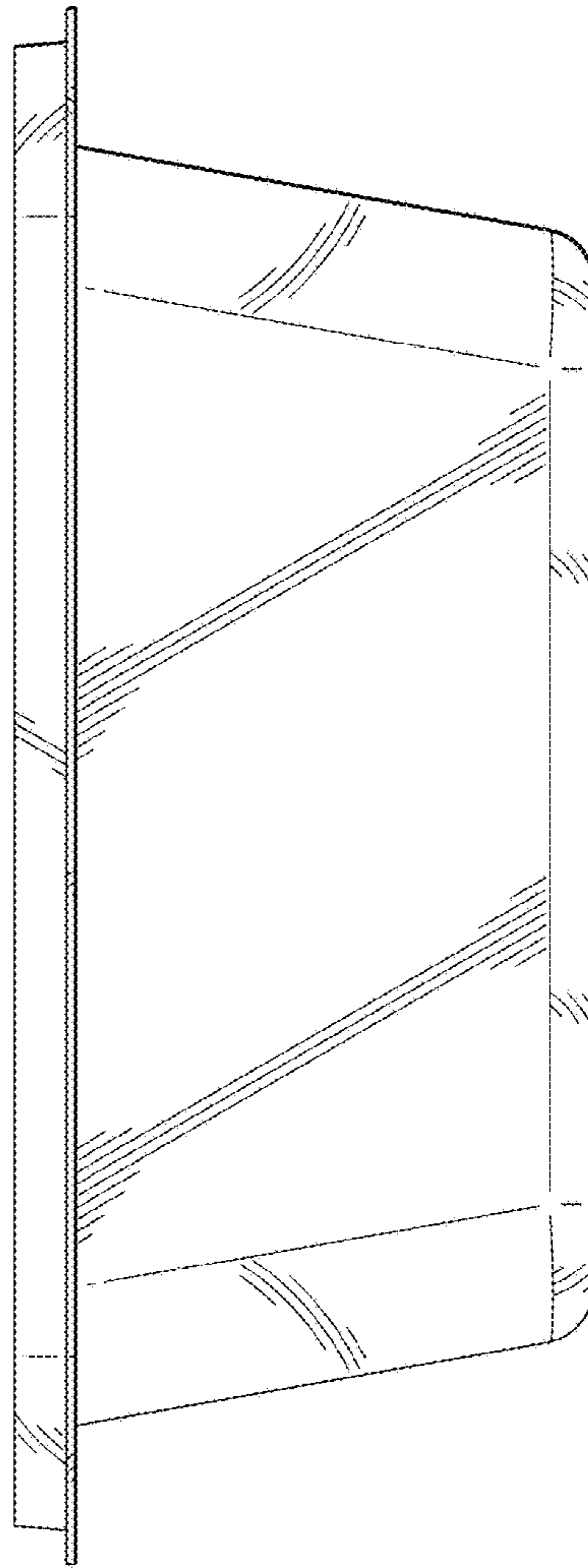

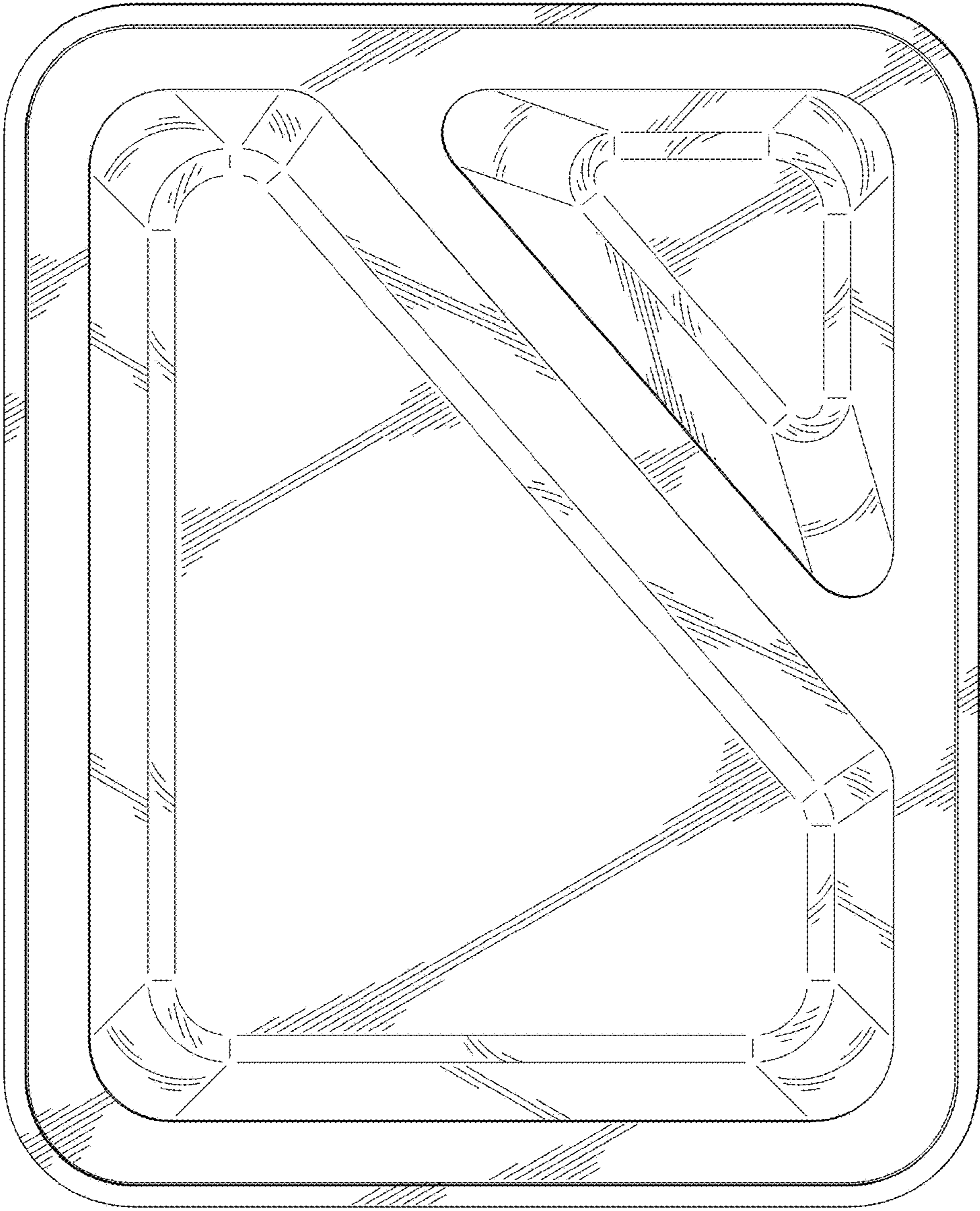

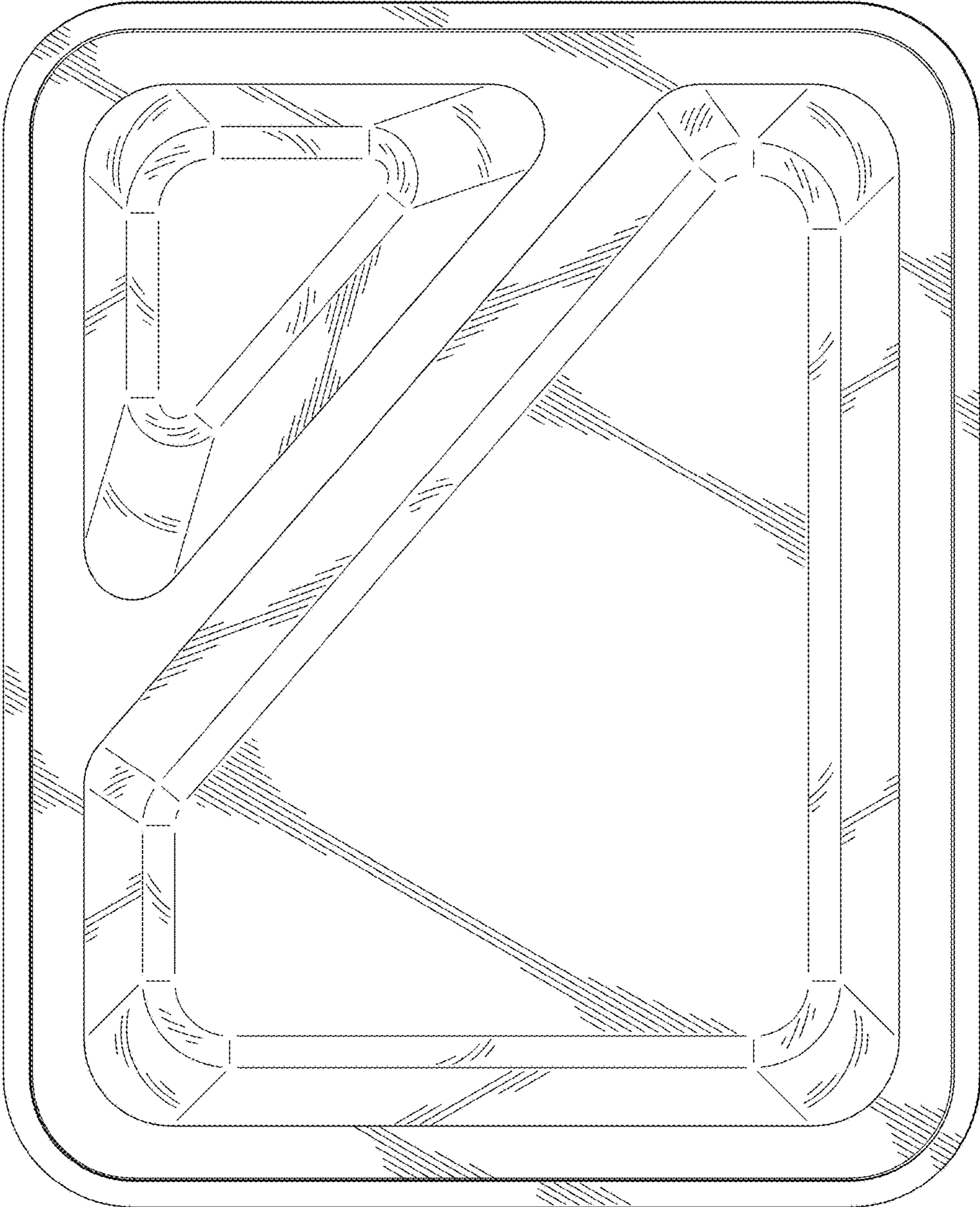

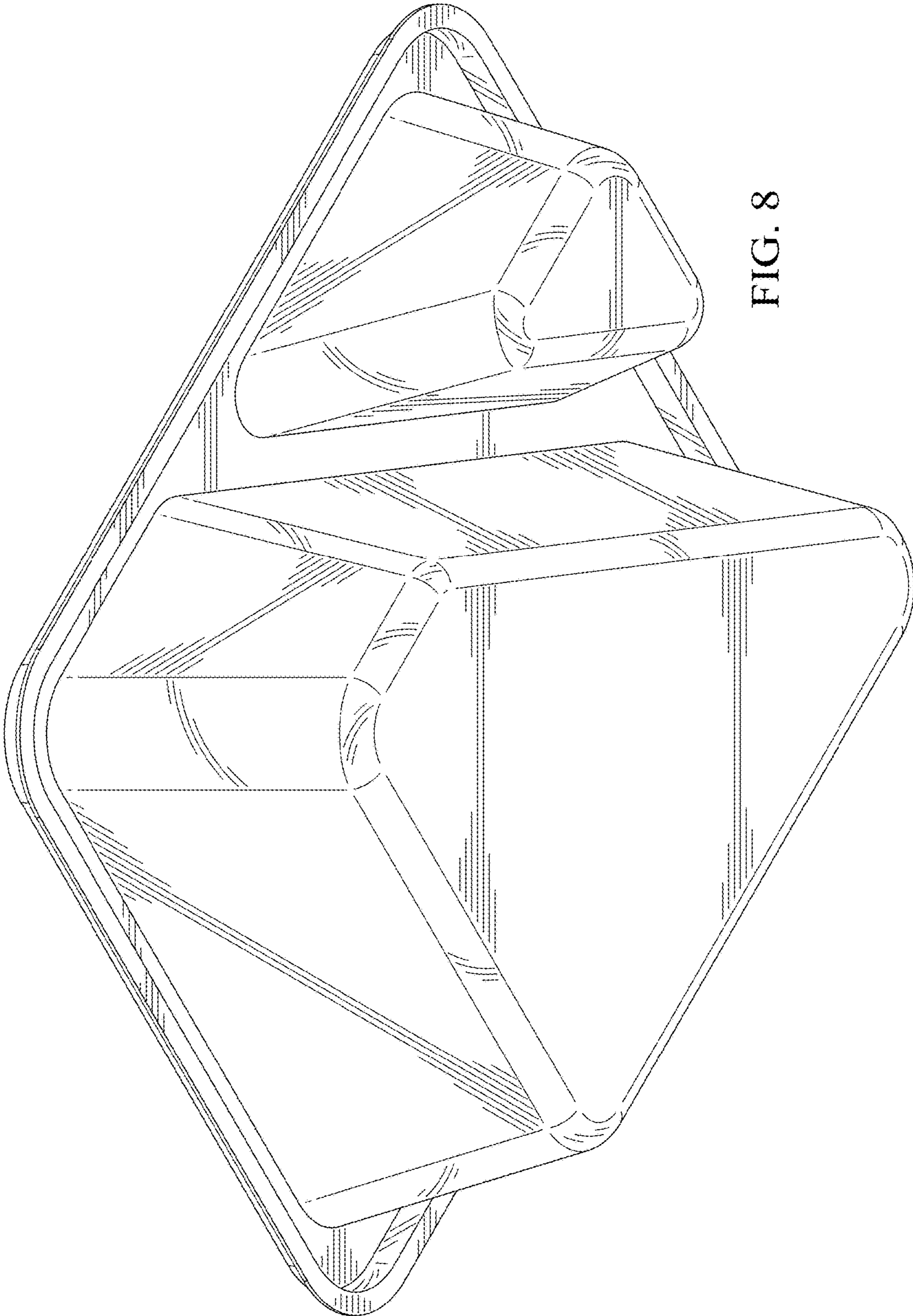
