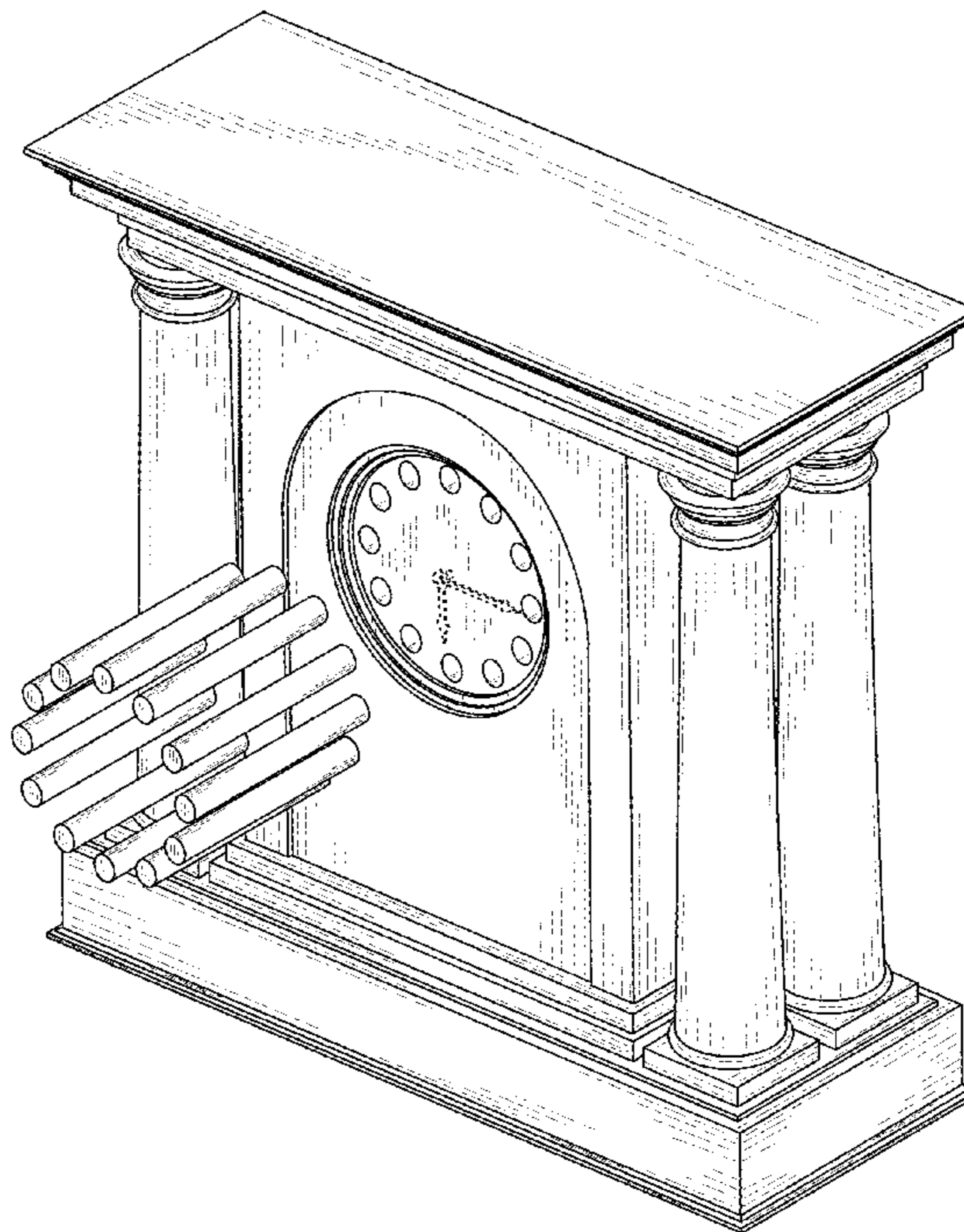
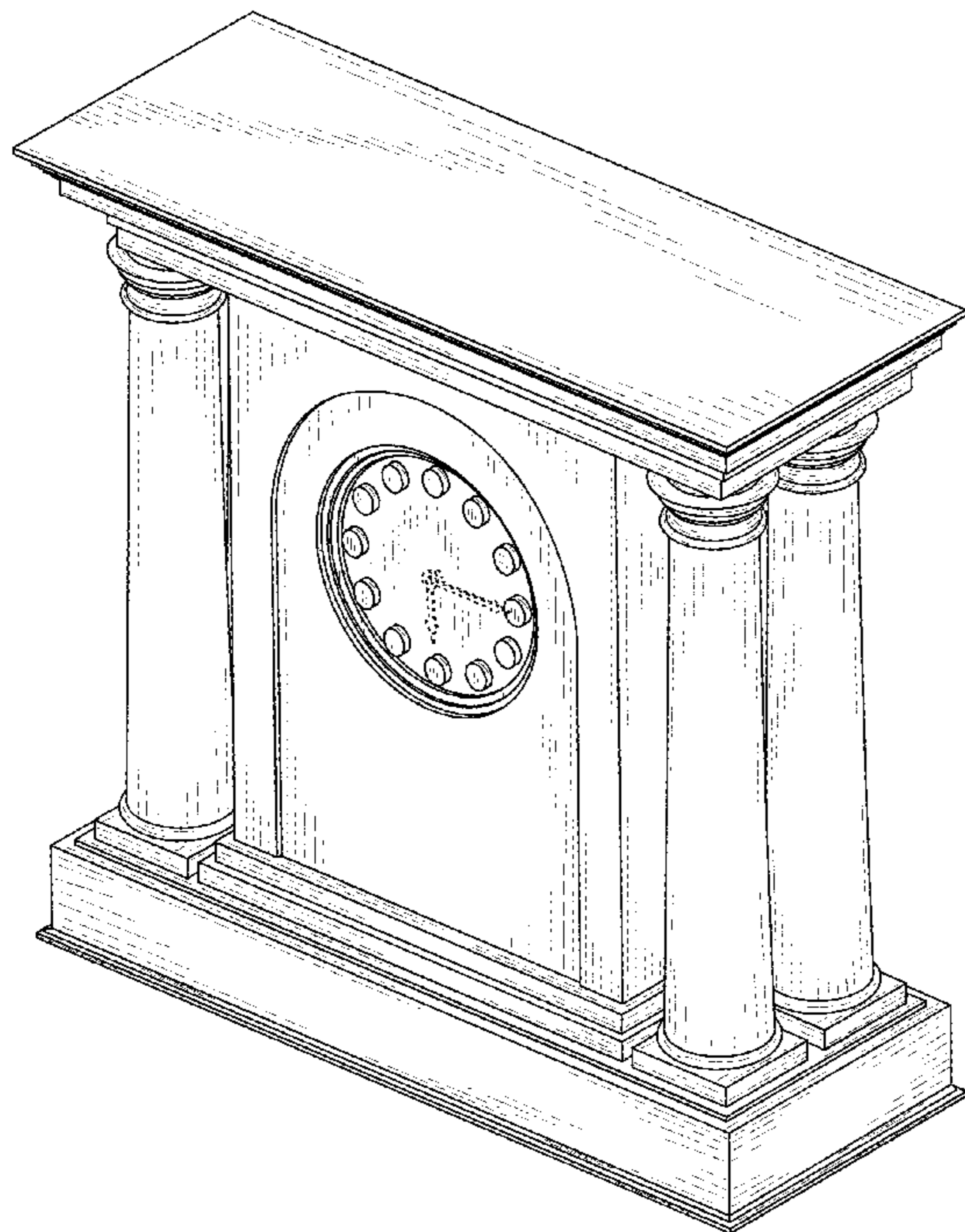
The ornamental design for a clock time capsule, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clock time capsule, wherein each of a plurality of capsules has been inserted into a corresponding pocket;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a front perspective view of a clock time capsule, wherein each of a plurality of capsules has been removed from a corresponding pocket.

The broken line showing of clock hands and back side supports and mounts is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

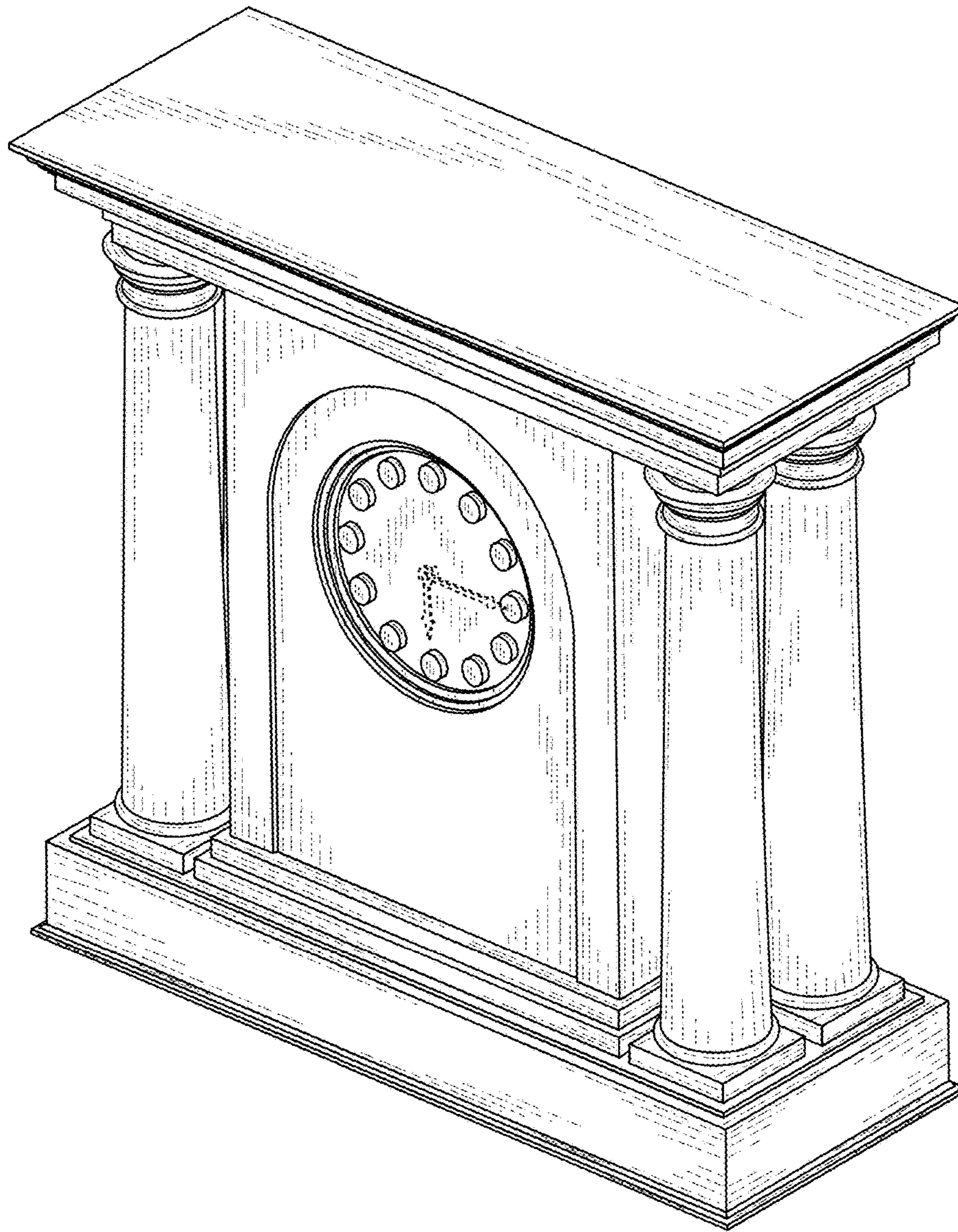

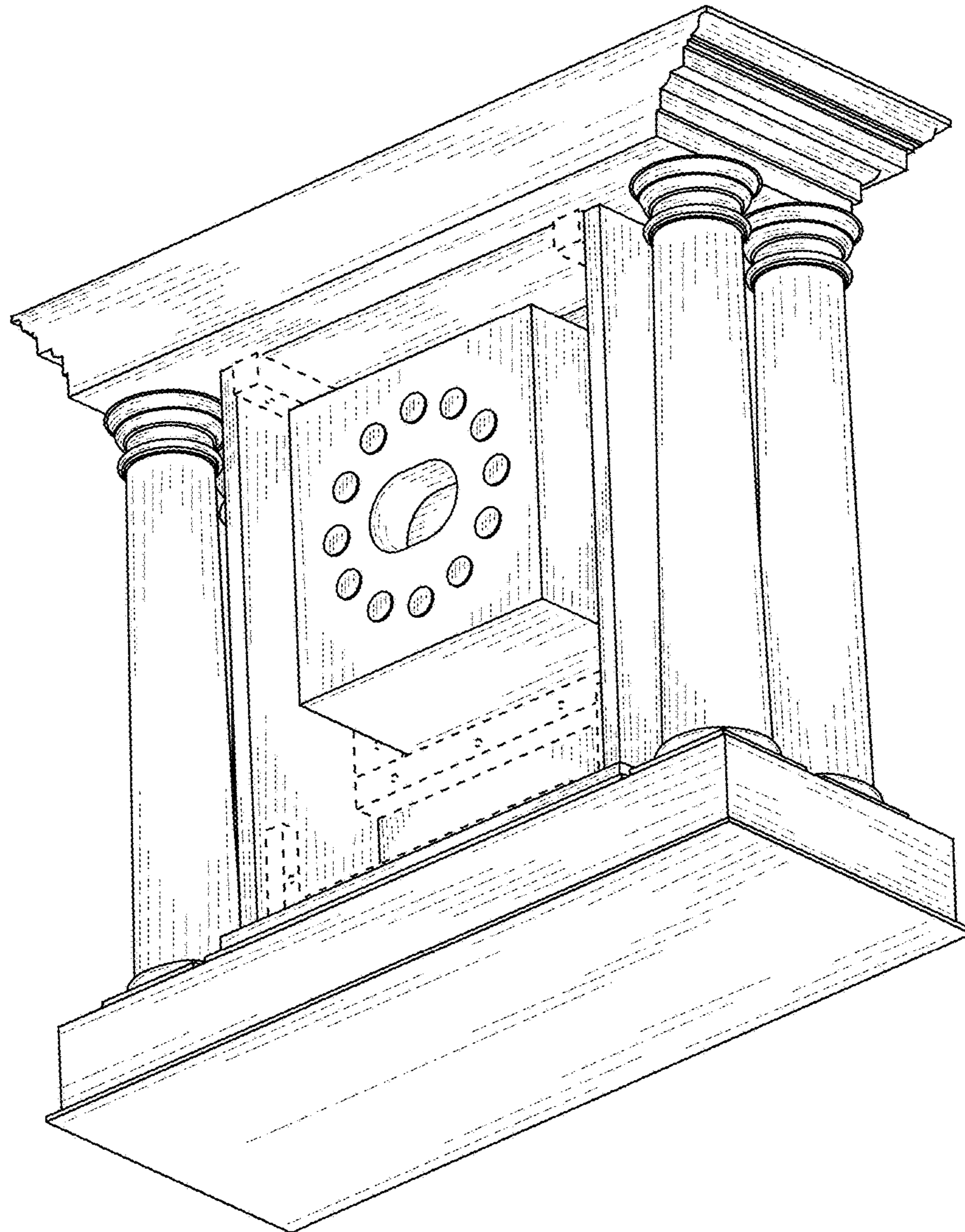

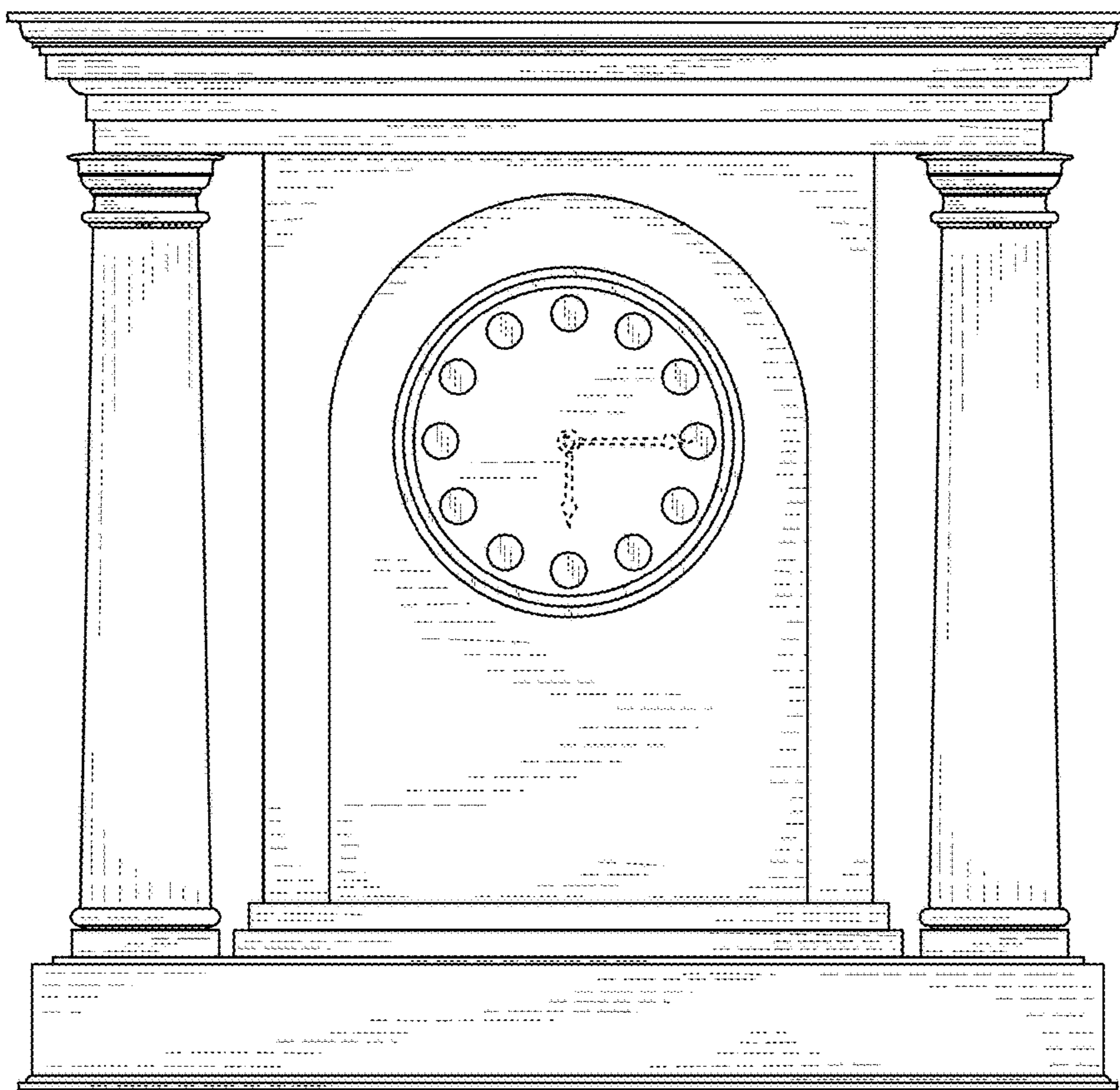

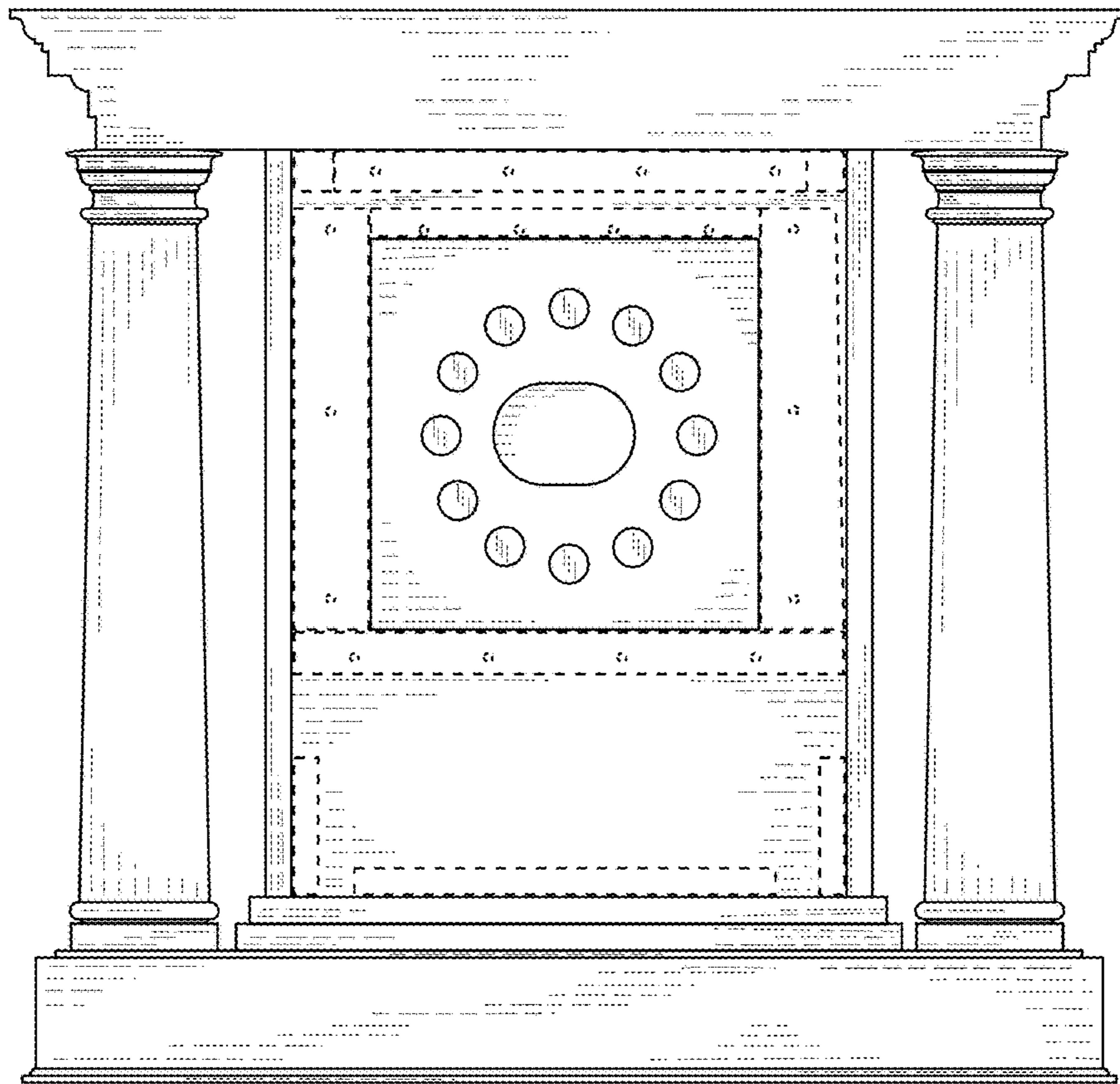

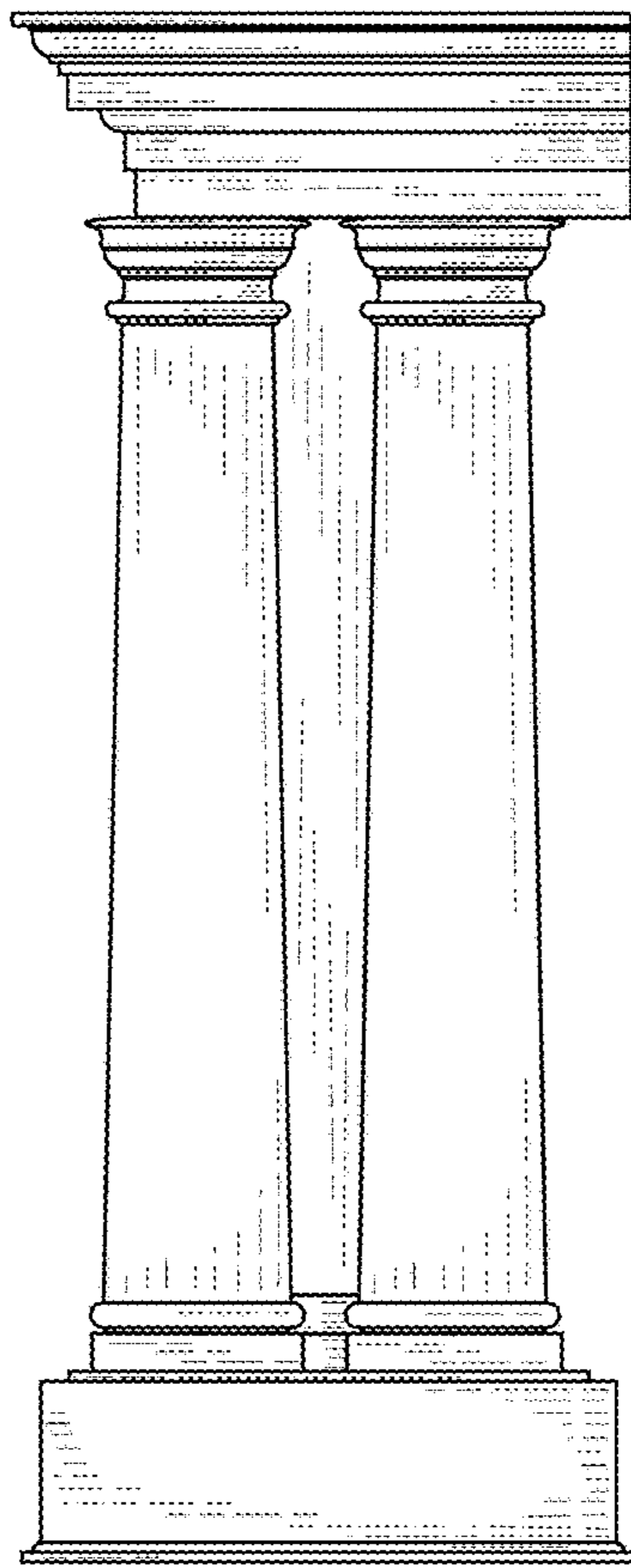

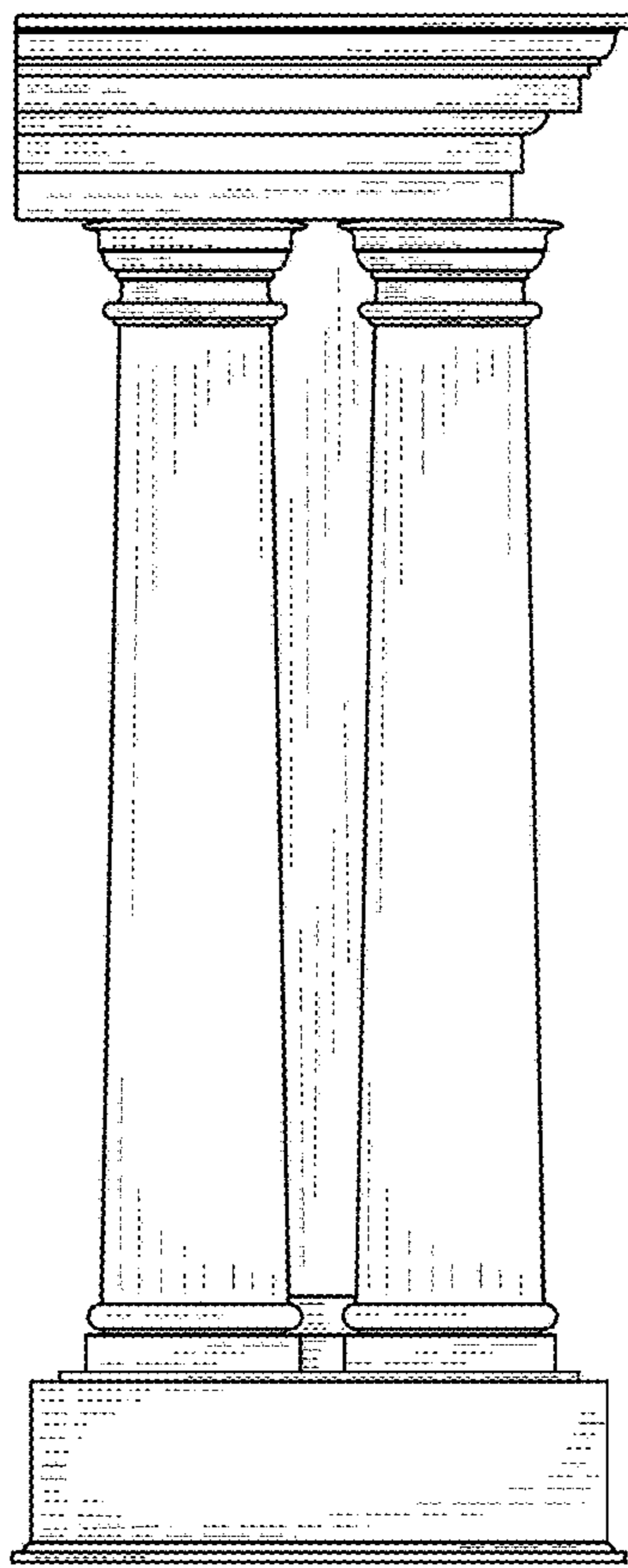

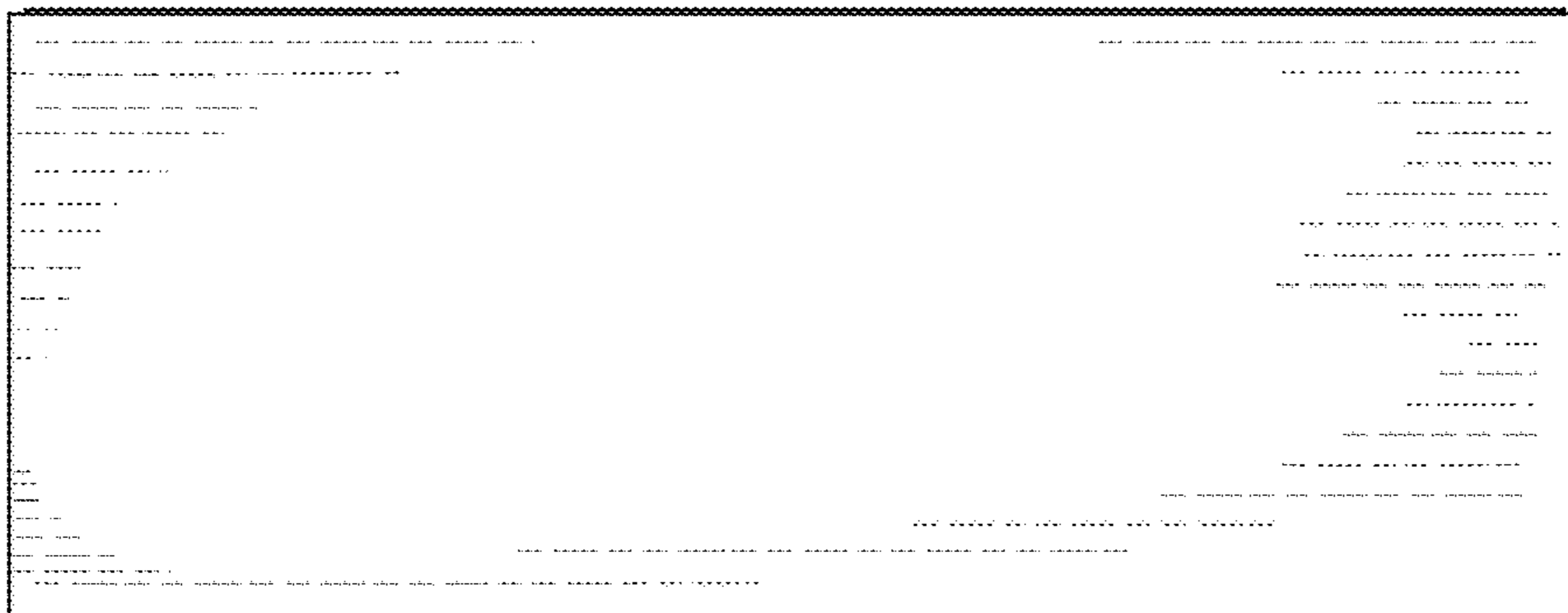

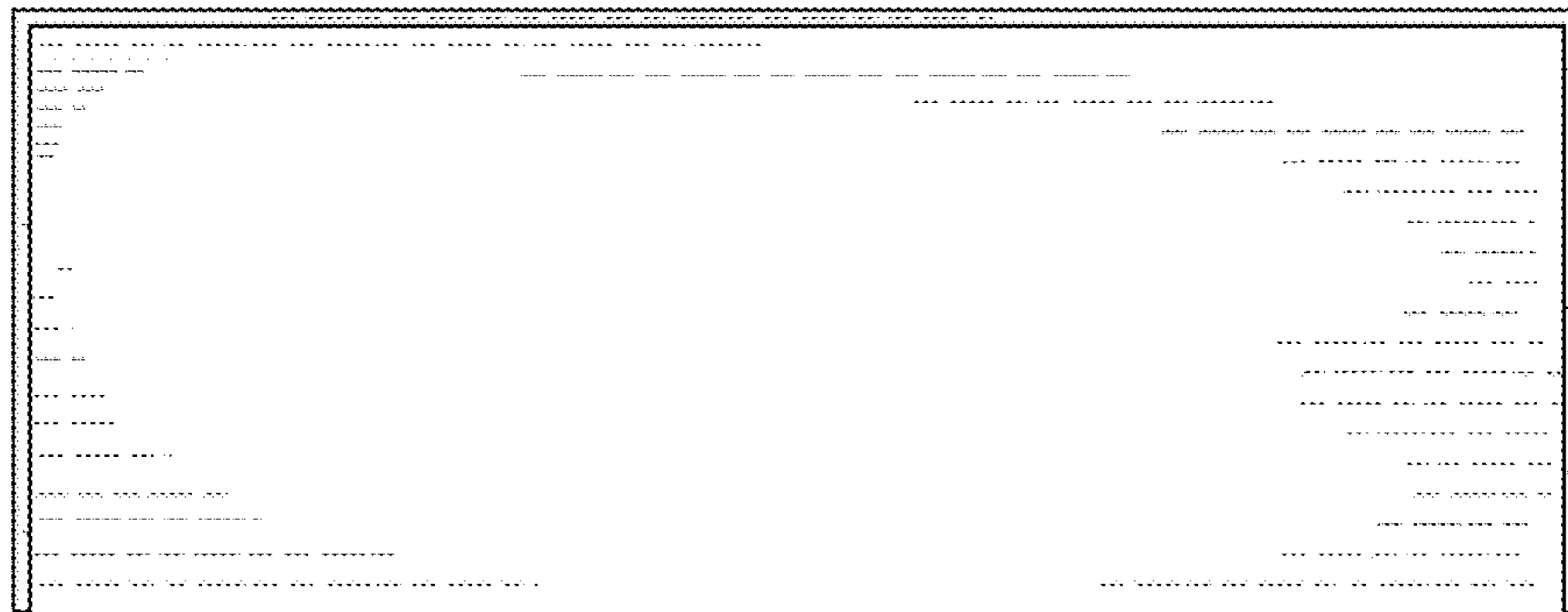

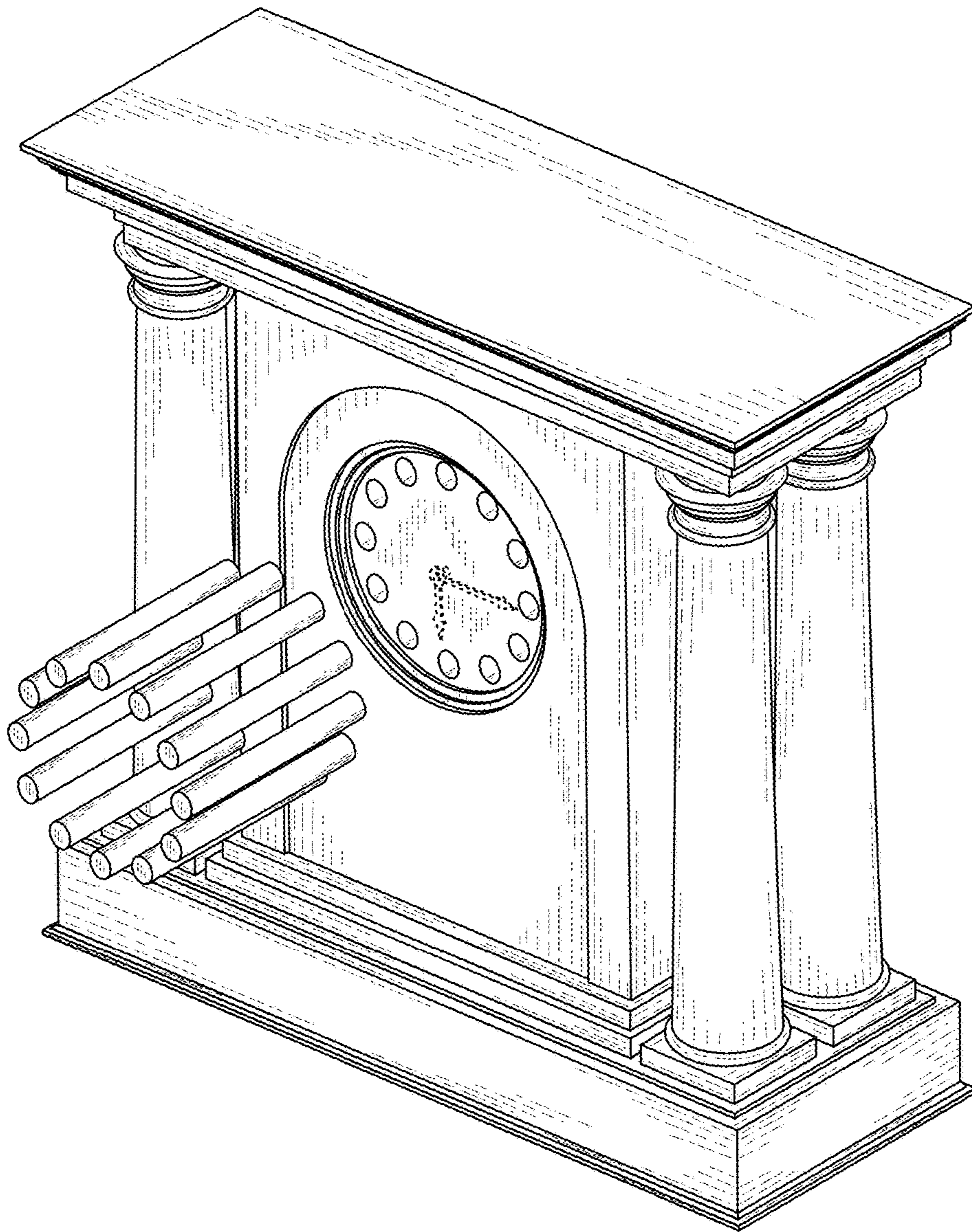
