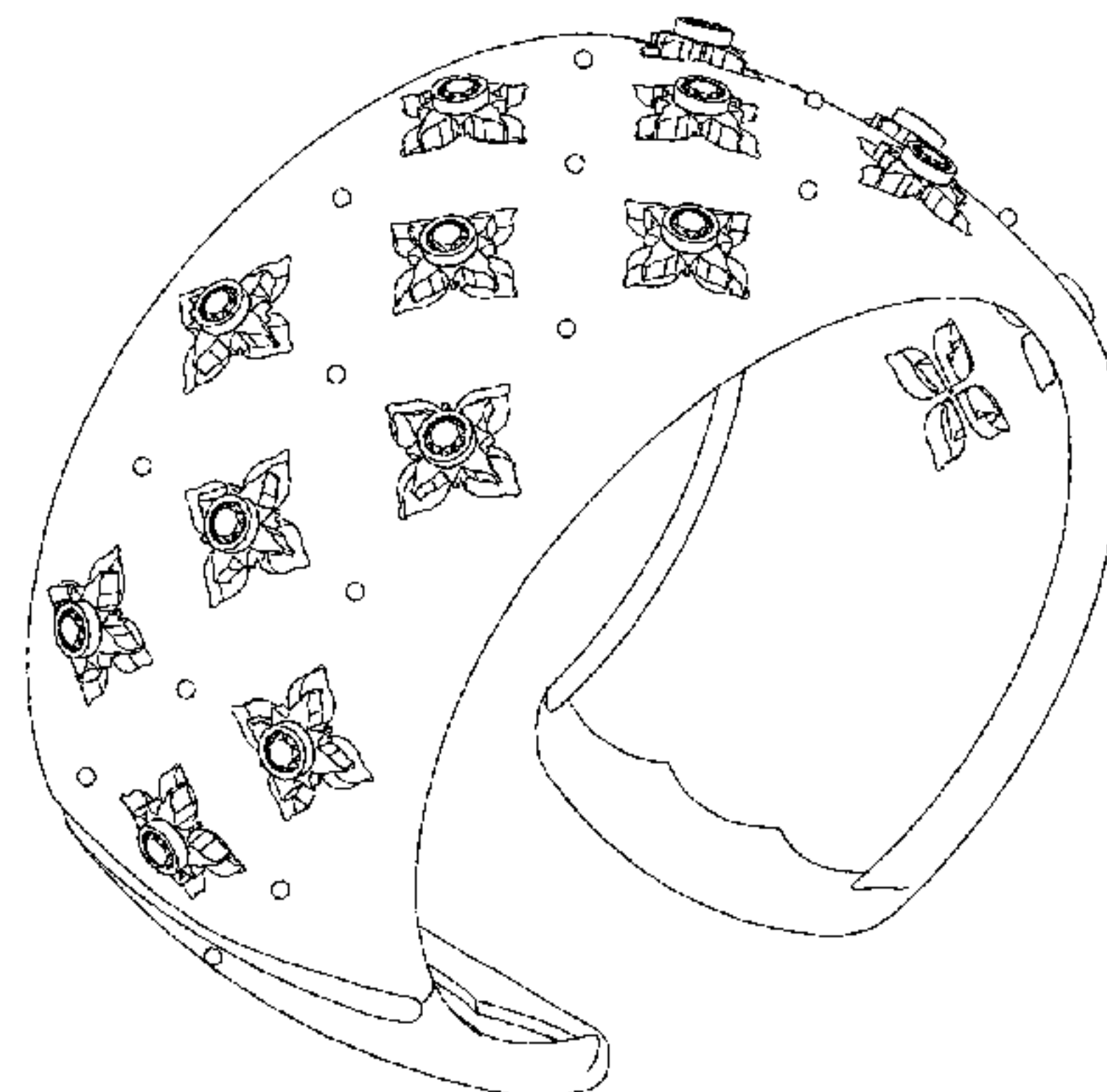
(57) **CLAIM**

The ornamental design for a bracelet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bracelet showing my new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is an inverted left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a rear view thereof; and,  
FIG. 8 is a top enlarged view of one of the jeweled elements of the bracelet, the others being the same.

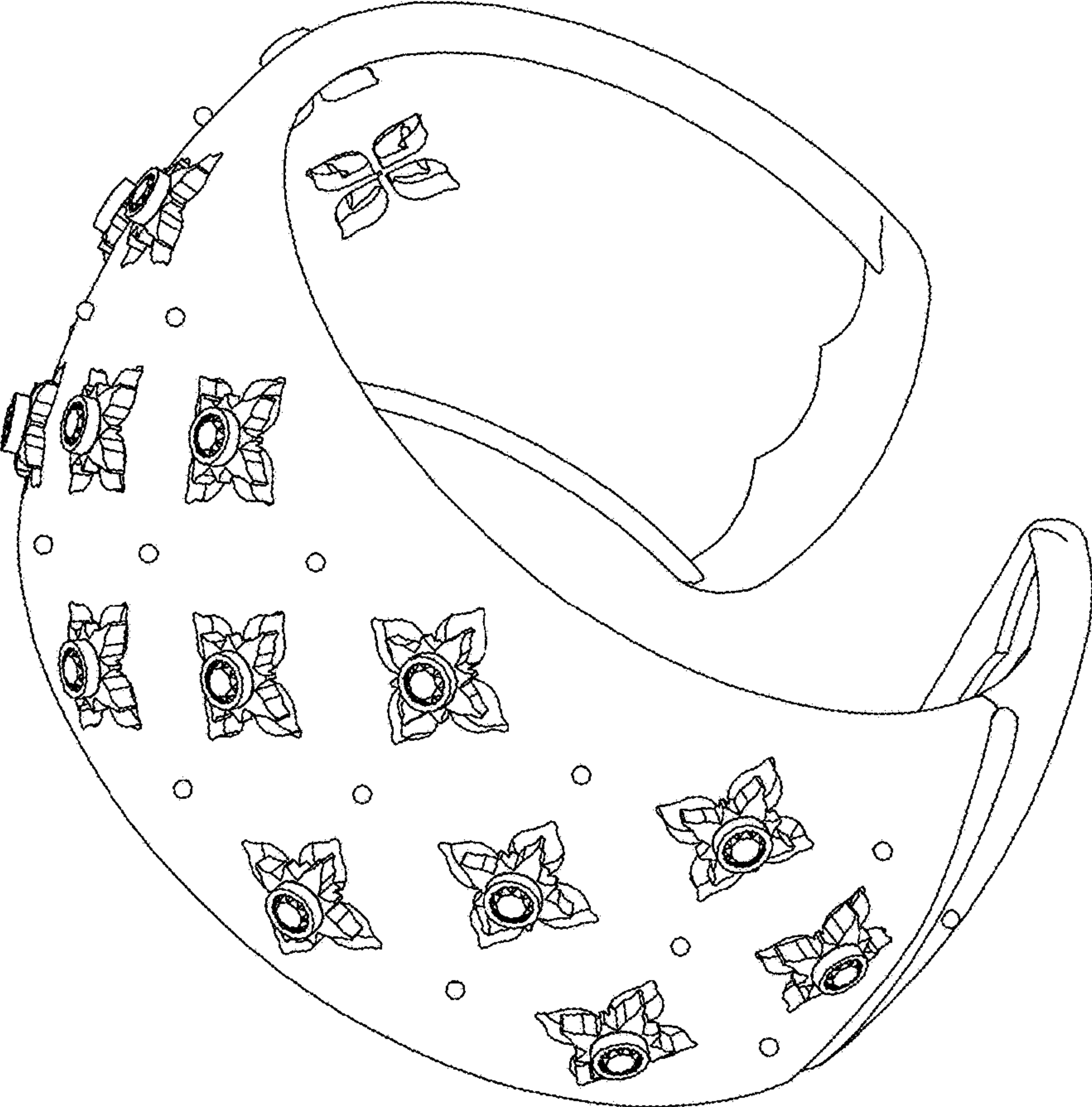

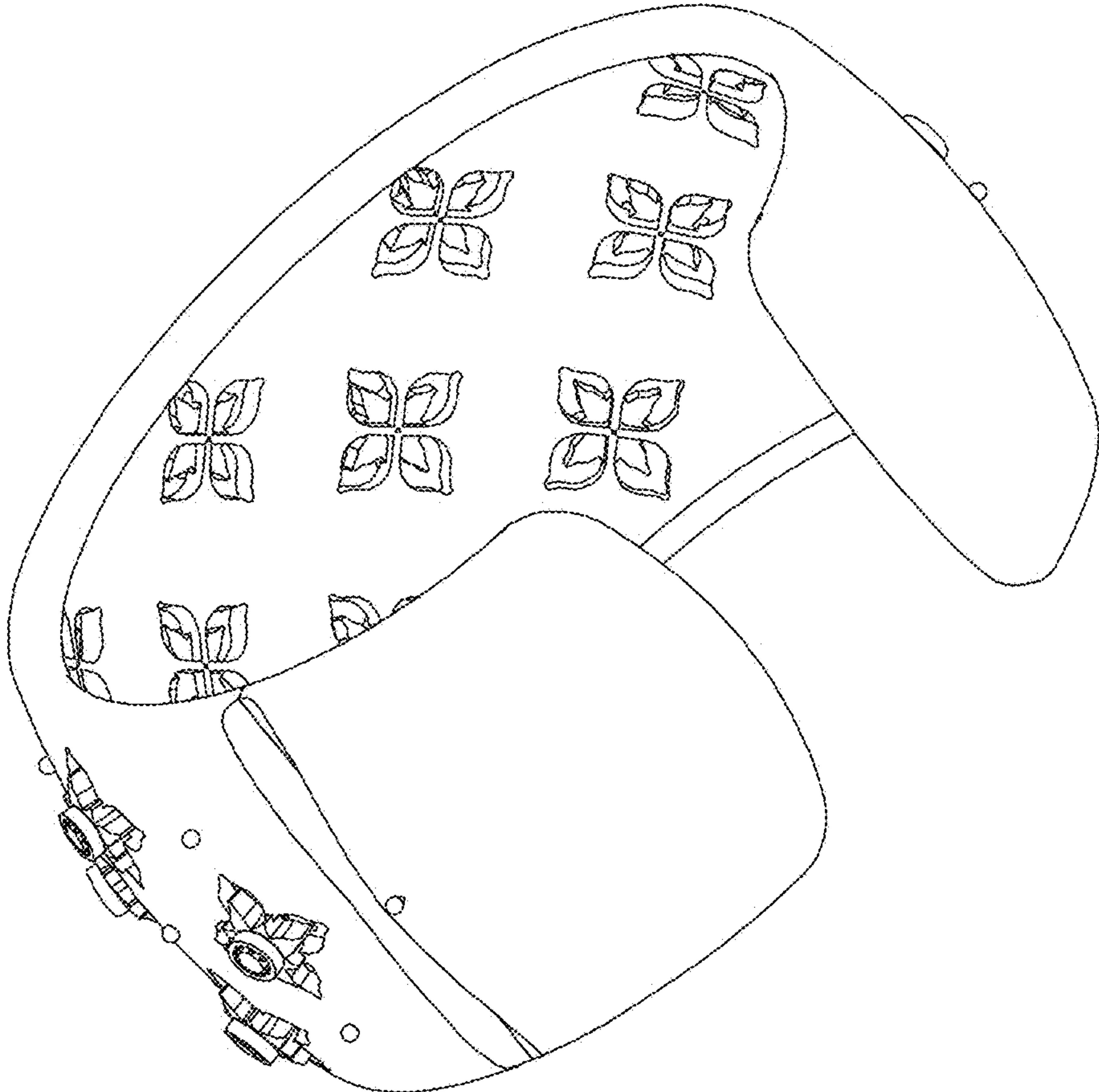

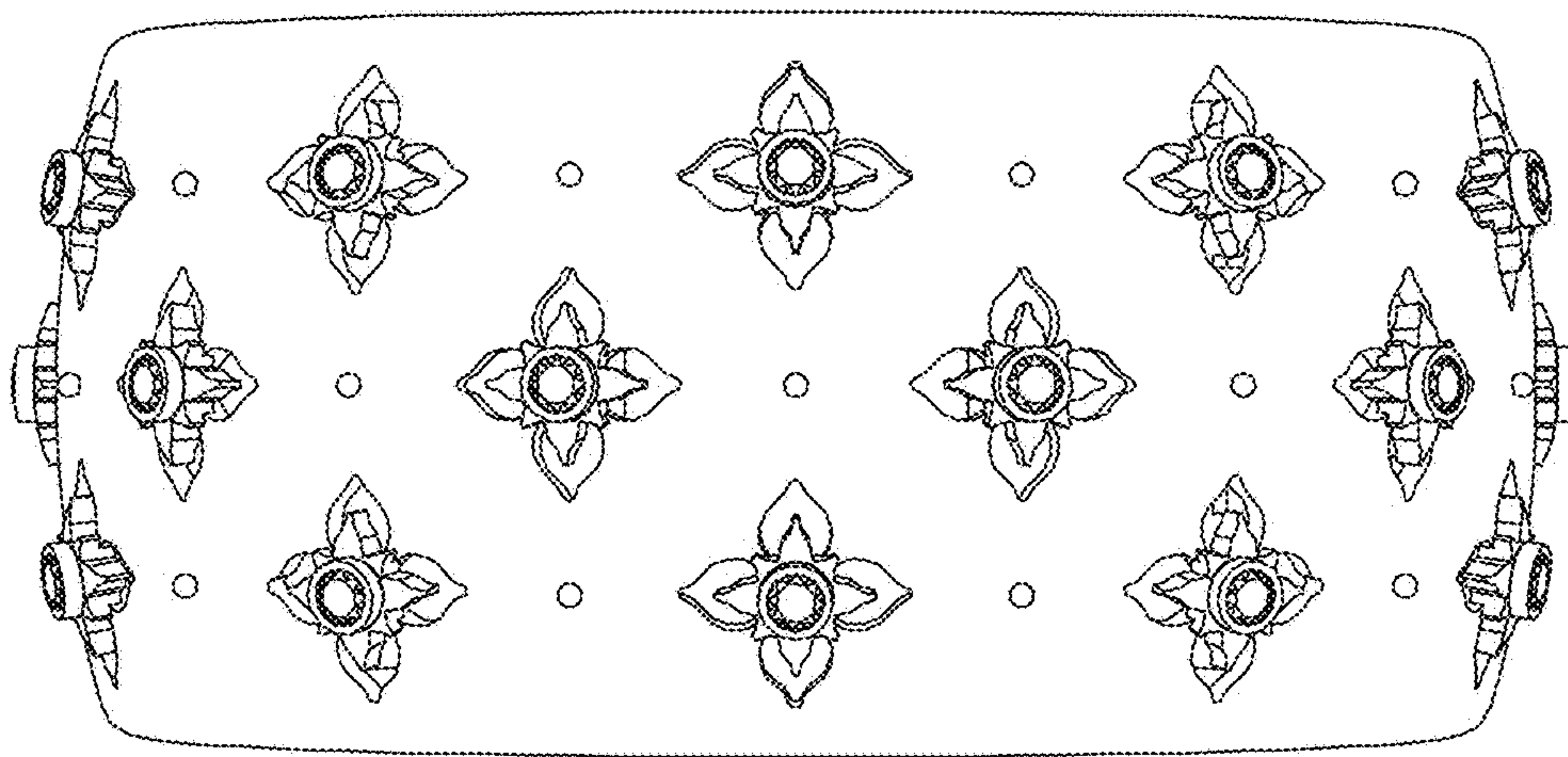

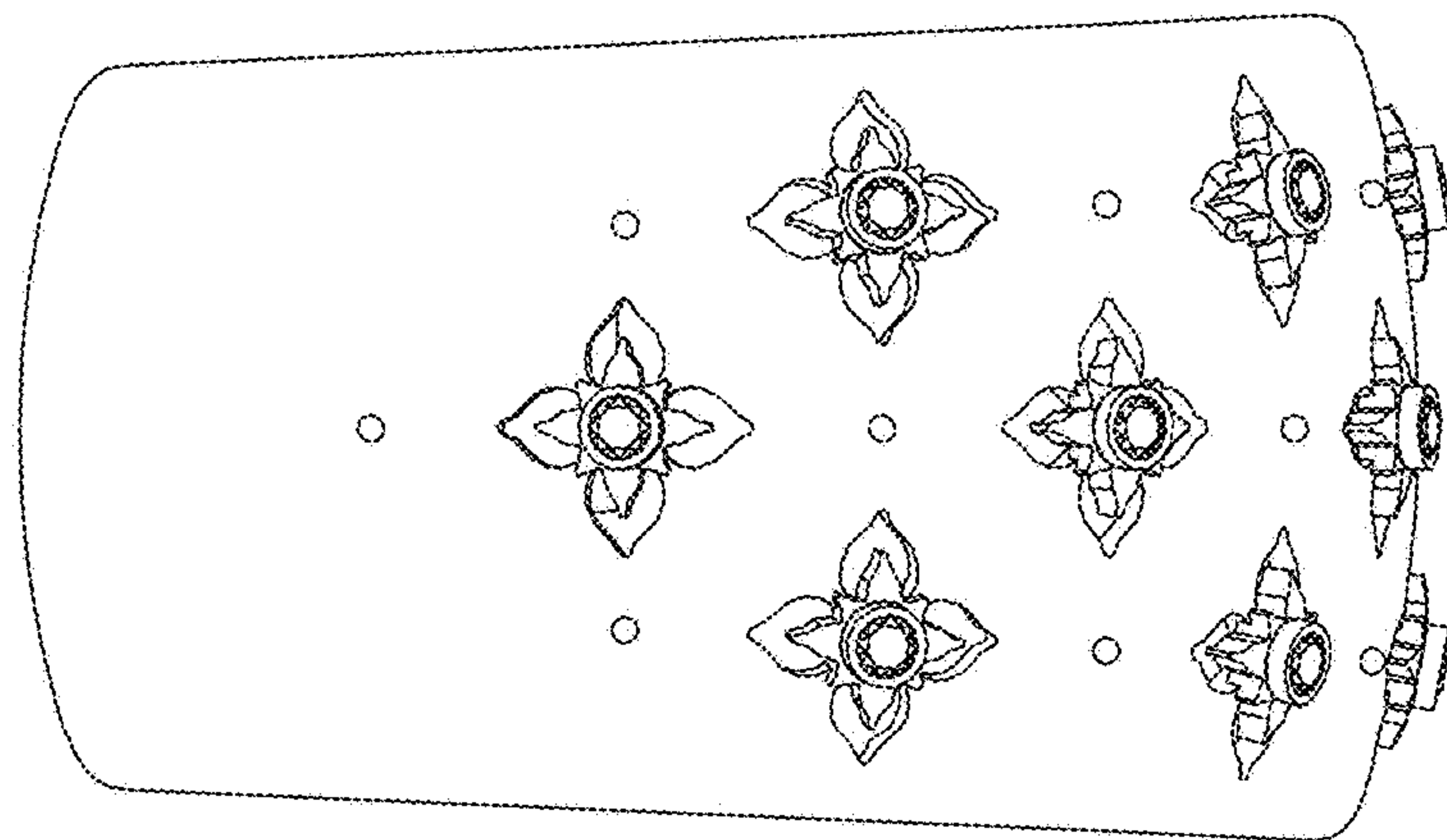

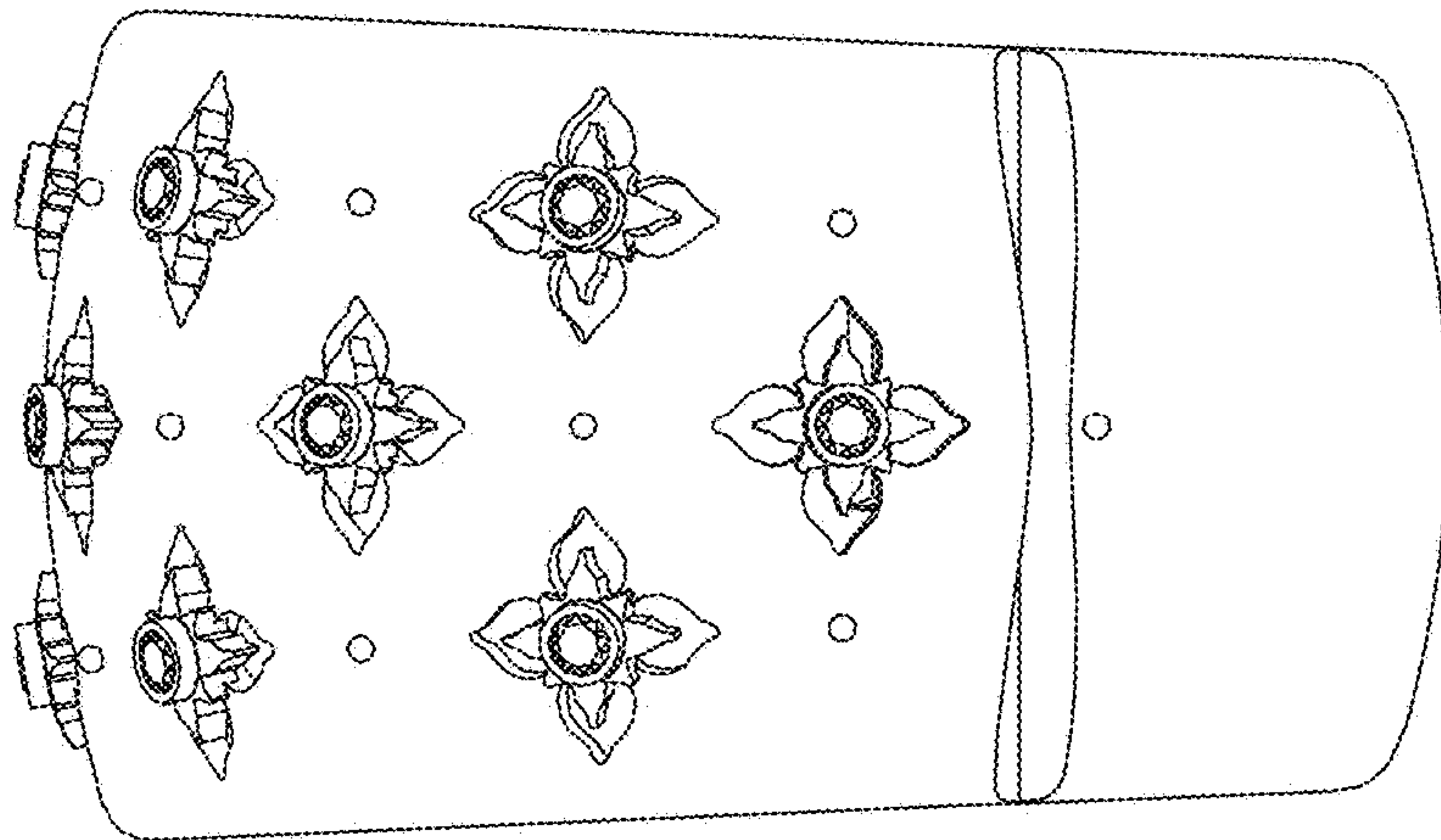

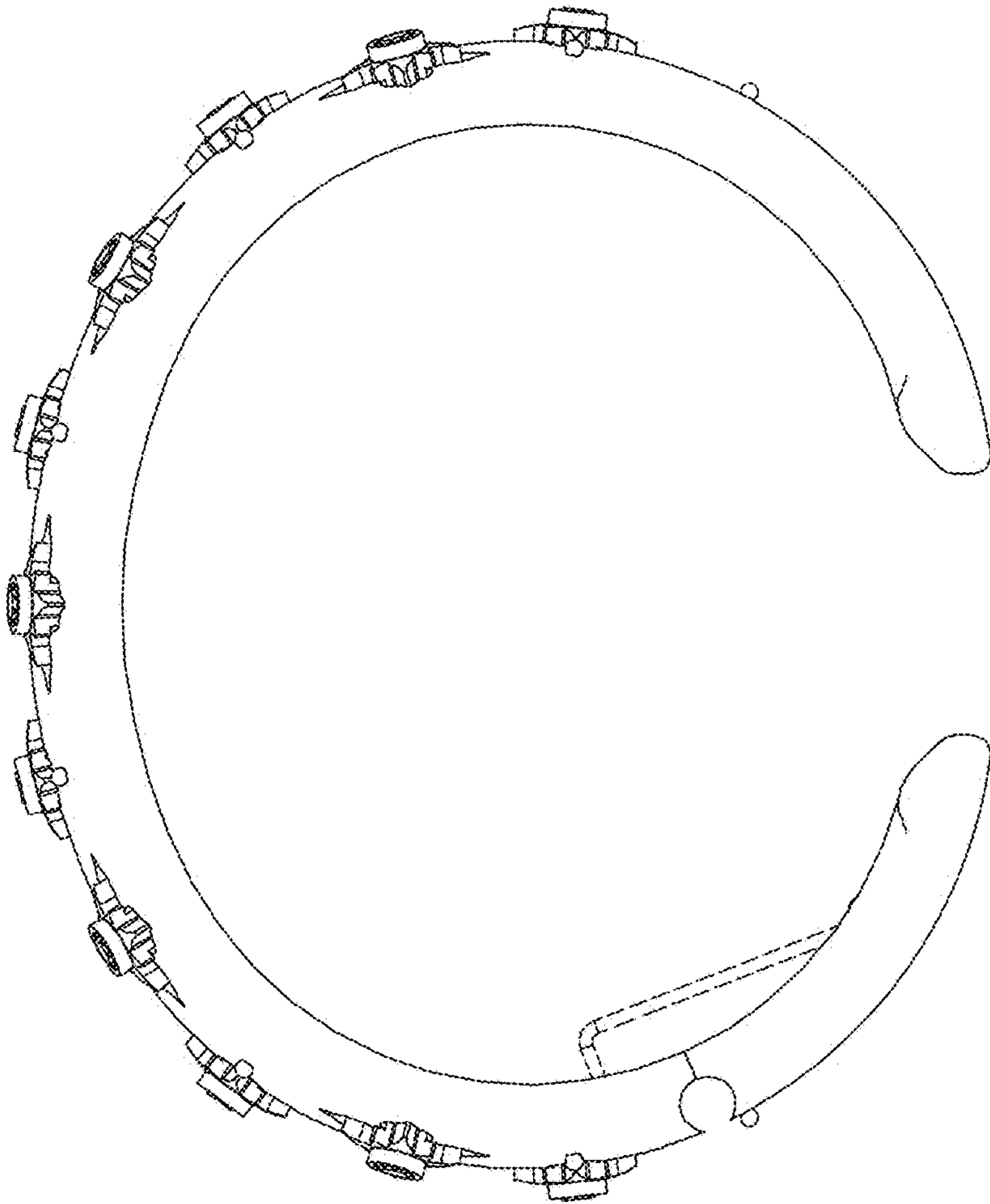

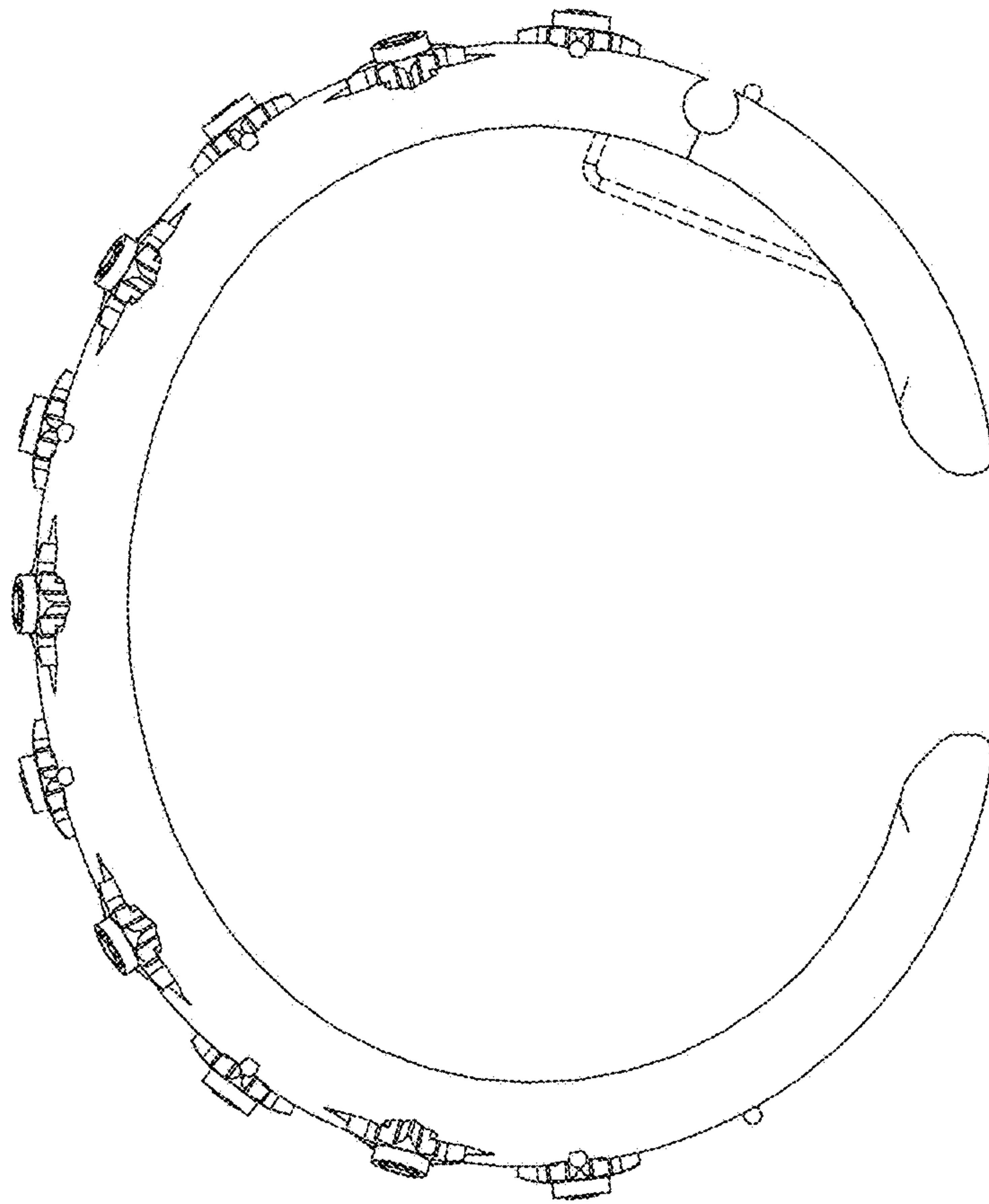

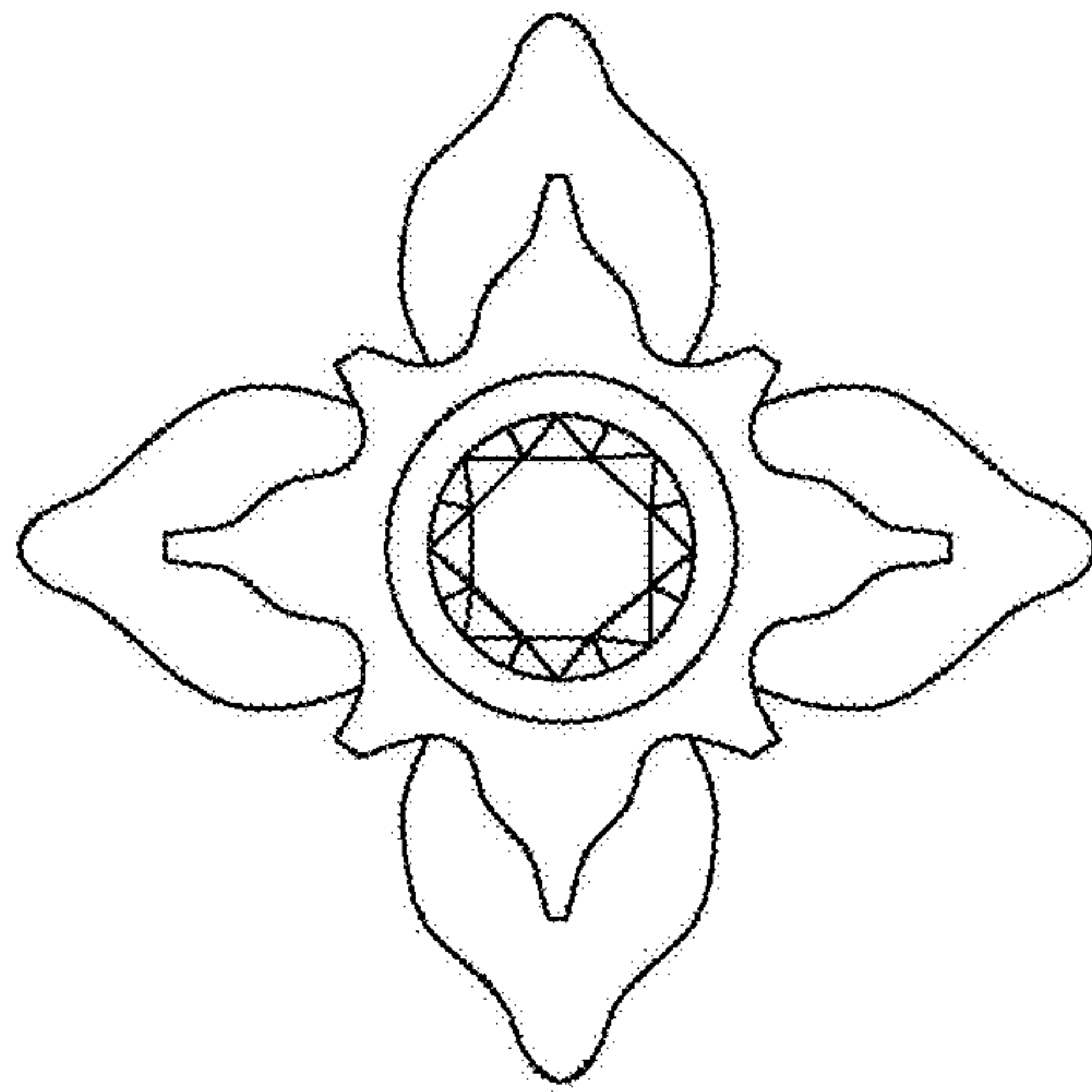
