**DESCRIPTION**

FIG. 1 is a front and left side perspective view of a wireless repeater showing our new design with features illustrated in broken lines for illustrative purposes and thus not constituting a part of the claimed design;  
FIG. 2 is a back and right perspective view of the wireless repeater of FIG. 1;  
FIG. 3 is a left side elevational view of the wireless repeater of FIG. 1;  
FIG. 4 is a right side elevational view of the wireless repeater of FIG. 1;  
FIG. 5 is a front plan view of the wireless repeater of FIG. 1;  
FIG. 6 is a back plan view of the wireless repeater of FIG. 1;  
FIG. 7 is a bottom elevational view of the wireless repeater of FIG. 1; and,  
FIG. 8 is a top elevational view of the wireless repeater of FIG. 1.

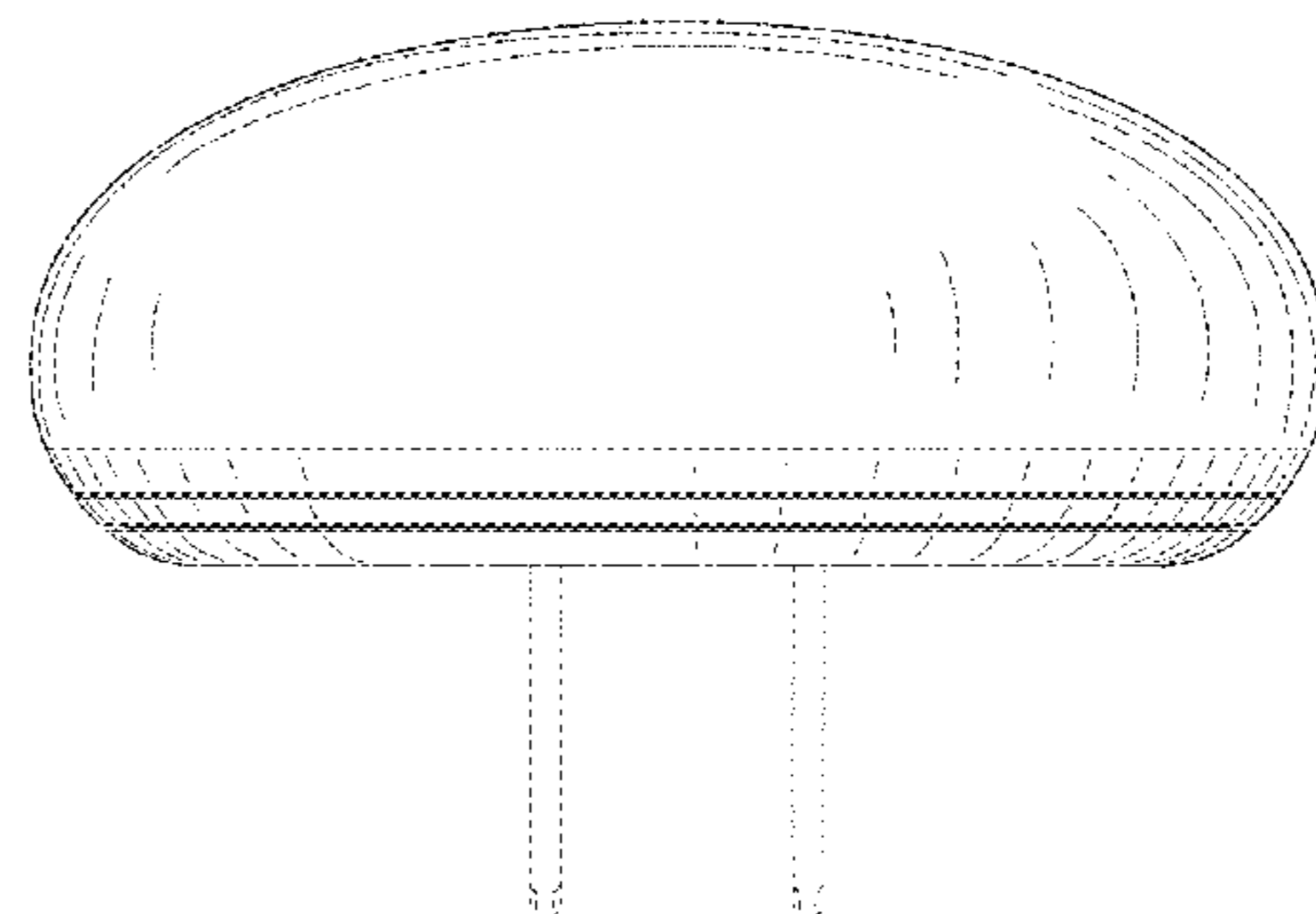
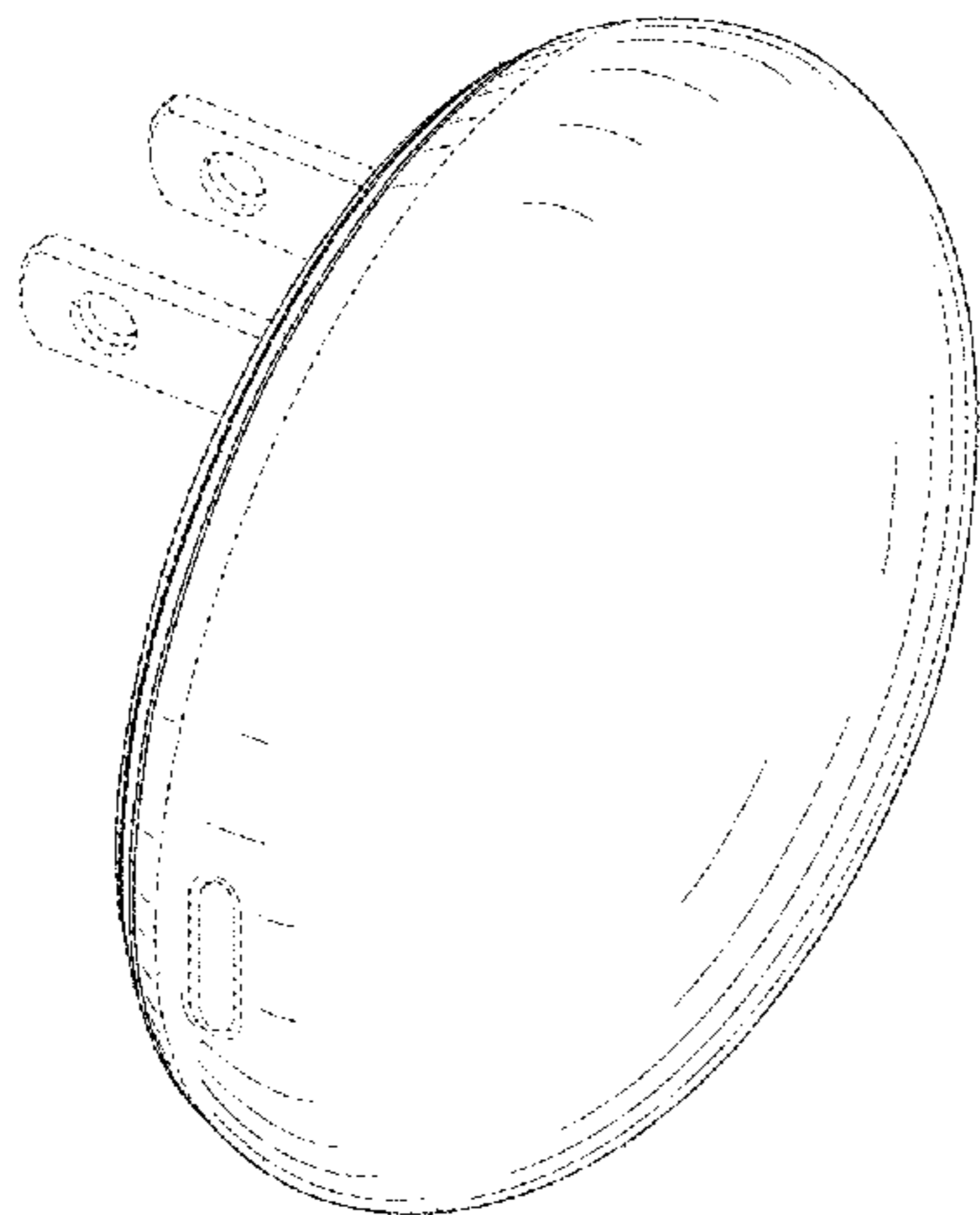

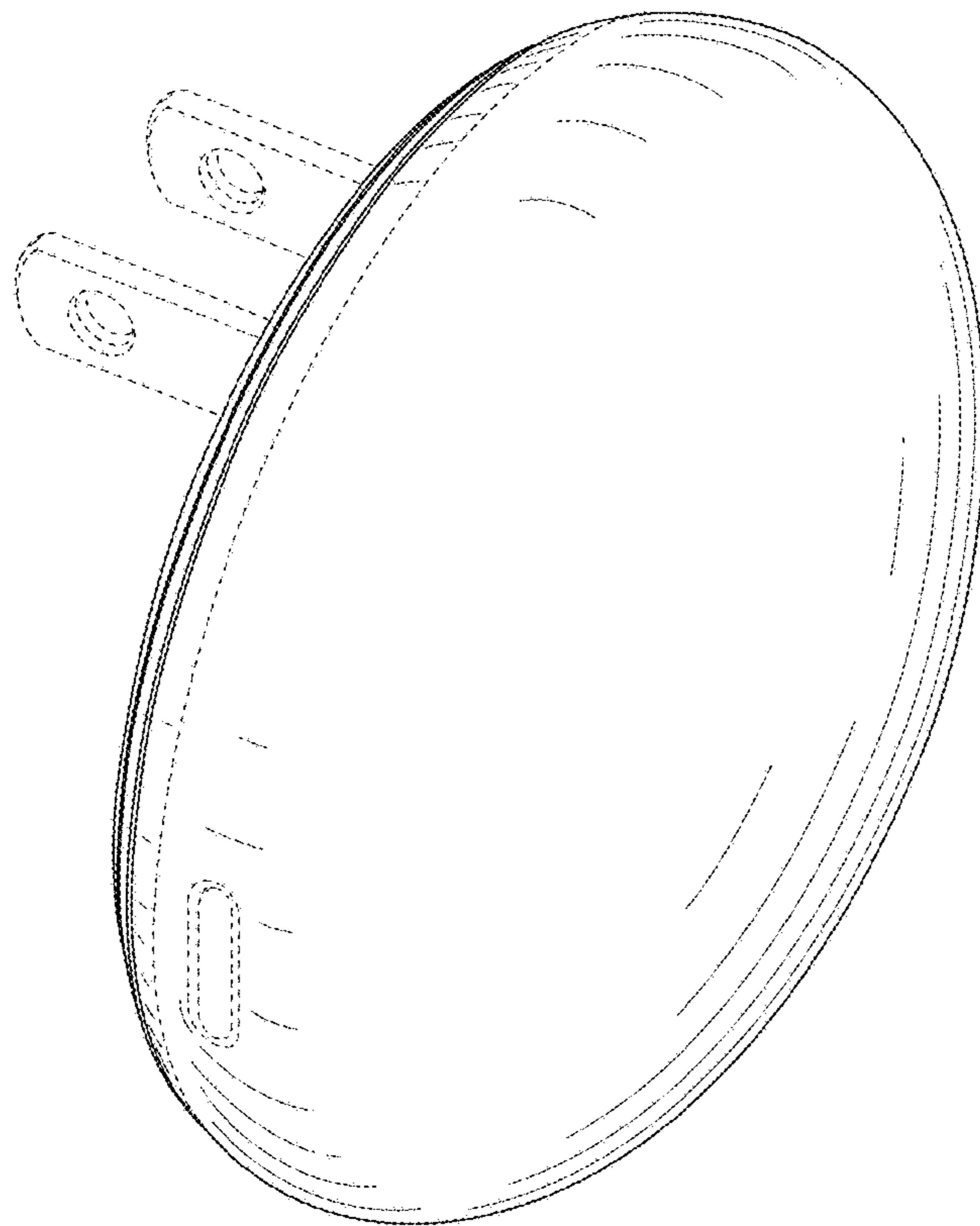

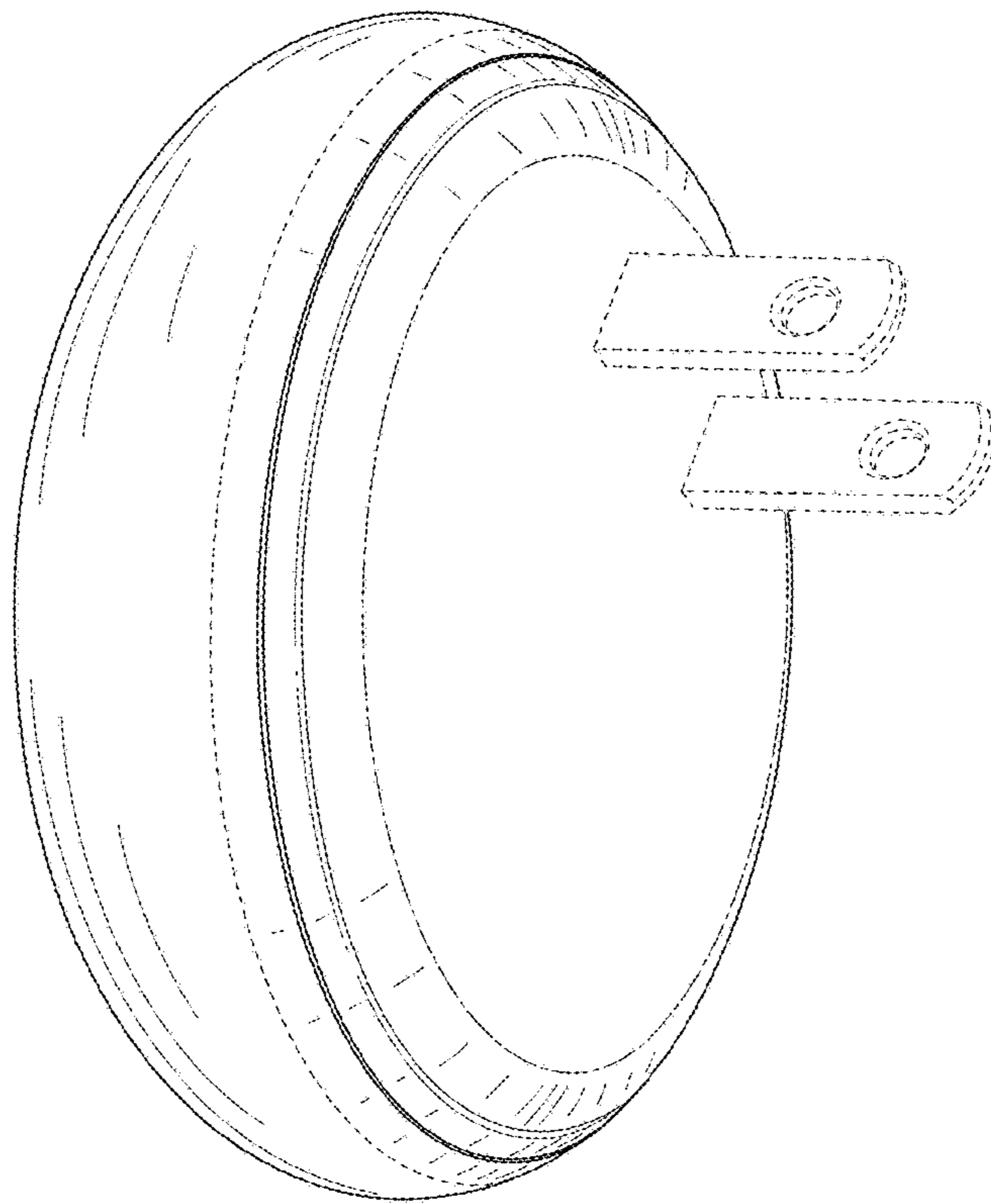

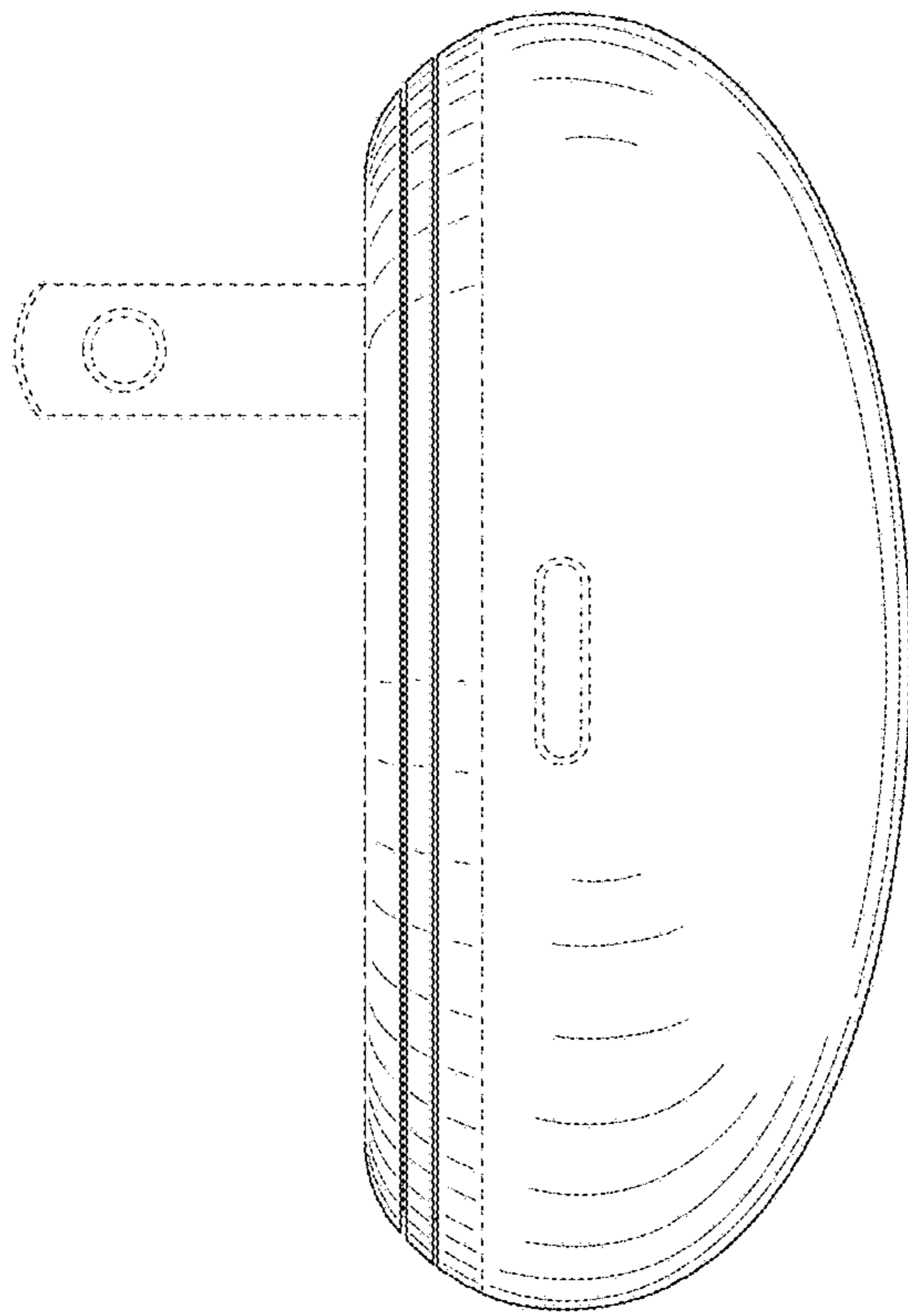

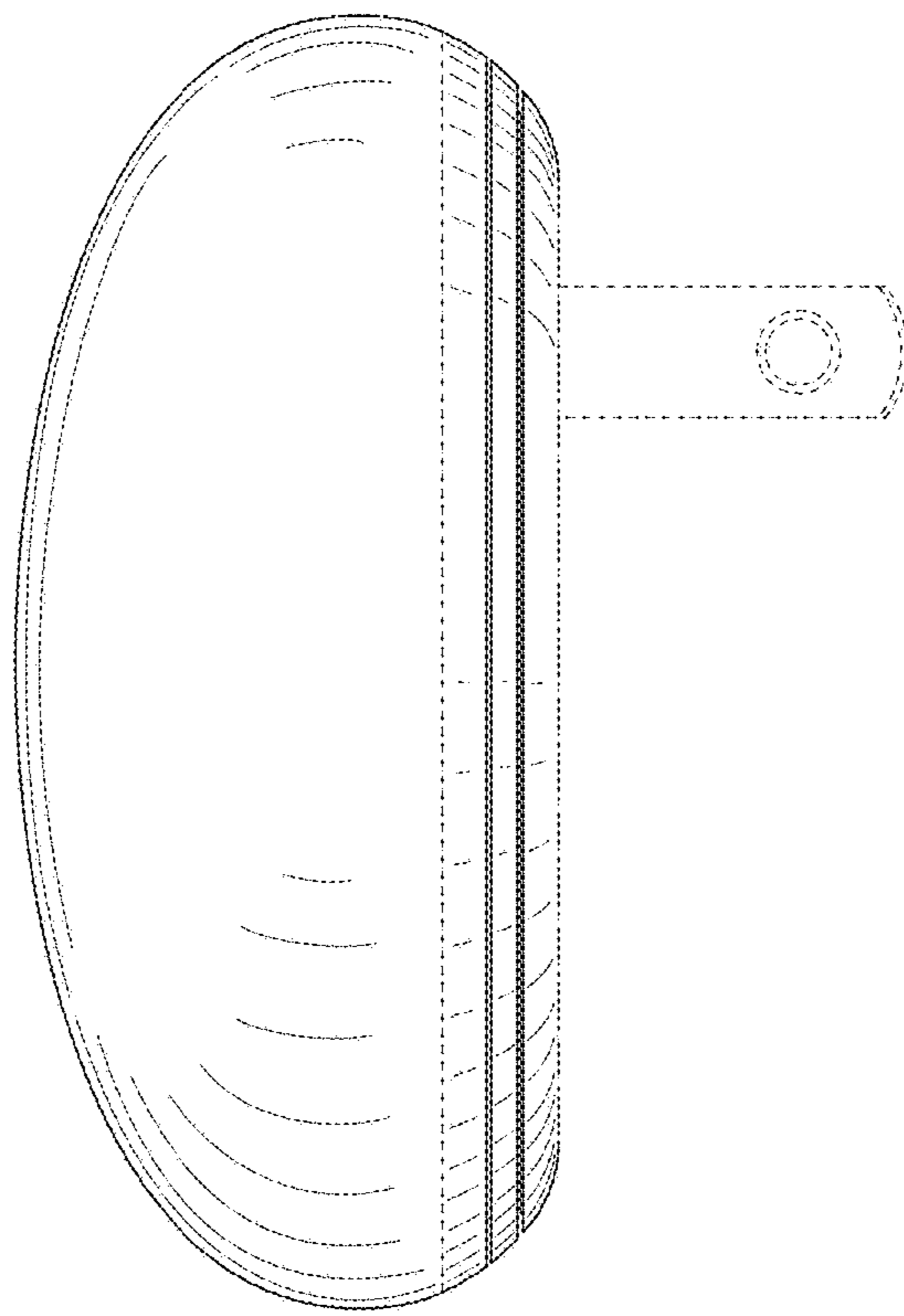

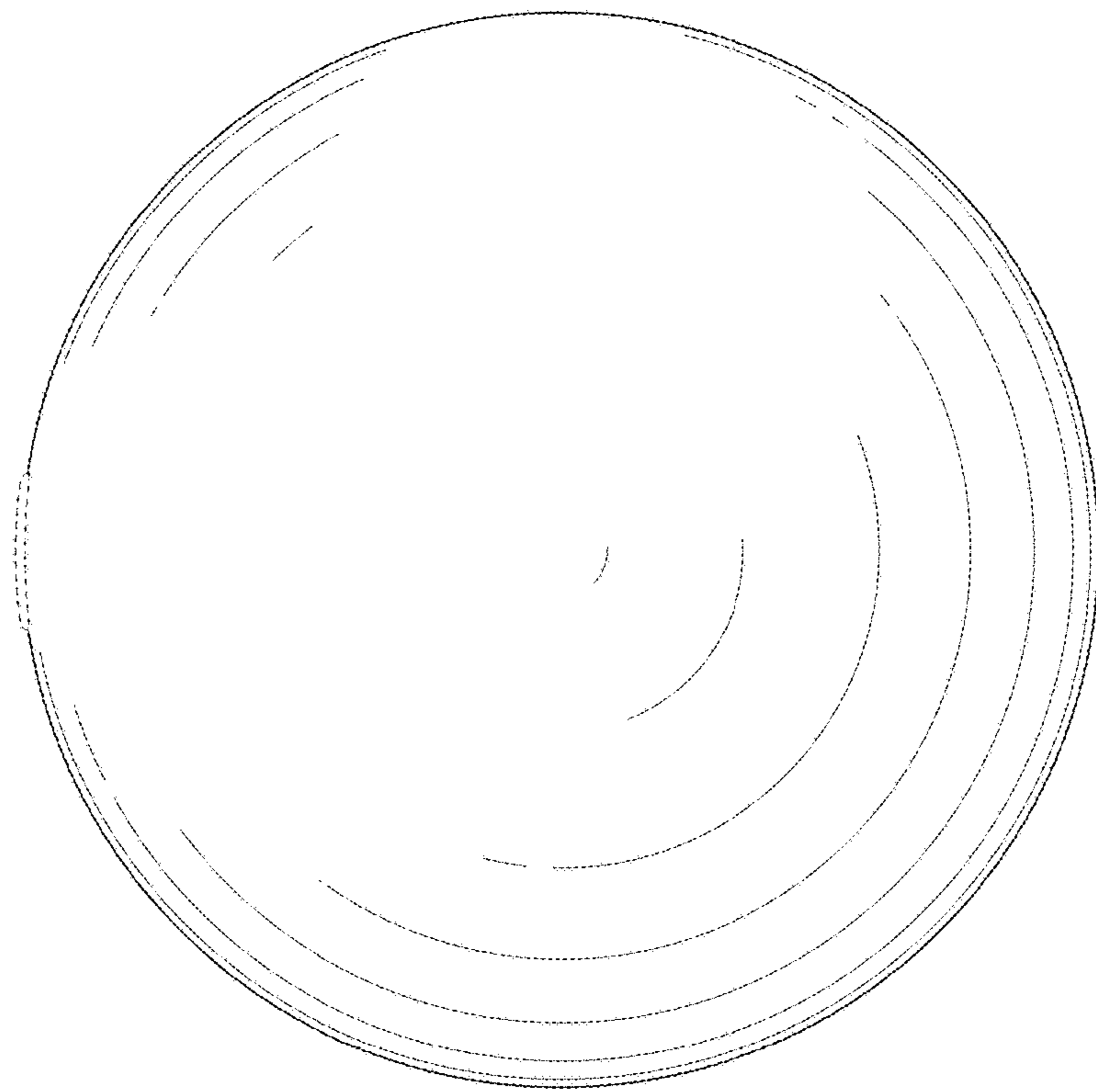

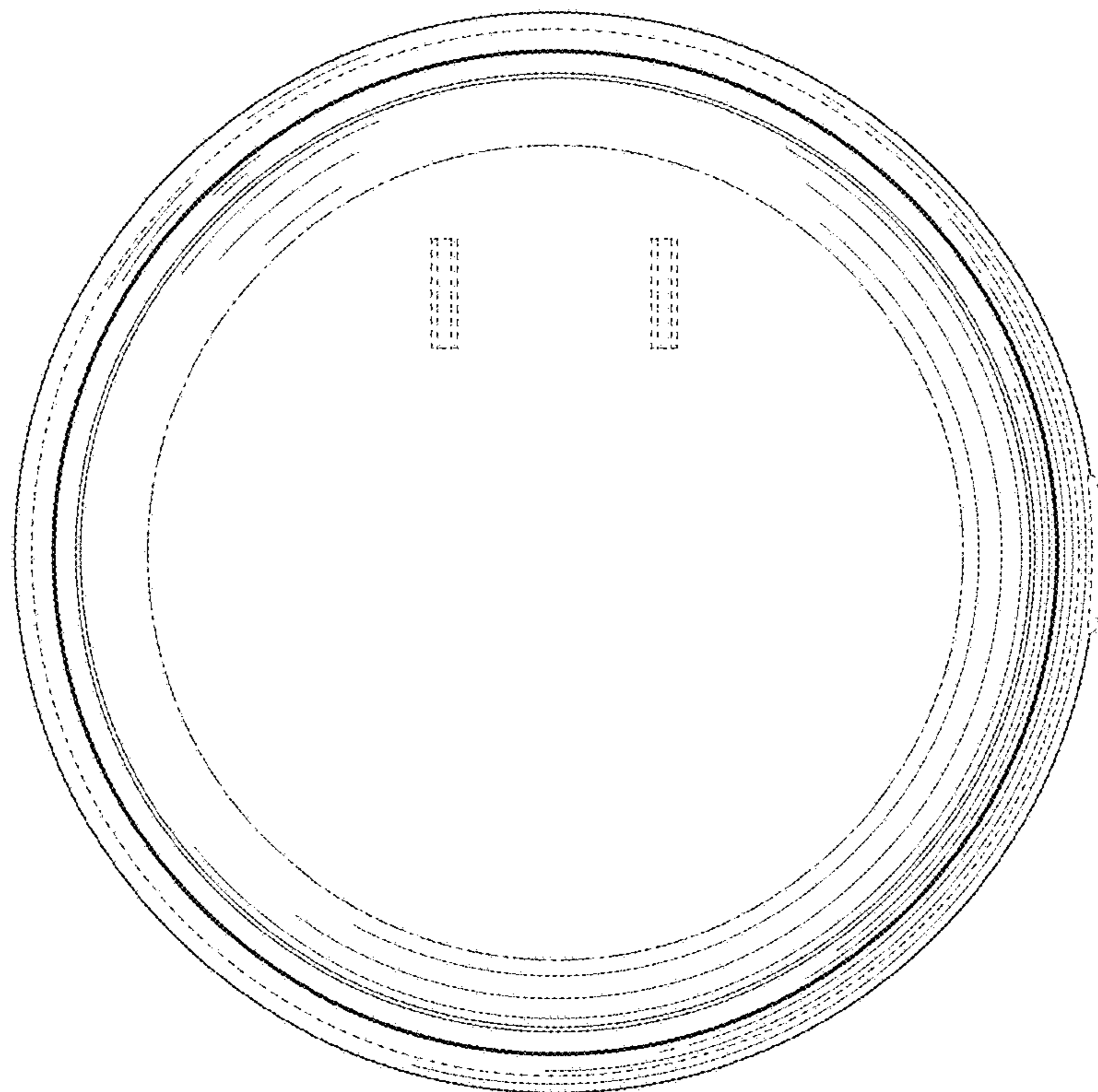

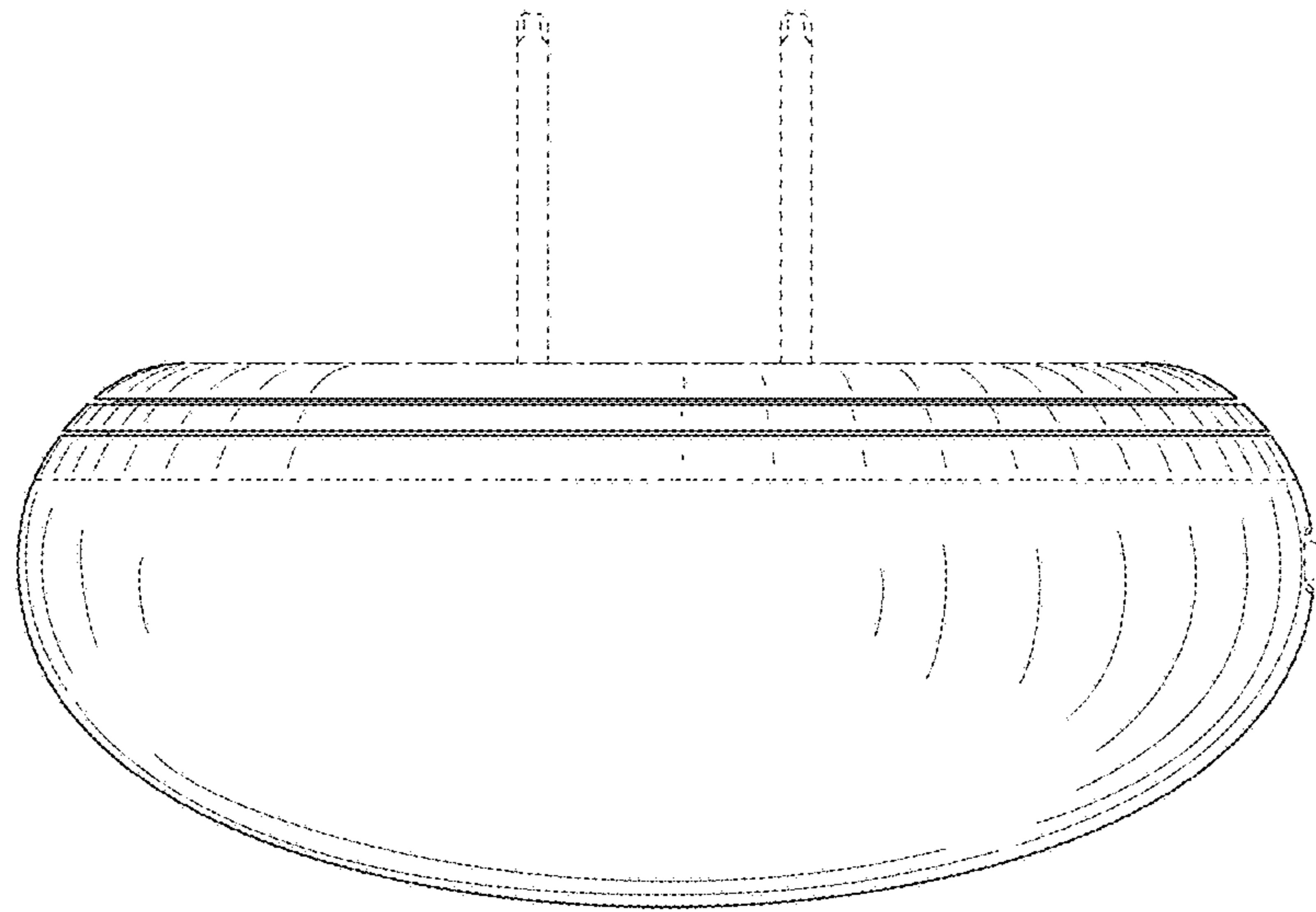

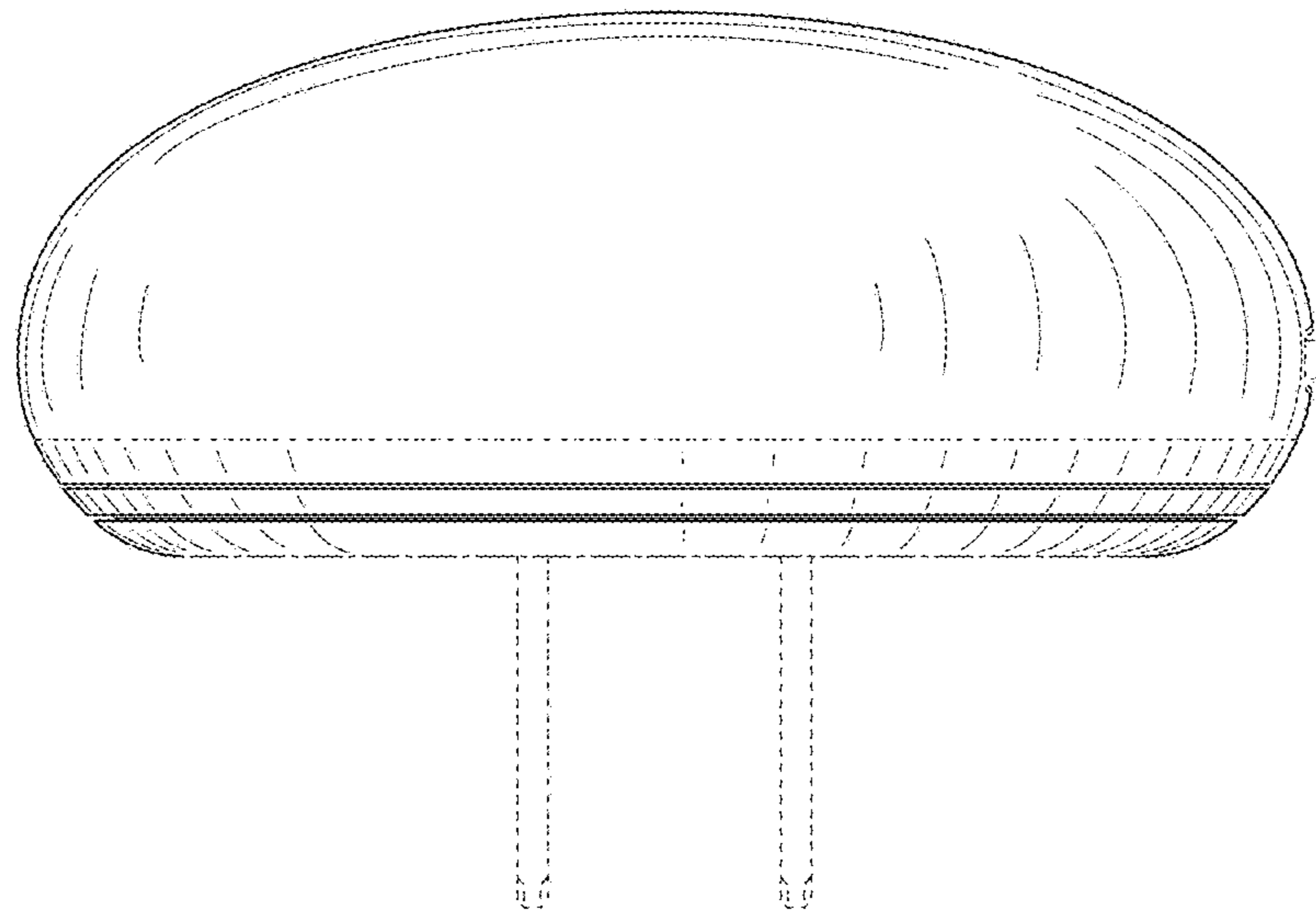
