FIG. 5 is a left-side elevational view thereof;

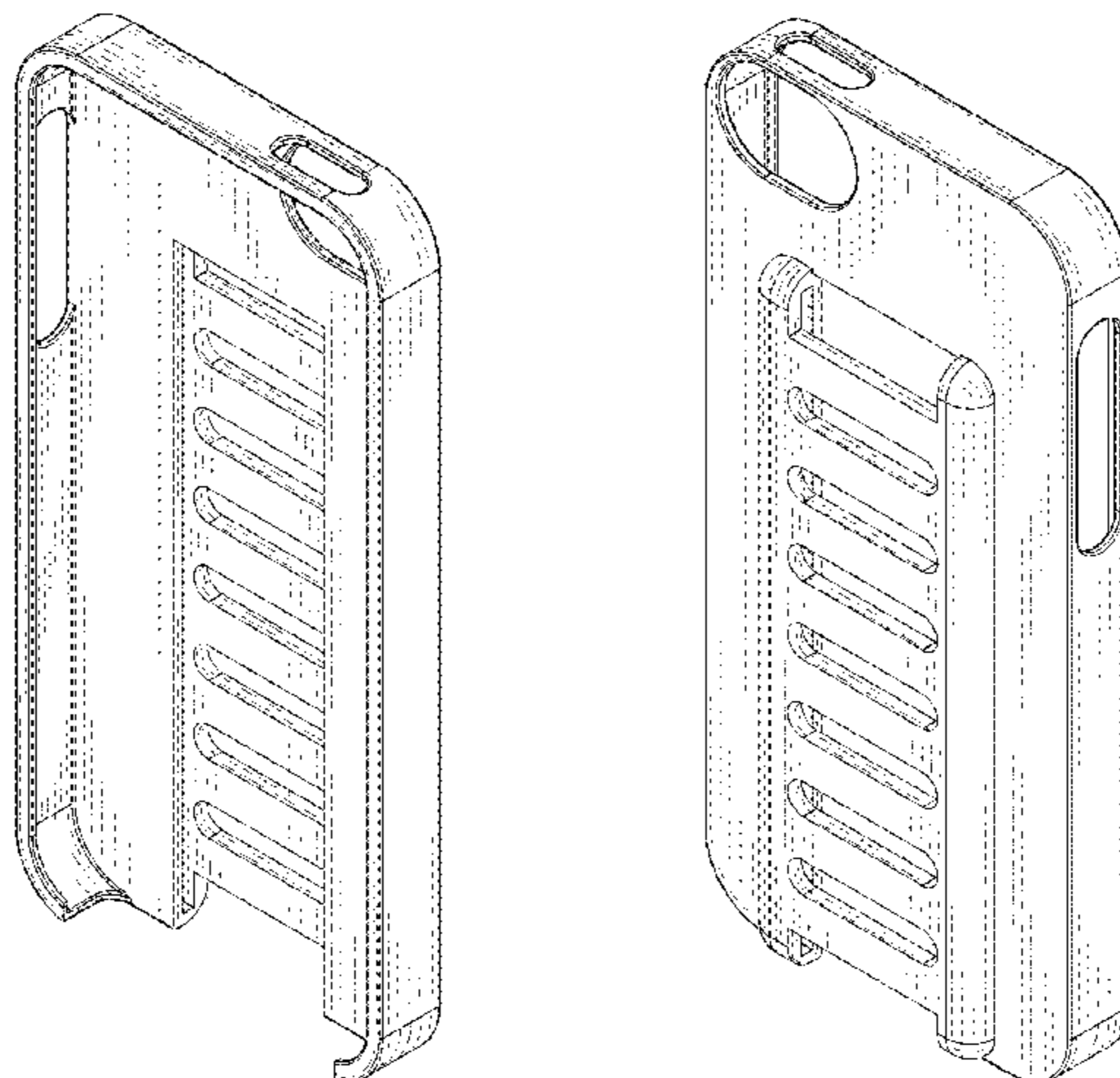
FIG. 6 is a top elevational view thereof;

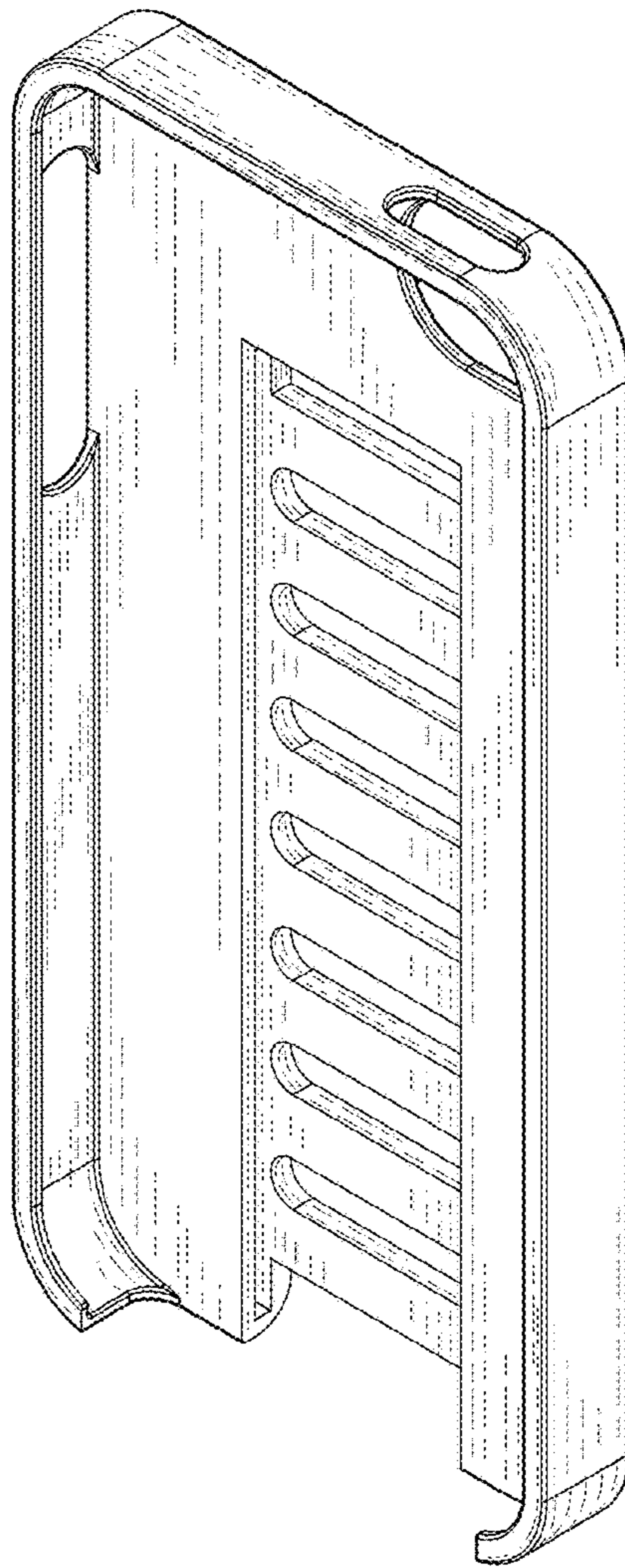

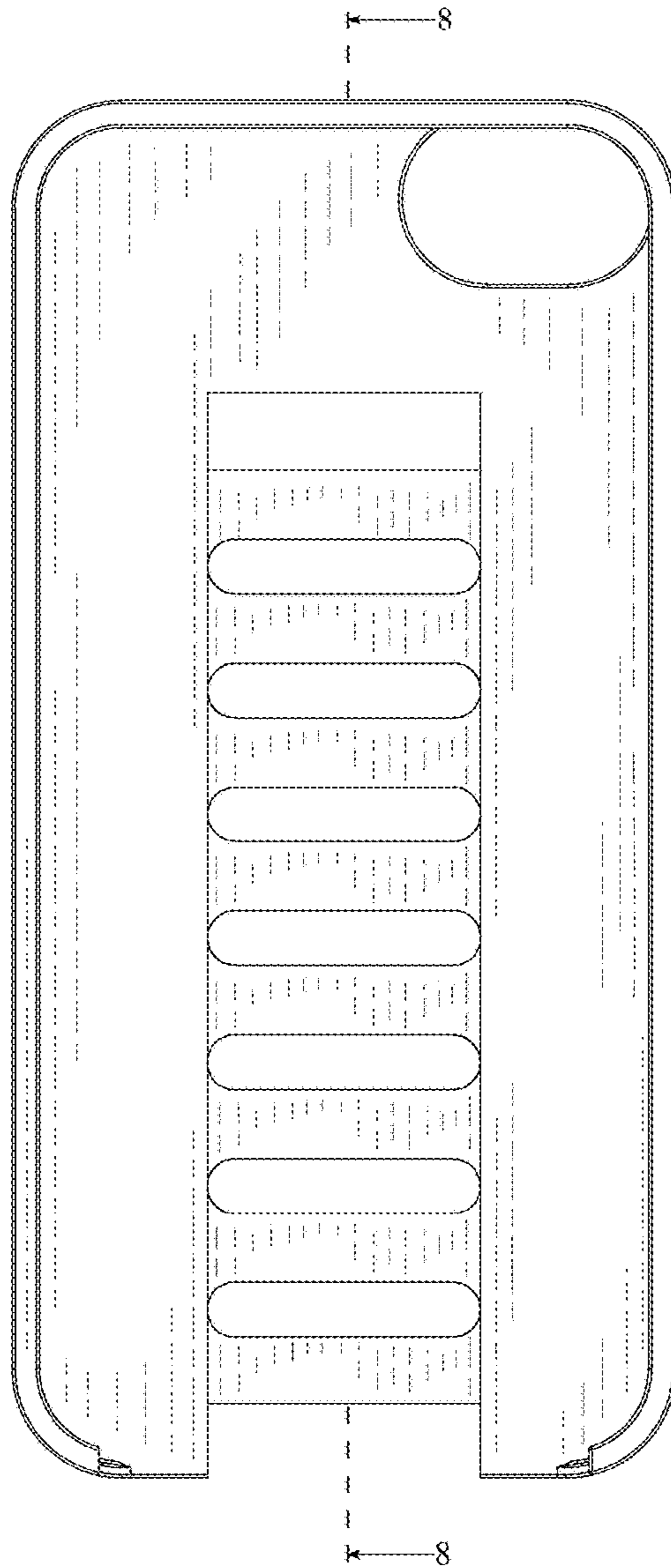

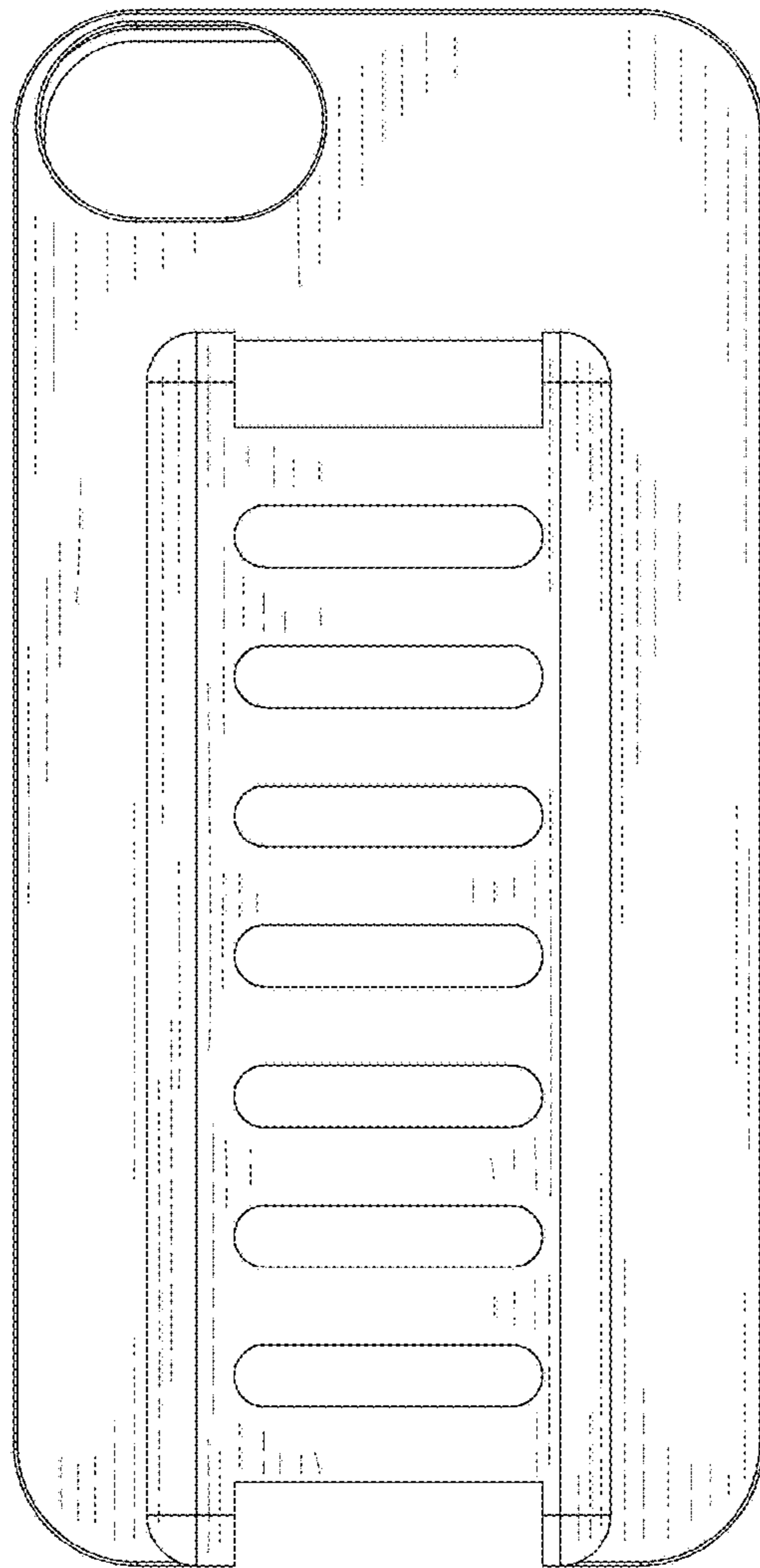

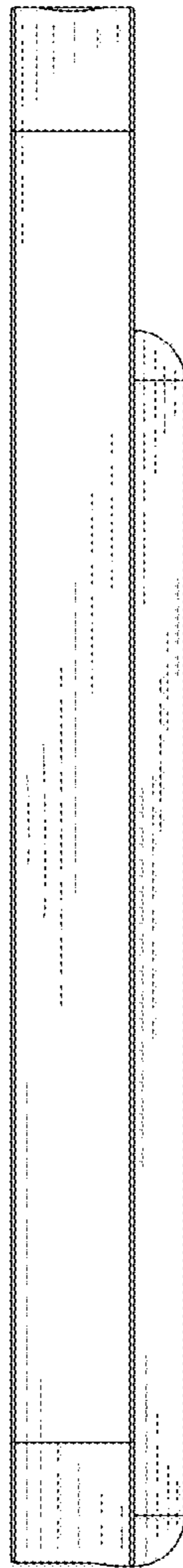

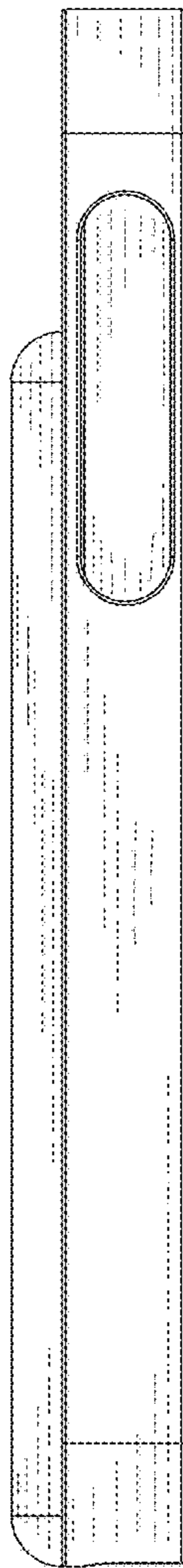

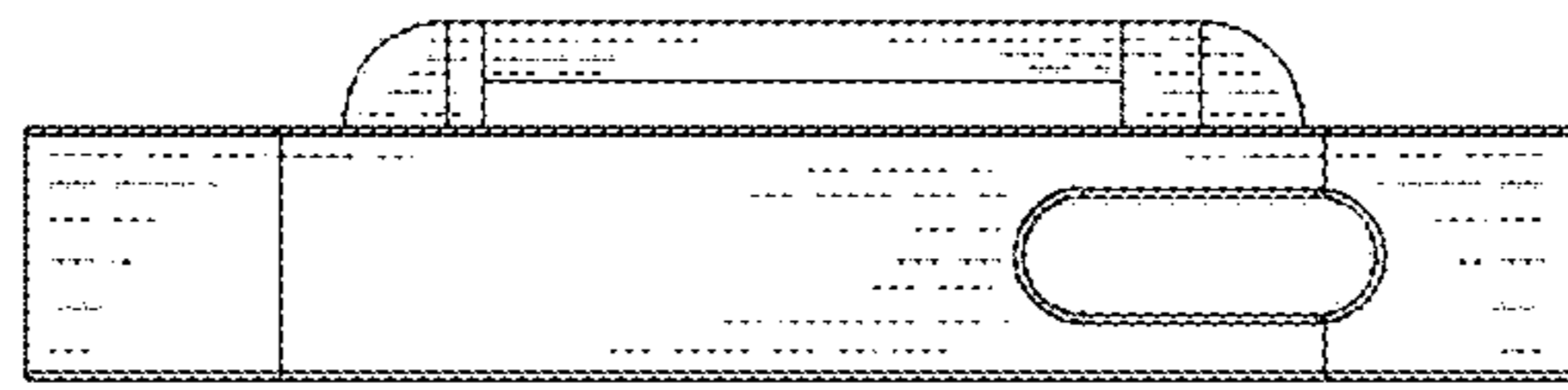

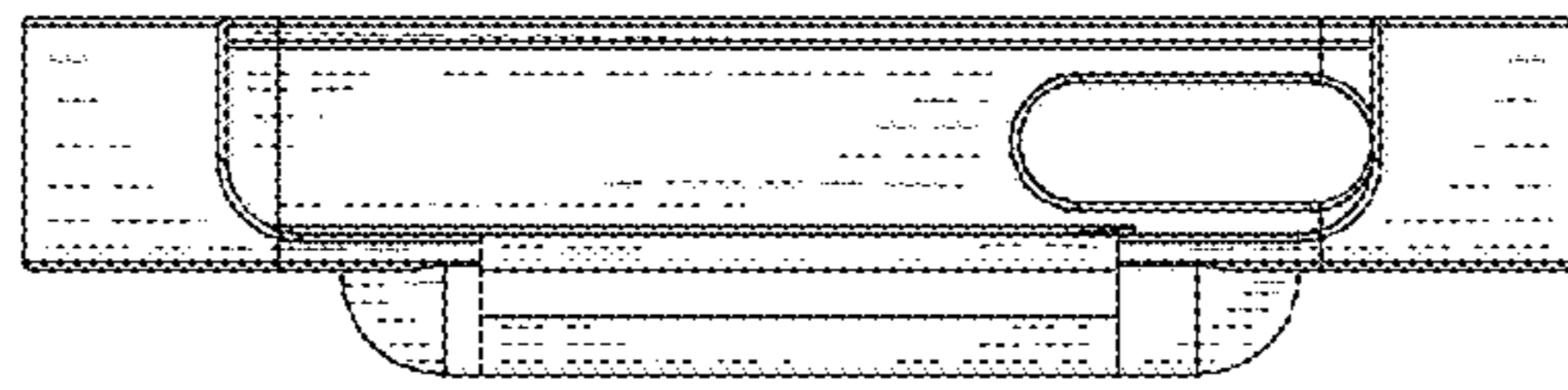

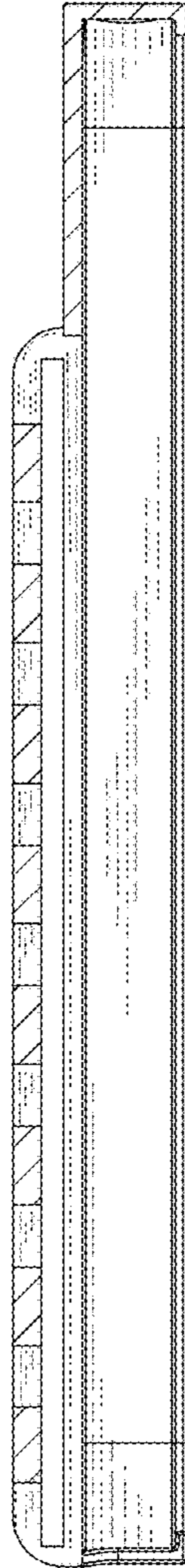

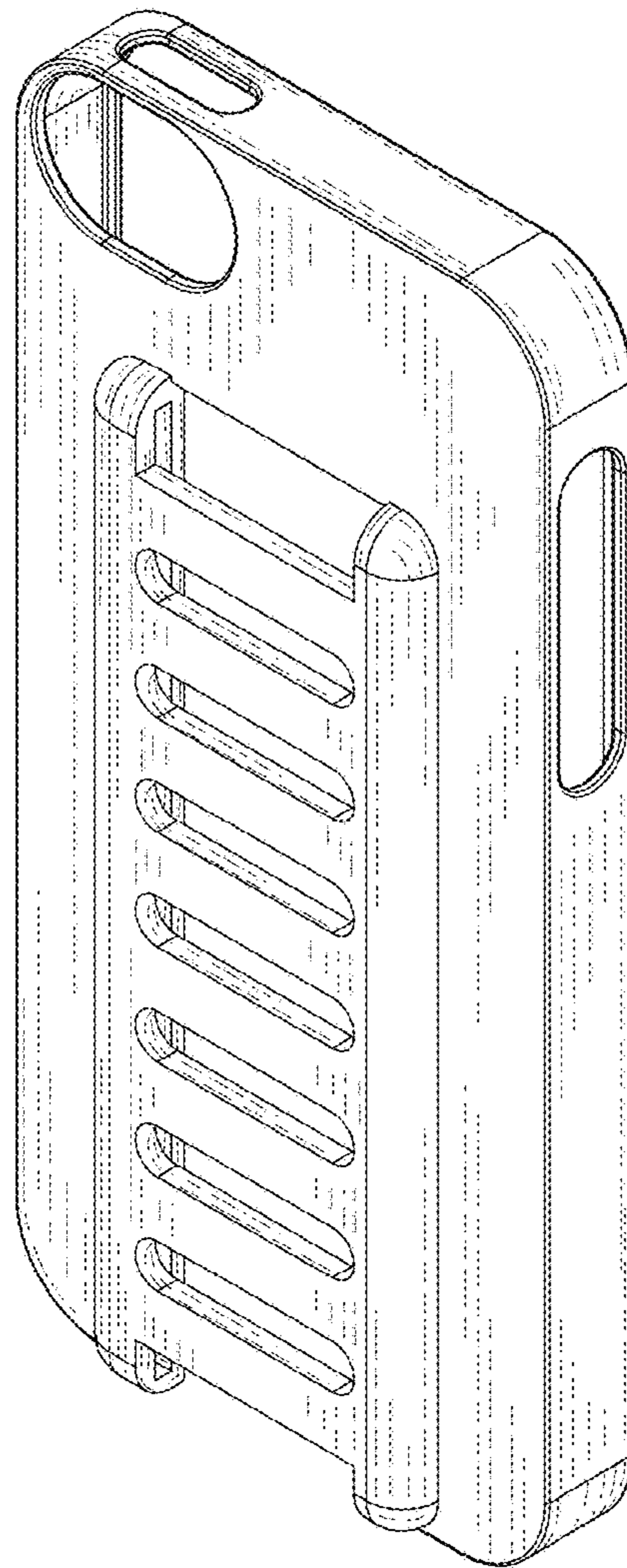
