The ornamental design for a pump, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of the pump; FIG. 2 is a right side perspective view thereof; FIG. 3 is a top perspective view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a left side elevation view thereof; and, FIG. 9 is a right side elevation view thereof.
