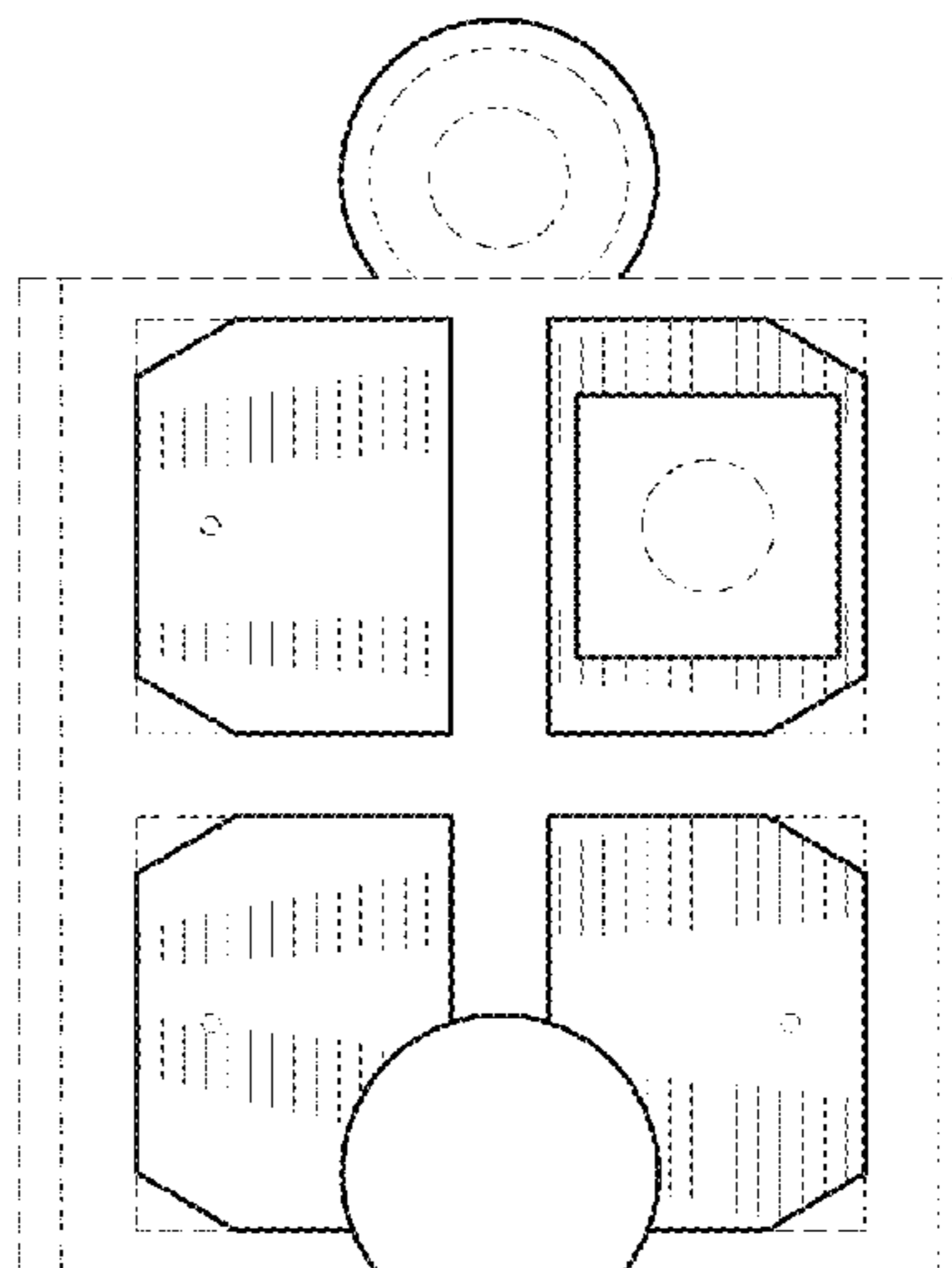
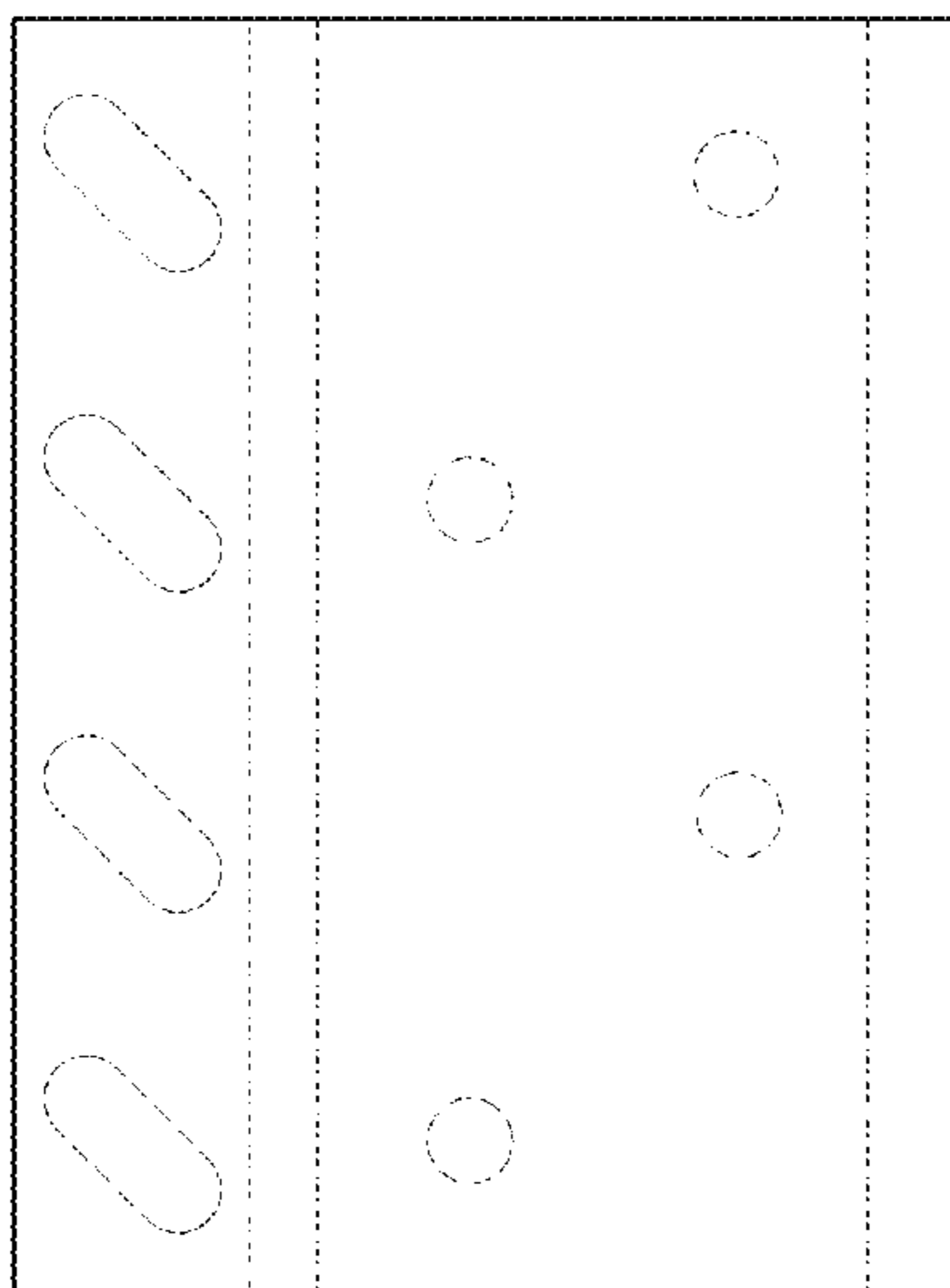
(57) **CLAIM**

I claim the ornamental design for a sign assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view for a sign assembly, showing my new design in an assembled configuration.

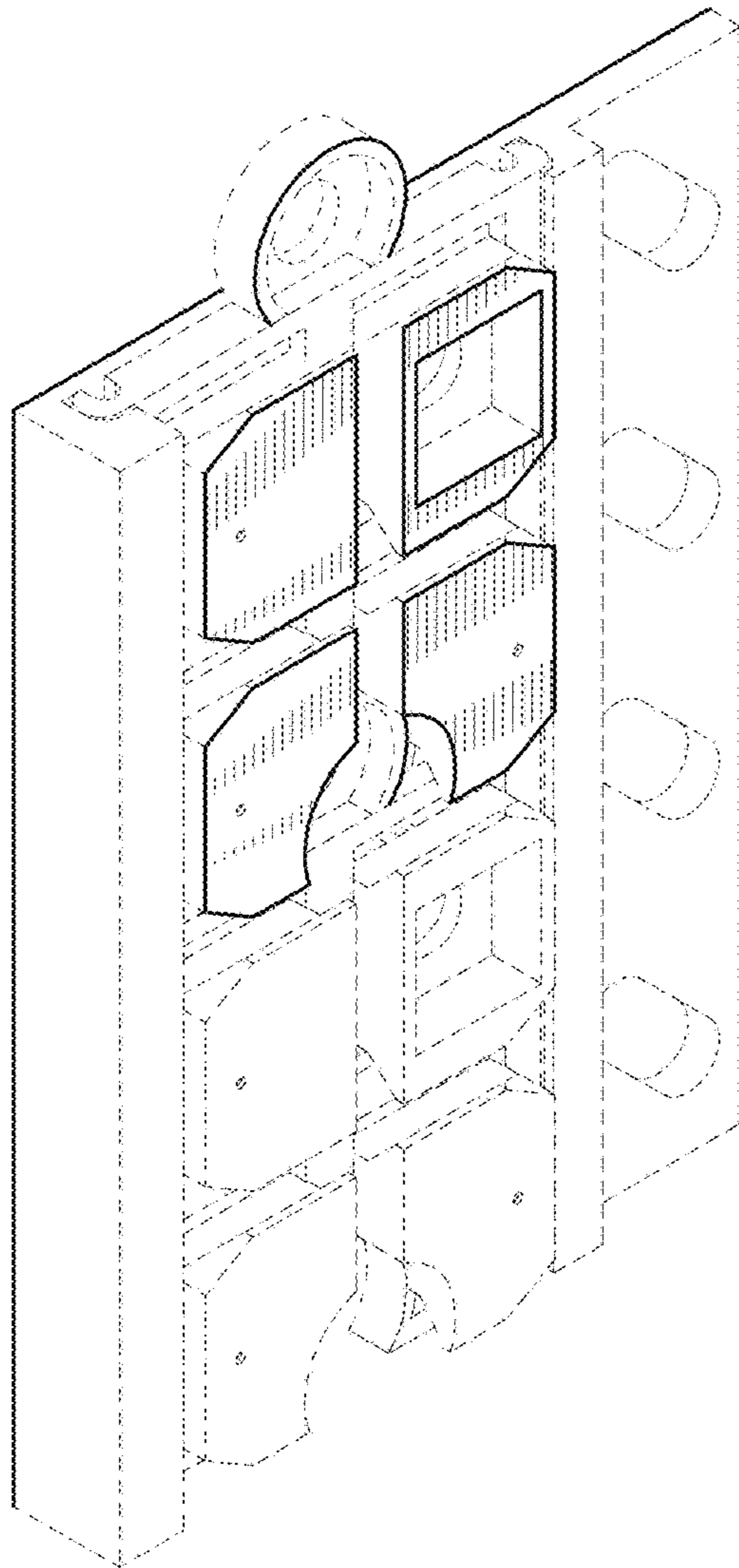

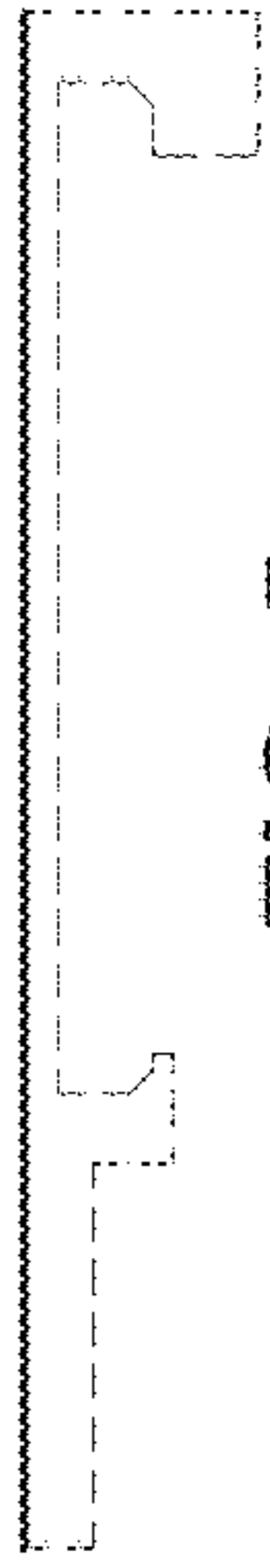

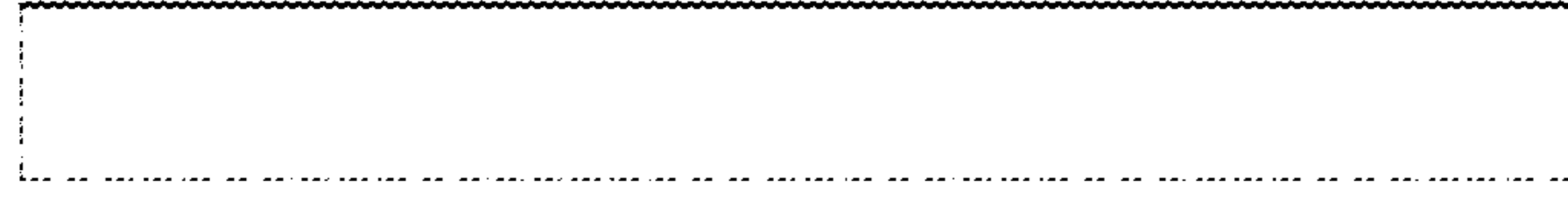

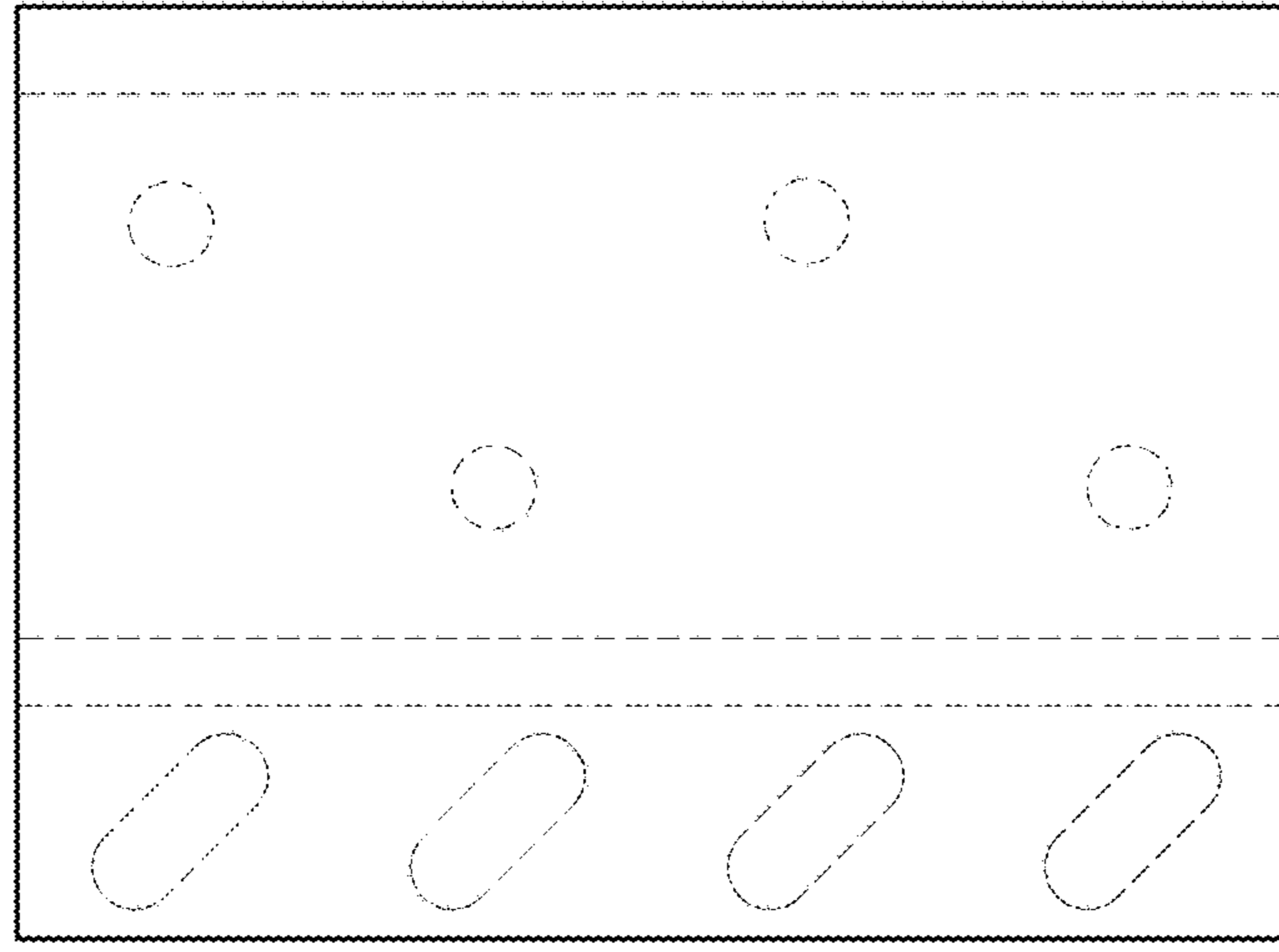

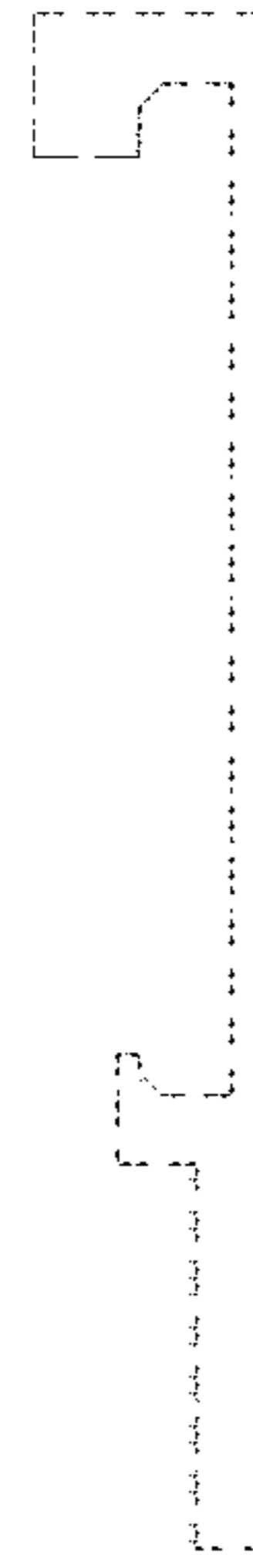

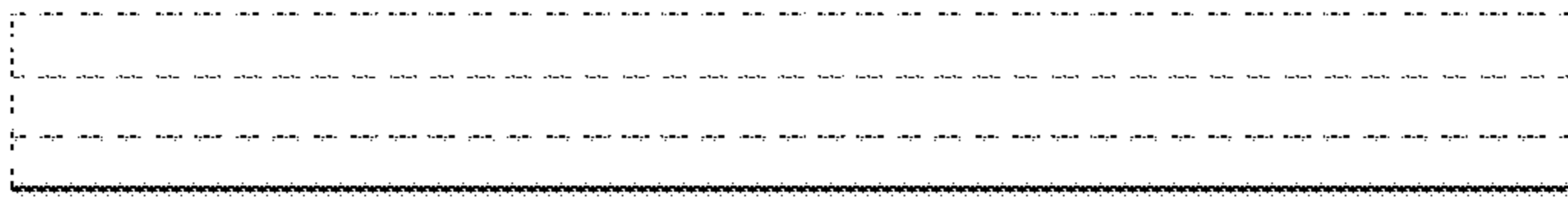

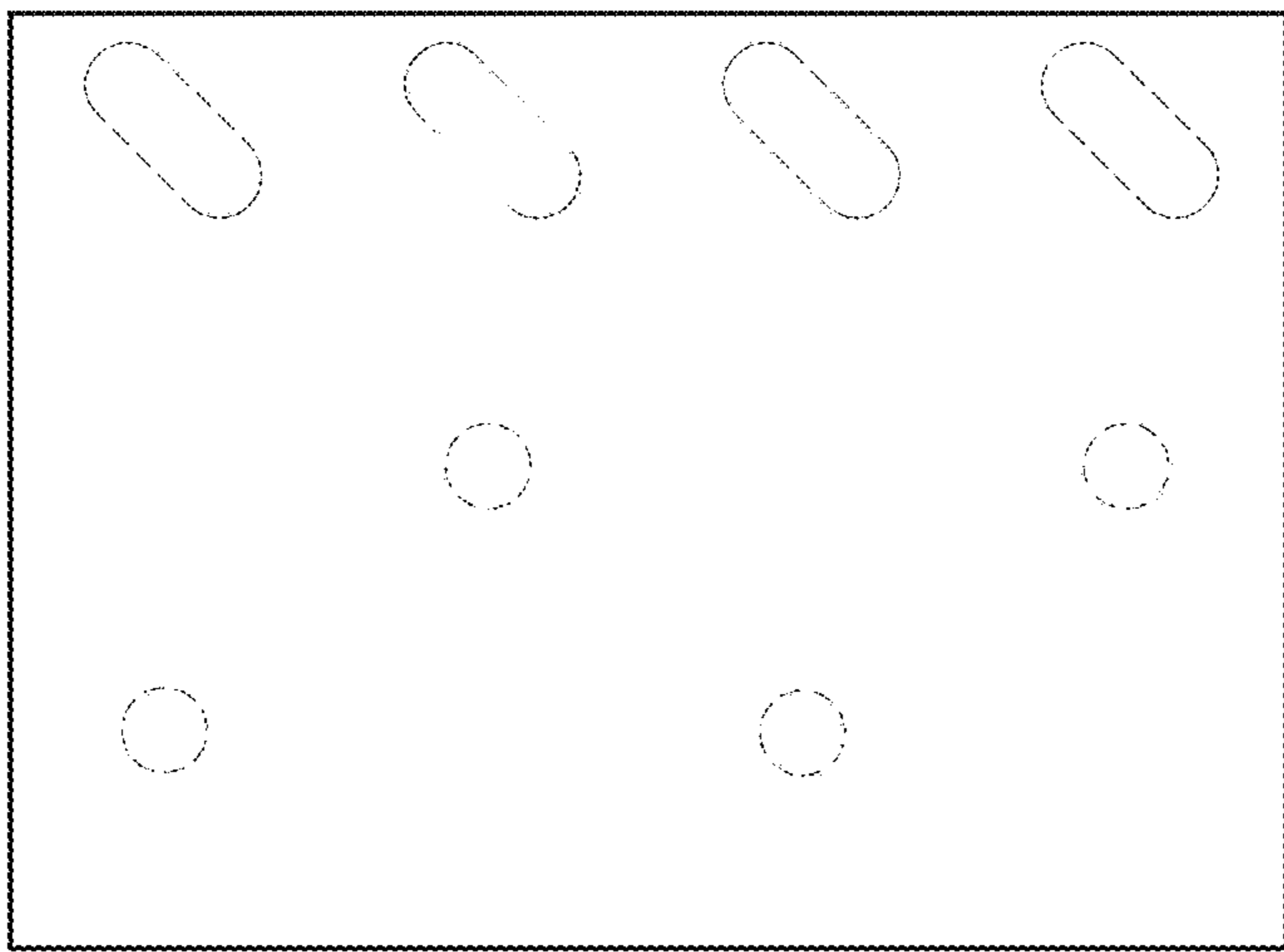

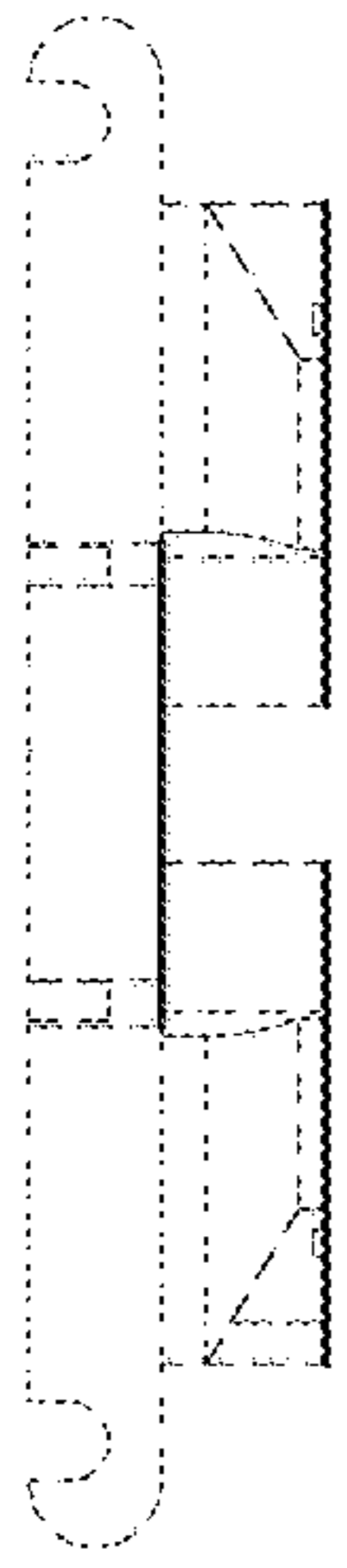

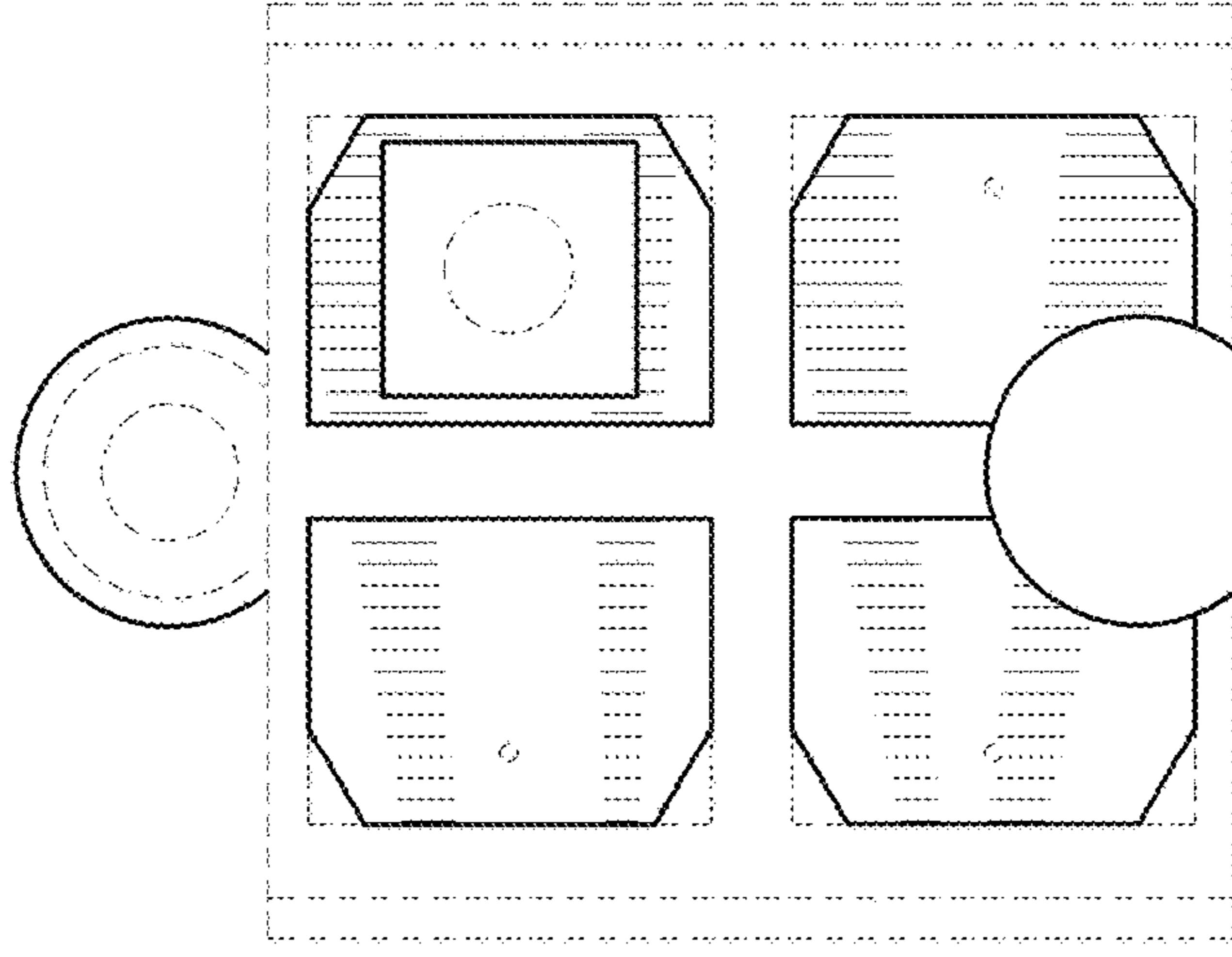

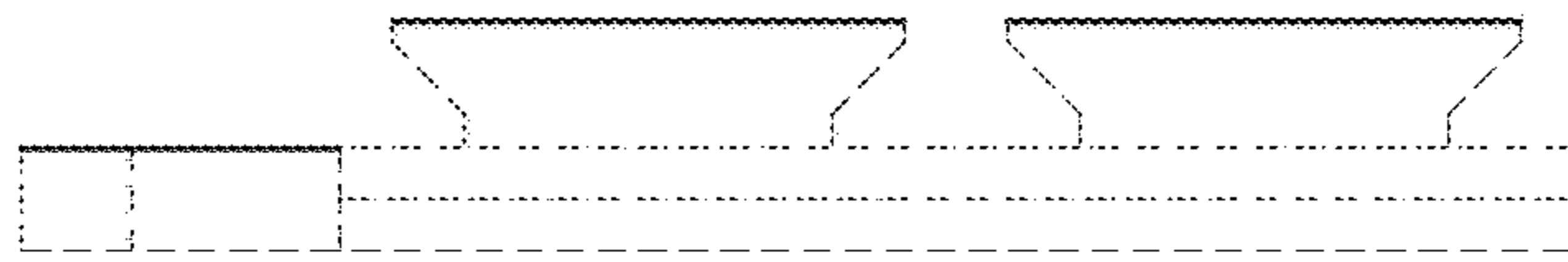

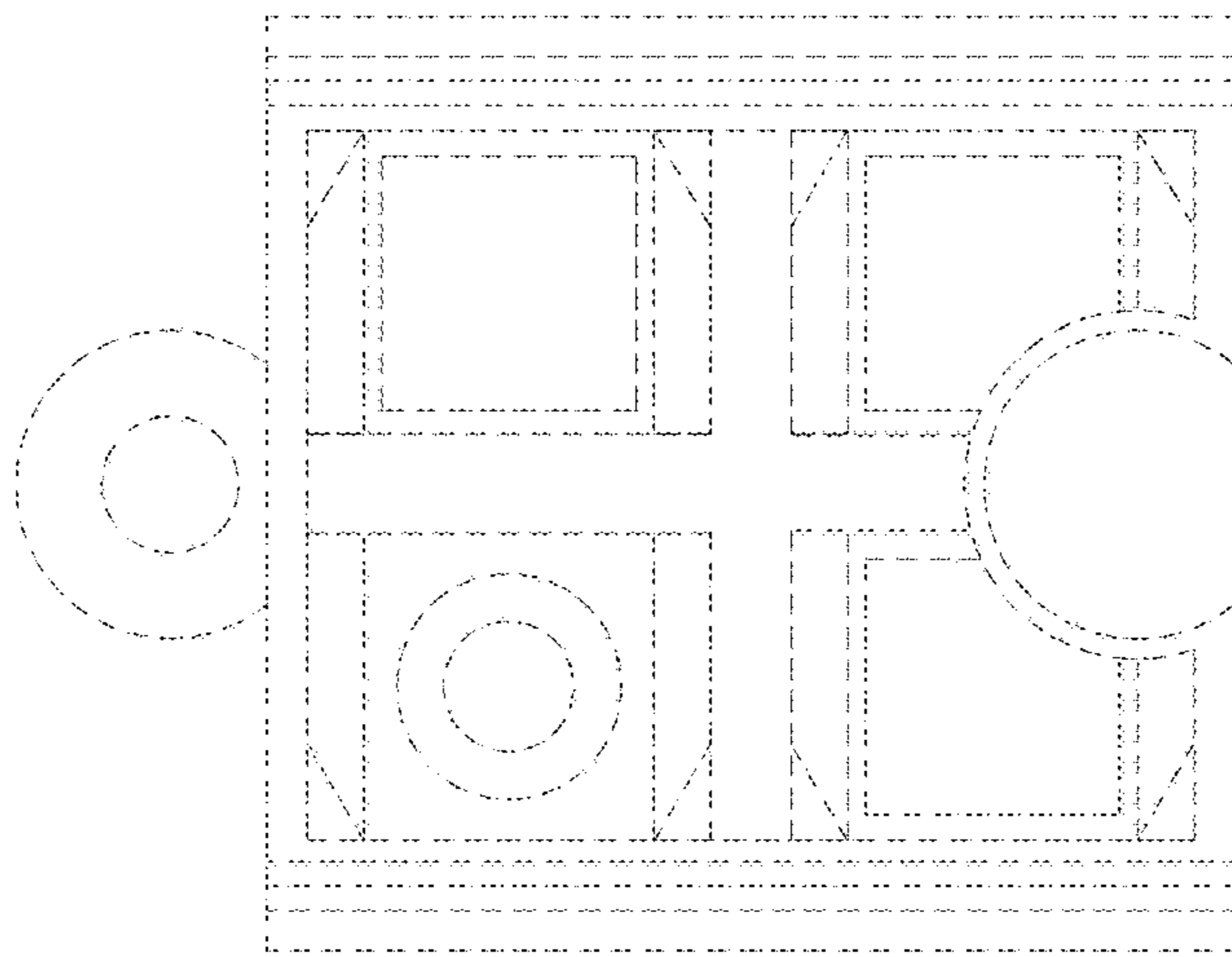

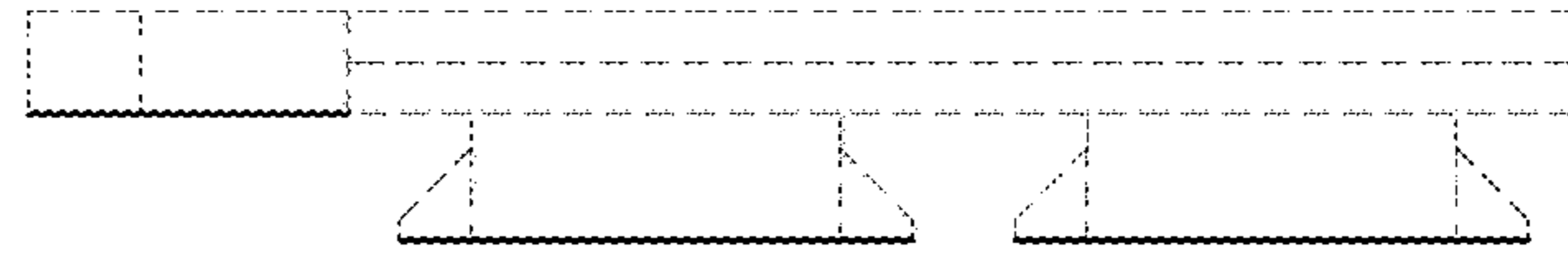

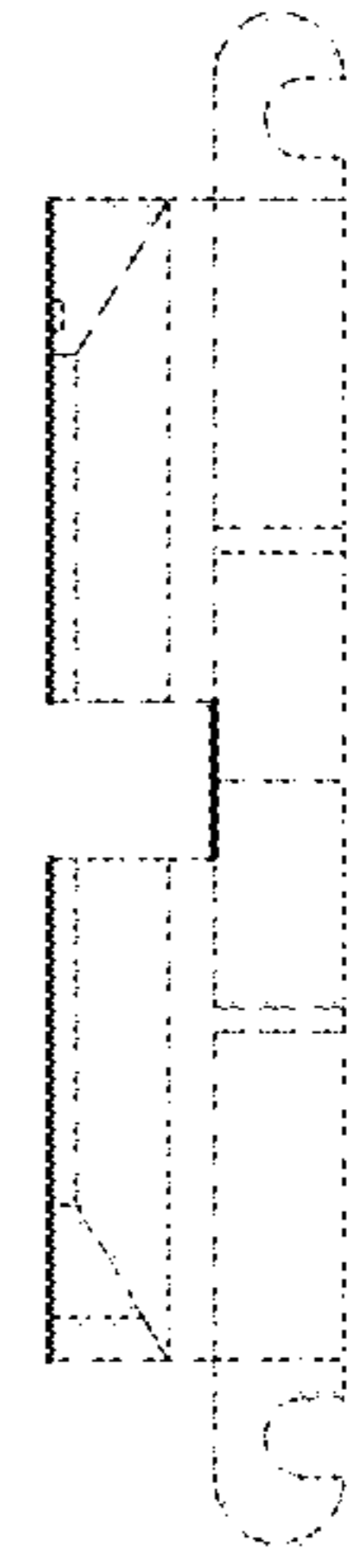

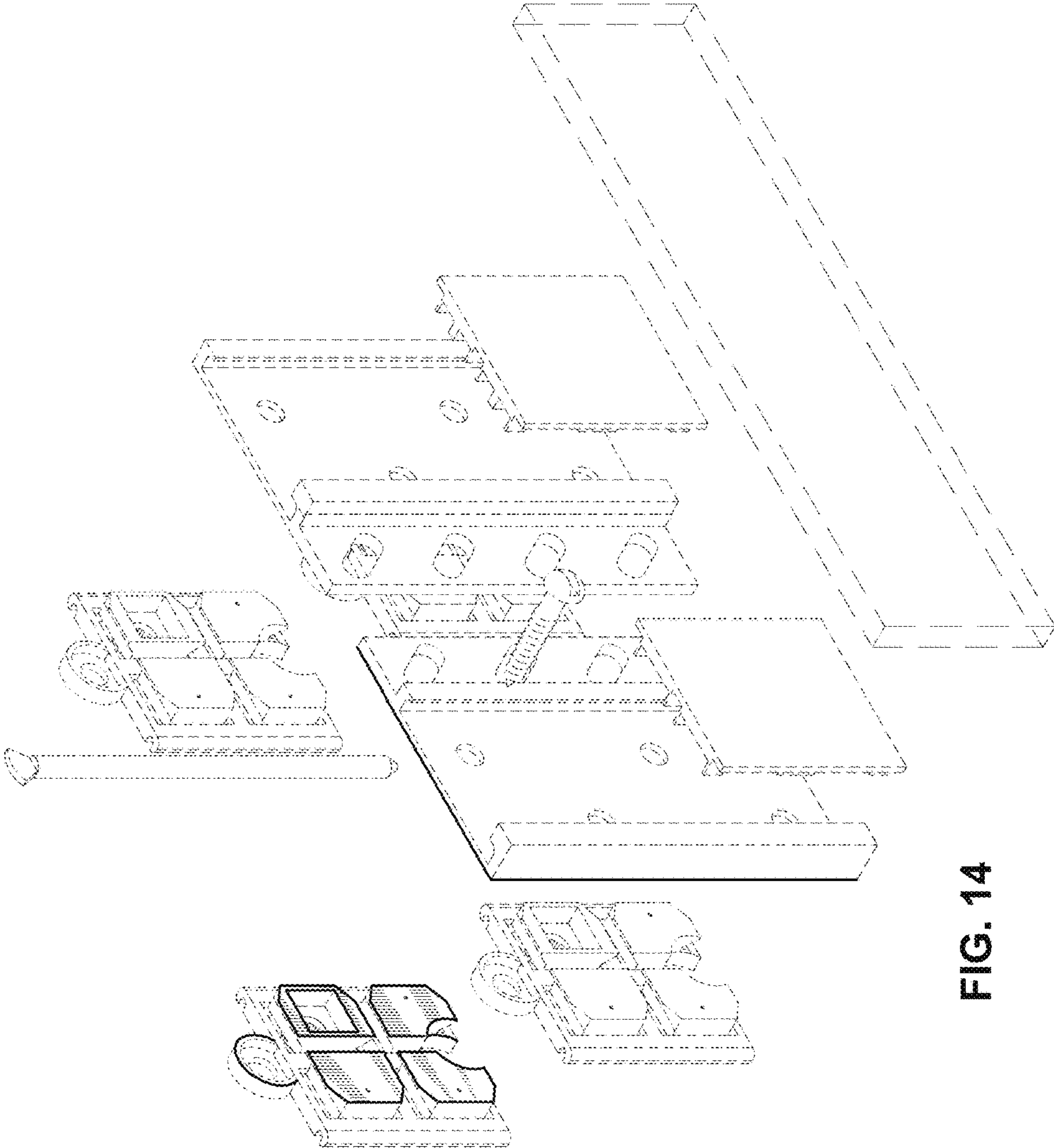
