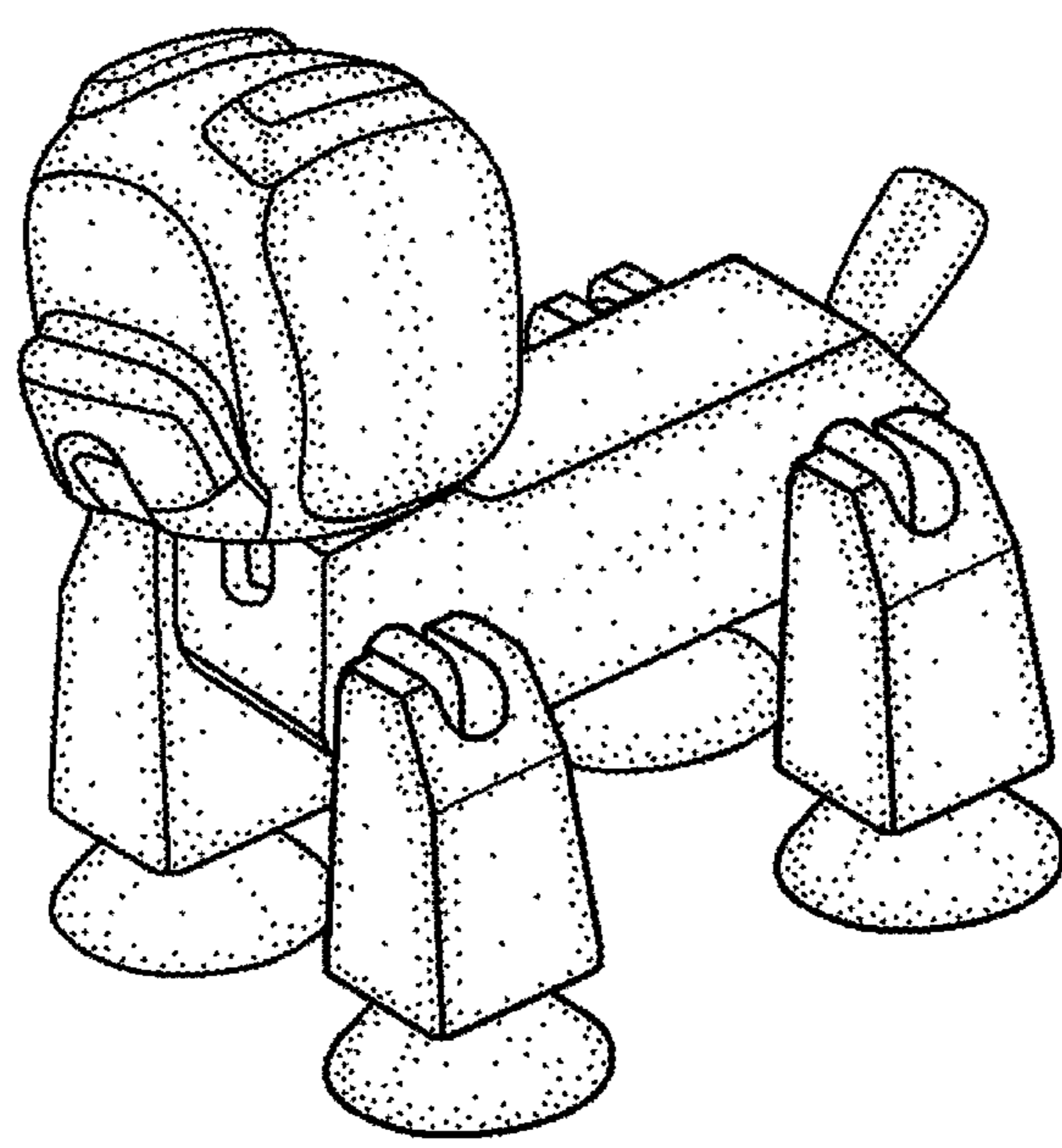
The ornamental design for a posable toy bulldog, as shown and described.

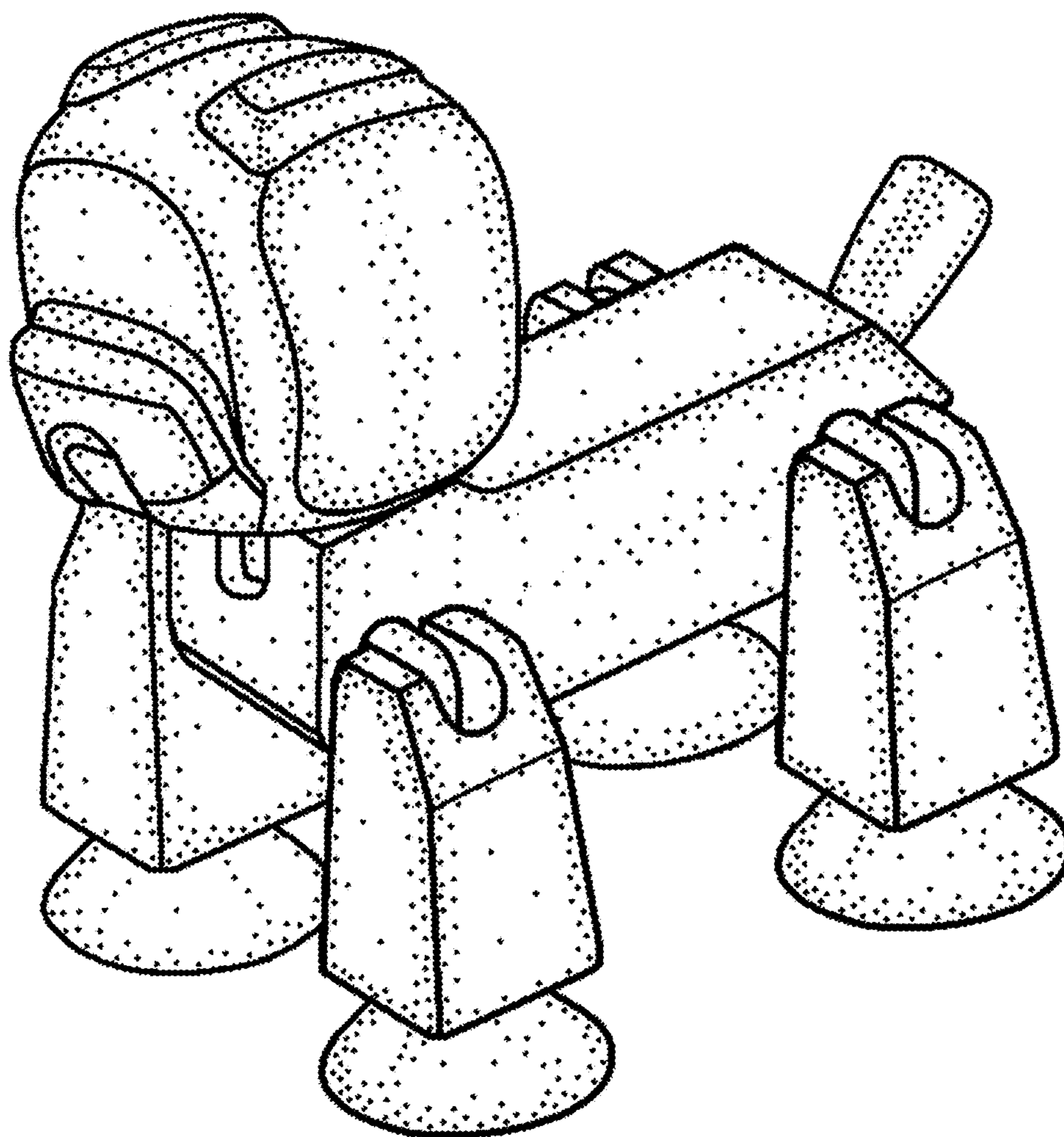

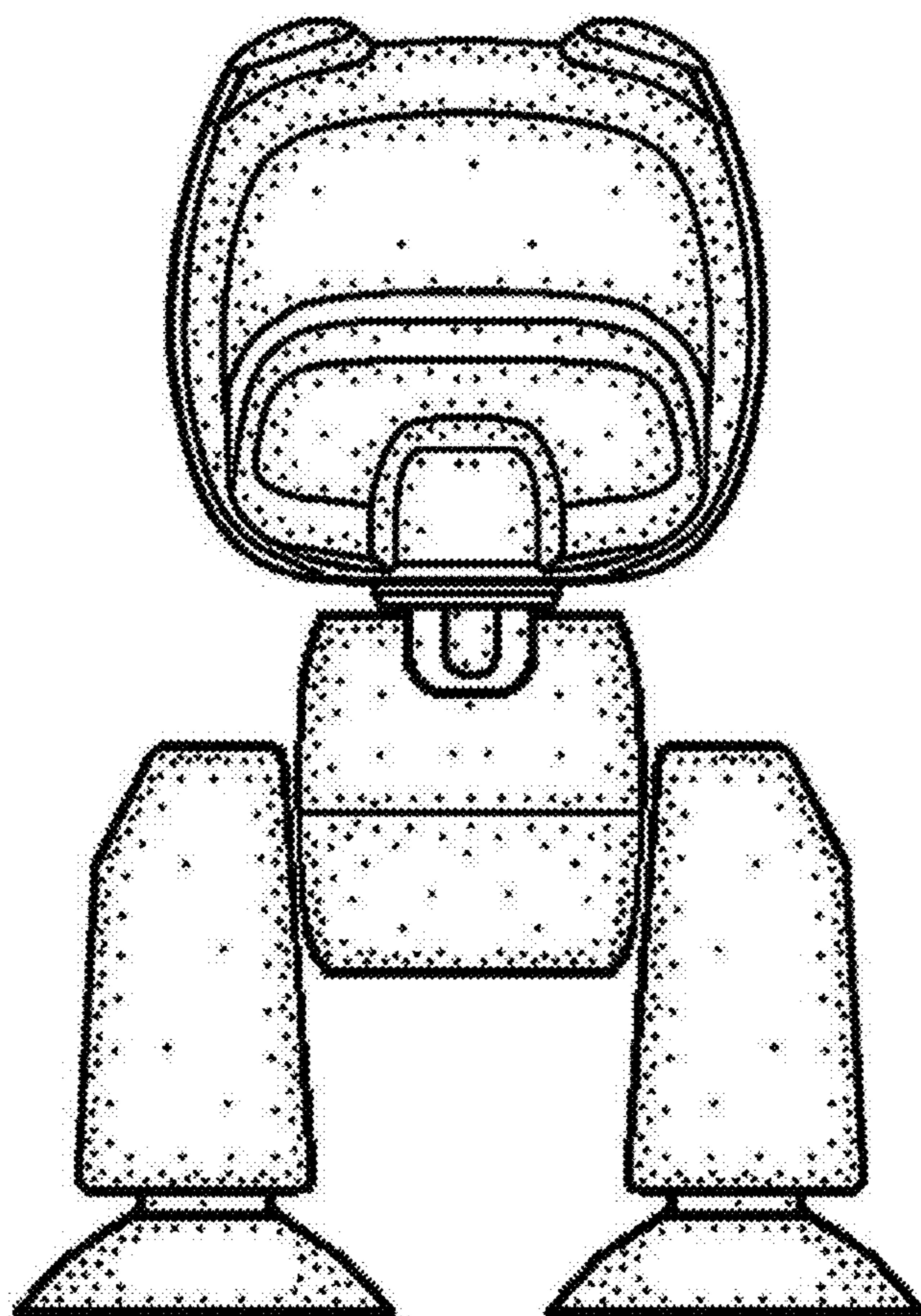

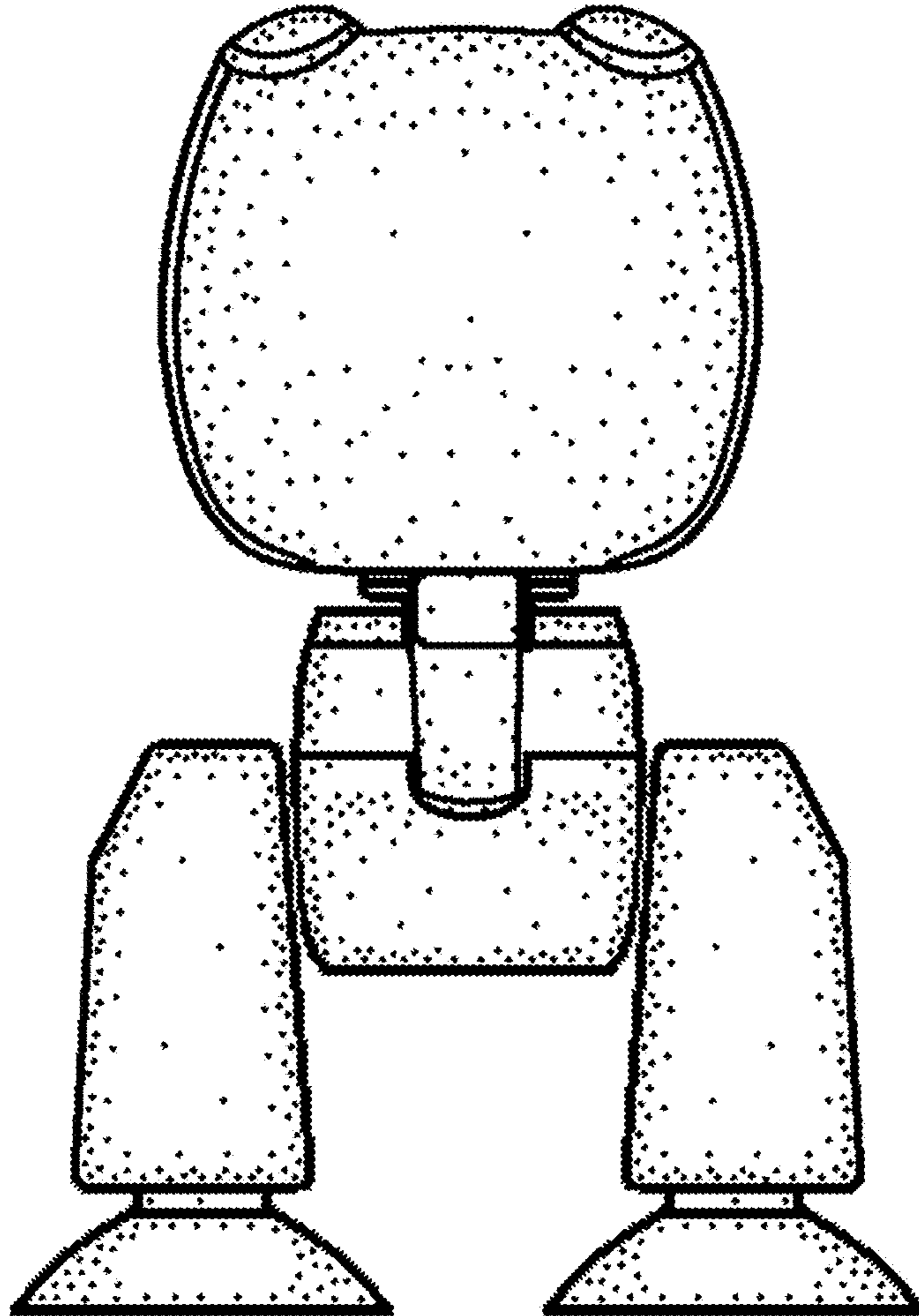

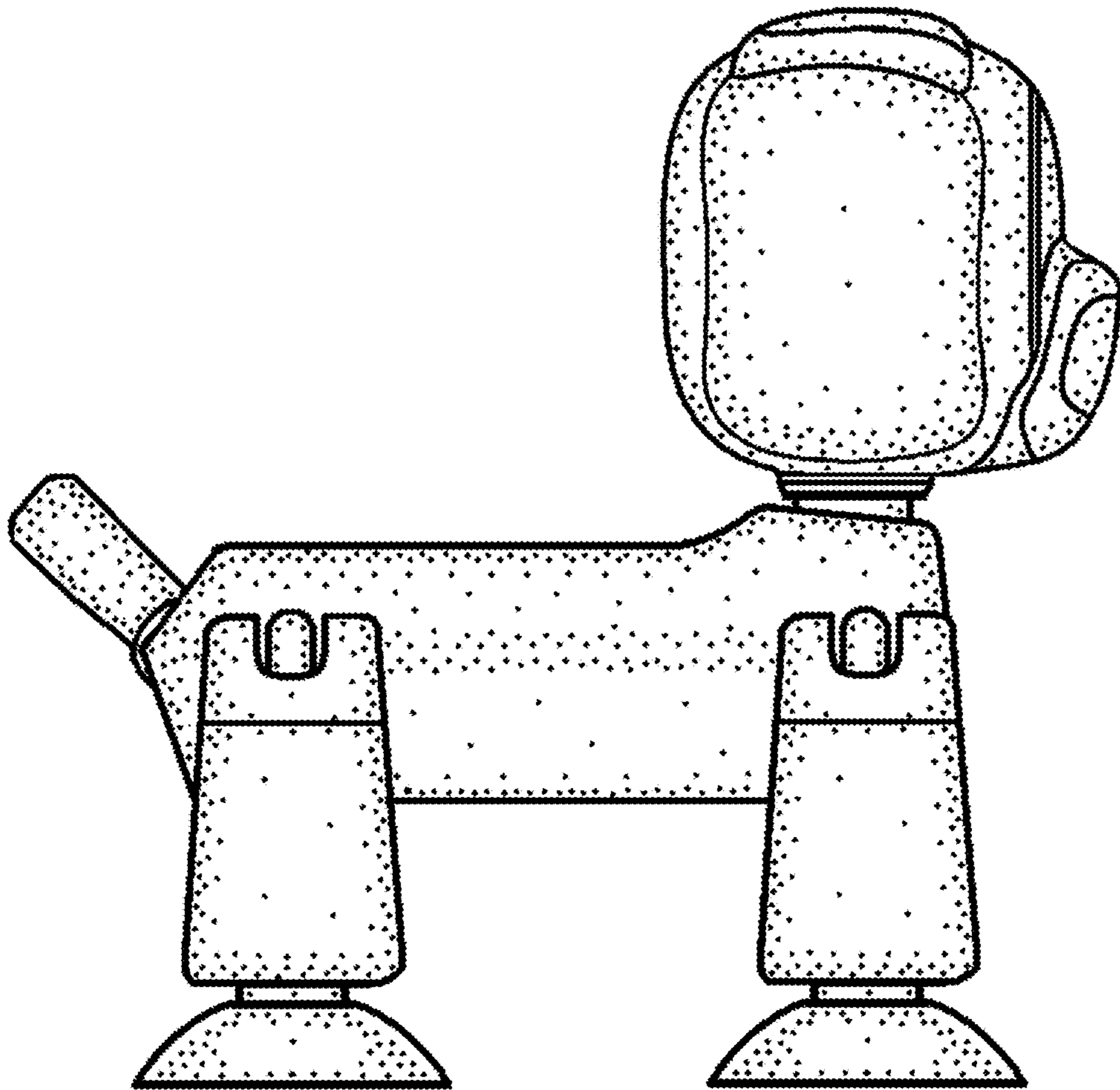

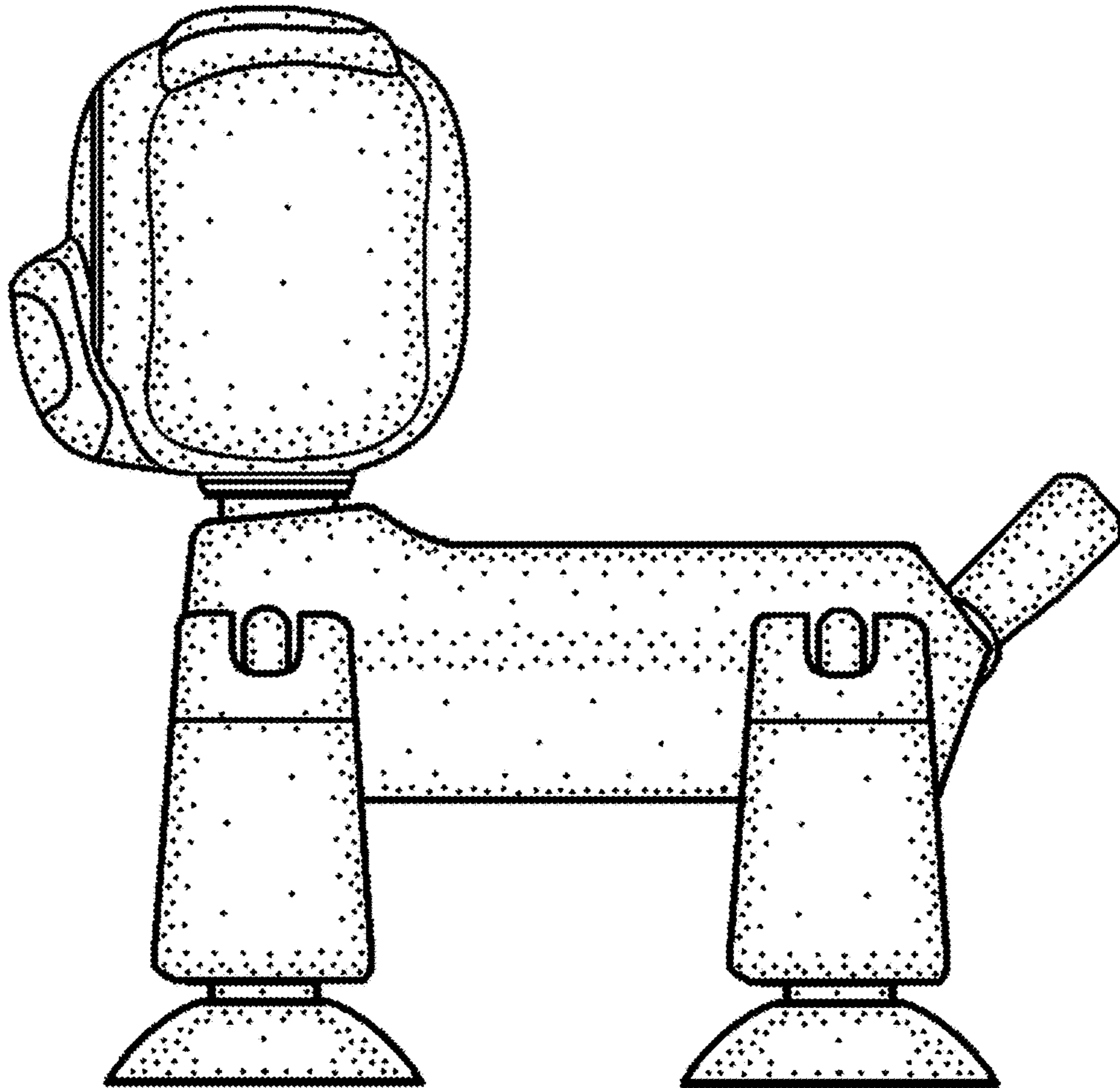

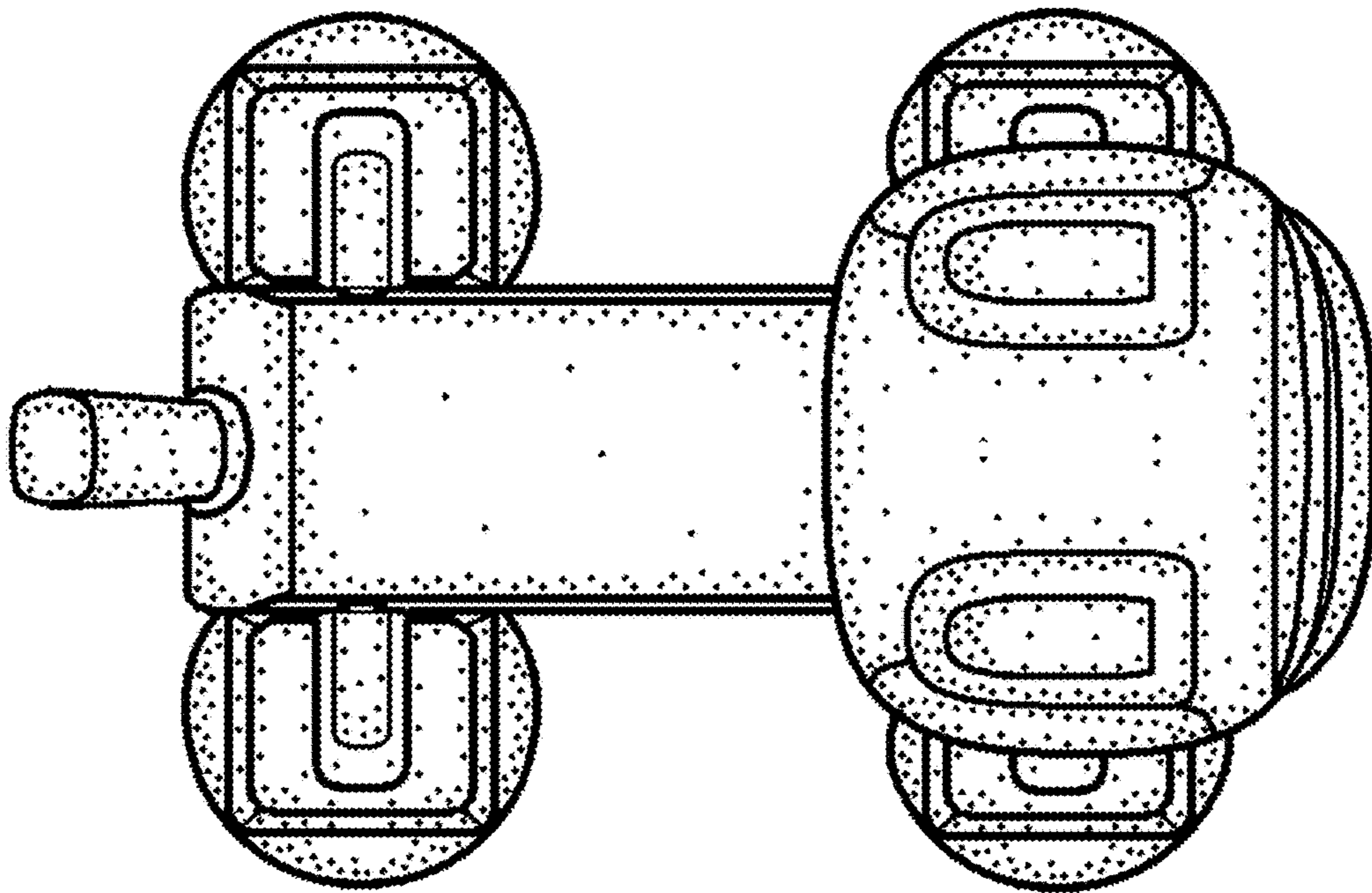

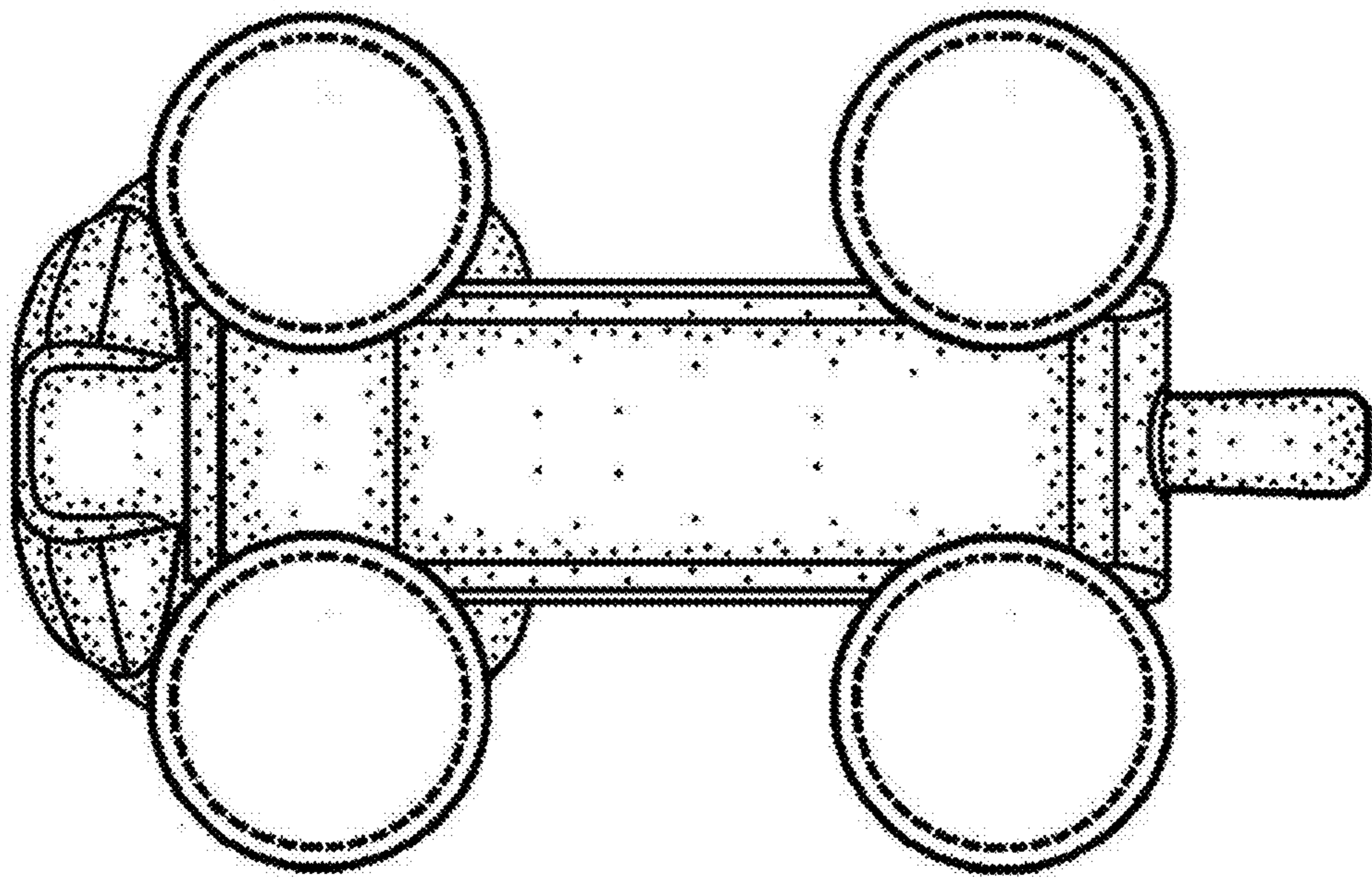
