FIG. 13 is a side view of the candle of FIG. 9;

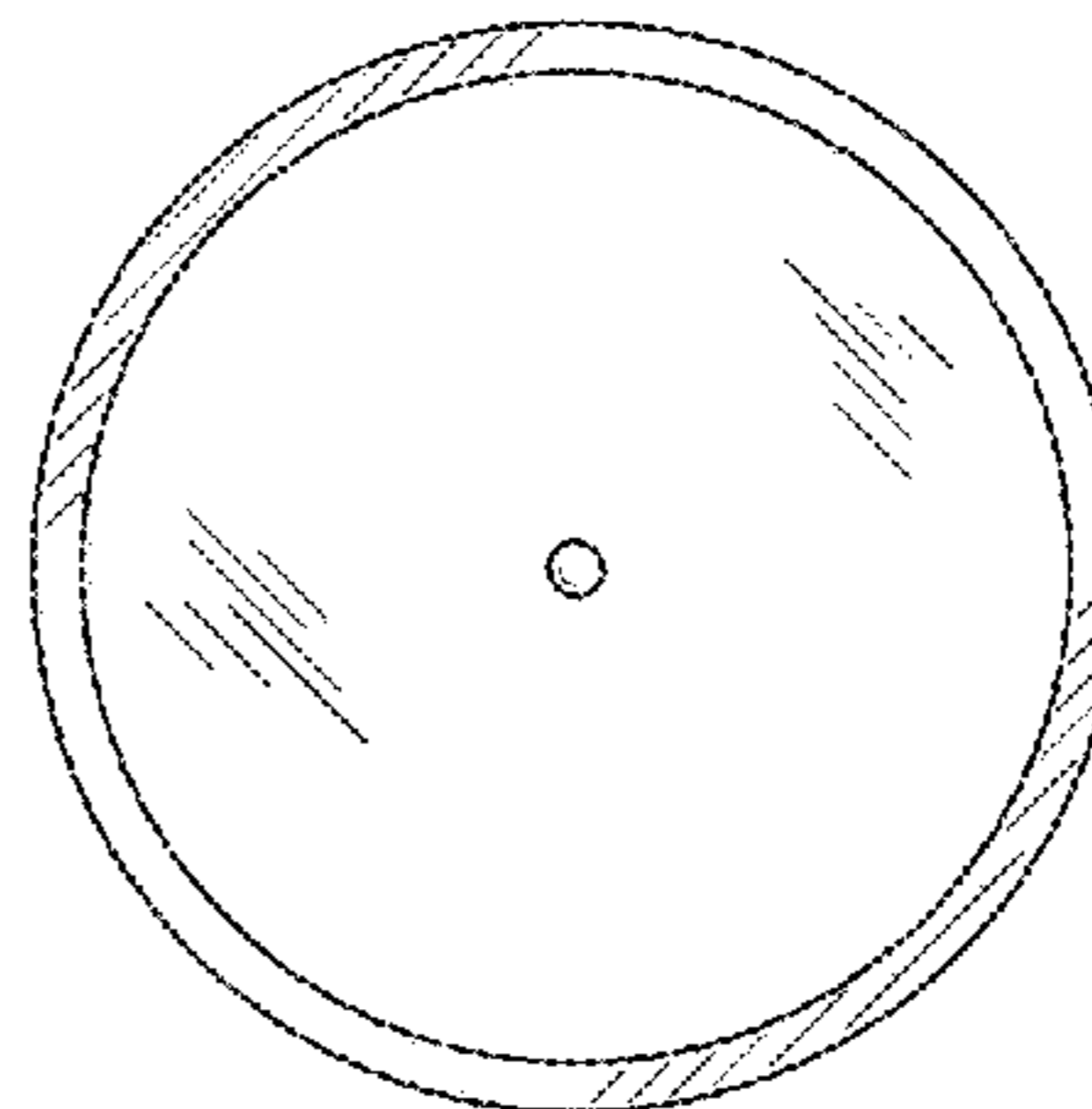
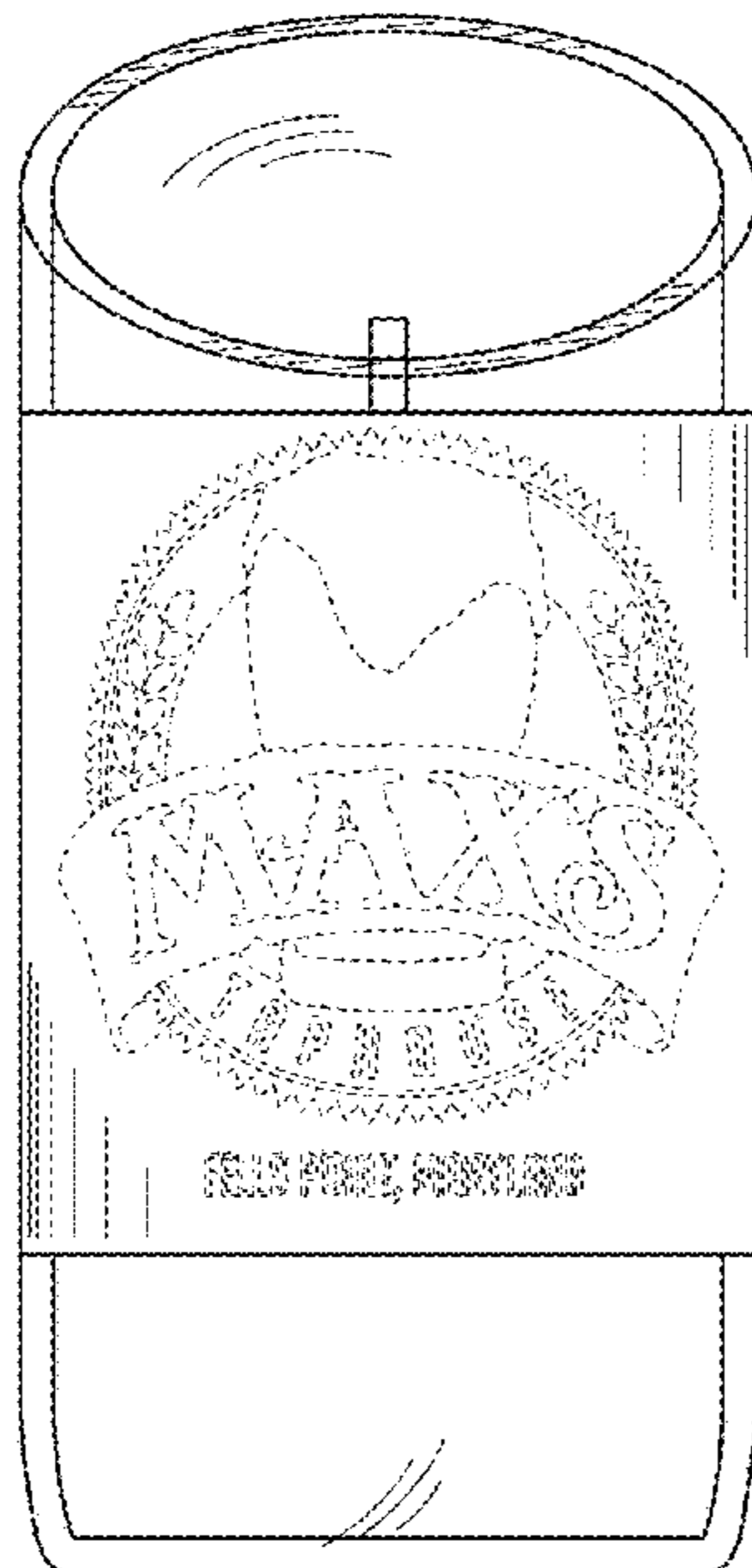
FIG. 14 is a side view of the candle of FIG. 9;

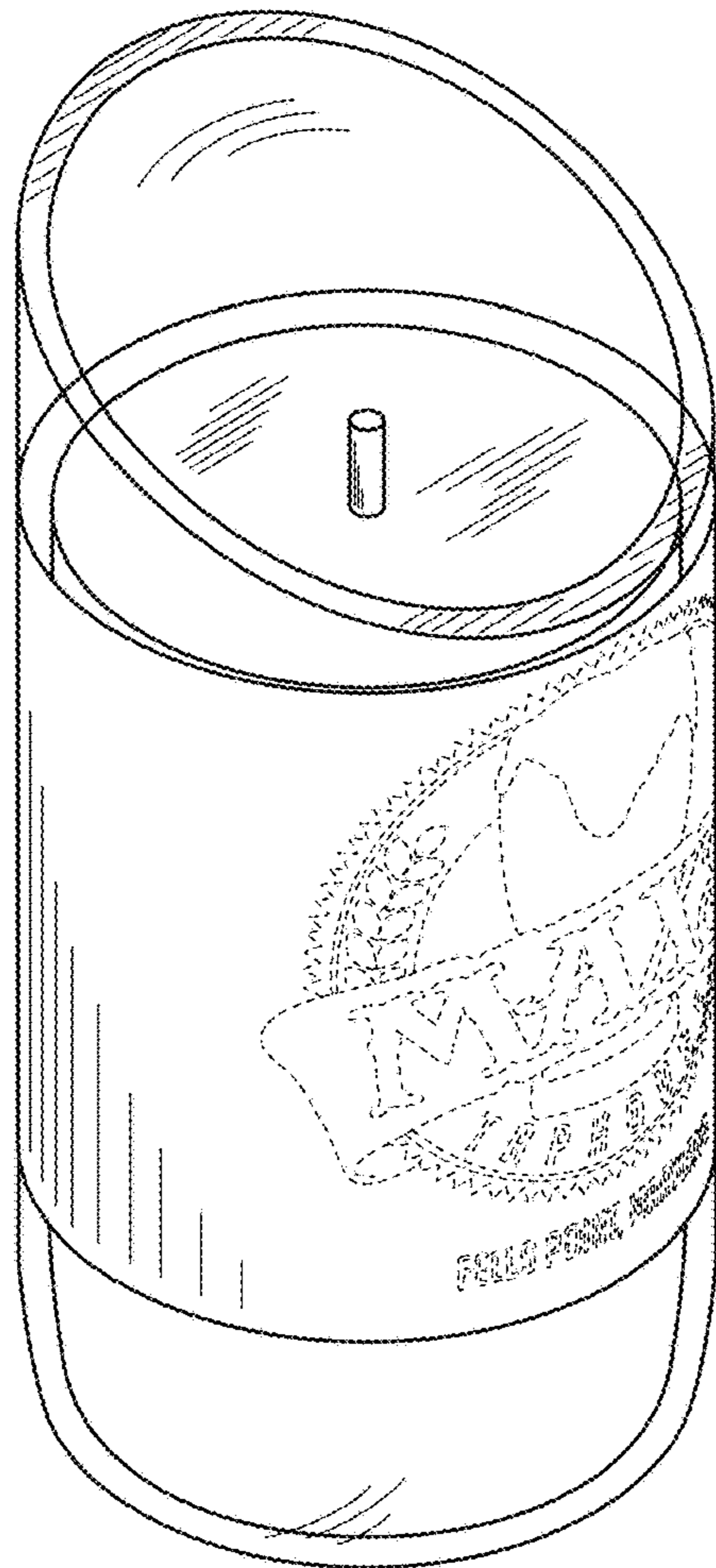

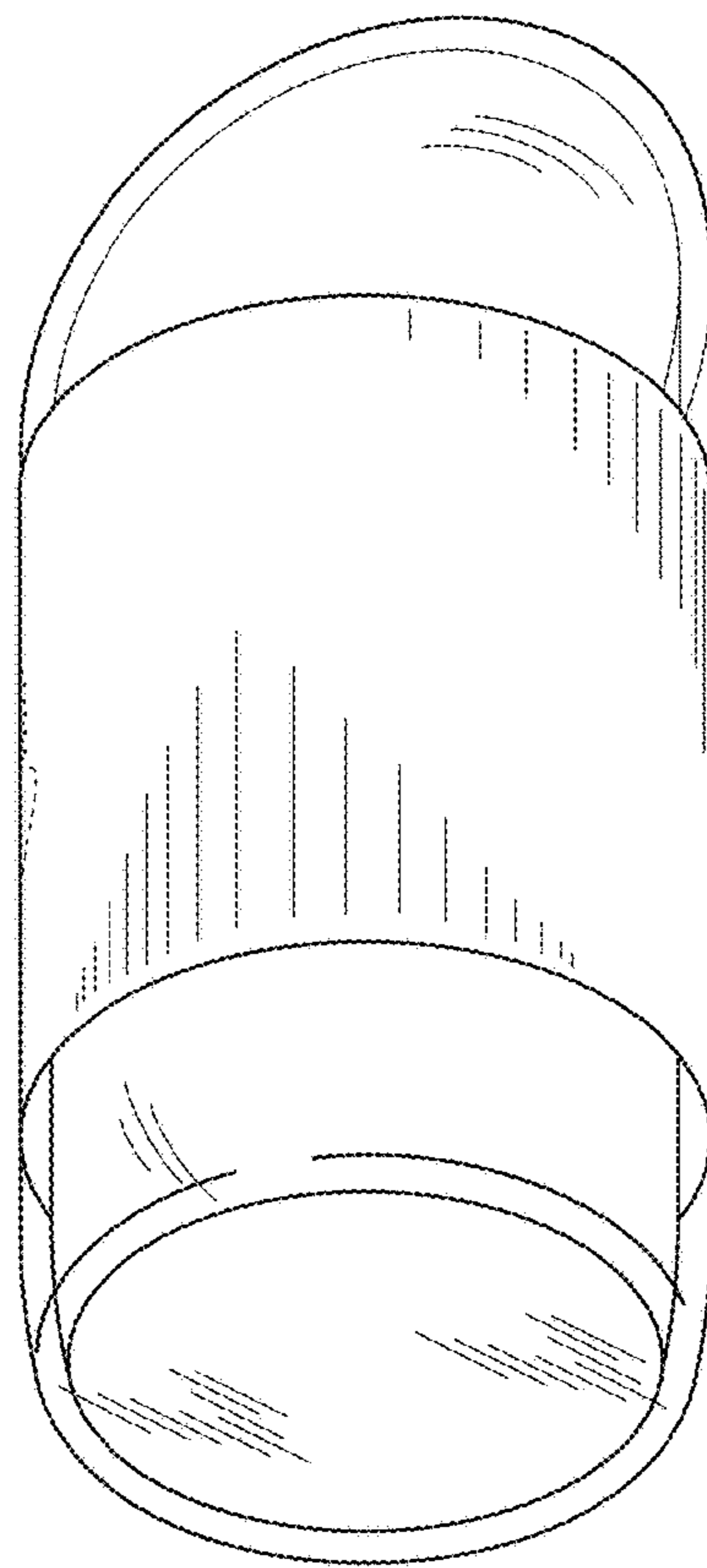

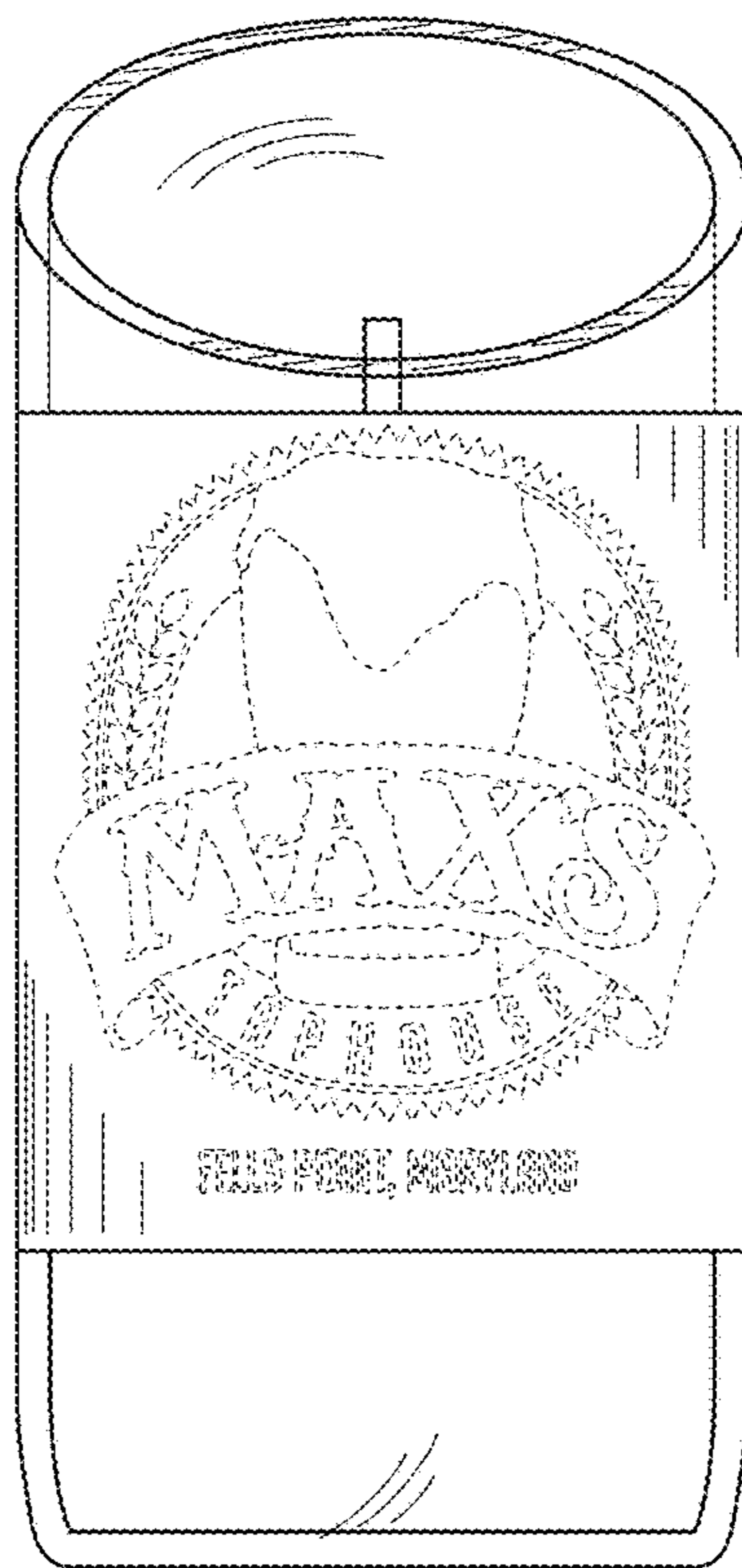

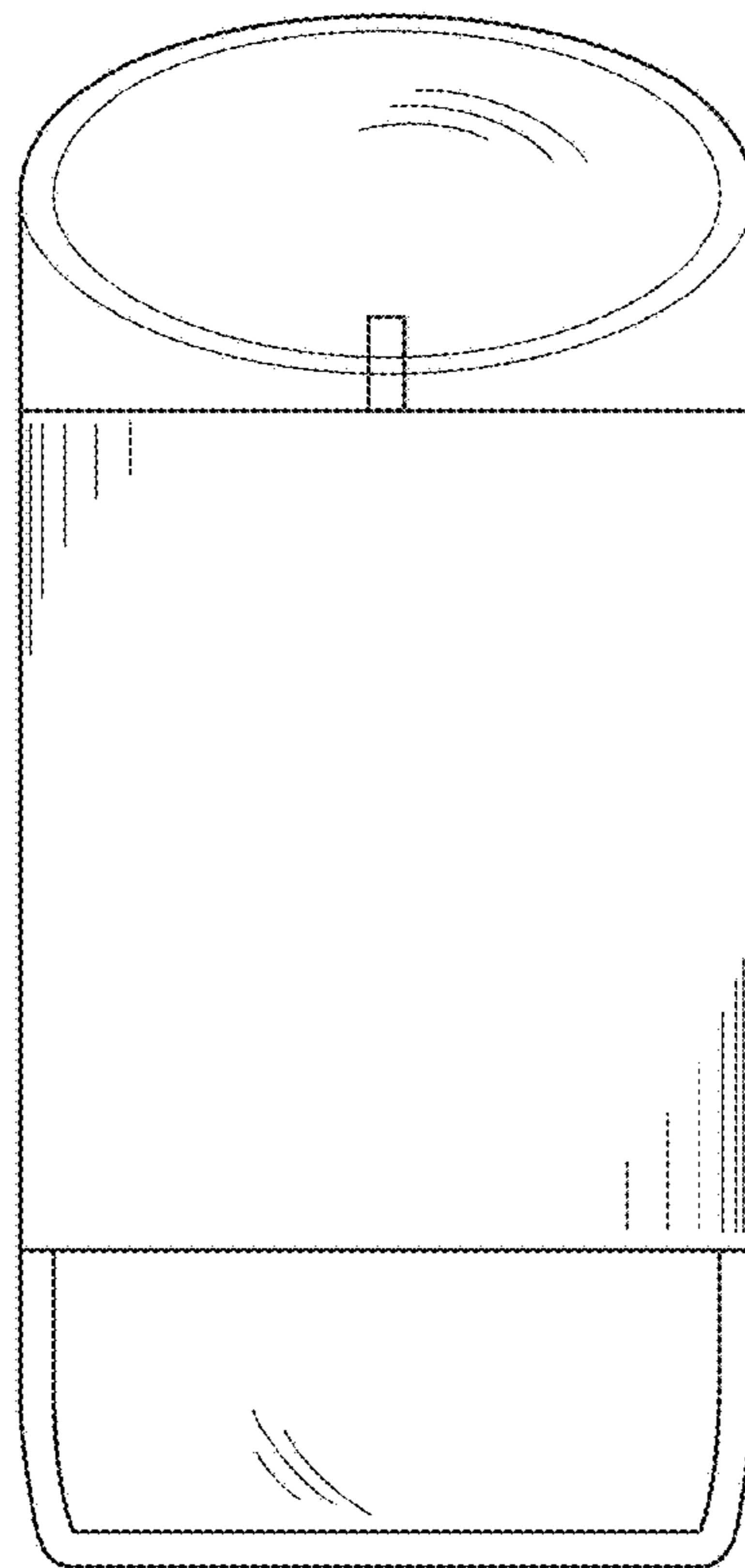

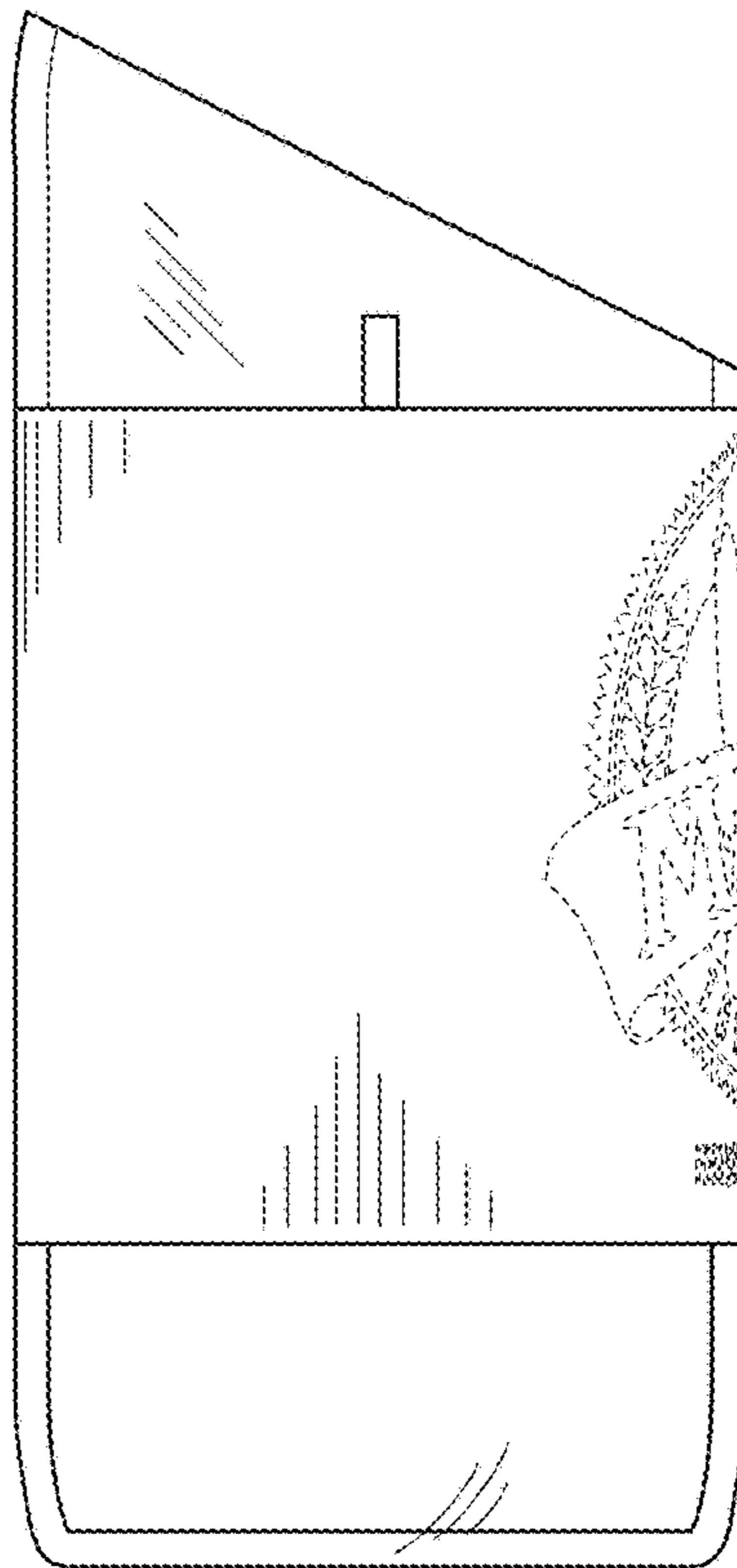

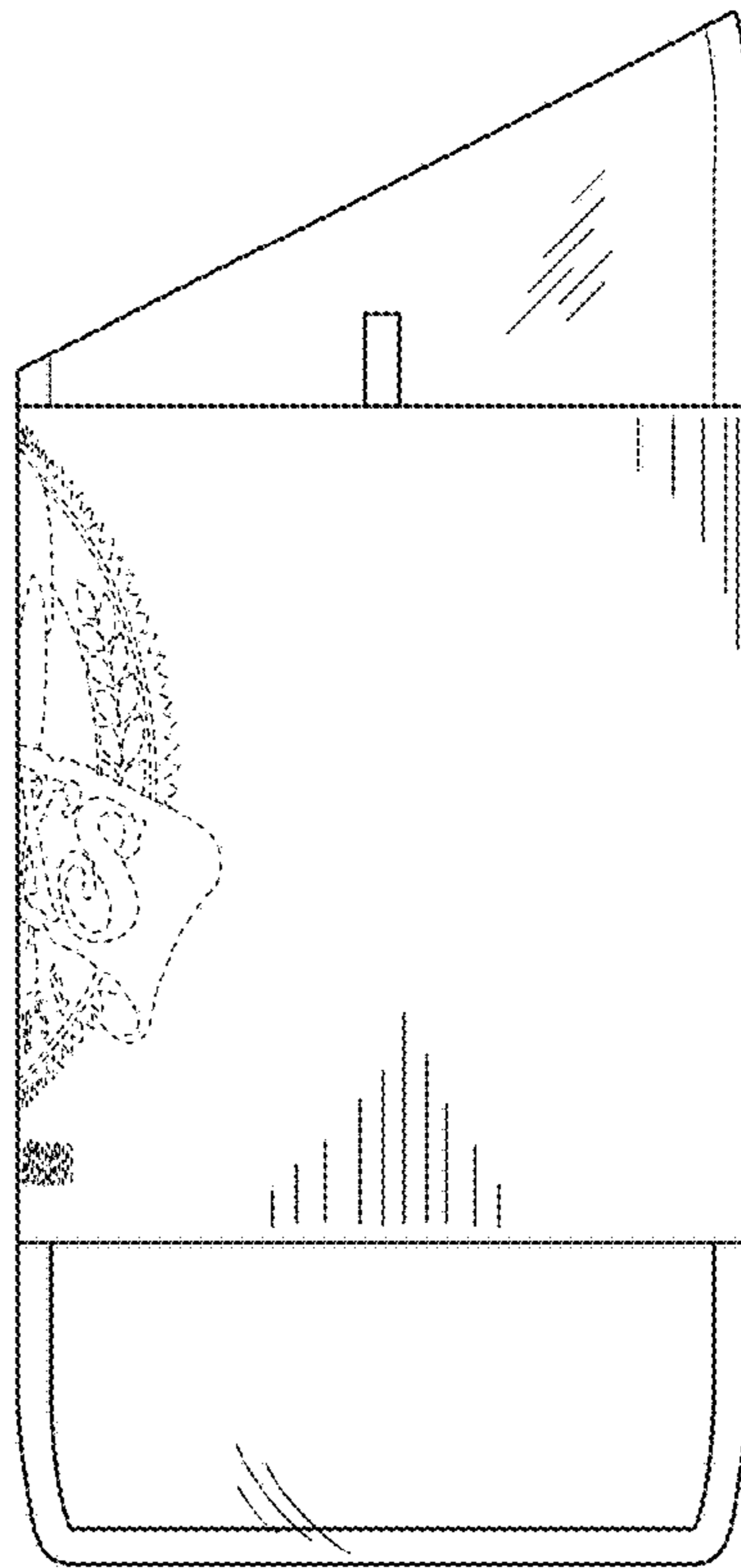

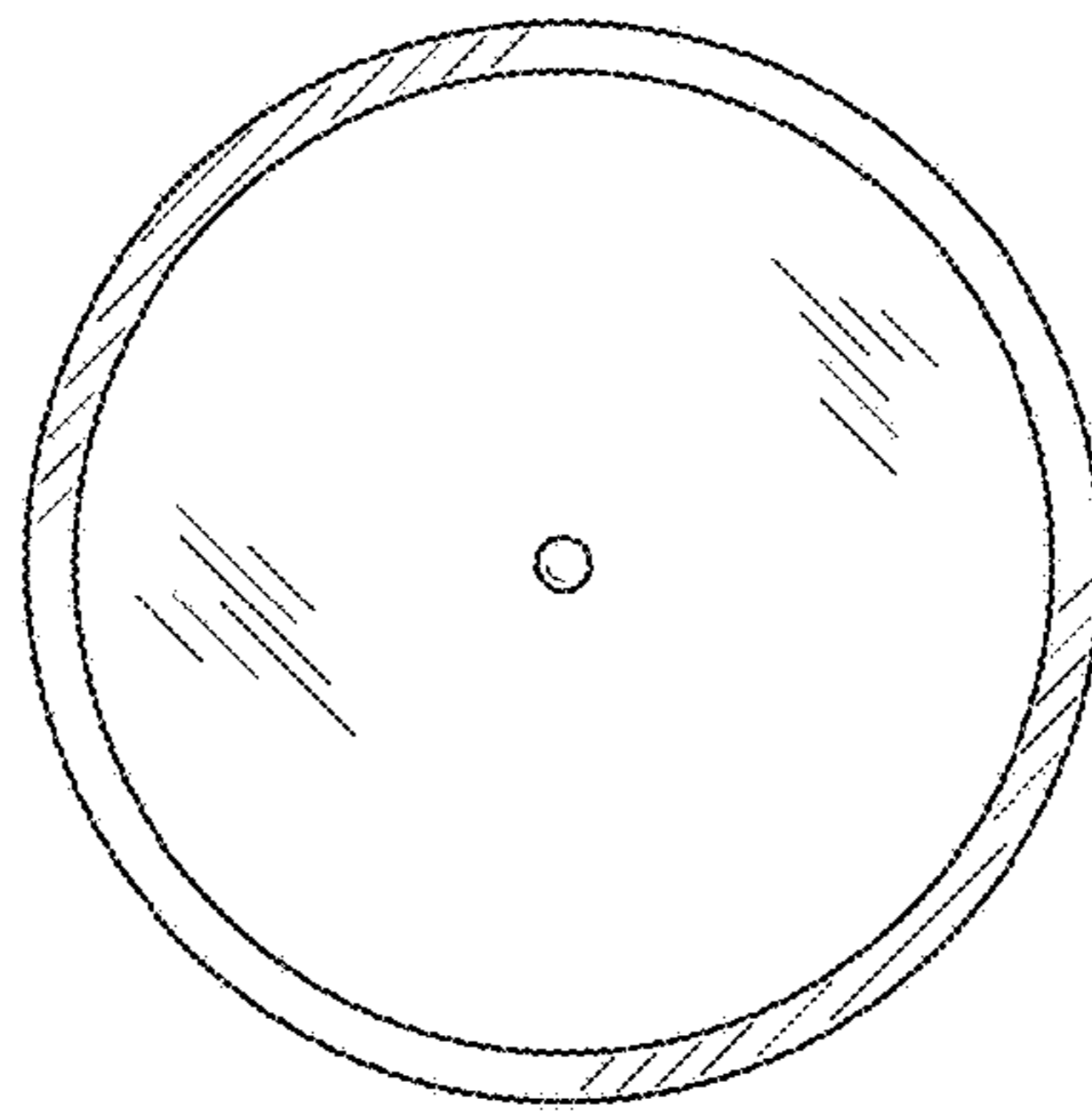

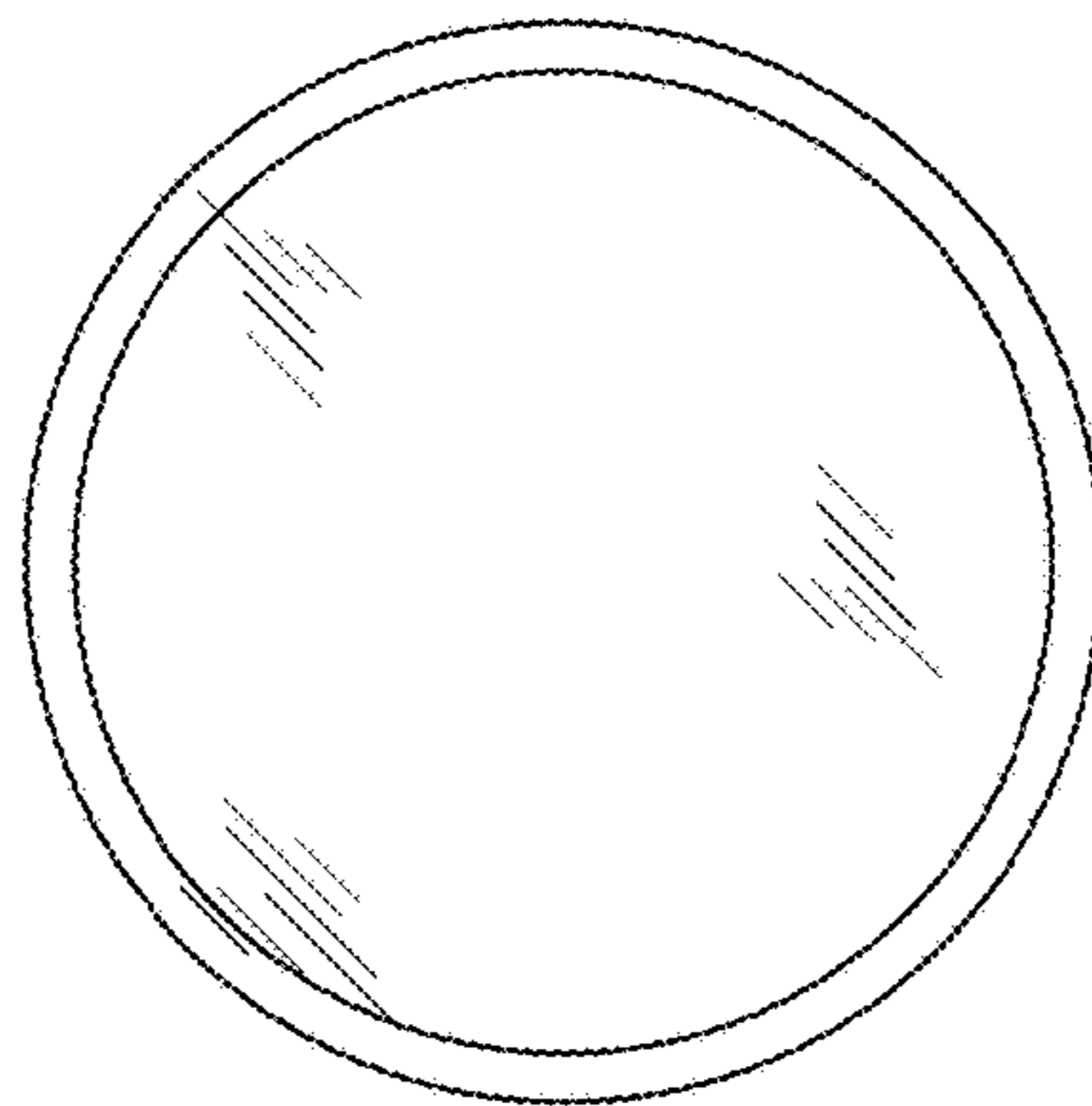

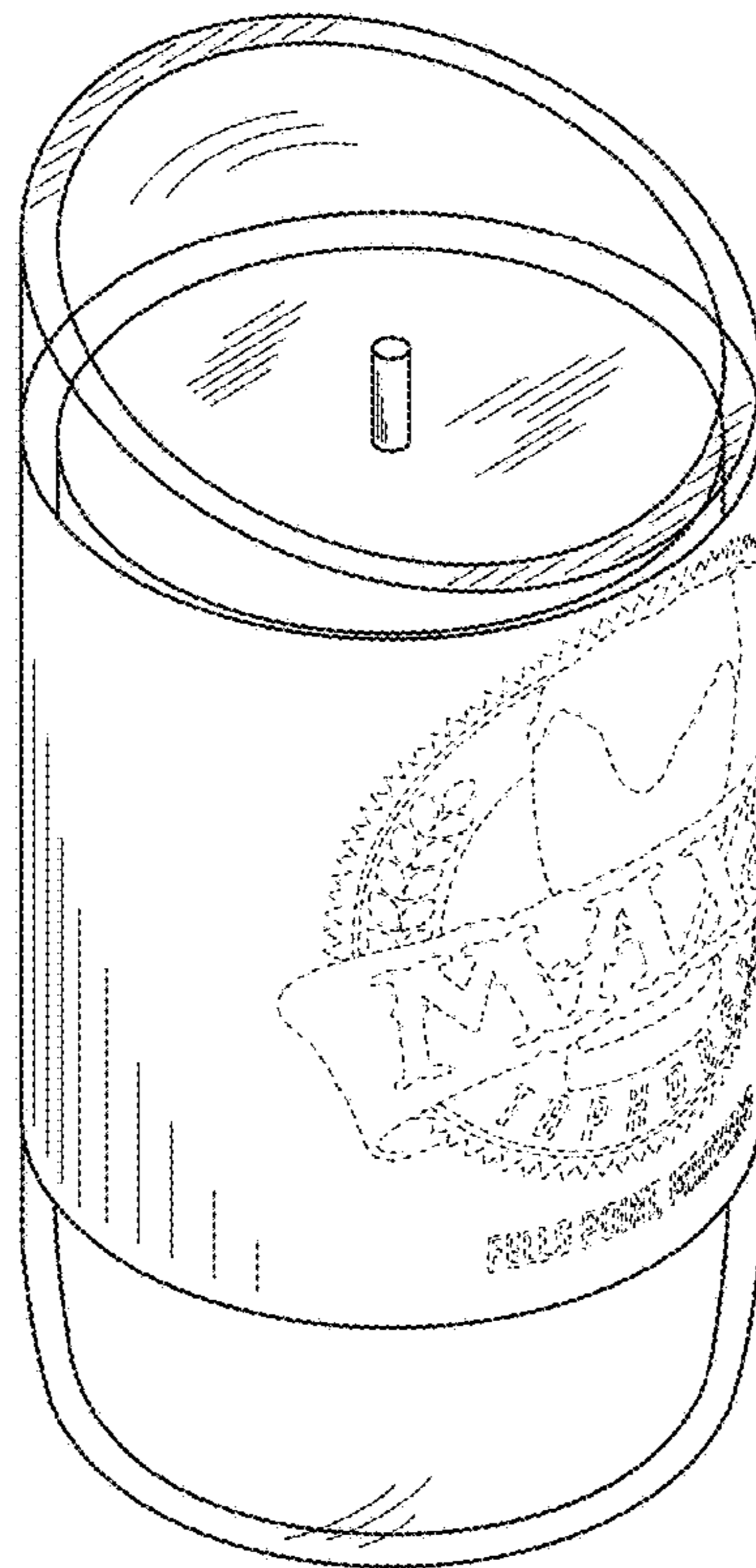

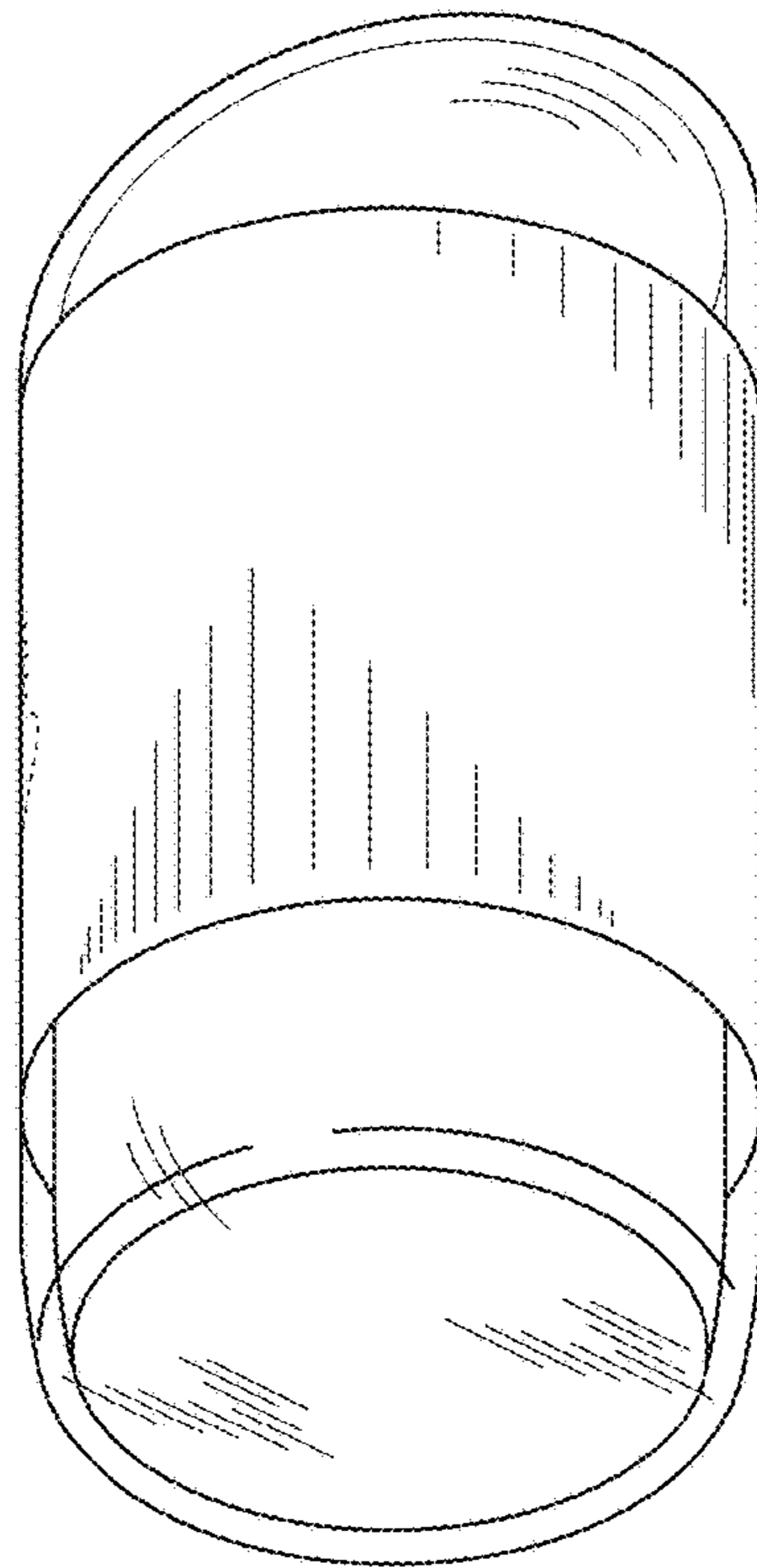

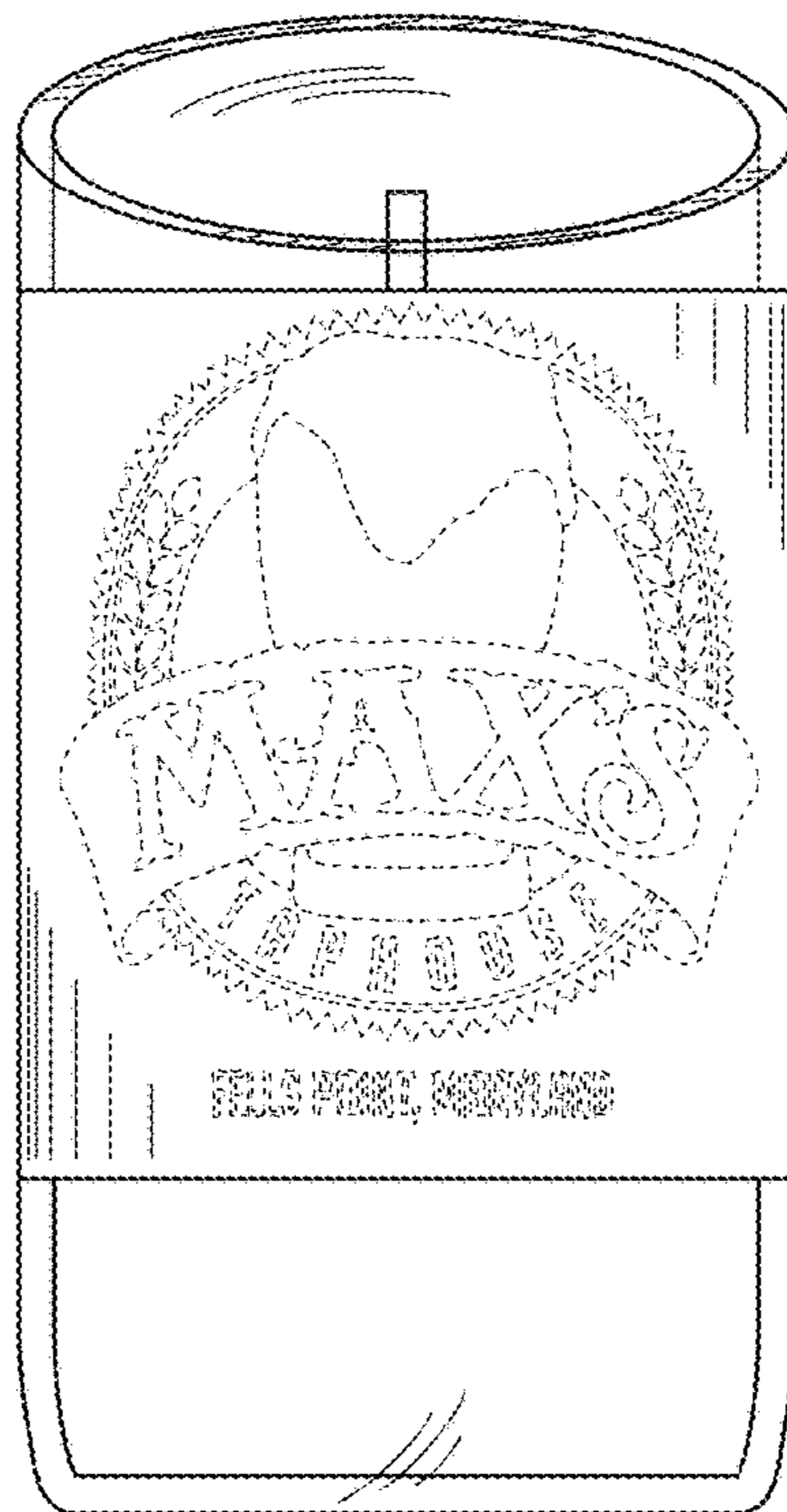

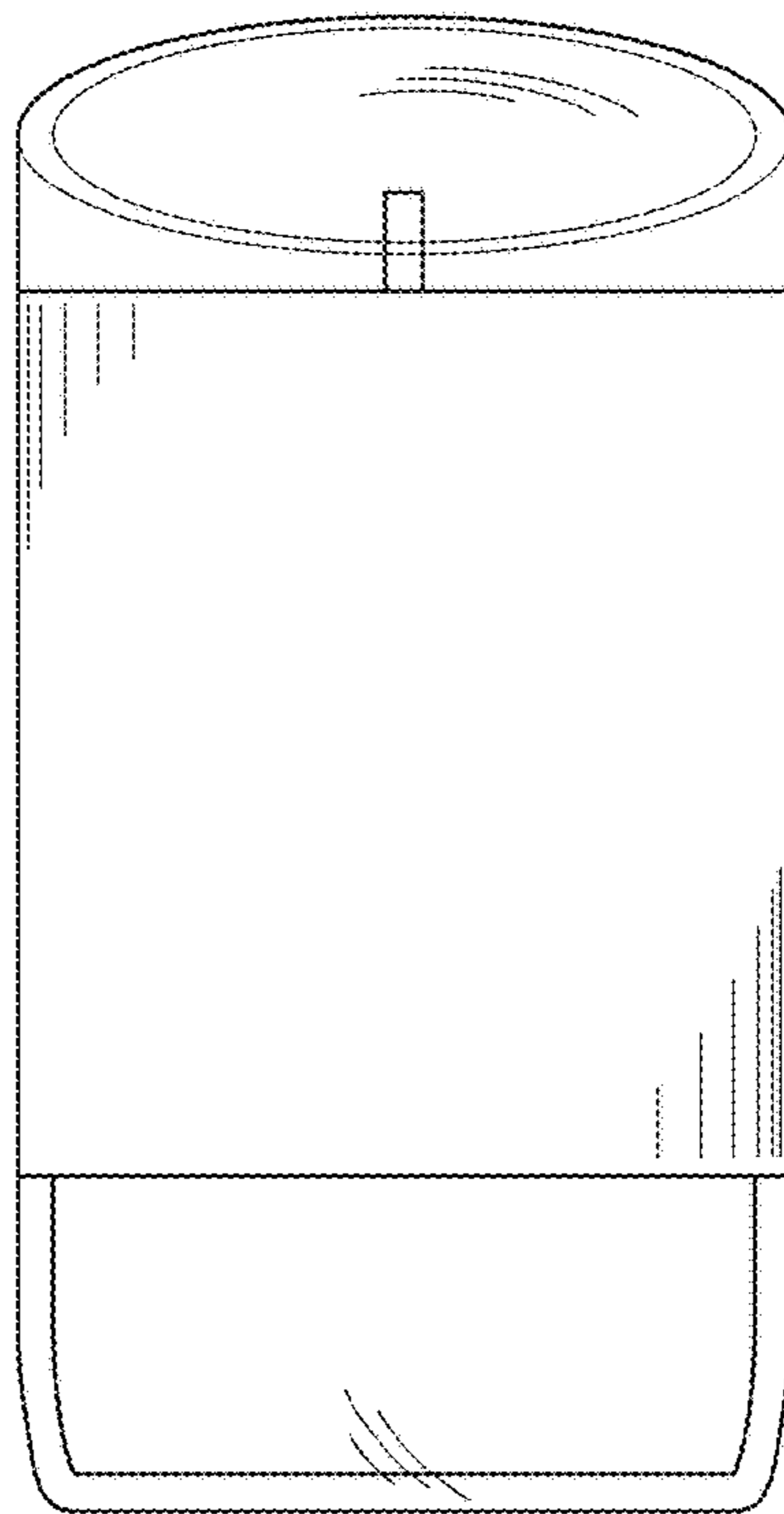

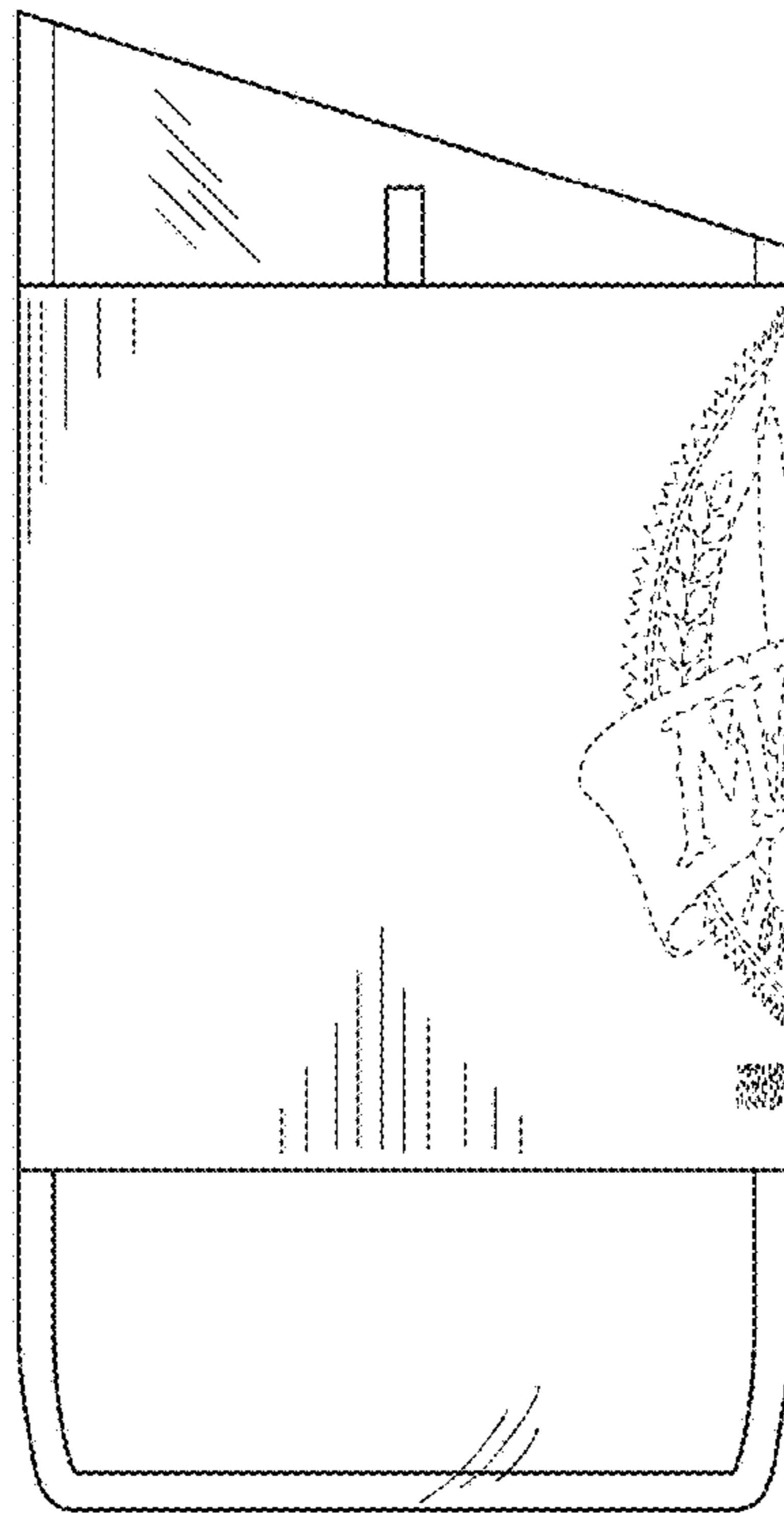

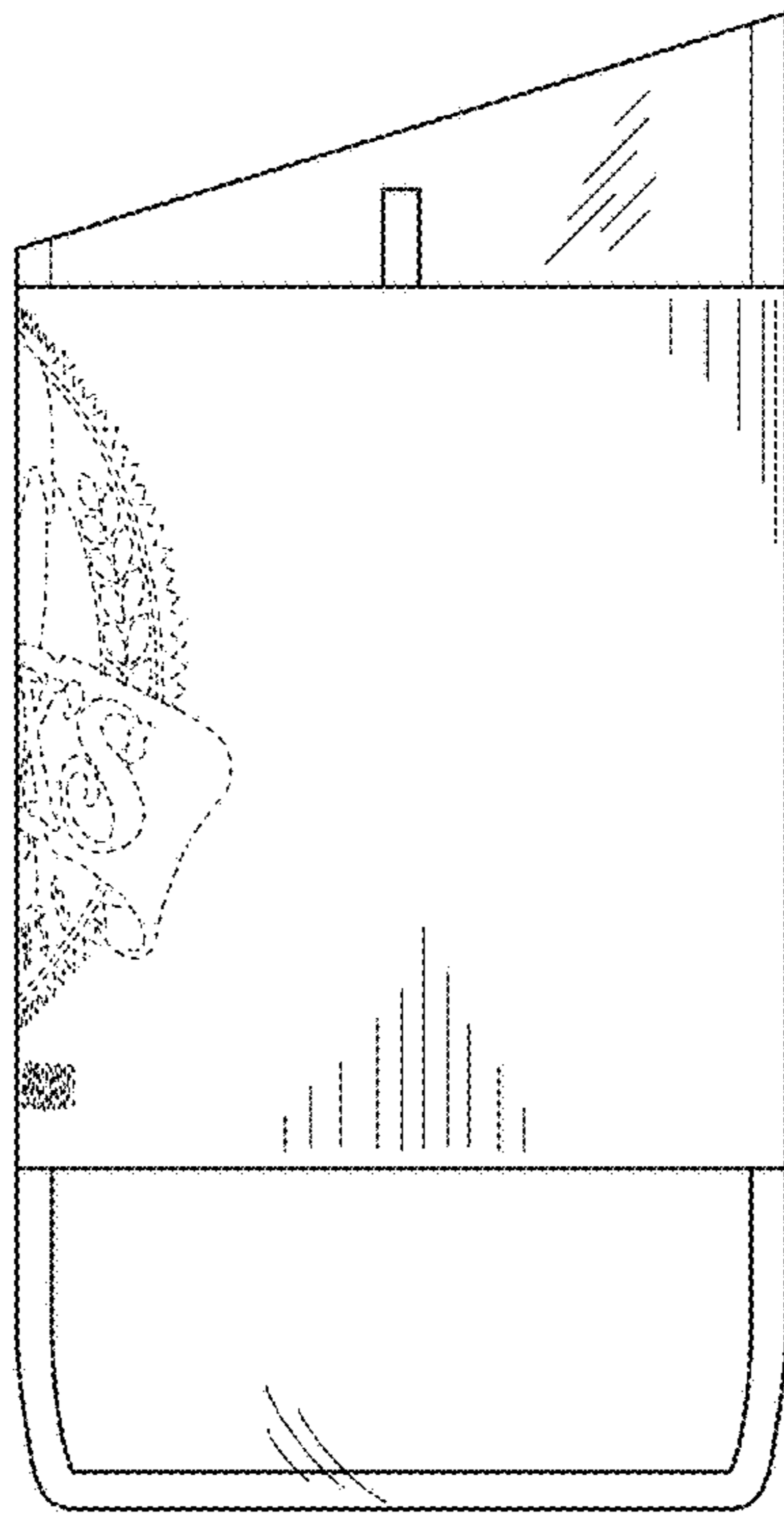

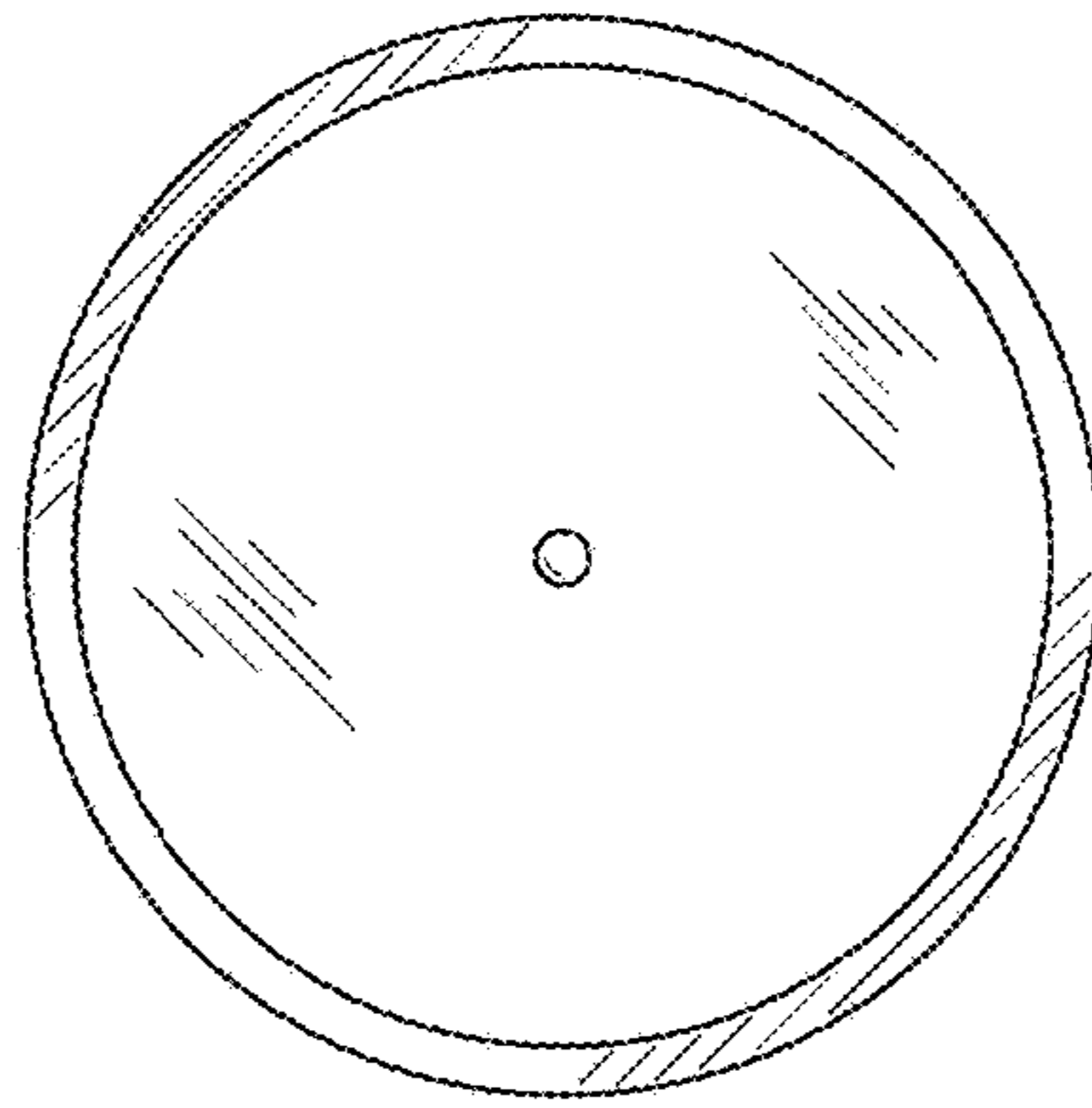

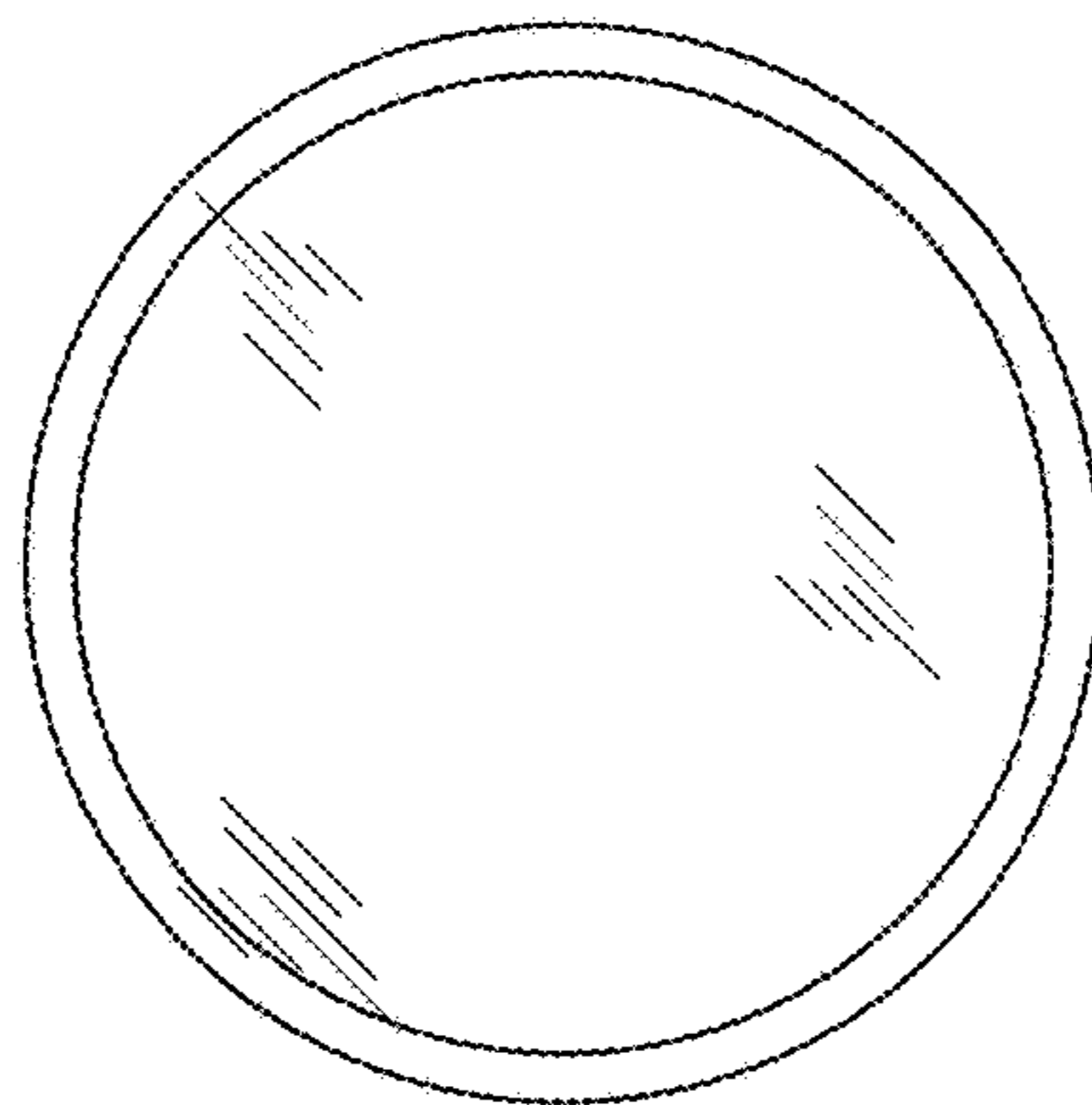
