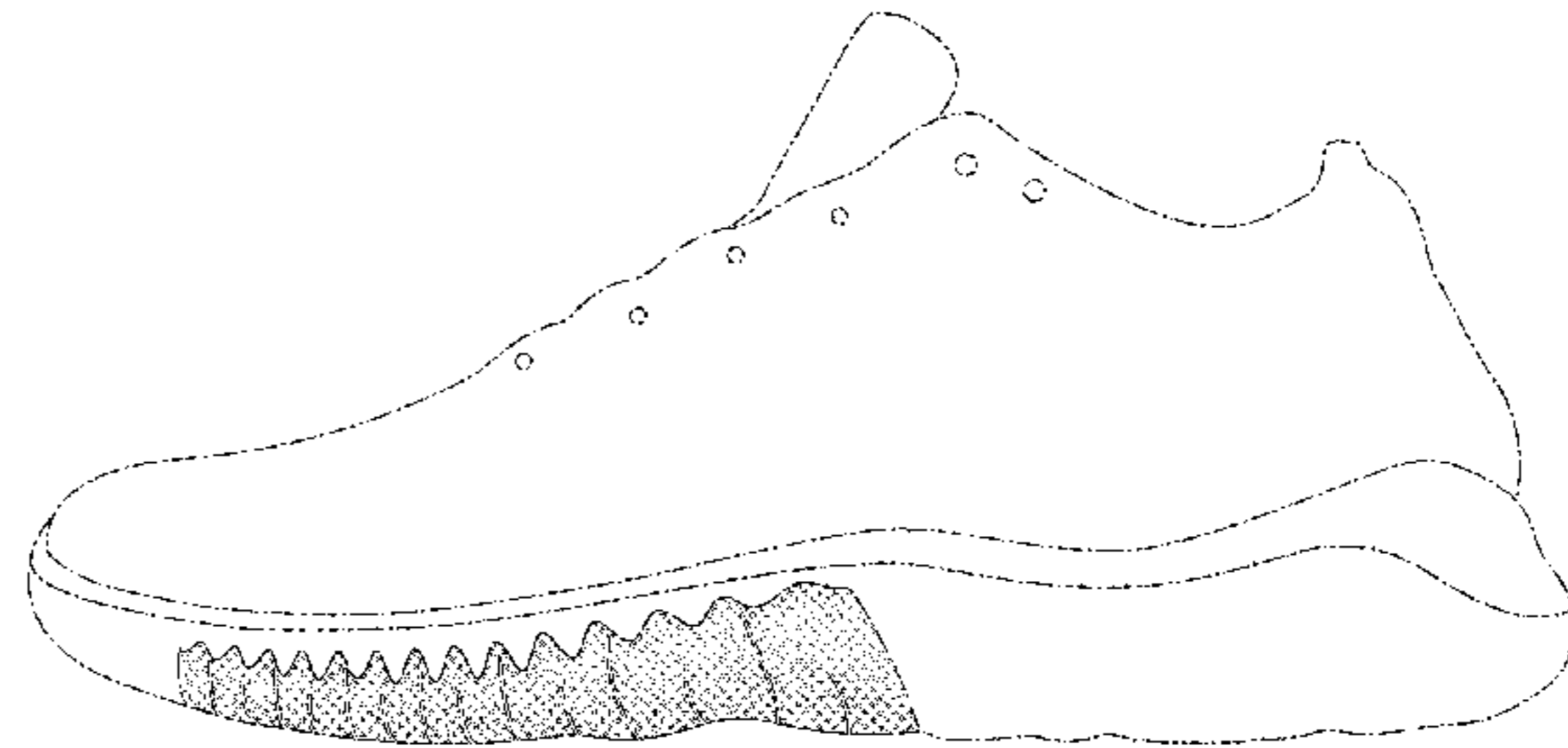
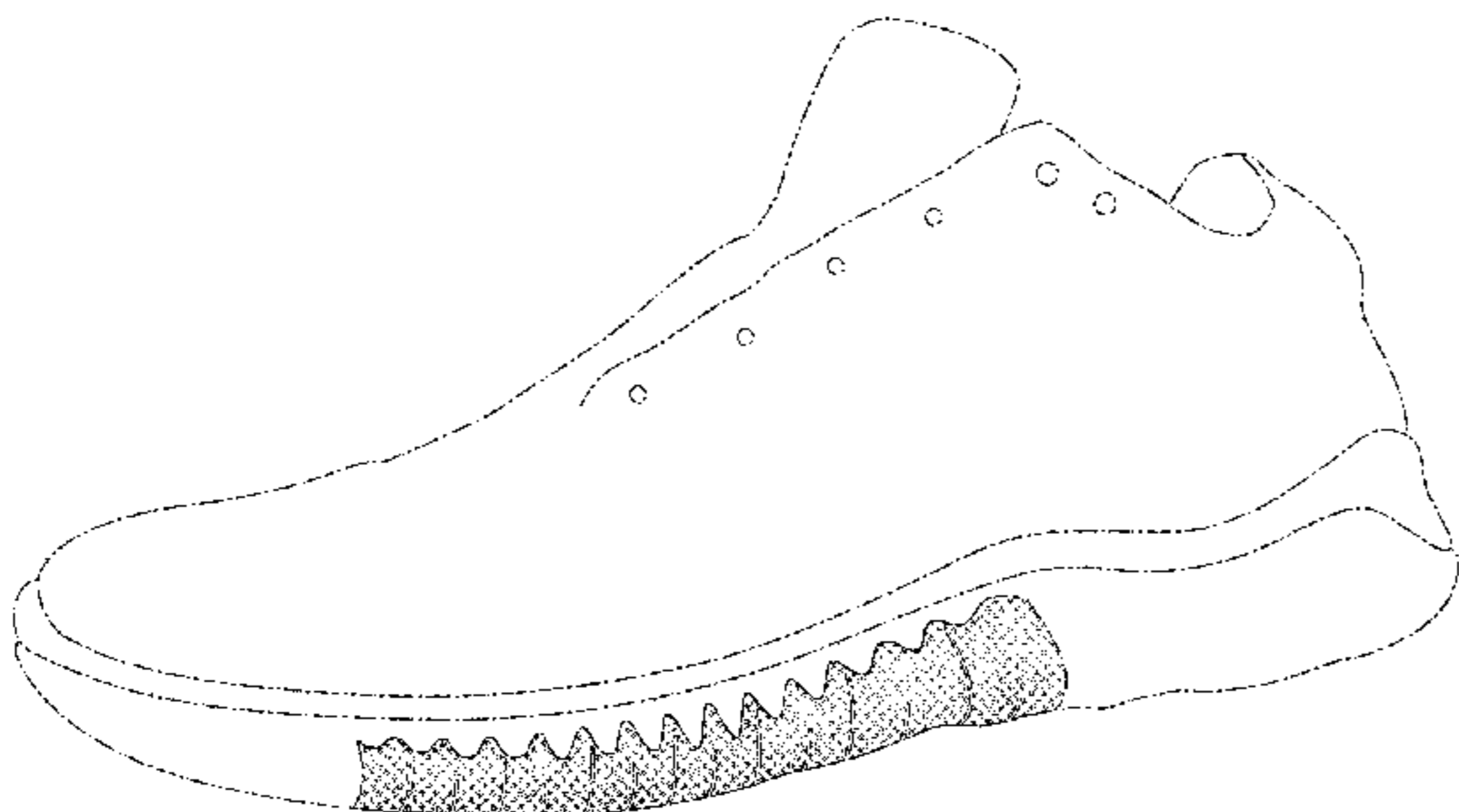
(57) **CLAIM**

The ornamental design for a shoe midsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe midsole showing our new design; FIG. 2 is a side view thereof; and, FIG. 3 is a rear perspective view thereof. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design. The fourteen unshaded regions within the shaded area form no part of the claimed design.

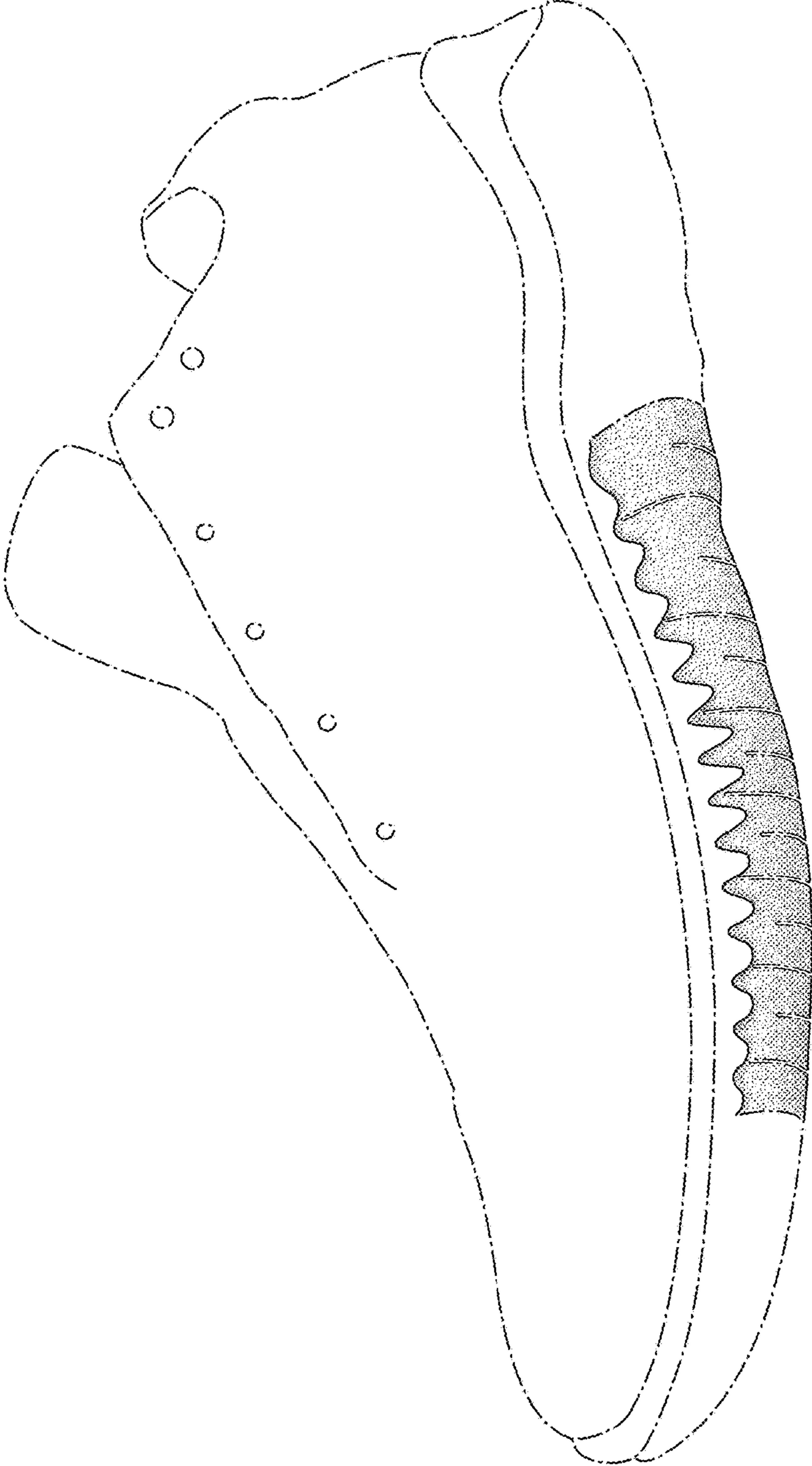

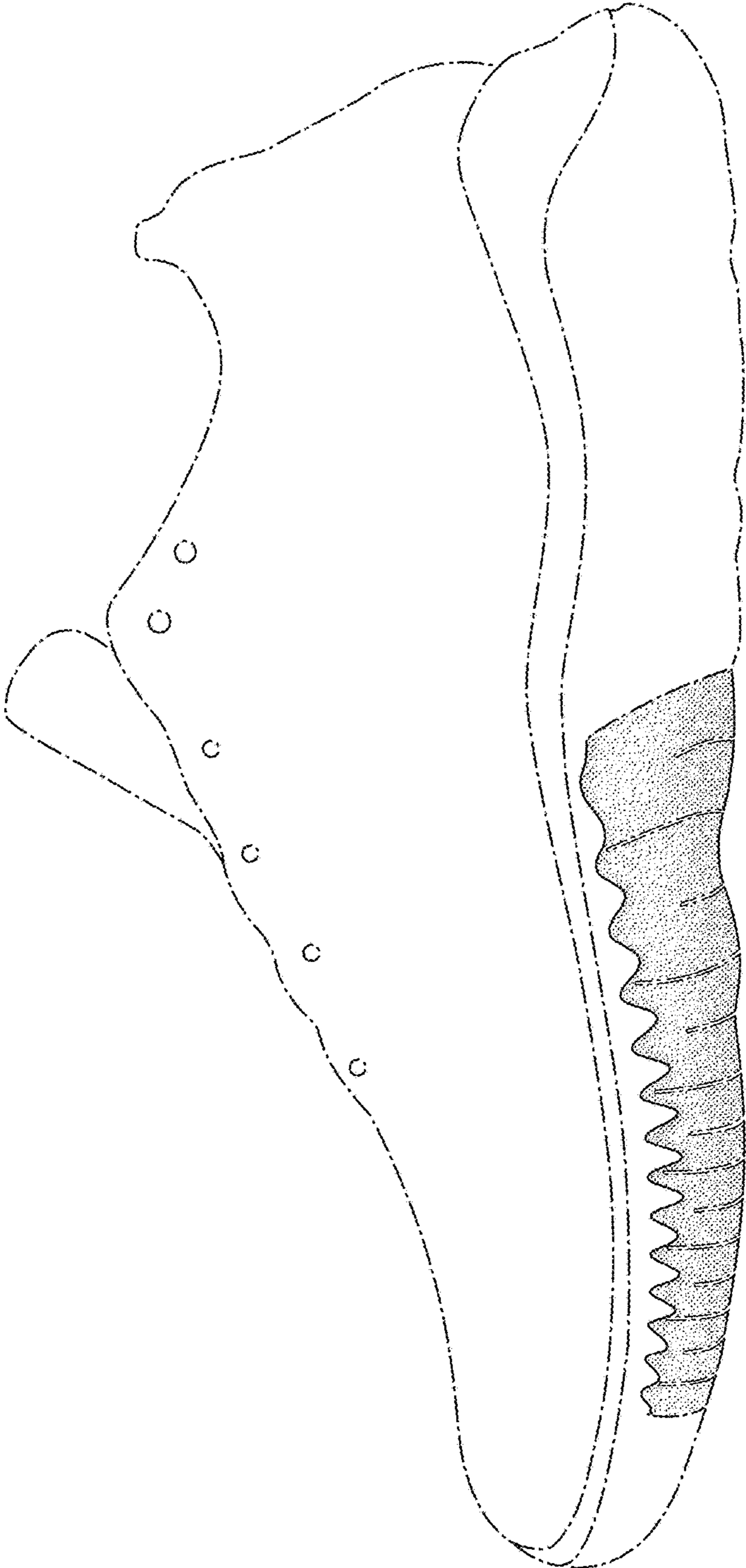

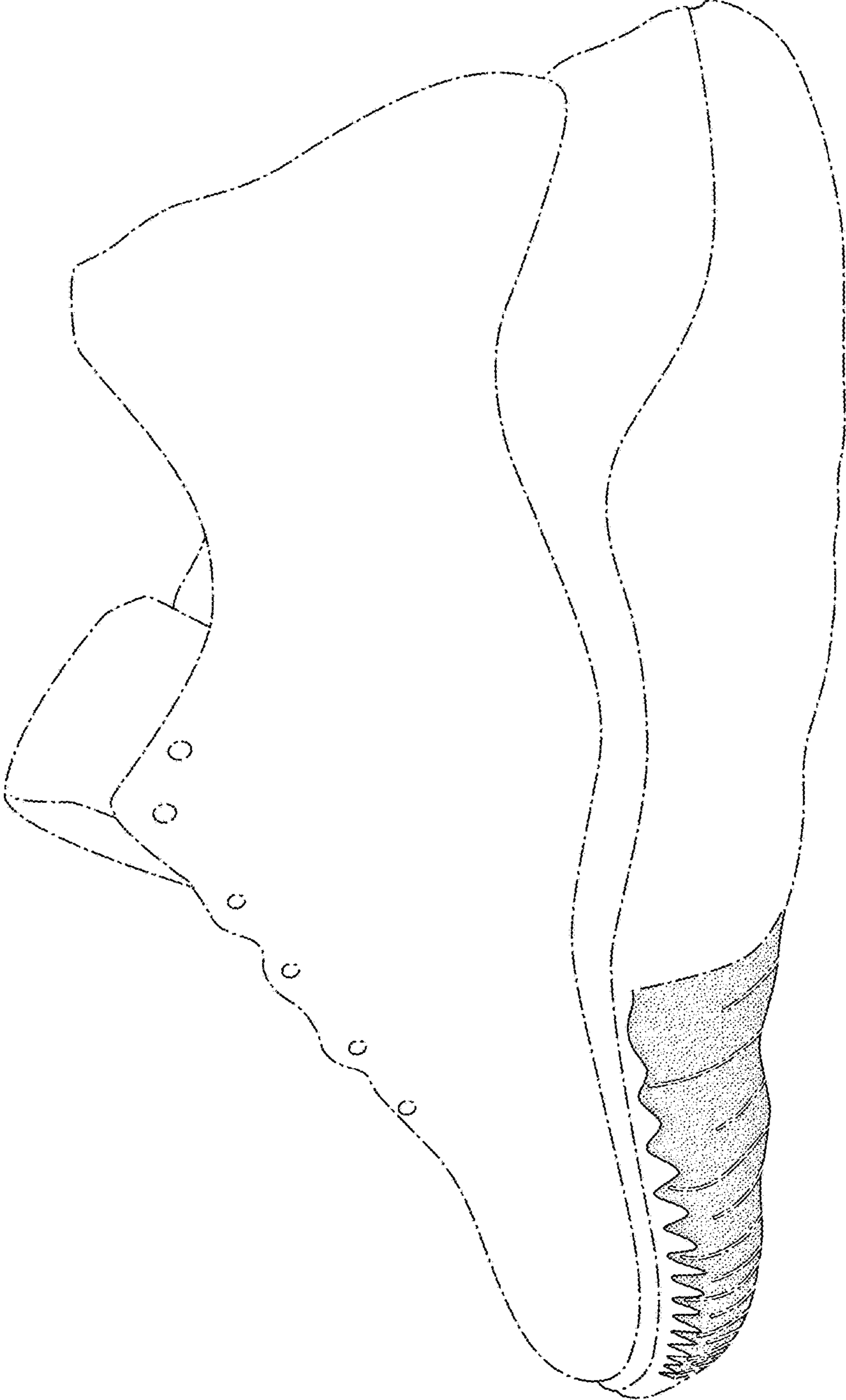
