(57) **CLAIM**

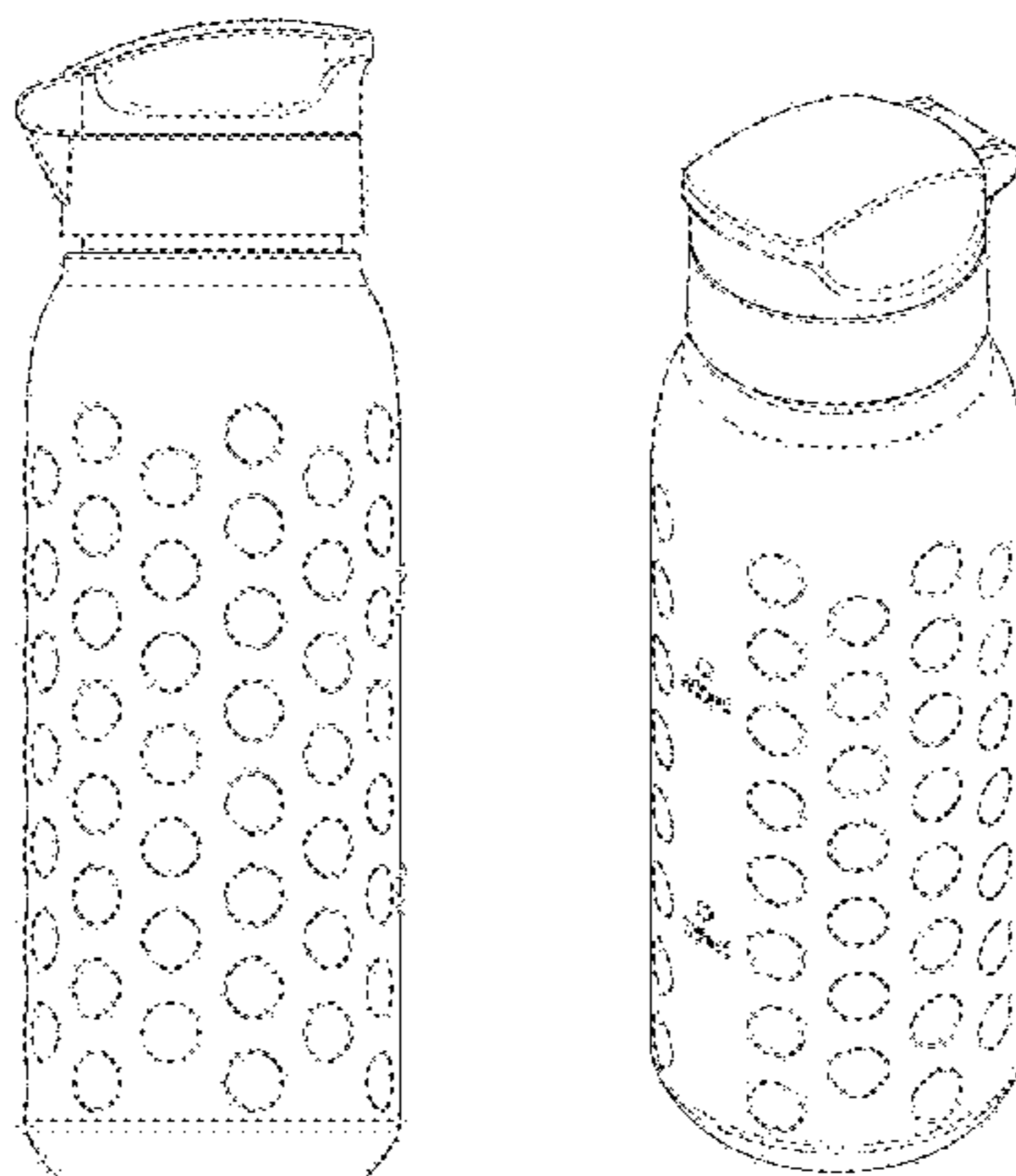
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a bottle, in a closed position, showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof; the right side view being a mirror image;
FIG. 4 is a top view thereof; and
FIG. 5 is a bottom view thereof;
FIG. 6 is a top perspective view thereof;
FIG. 7 is a top perspective view of the bottle shown in FIG. 1, in an opened position;
FIG. 8 is a front view of a second embodiment of a bottle, in a closed position;
FIG. 9 is a rear view thereof;
FIG. 10 is a left side view thereof; the right side view being a mirror image;
FIG. 11 is a top view thereof;
FIG. 12 is a bottom view thereof;
FIG. 13 is a top perspective view thereof; and,
FIG. 14 is a top perspective view of the bottle shown in FIG. 8 in an opened position.

The broken lines in the drawings depict portions of the bottle that form no part of the claimed design.

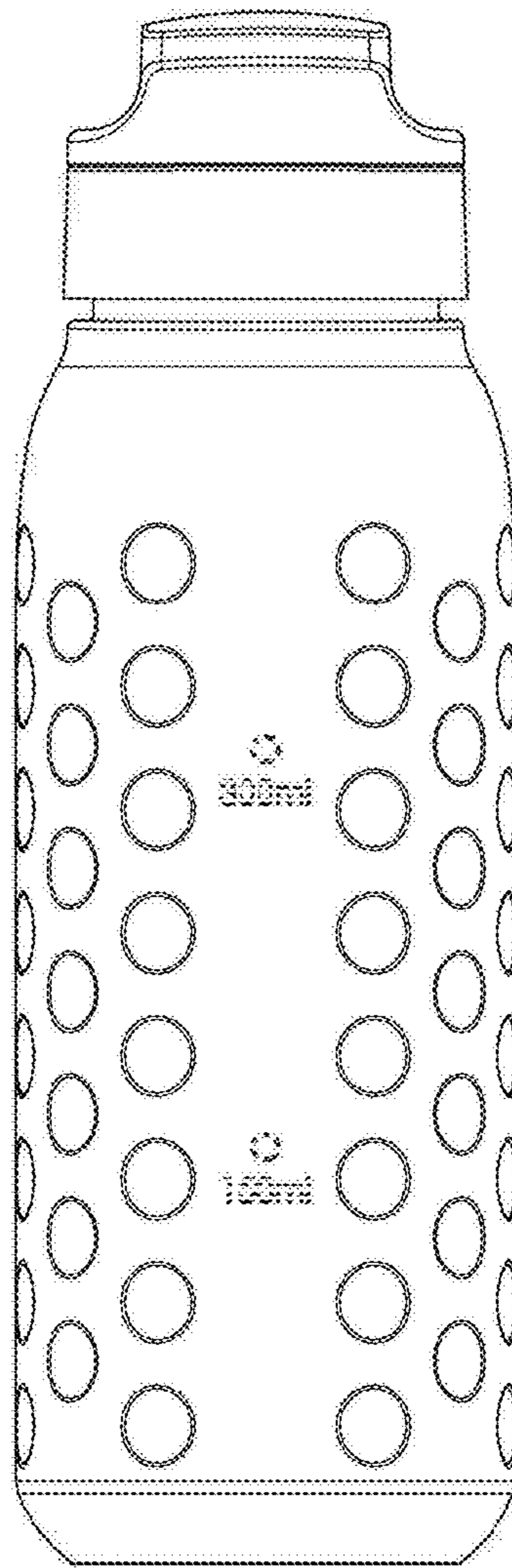

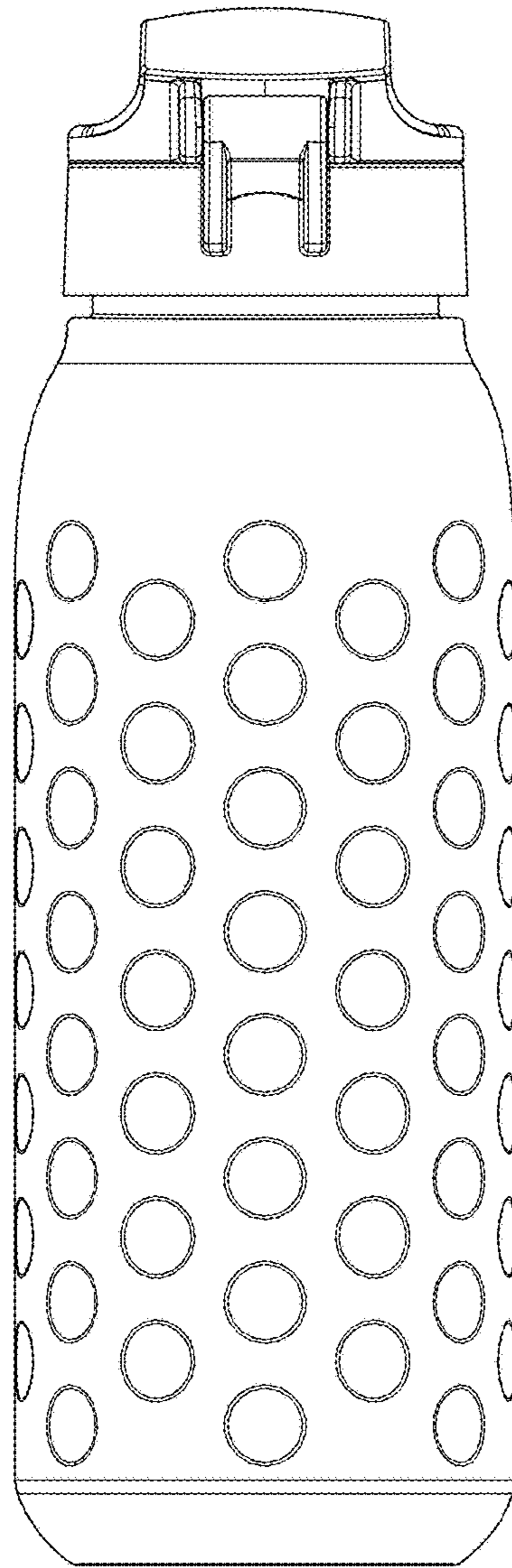

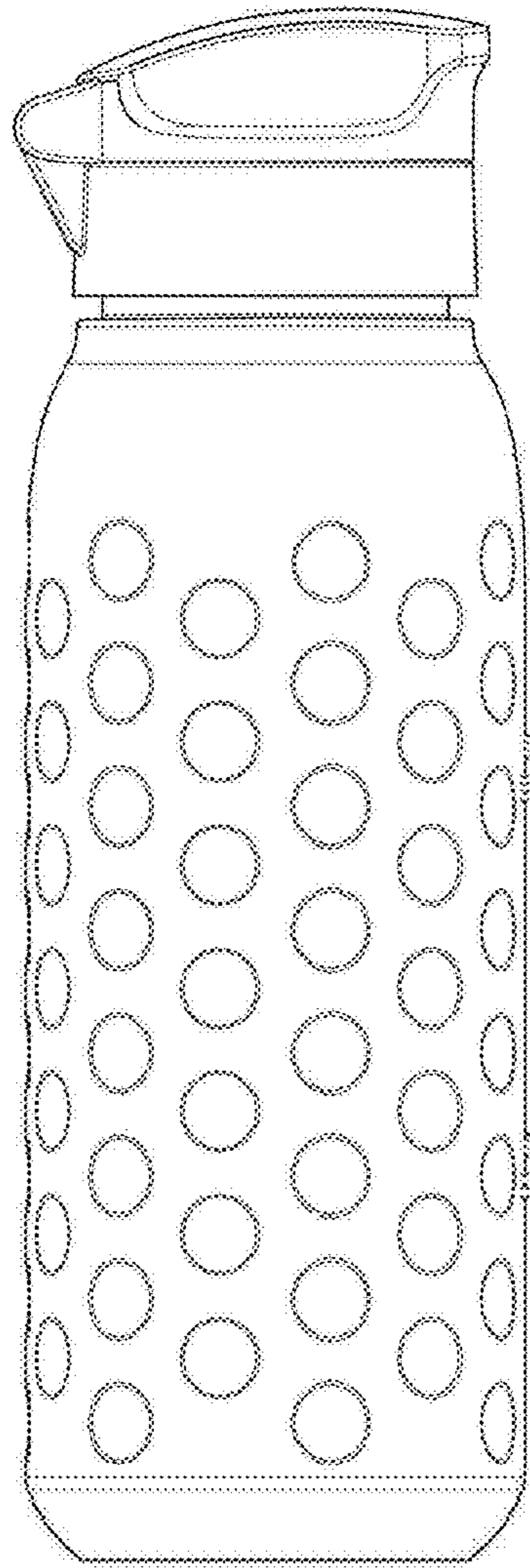

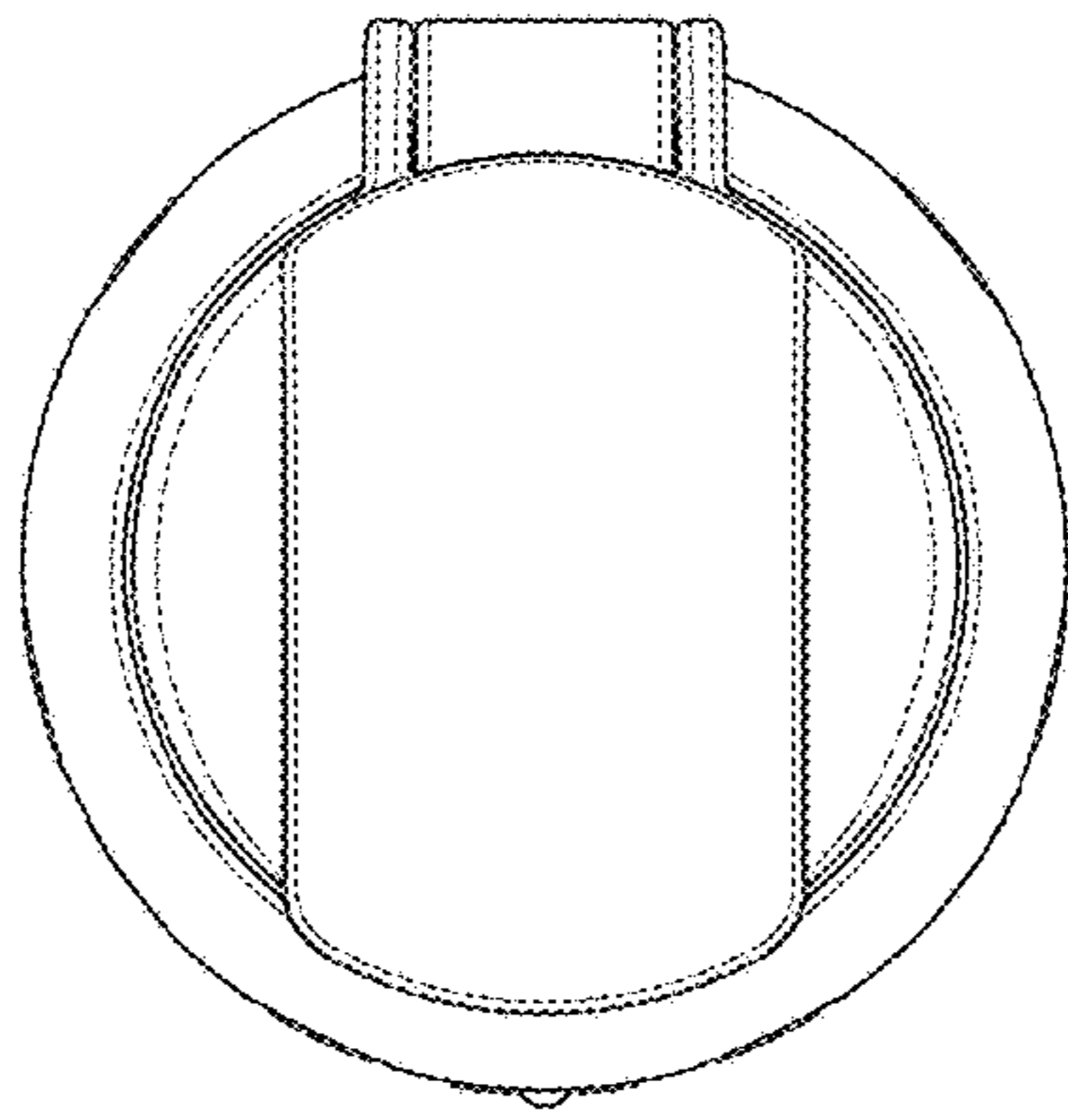

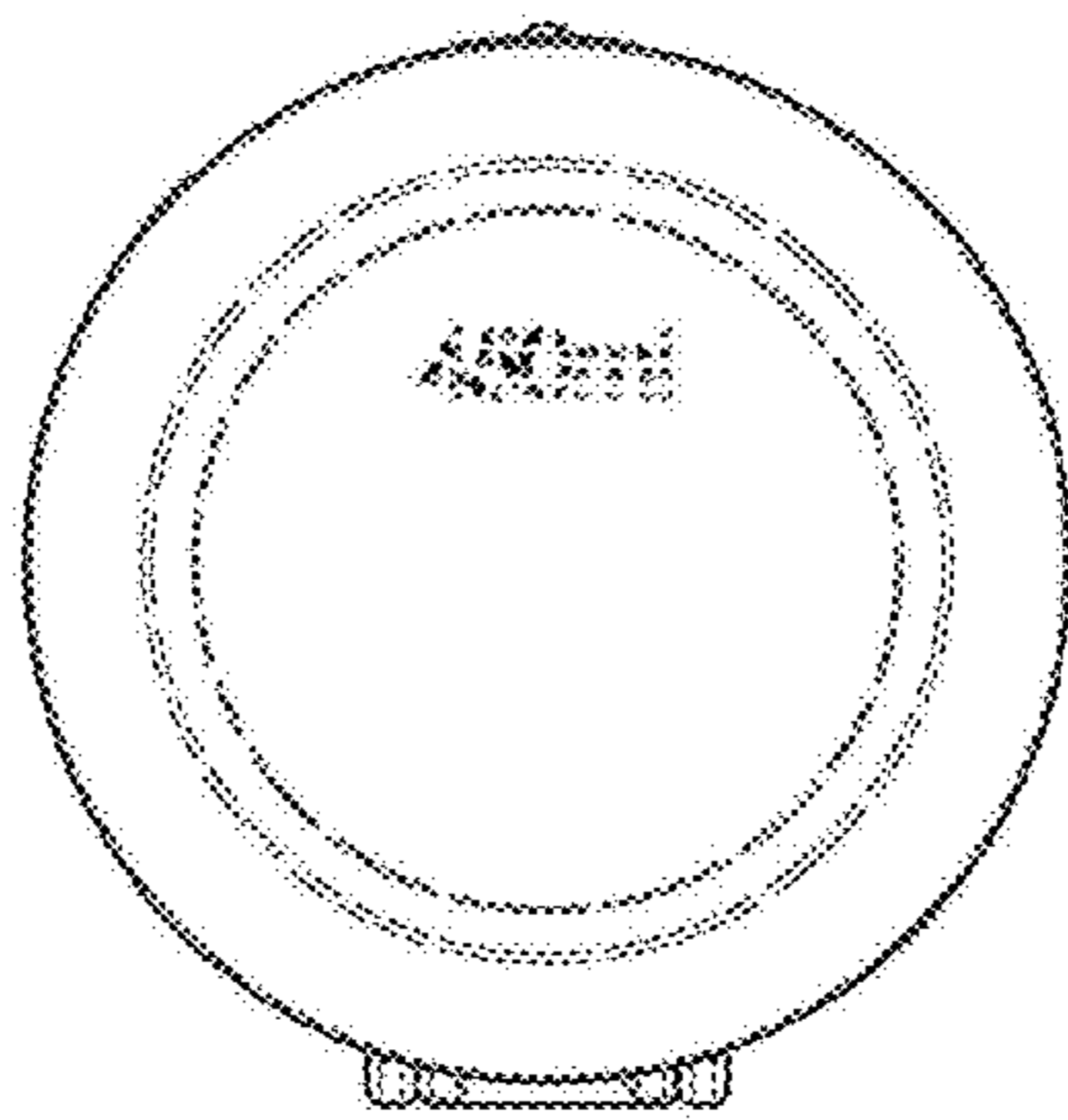

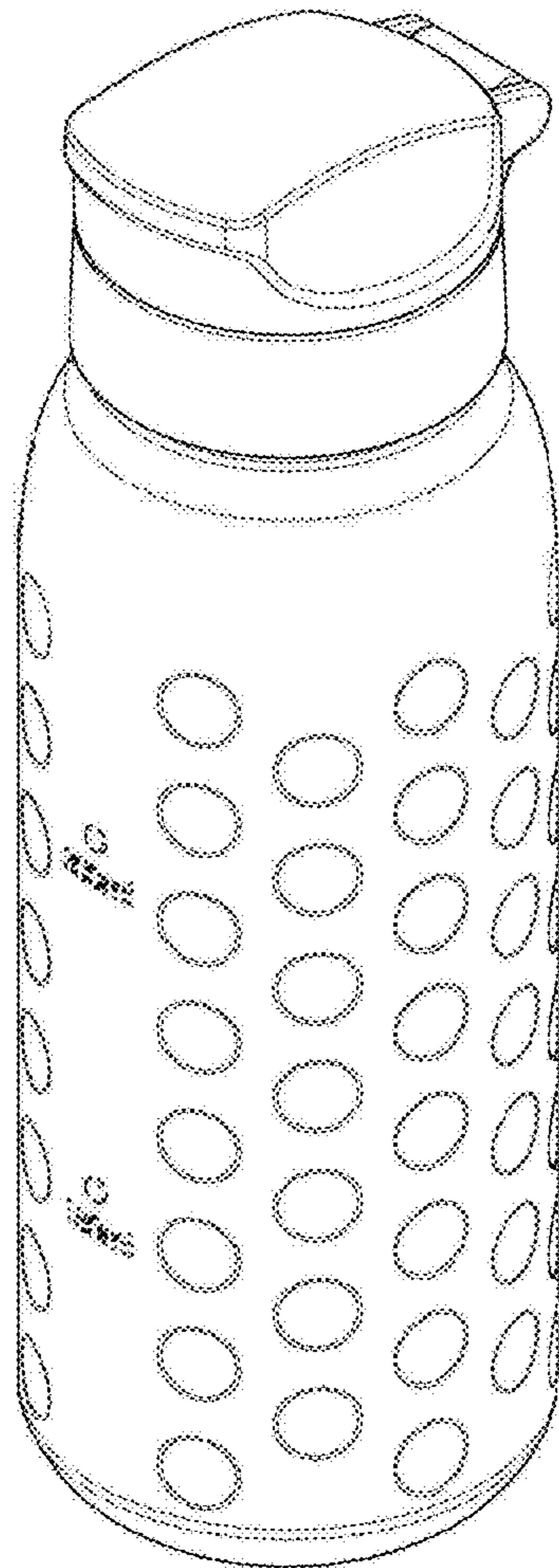

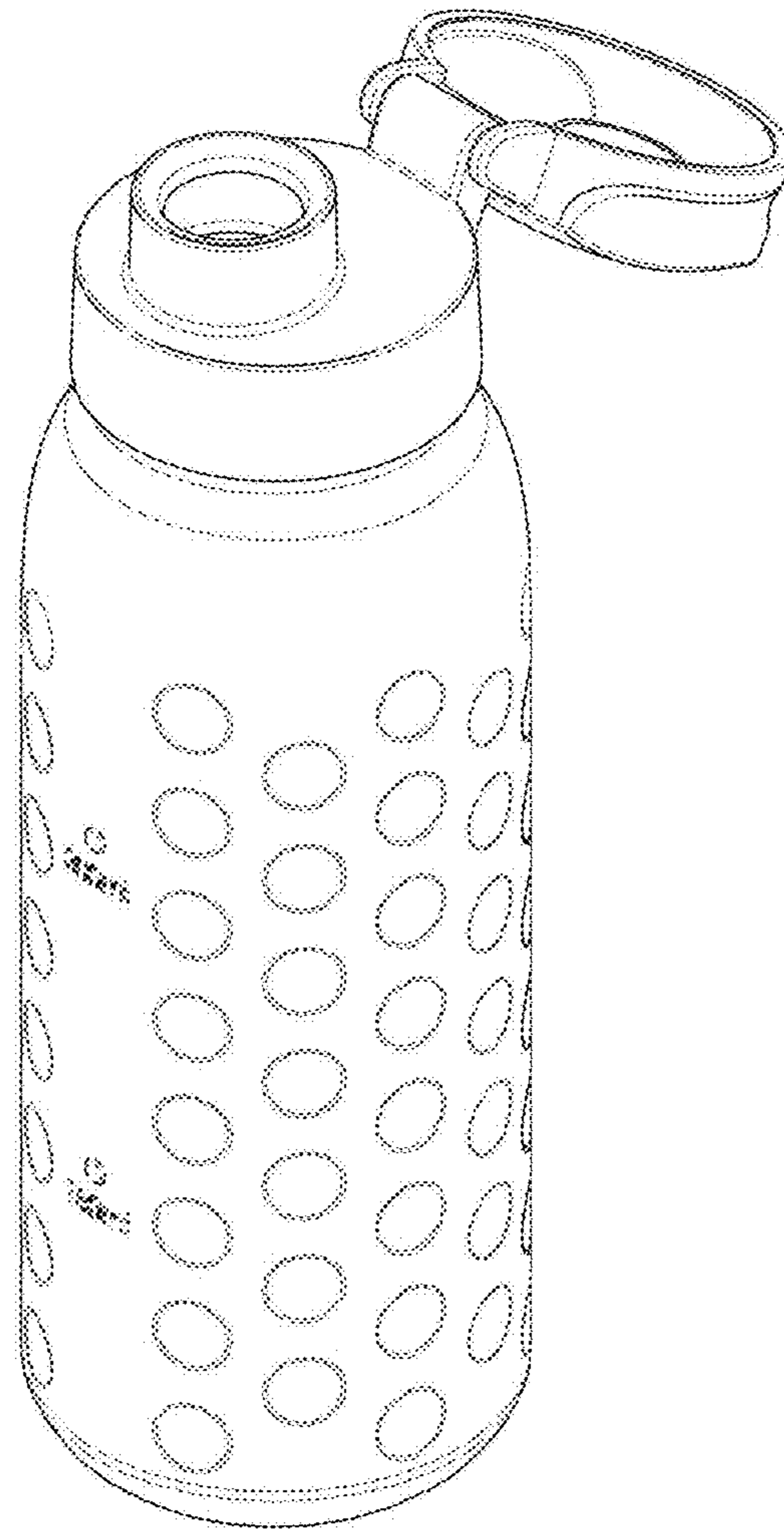

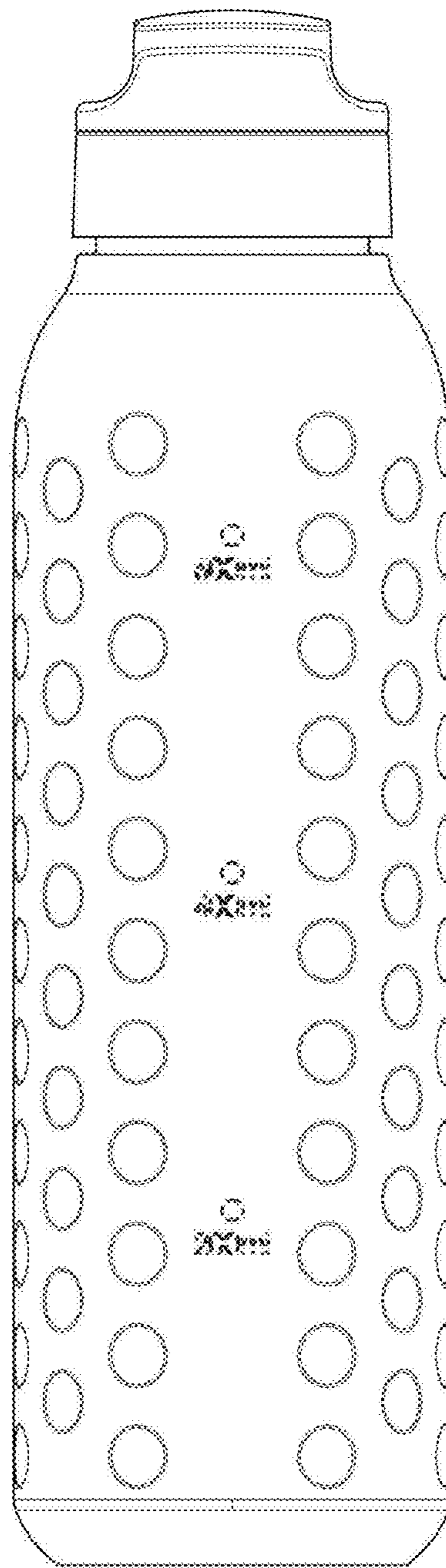

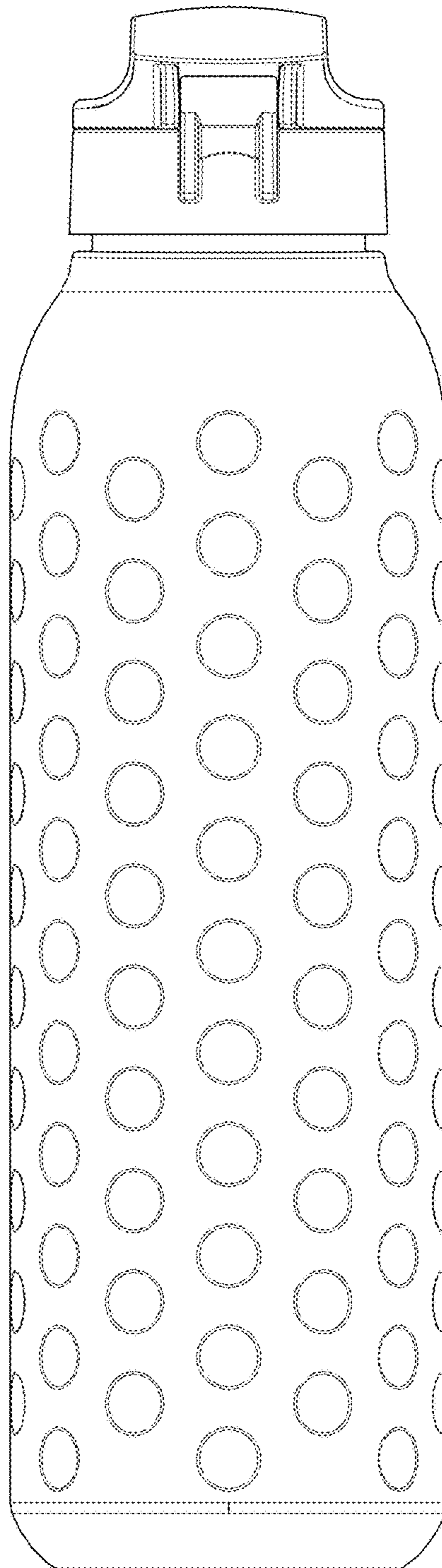

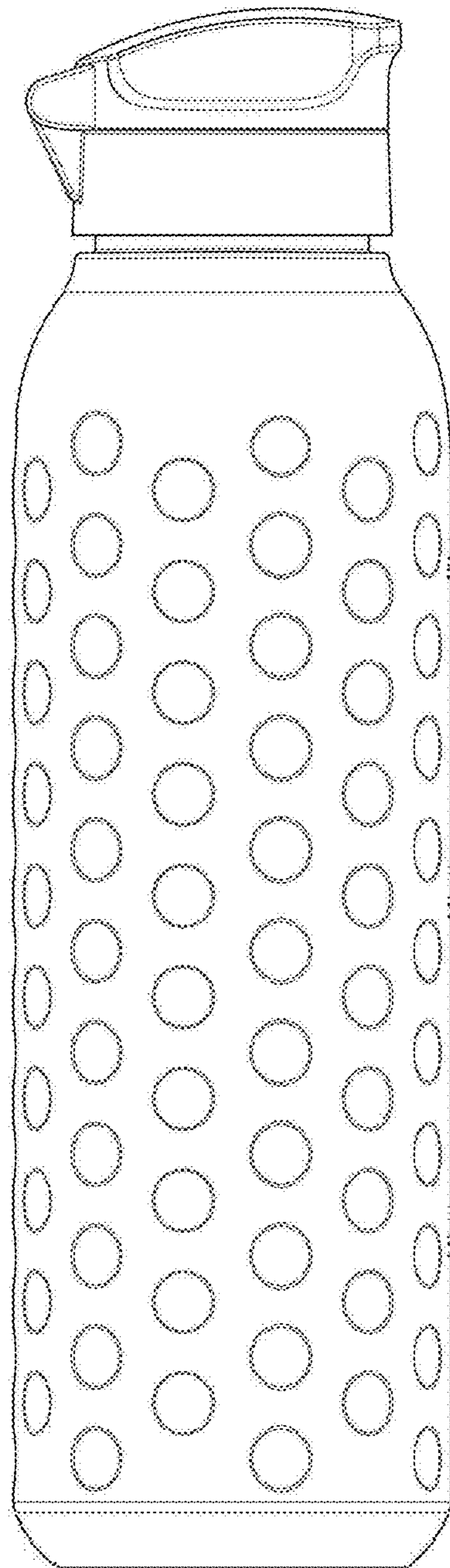

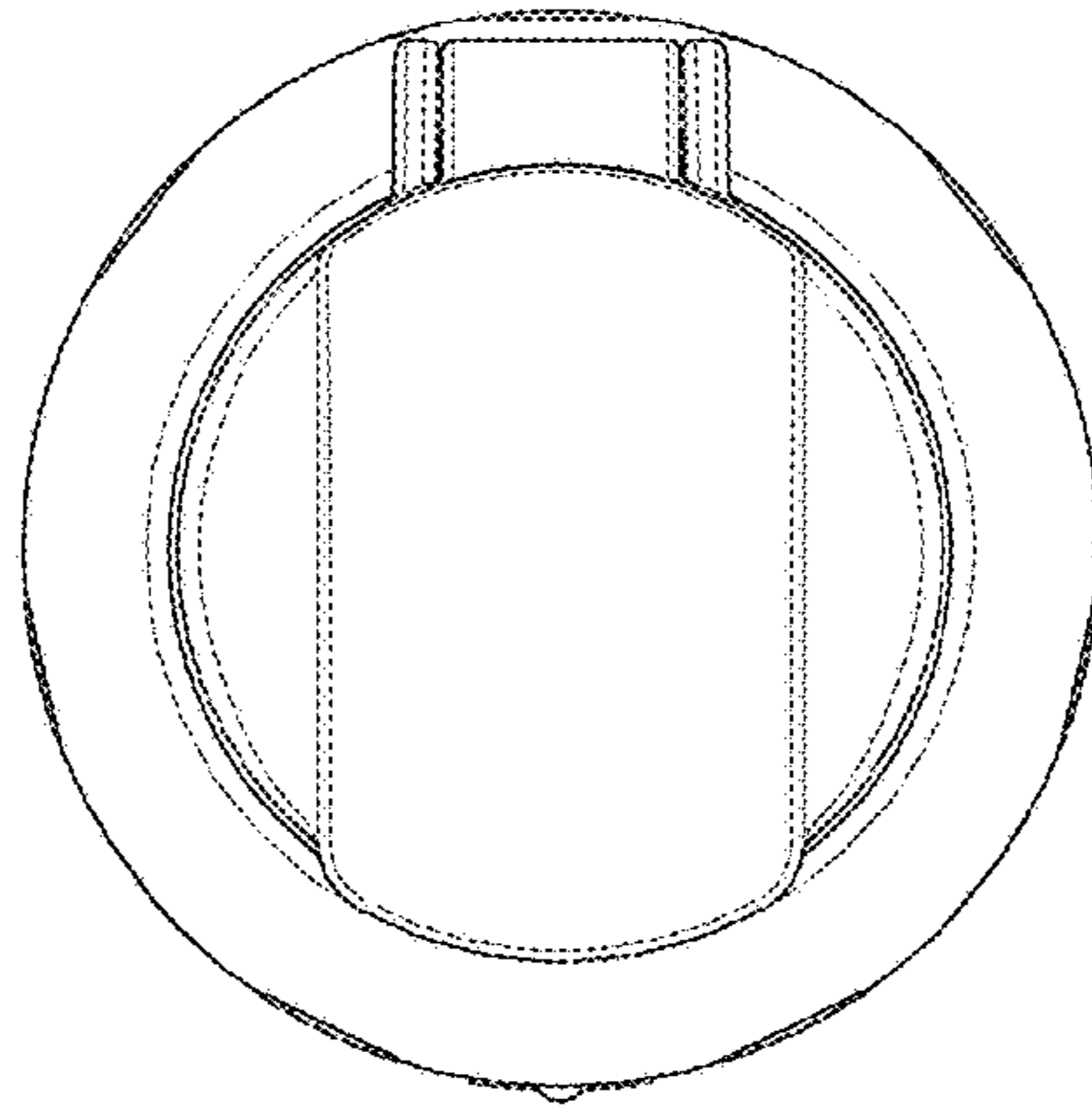

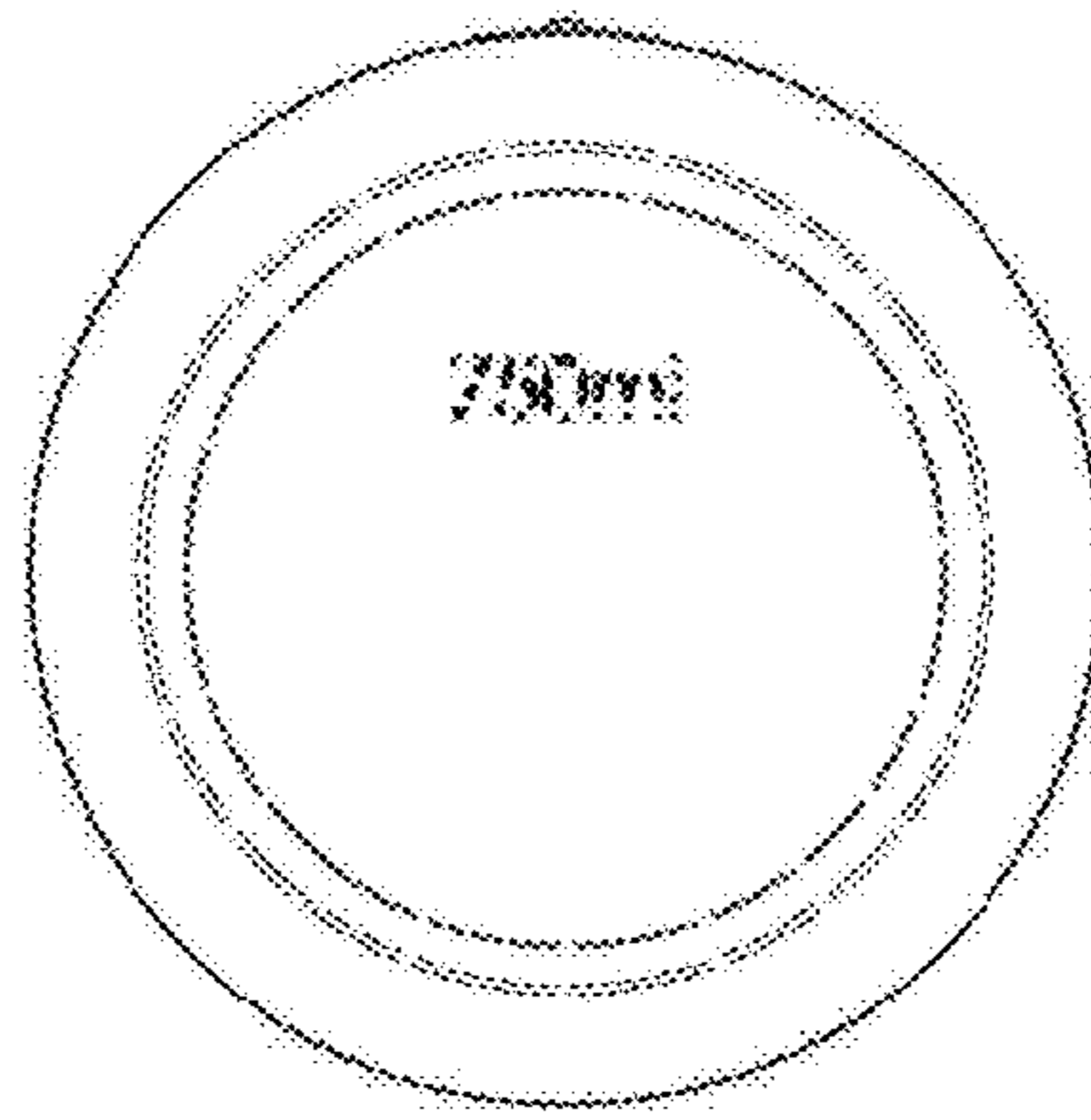

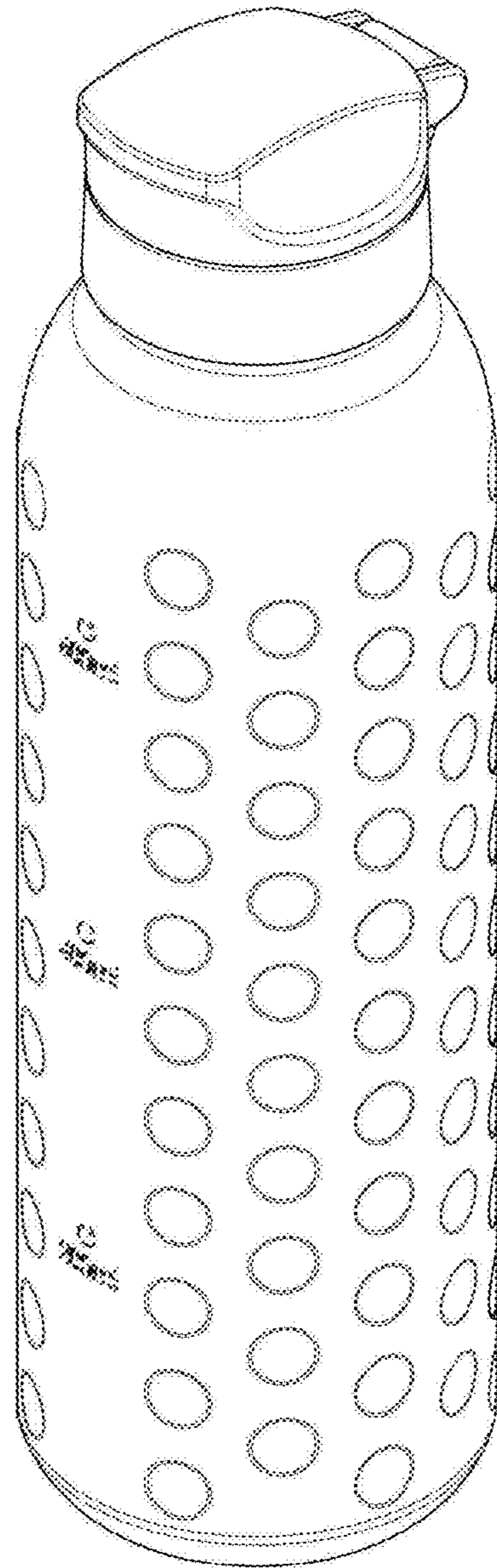

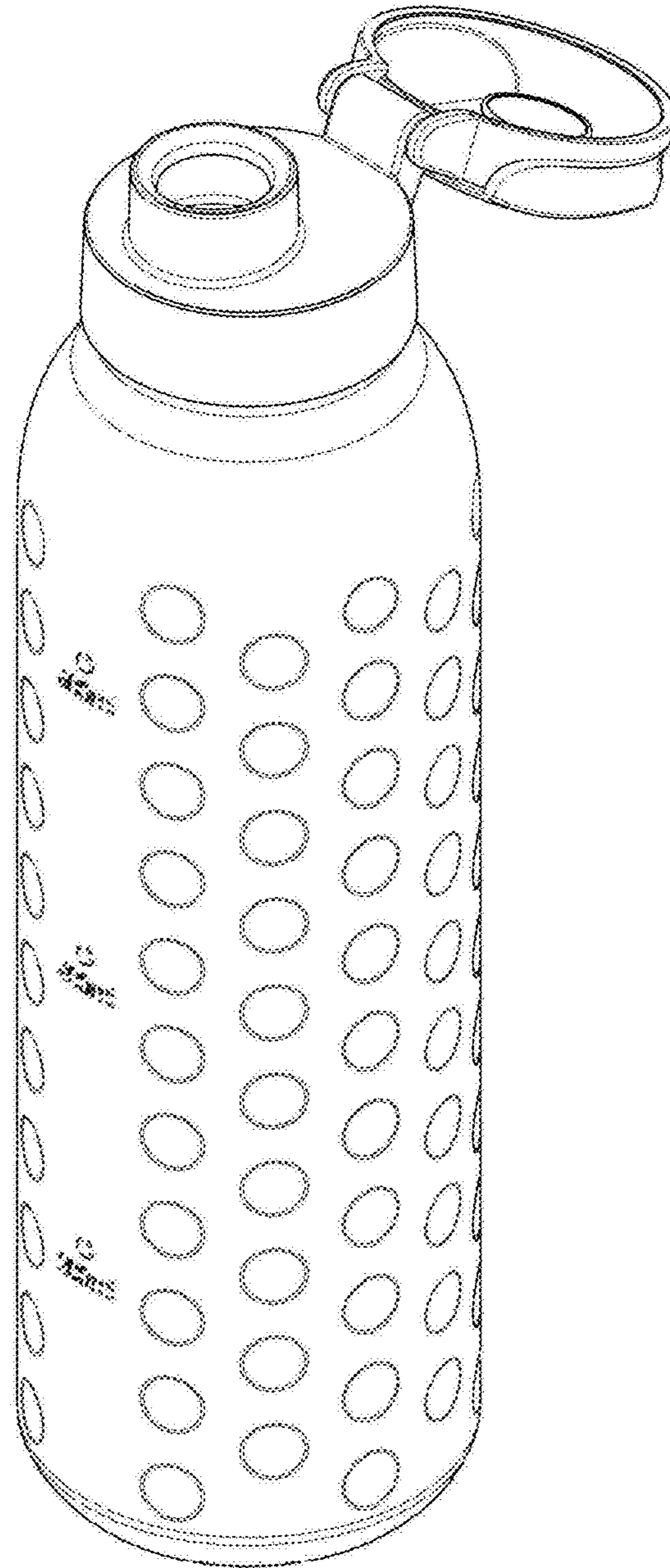
