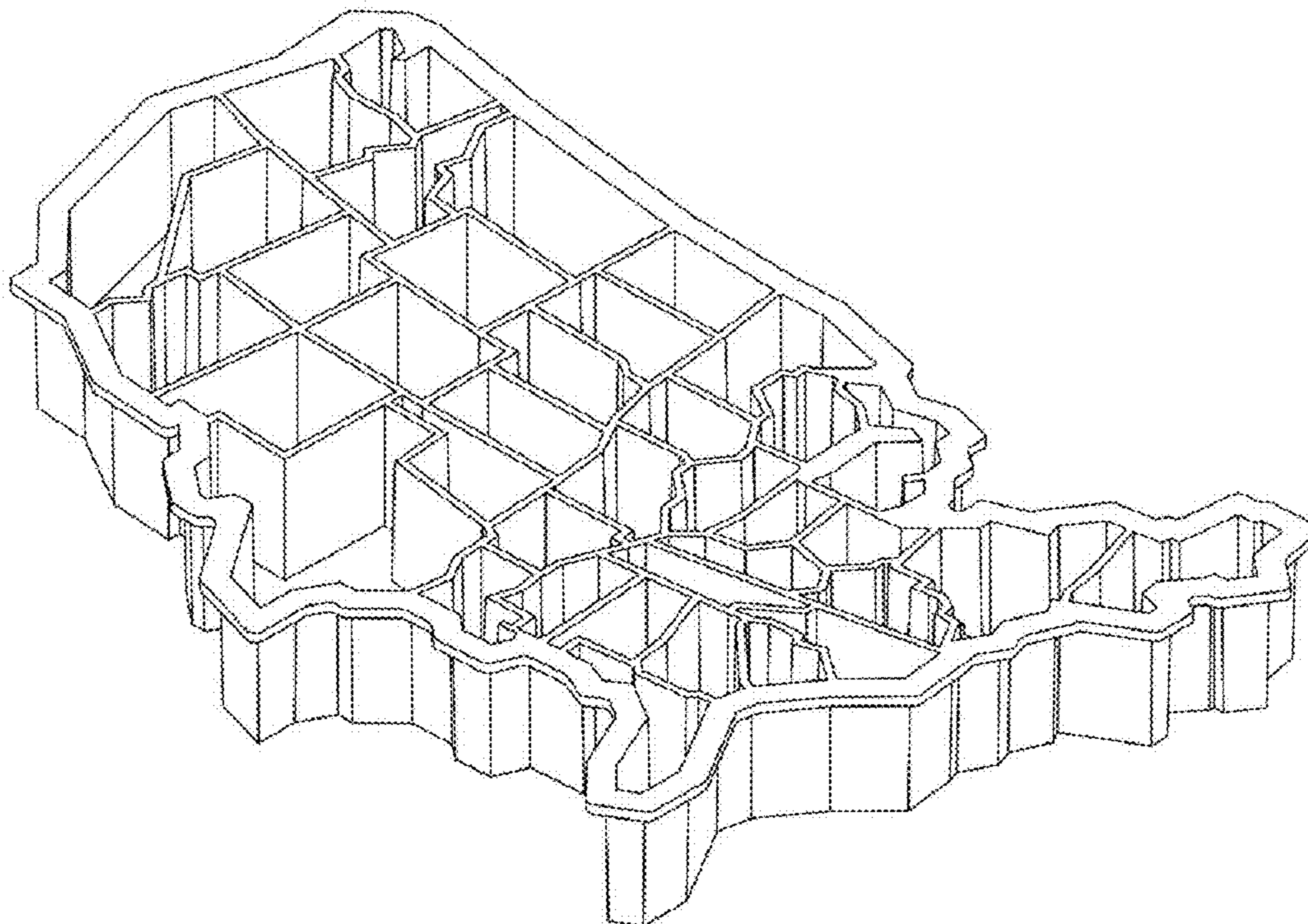
(57) **CLAIM**

The ornamental design for an ice mold, as shown and described.

DESCRIPTION

FIG. 1 is a top view of an ice mold showing our new design; FIG. 2 is a bottom view of the ice mold of FIG. 1; FIG. 3 is a front elevation view of the ice mold of FIG. 1; FIG. 4 is a rear elevation view of the ice mold of FIG. 1; FIG. 5 is a left elevation view of the ice mold of FIG. 1; FIG. 6 is a right elevation view of the ice mold of FIG. 1; FIG. 7 is a top perspective view of the ice mold of FIG. 1; and, FIG. 8 is a bottom perspective view of the ice mold of FIG. 1.

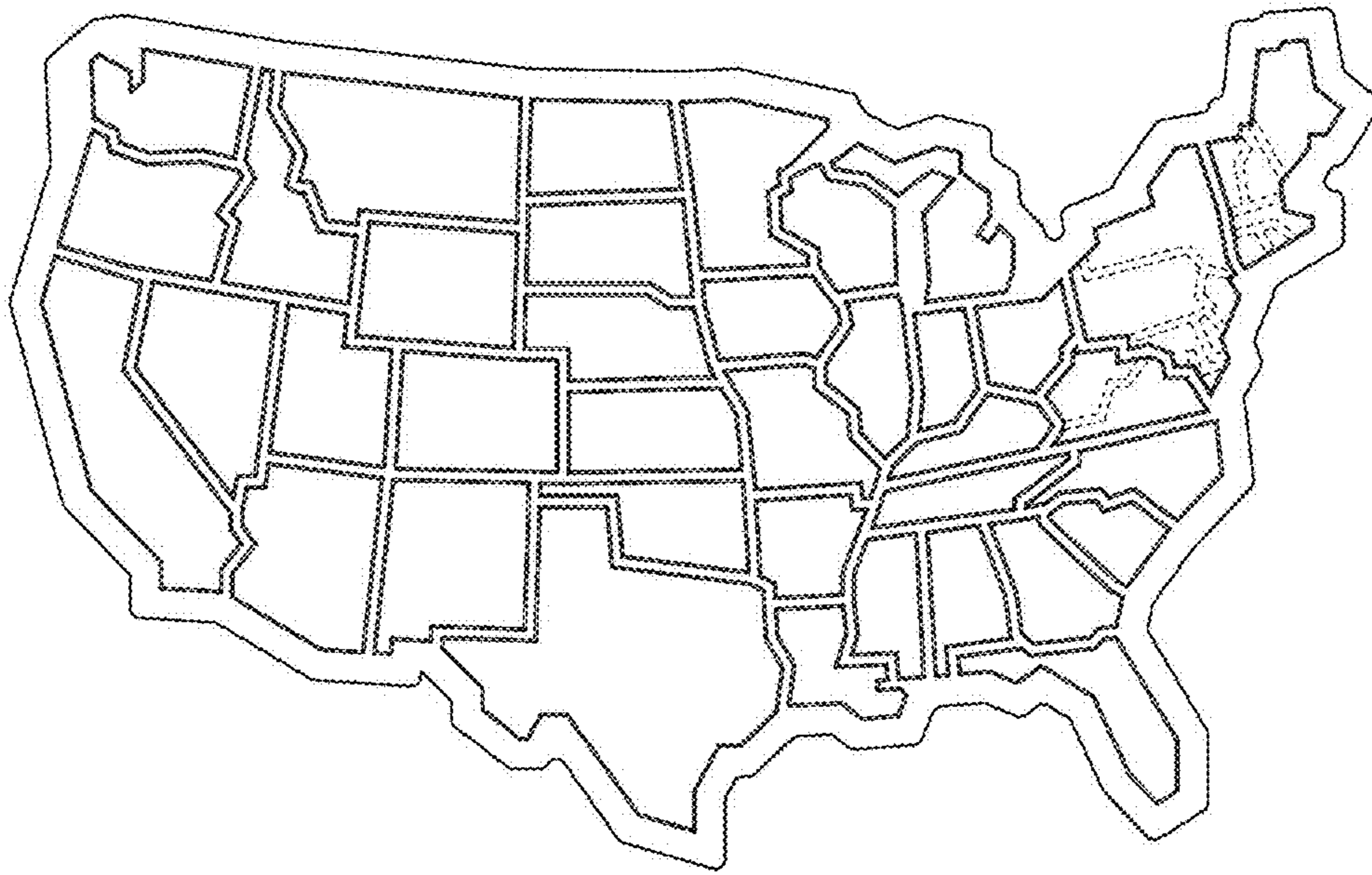

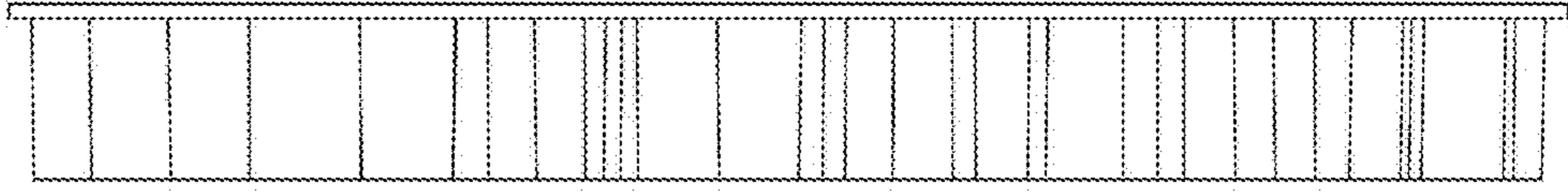

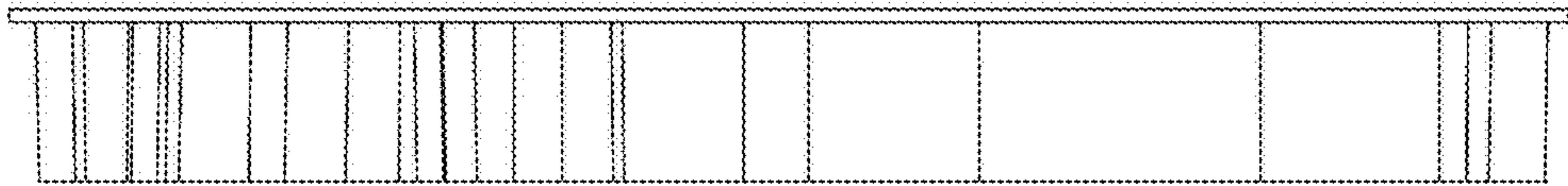

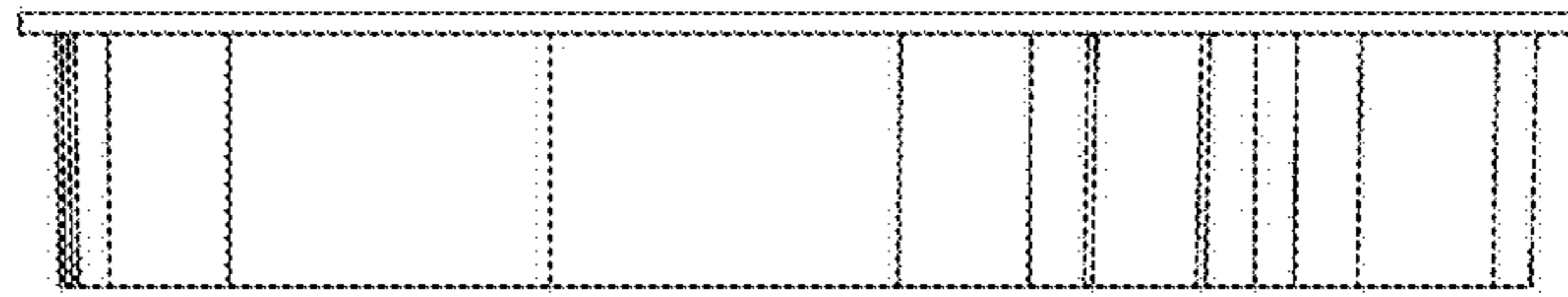

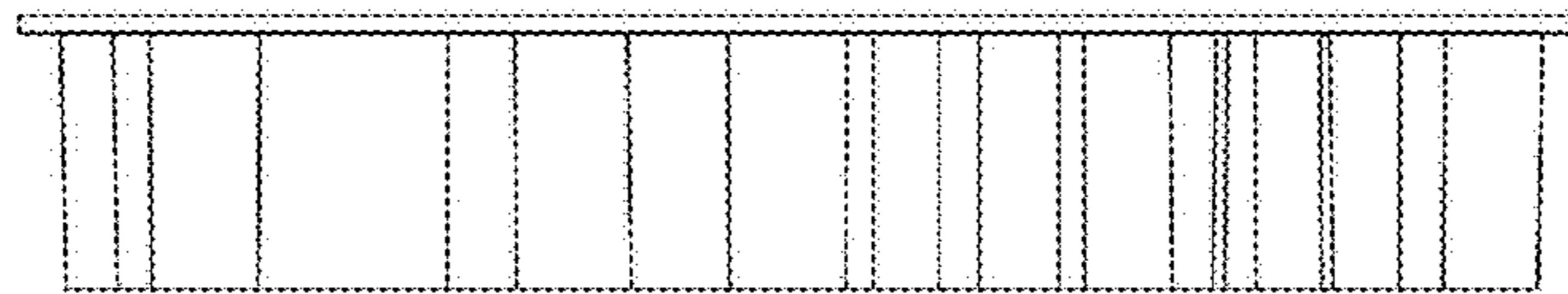

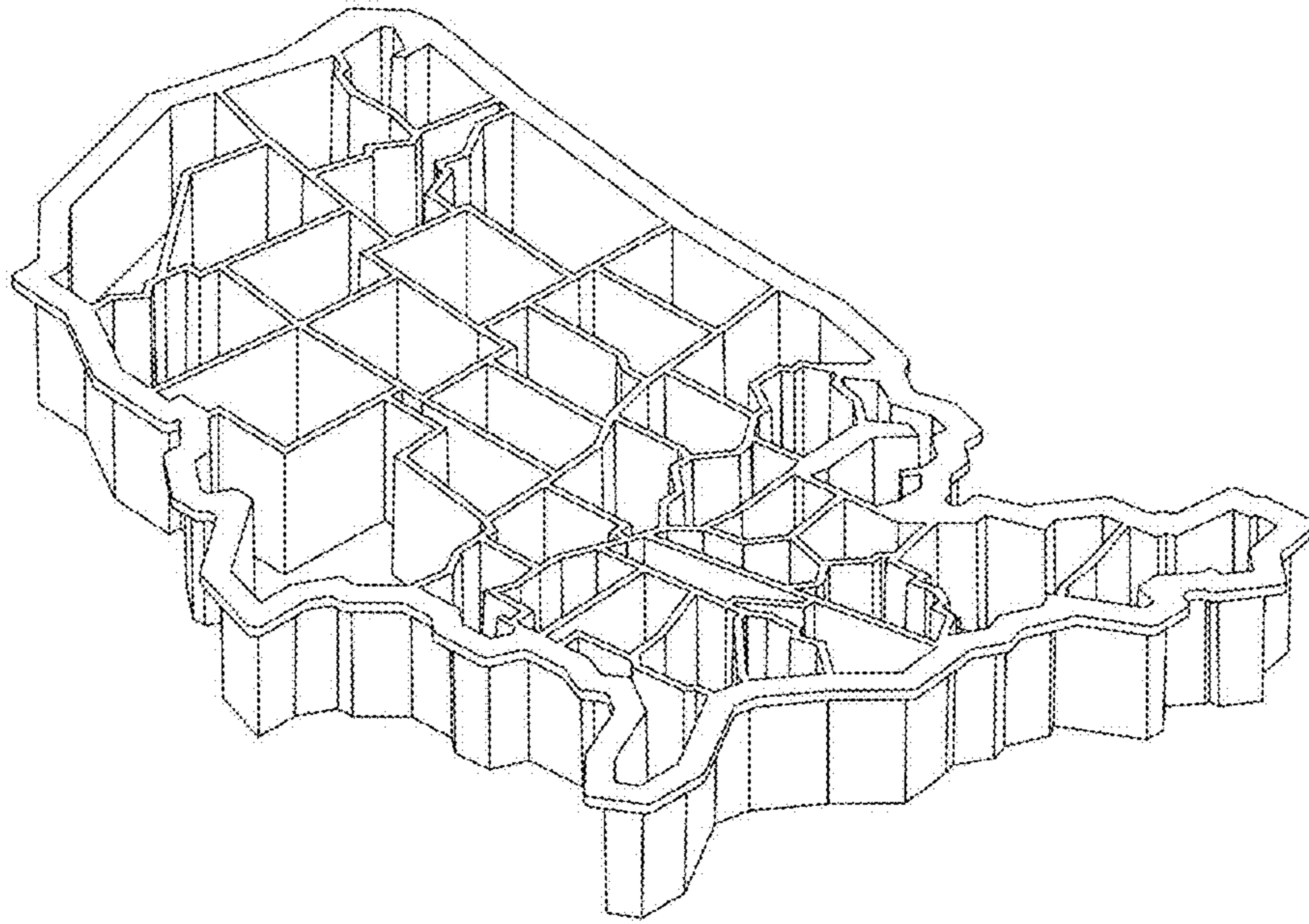

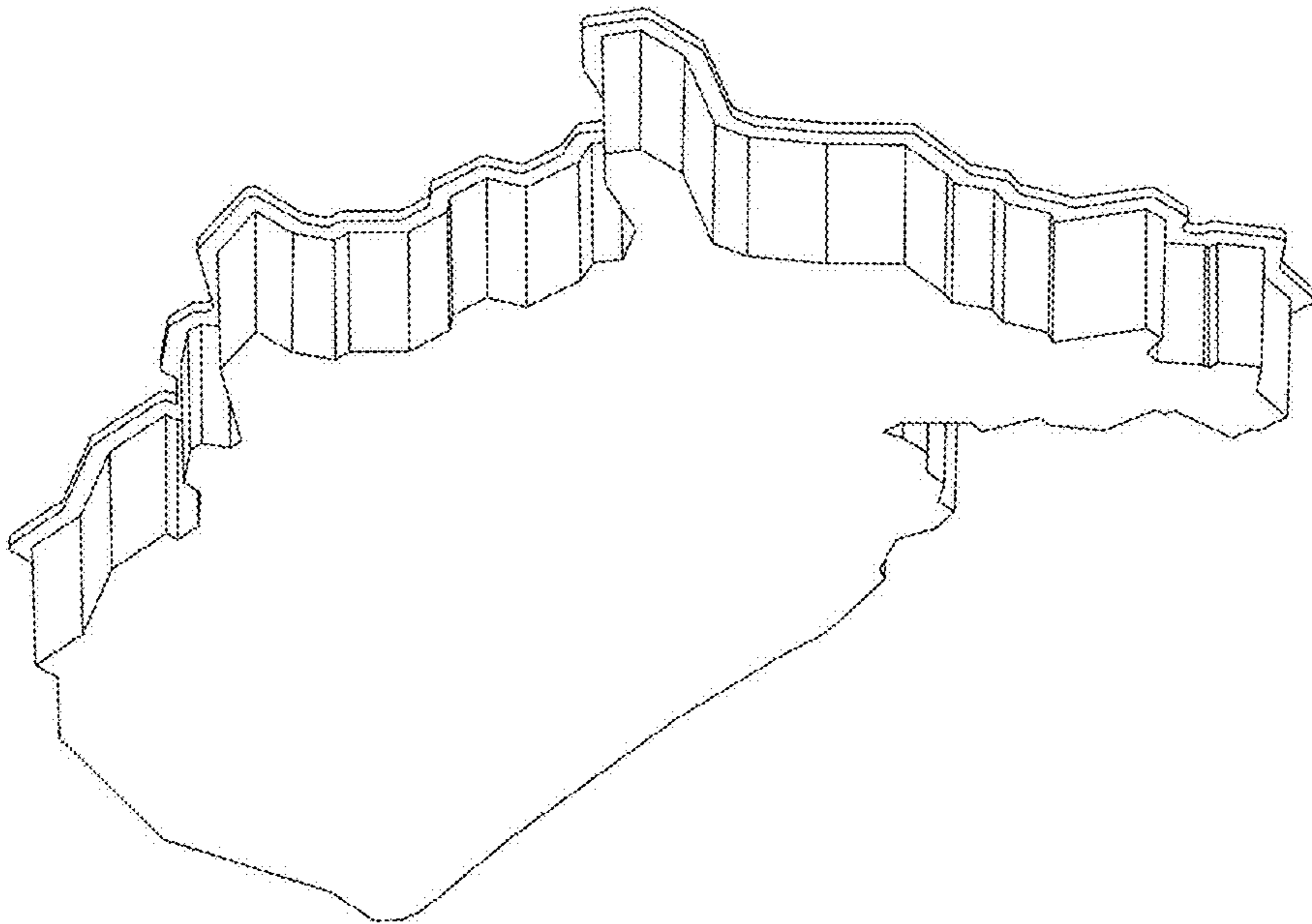
