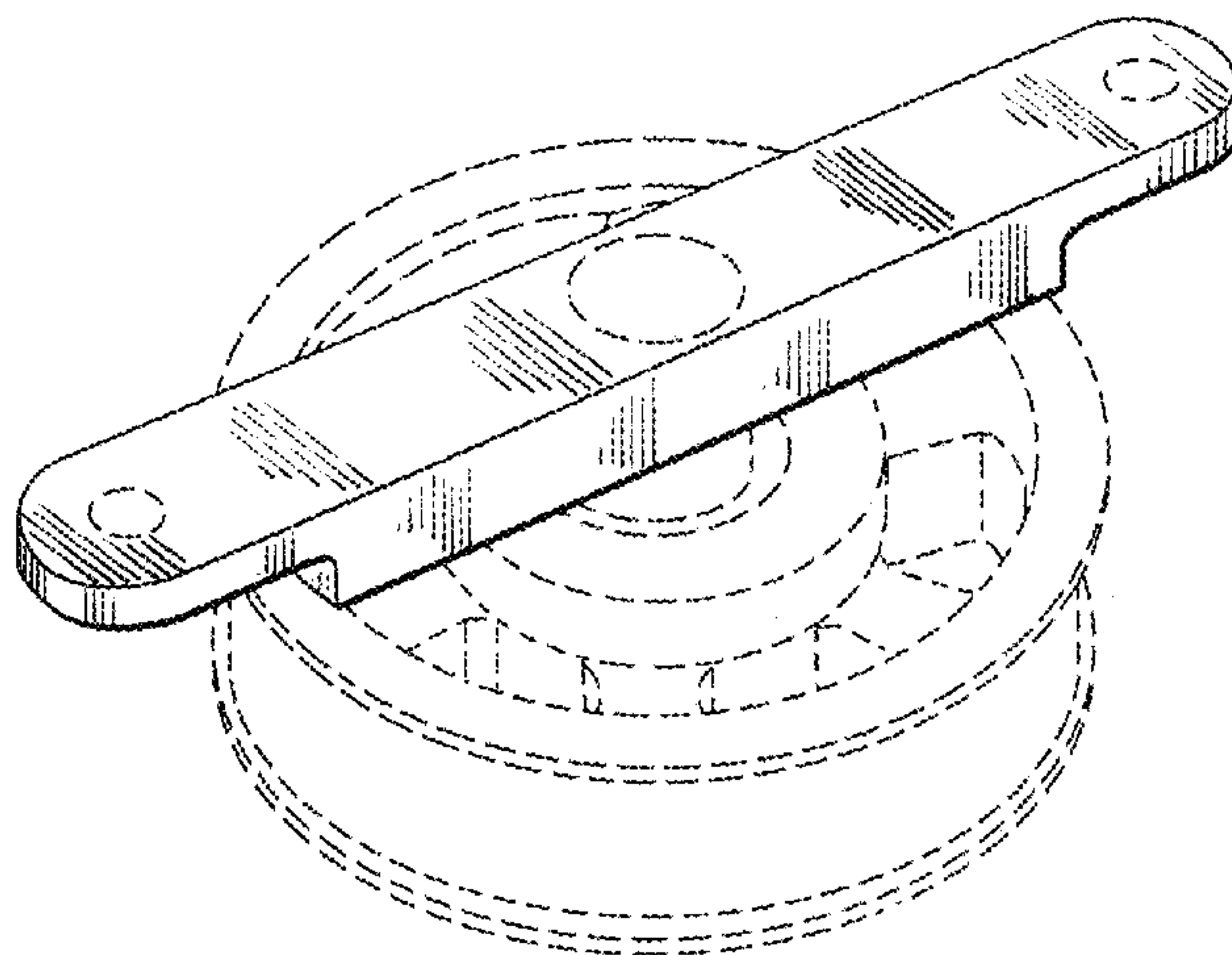
(57) **CLAIM**

The ornamental design for an idler pulley bracket, as shown and described.

DESCRIPTION

FIG. 1 is a isometric top view of an idler pulley bracket with an idler pulley in broken lines;
FIG. 2 is a isometric bottom view of an idler pulley bracket with an idler pulley and rotational axis in broken lines;
FIG. 3 is a top view of an idler pulley bracket with an idler pulley in broken lines;
FIG. 4 is a right side view of the idler pulley bracket with an idler pulley in broken lines;
FIG. 5 is a bottom view of the idler pulley bracket with an idler pulley in broken lines;
FIG. 6 is a left side view of the idler pulley bracket with an idler pulley in broken lines; and,
FIG. 7 is an end view of the idler pulley bracket with an idler pulley in broken lines.
The broken lines in FIG. 1, FIG. 2, FIG. 3, FIG. 4, FIG. 5, FIG. 6, and FIG. 7 of the idler pulley bracket are for the purpose of illustrating environment, and form no part of the claimed design.

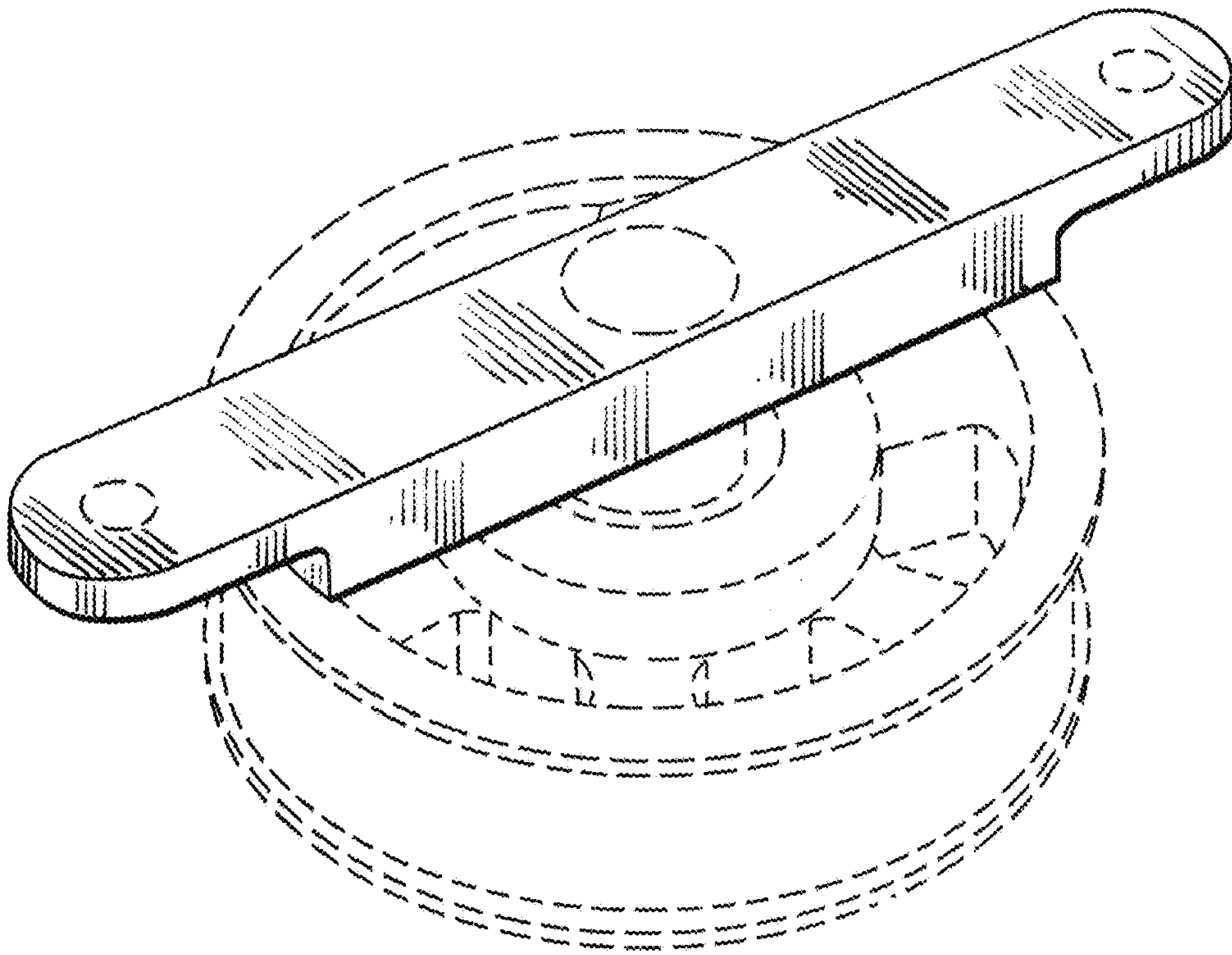

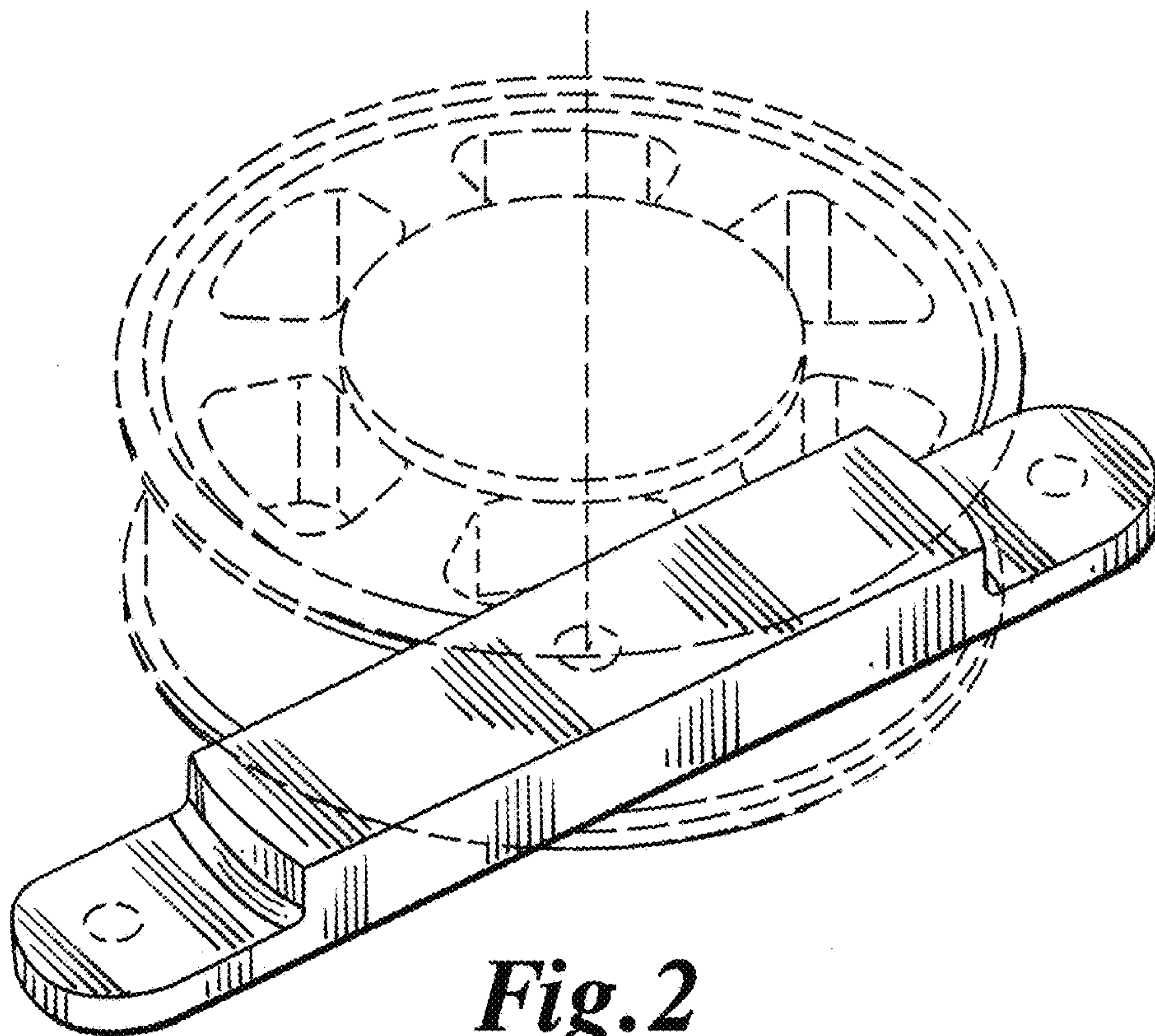

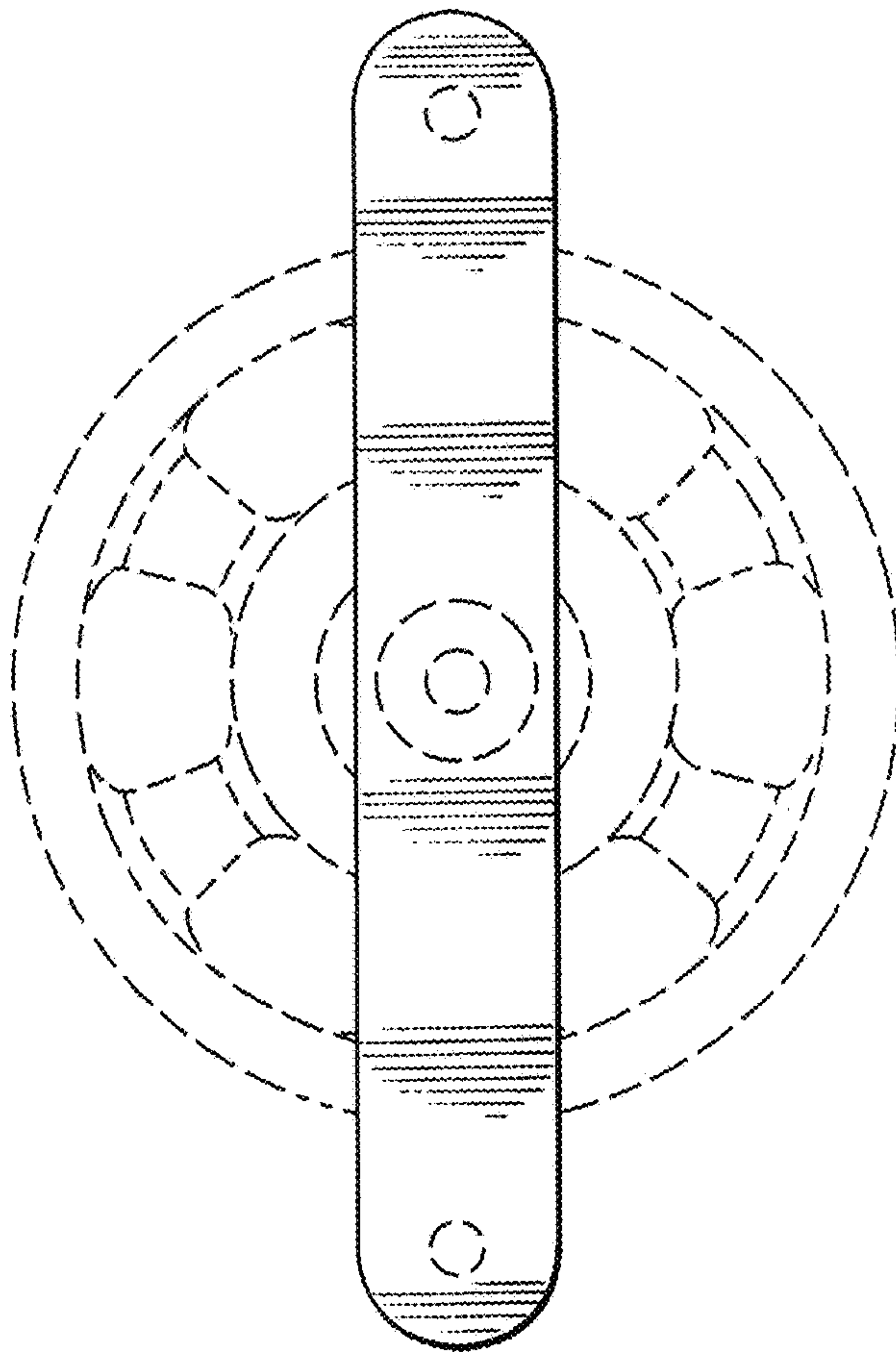

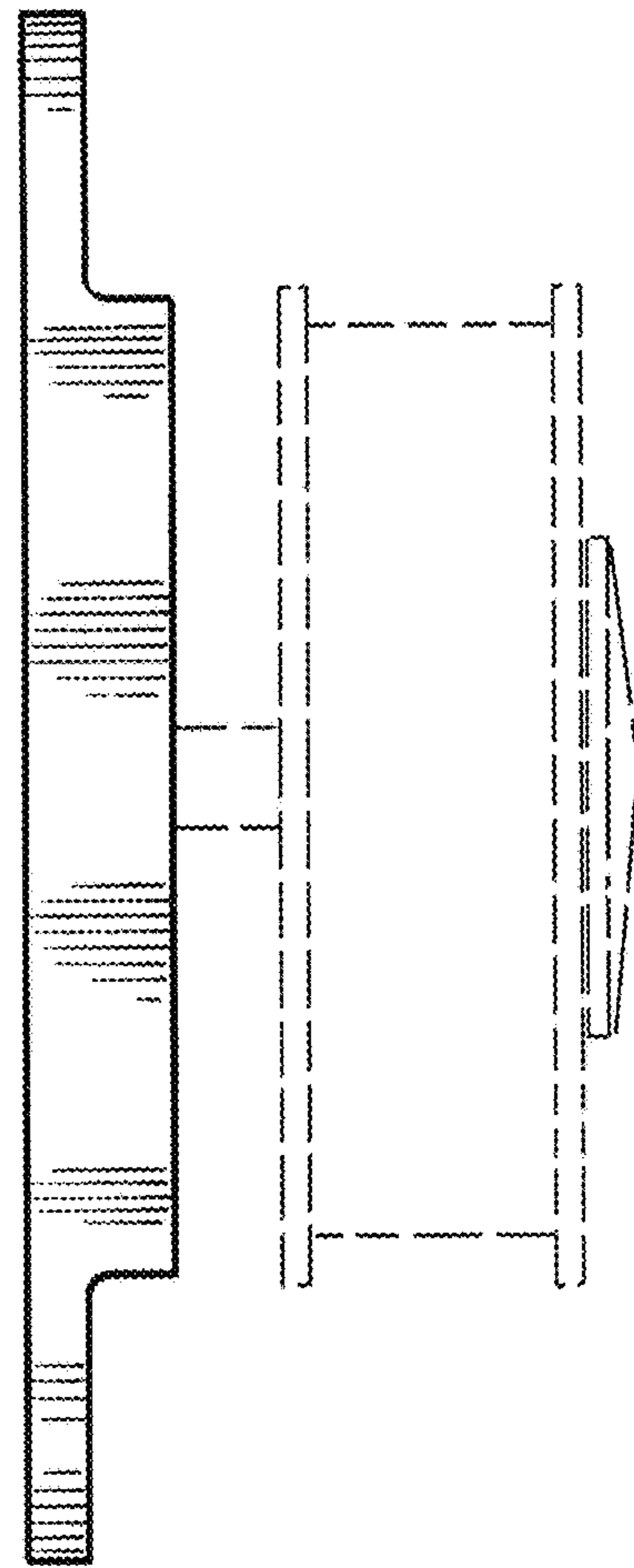

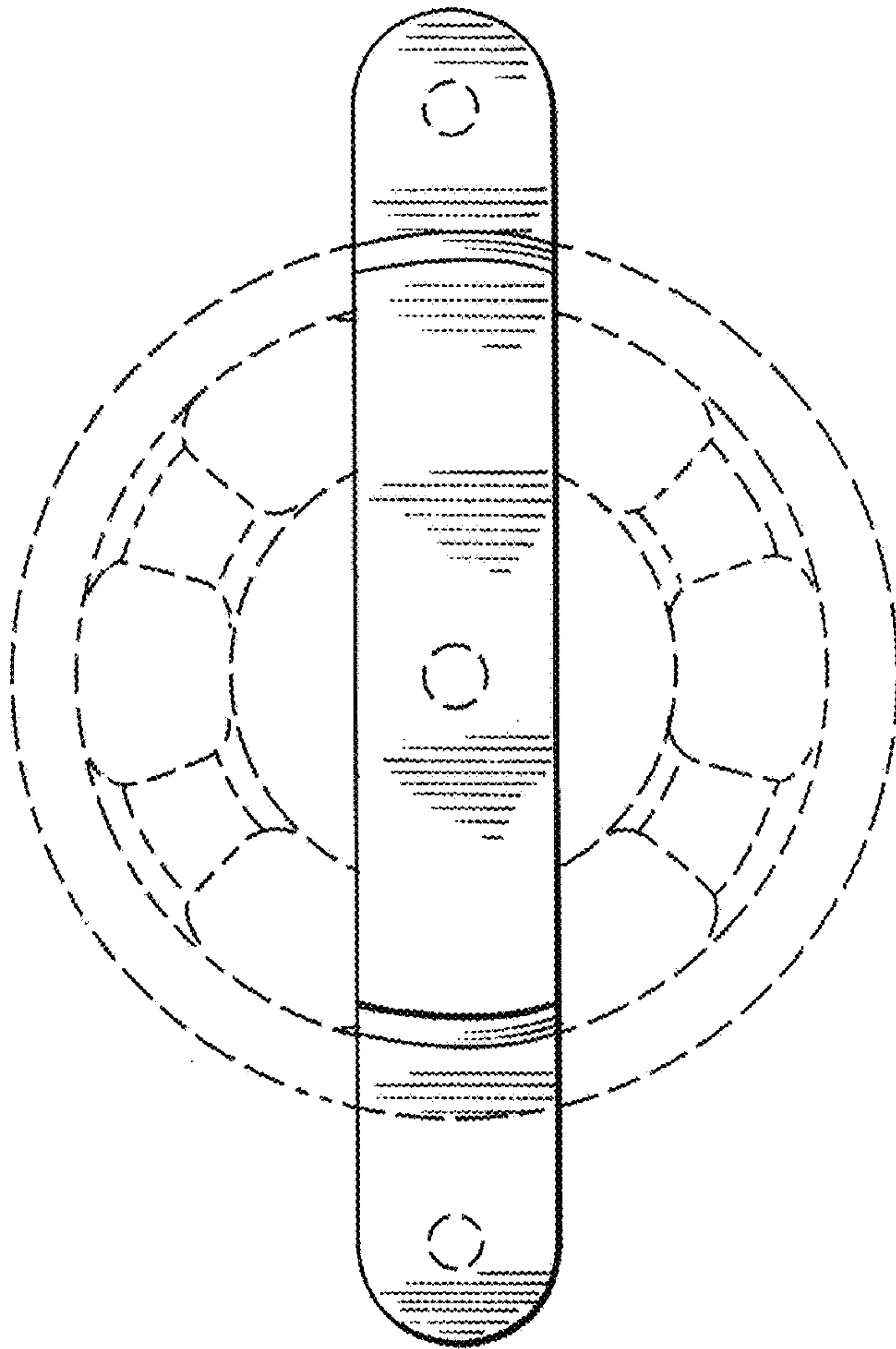

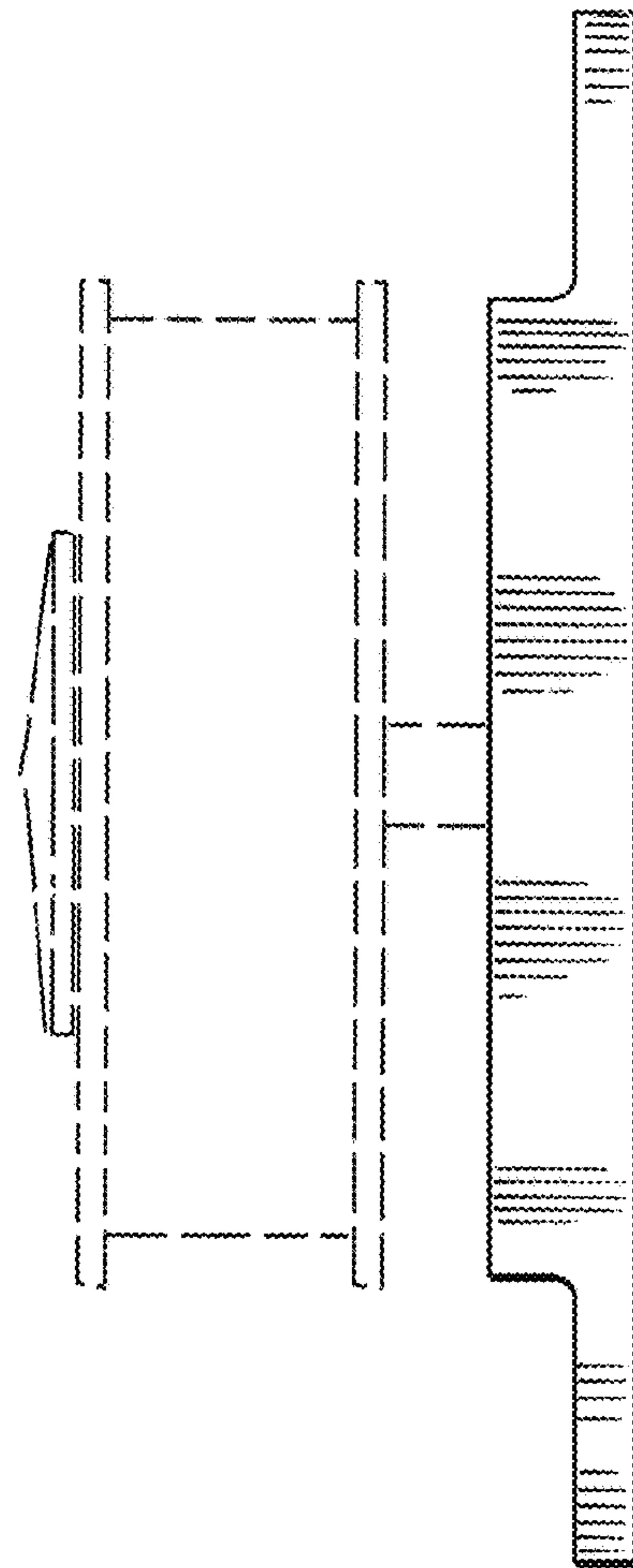

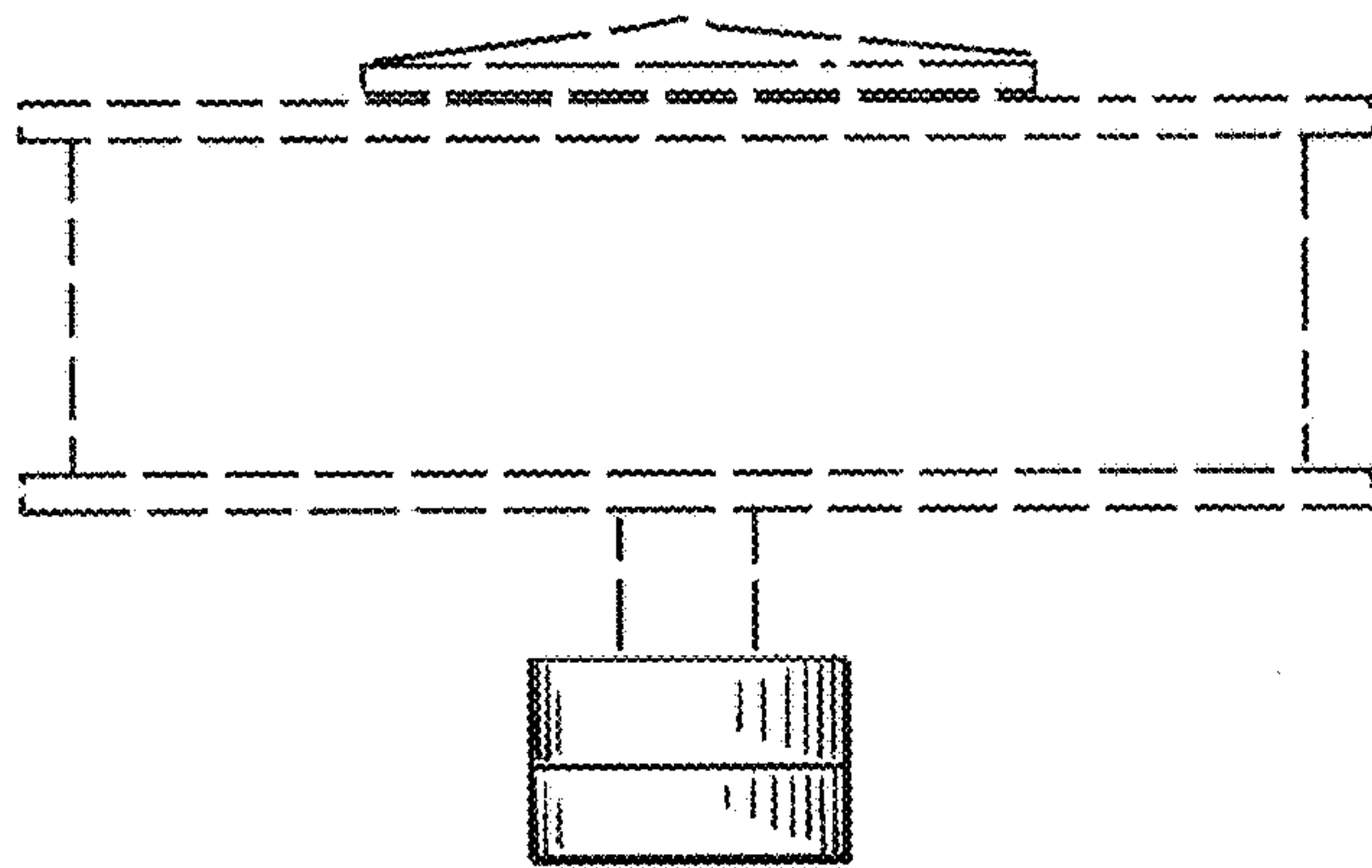
