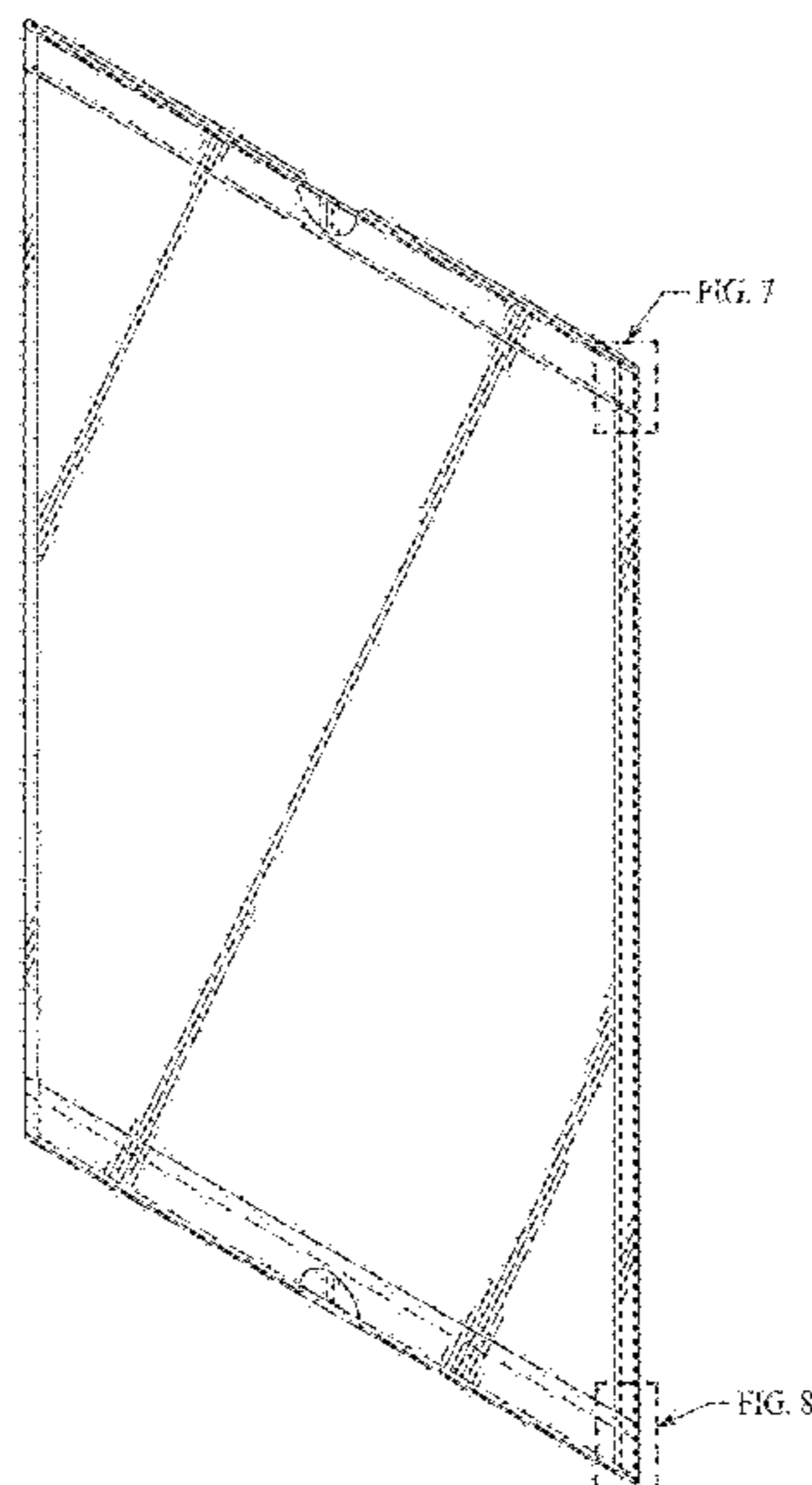
(57) **CLAIM**

The ornamental design for a bag having dual top drawstring handles and a single bottom drawstring handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bag having dual top drawstring handles and a single bottom drawstring handle, showing our new design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a right or left side view thereof.
FIG. 5 is a top view thereof.
FIG. 6 is a bottom view thereof.
FIG. 7 is a detail view of the top right corner of FIG. 1; and,
FIG. 8 is a detail view of the lower right corner of FIG. 1.
The rectangular broken line is included for the purpose of illustrating the detail of the top and lower corners of the bag and forms no part of the claimed design.

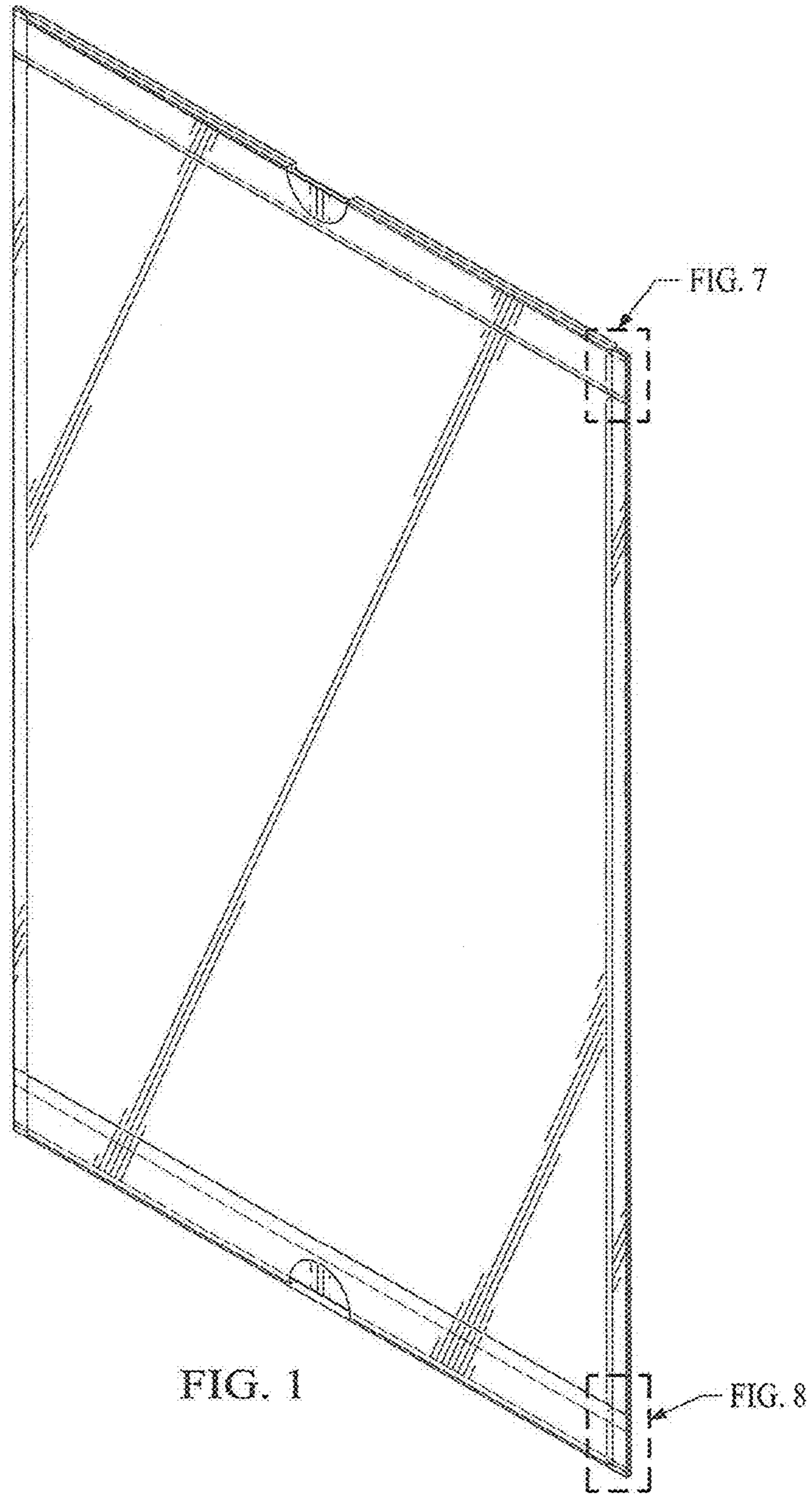

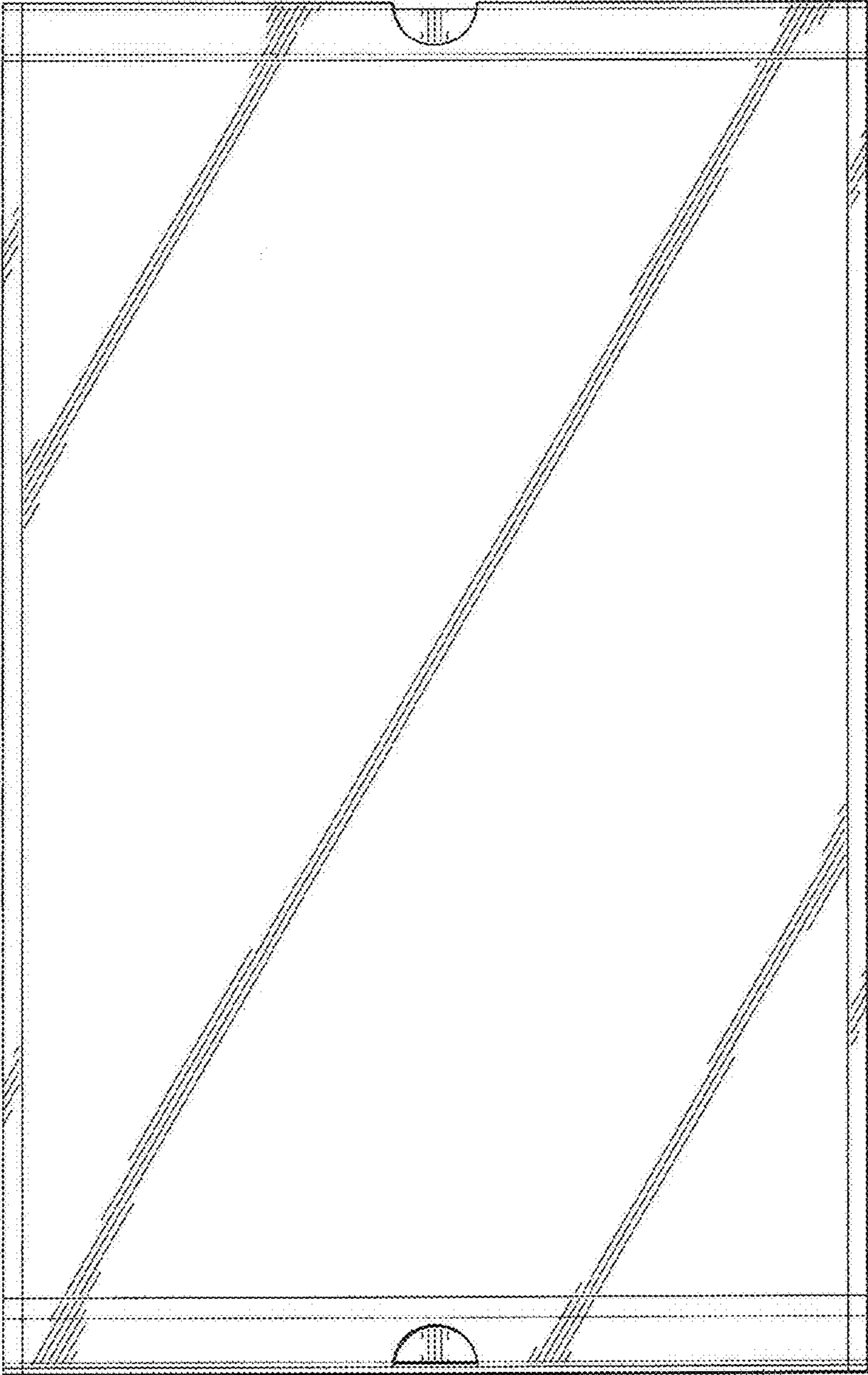

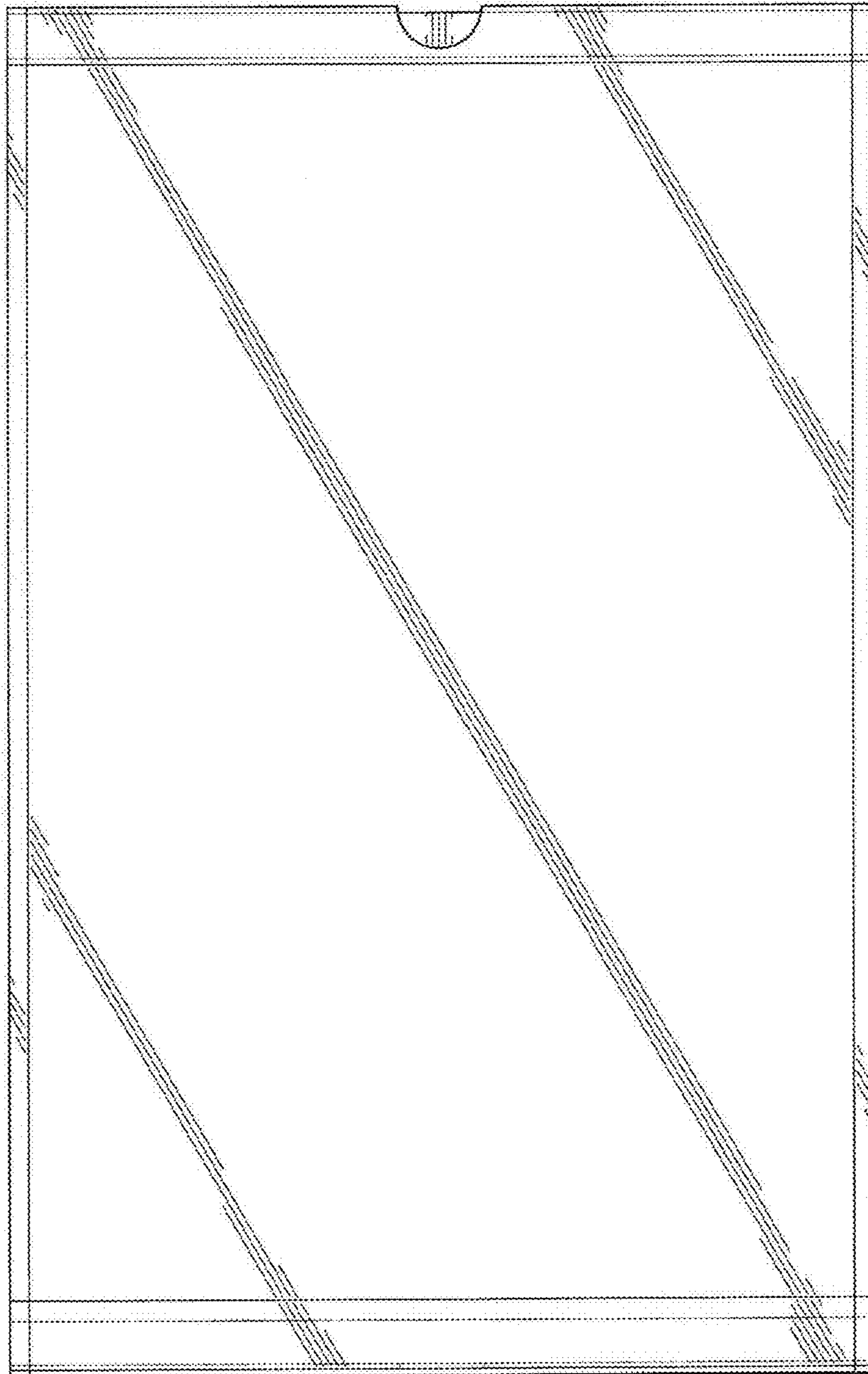

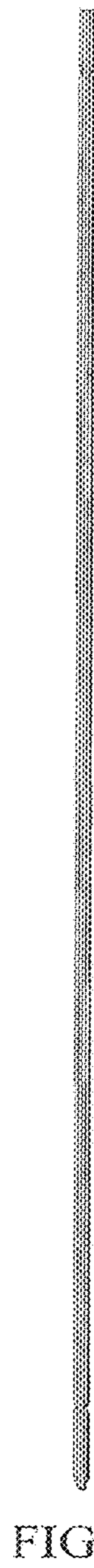

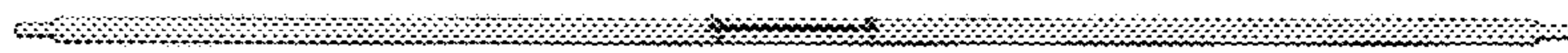

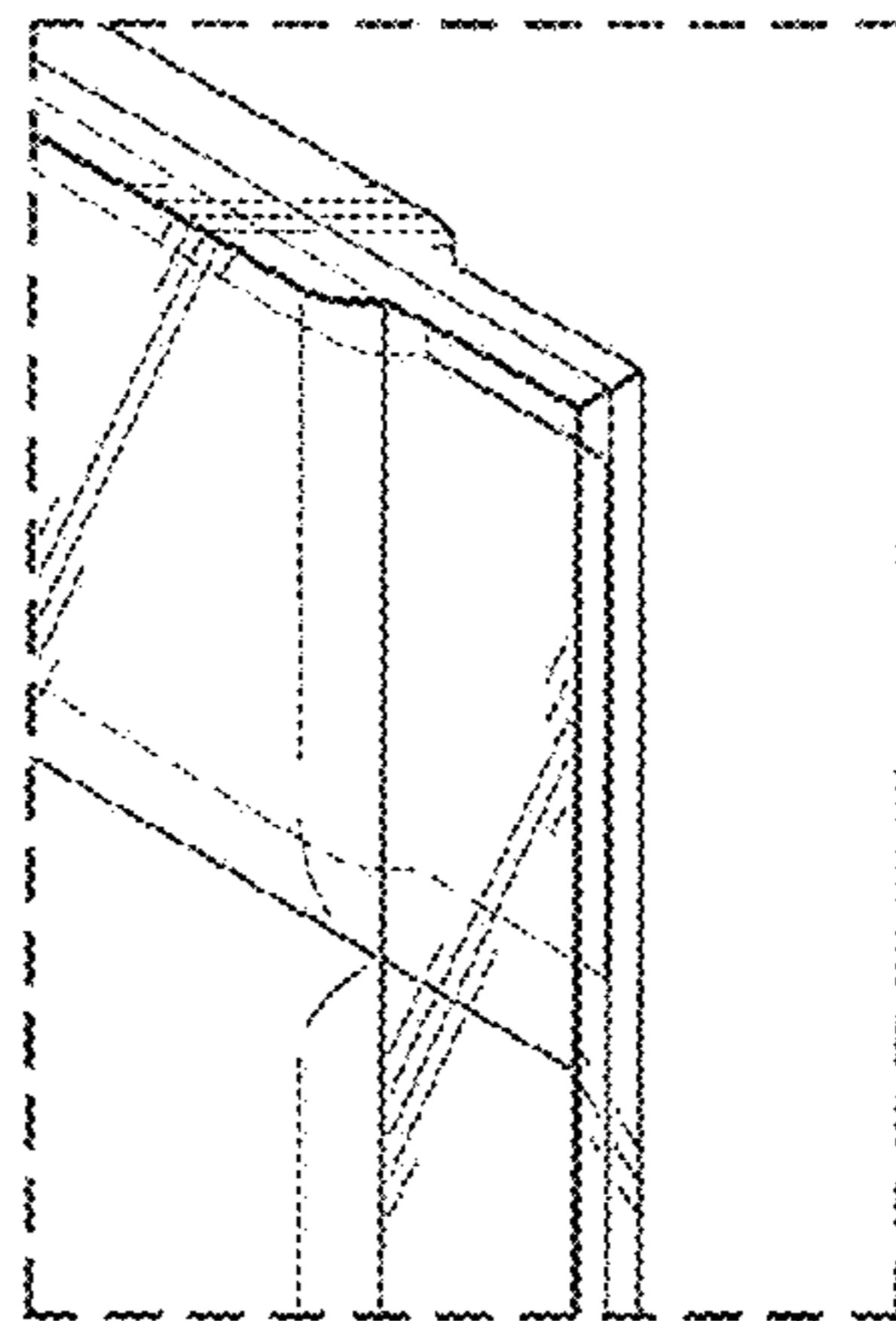

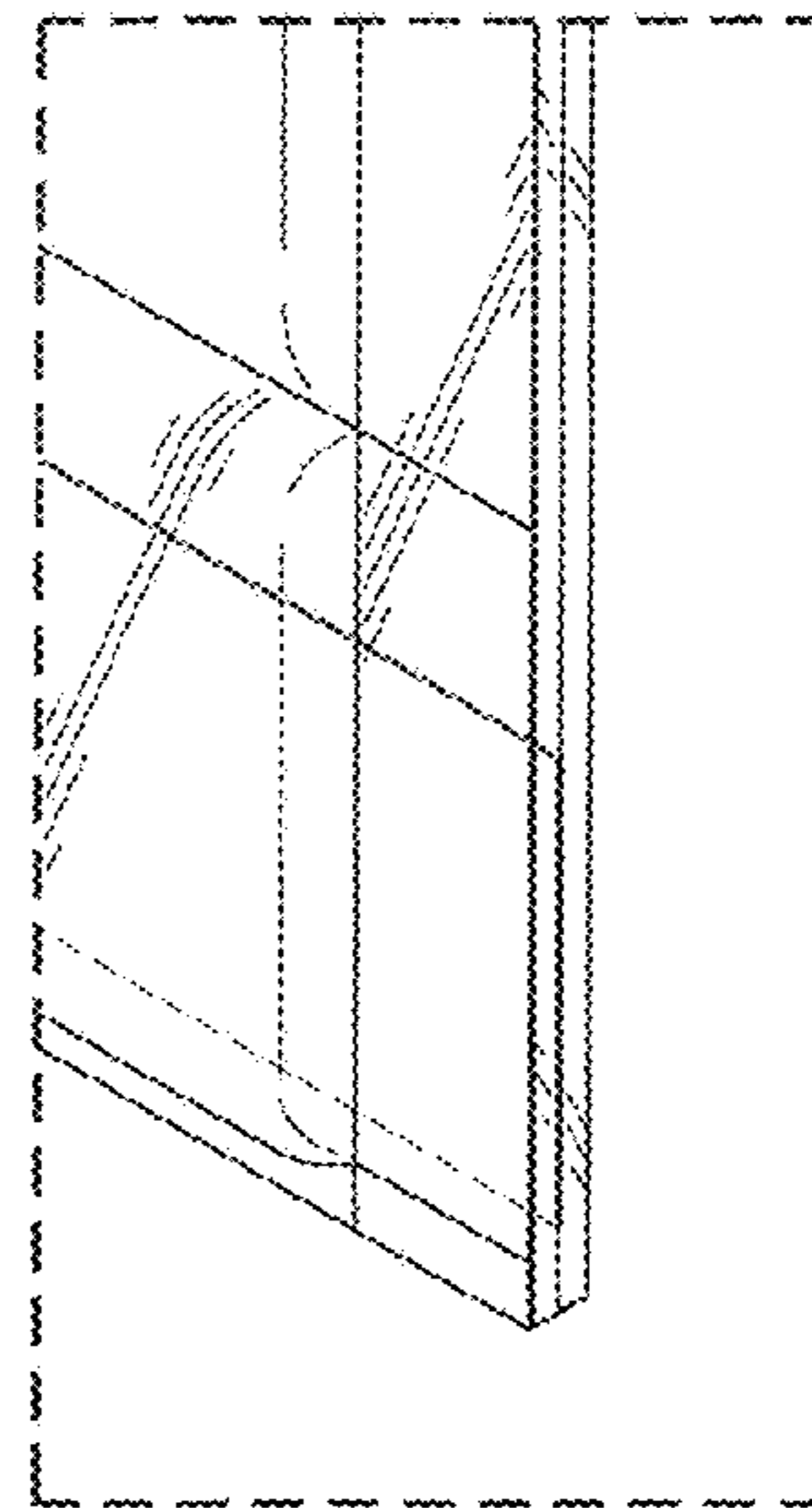
