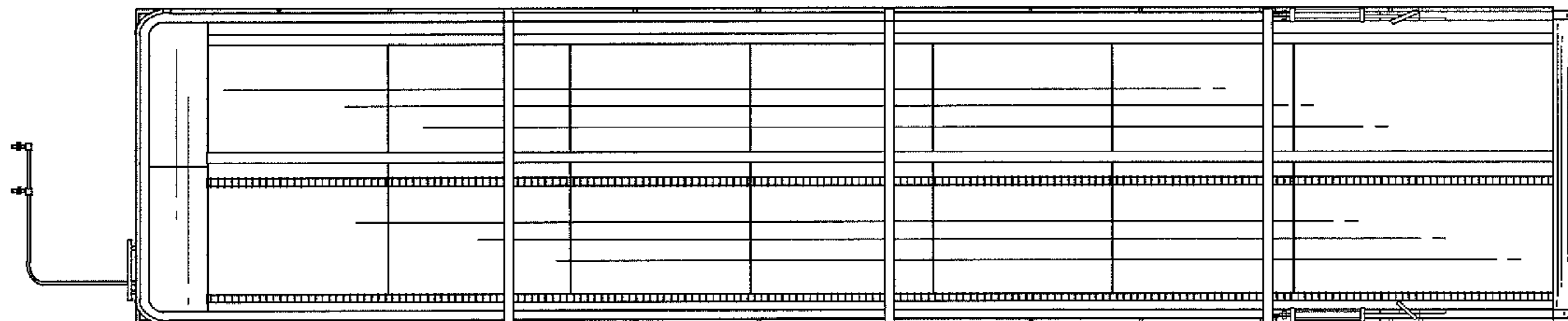
(57) **CLAIM**

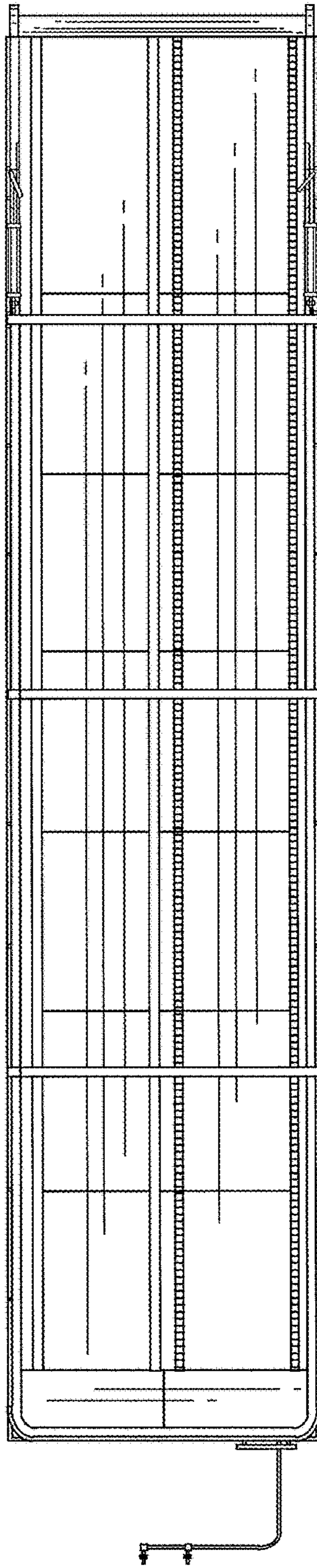
The ornamental design for a silage trailer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of silage trailer showing my new design. FIG. 2 is a right-side elevation view of FIG. 1. FIG. 3 is a left-side elevation view of the silage trailer of FIG. 1. FIG. 4 is a front view of the silage trailer of FIG. 1. FIG. 5 is a rear view of the silage trailer of FIG. 1. FIG. 6 is a bottom view of the silage trailer of FIG. 1; and, FIG. 7 is a rear perspective view of FIG. 1. The broken lines illustrate portions of the silage trailer that form no part of the claimed design.

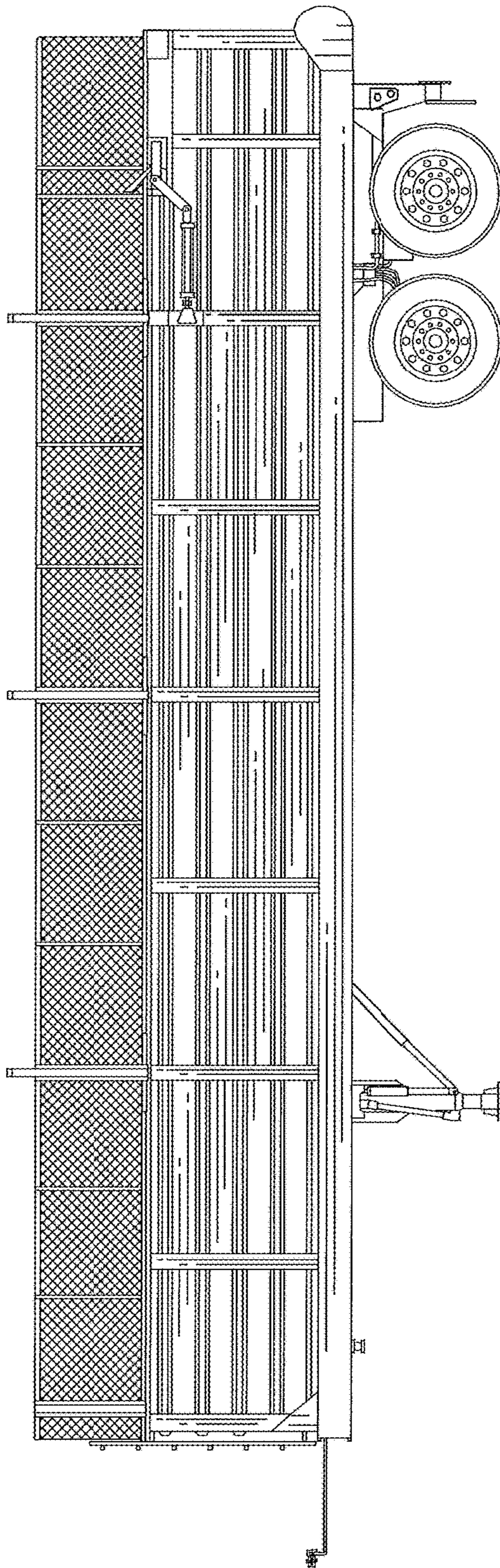

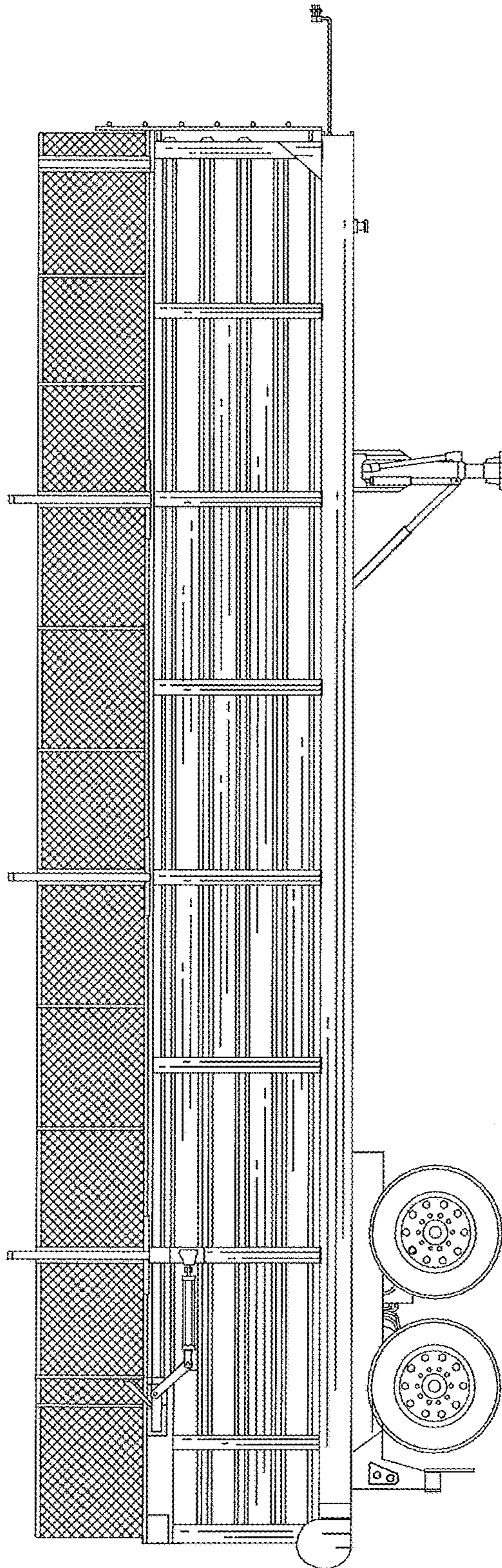
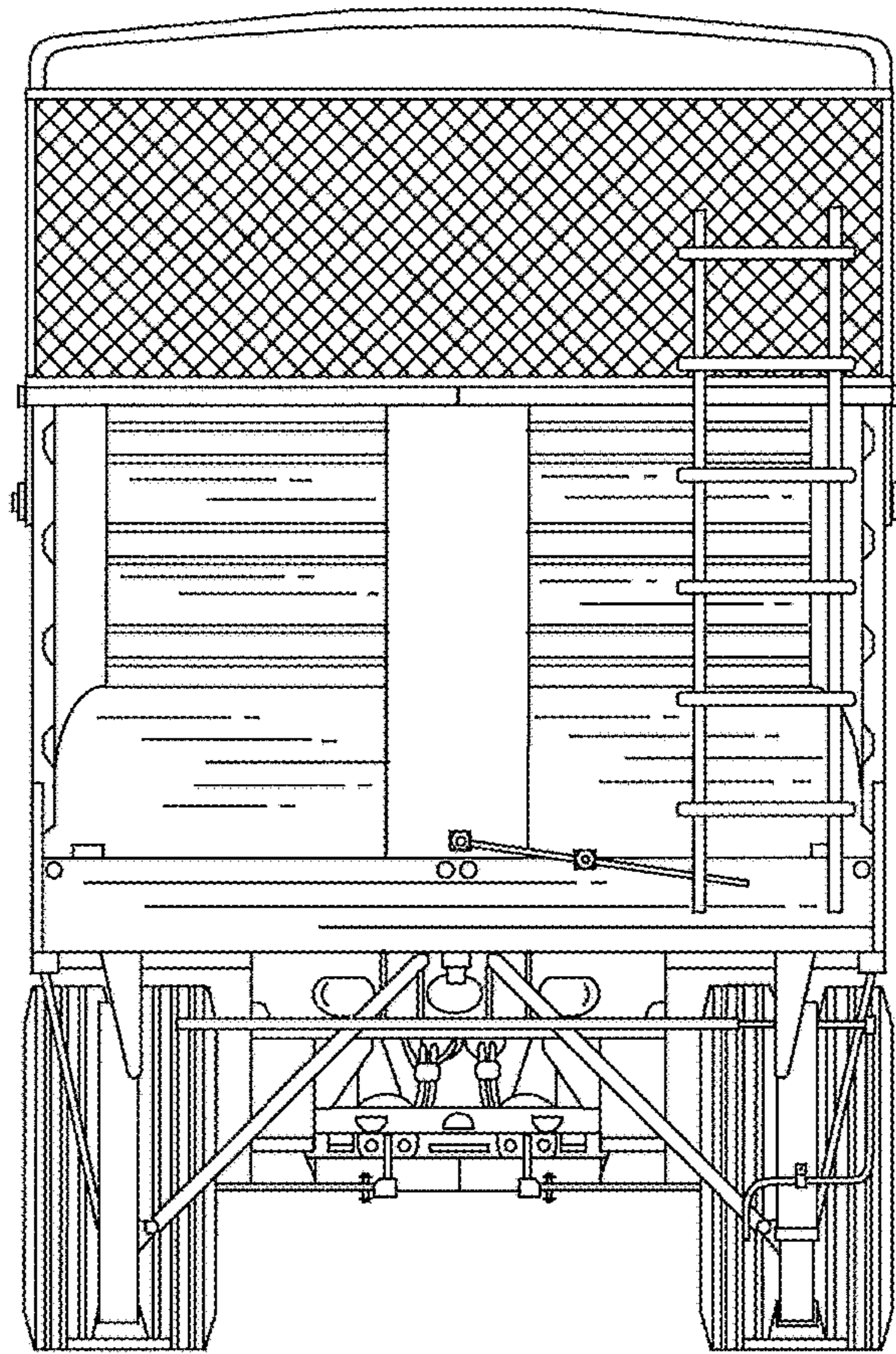
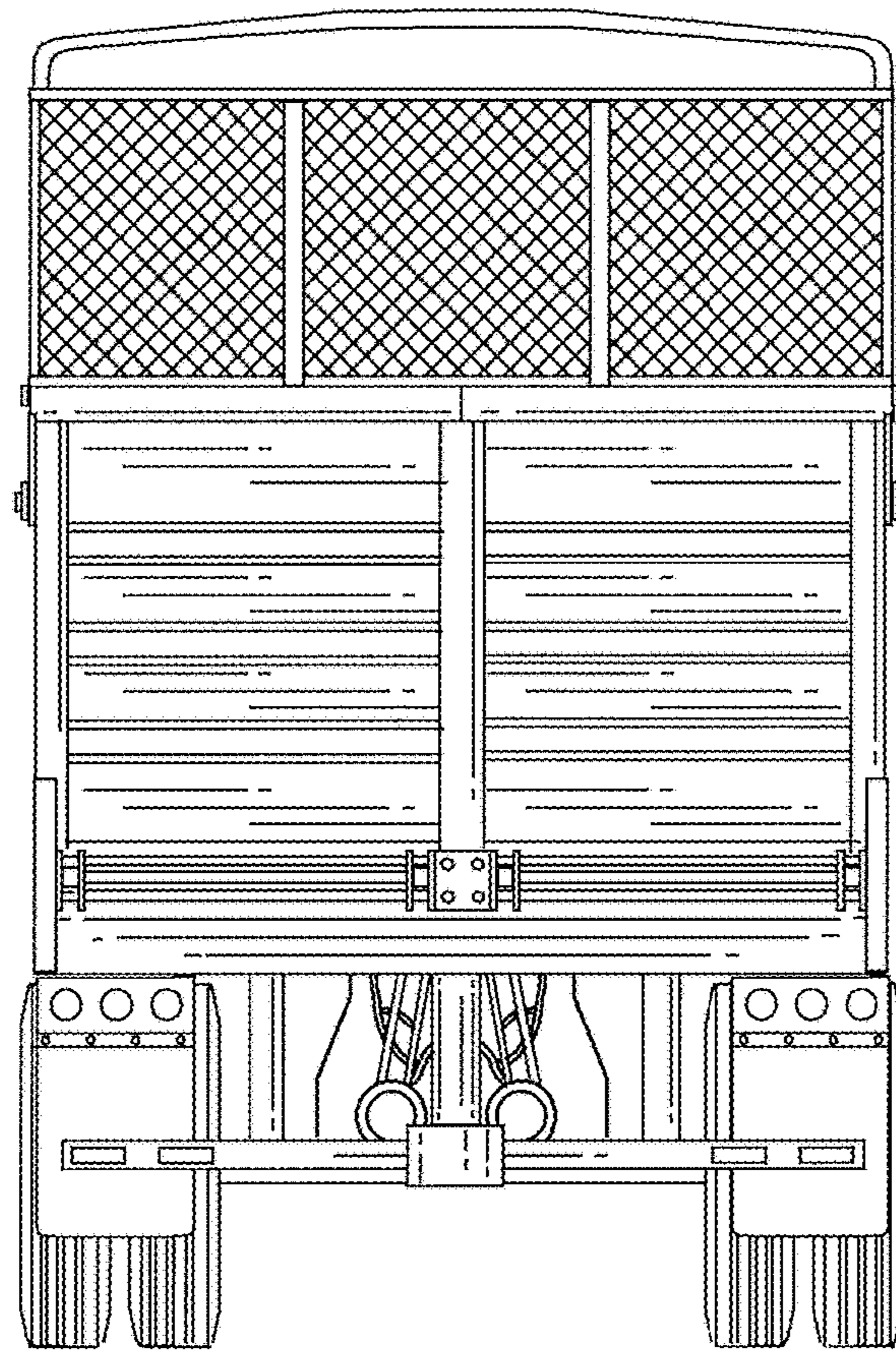


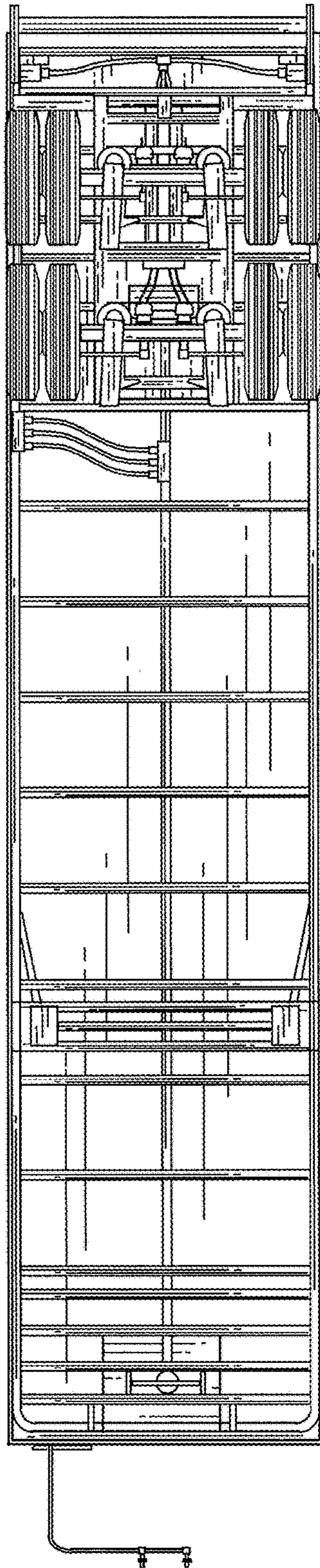

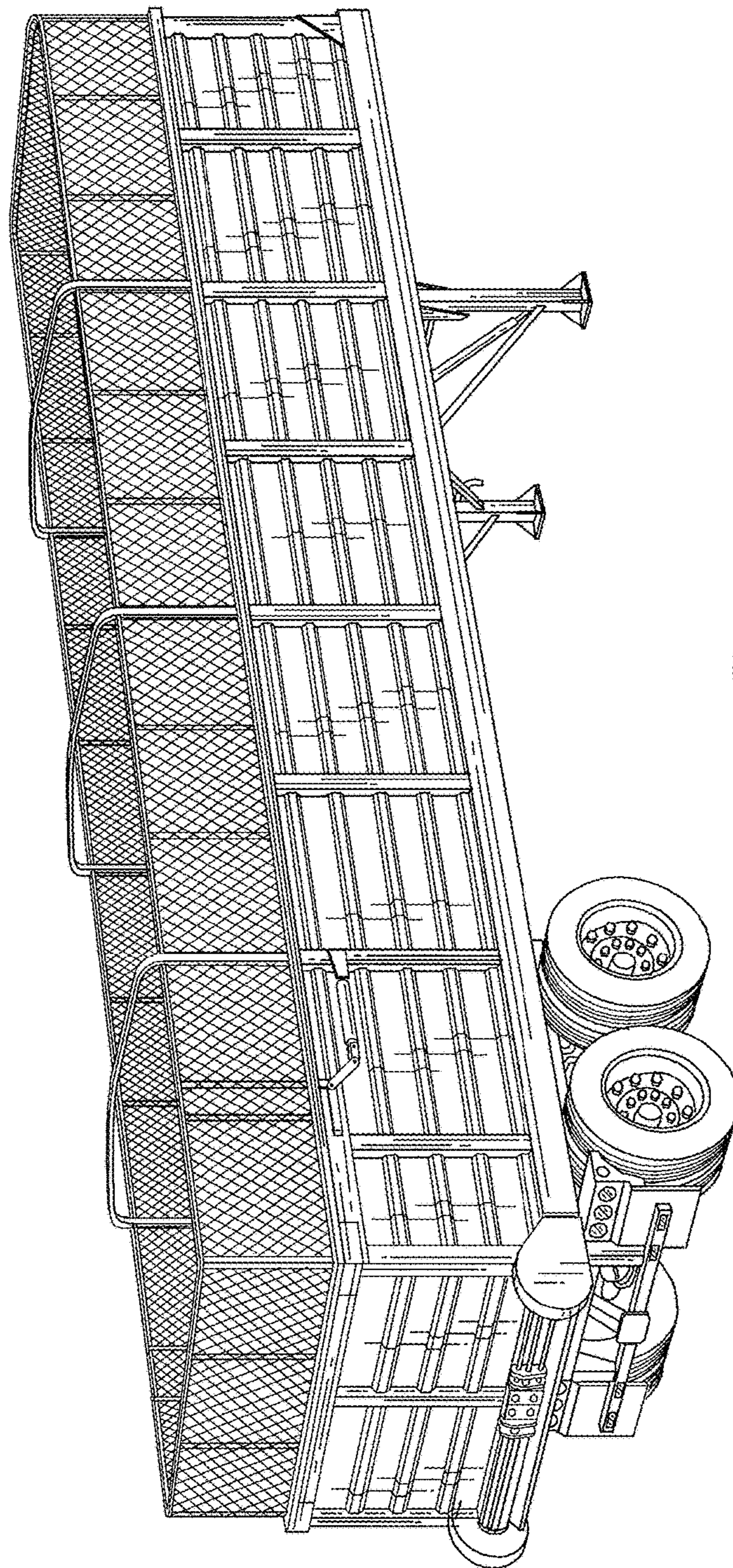
