(57) **CLAIM**

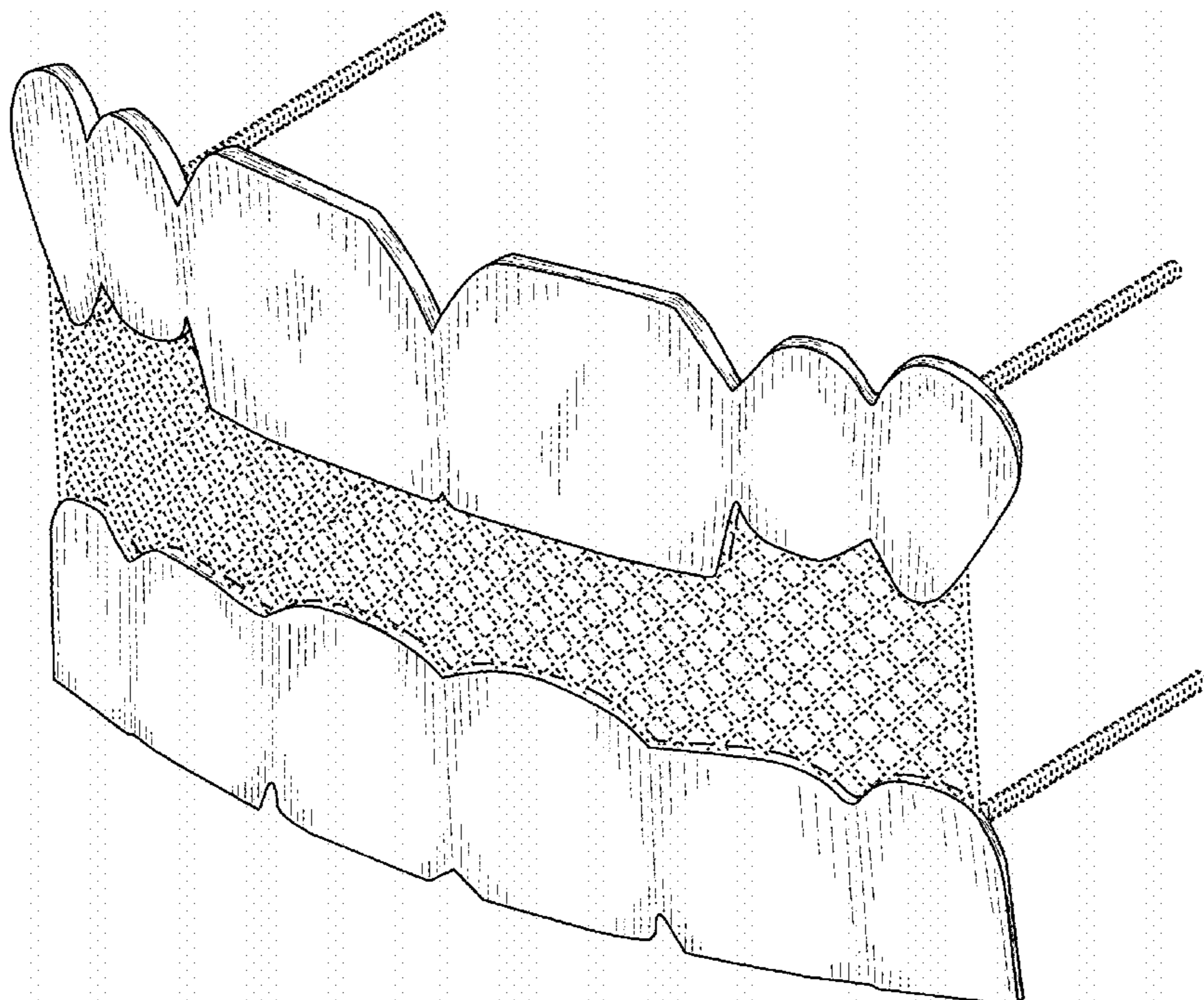
The ornamental design for a grill ornament, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grill ornament;
FIG. 2 is a front elevational view thereof;

FIG. 6 is a top plan view thereof; and,

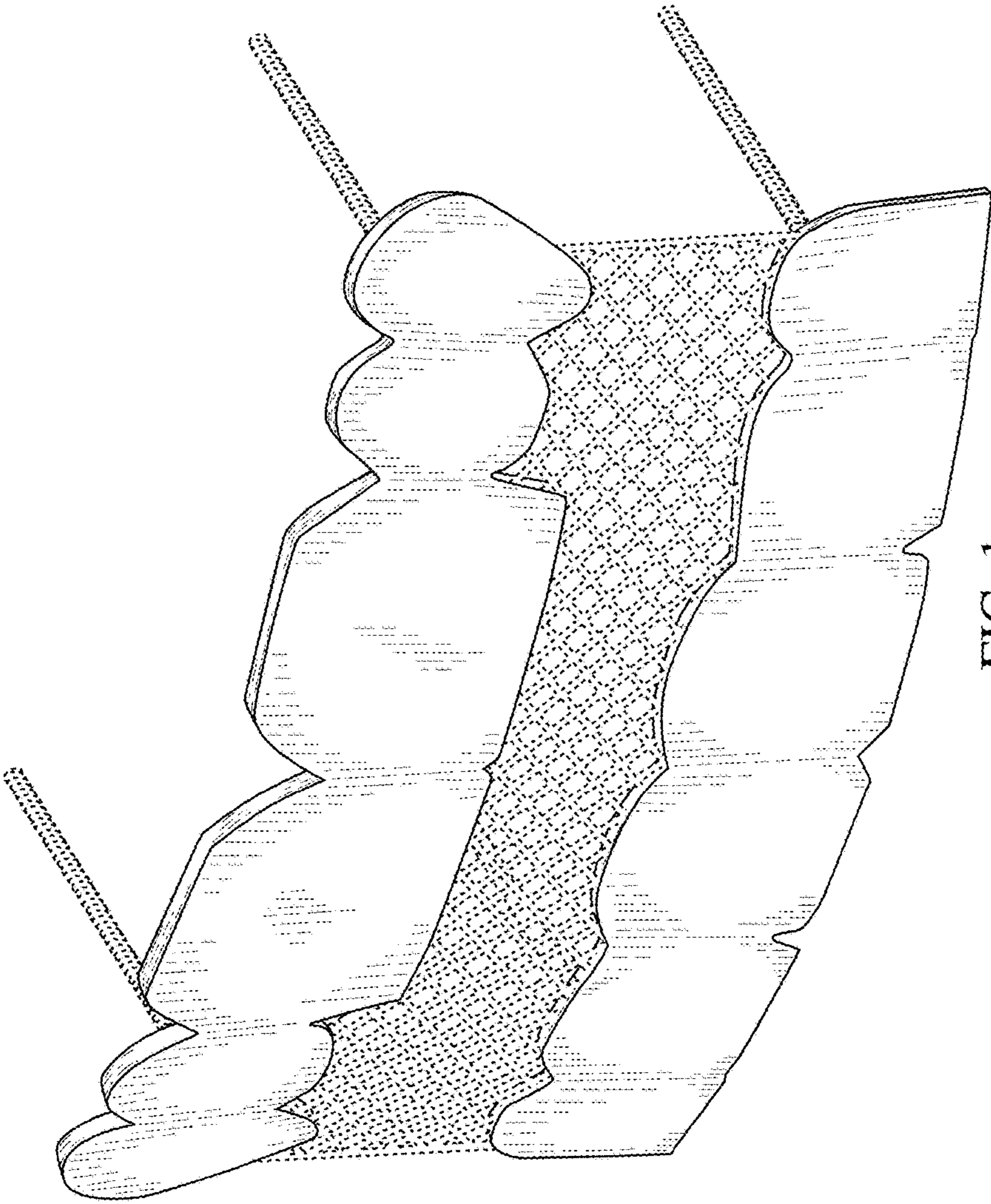

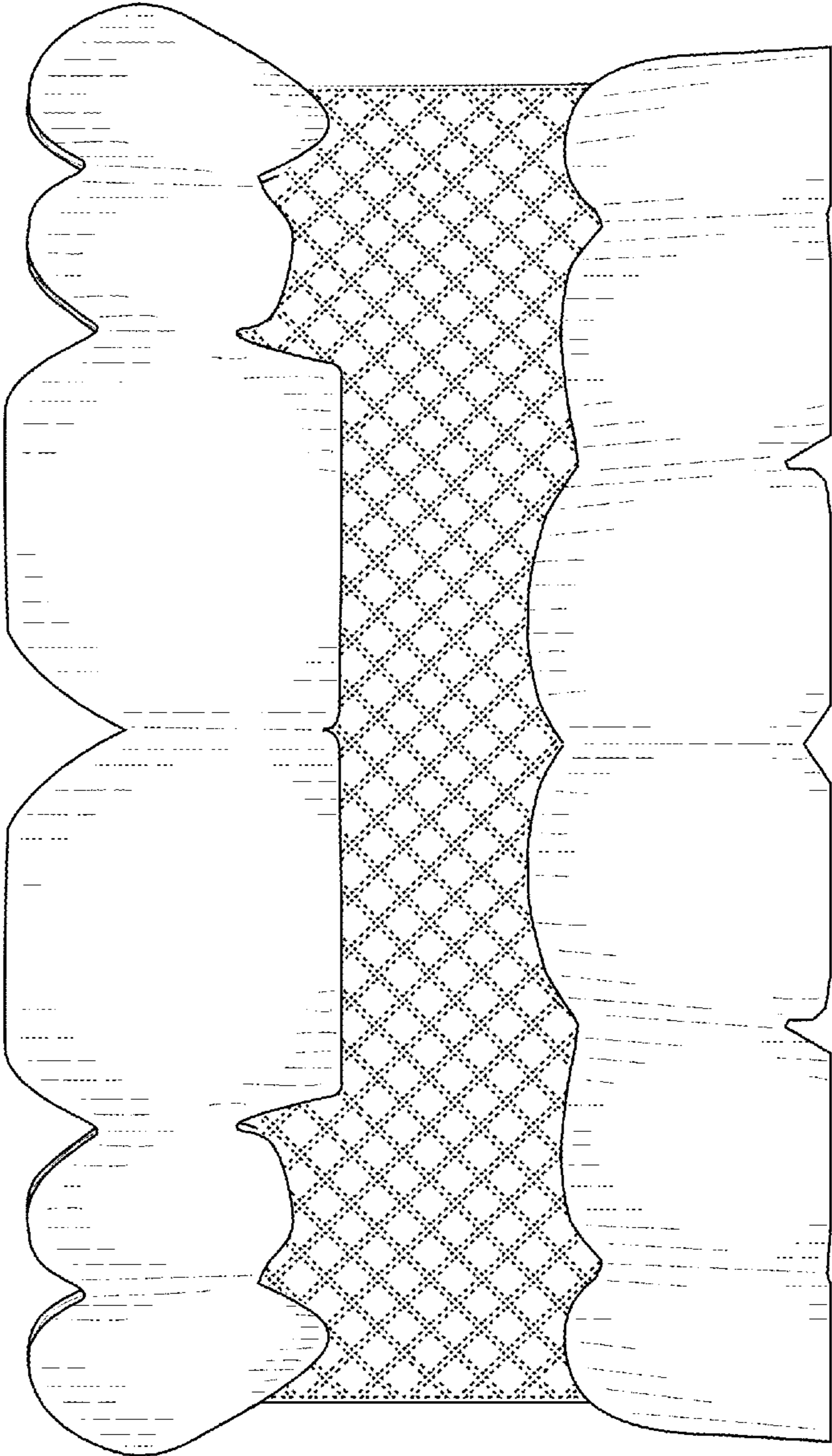

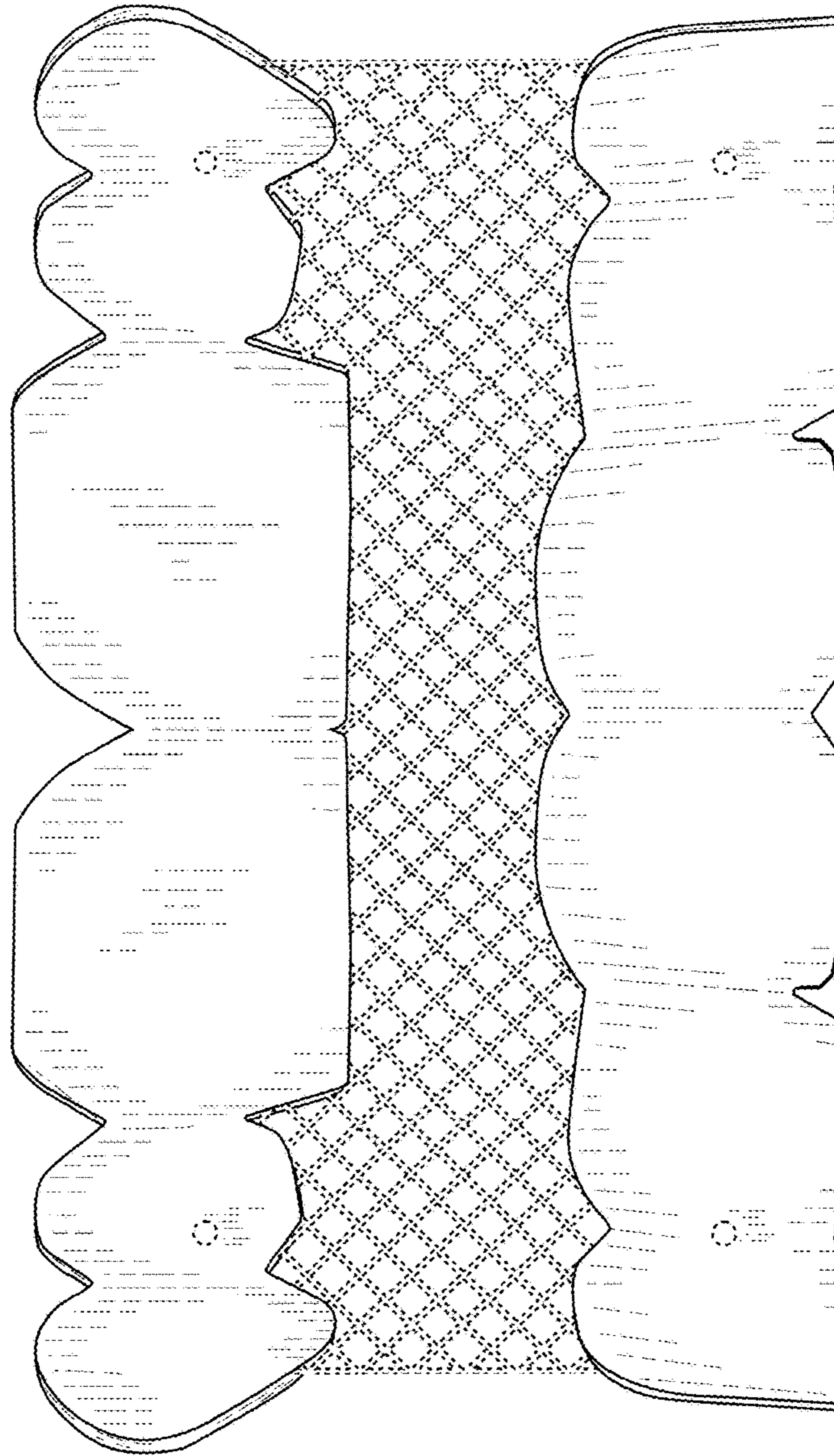

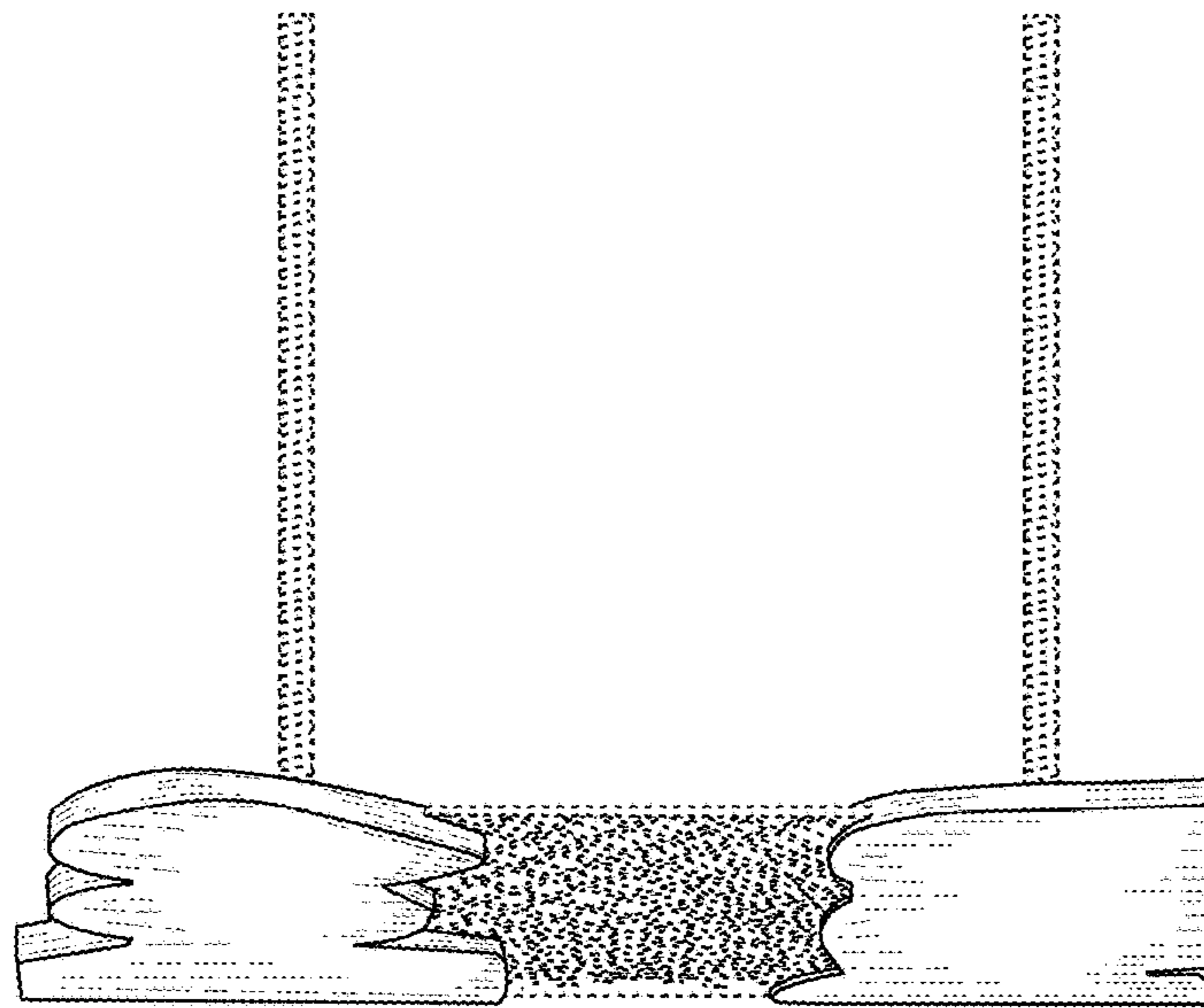

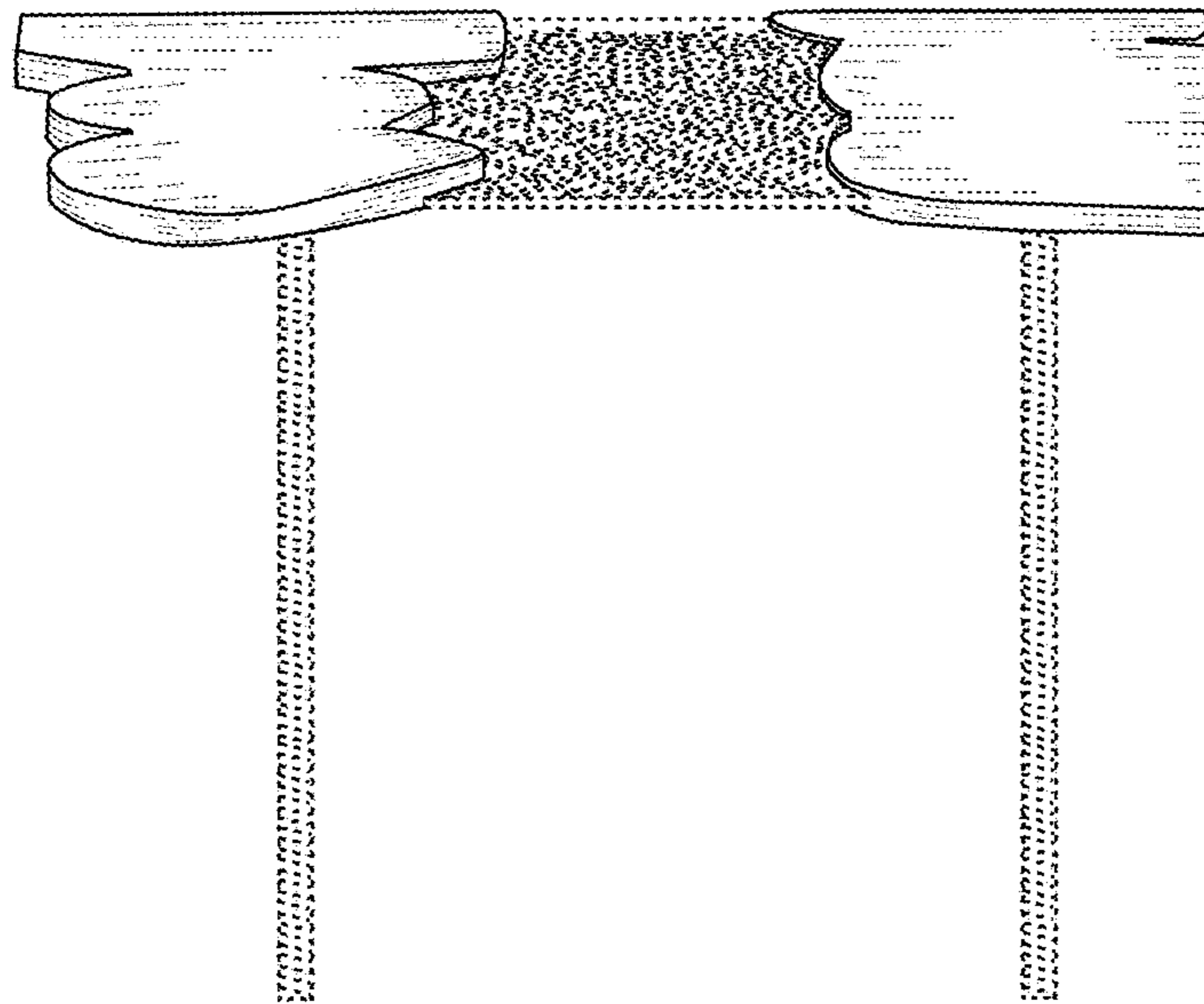

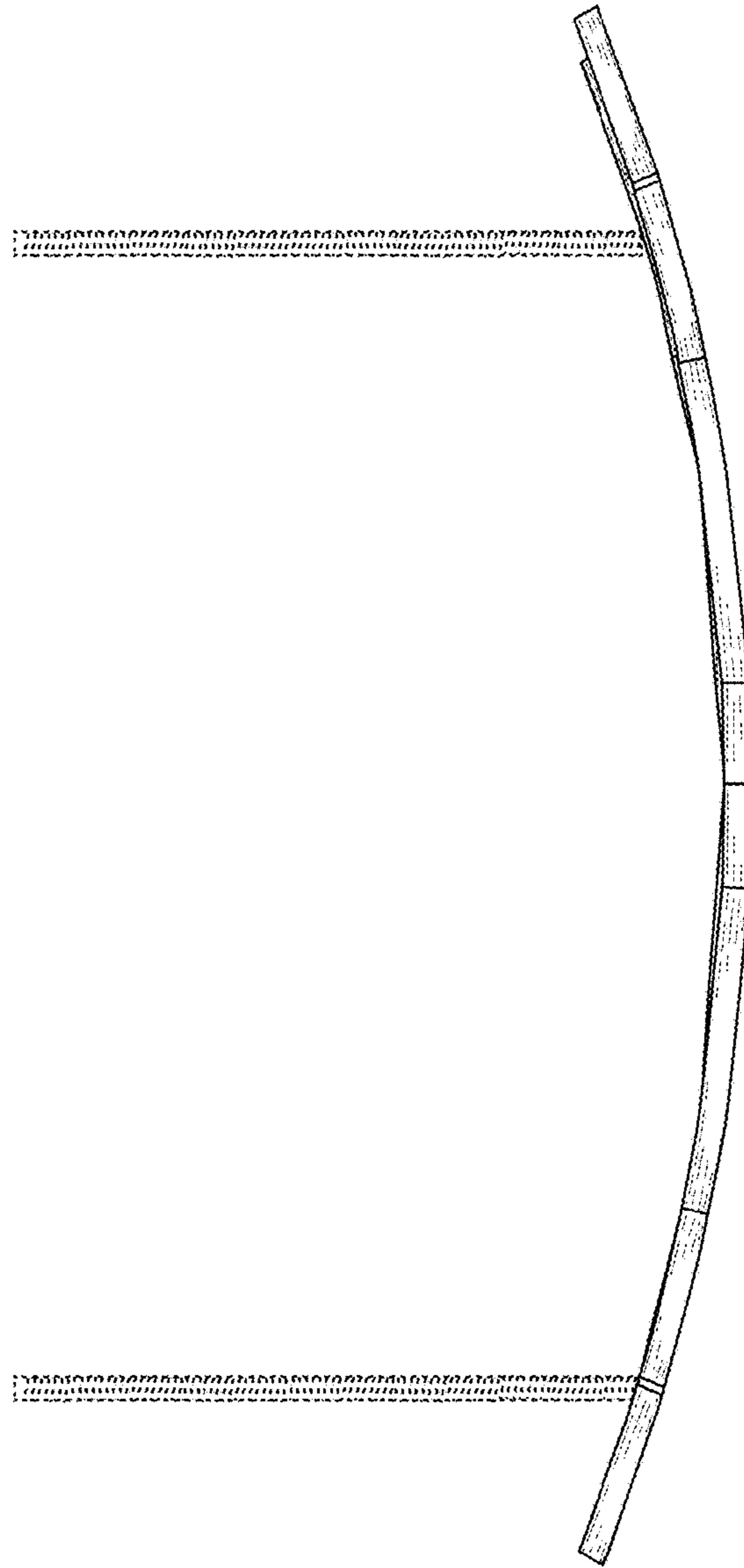

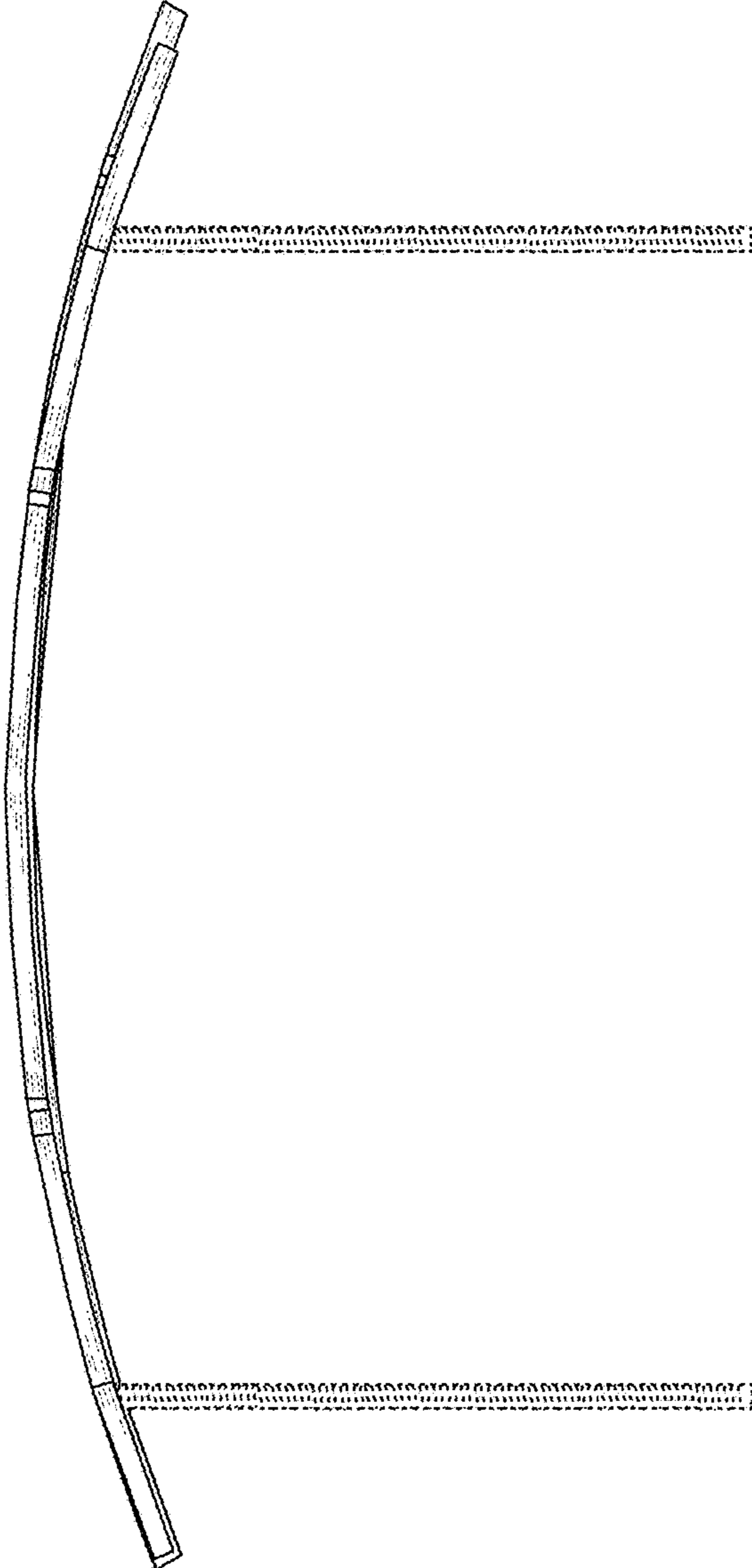
