The ornamental design for an interactive equipment, as shown and described.

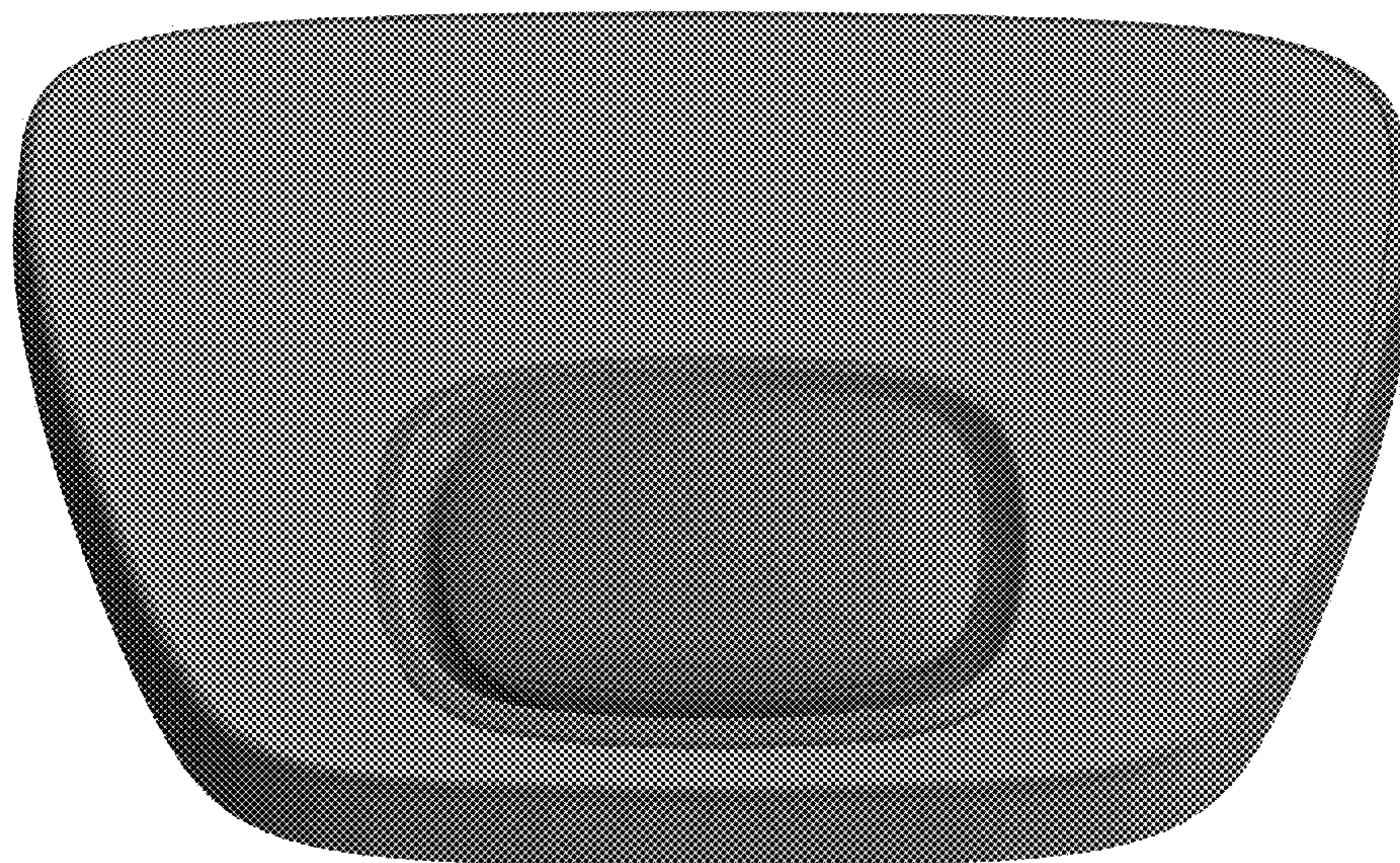
DESCRIPTION

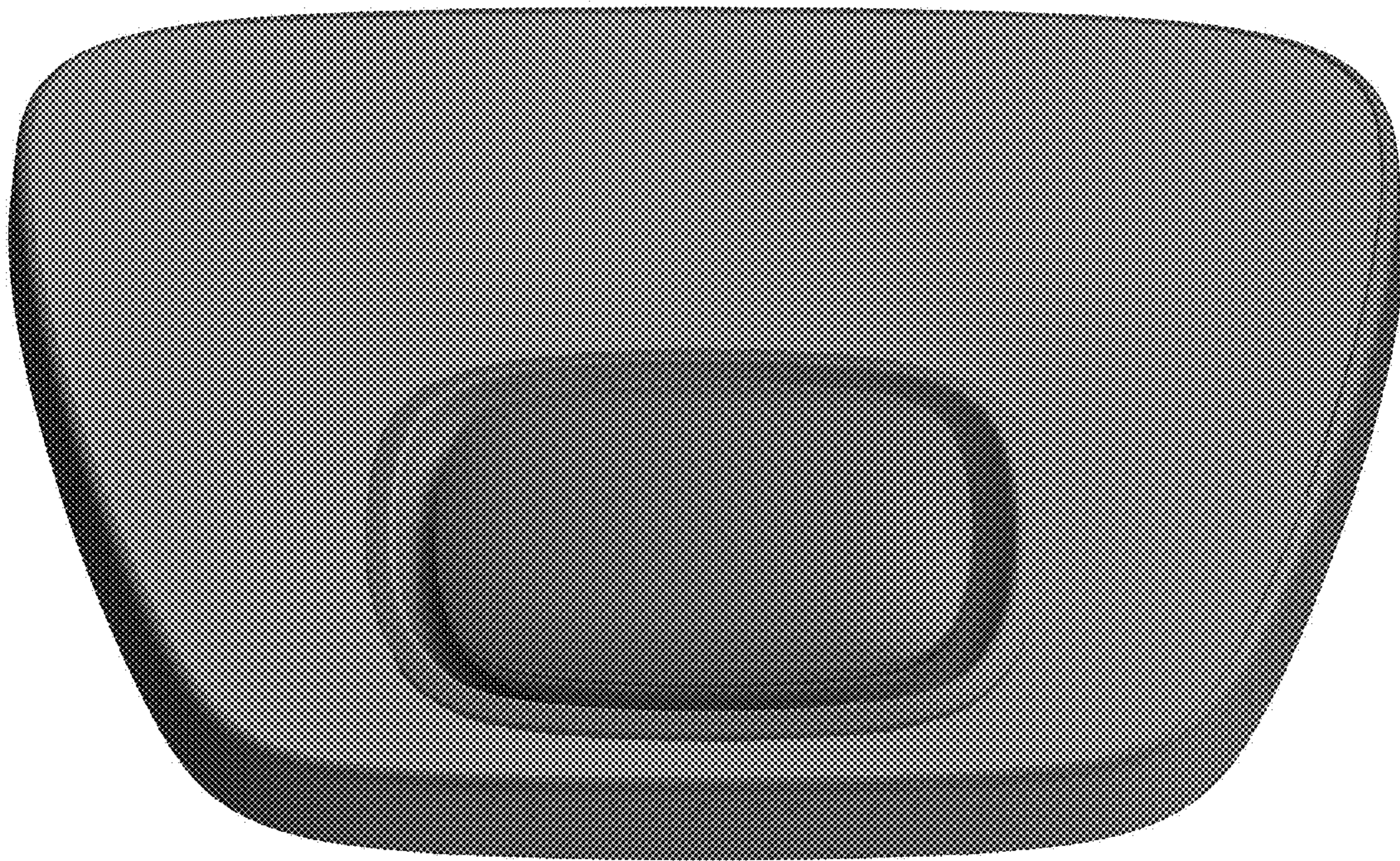

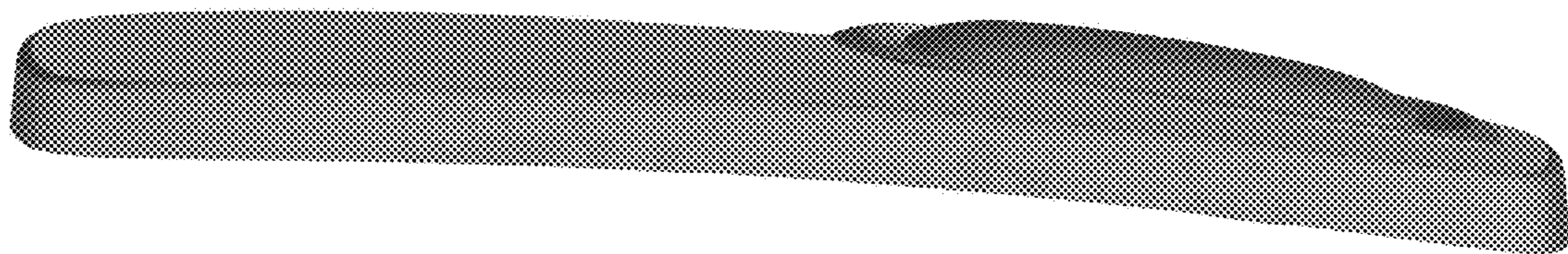

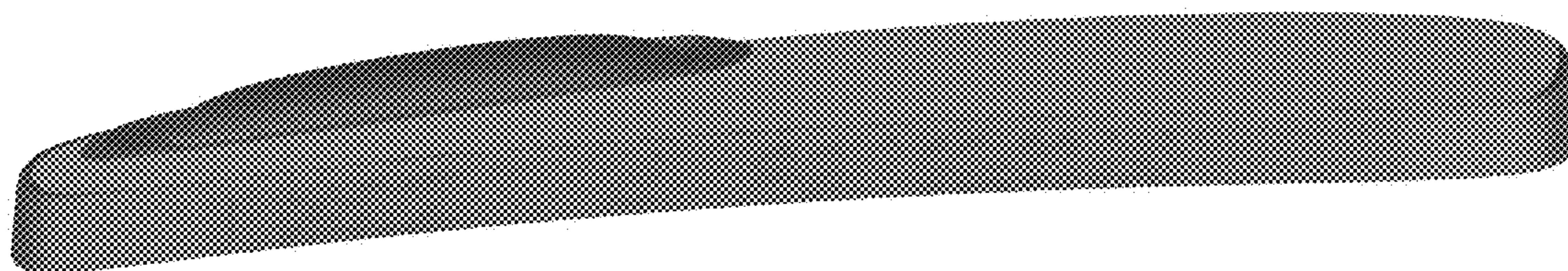

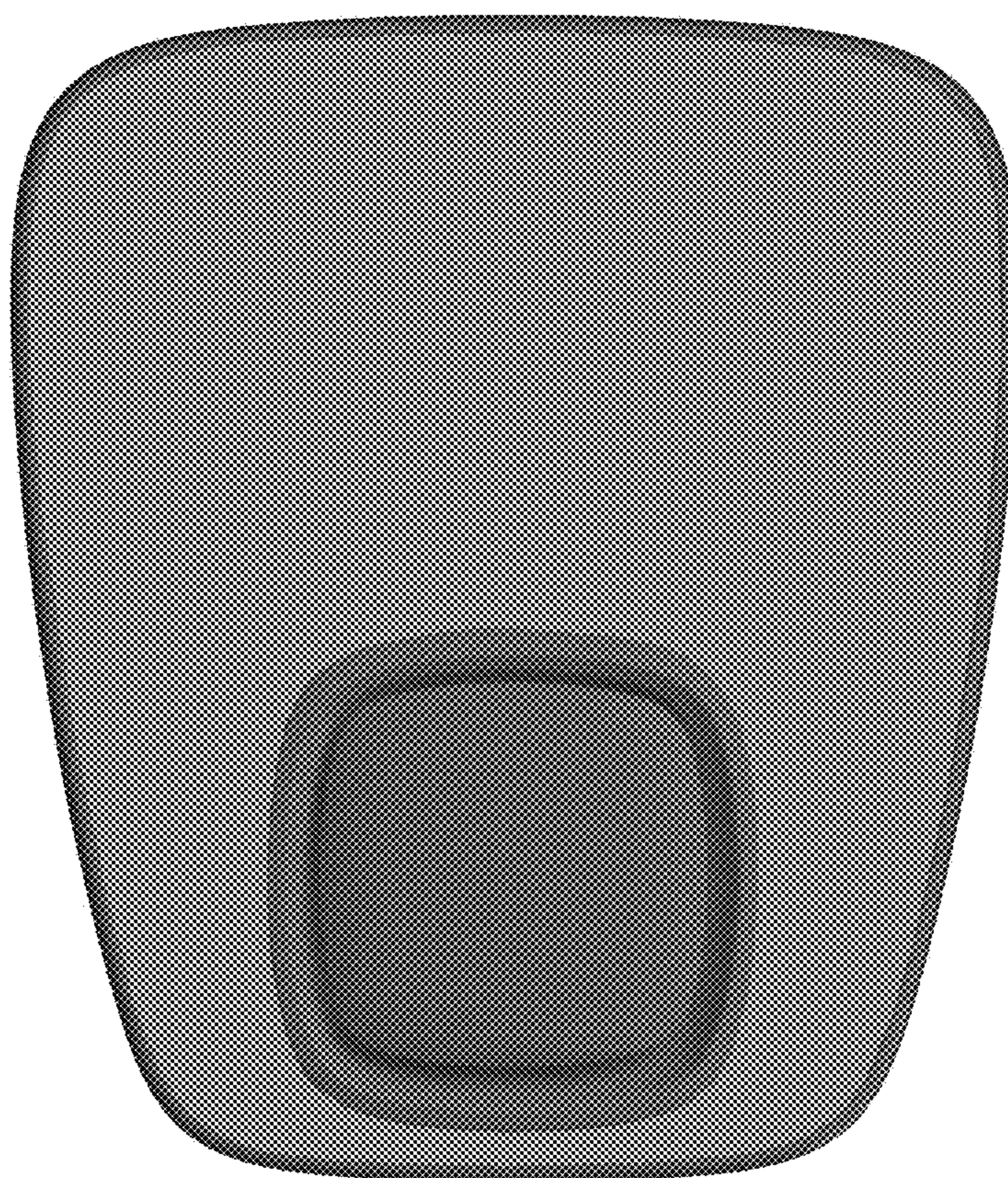

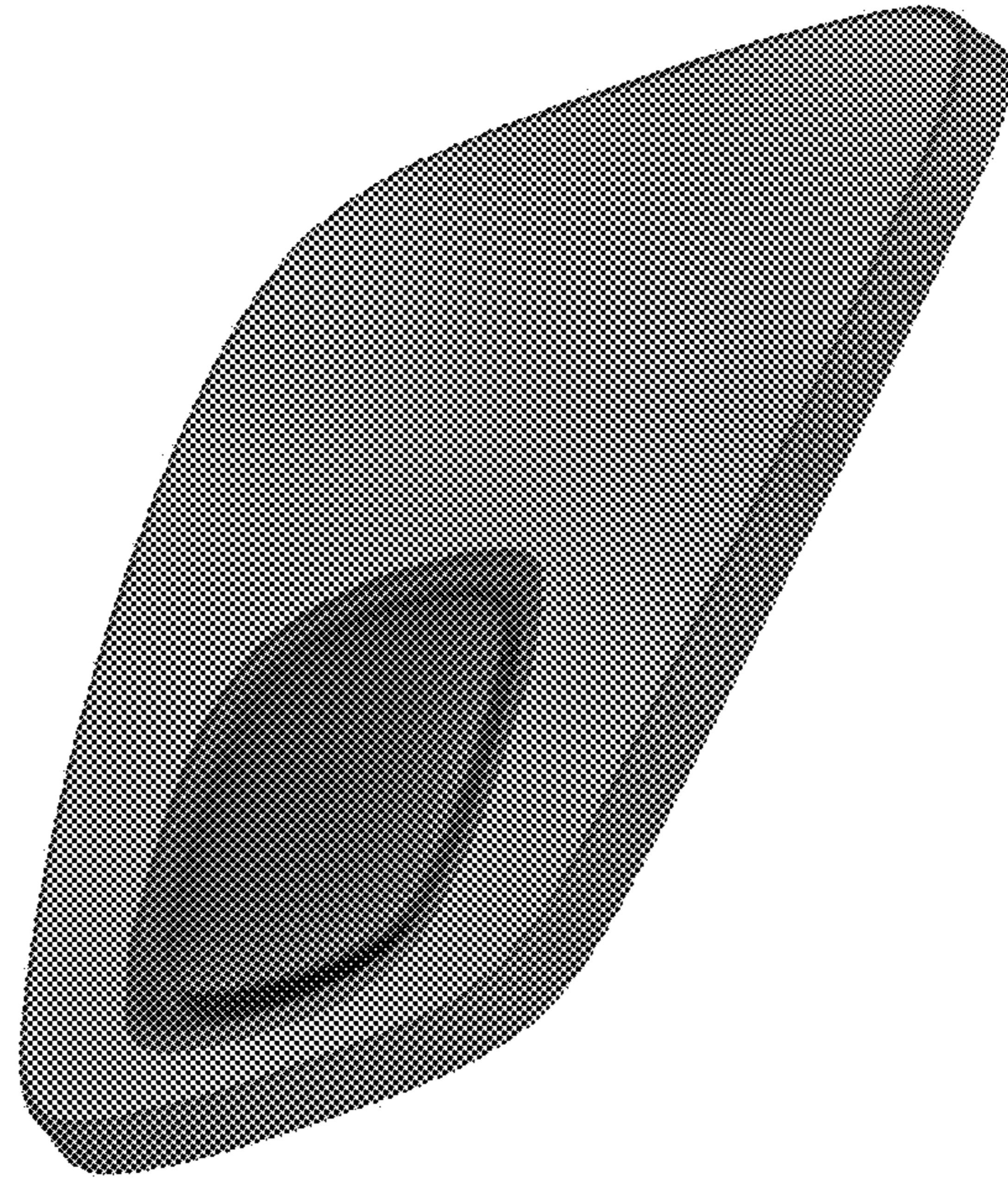

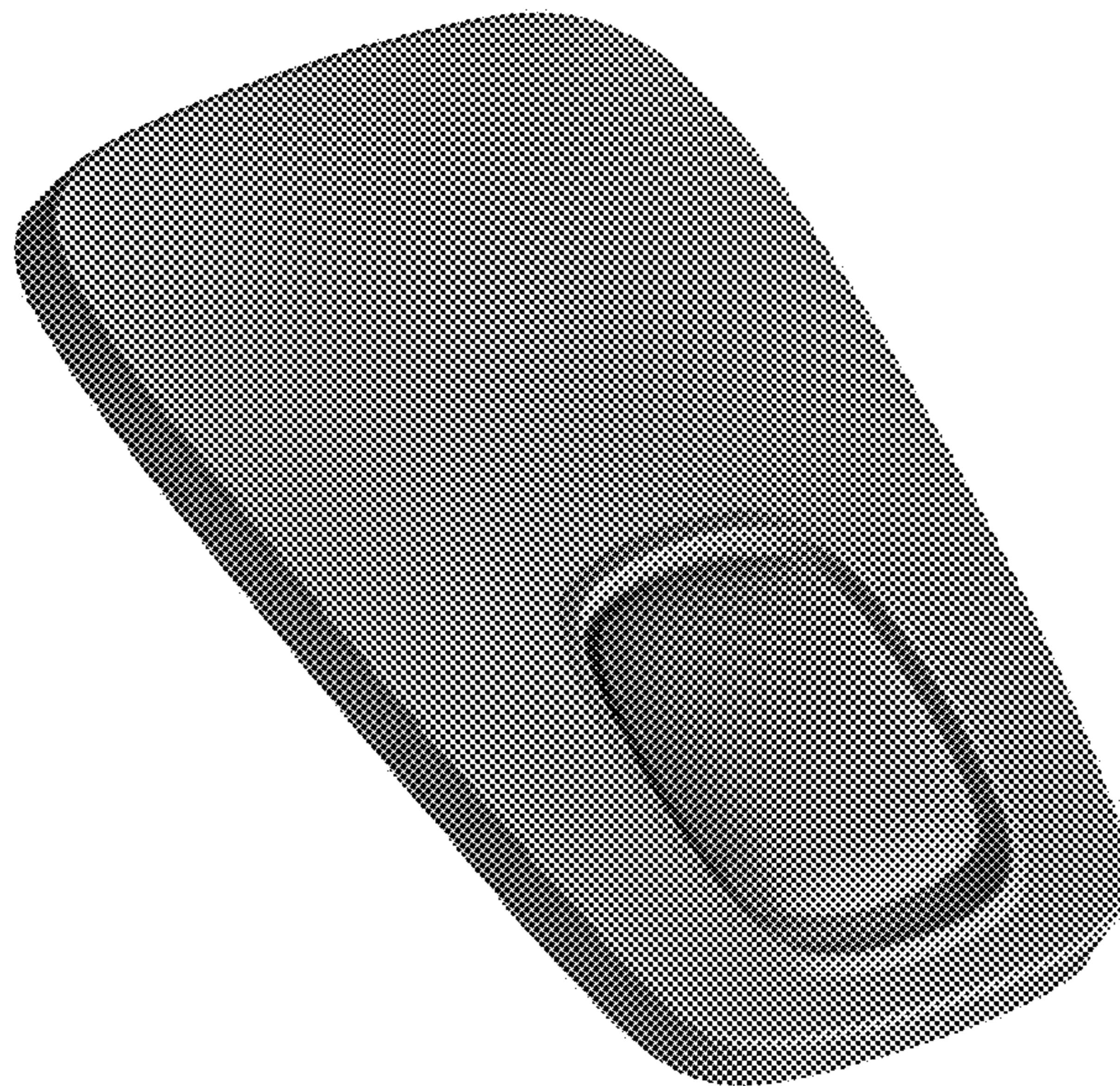

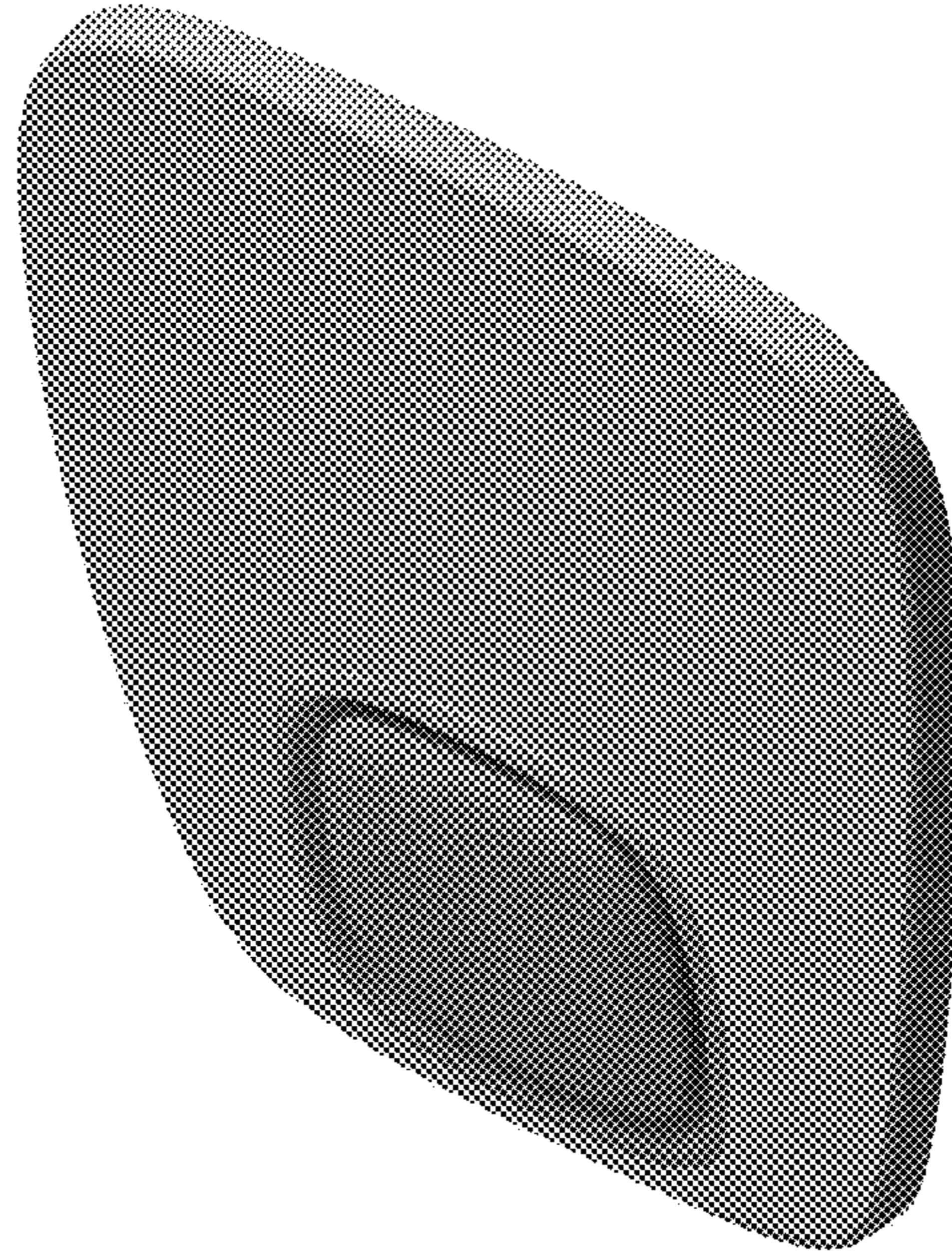

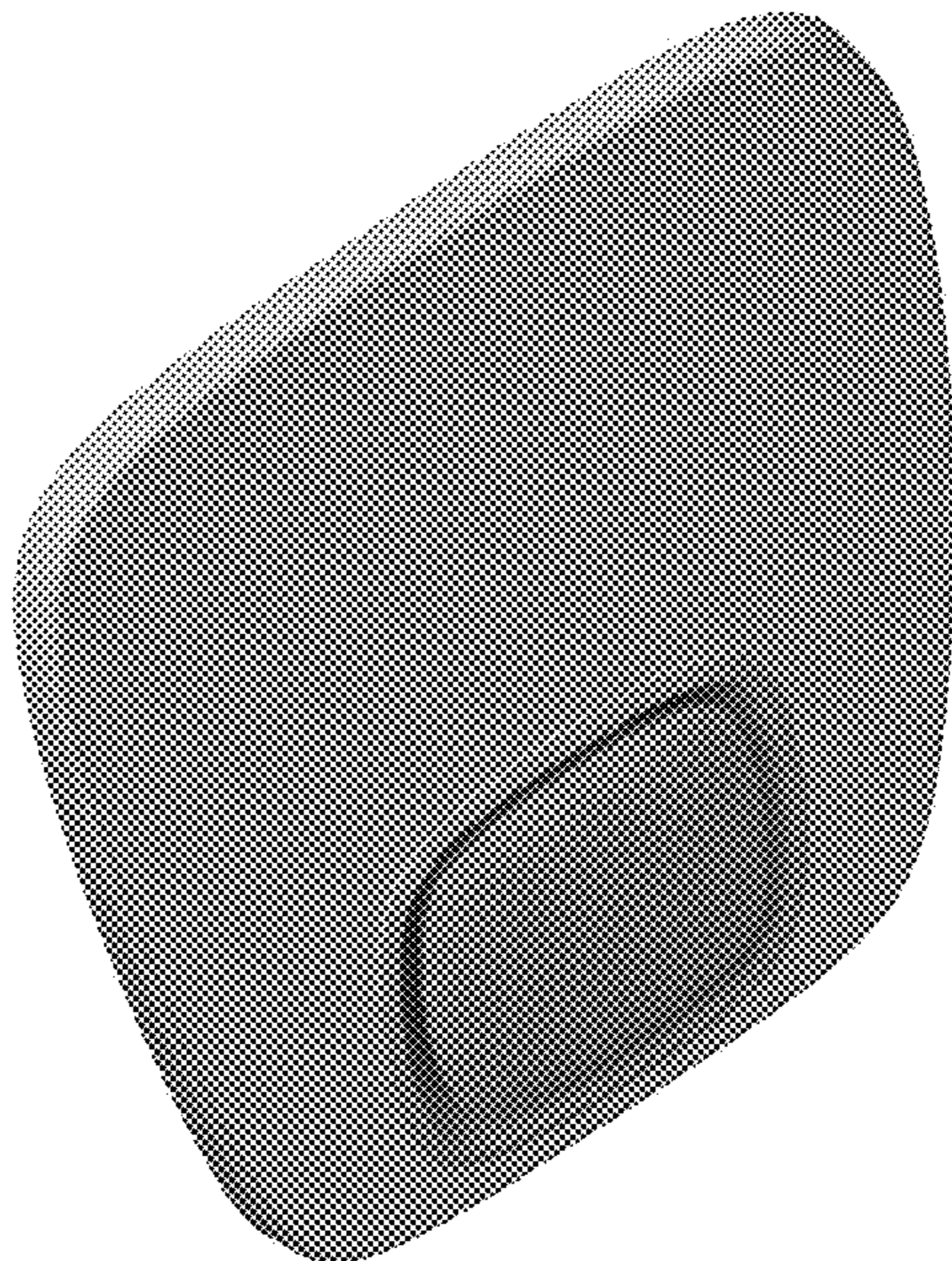

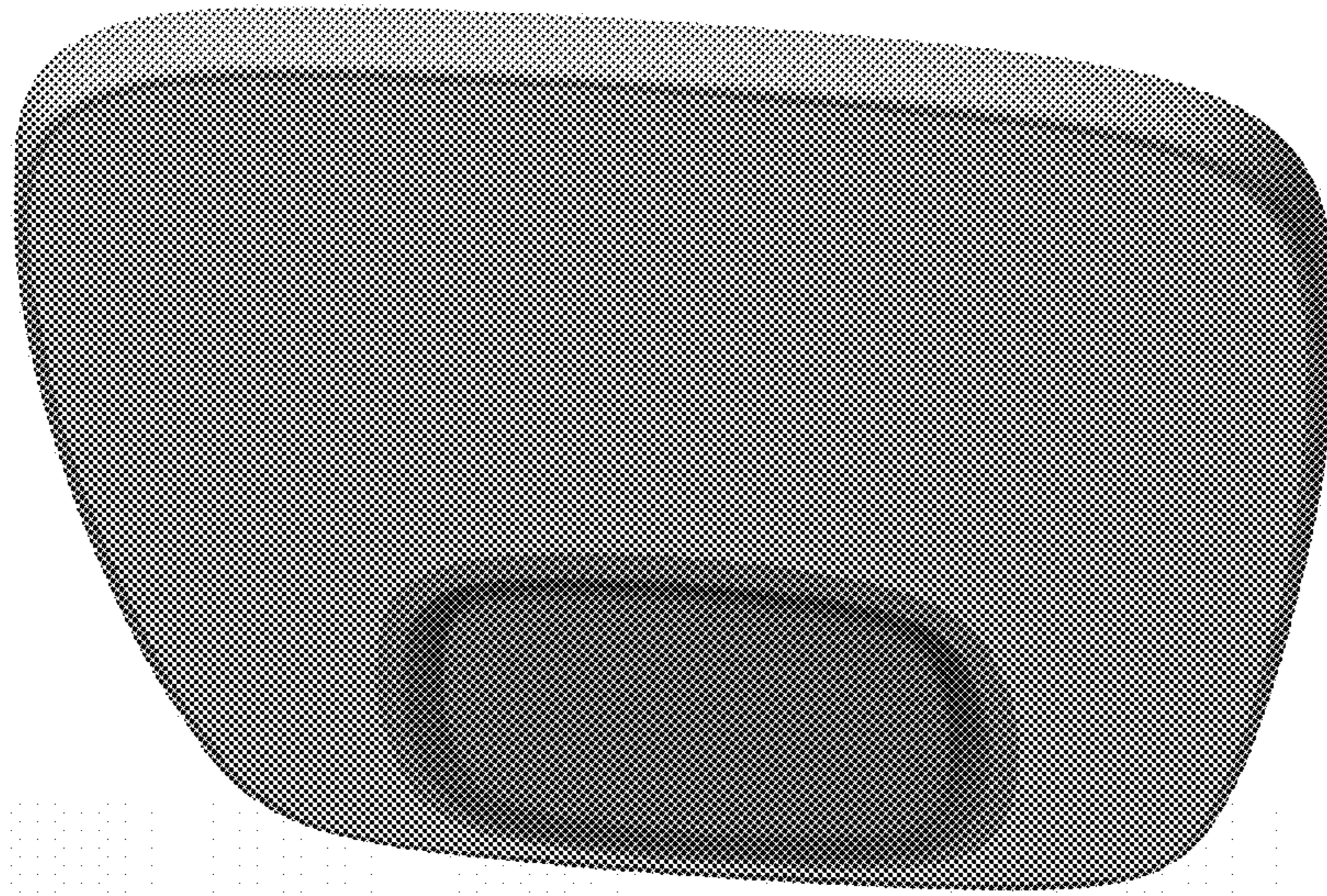

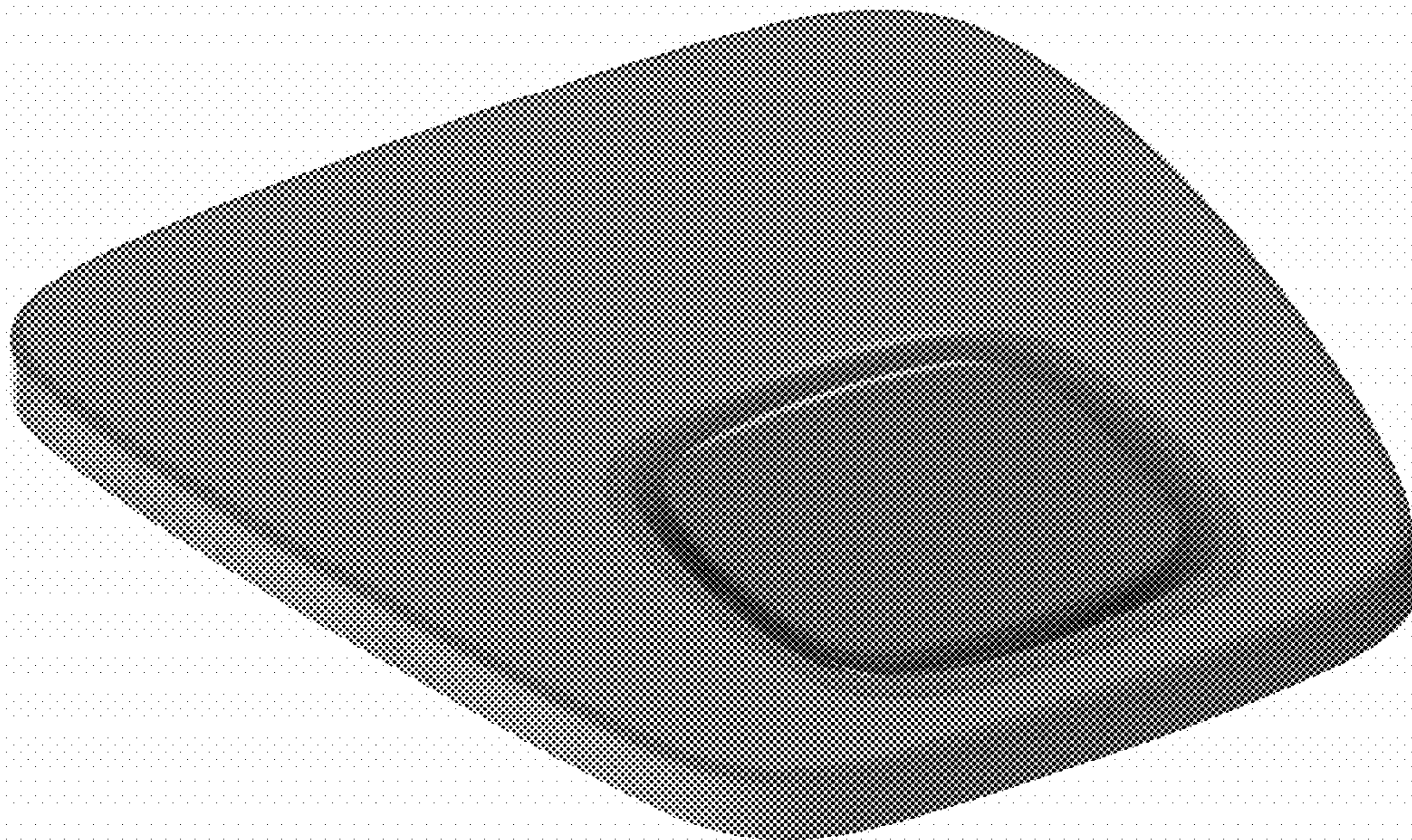

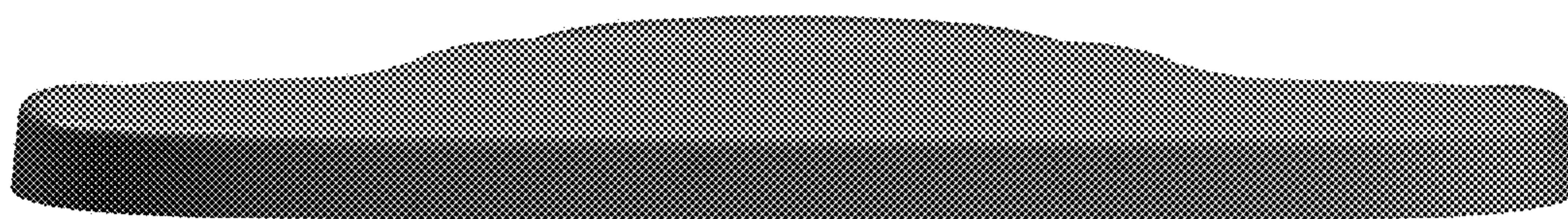

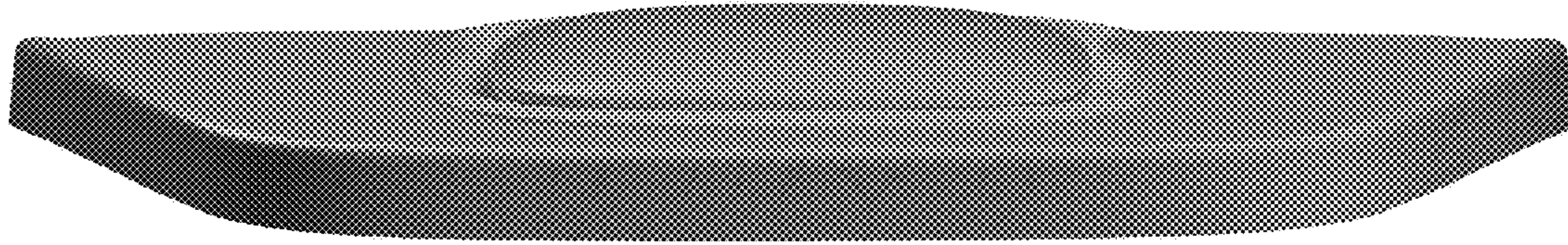

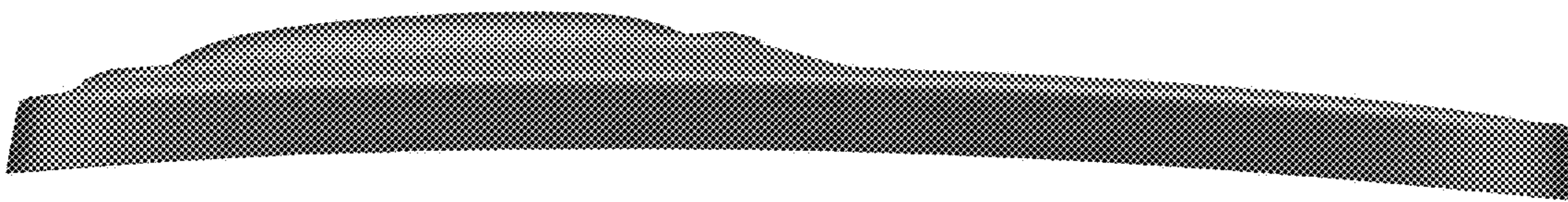

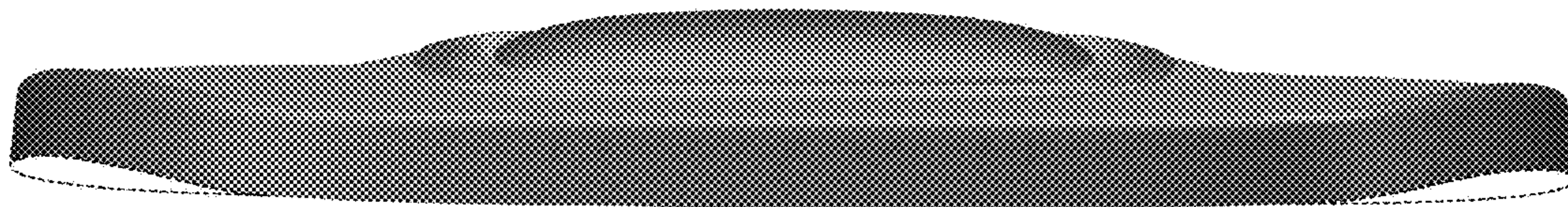

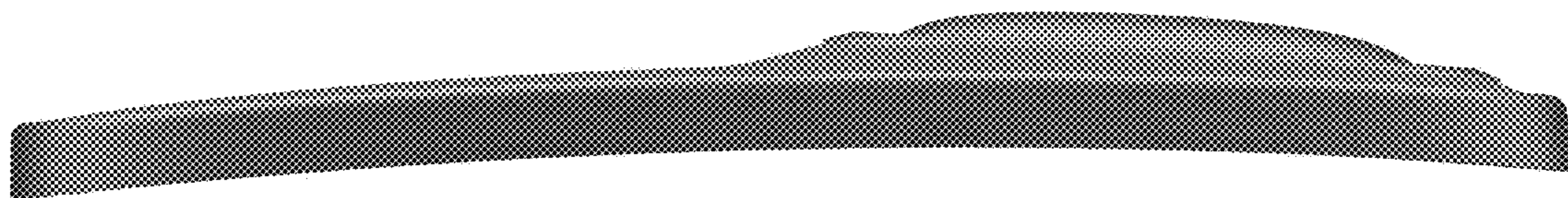
