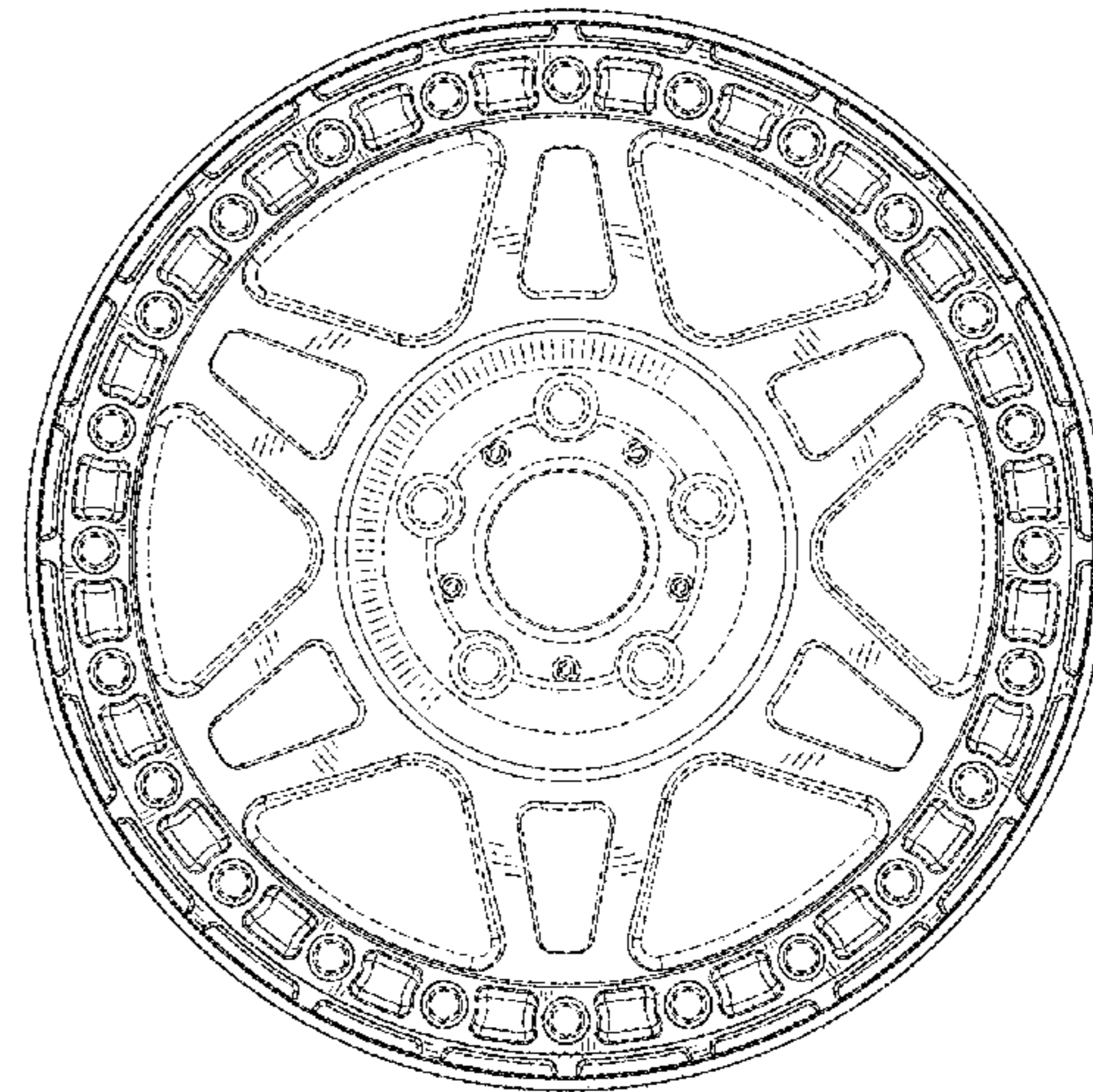
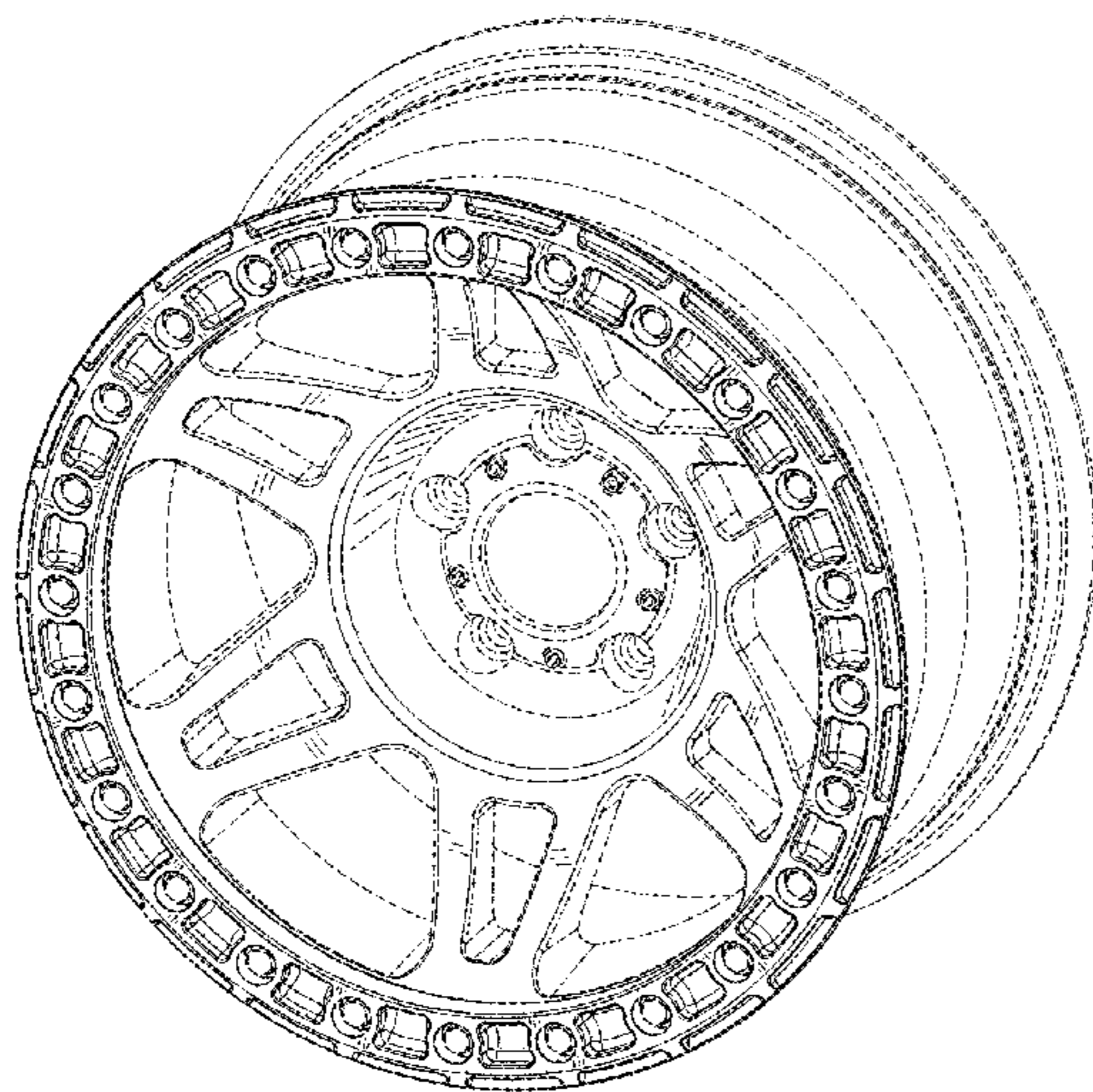
The ornamental design for a vehicle wheel front face, as shown and described.

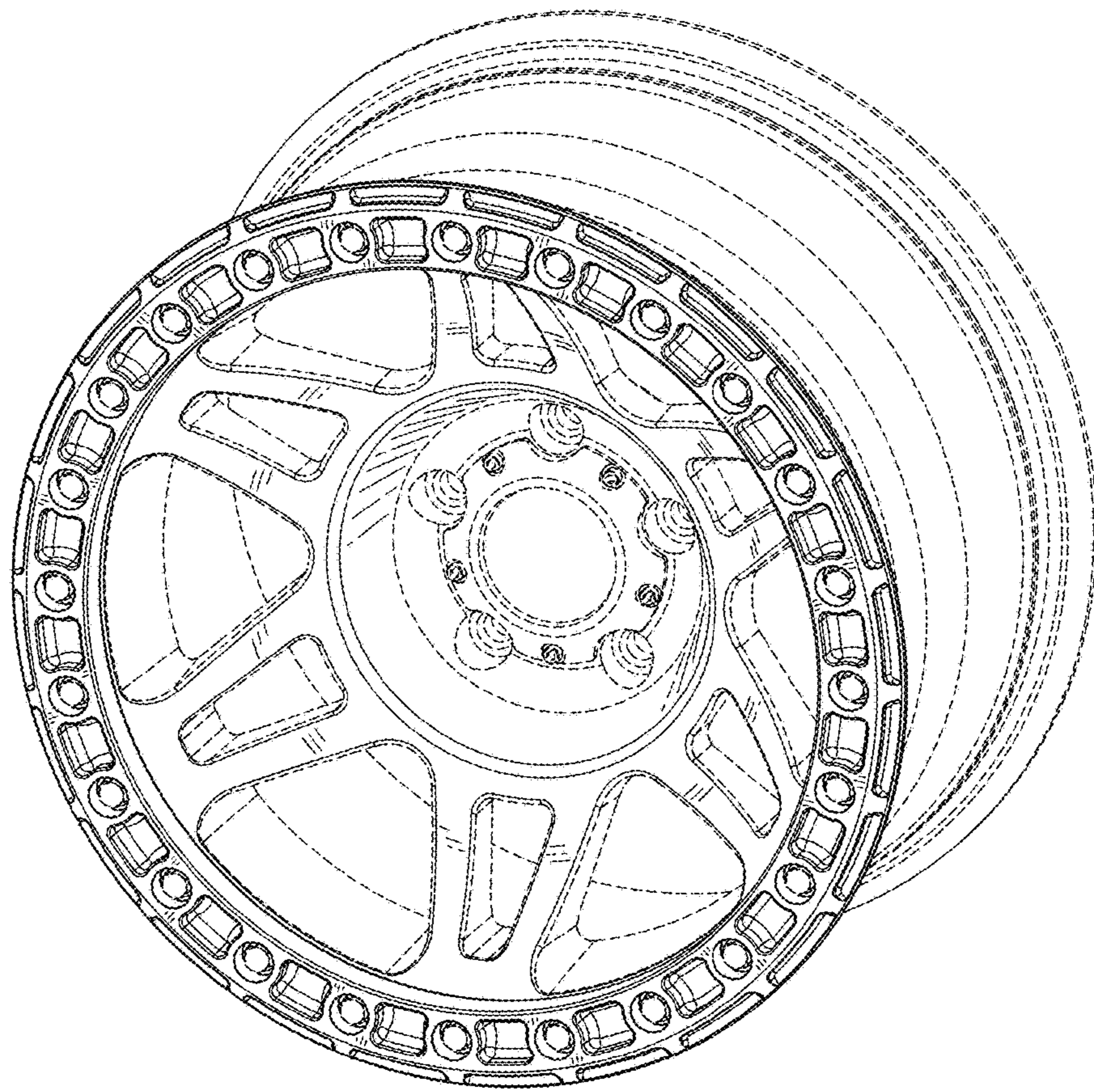

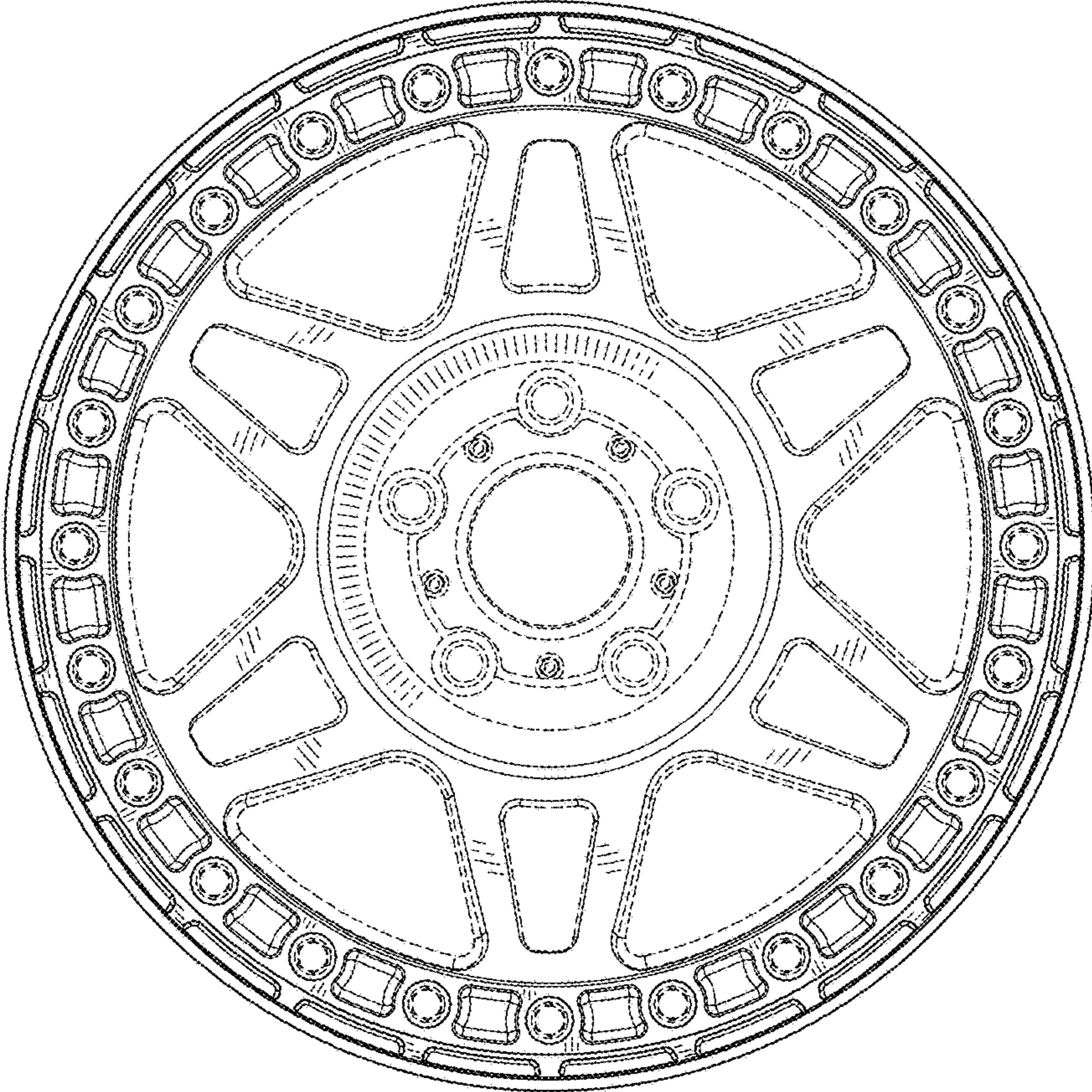

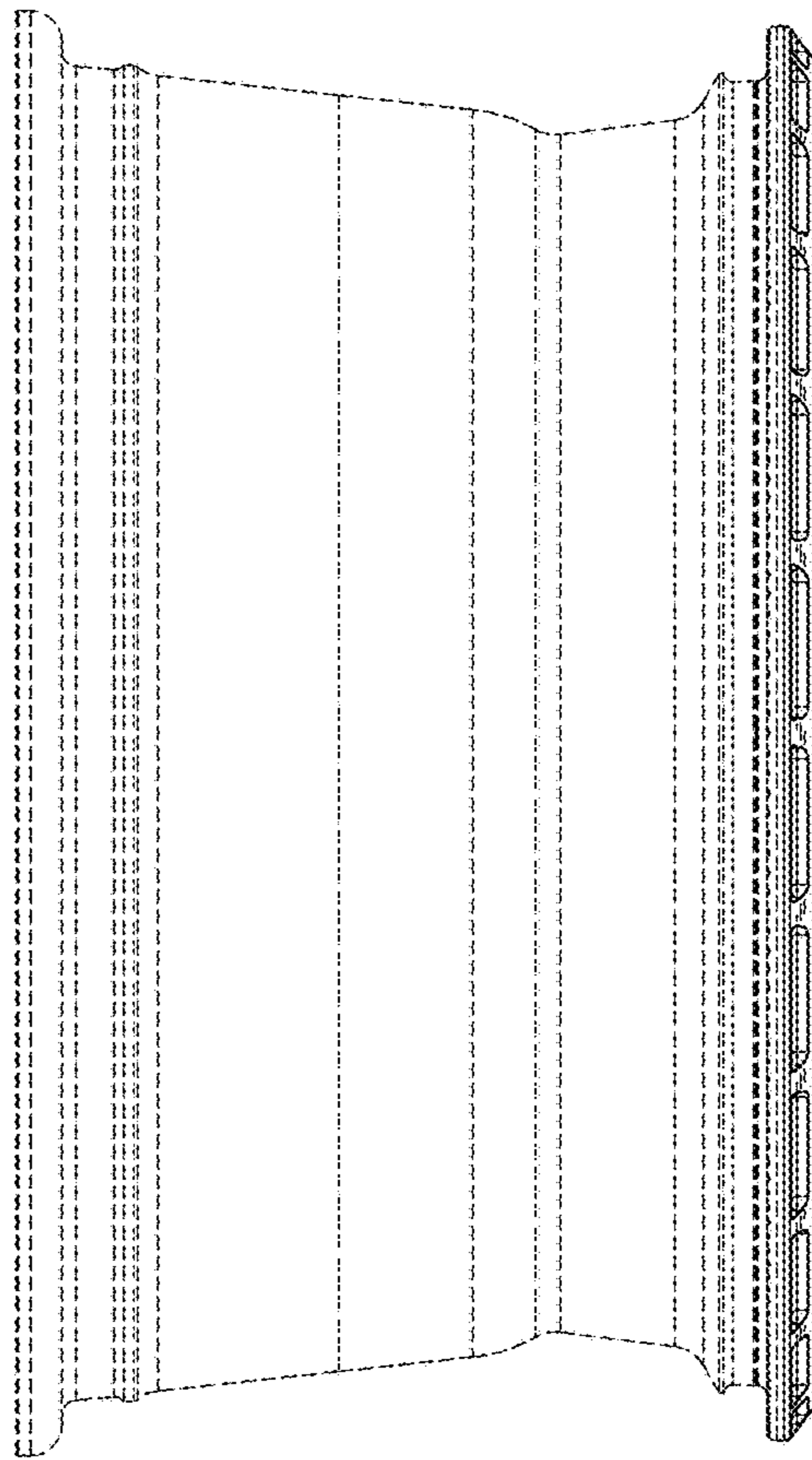
