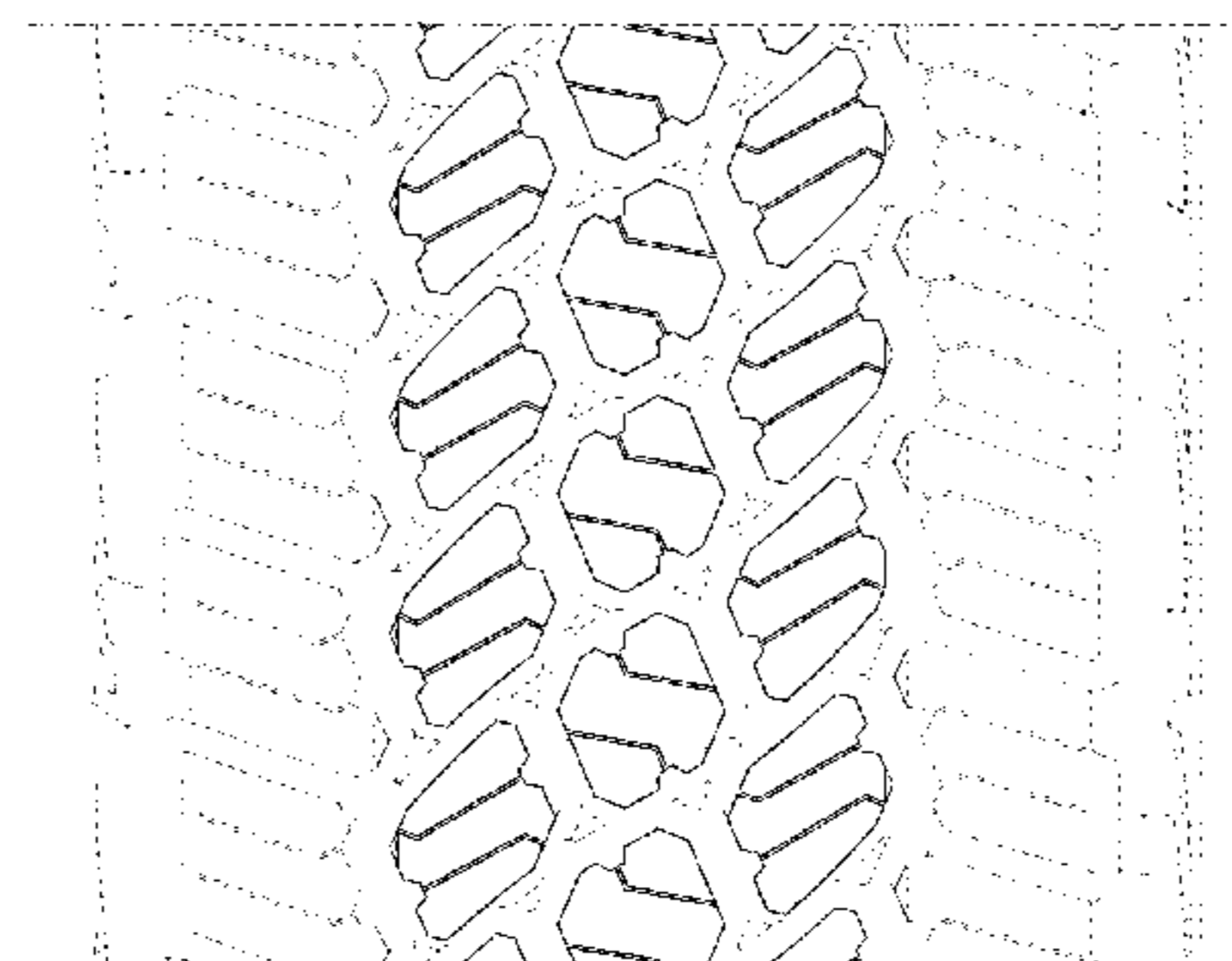
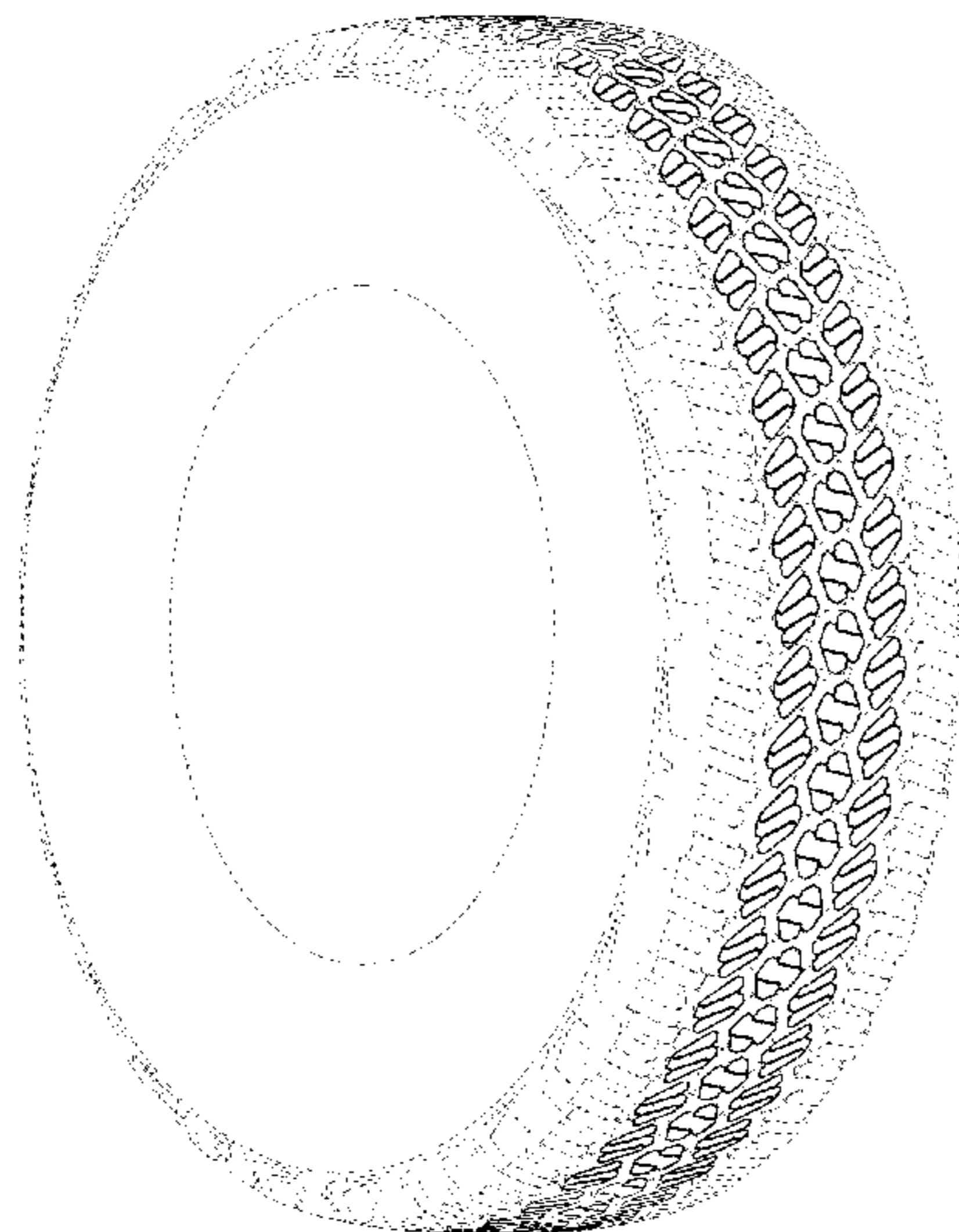
(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a tire tread showing our new design, it being understood that the tread pattern is repeated throughout the circumference of the tire tread, the opposite side being the same as that shown; FIG. 2 is a front elevational view thereof, the opposite side being identical thereto; FIG. 3 is an enlarged fragmentary front elevational view thereof; FIG. 4 is a side elevational view of the left side thereof; and, FIG. 5 is a side elevational view of the right side thereof. The broken lines in the drawings depict environmental subject matter only and form no part of the claimed design.

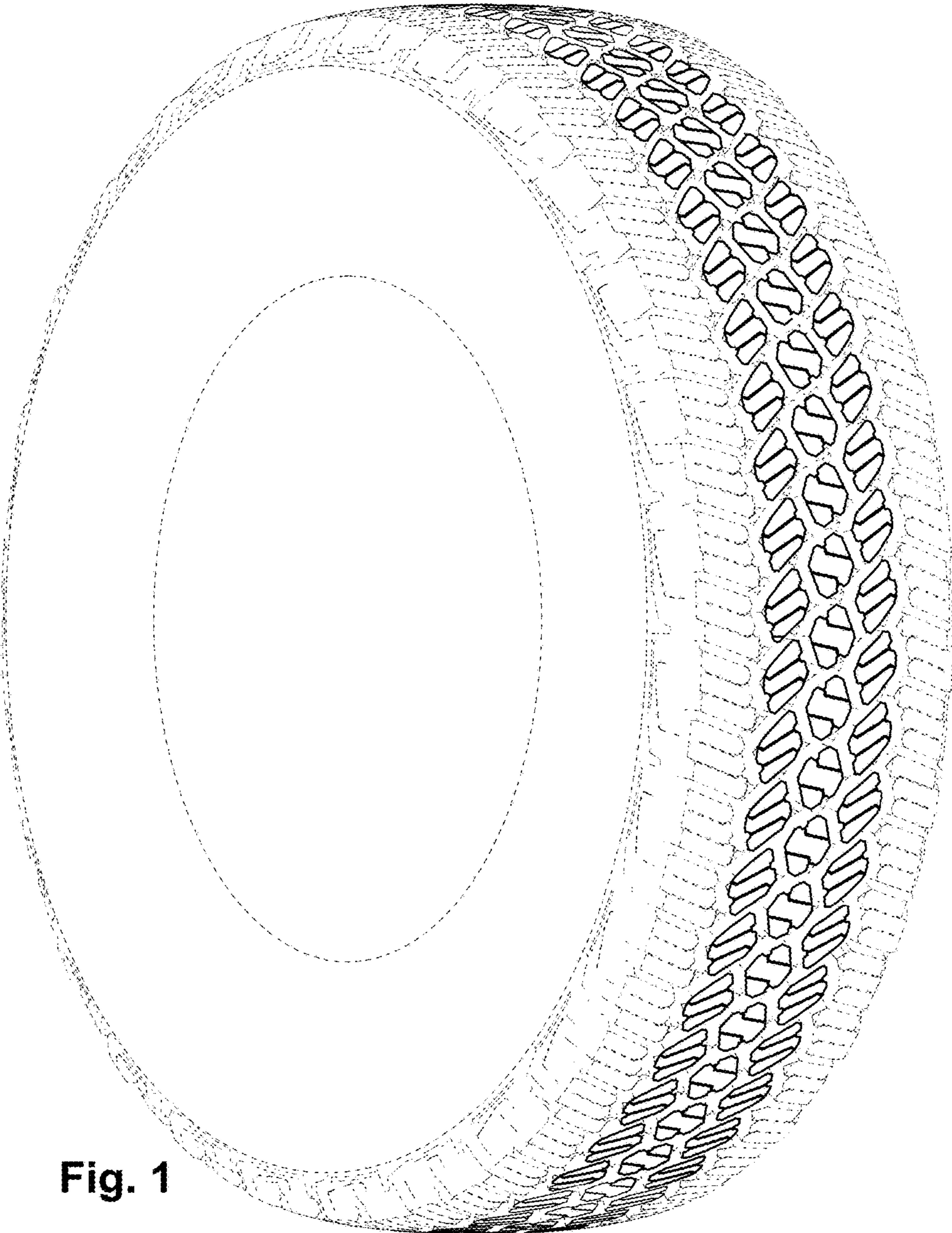
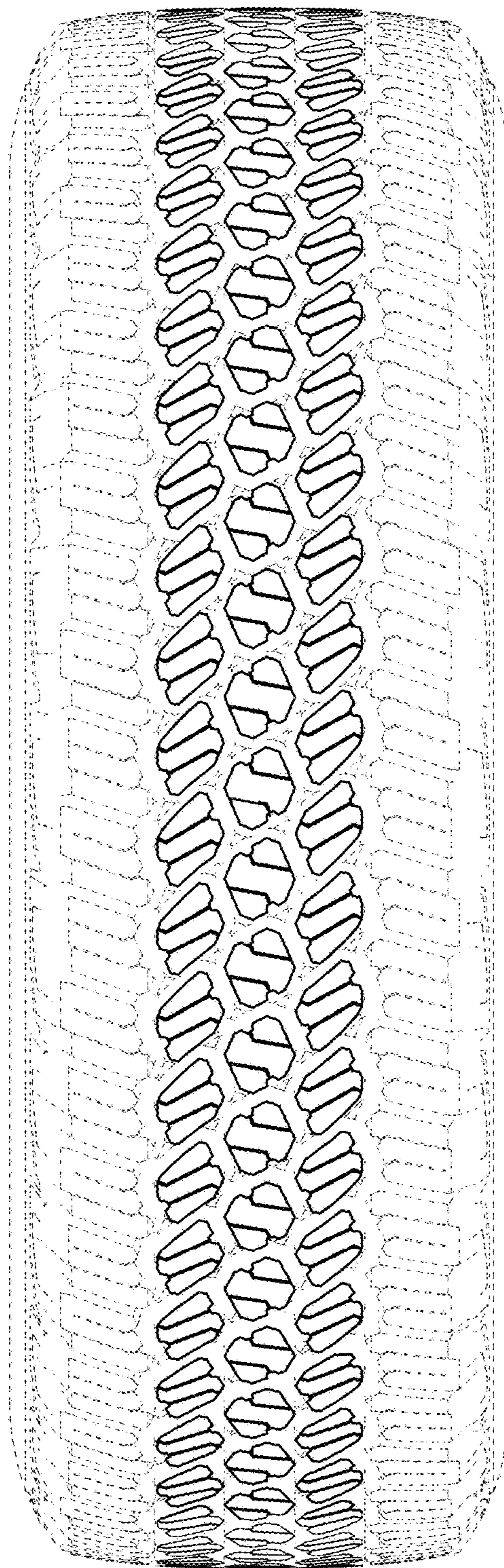

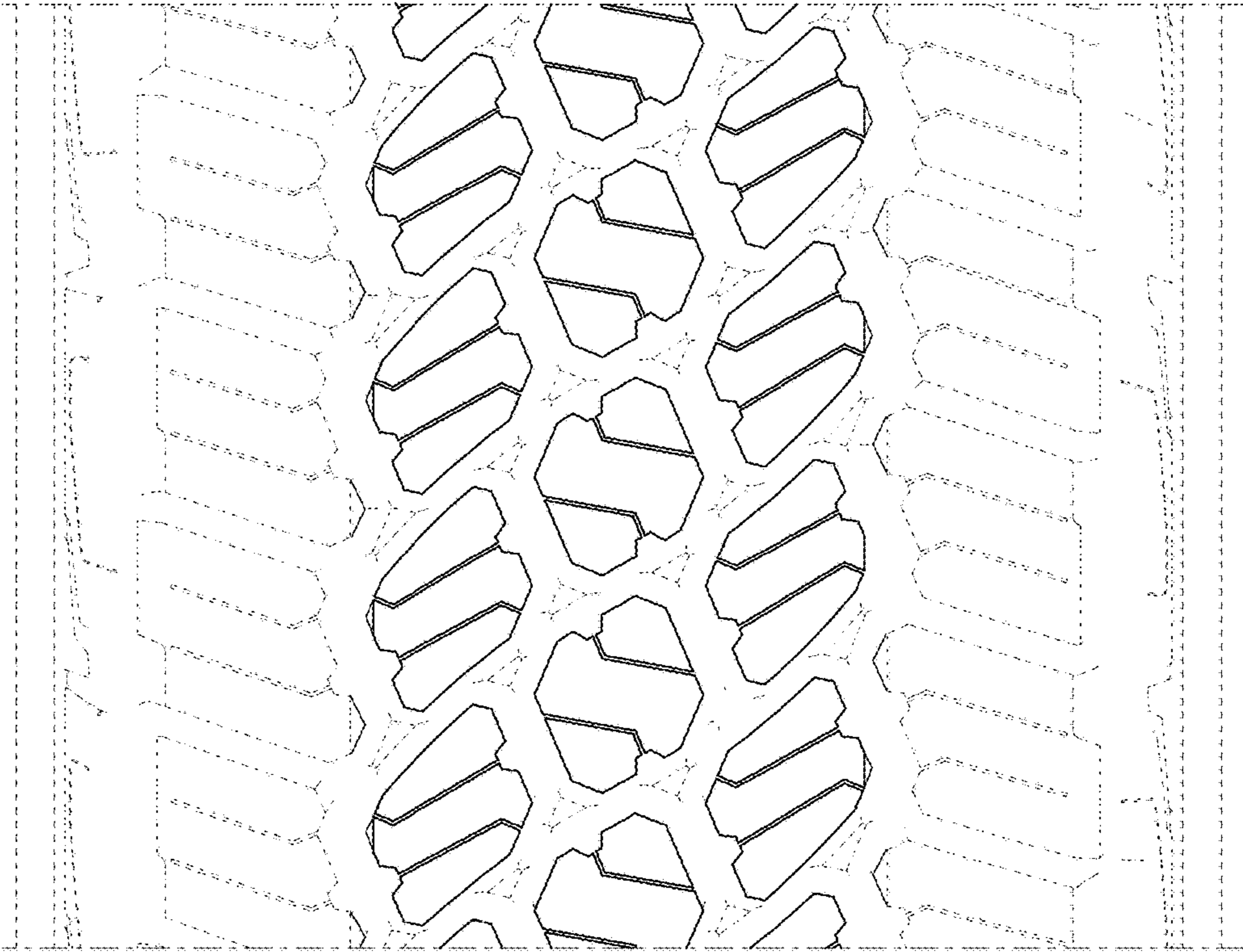

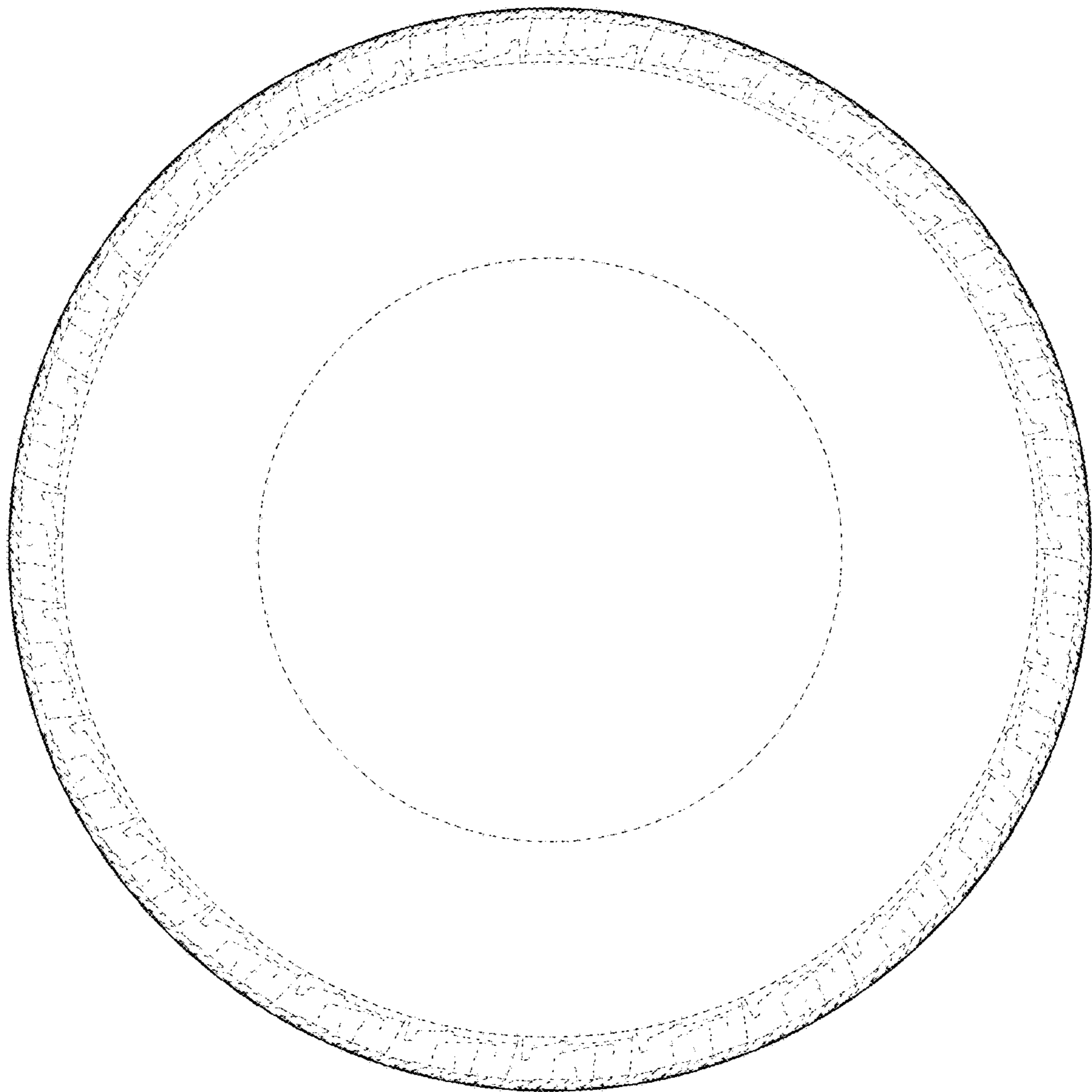

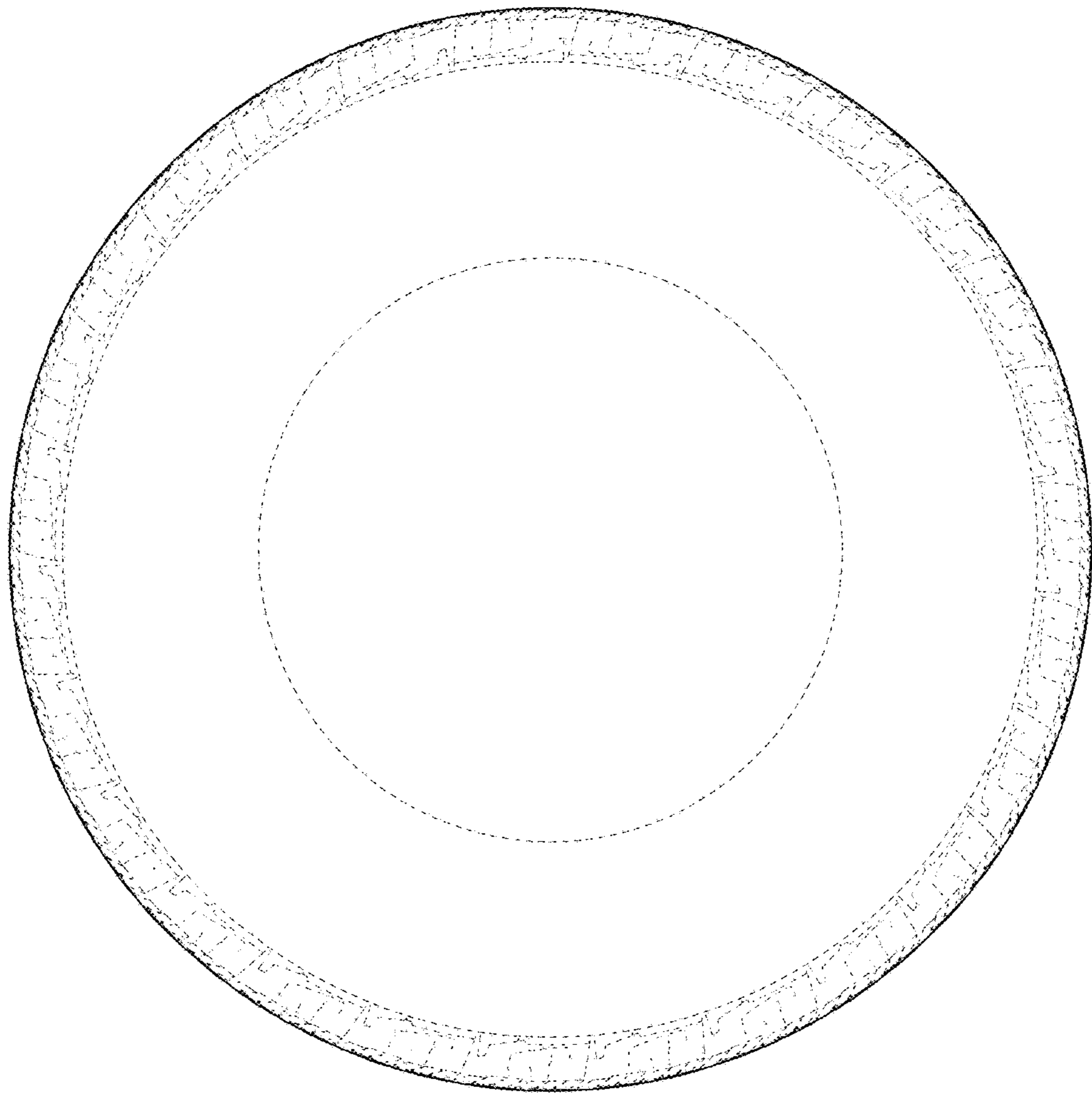
