DESCRIPTION

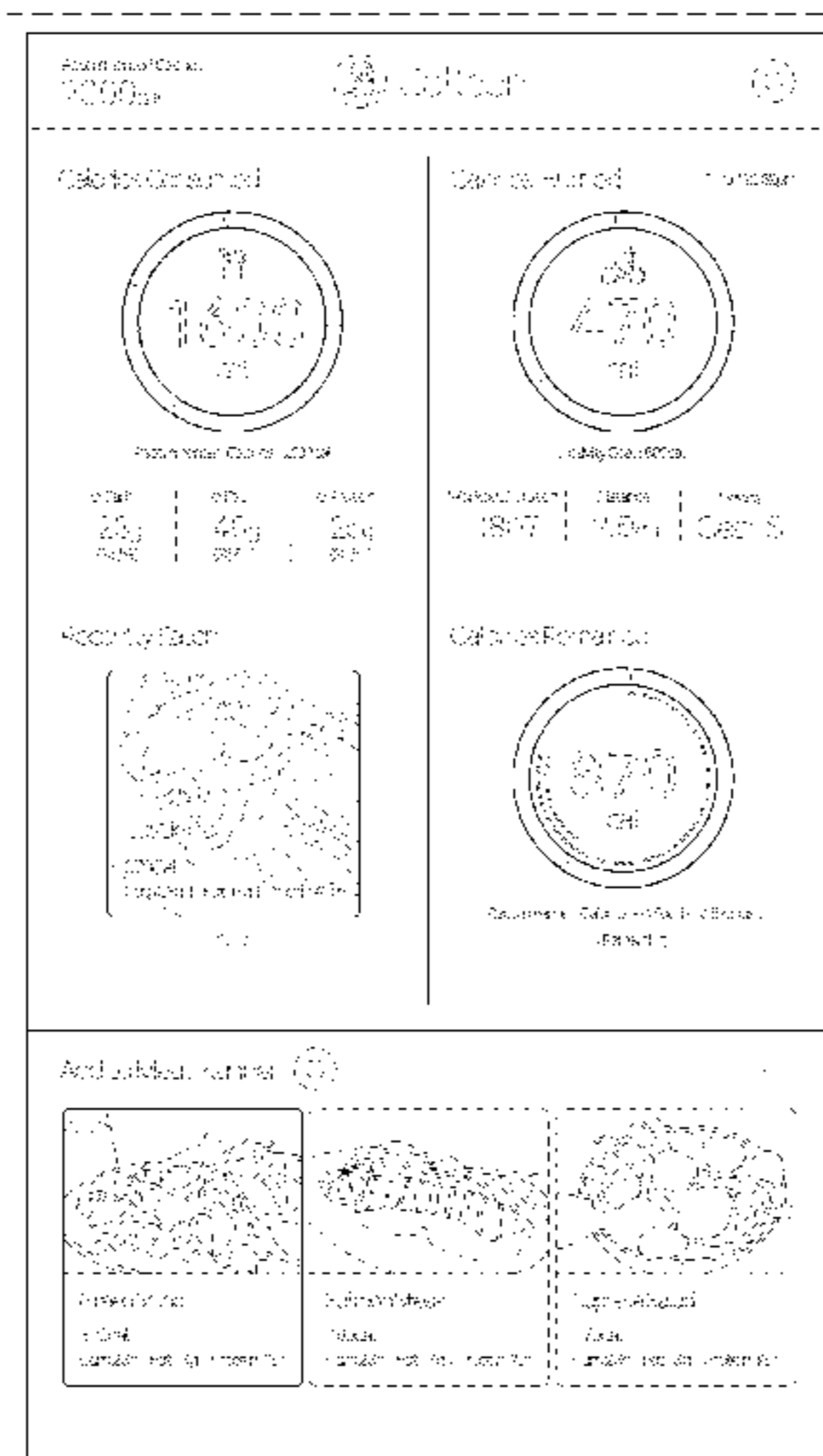
The sole FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design.
