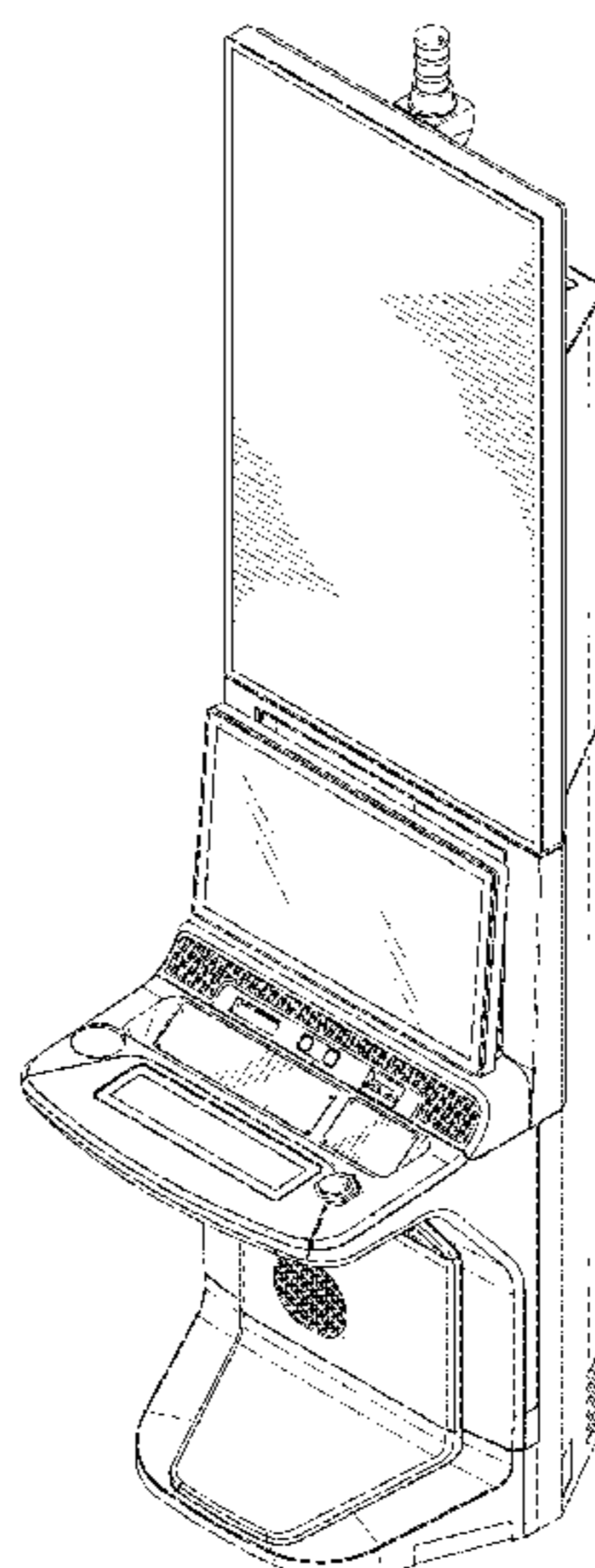
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view from above of a gaming machine showing the new design.

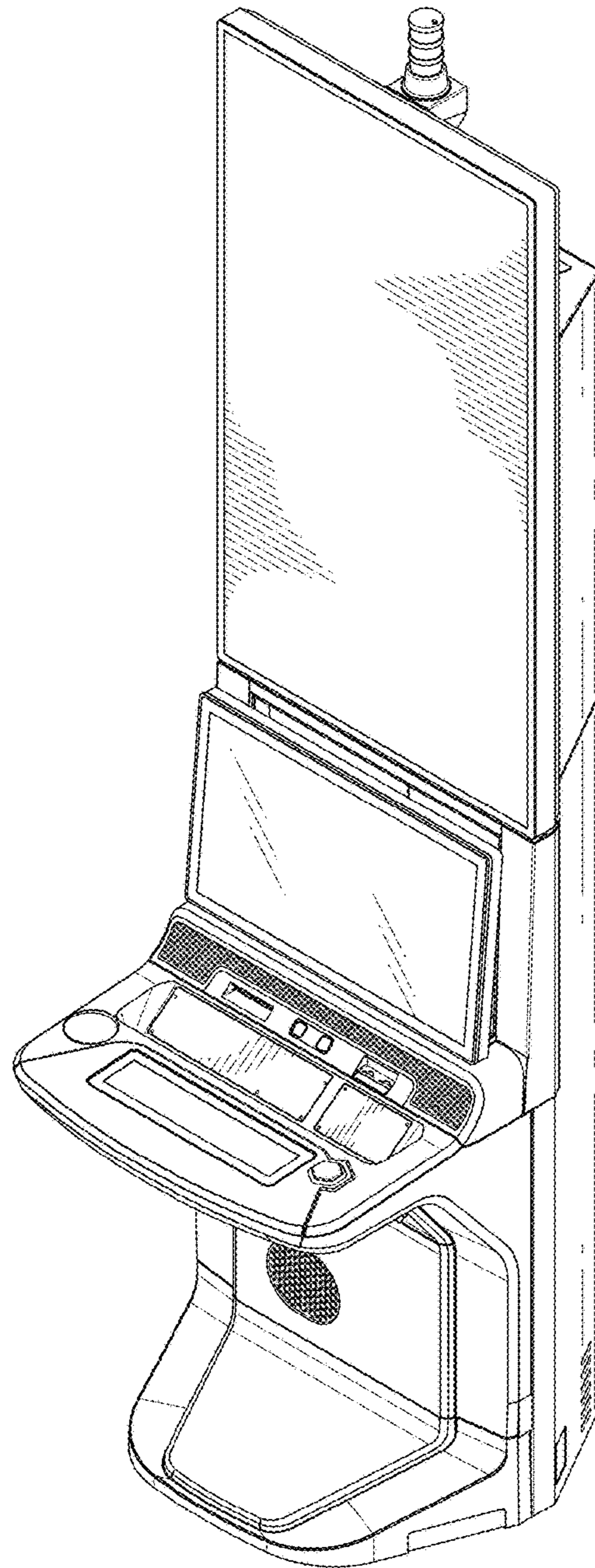

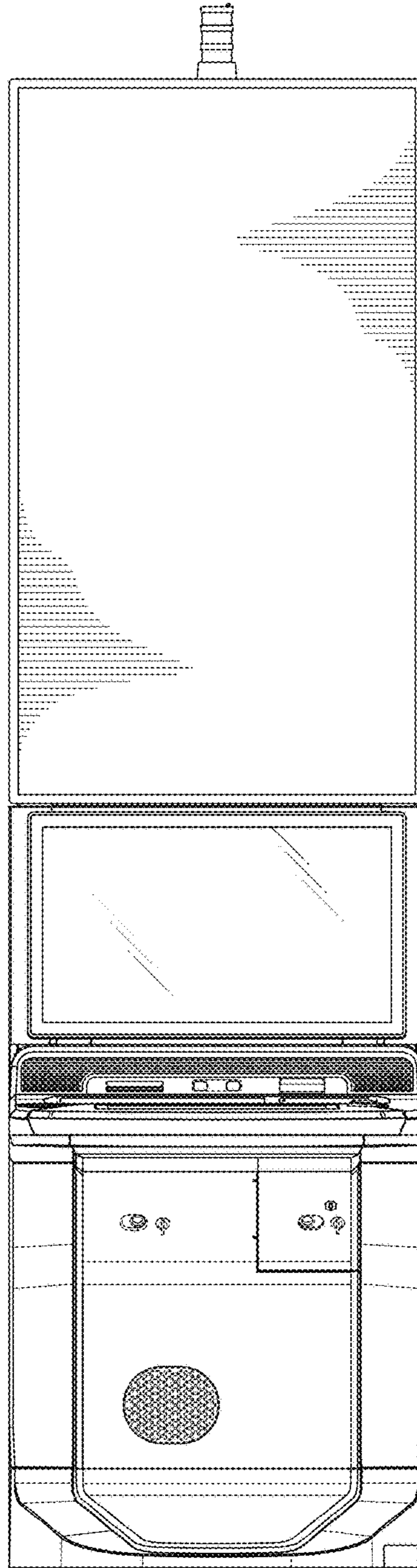

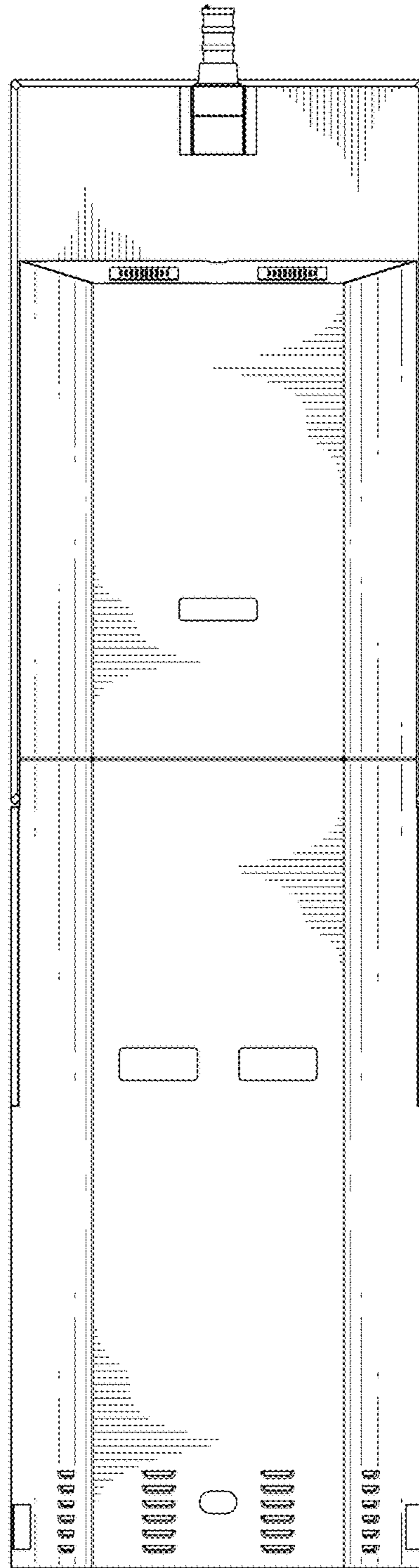

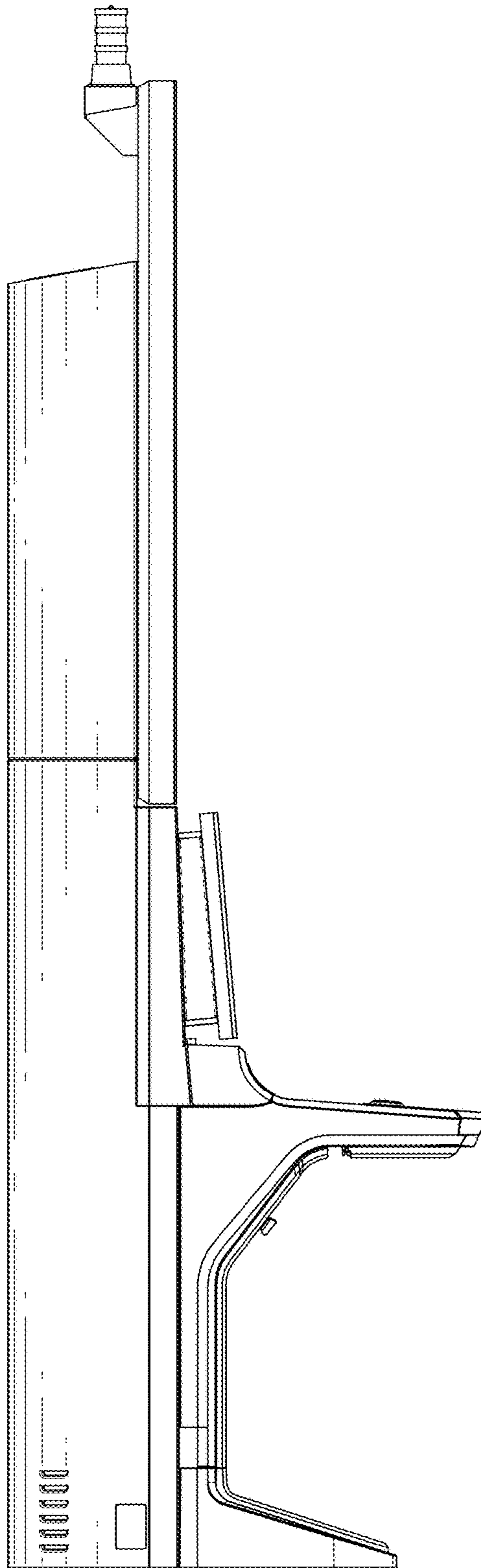

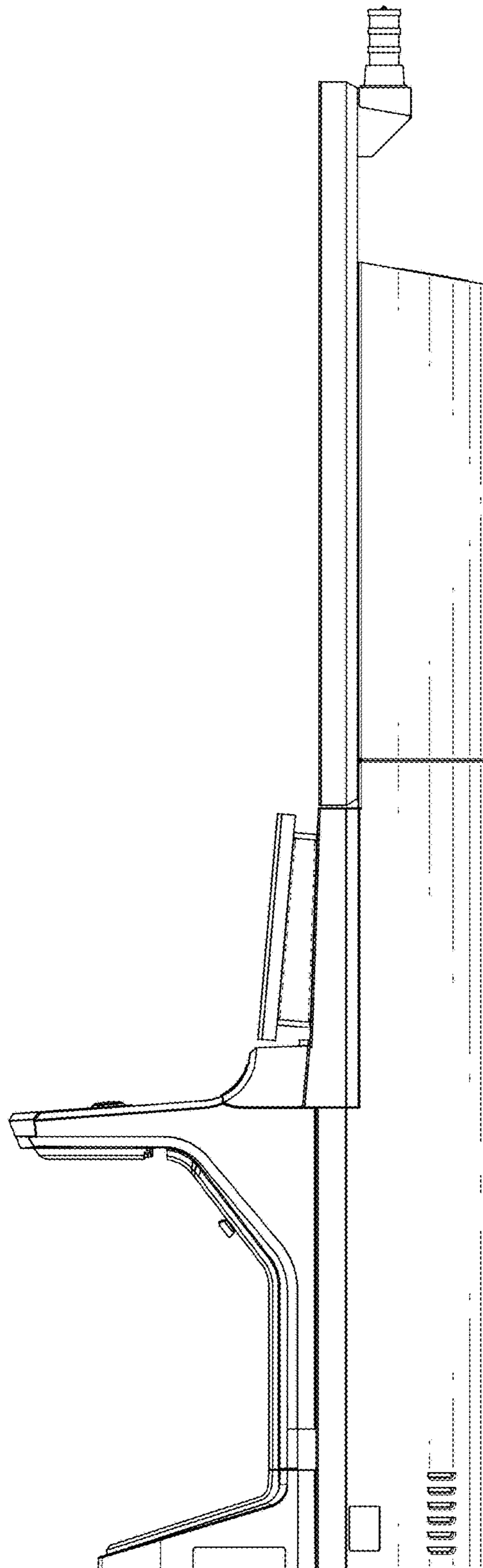

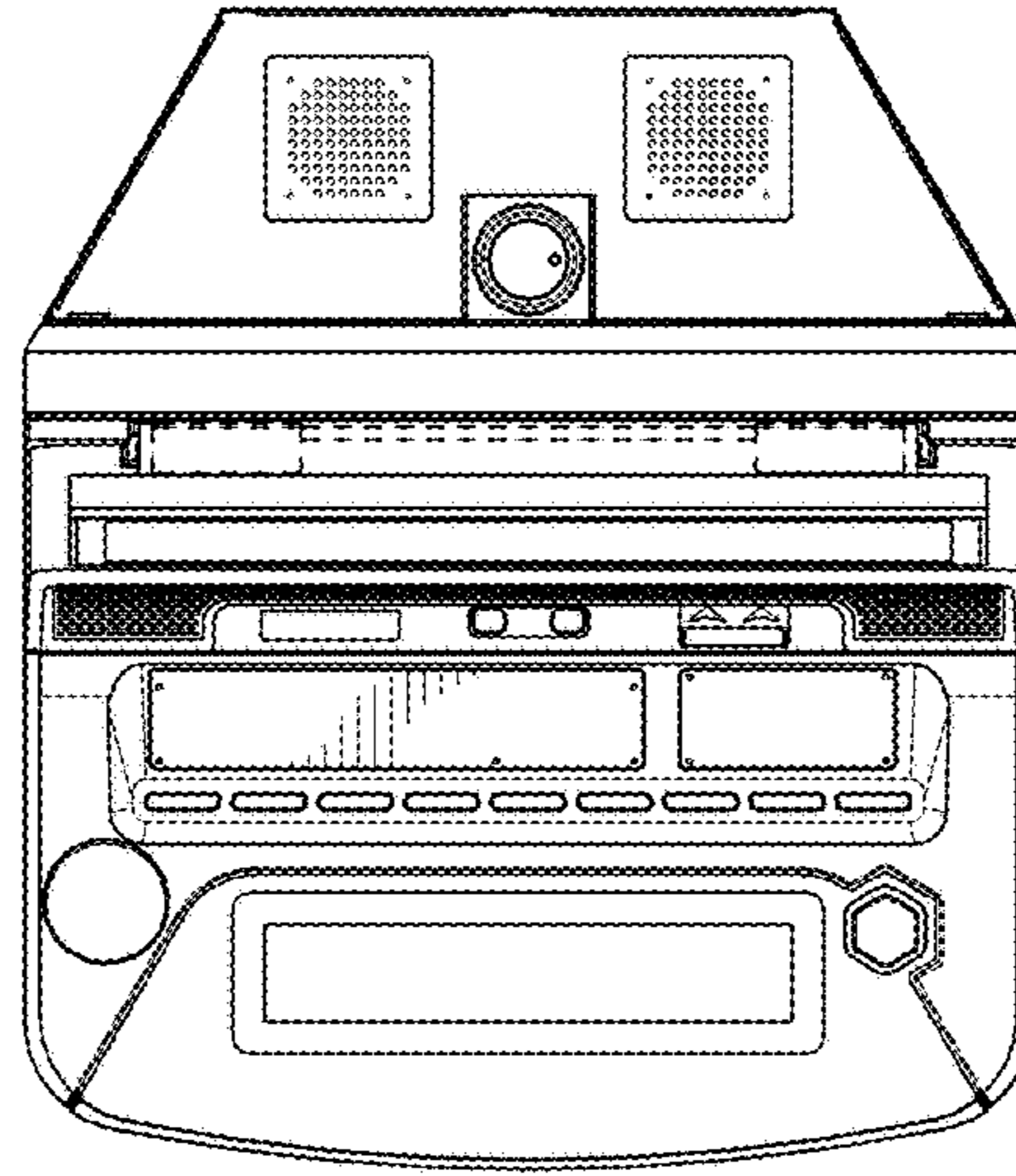

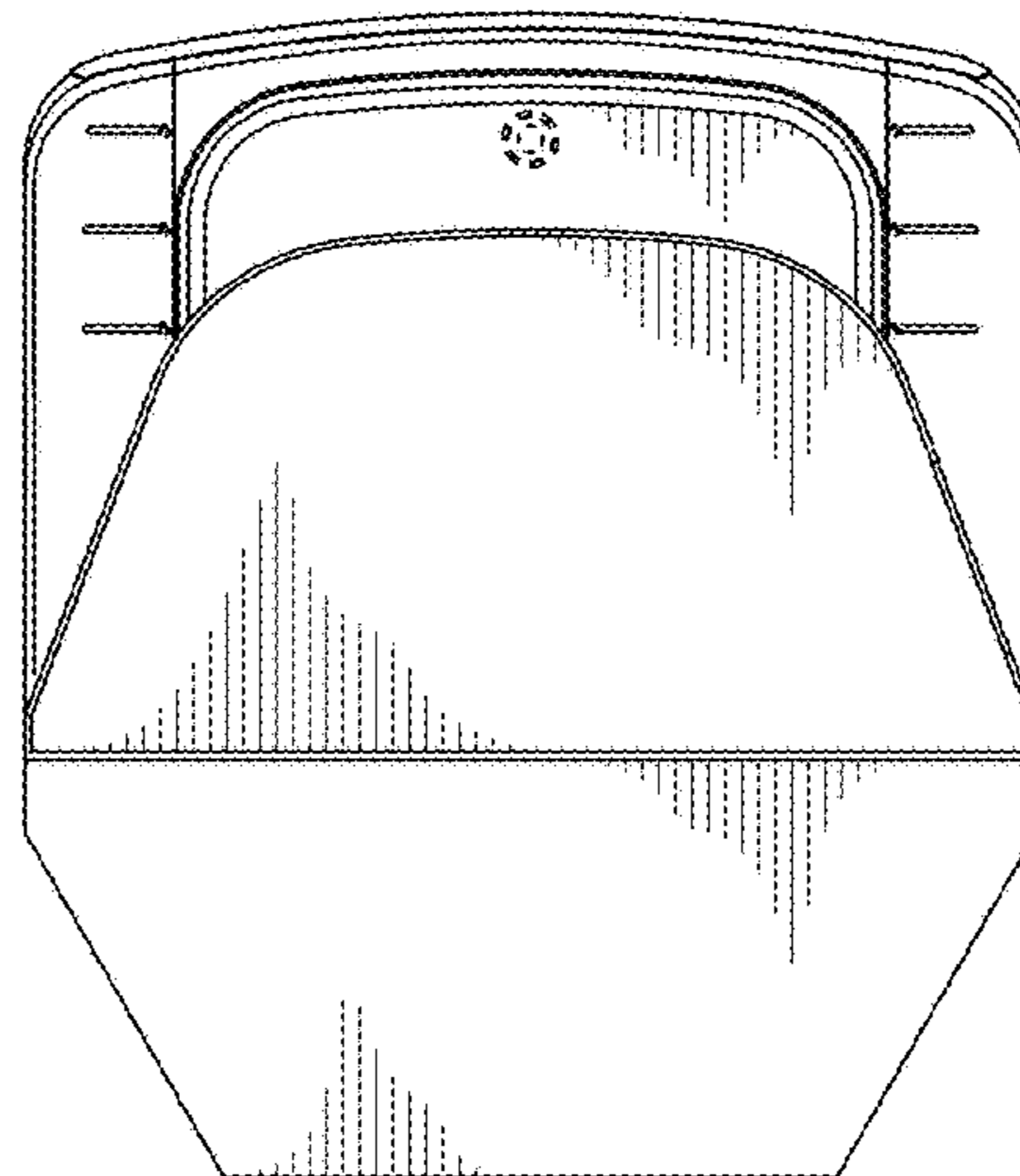
