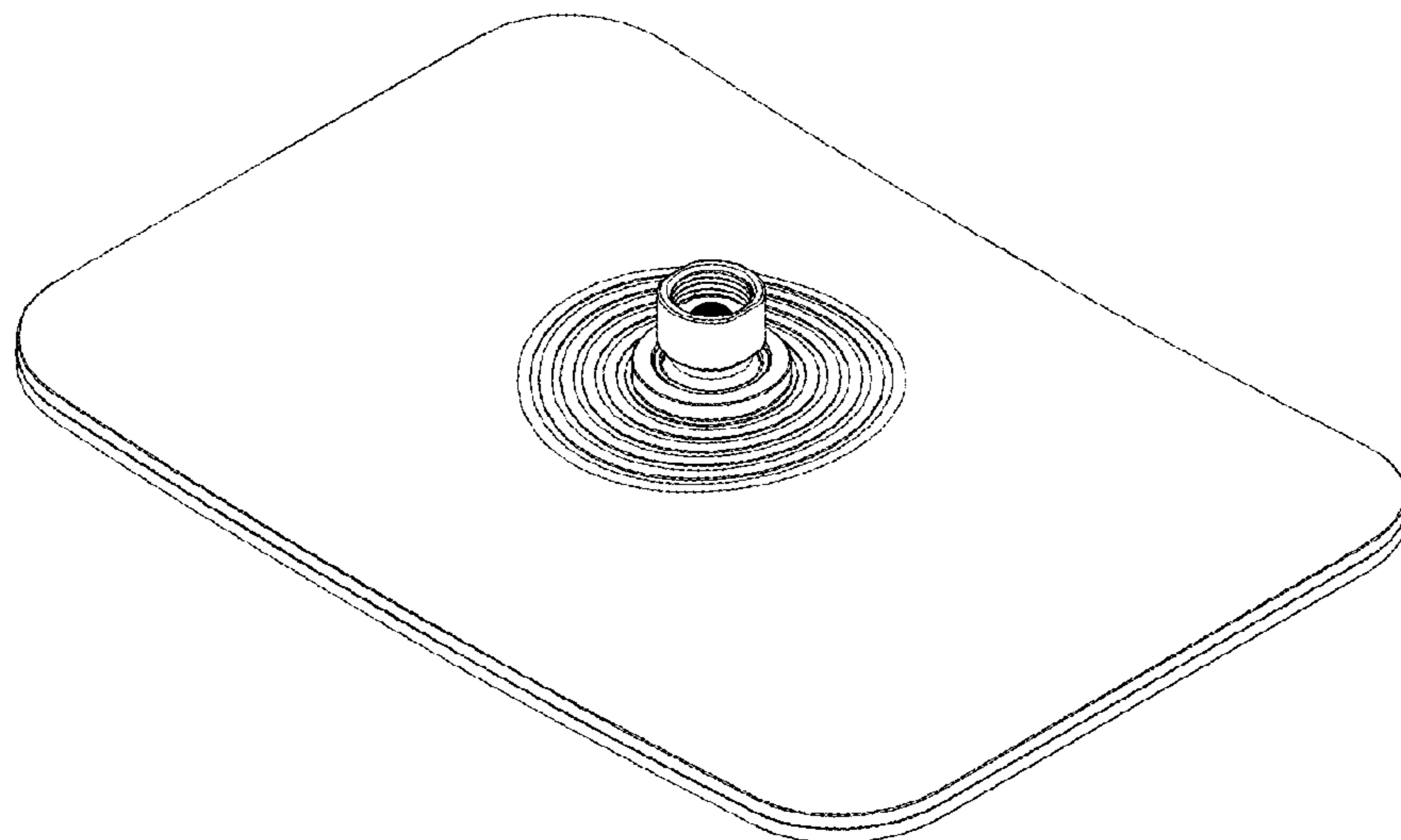
(57) **CLAIM**

We claim the ornamental design for a shower rose, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front right perspective view of a shower rose incorporating our new design;  
FIG. 2 is a bottom front left perspective view thereof;  
FIG. 3 is a front view thereof, the rear view being a mirror image thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a right side view thereof, the left side view being a mirror image thereof; and,  
FIG. 6 is a bottom view thereof.

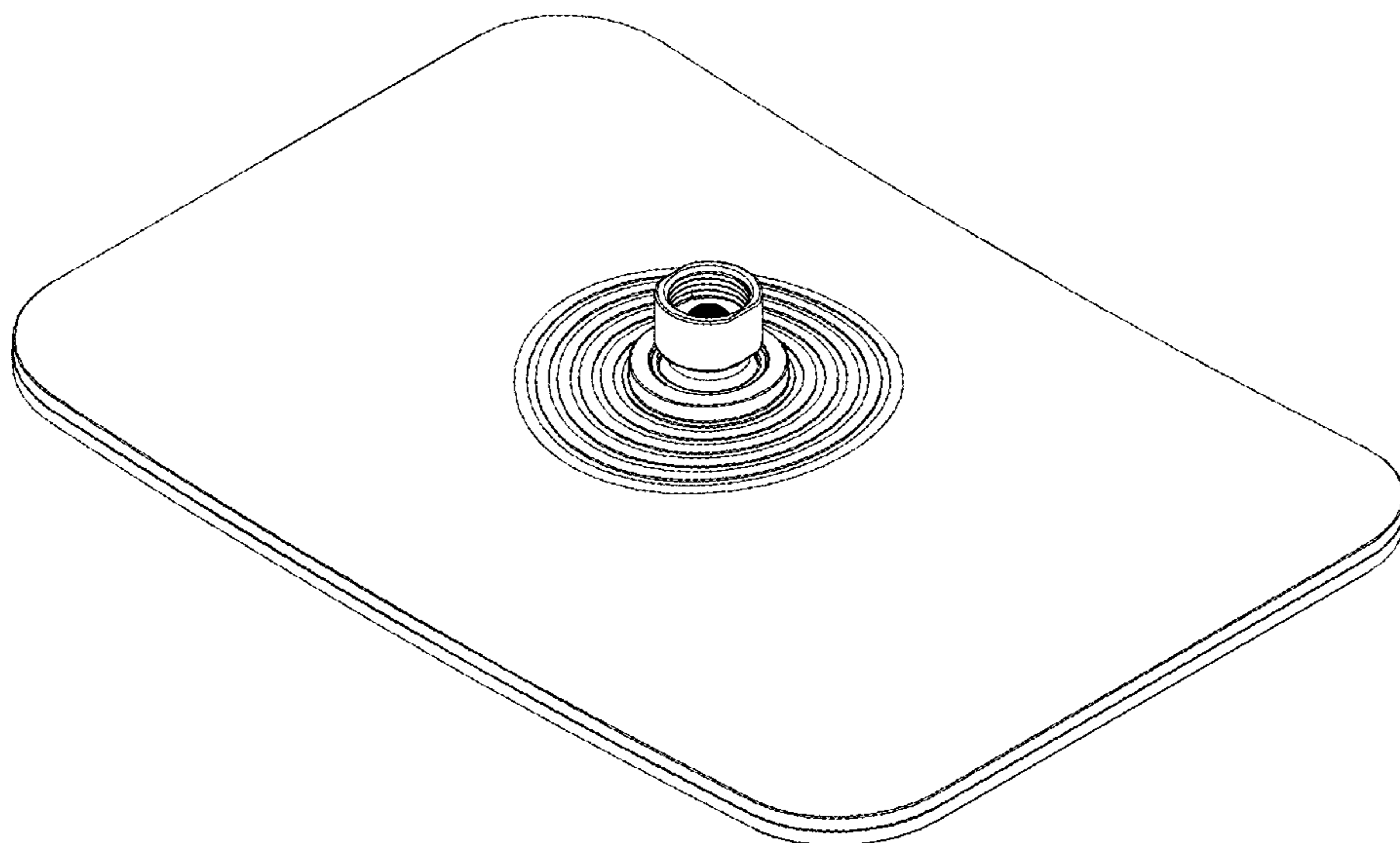

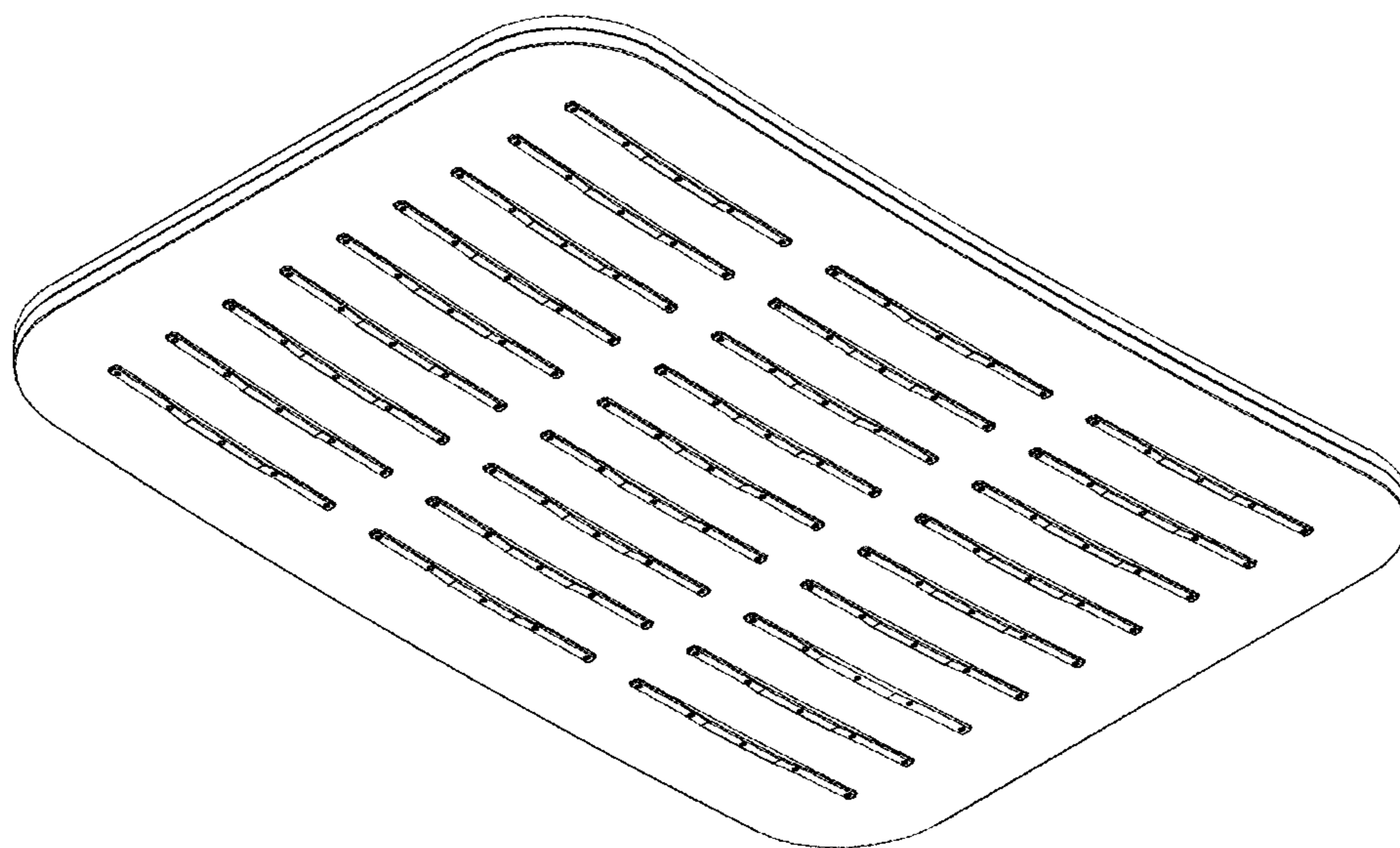

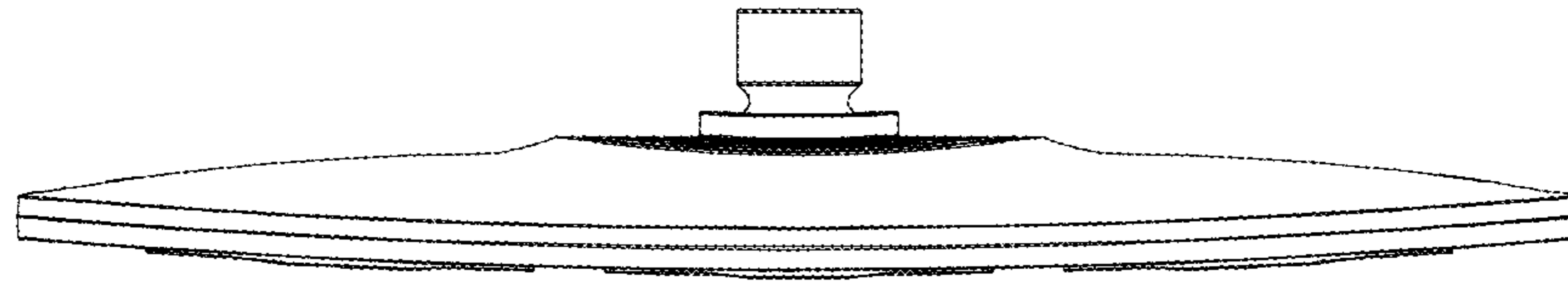

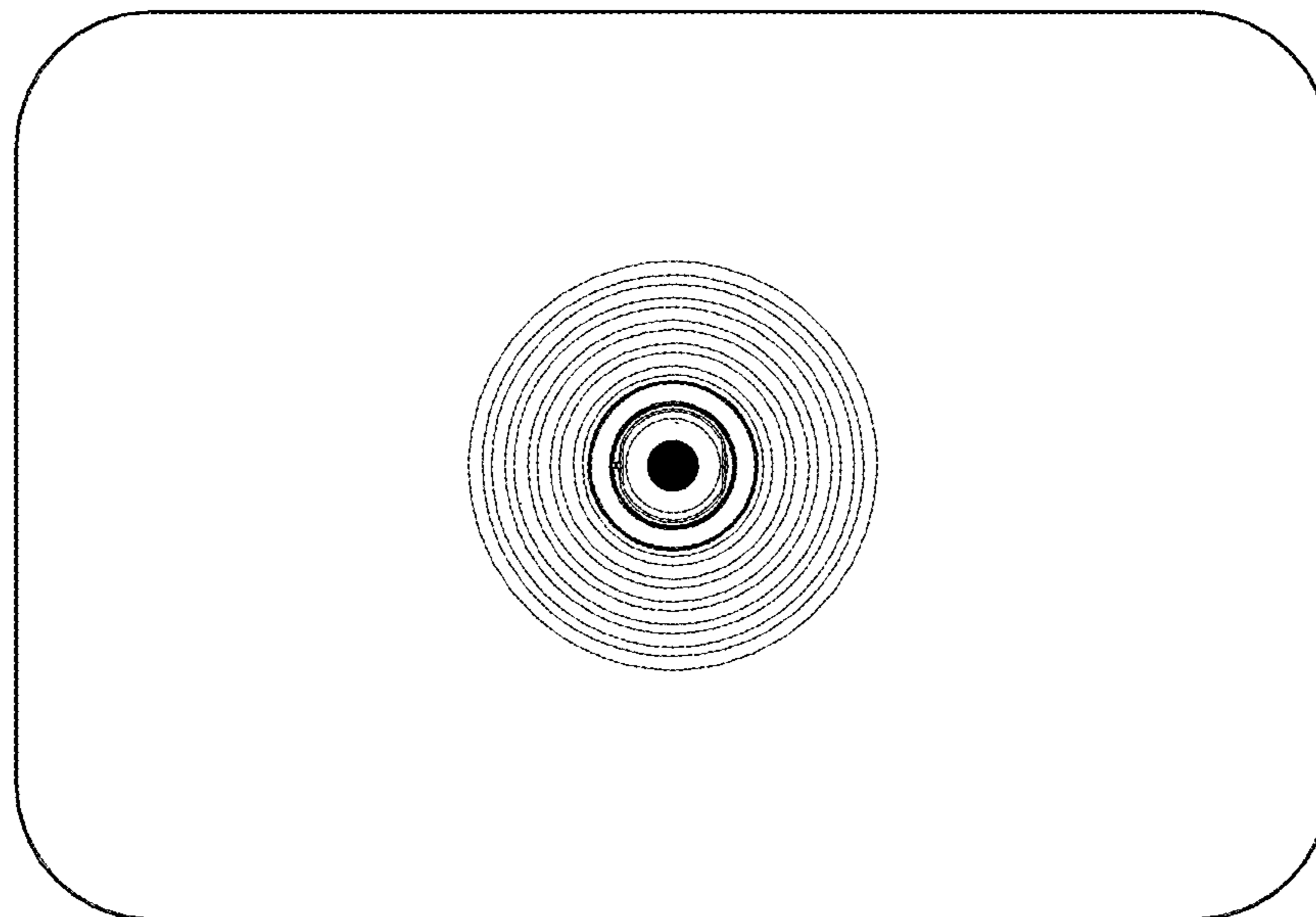

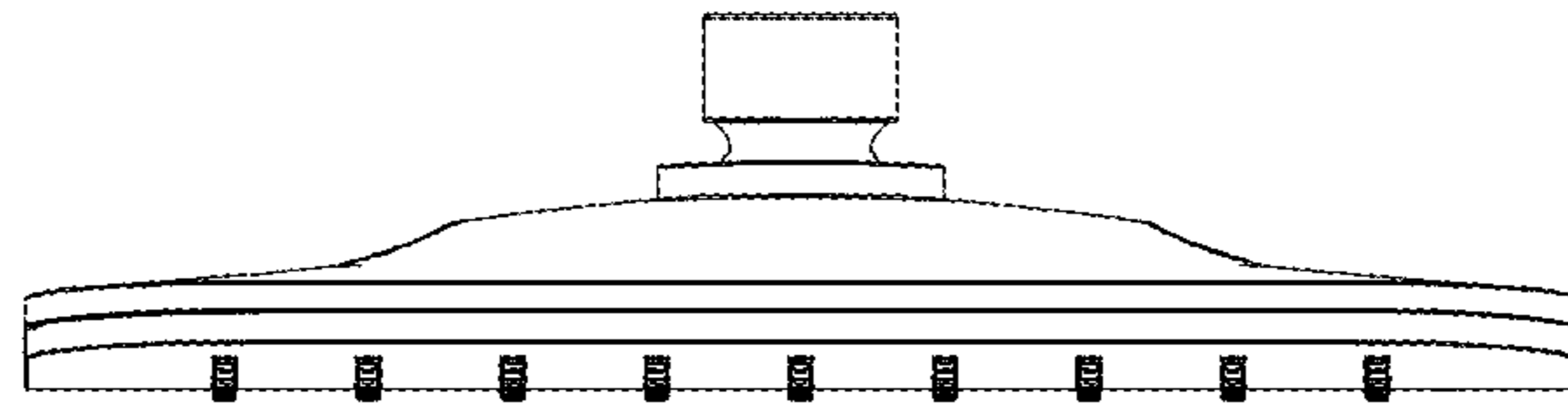

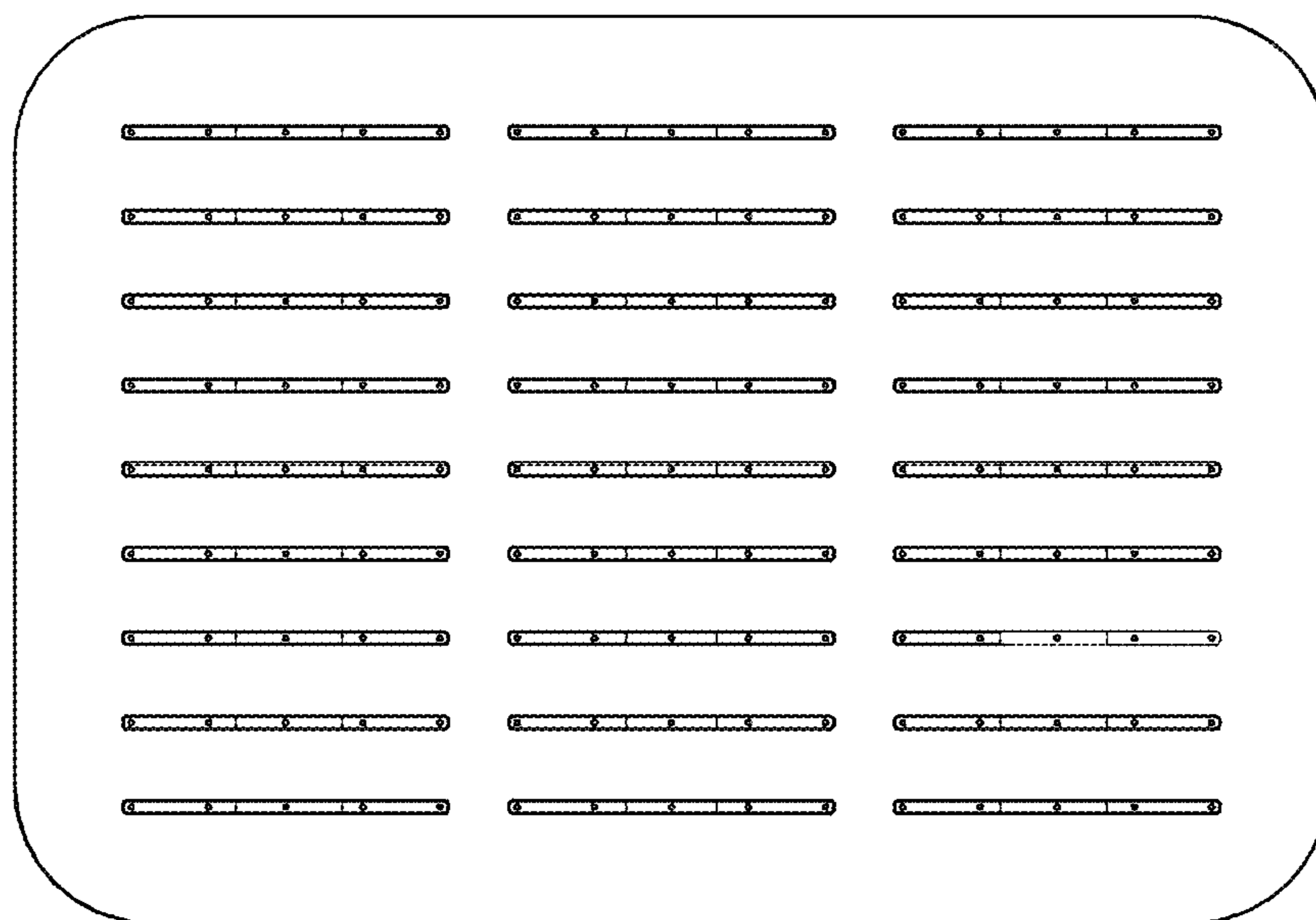
