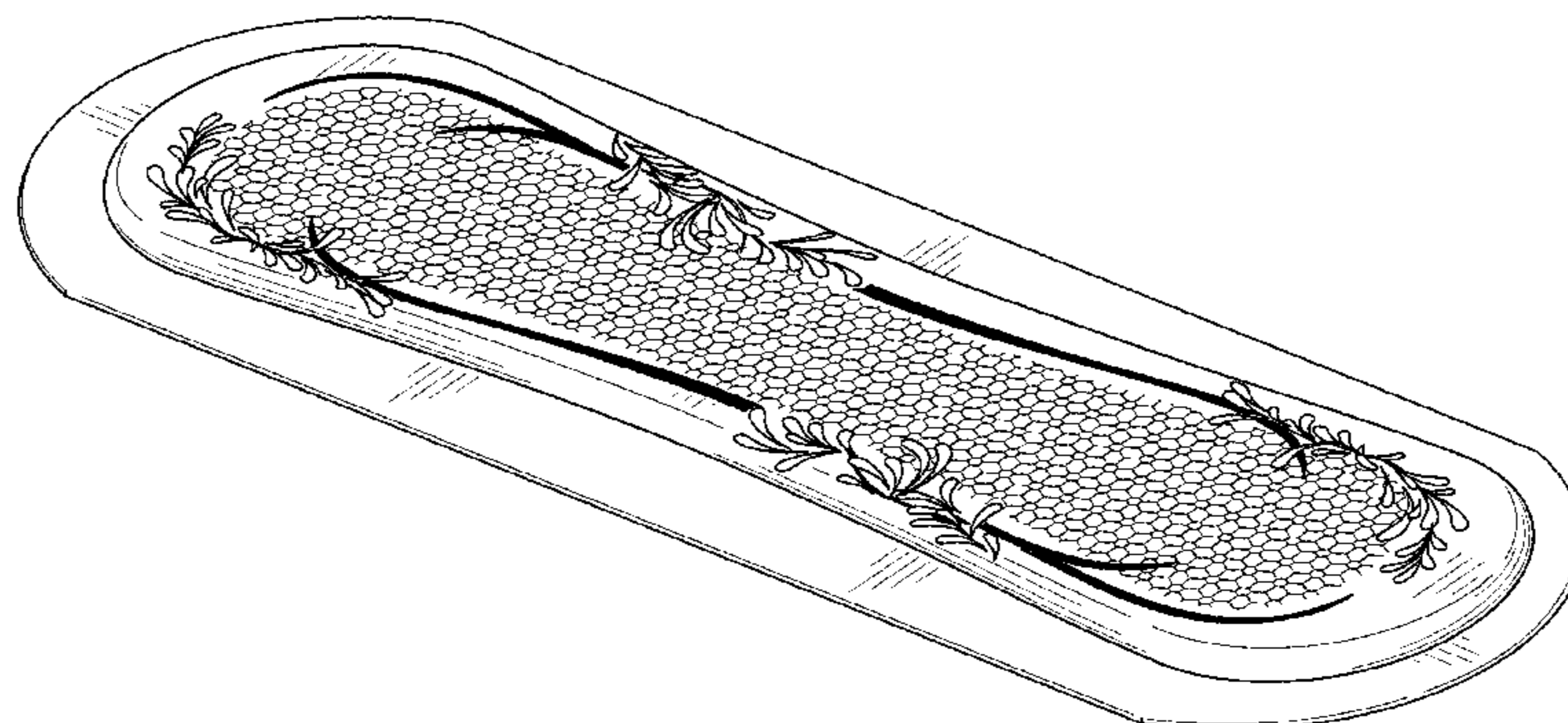


FIG. 8 is a back, bottom, and left side perspective view of the surface pattern applied to the sanitary article of FIG. 1.

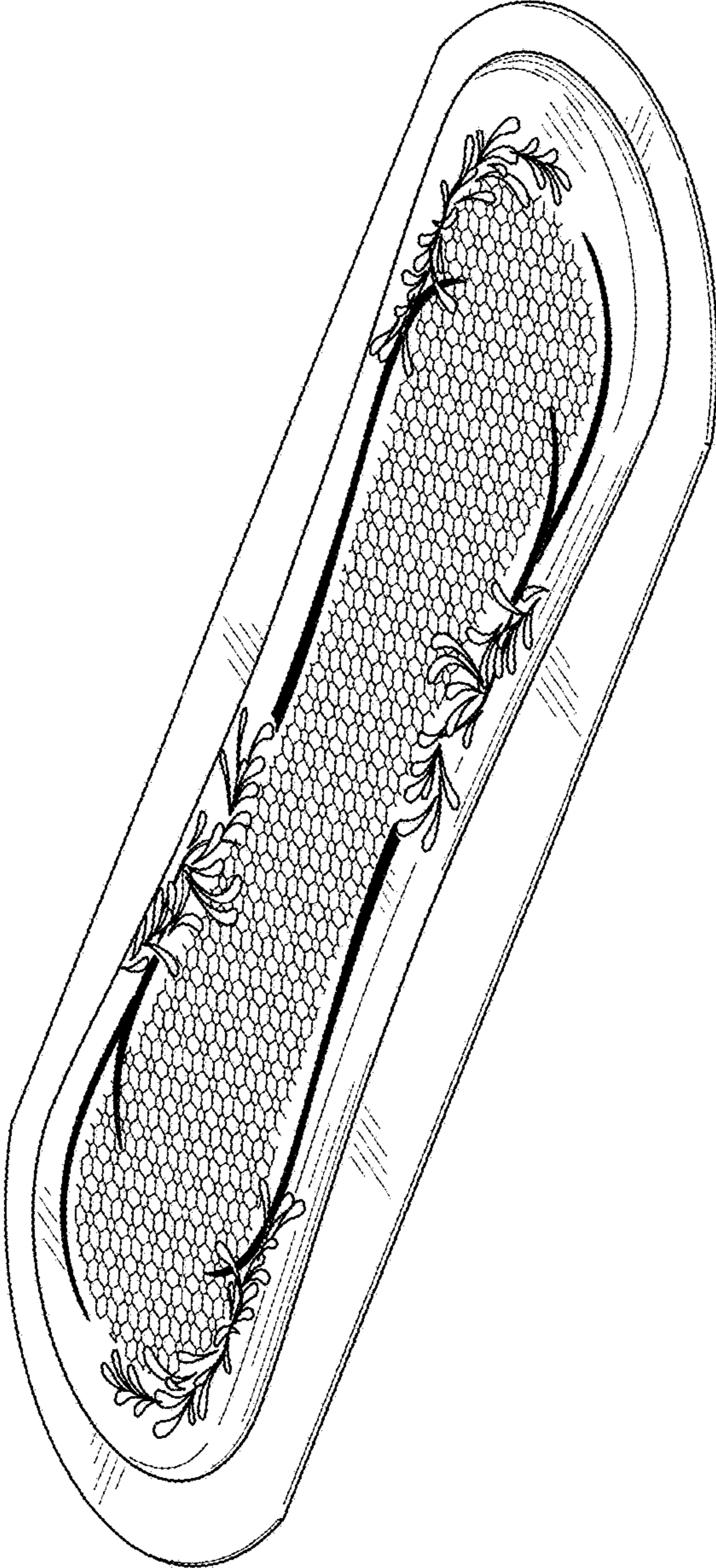

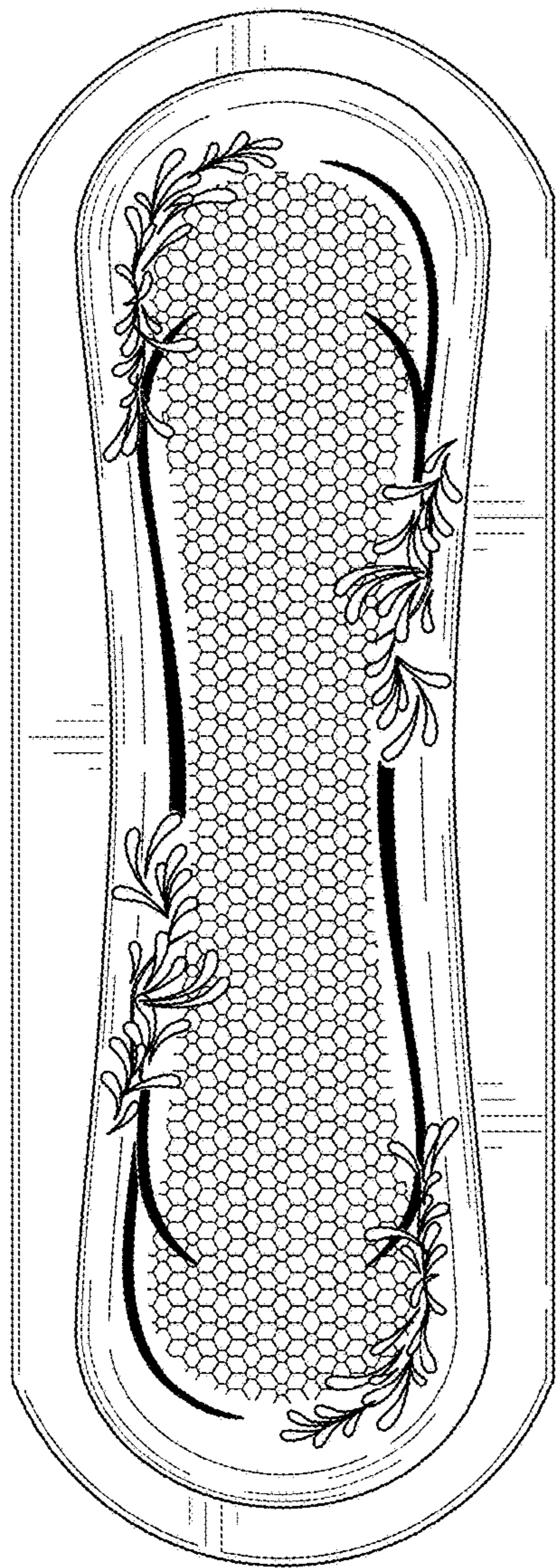

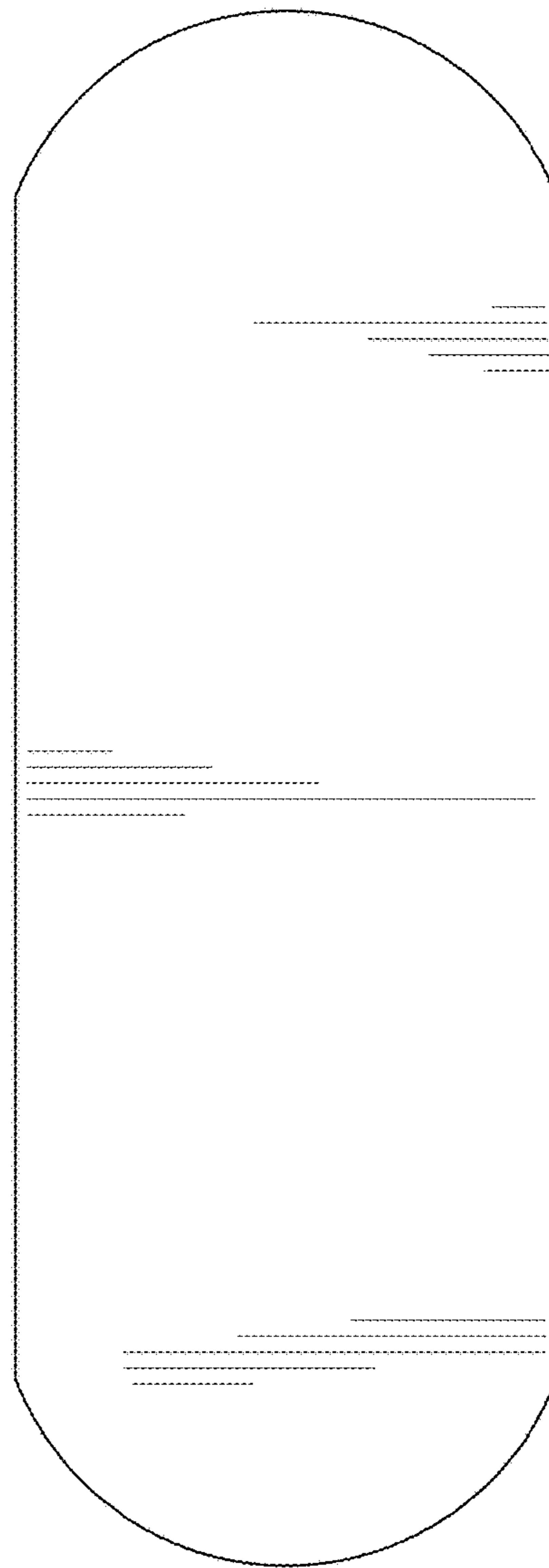

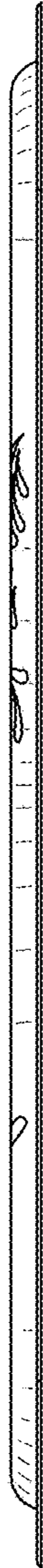

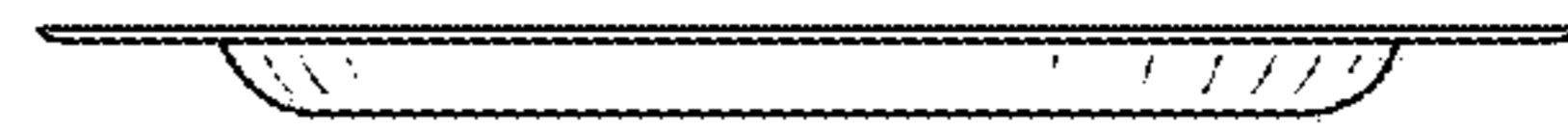

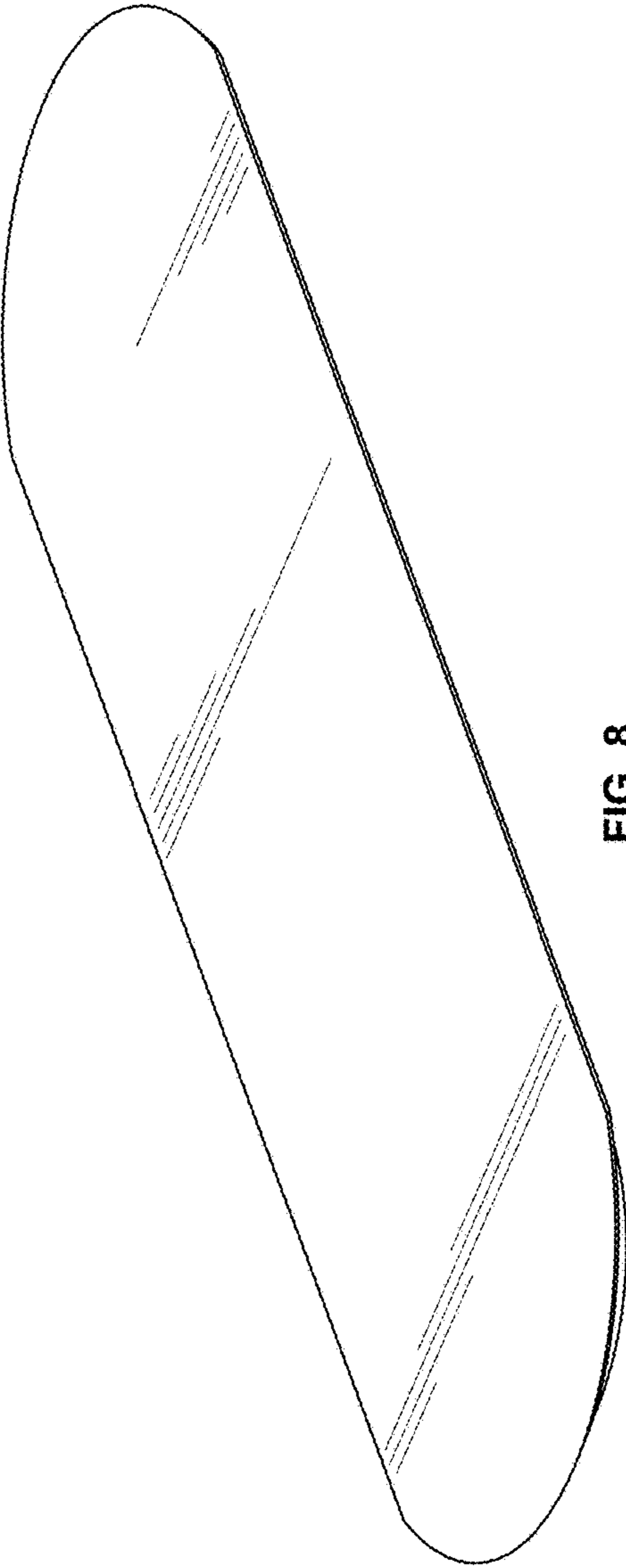
