The ornamental design for foot soaking basin, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a foot soaking basin showing my new design;  
 FIG. 2 is a top plan view of the foot soaking basin of FIG. 1;  
 FIG. 3 is a right side elevation view of the foot soaking basin of FIG. 1, the left side elevation view being a mirror image thereof;  
 FIG. 4 is a side elevation cross-sectional view of the foot soaking basin of FIG. 8, taken along line 4-4 in FIG. 2;  
 FIG. 5 is a side elevation cross-sectional view of the foot soaking basin of FIG. 8, taken along line 5-5 in FIG. 2;  
 FIG. 6 is a side elevation cross-sectional view of the foot soaking basin of FIG. 8, taken along line 6-6 in FIG. 2; and,  
 FIG. 7 is a bottom plan view of the foot soaking basin of FIG. 1.  
 The broken lines depict unclaimed subject matter only and form no part of the claimed design.  
 The broken lines and hatching in the cross-sectional views of FIGS. 4-6 show unclaimed internal structure that forms no part of the claimed design.

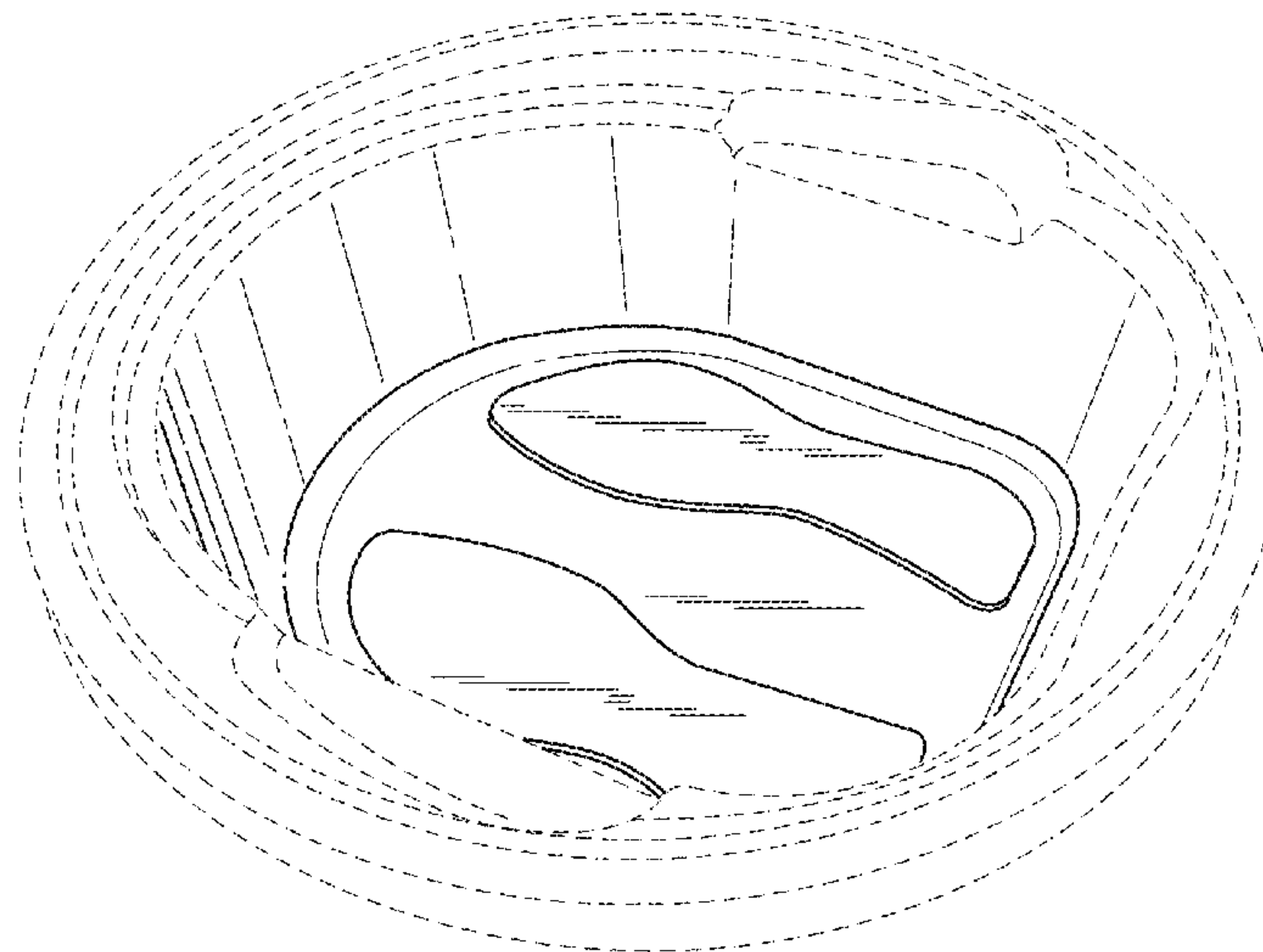

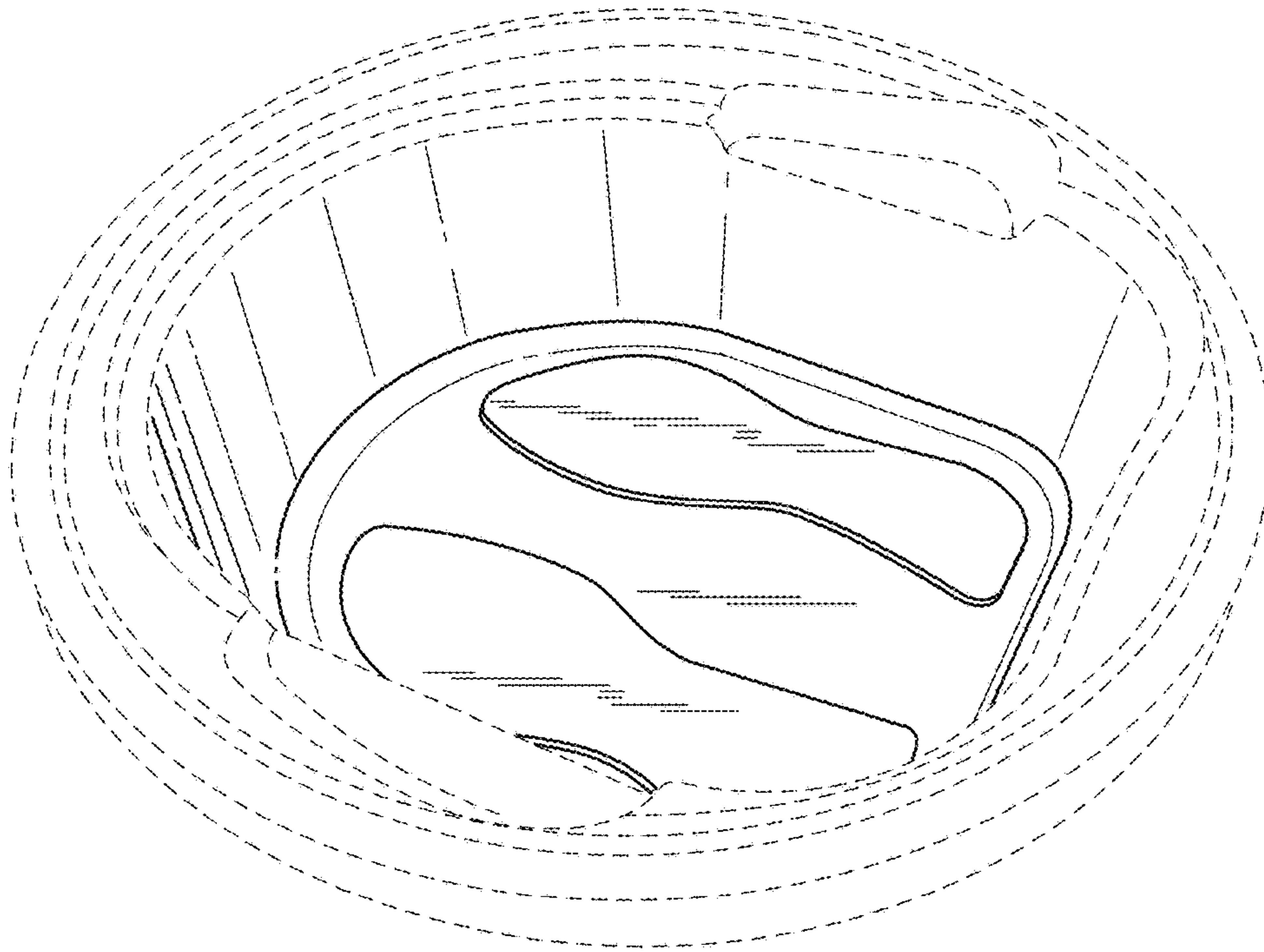
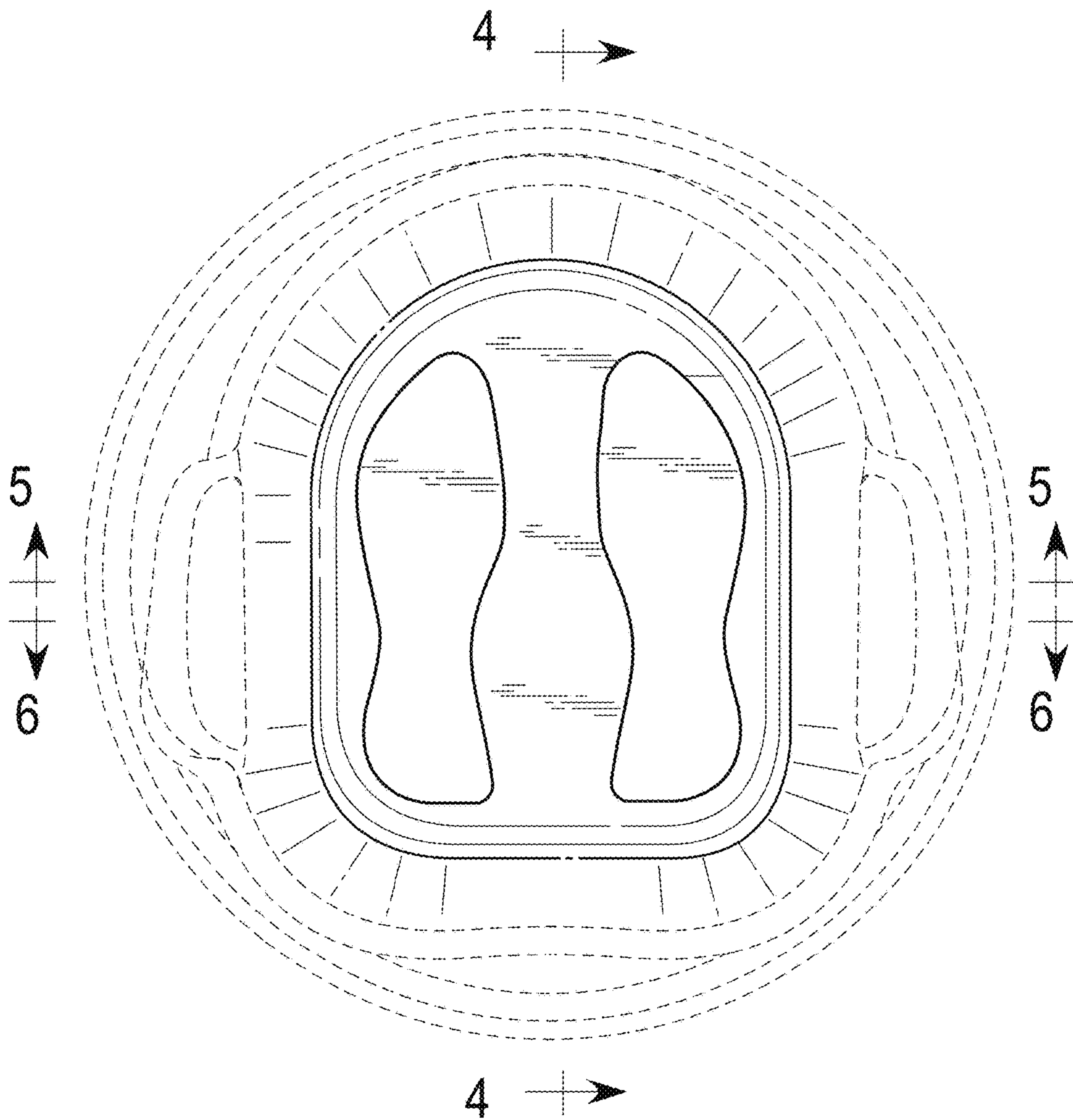

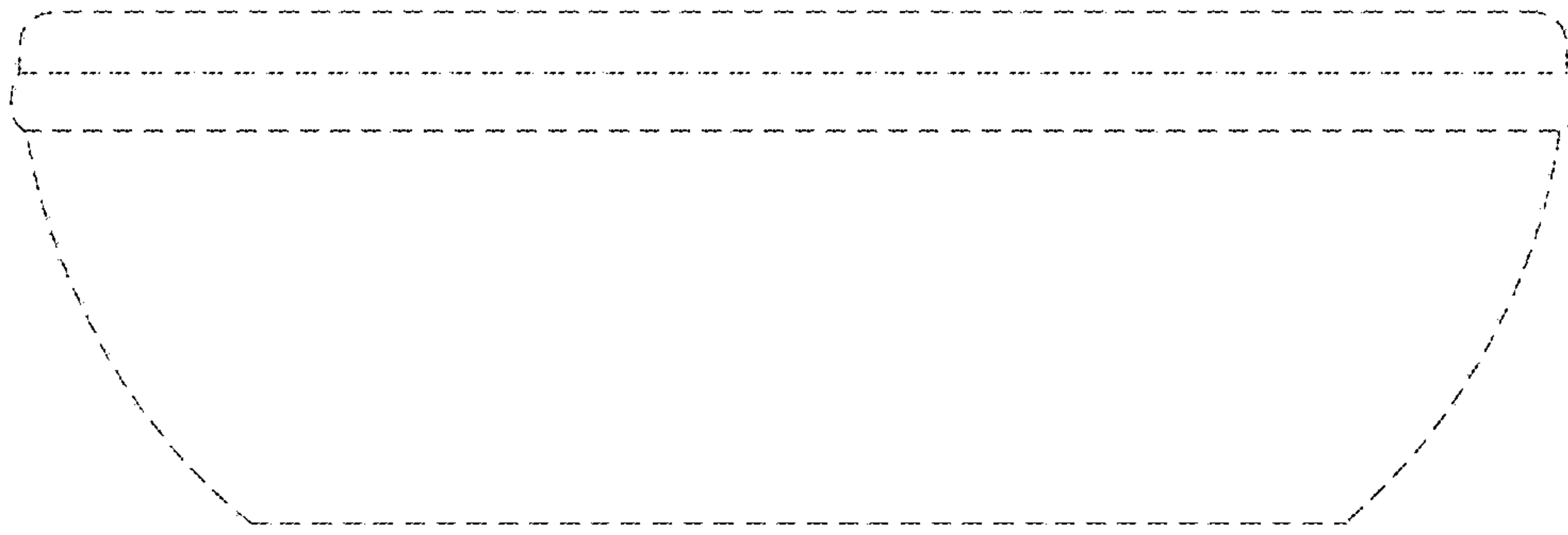

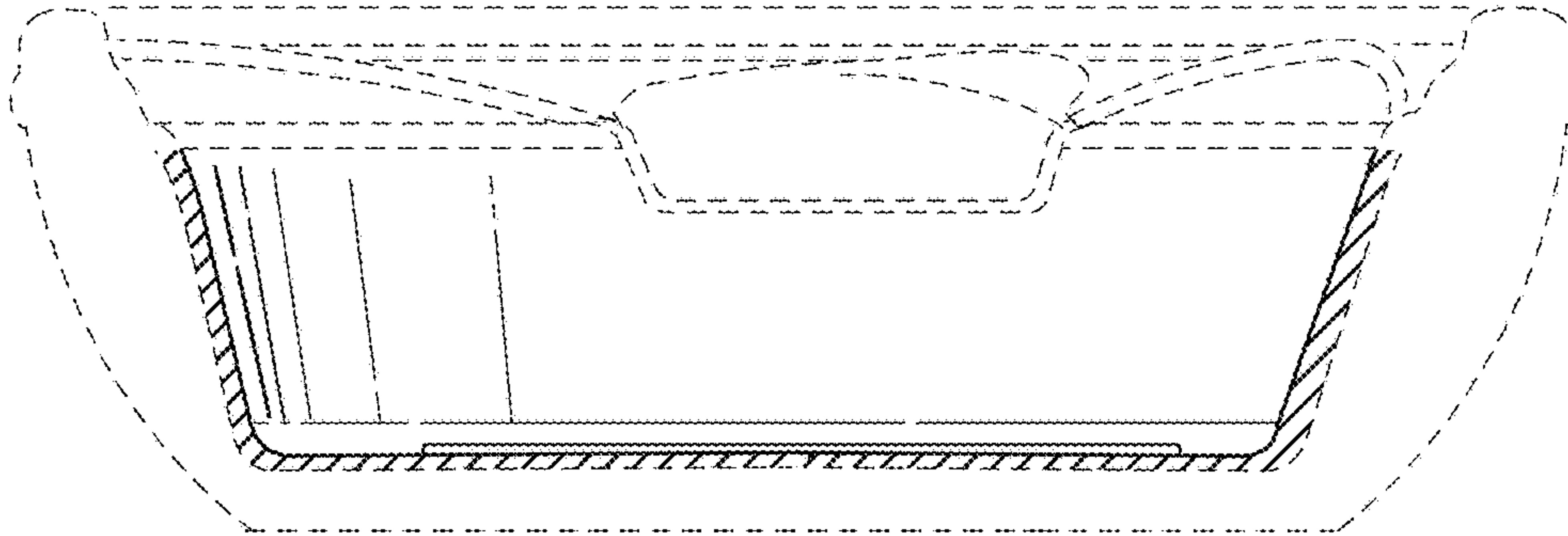

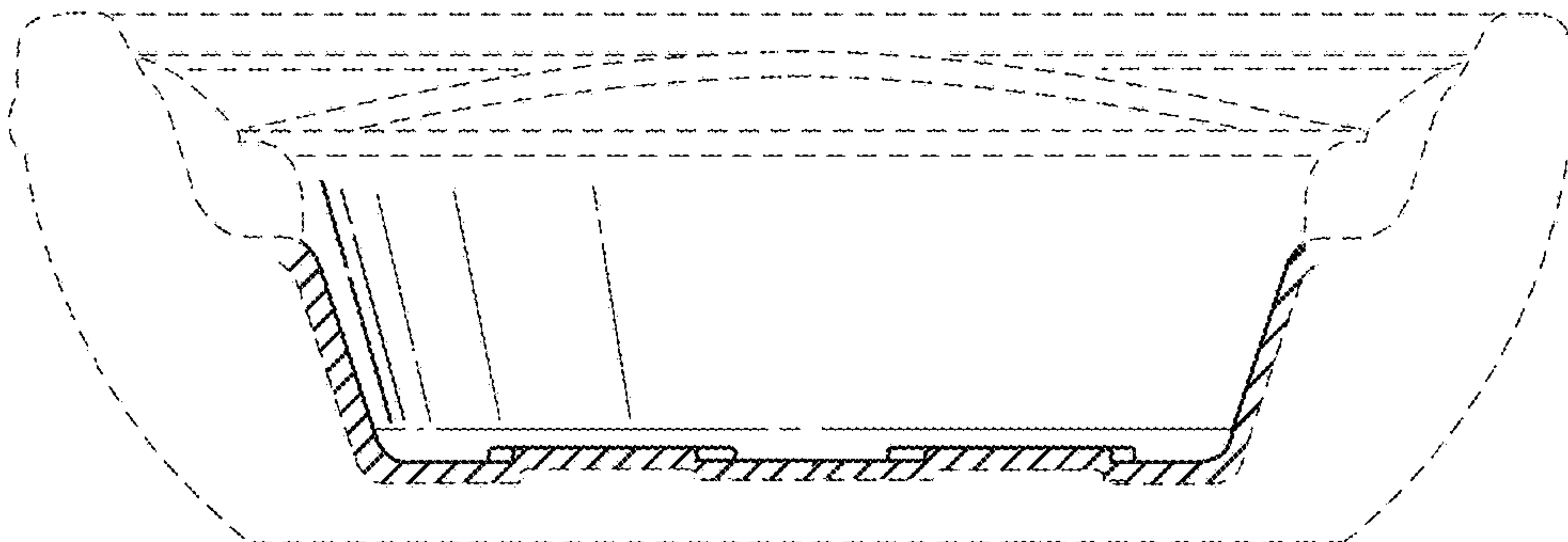

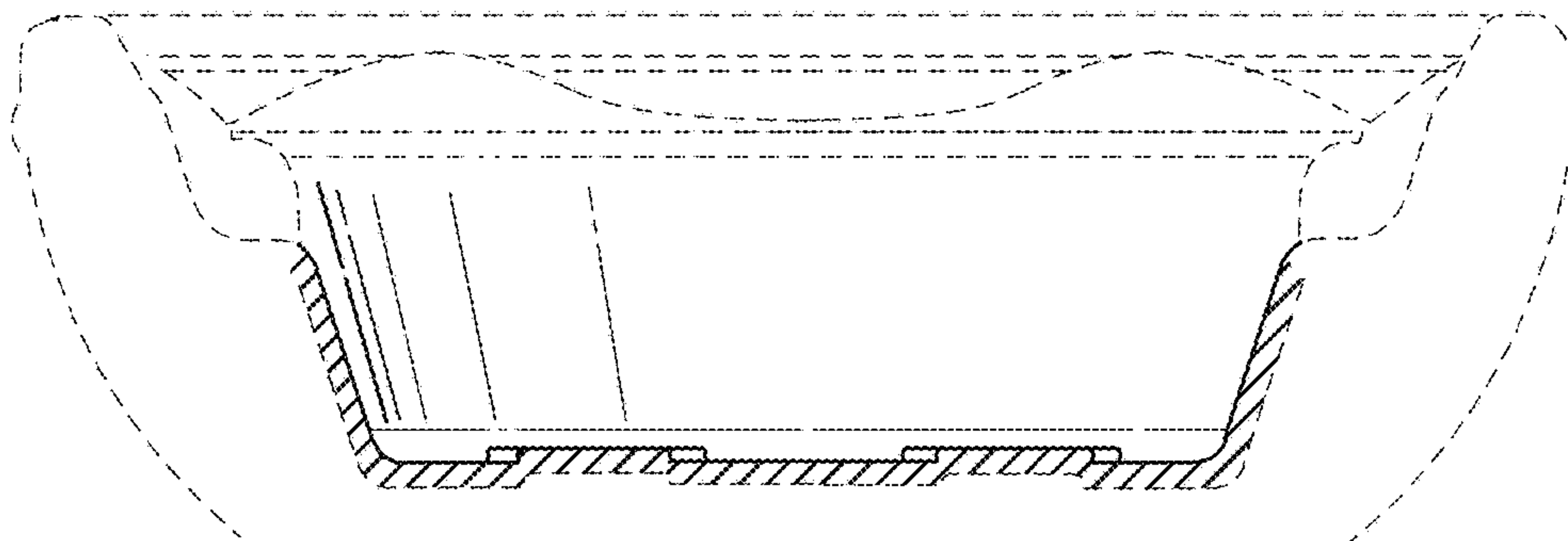
