(57) **CLAIM**

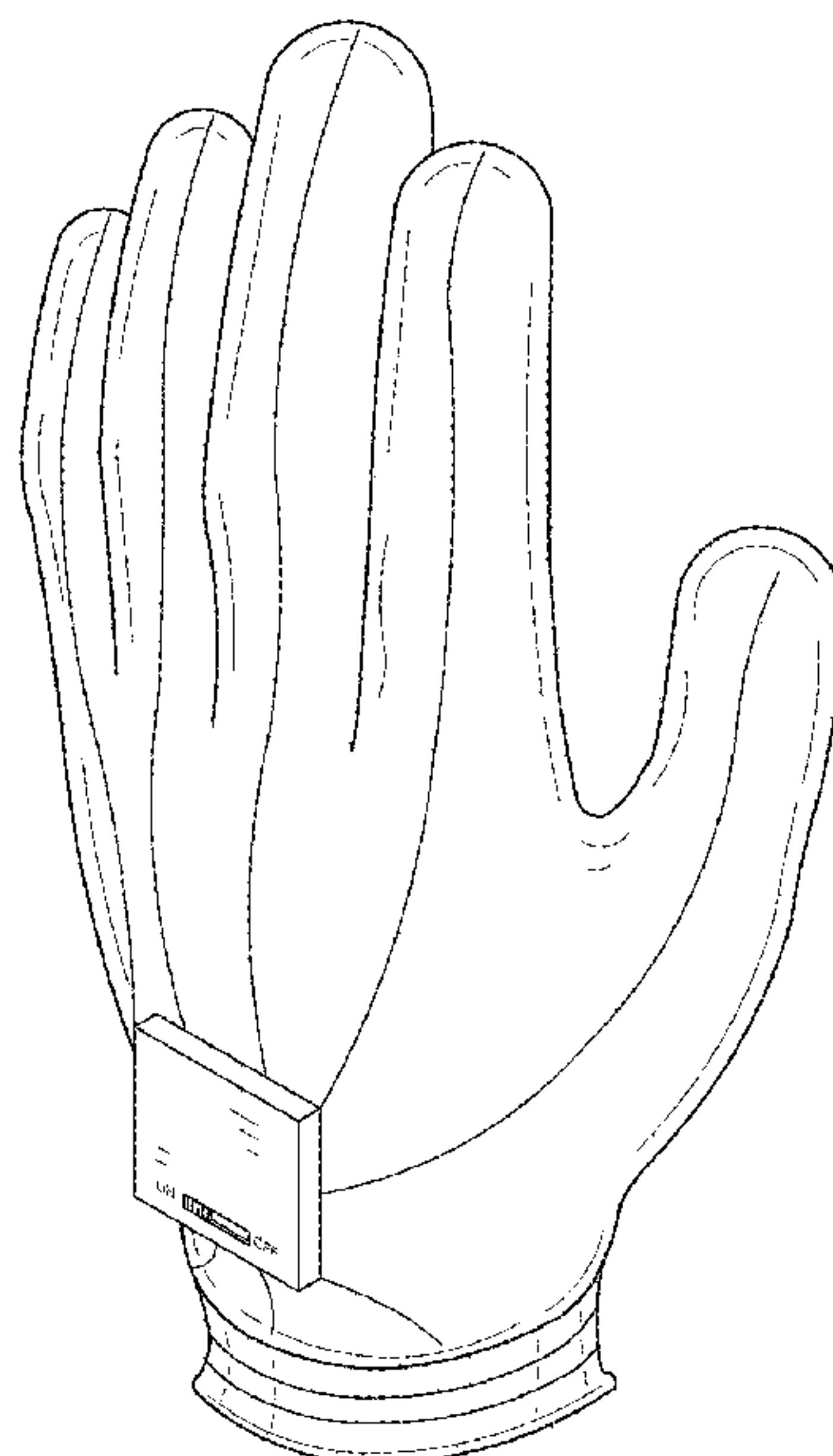
The ornamental design for a heated glove, as shown and described.

DESCRIPTION

FIG. 1 is a back view of a heated glove showing my new design;
FIG. 2 is a front view of the heated glove;
FIG. 3 is a right side side view of the heated glove;
FIG. 4 is a left side view of the heated glove;
FIG. 5 is a top view of the heated glove;
FIG. 6 is a bottom view of the heated glove;
FIG. 7 is a top back side perspective view of the heated glove; and,
FIG. 8 is a cross-sectional view of the heated glove taken along line 8-8 of FIG. 2.
The Figures depict a left hand embodiment, a right hand embodiment being a mirror image thereof. A wall thickness of the heated glove as shown in FIG. 8 is consistent throughout the body of the heated glove.

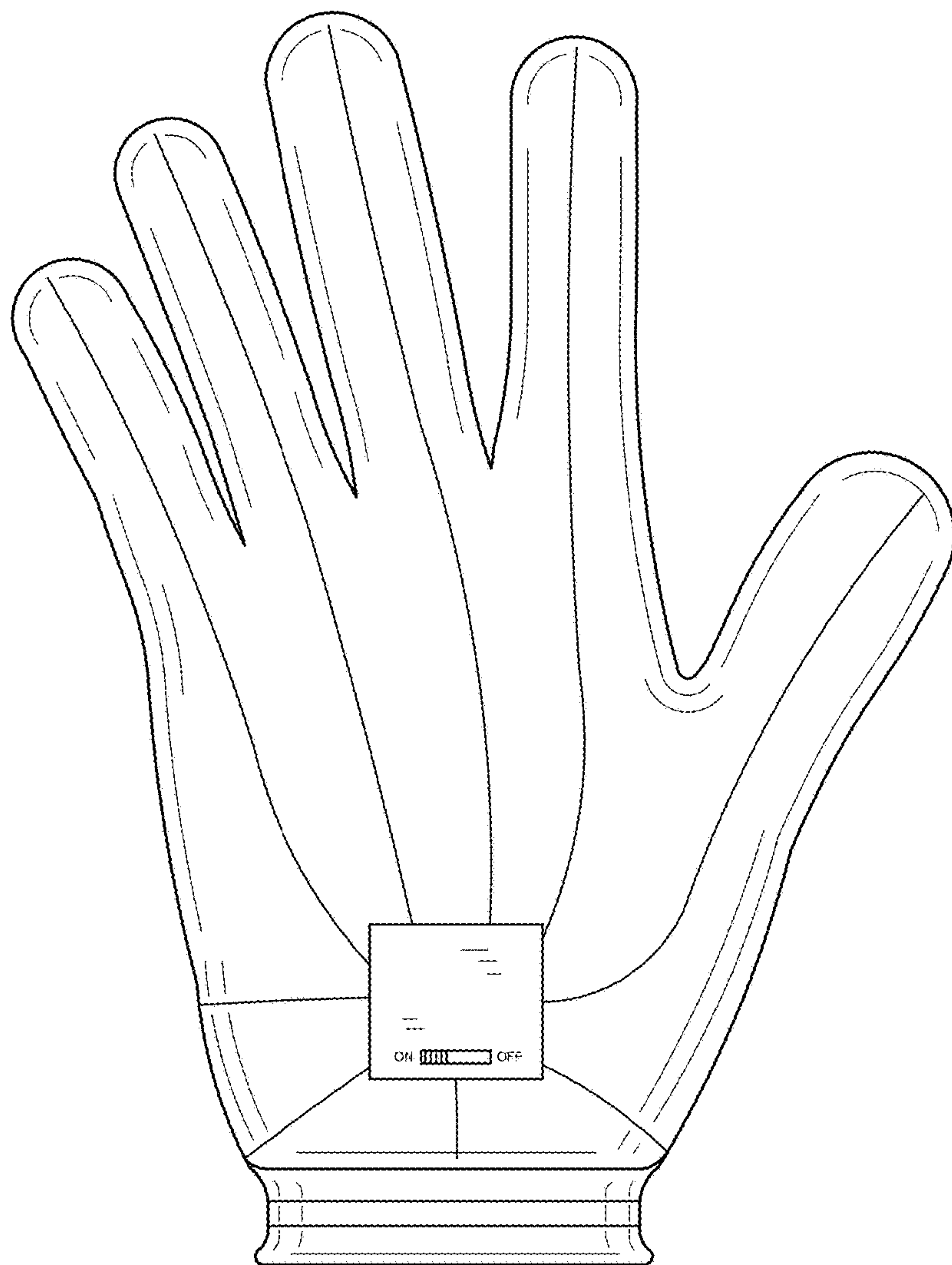

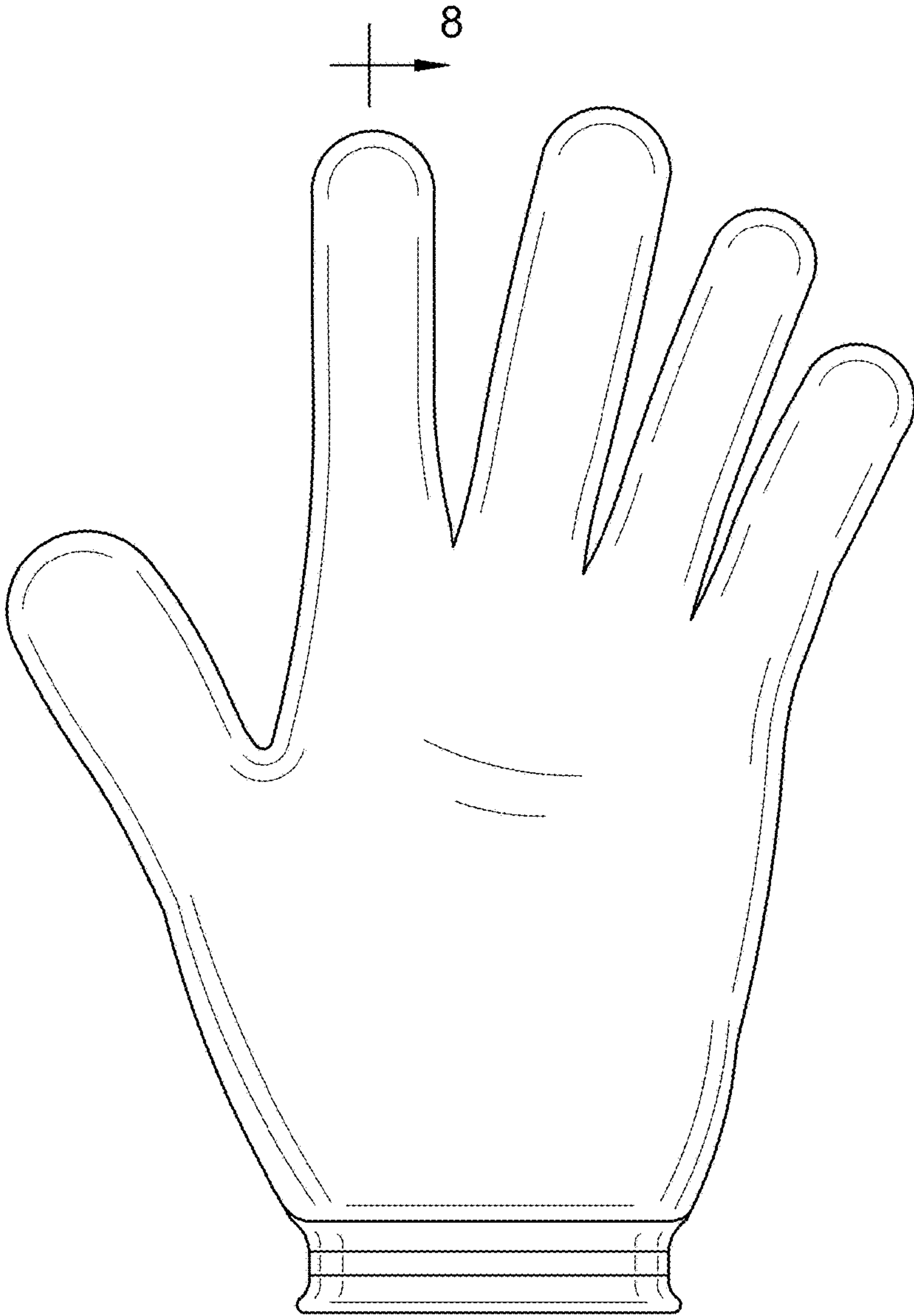
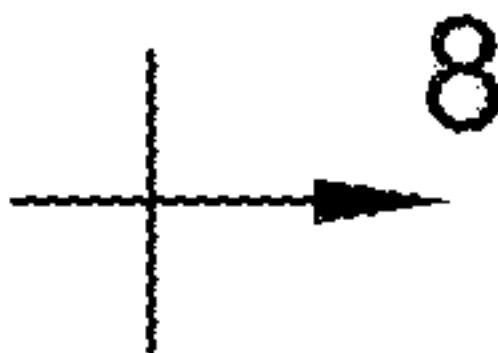

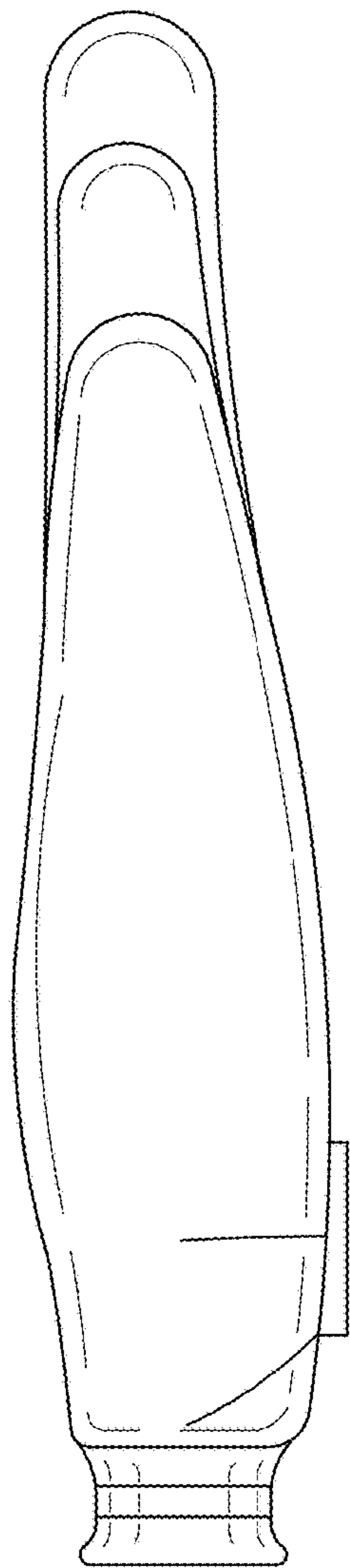

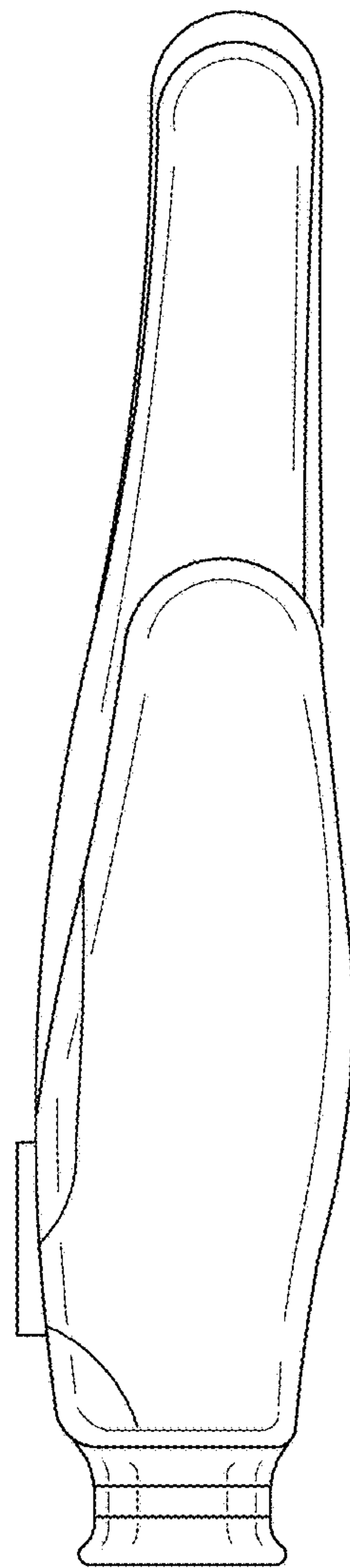

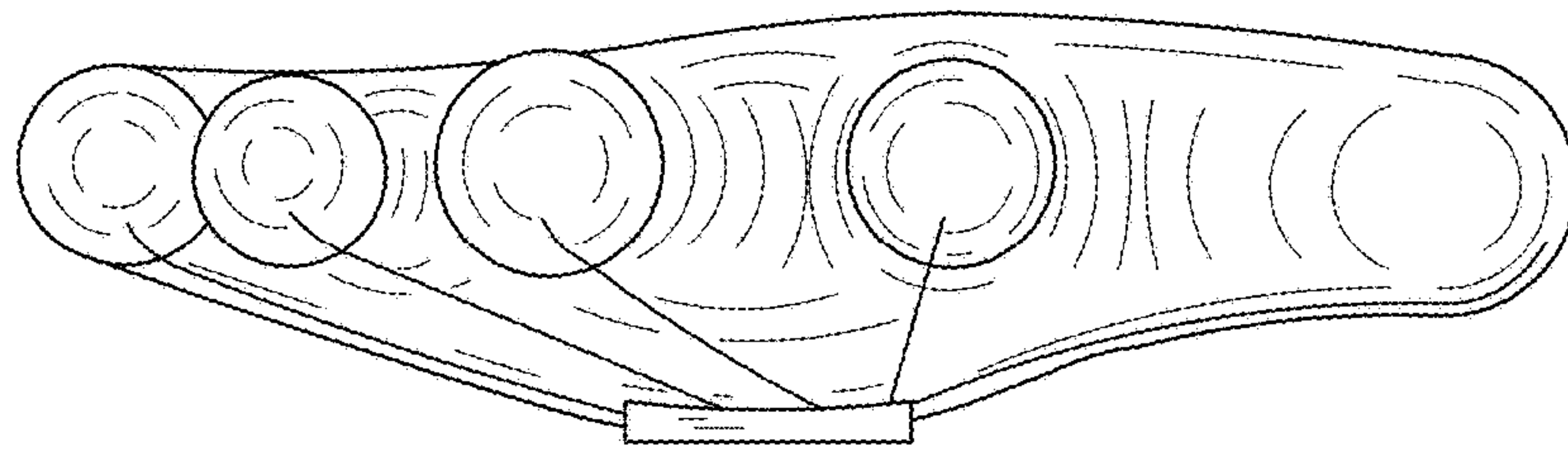

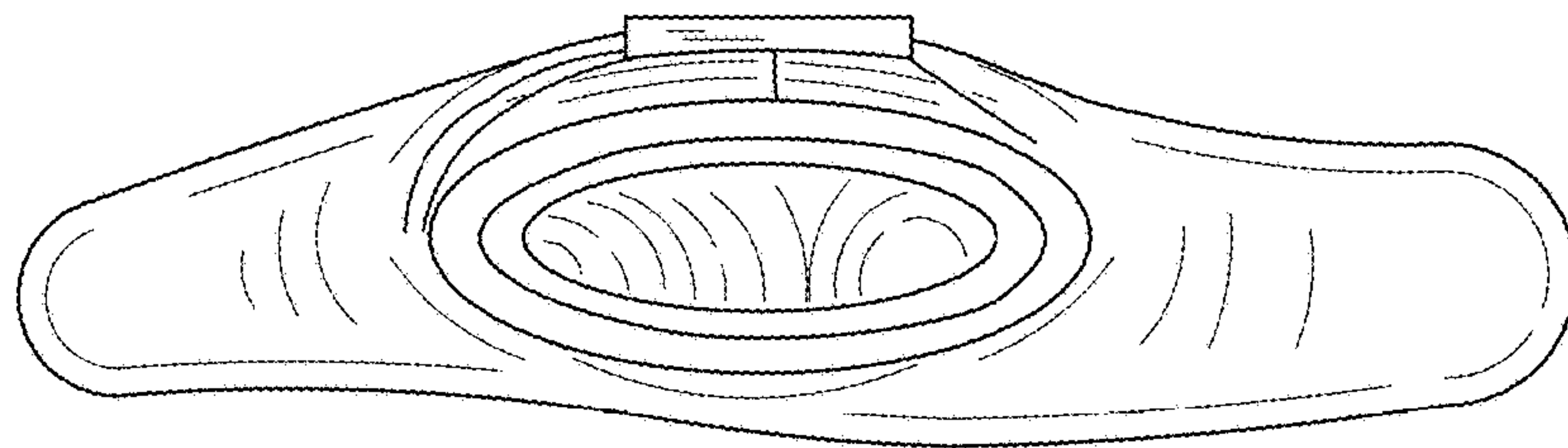

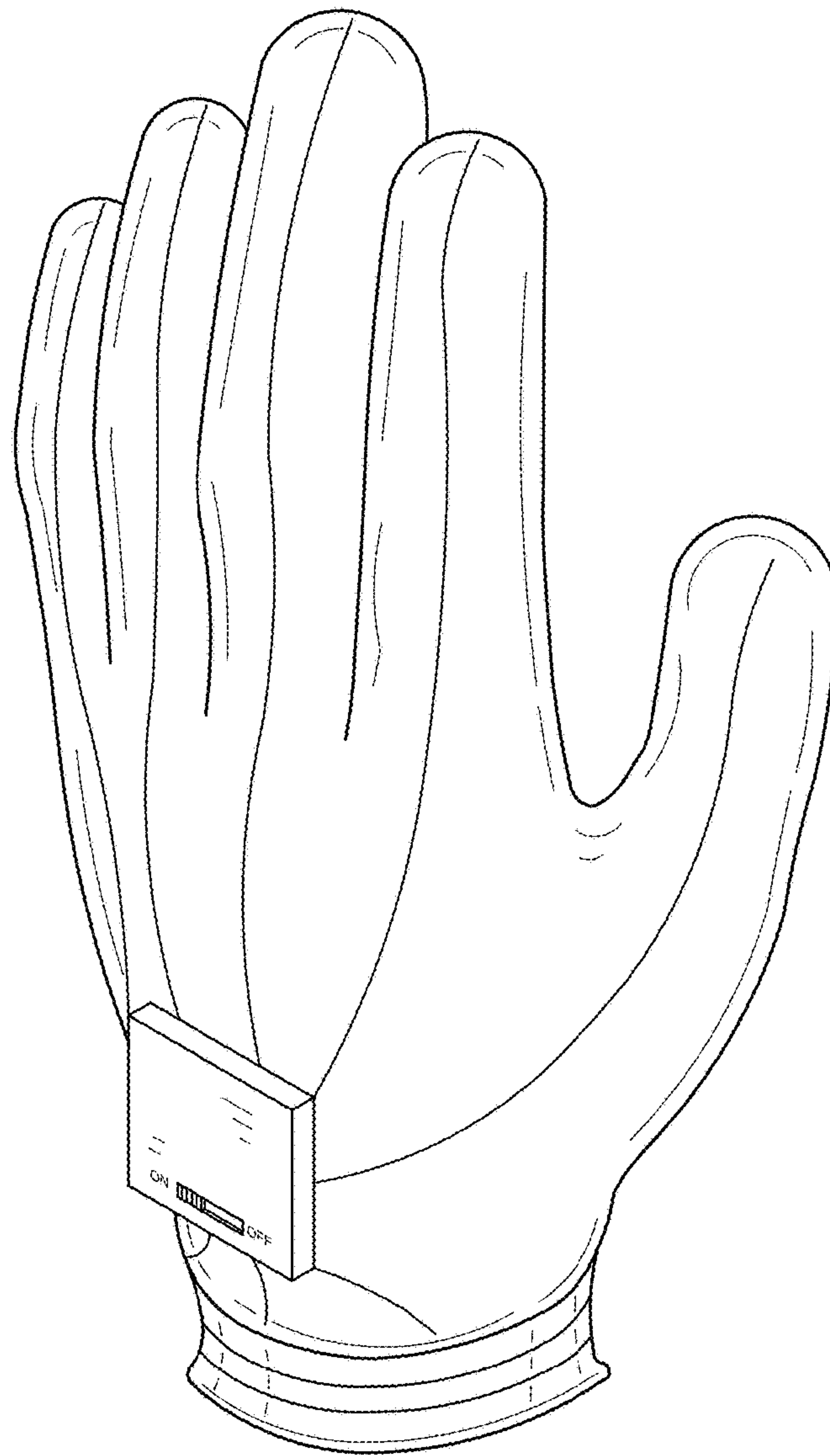

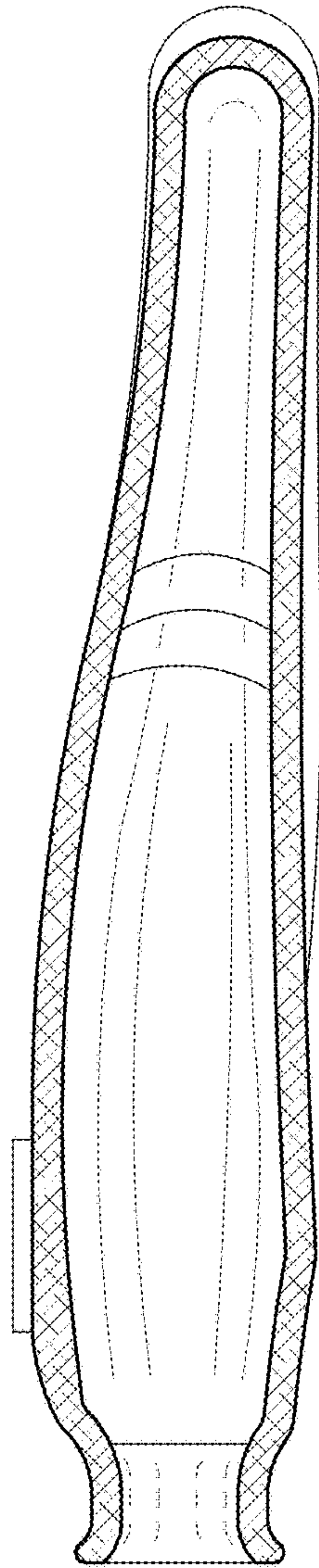
